The ornamental design for display screen with graphical user interface for options and selection of health plans, as shown and described.

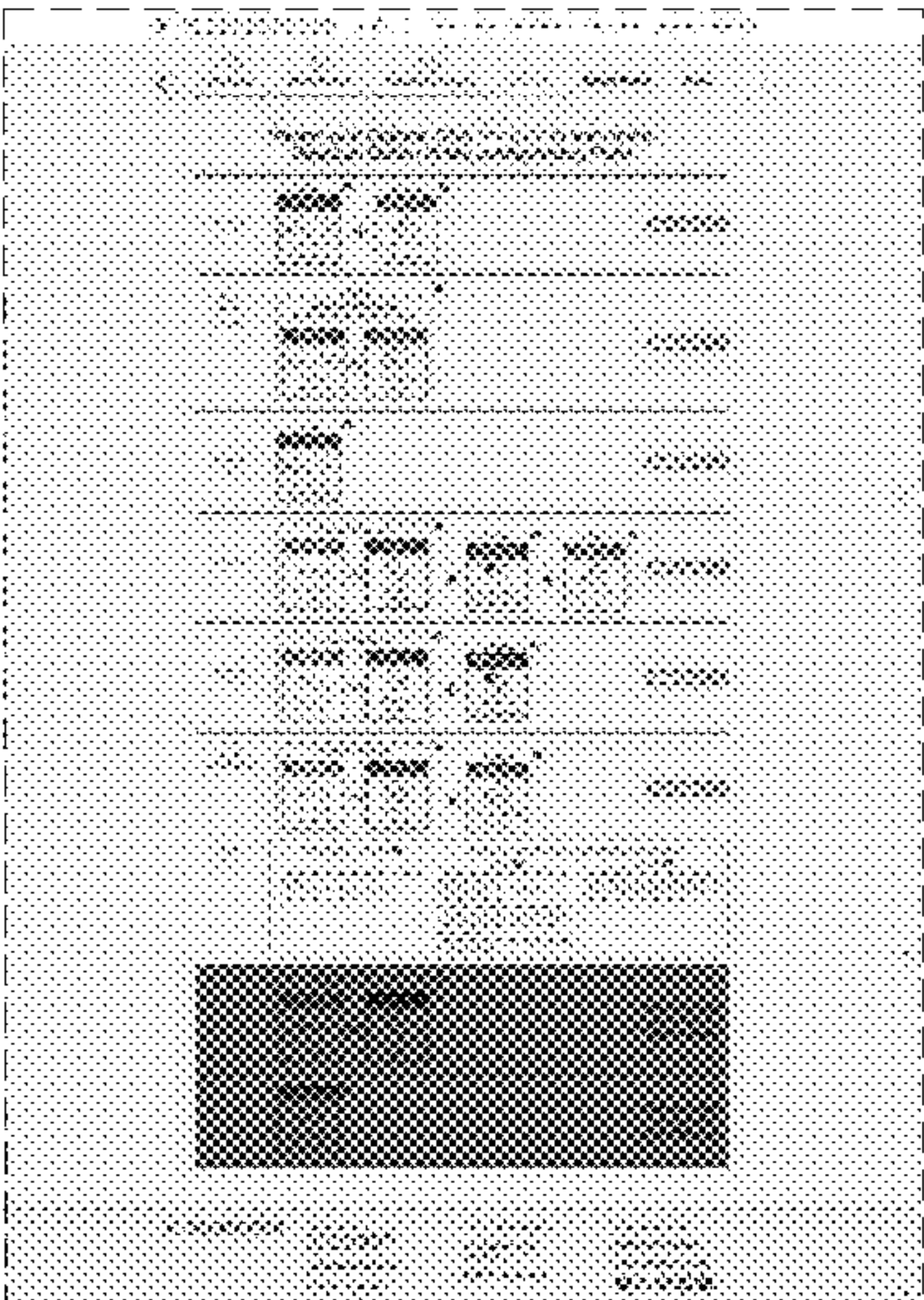
DESCRIPTION

FIG. 1 is a display screen with graphical user interface for options and selection of health plans showing a first image; and,

FIG. 2 shows a second image thereof.

The broken lines showing of a display screen is included for the purpose of illustrating portions of the article and forms no part of the claimed design. The appearance of the transitional image sequentially transitions down and out from the top-center, between the images shown in FIG. 1-2. The processor period in which one image transitions another image forms no part of the claimed design.

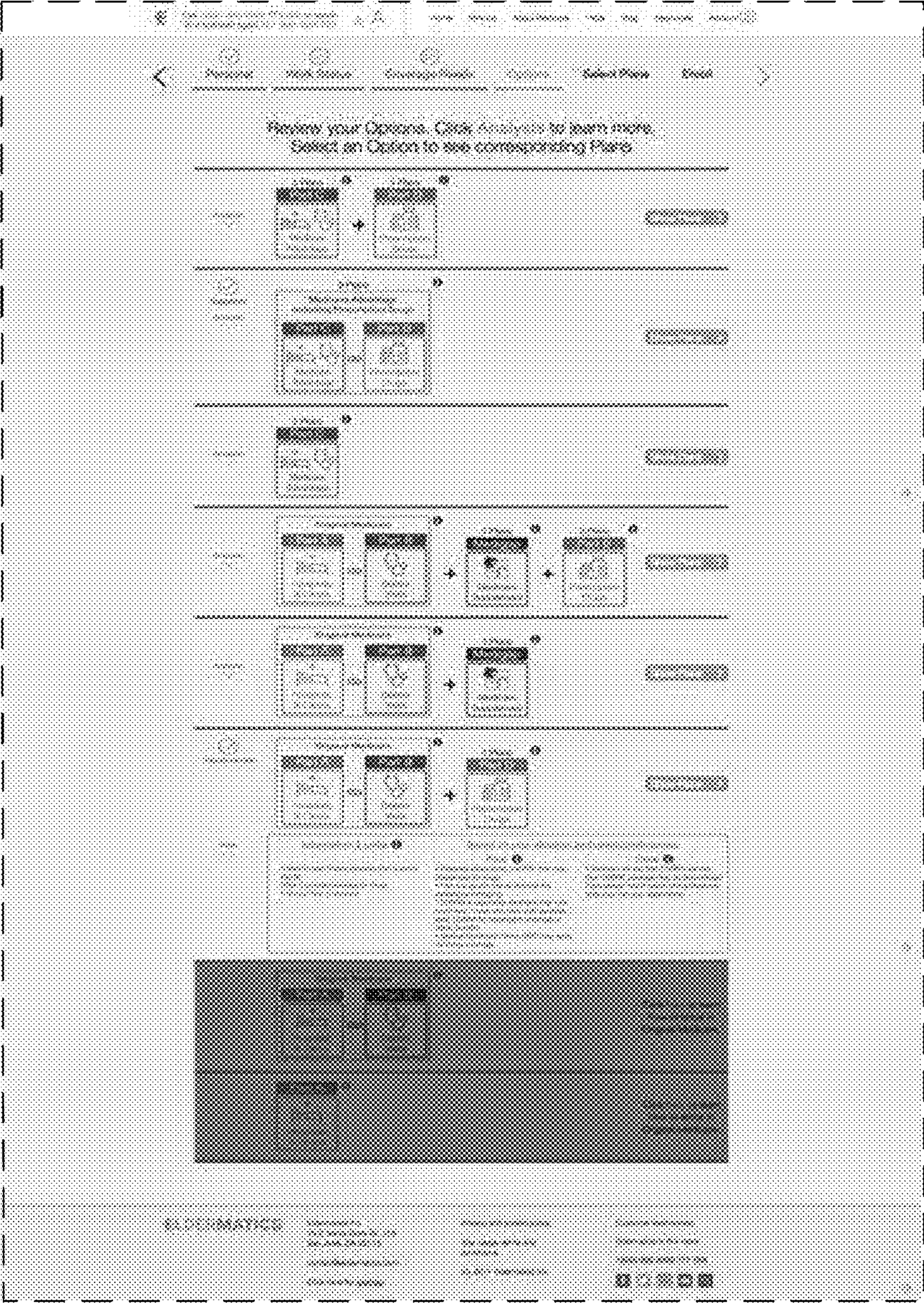

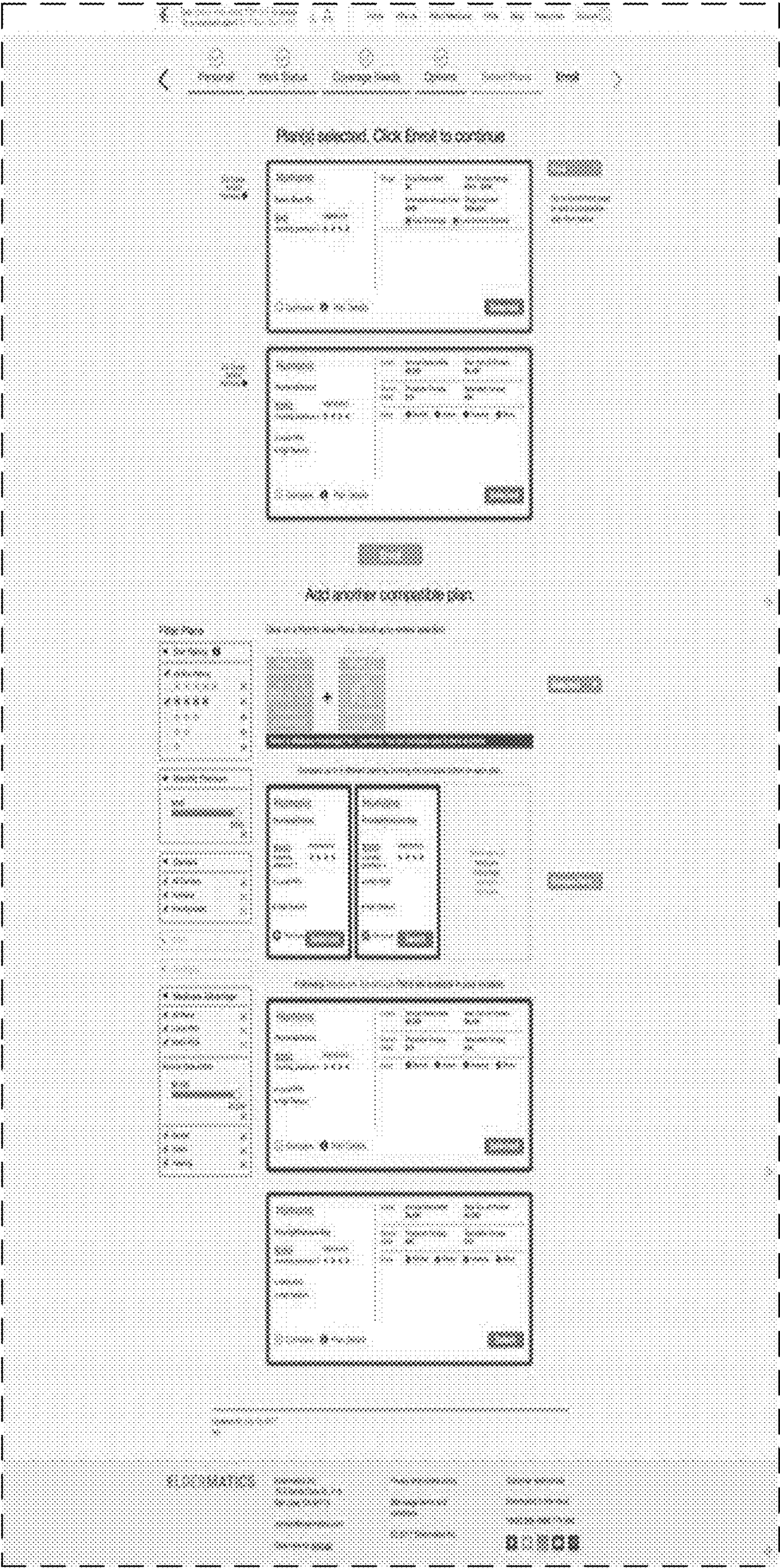
