DESCRIPTION

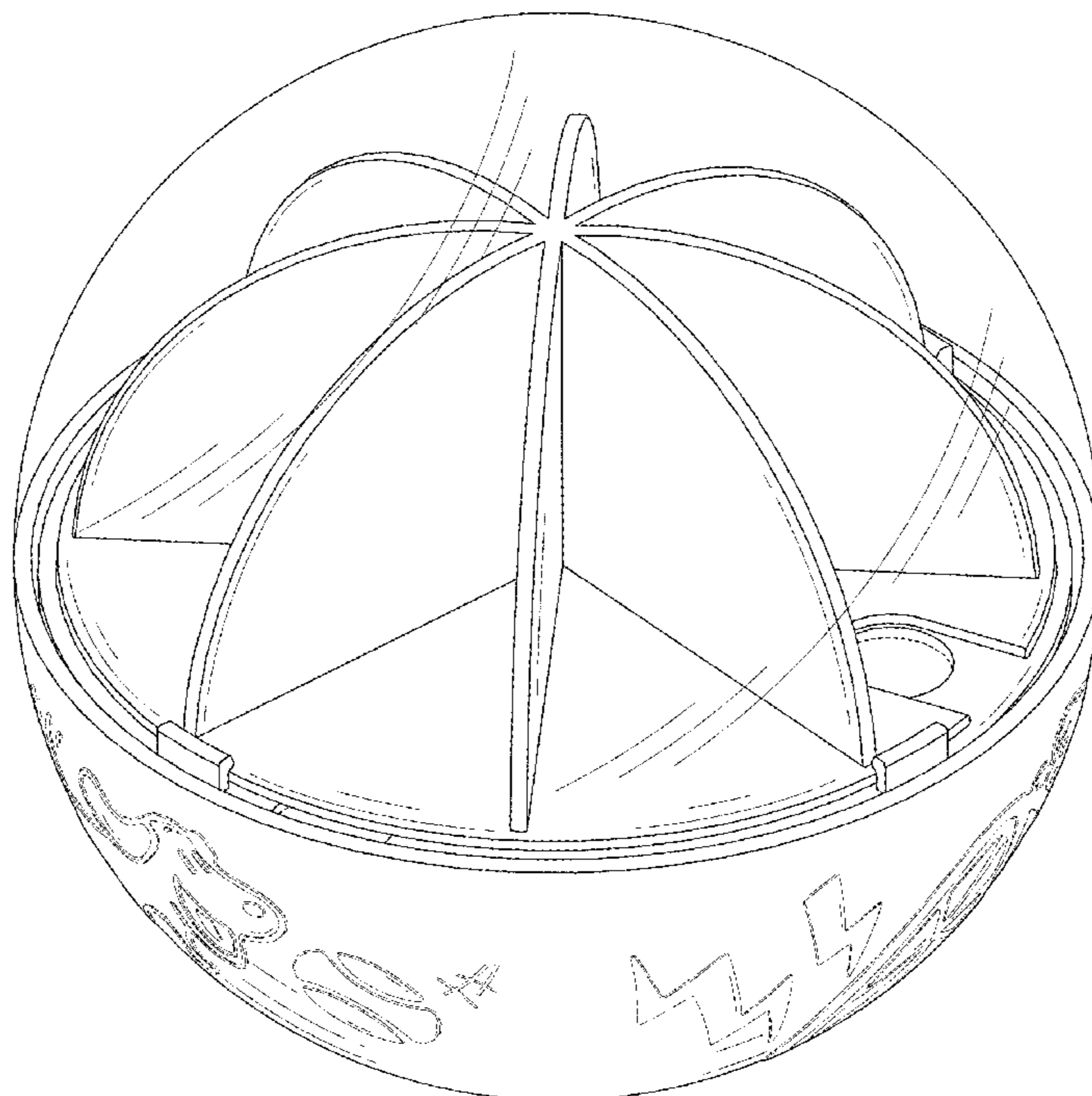

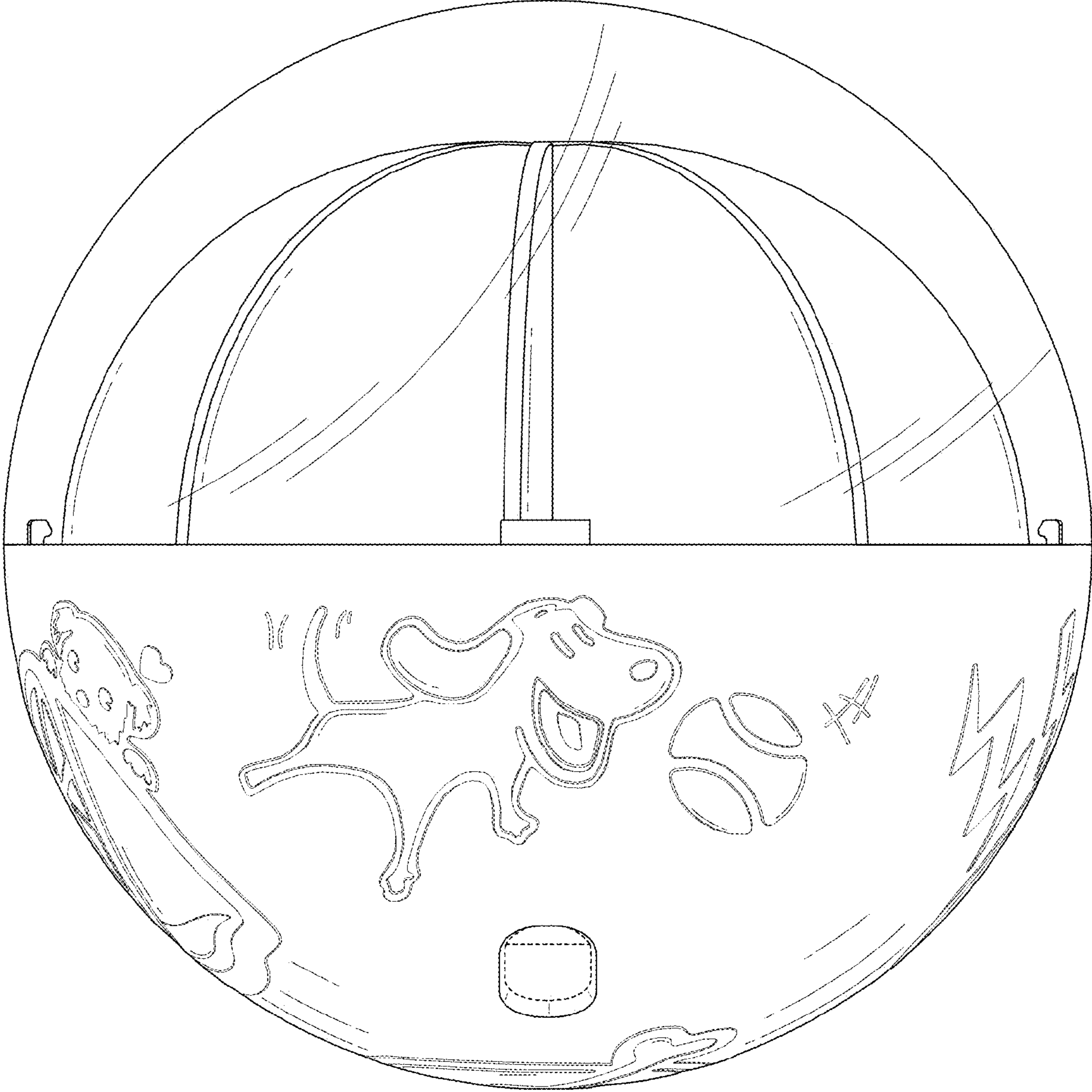

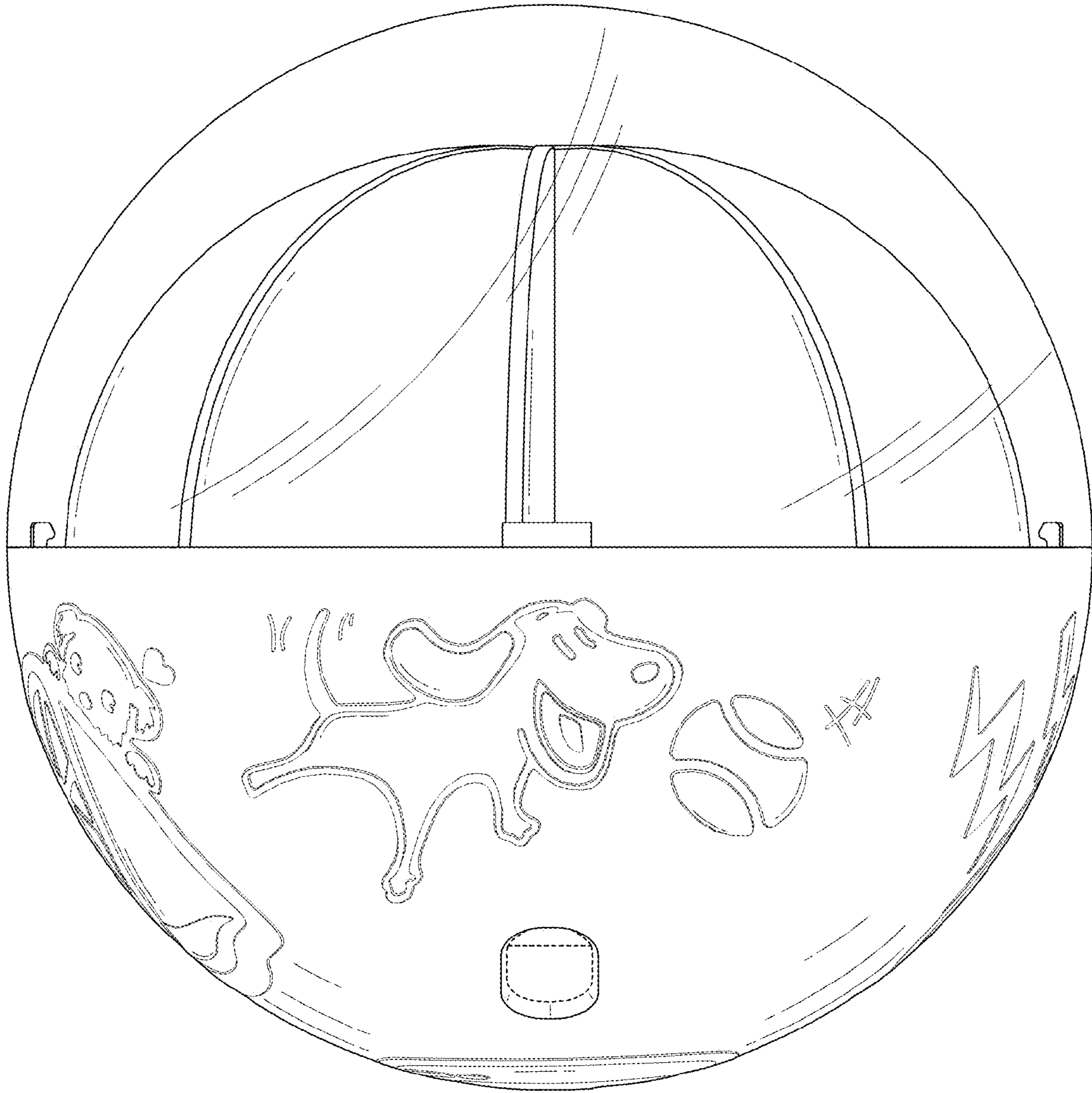

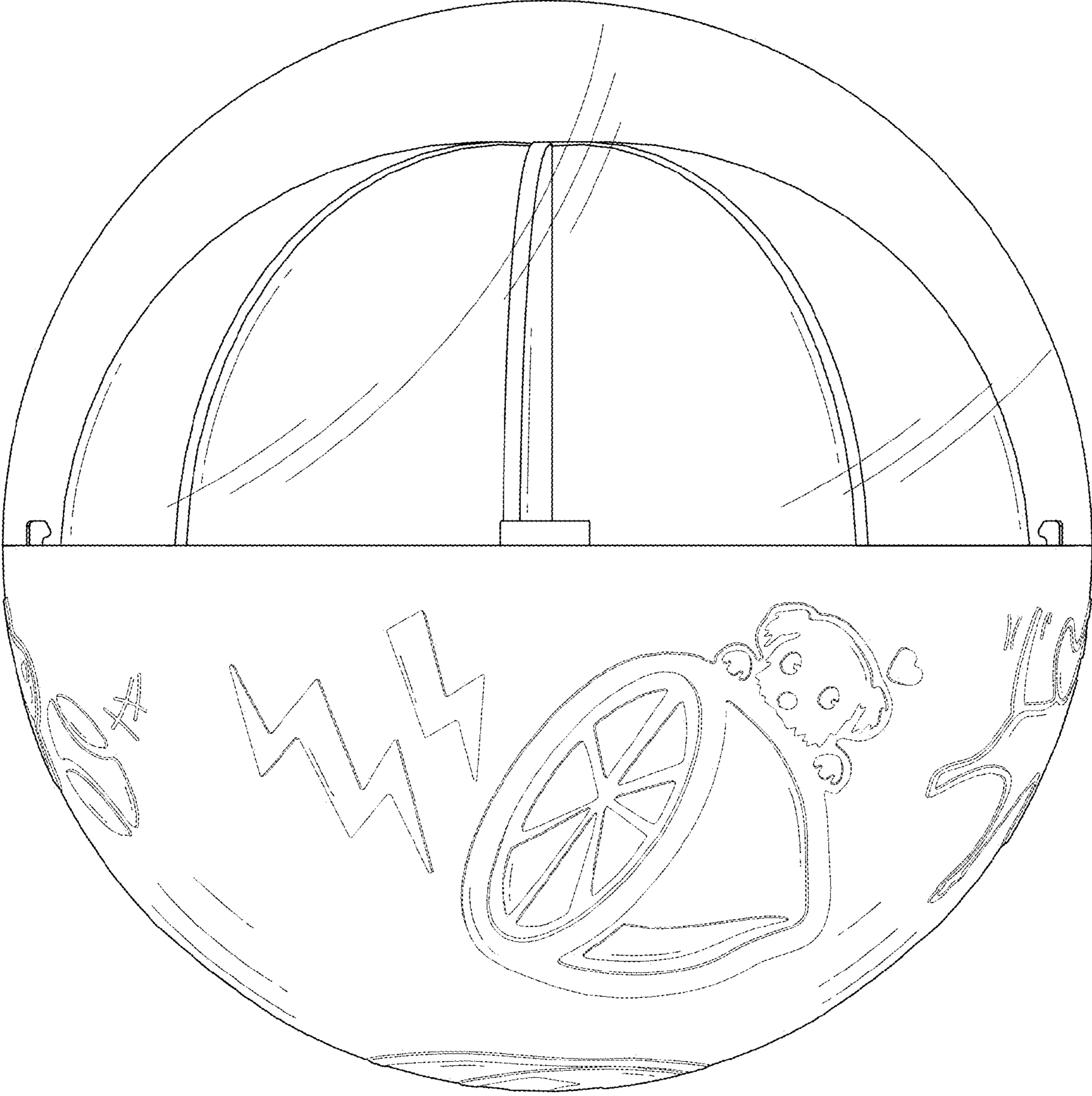

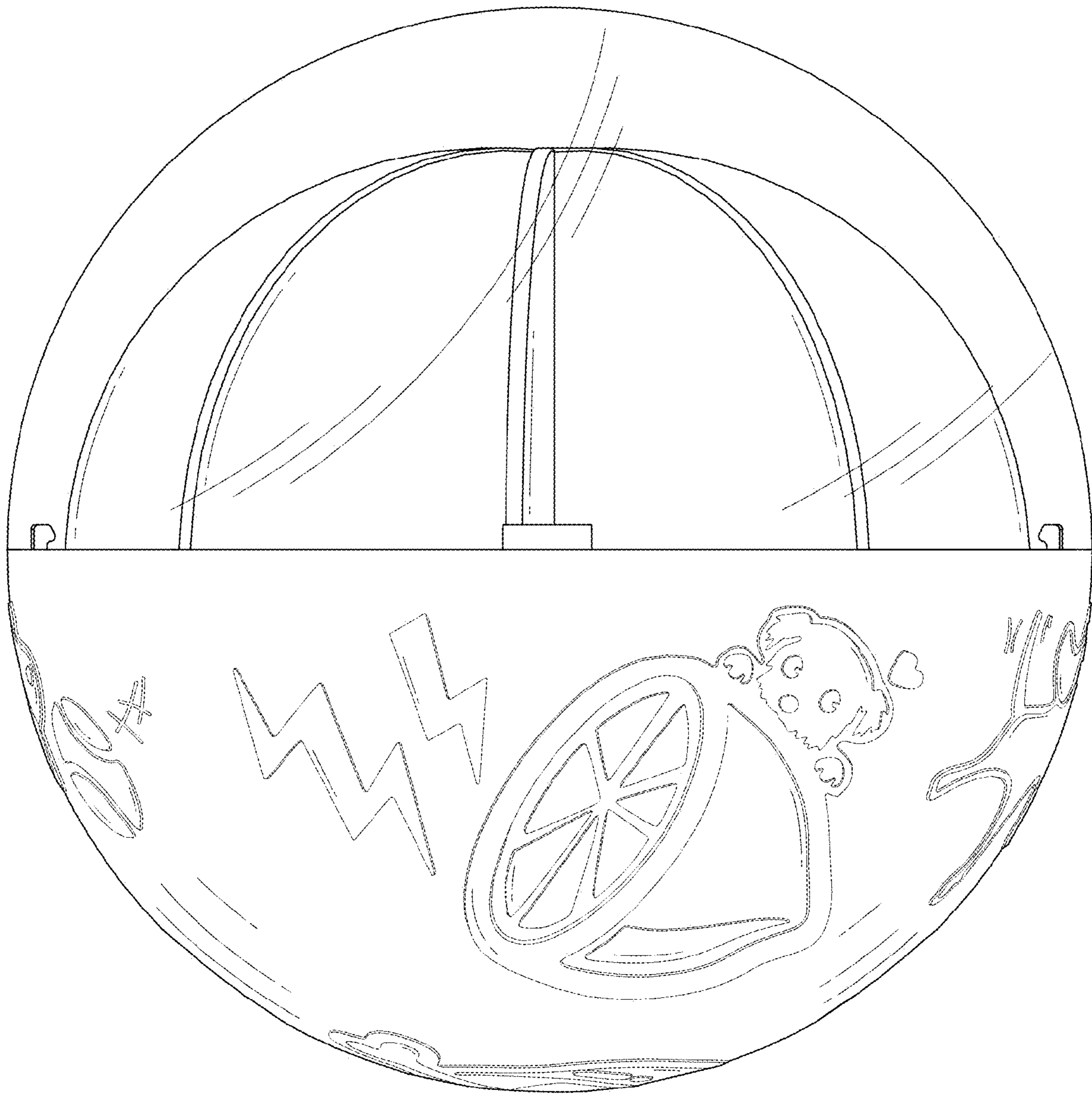

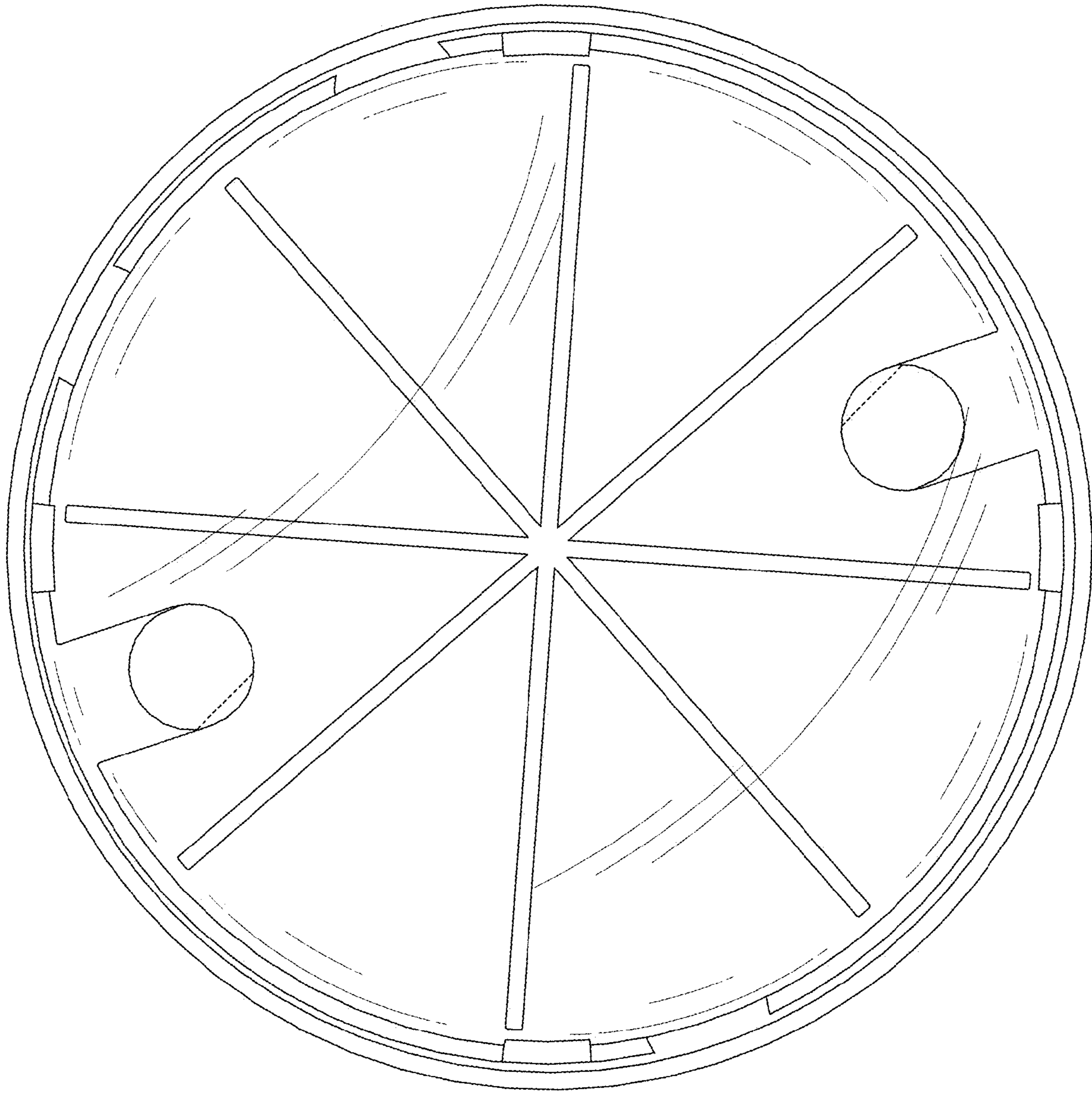
