The ornamental design for an aromatherapy diffuser, as shown and described.

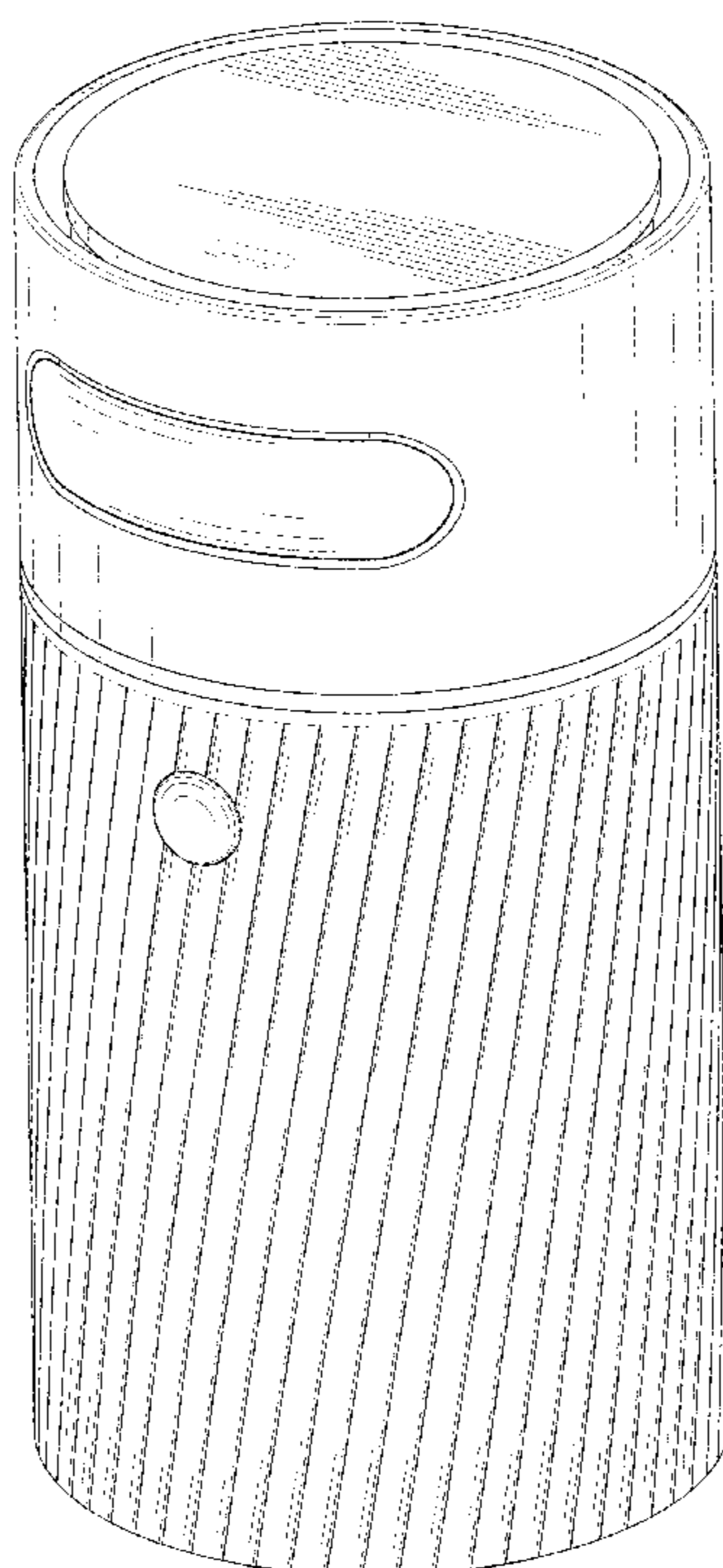
**DESCRIPTION**

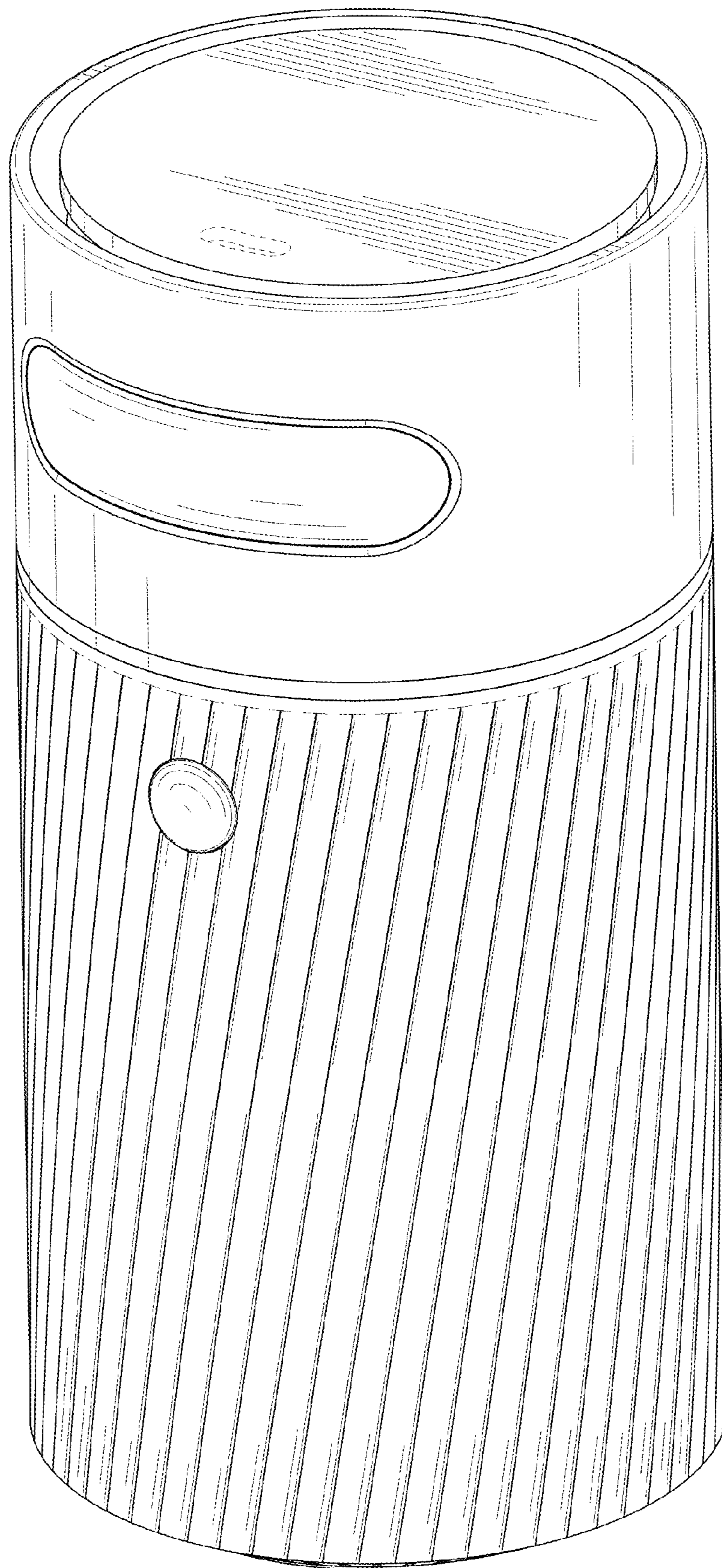

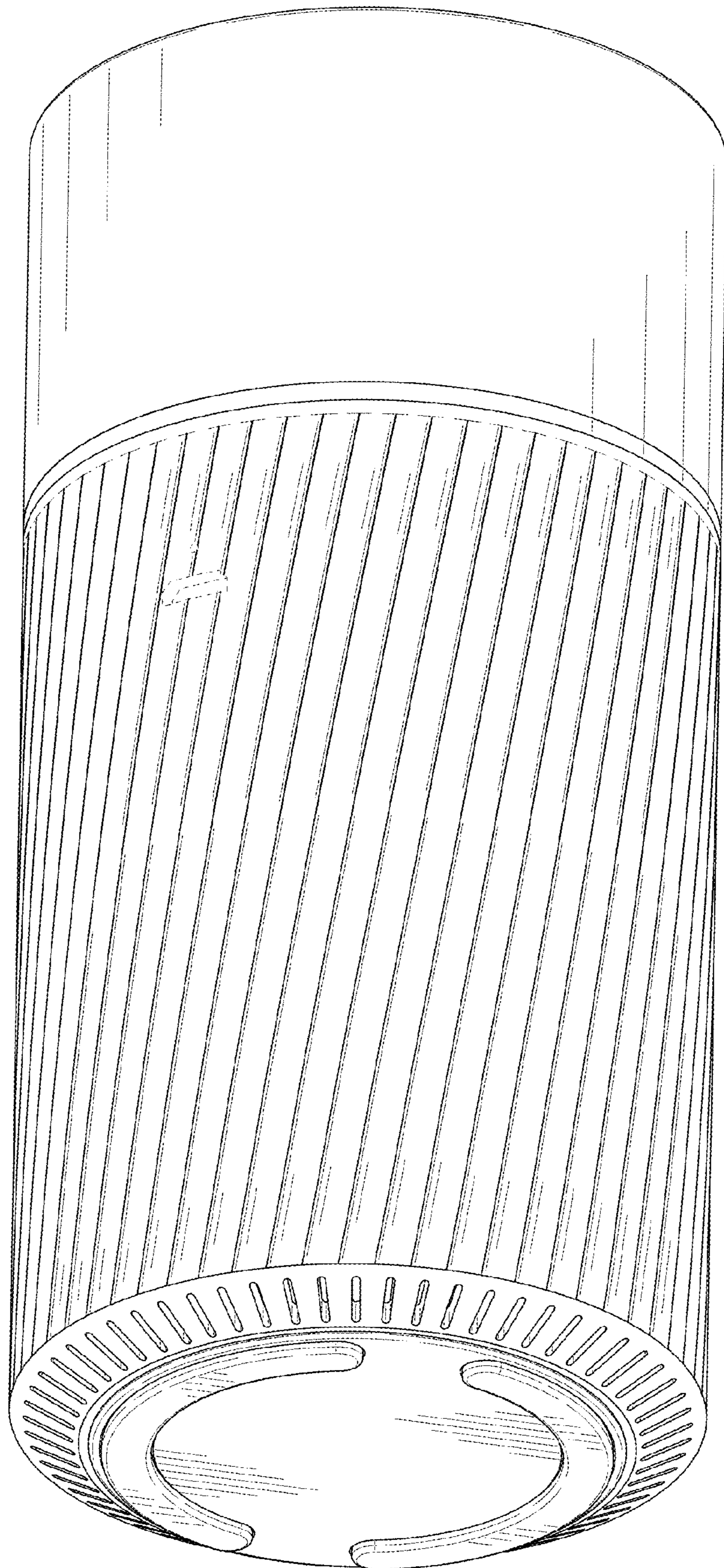

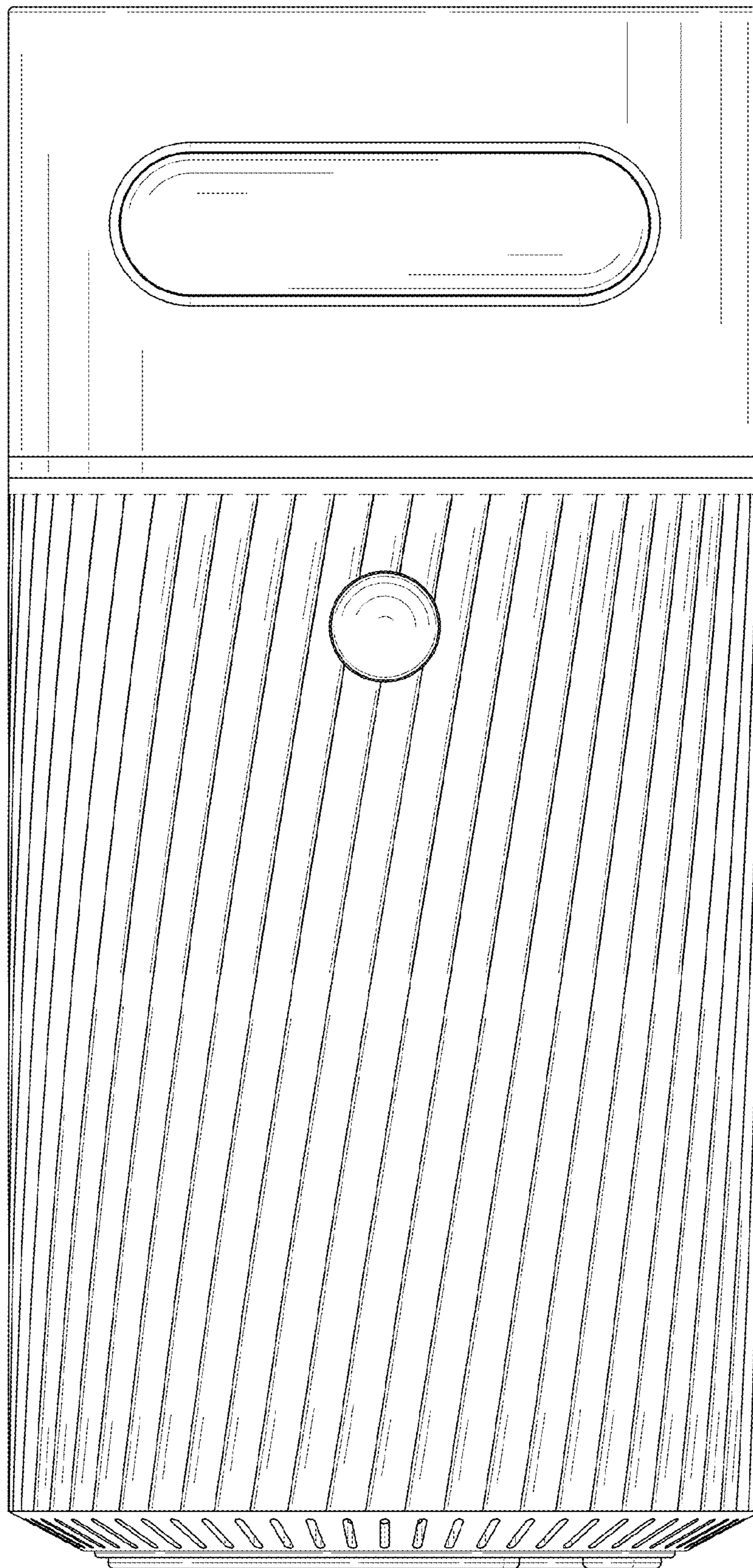

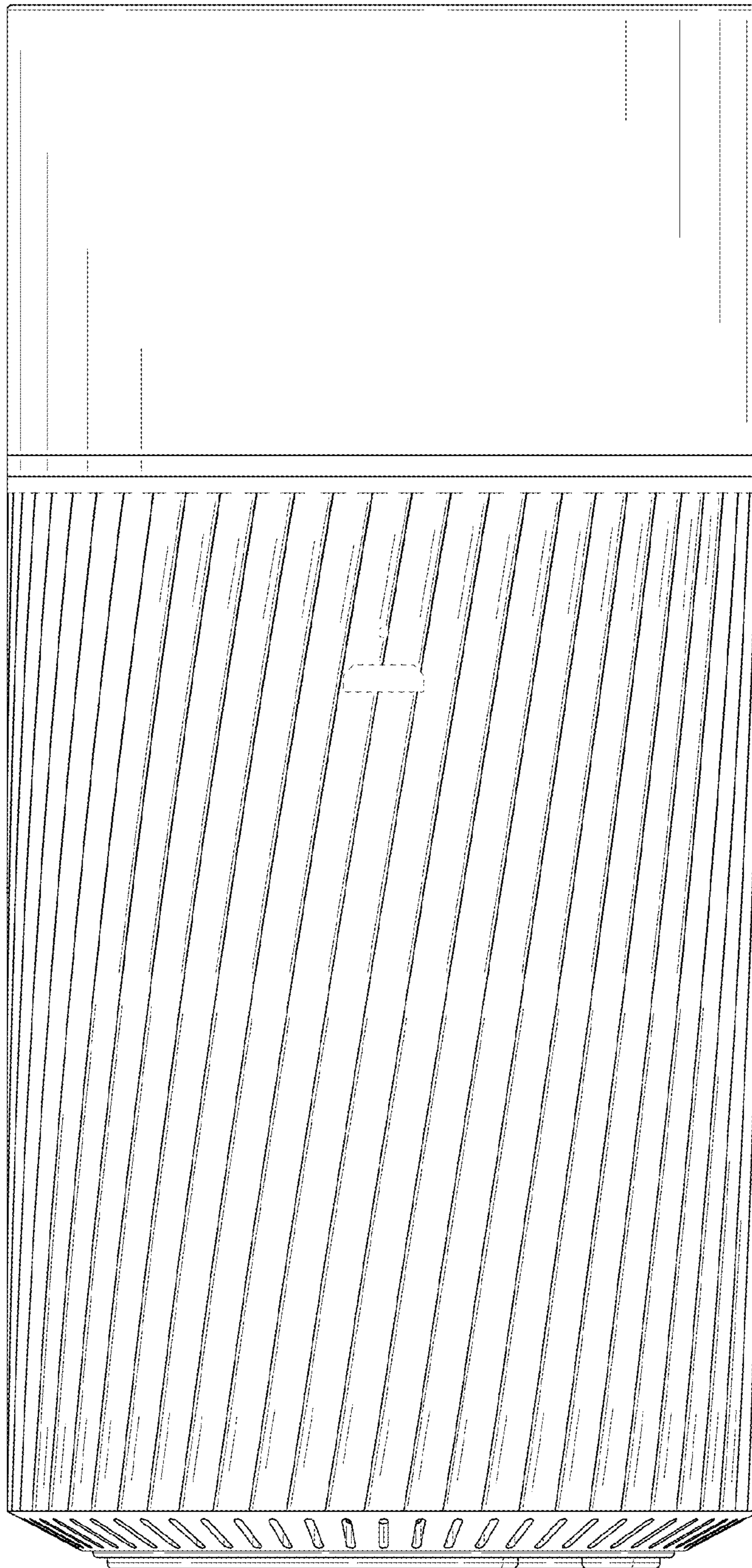

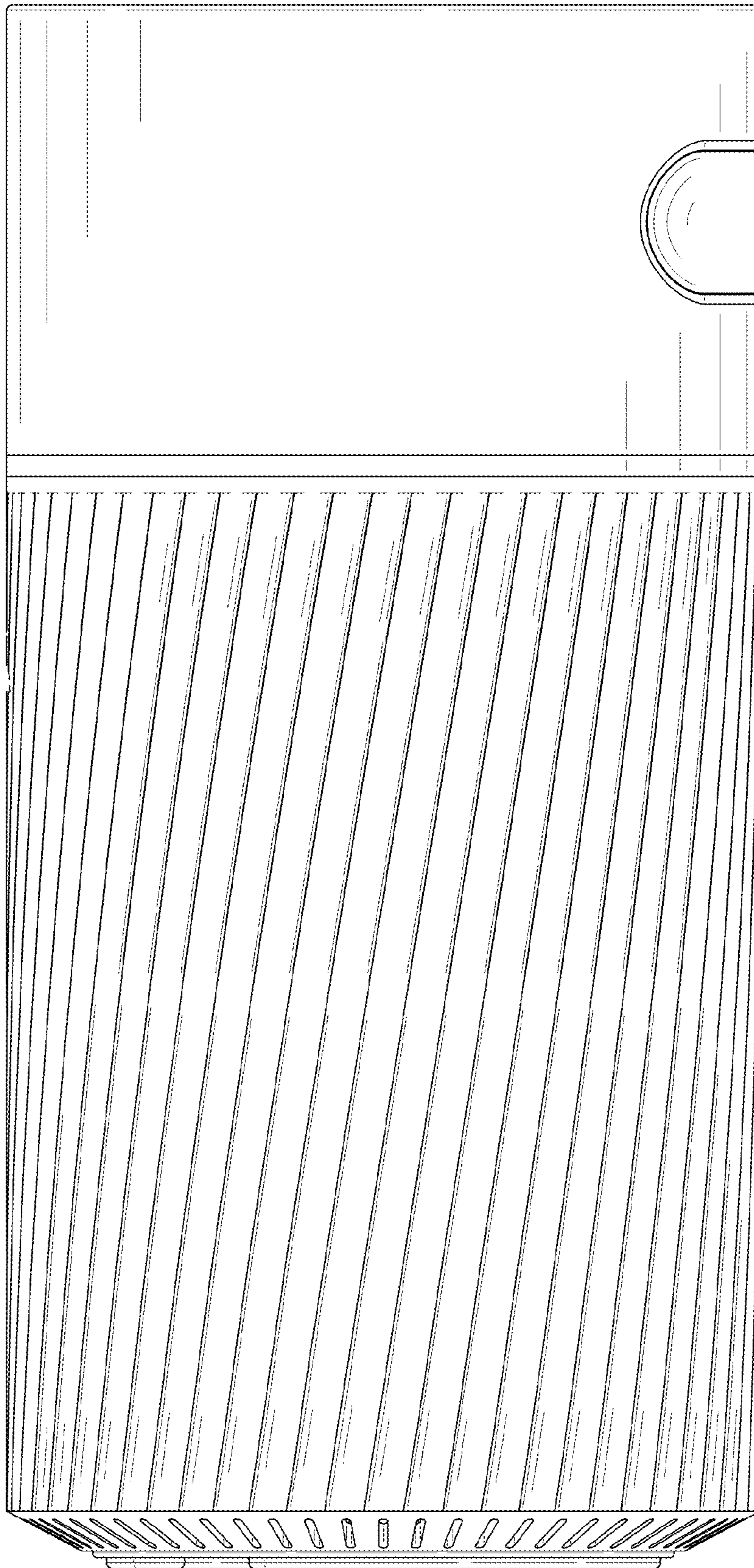

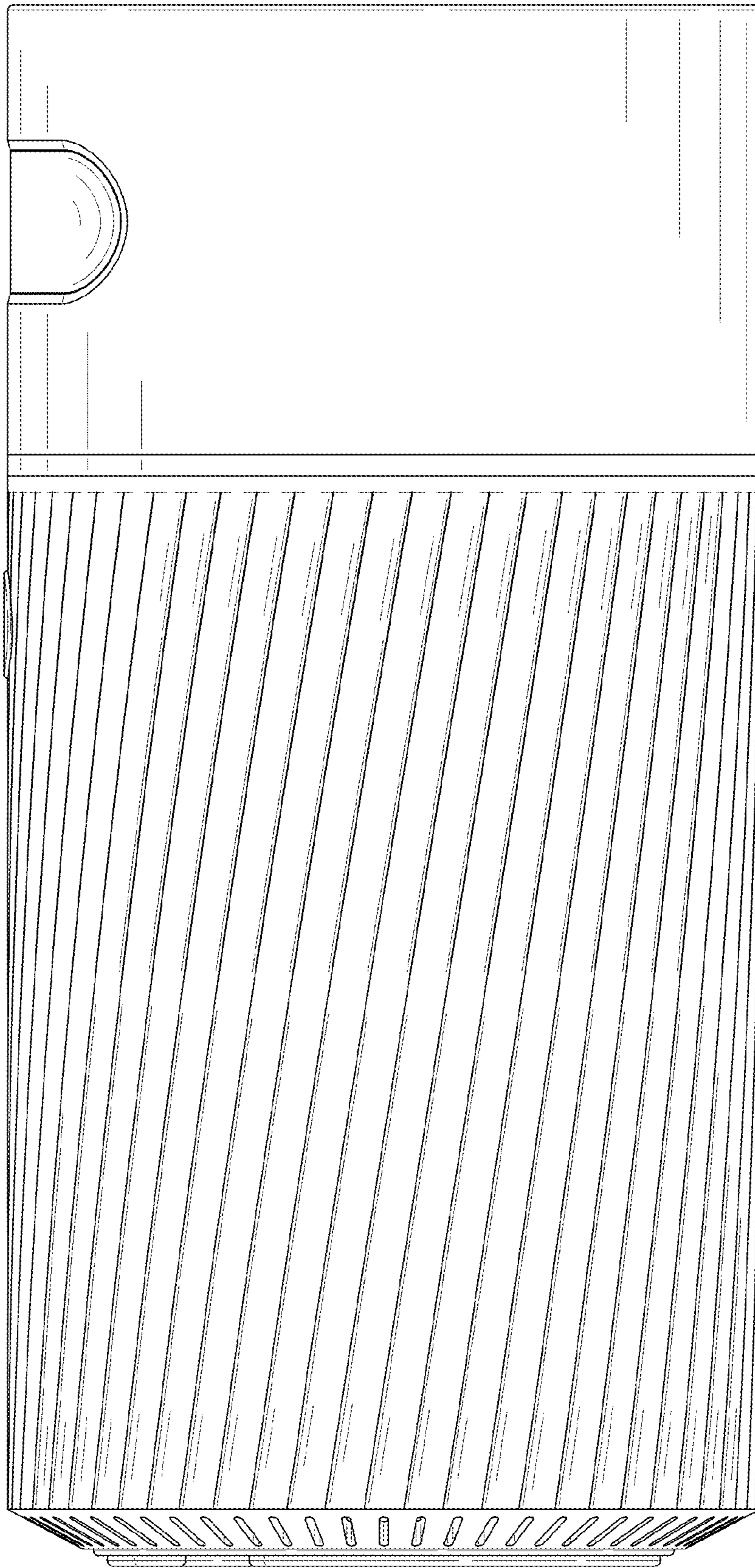

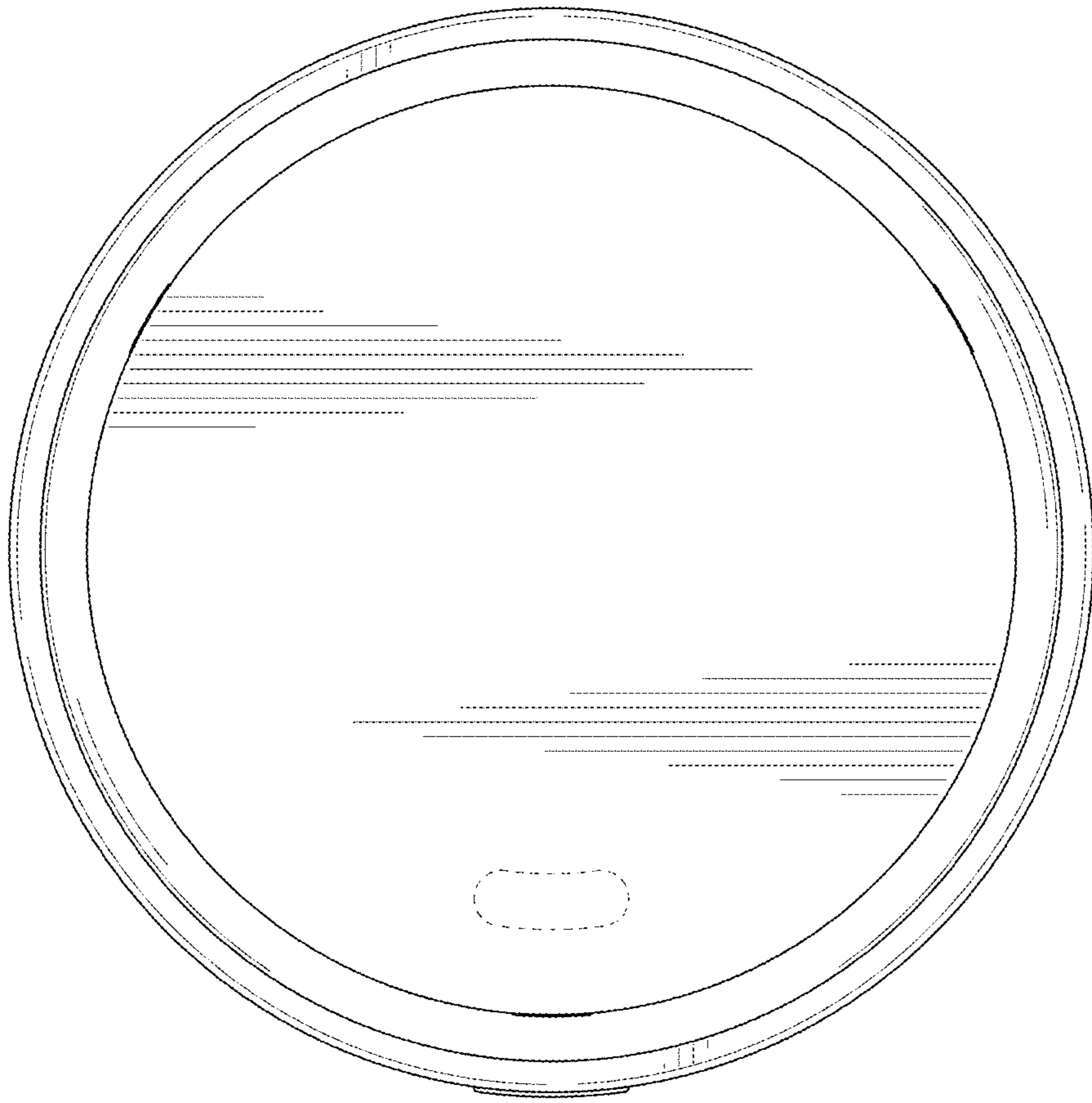

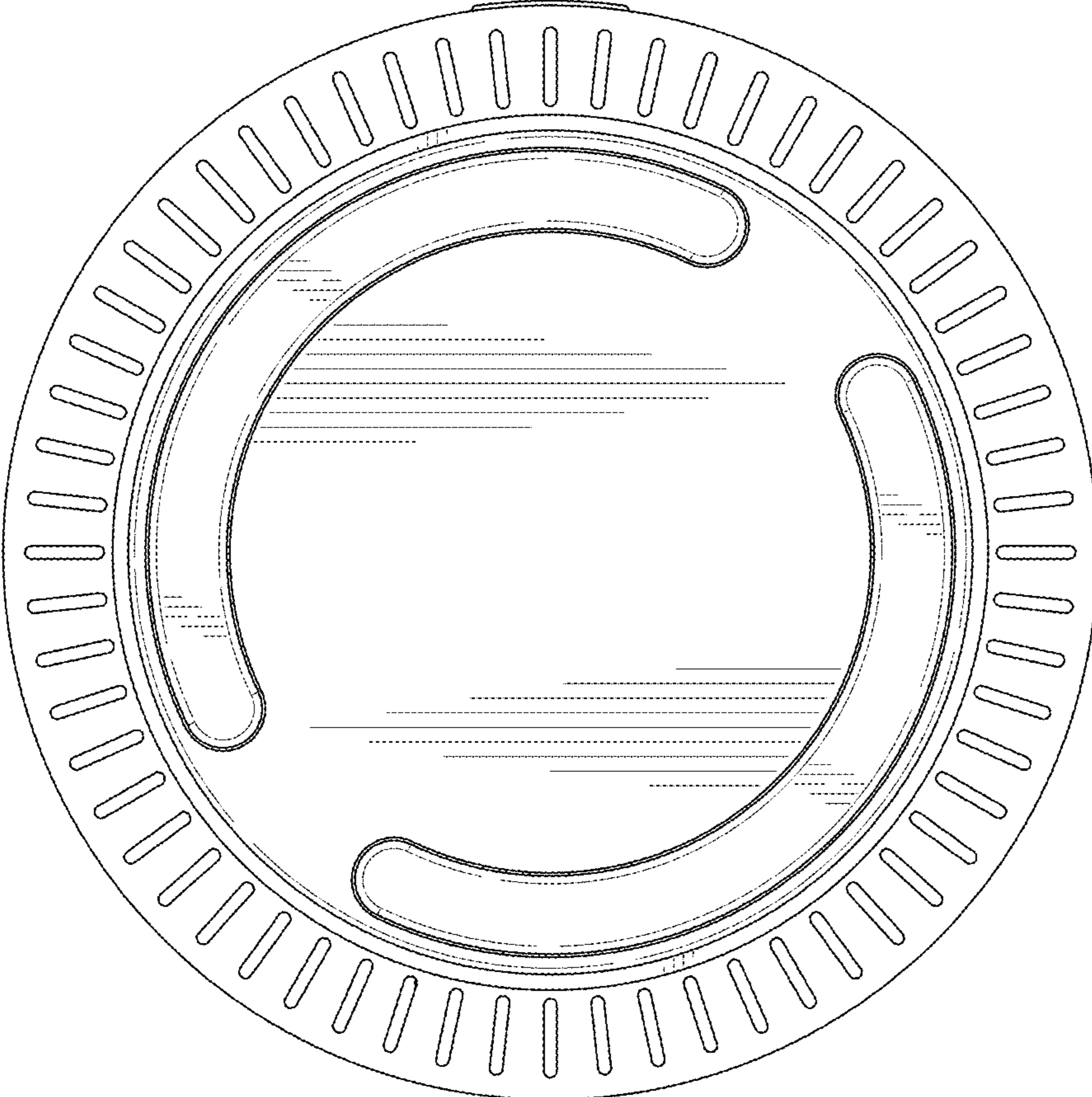
