The ornamental design for a collapsible pet bowl, as shown and described.

DESCRIPTION

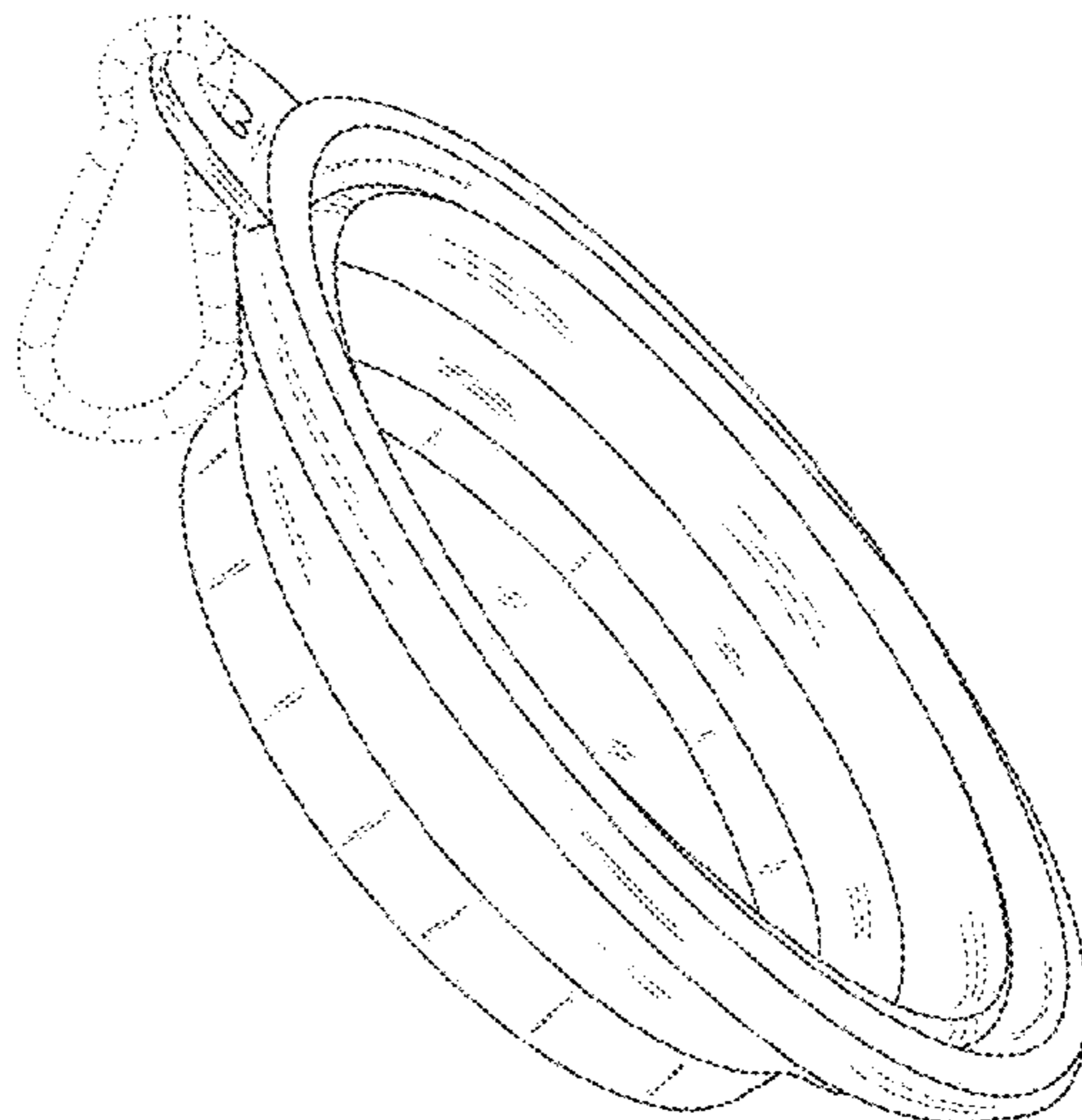
FIG. 1 is a perspective view of a collapsible pet bowl according to my new design;

 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side devotional view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top plan view thereof; and,
 FIG. 8 is a bottom plan view thereof.
 The shade lines in the Figures show contour and not surface ornamentation.
 The broken lines in the Figures show portions of the collapsible pet bowl, which form no part of the claimed design.

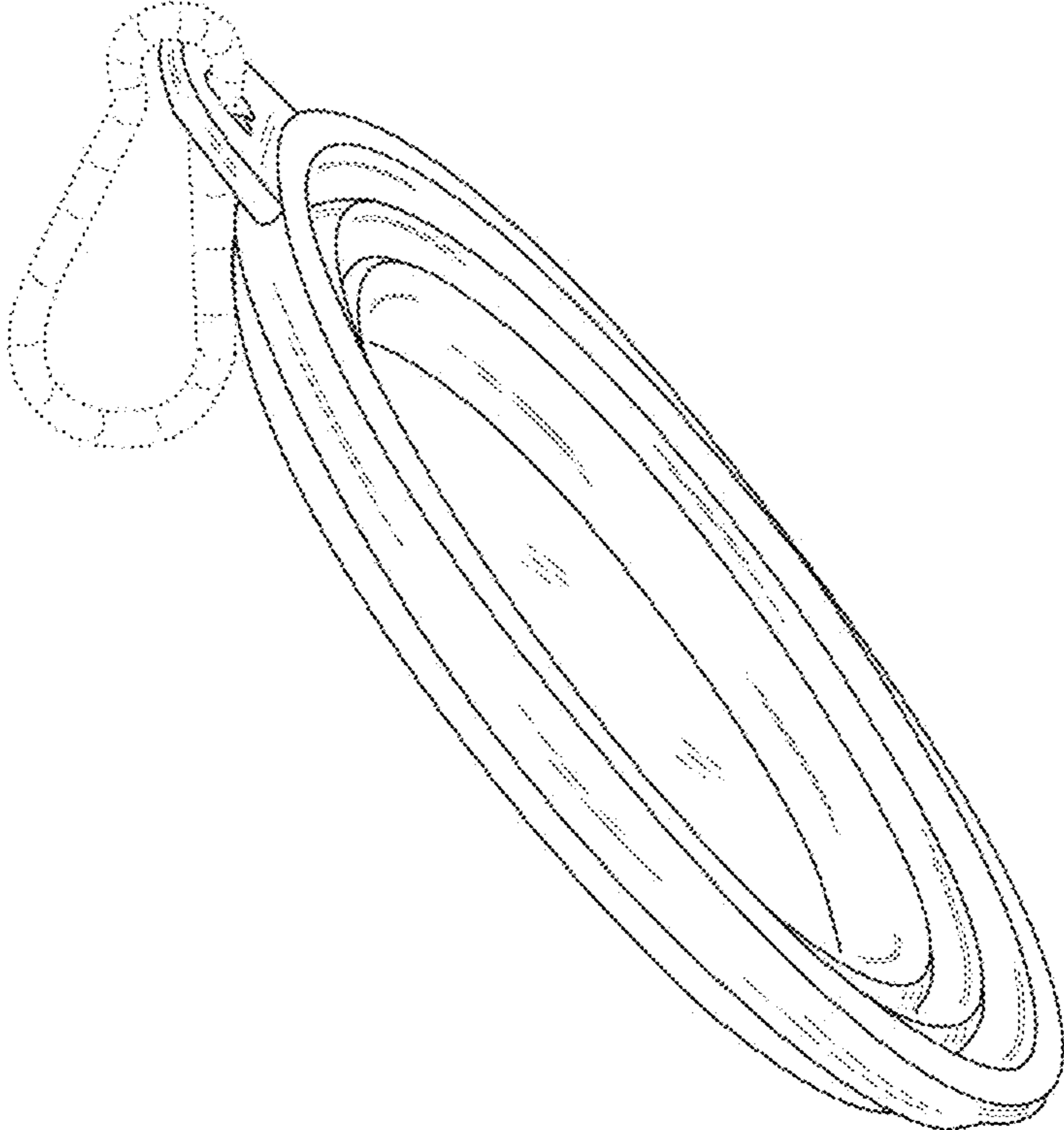

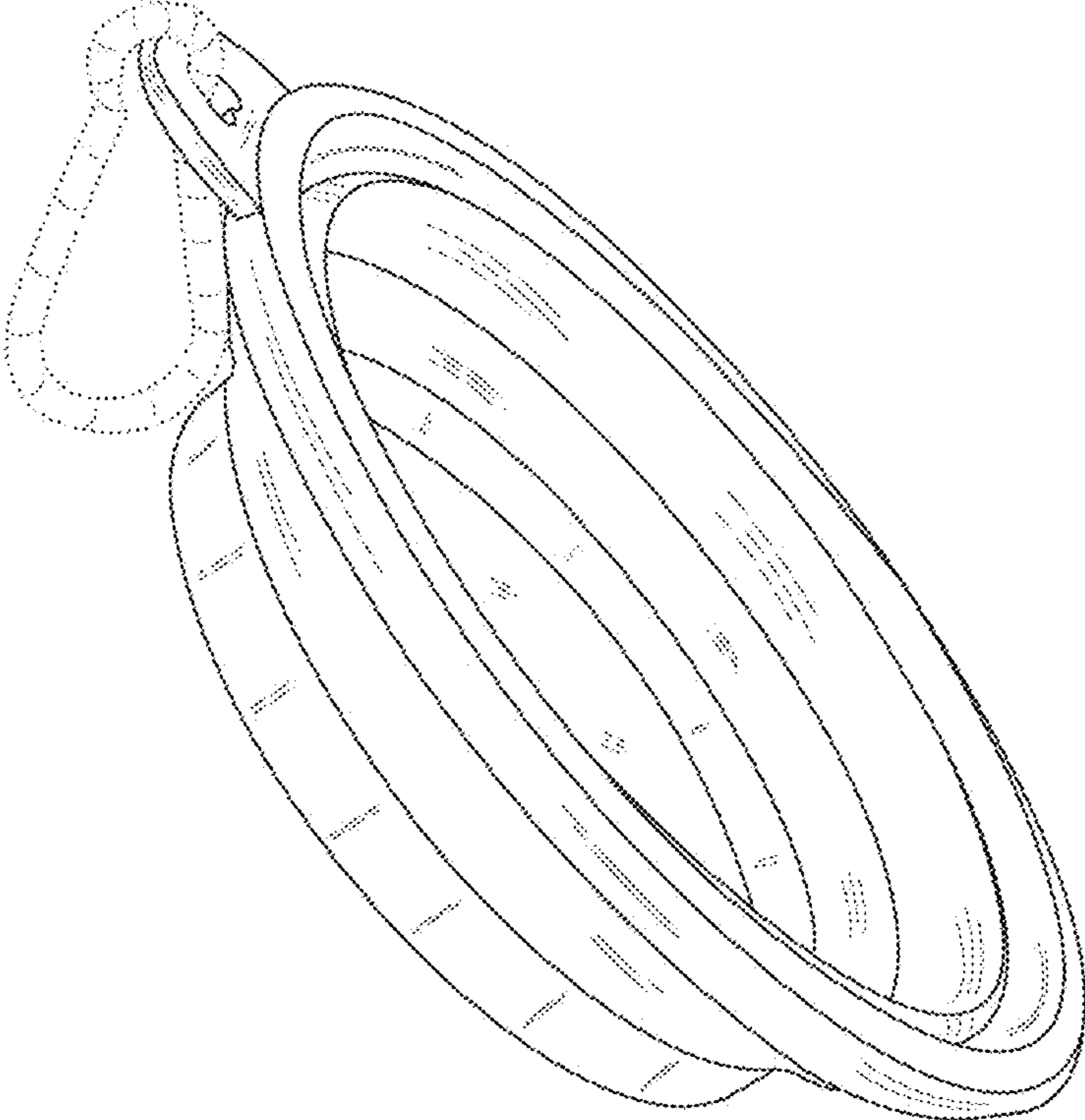

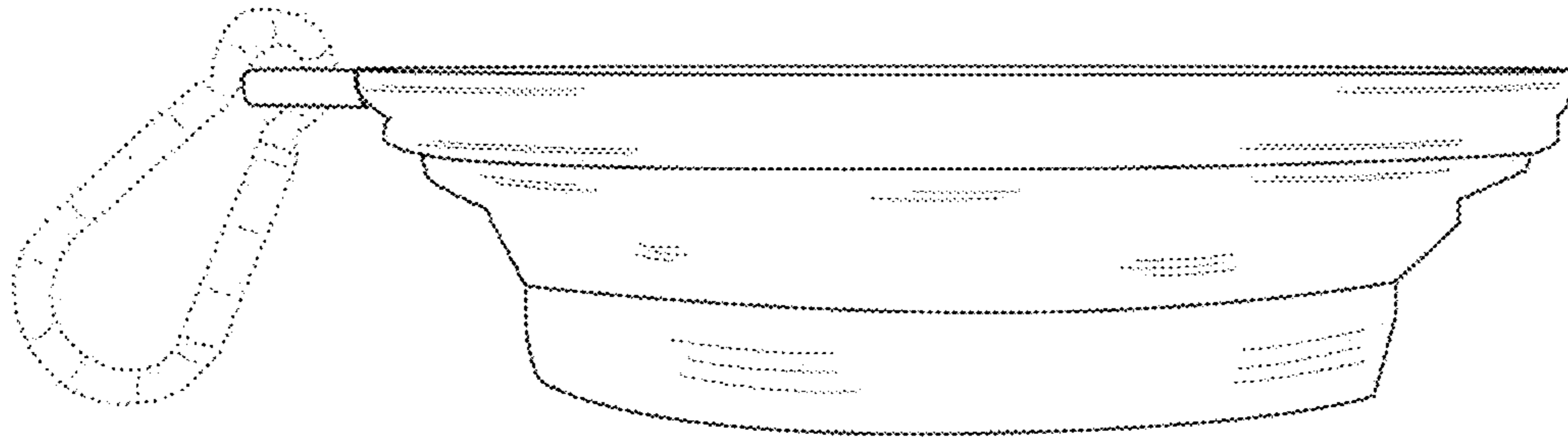

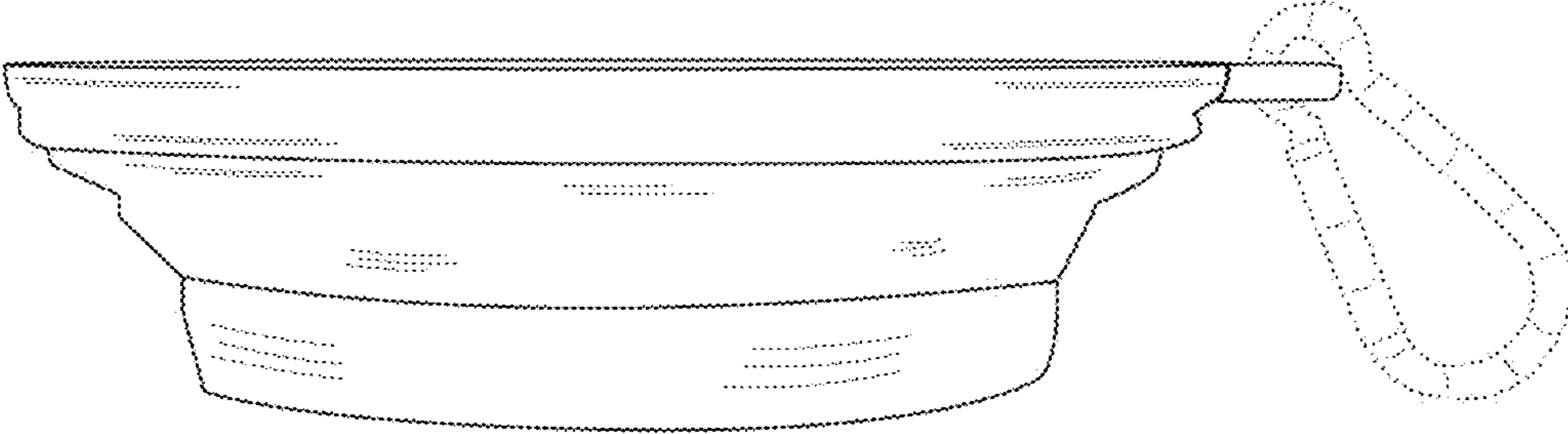

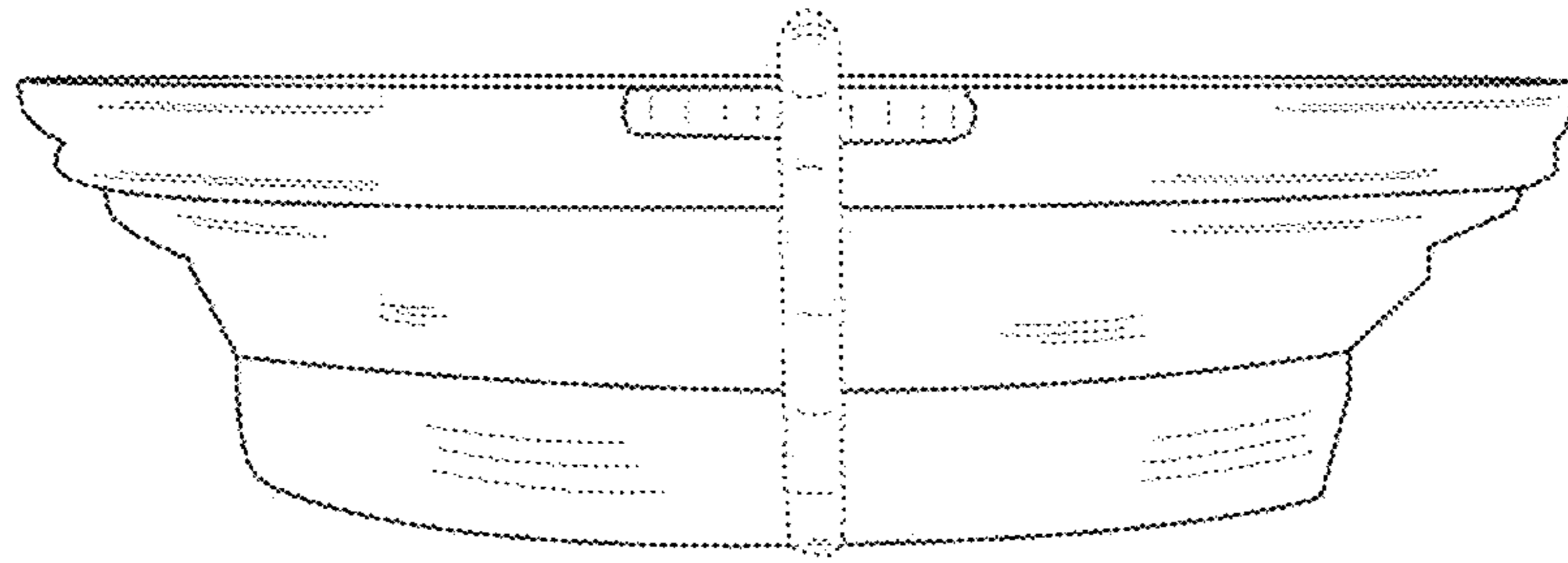

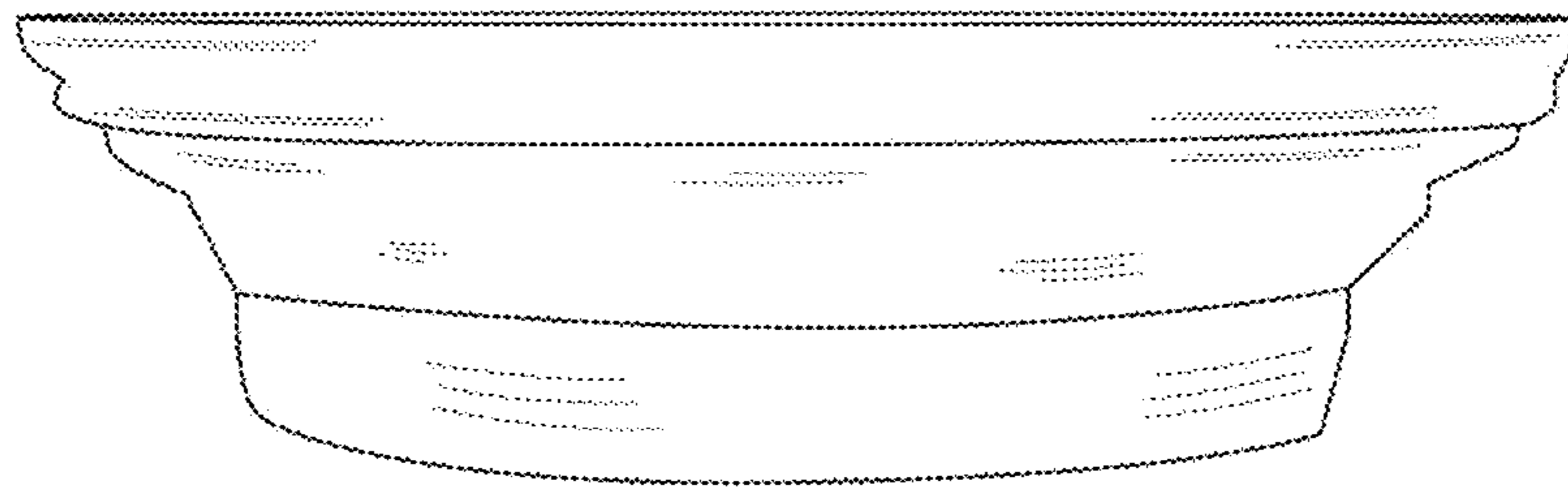

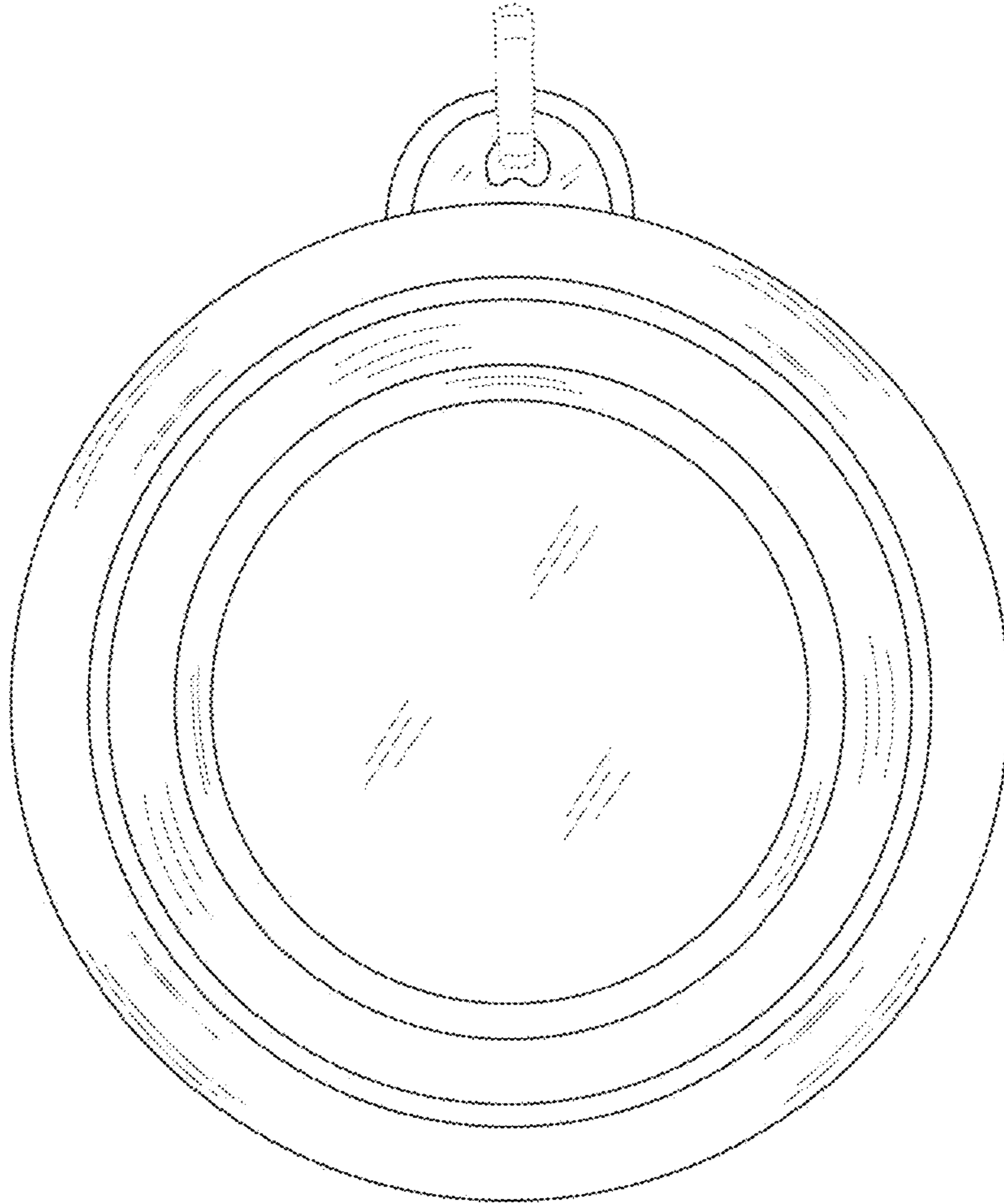

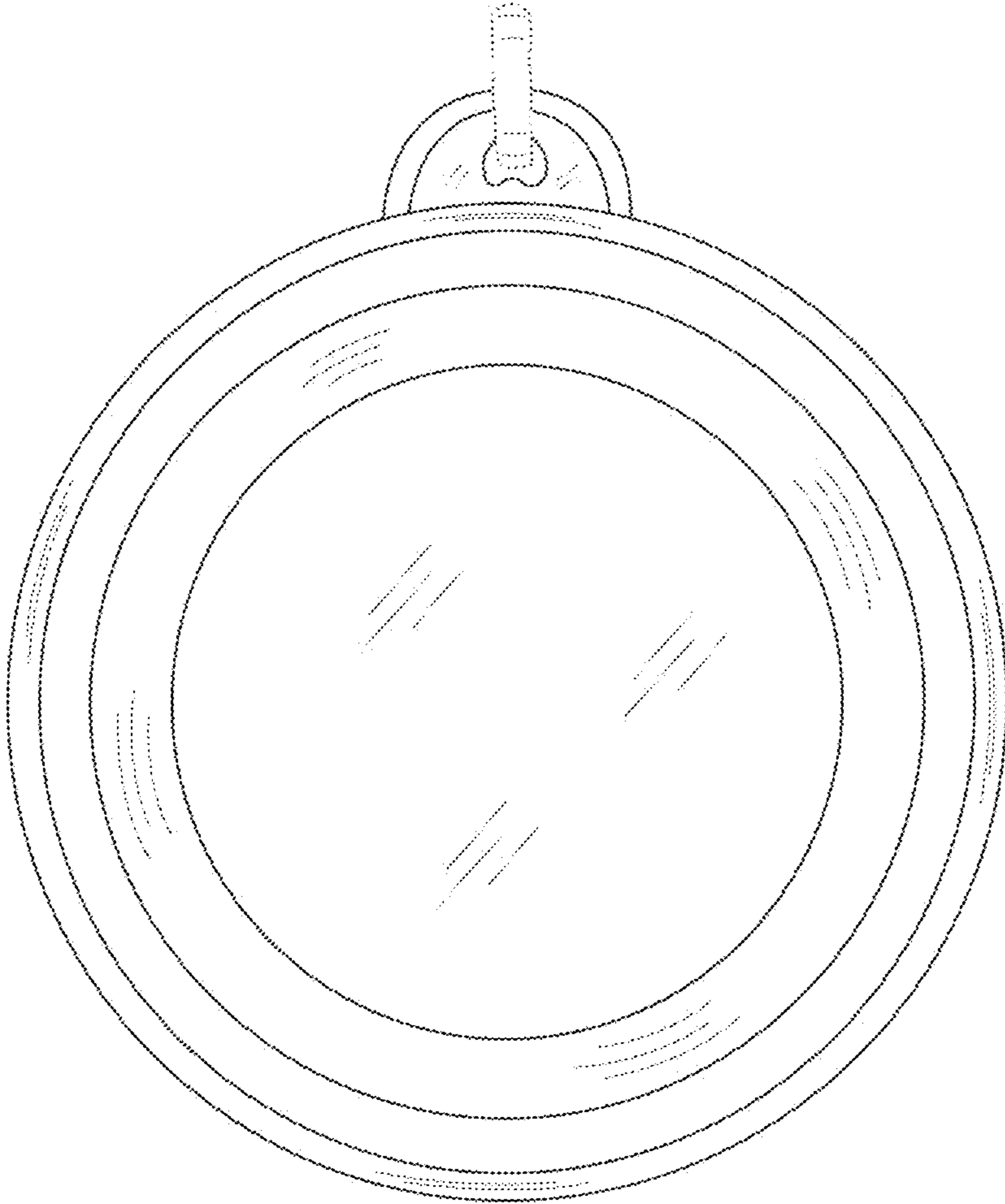
