DESCRIPTION

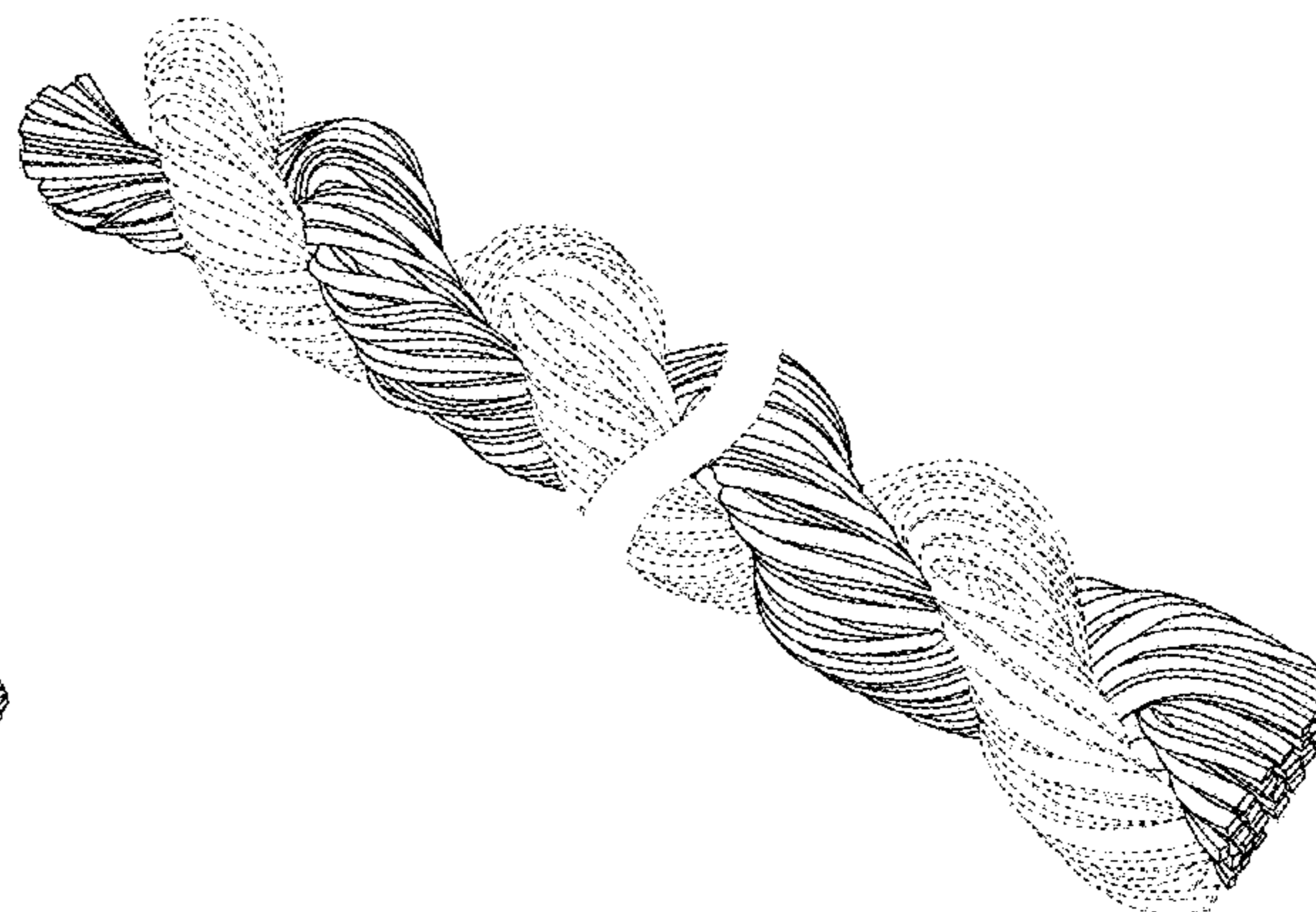
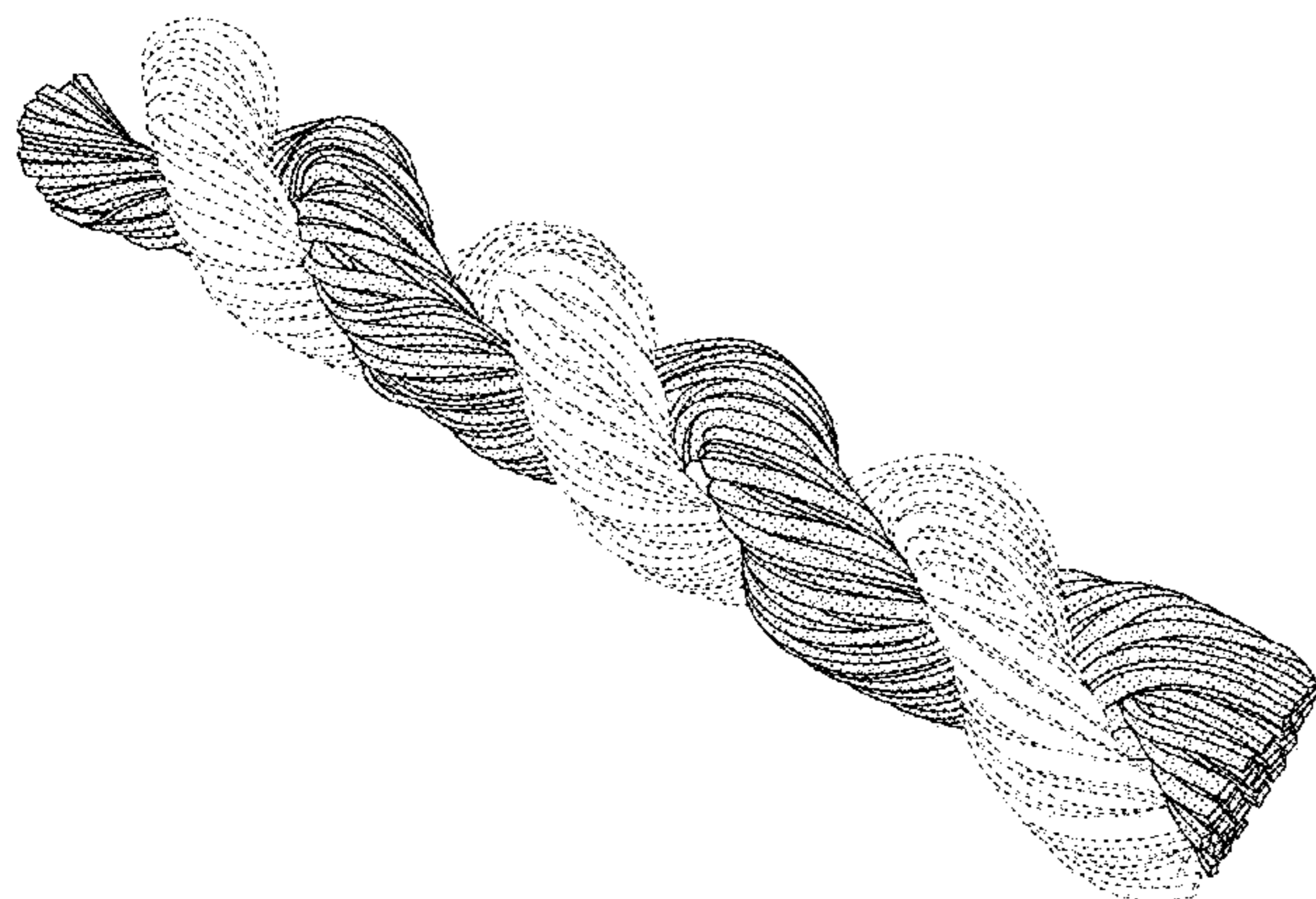


FIG. 19 is a rear elevation view of the embodiment of FIG. 17;

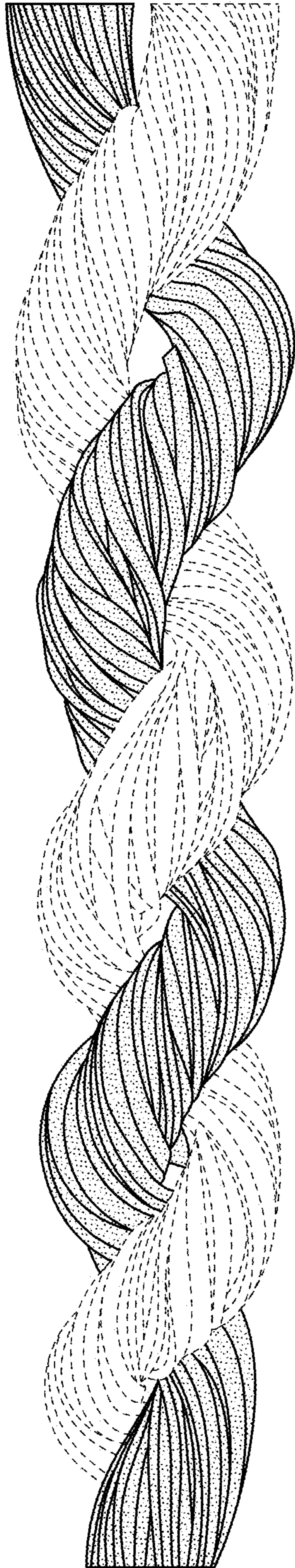

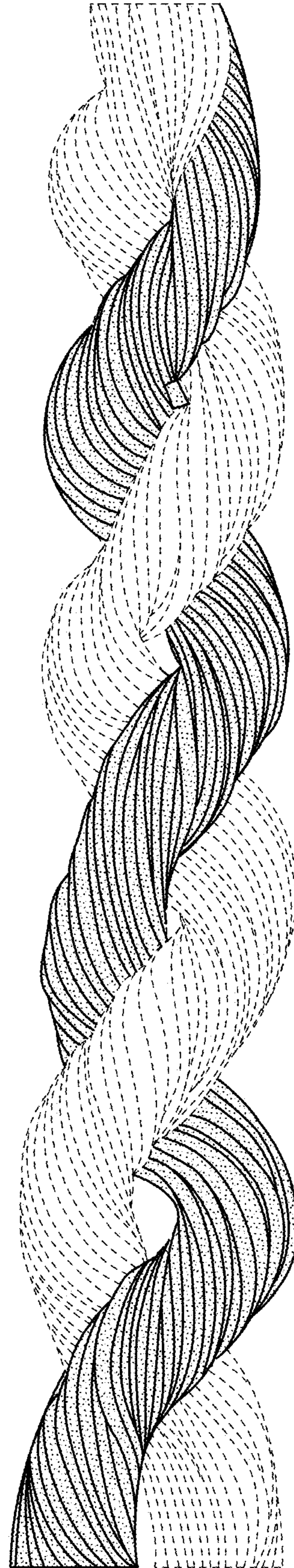

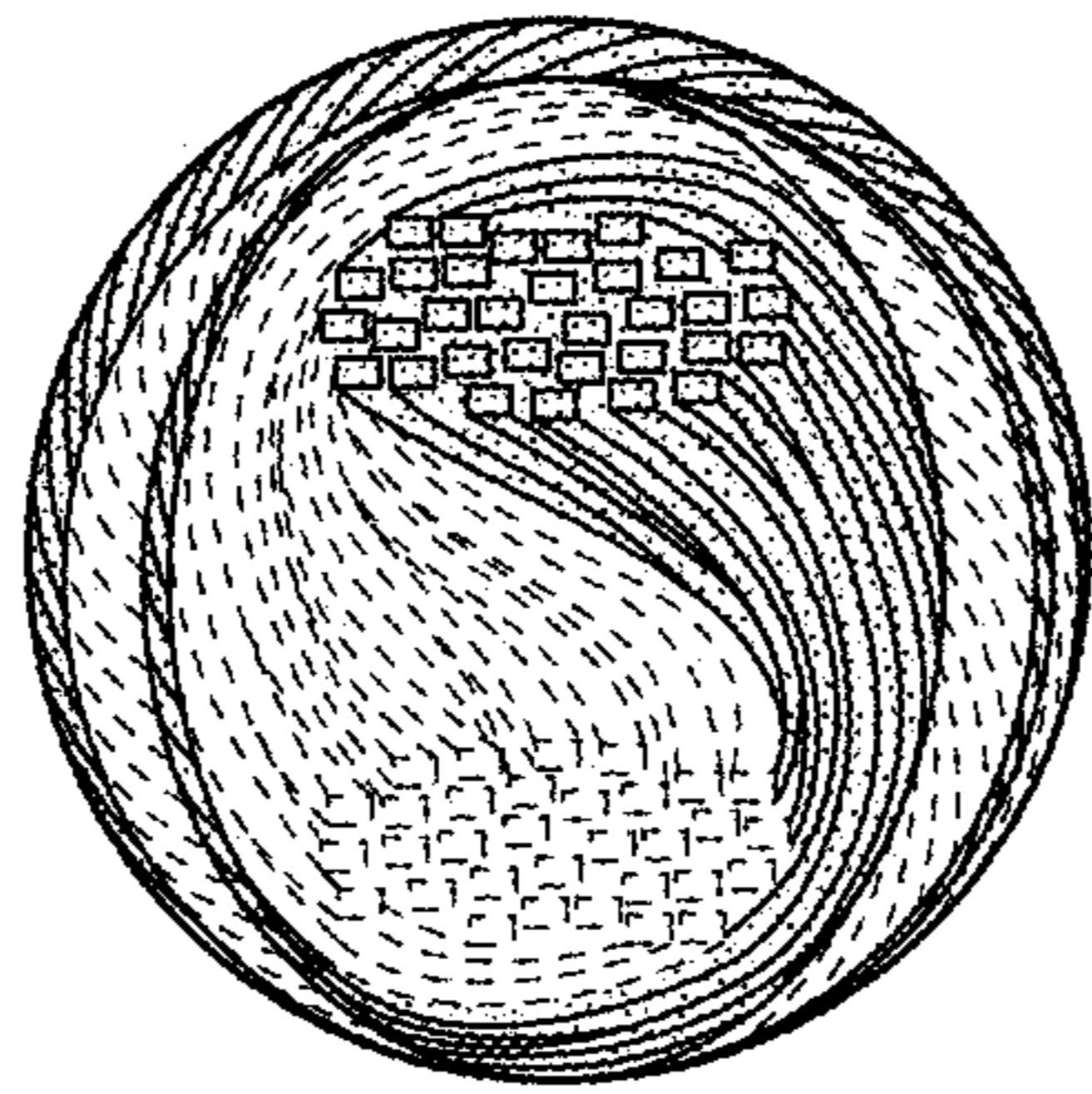

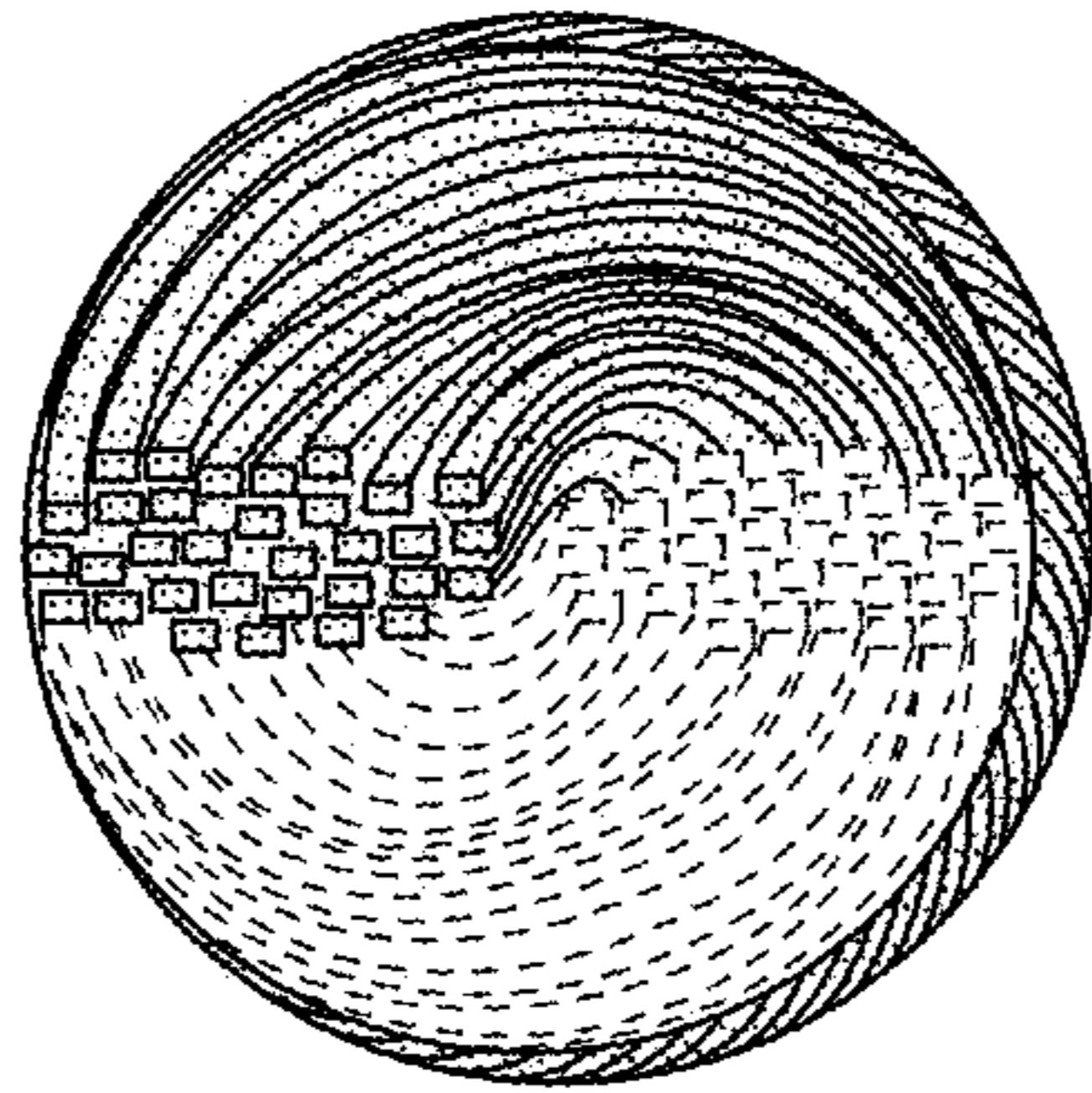

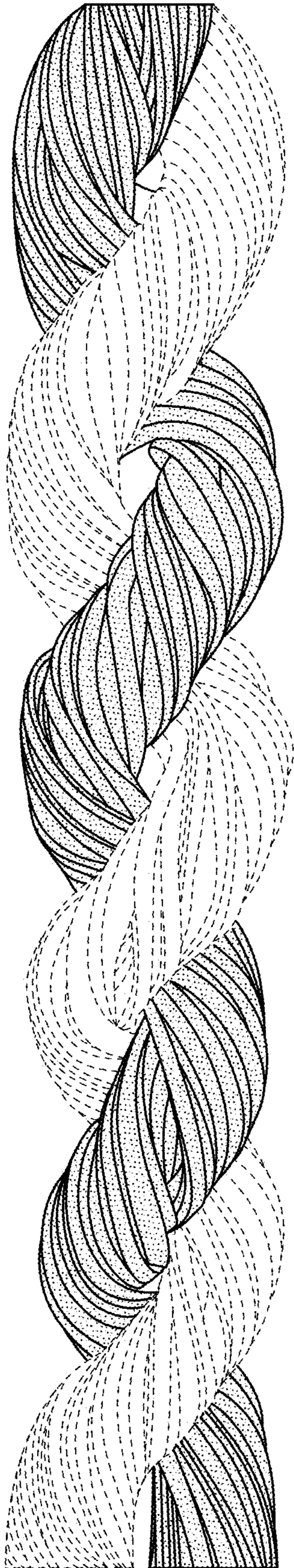

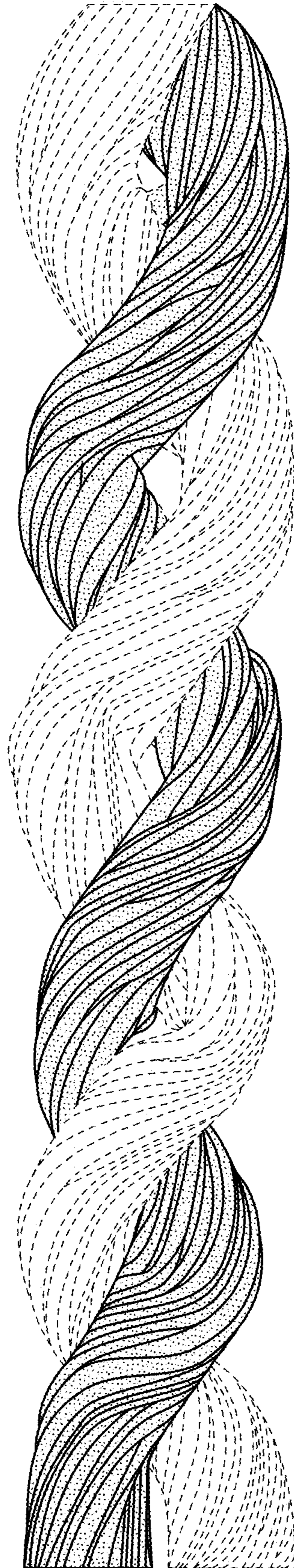

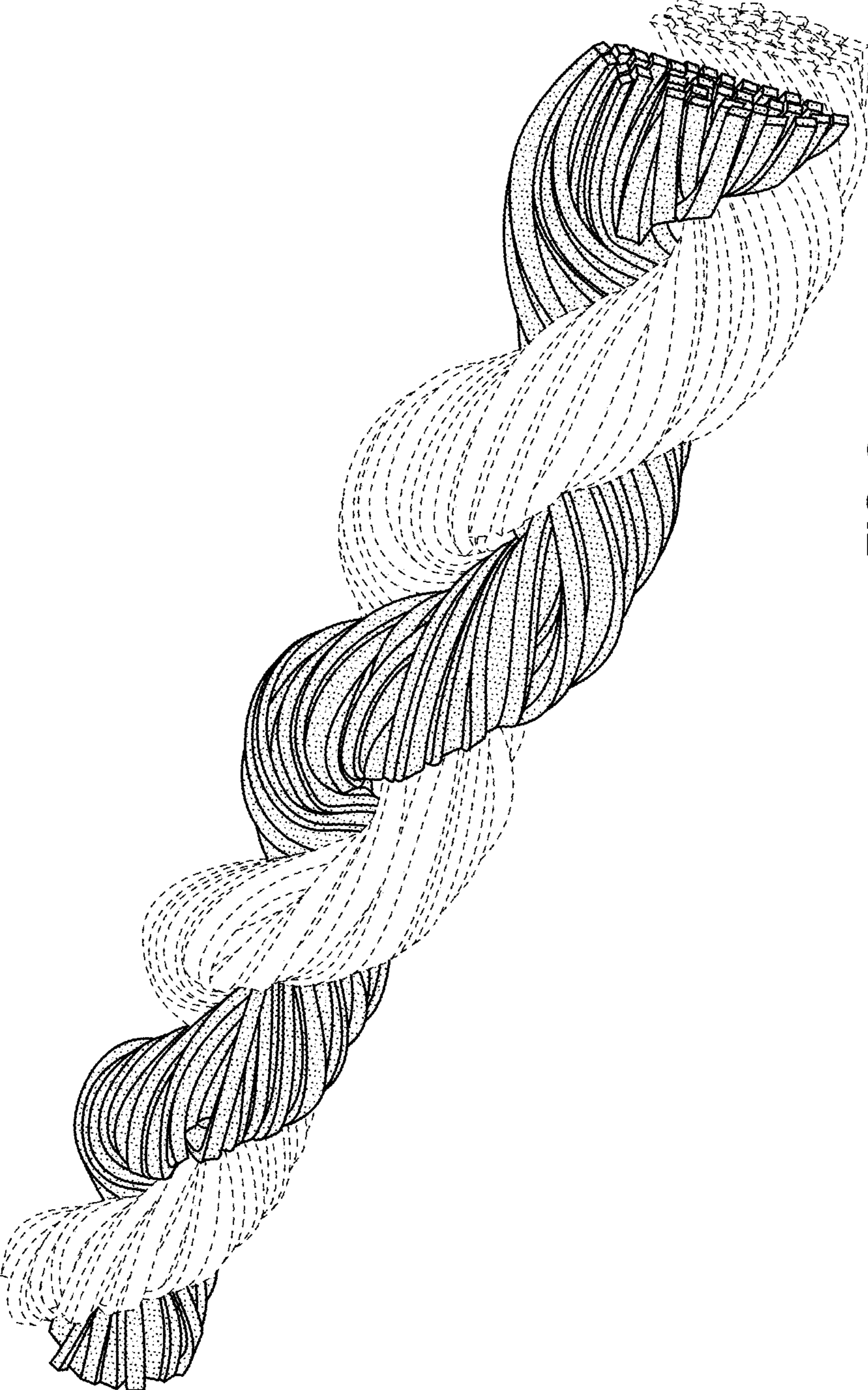

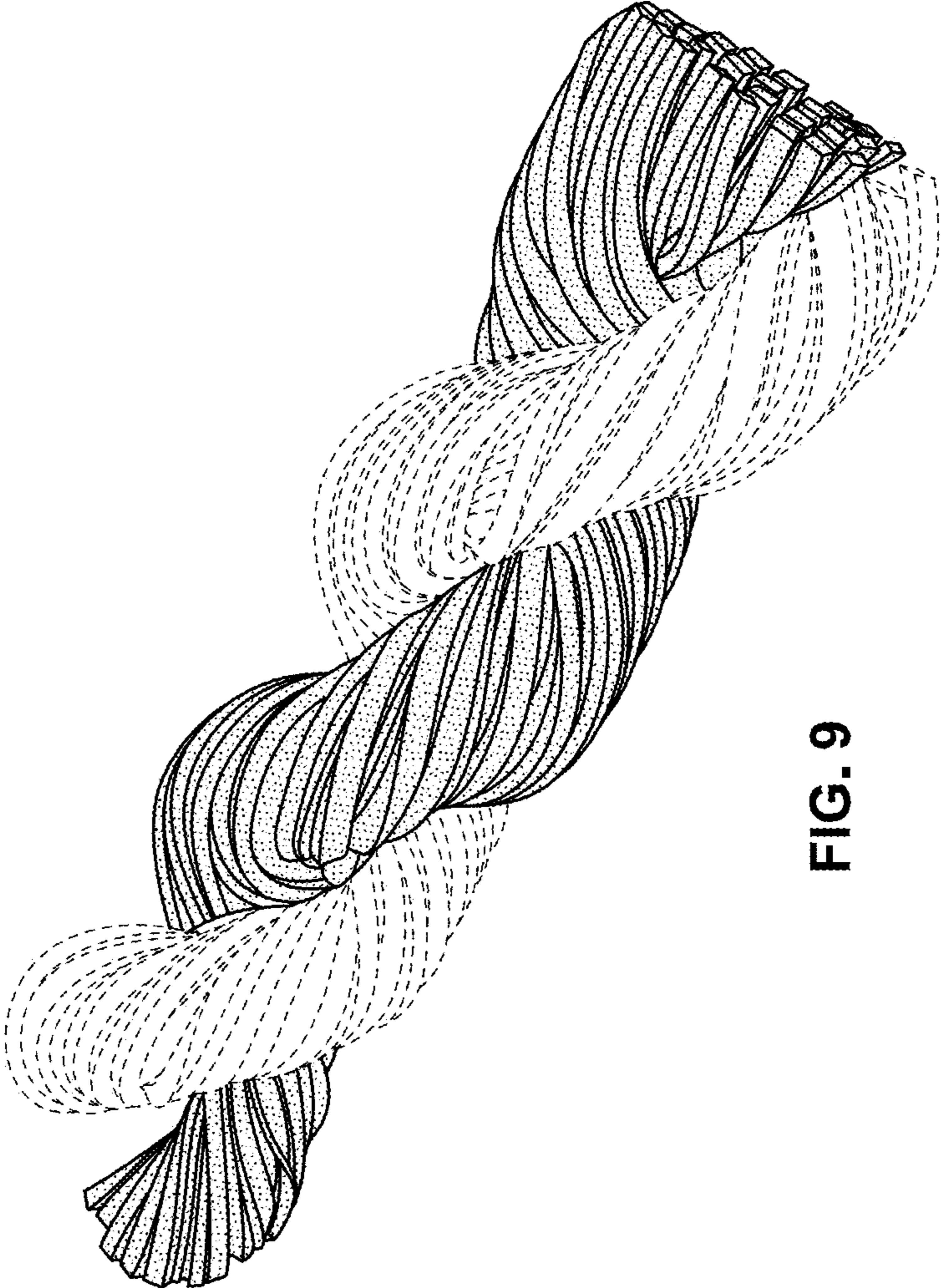

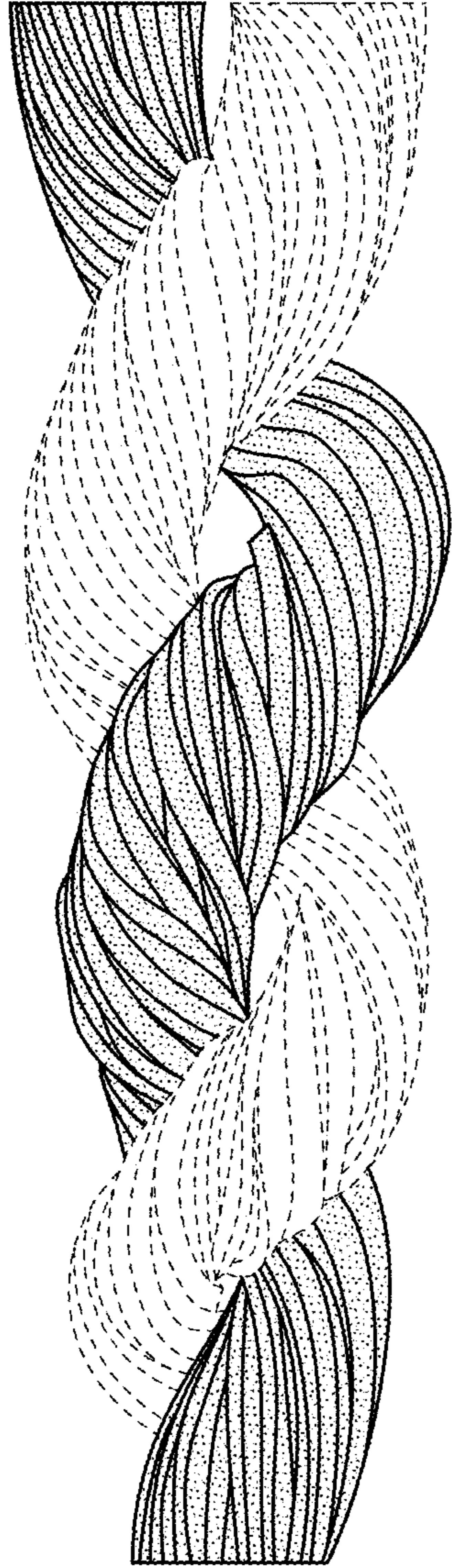

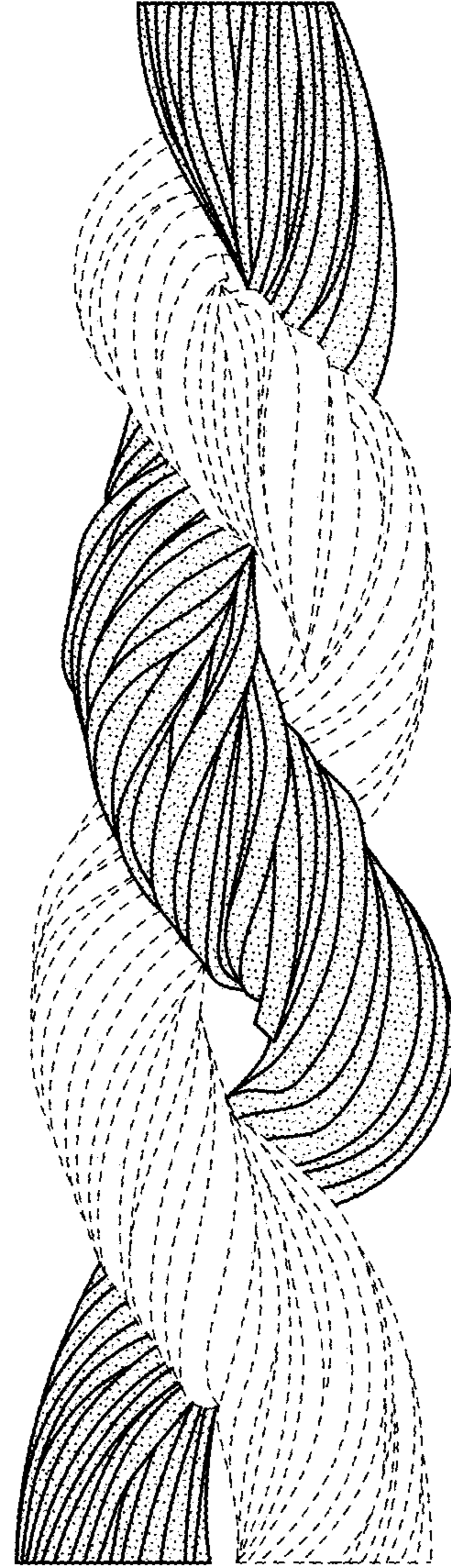

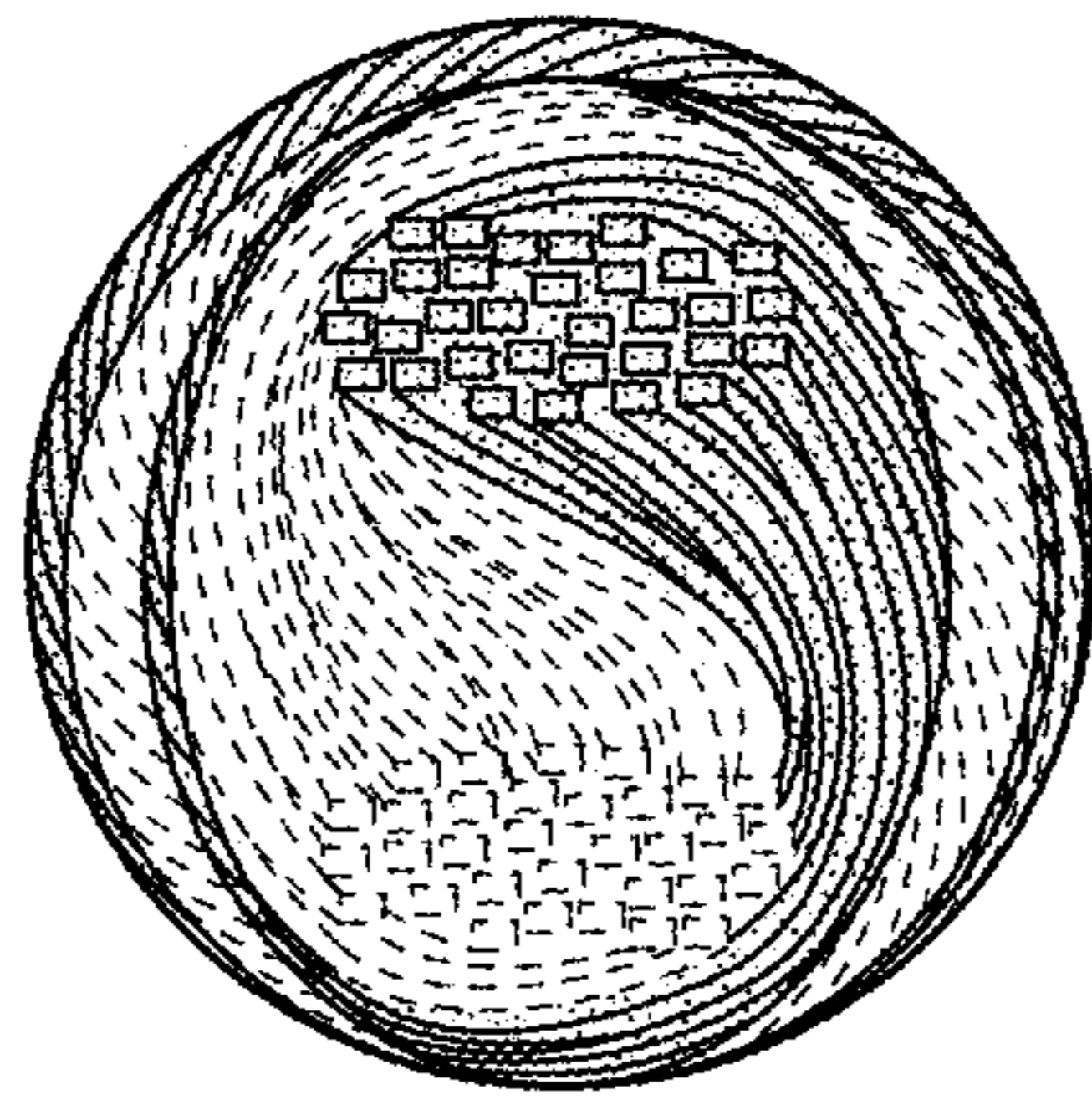

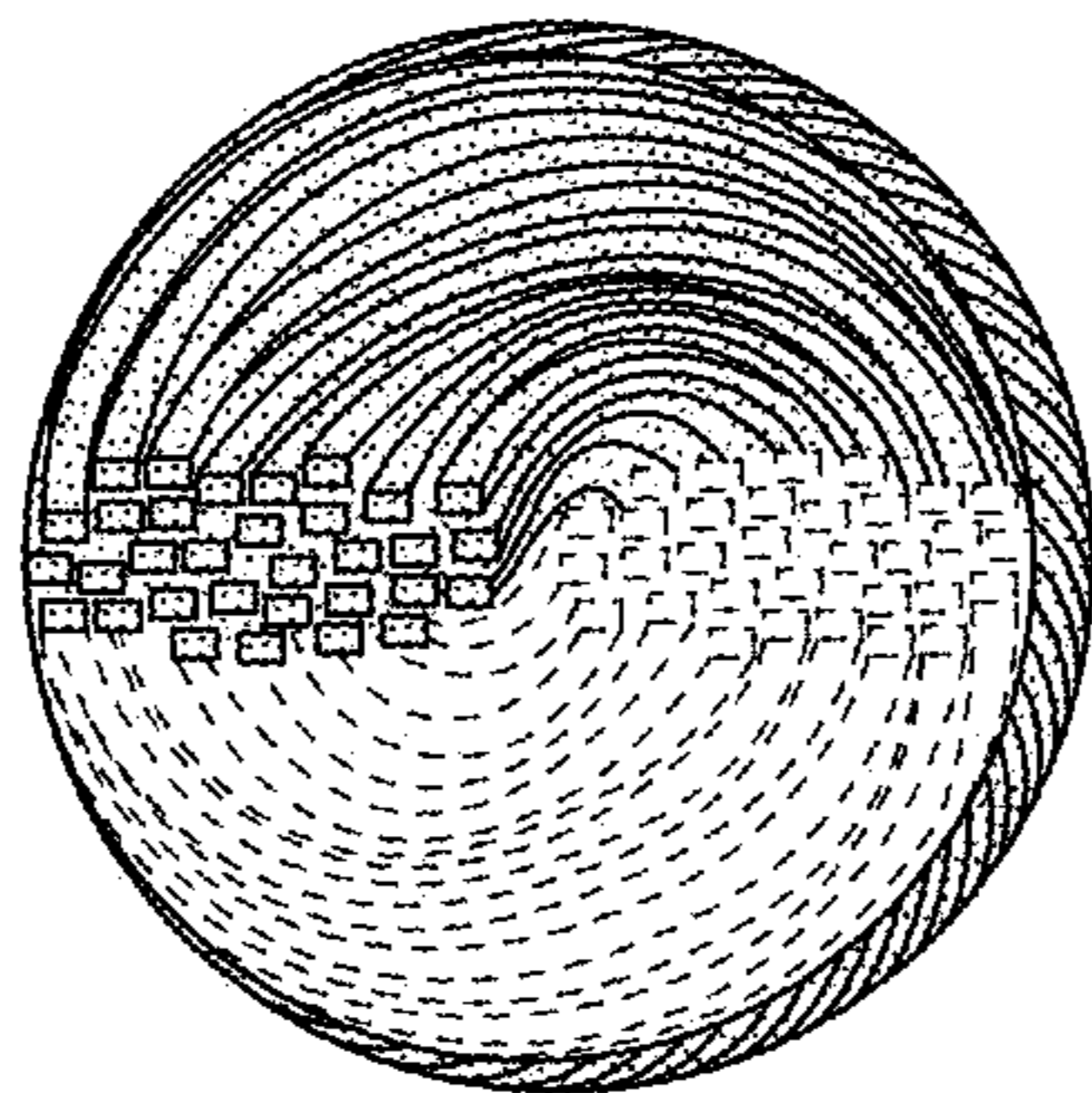

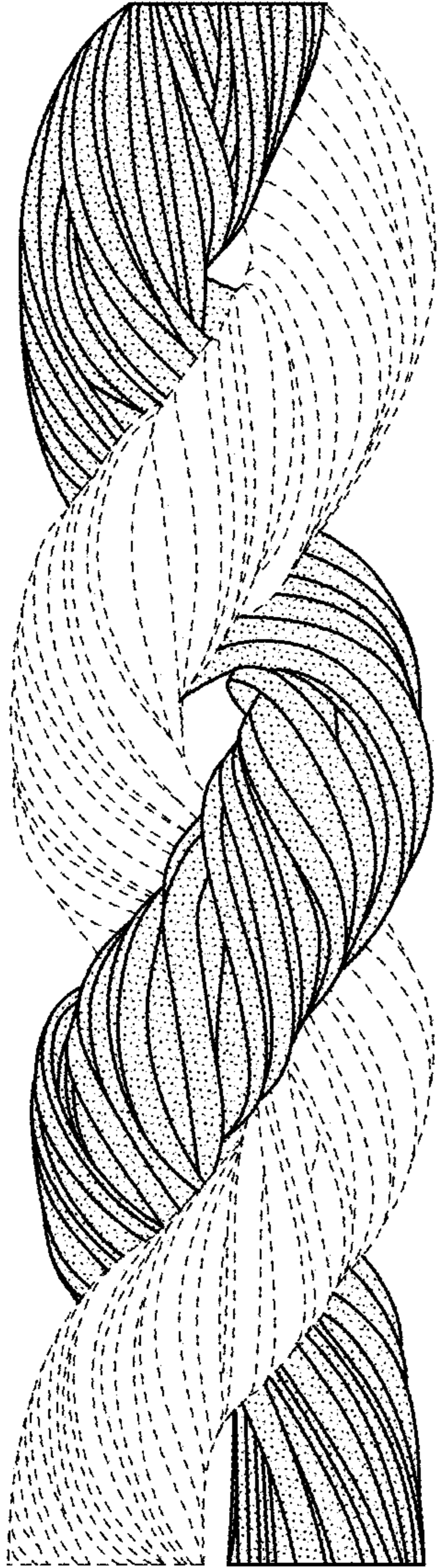

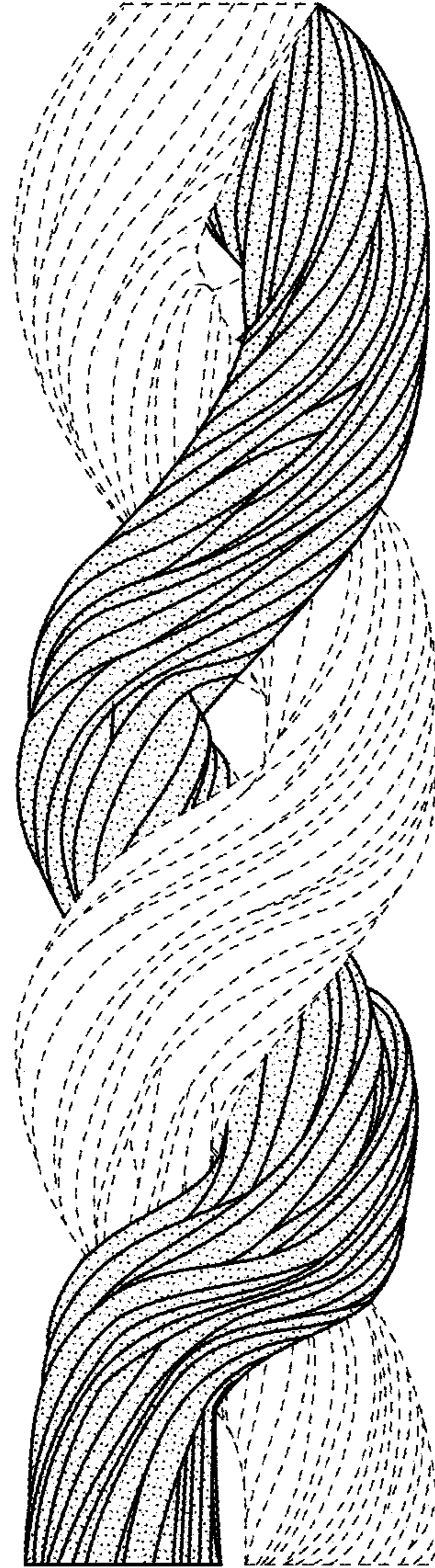

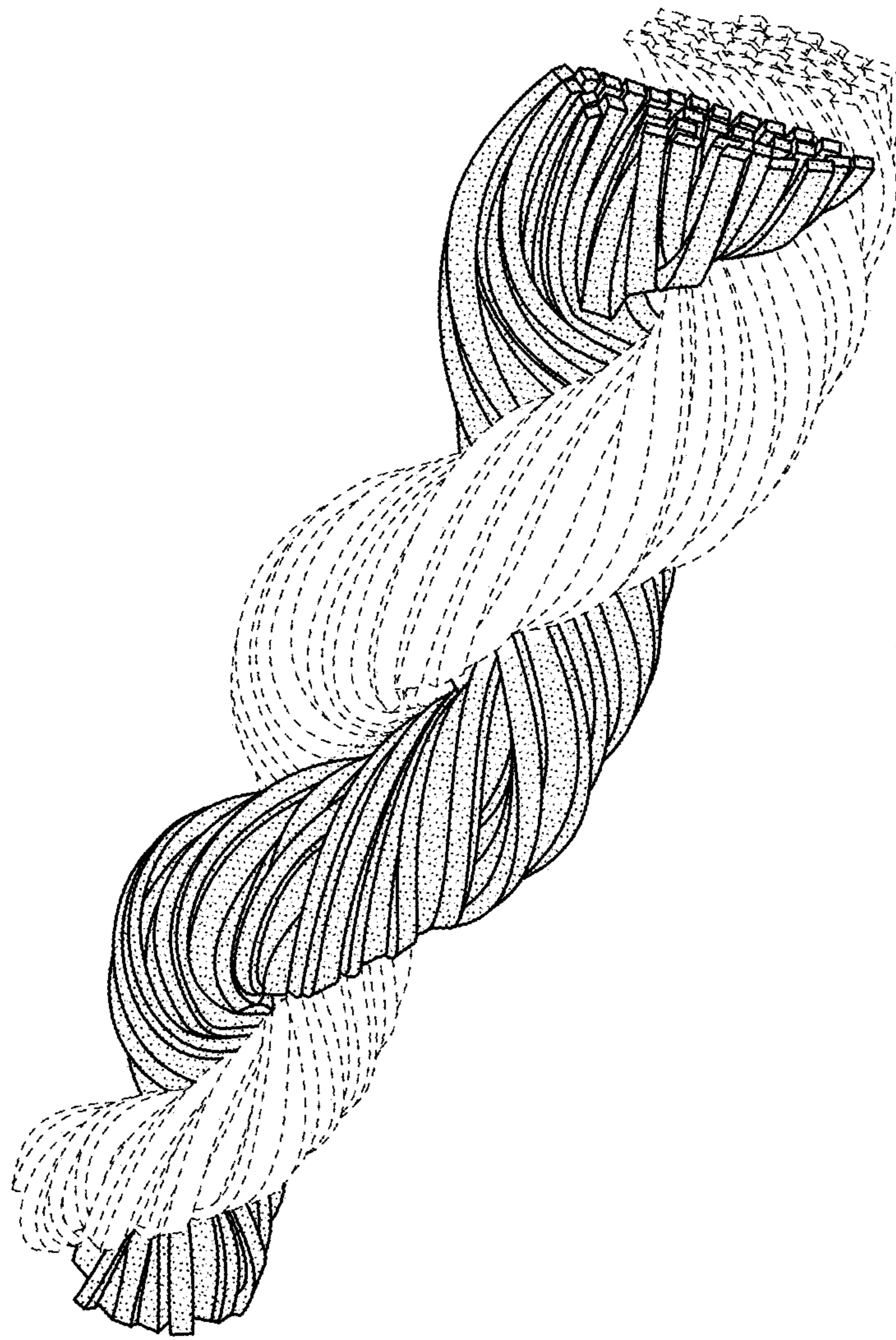

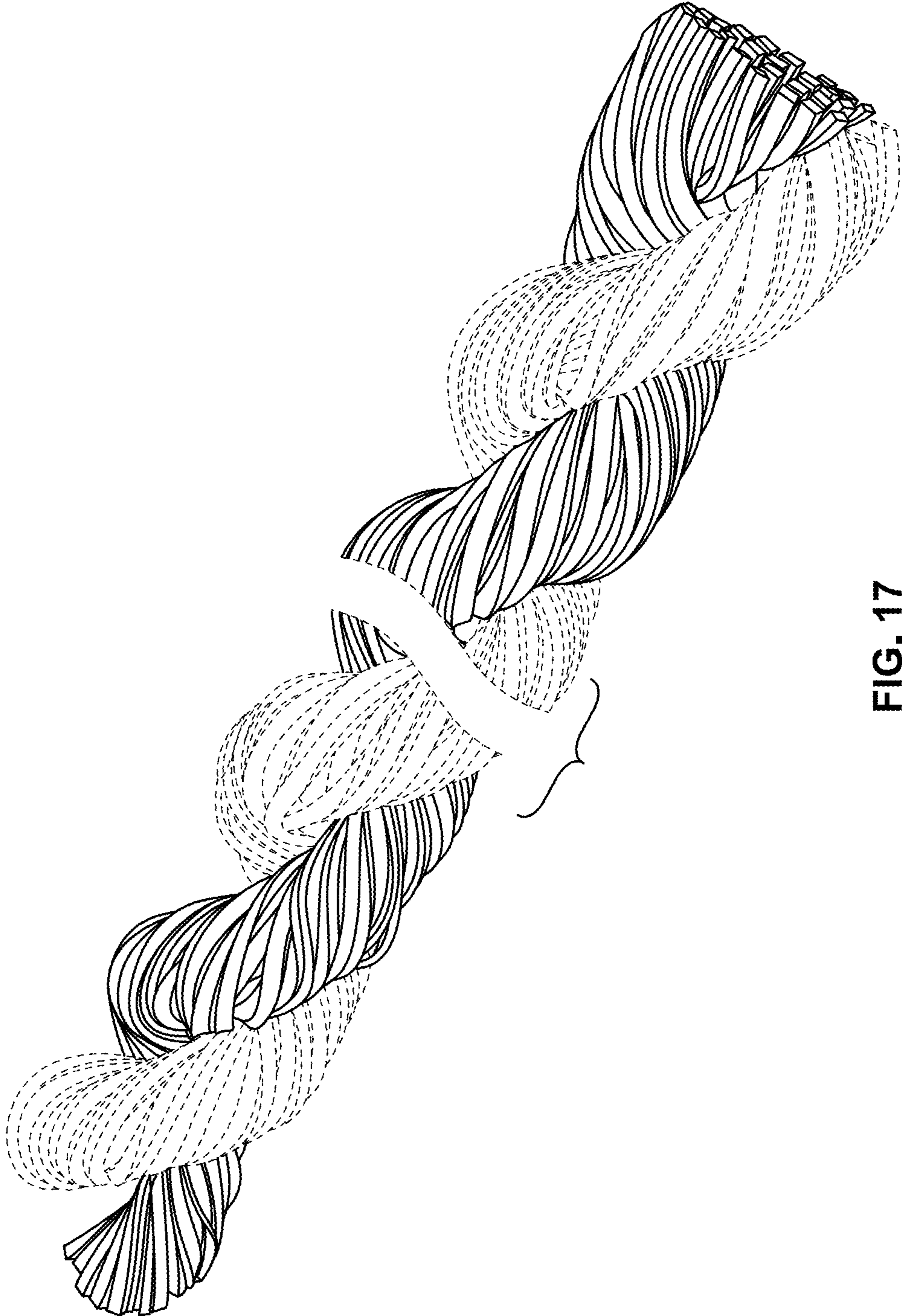

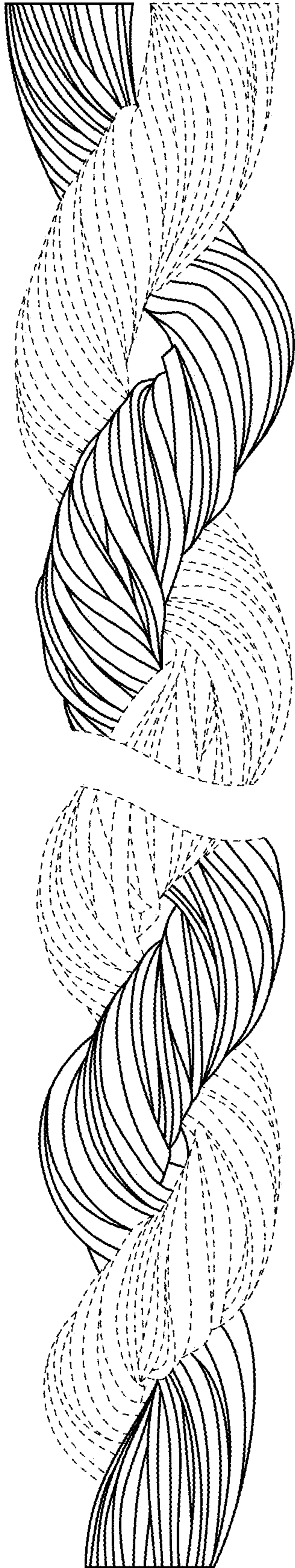

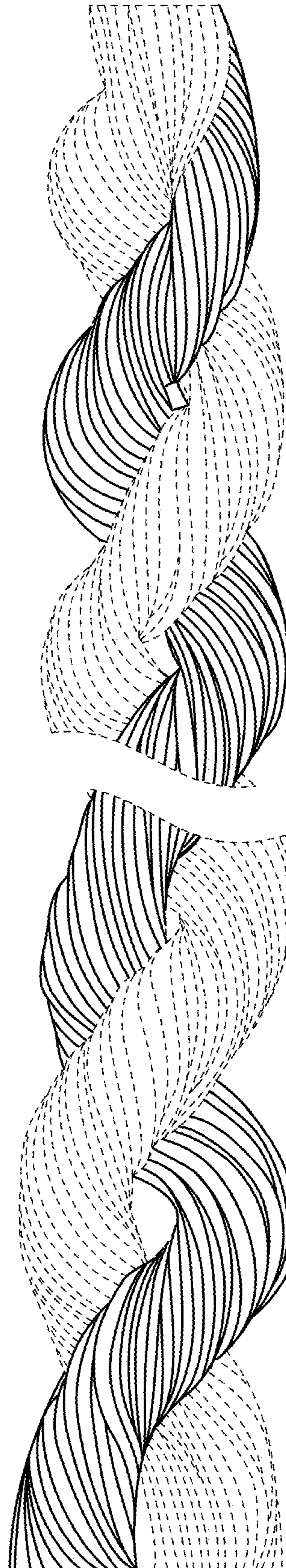

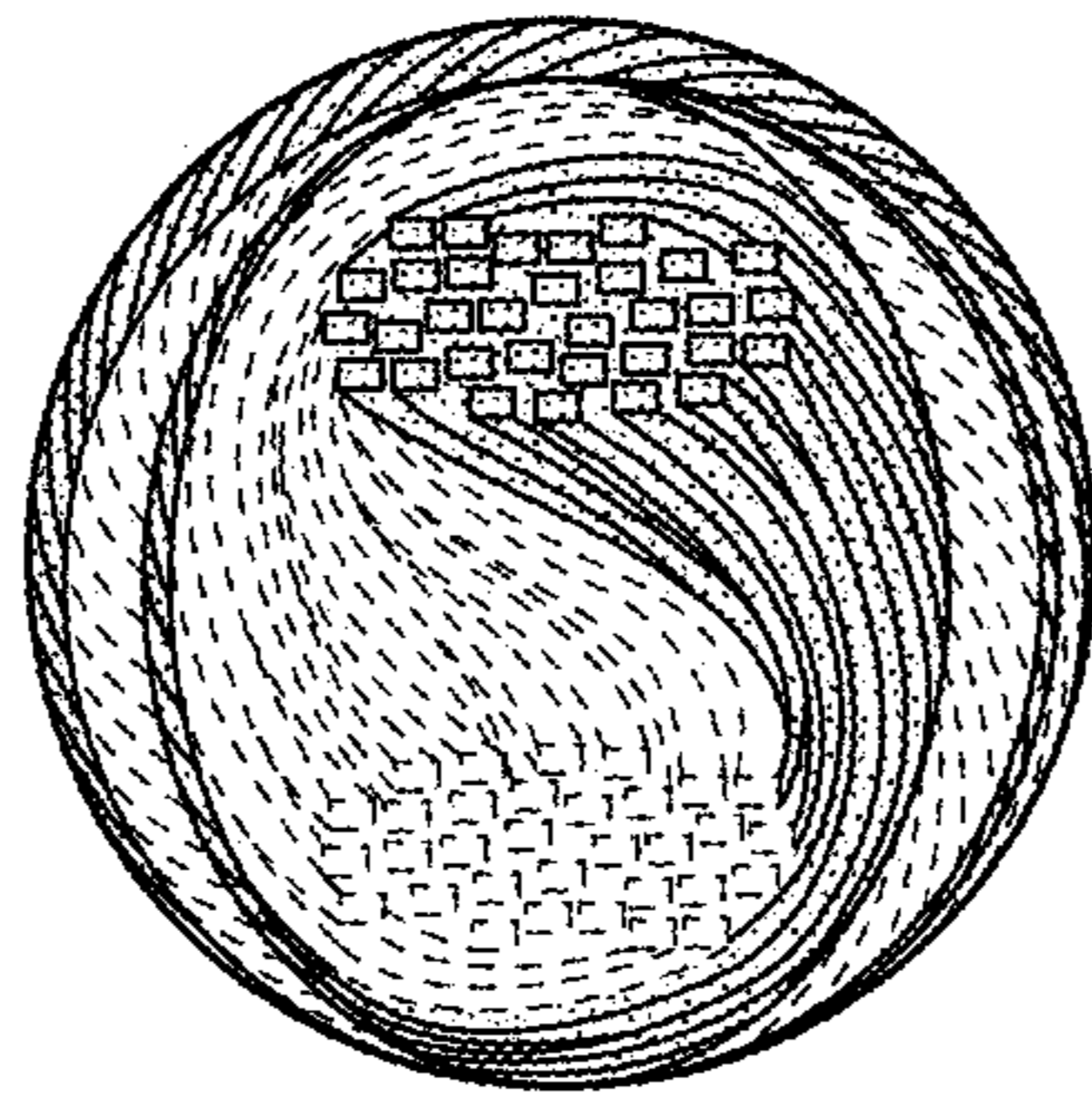

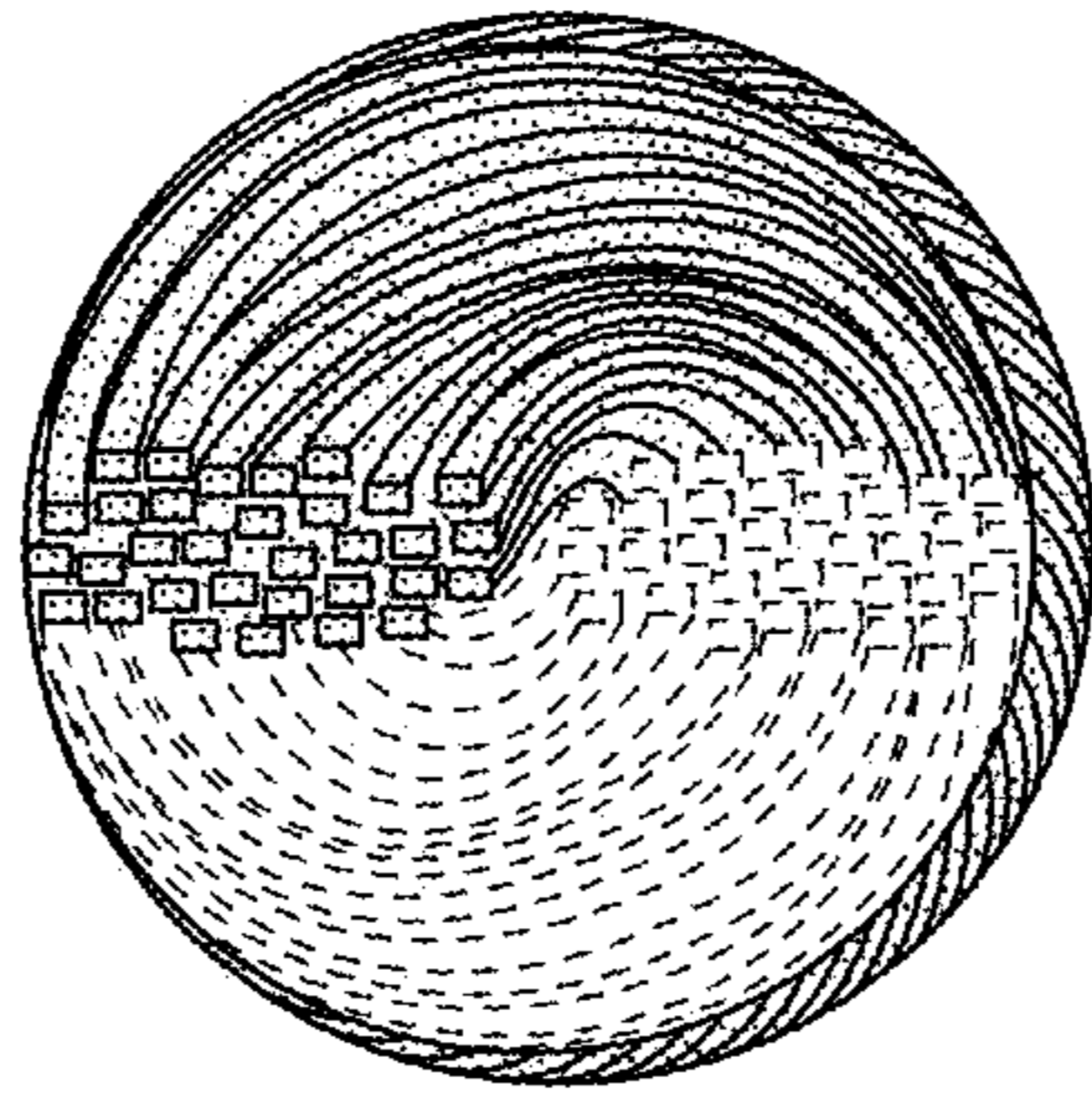

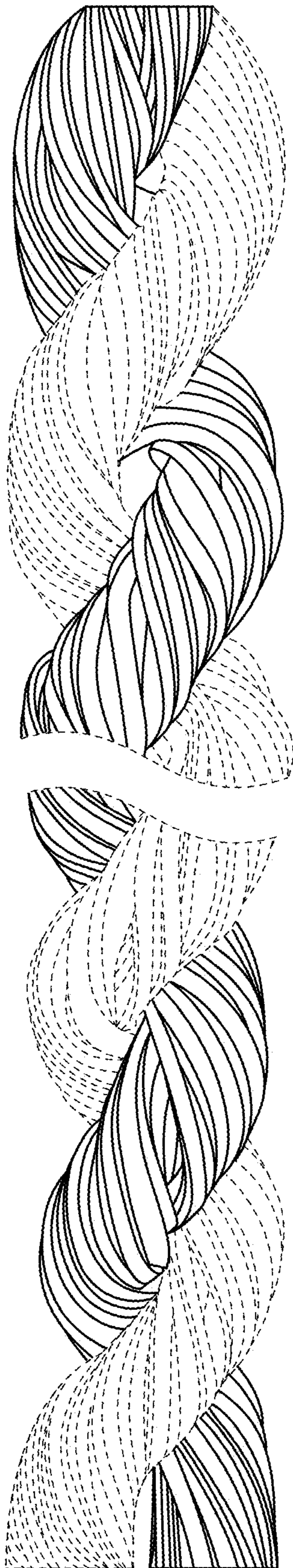

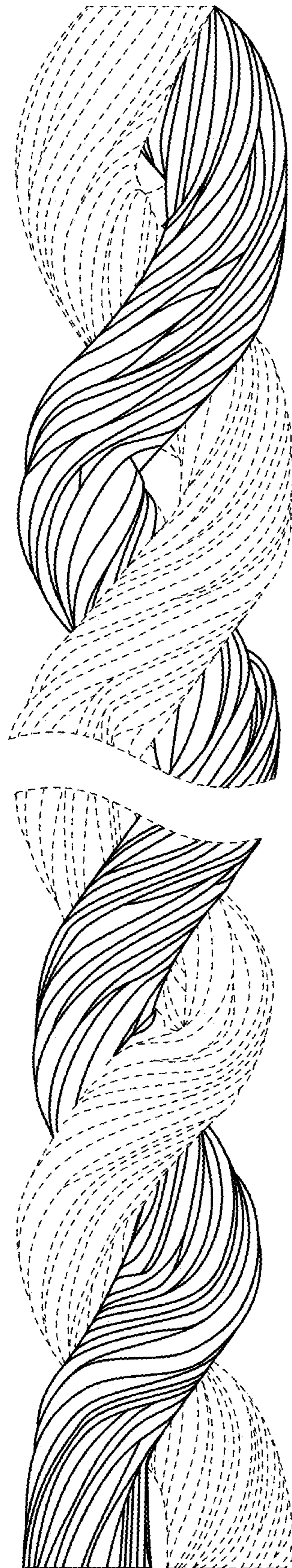

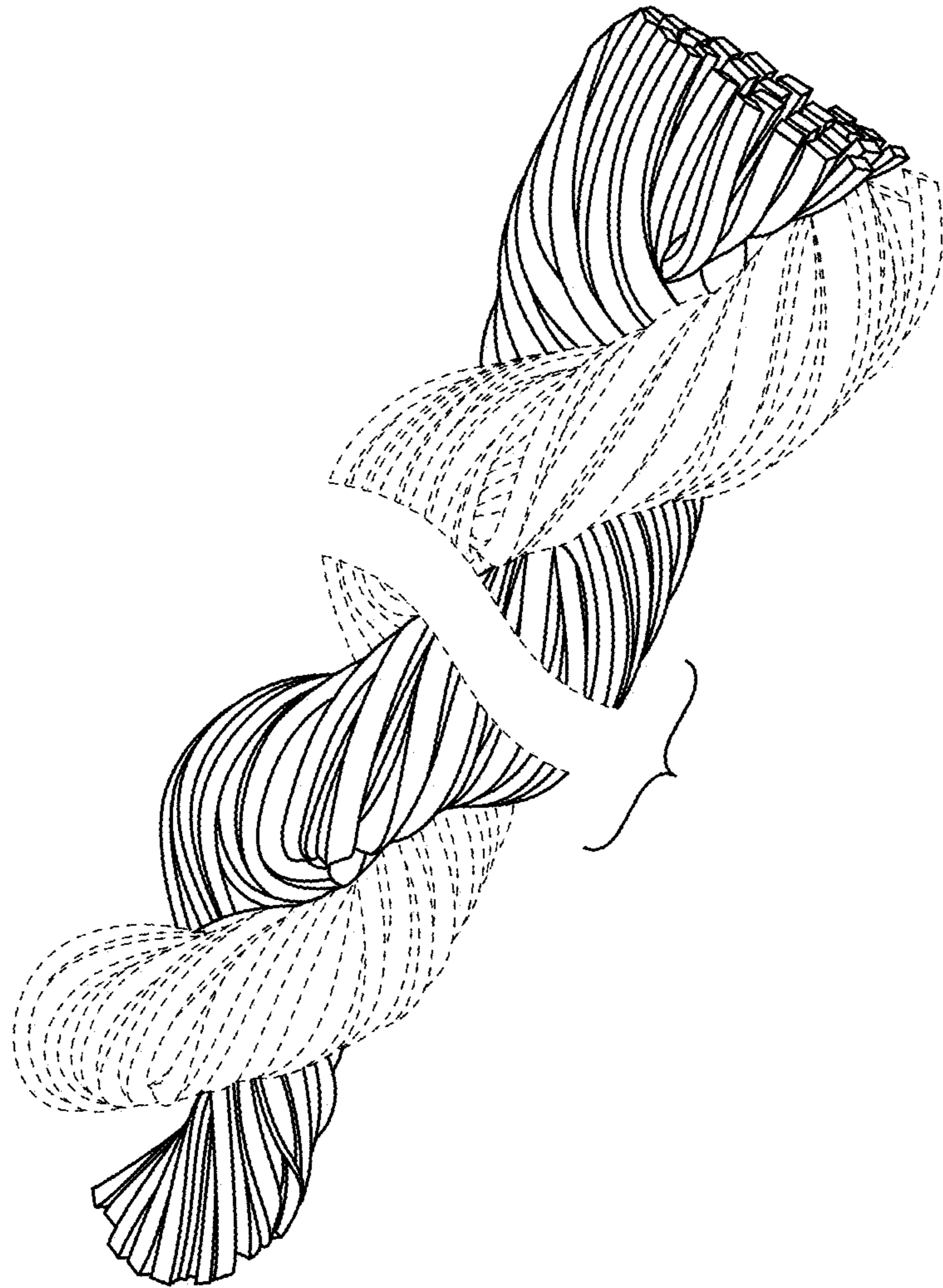

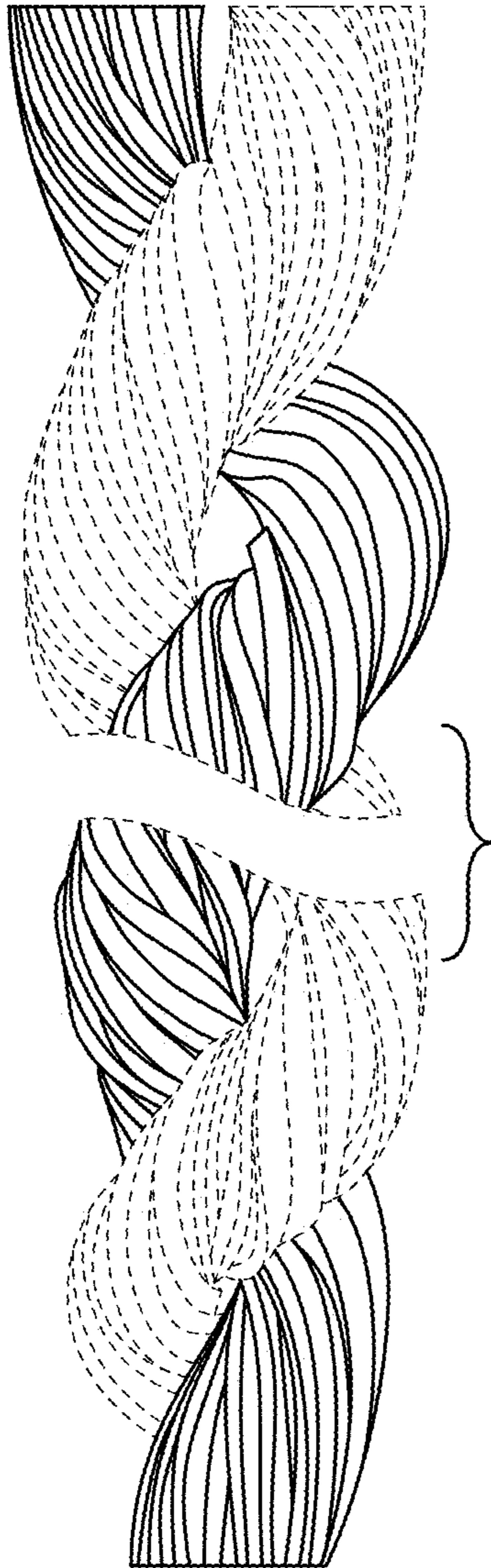

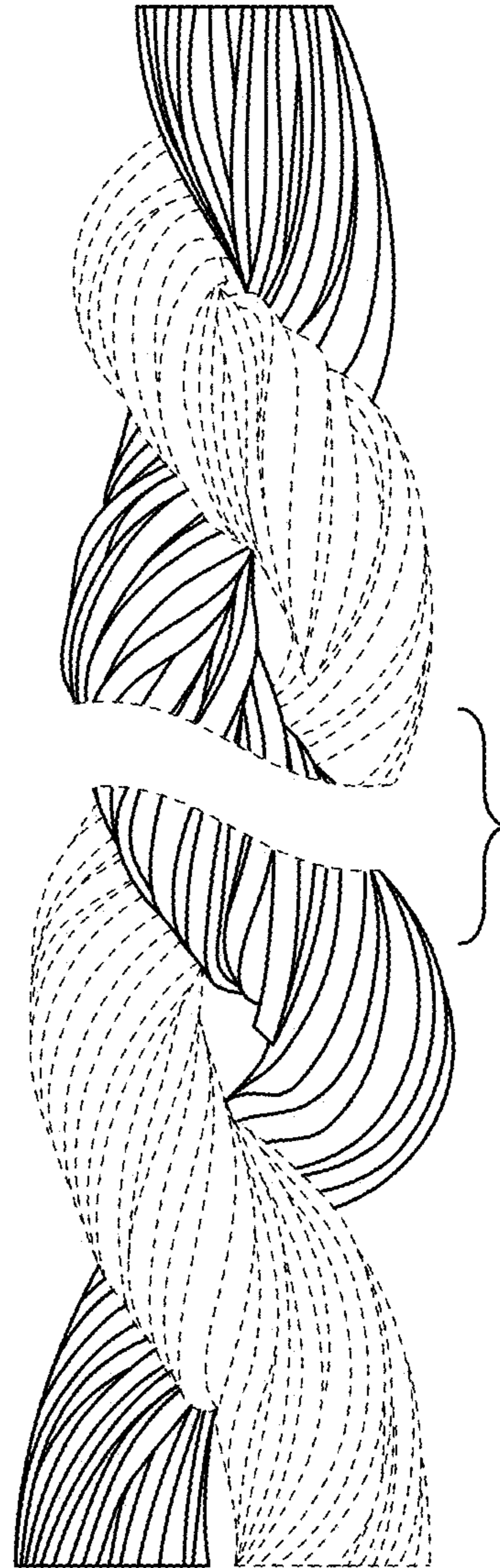

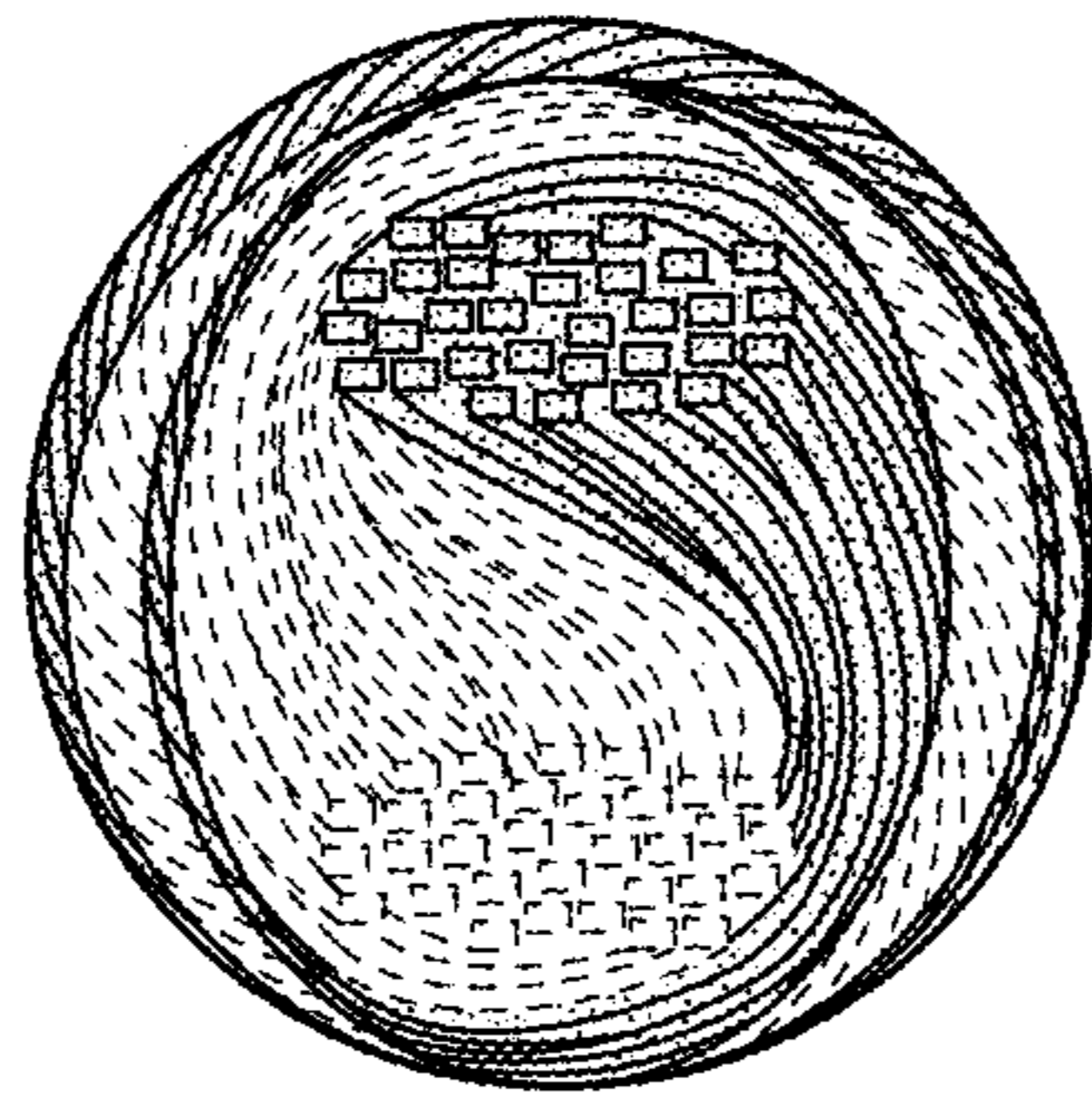

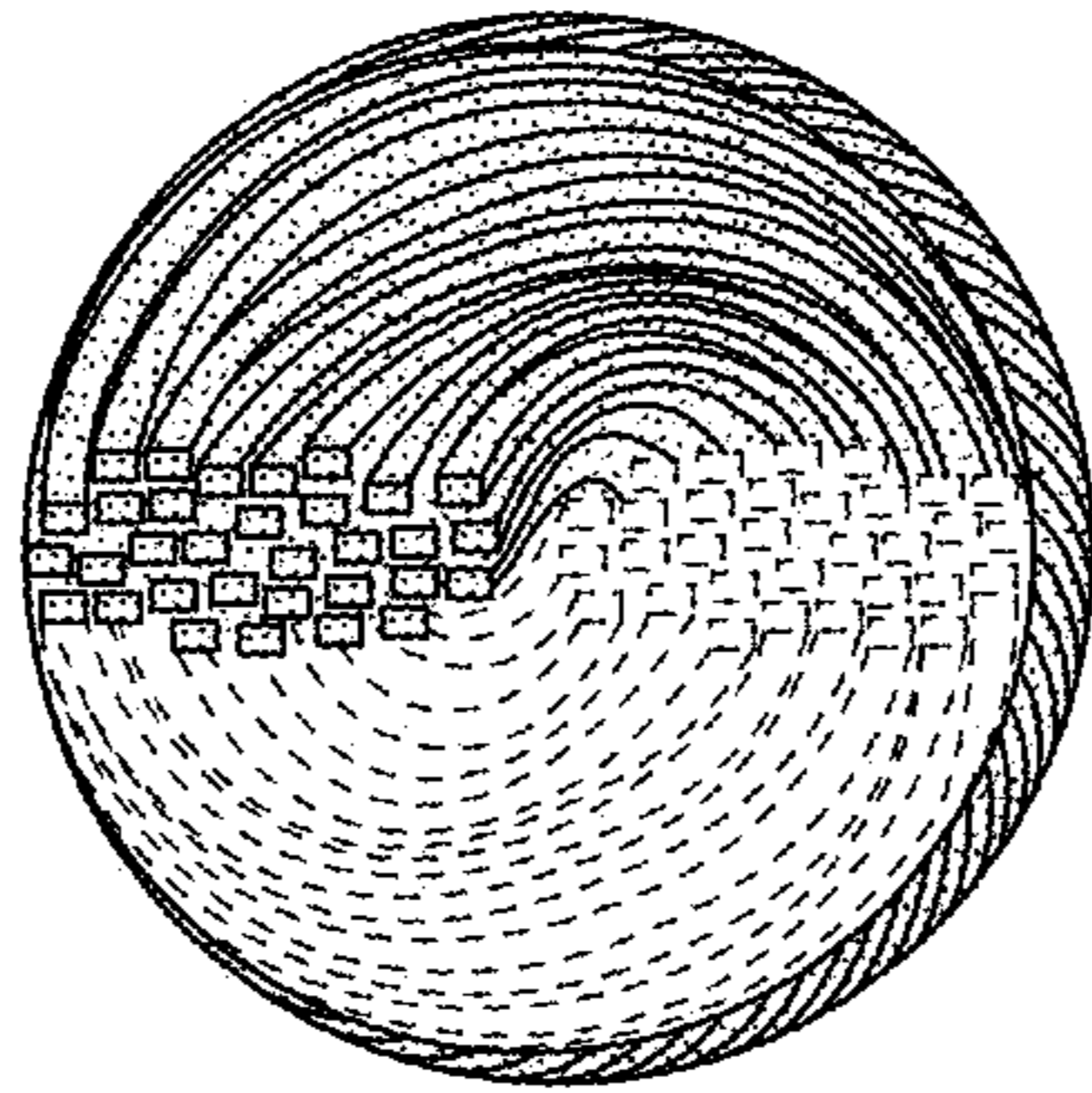

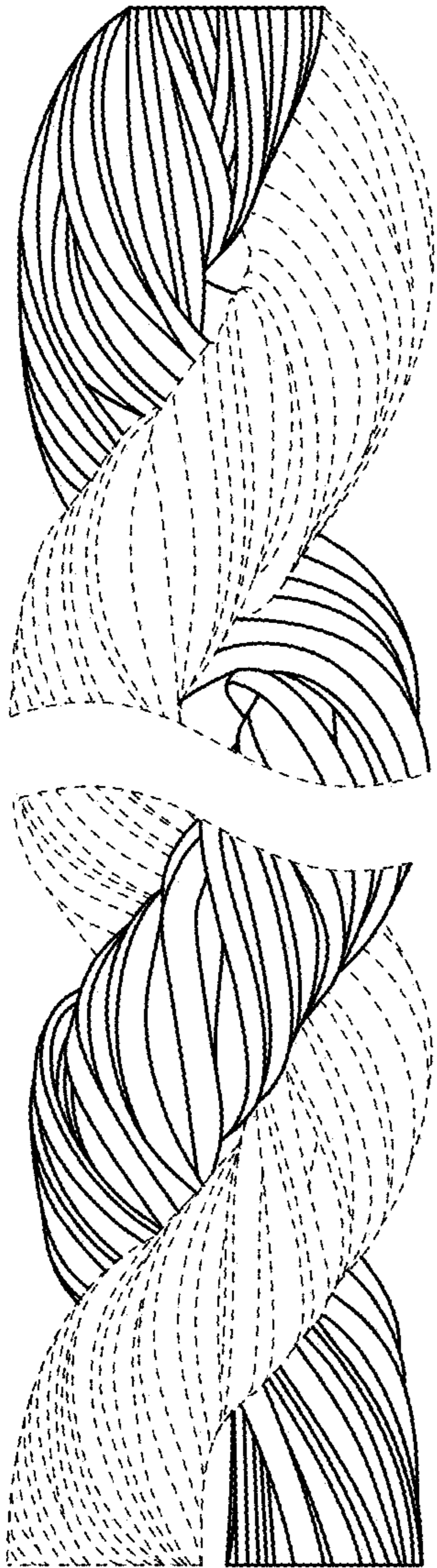

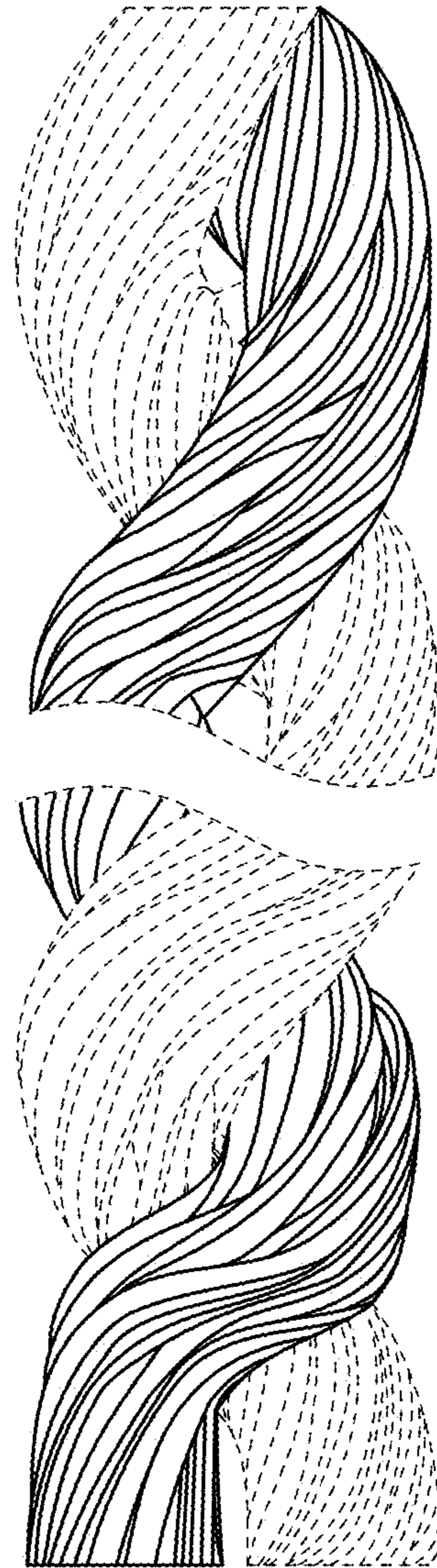

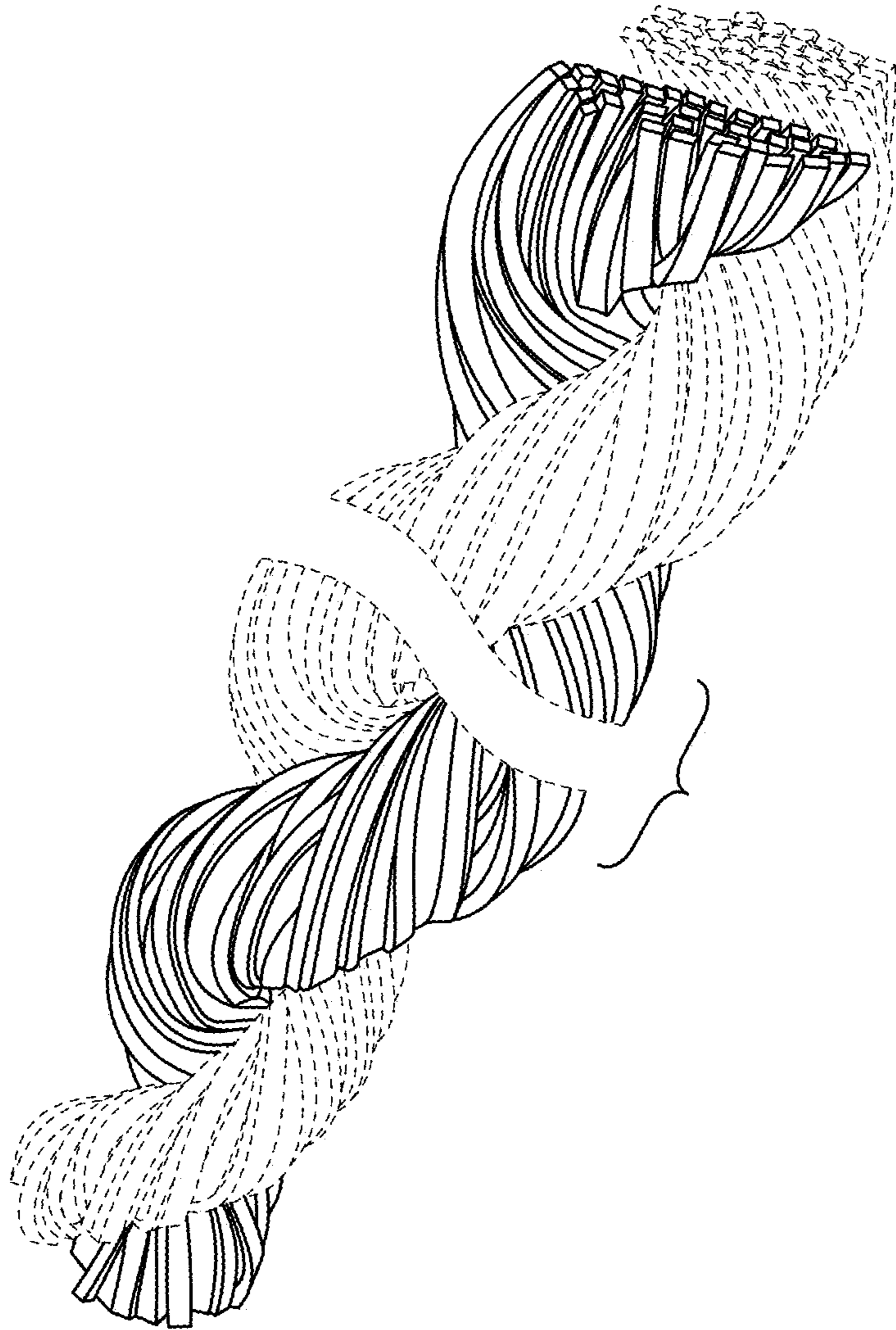
