FIG. 2 is a bottom, front perspective view thereof.

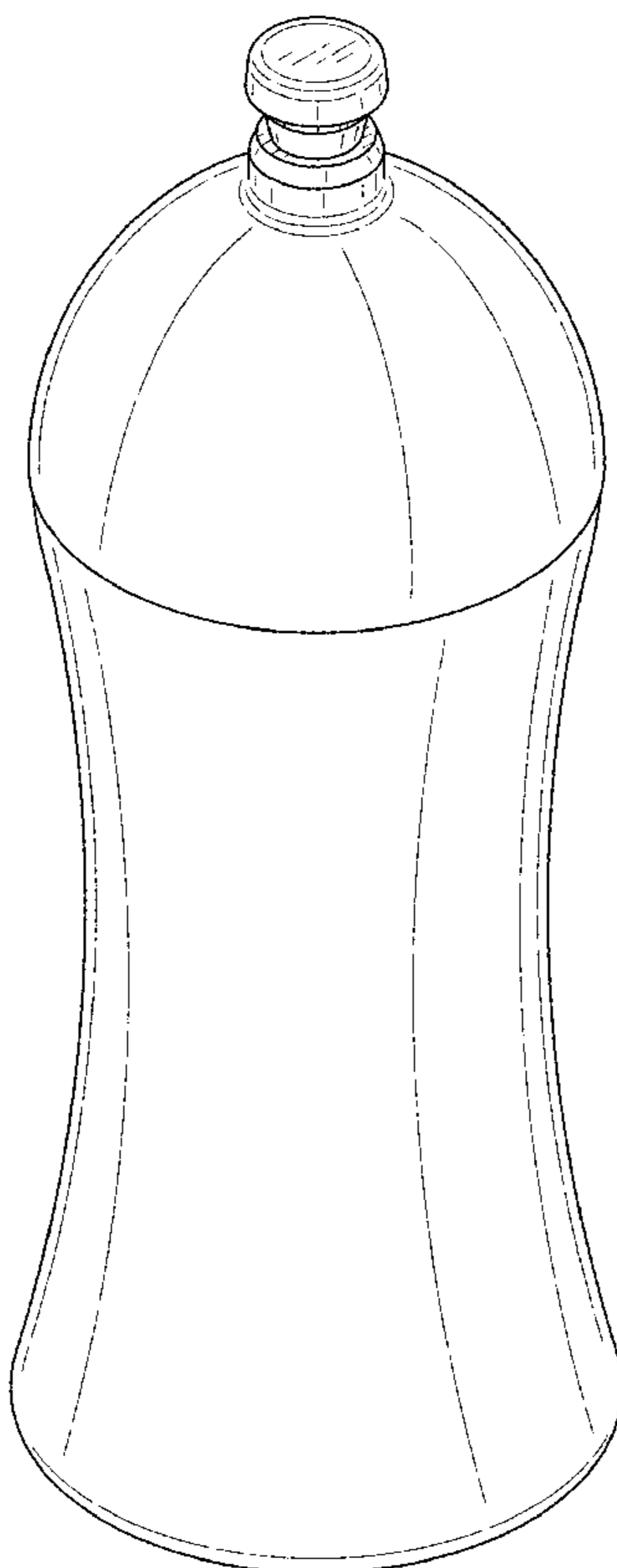
FIG. 3 is a front view thereof, wherein the back, side, and opposite side views being the same.

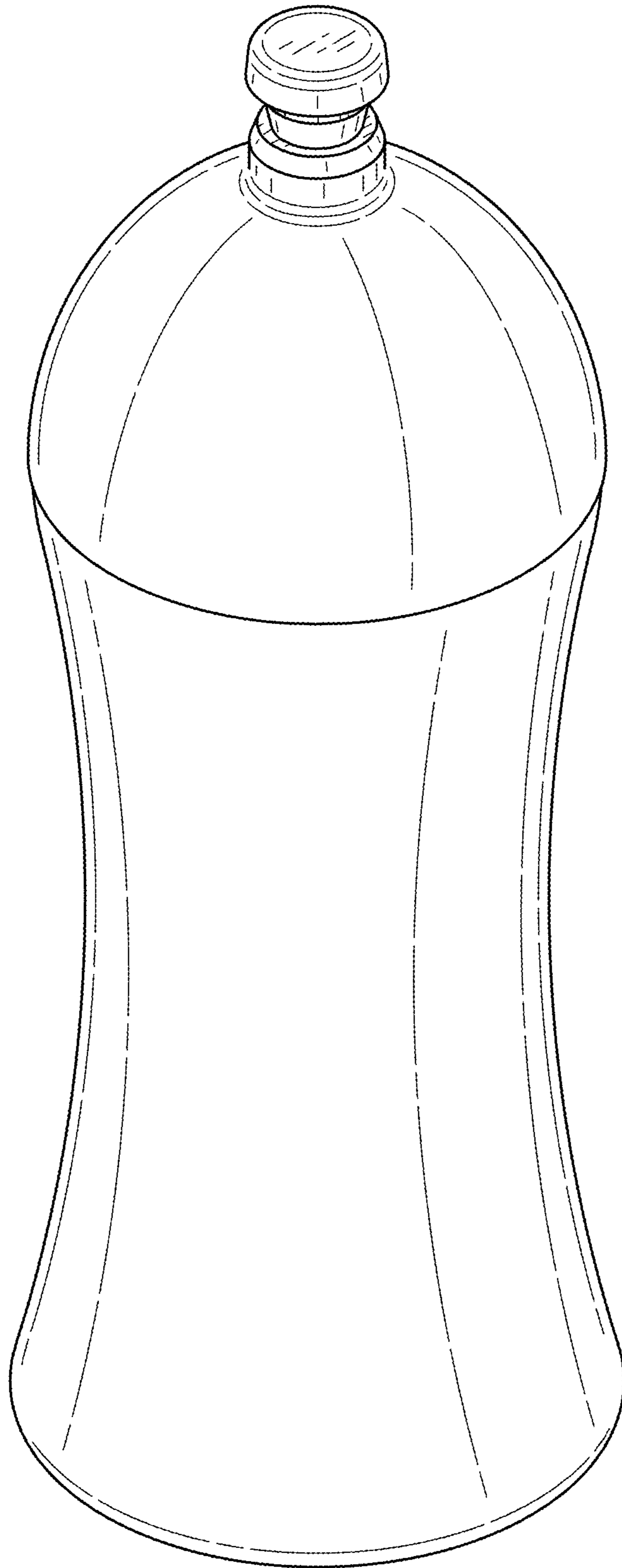

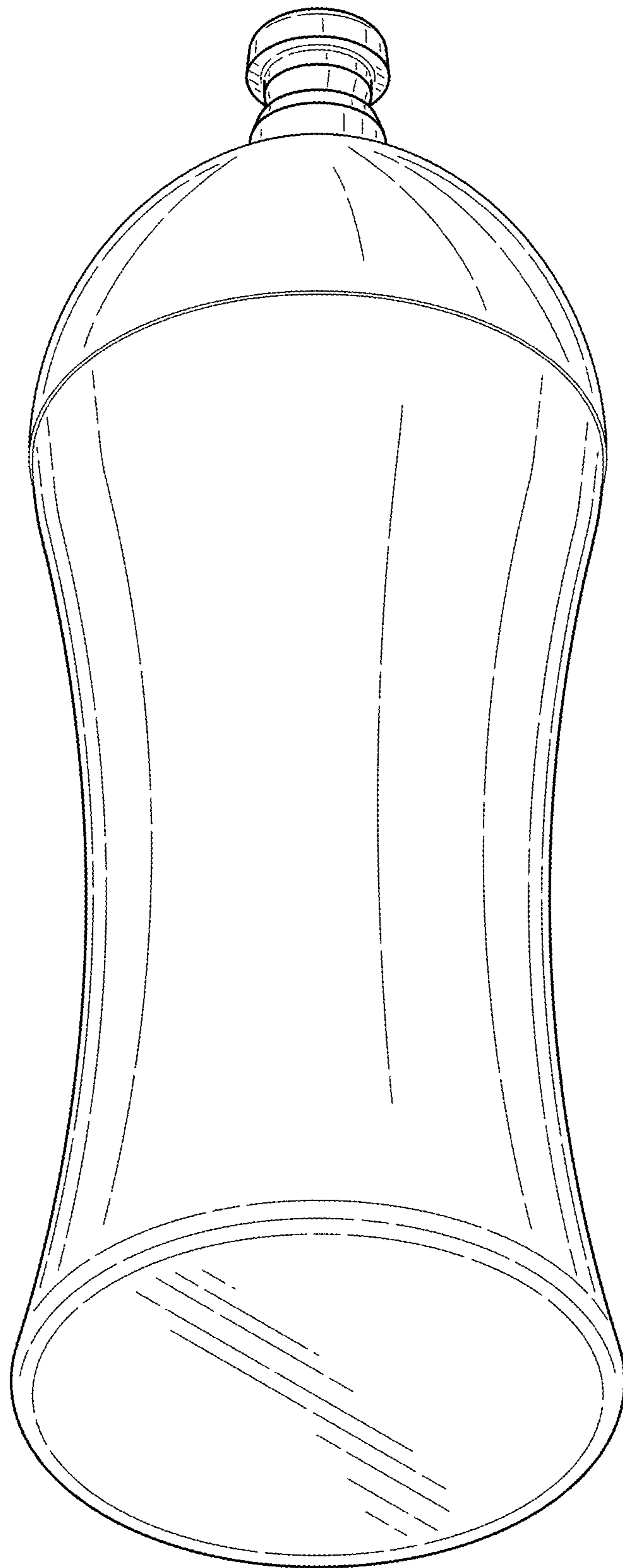

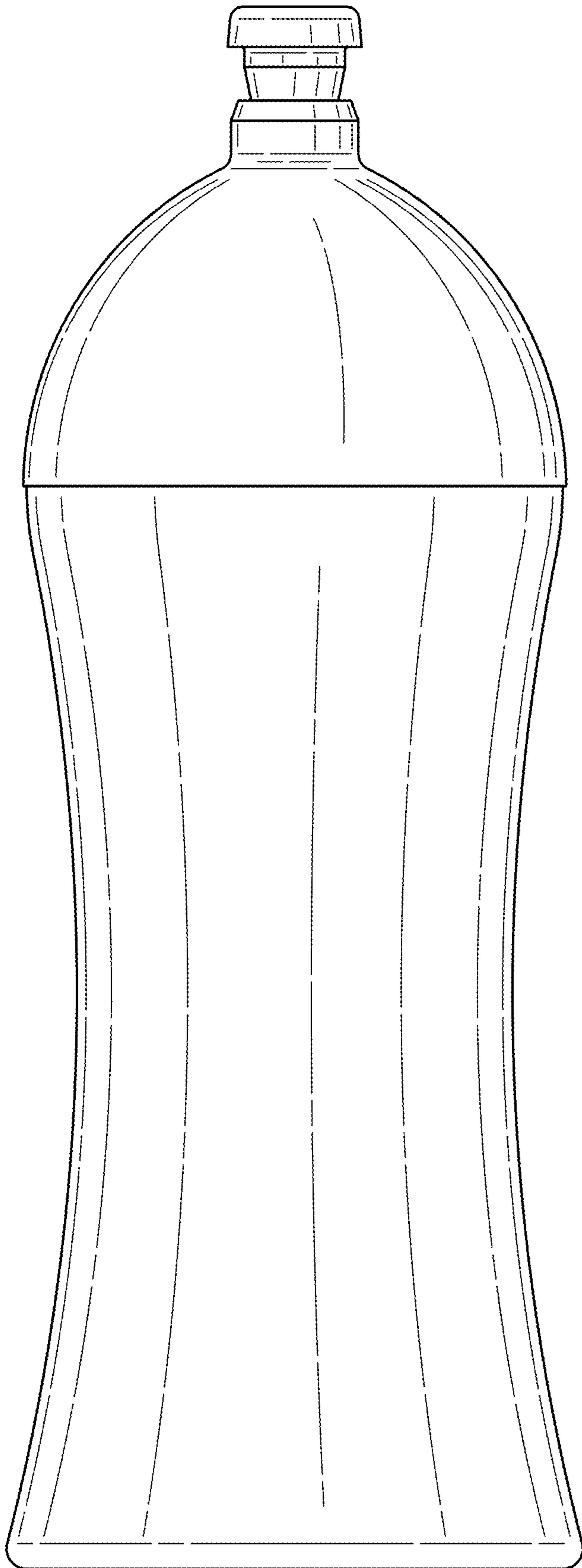

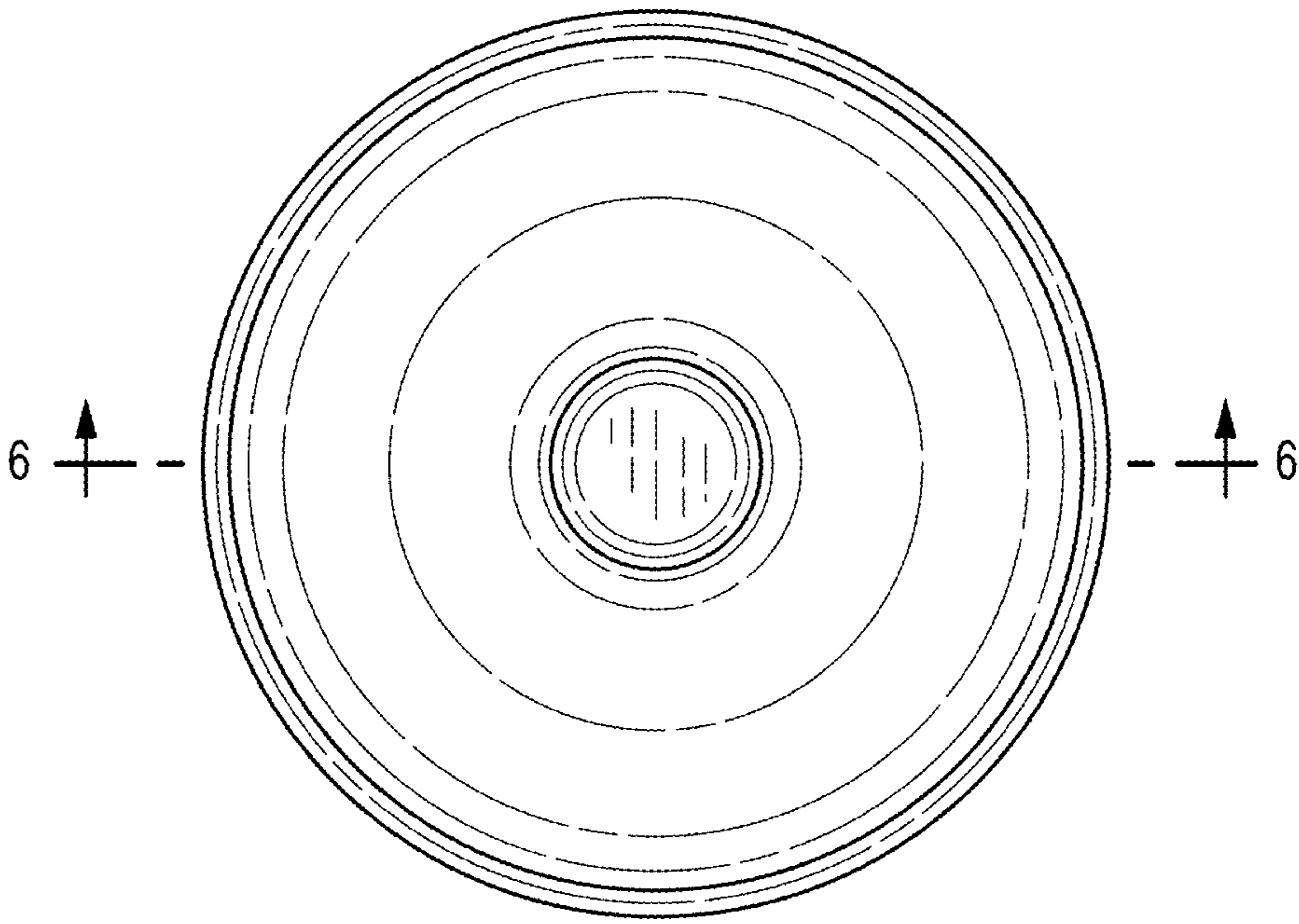

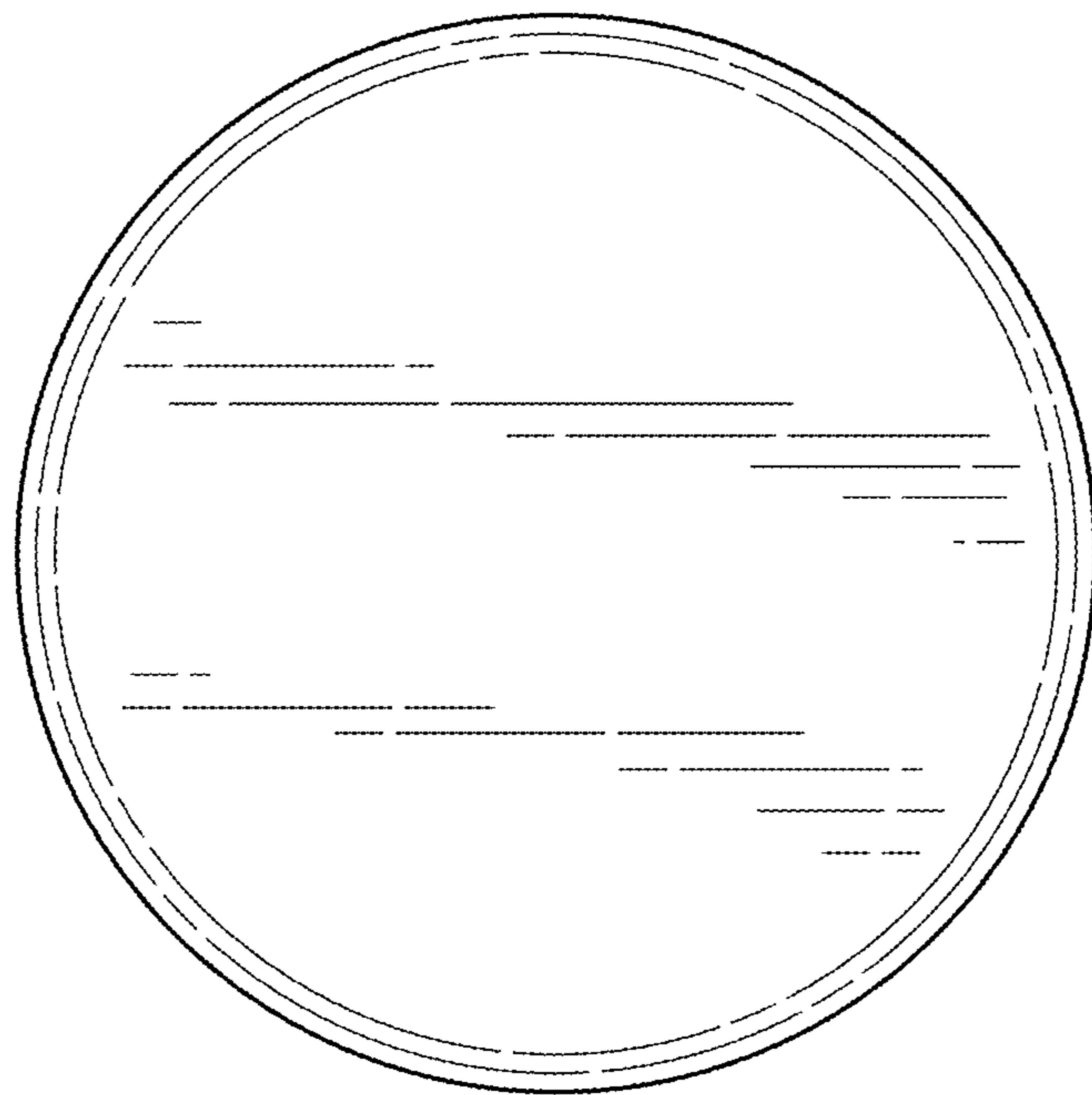

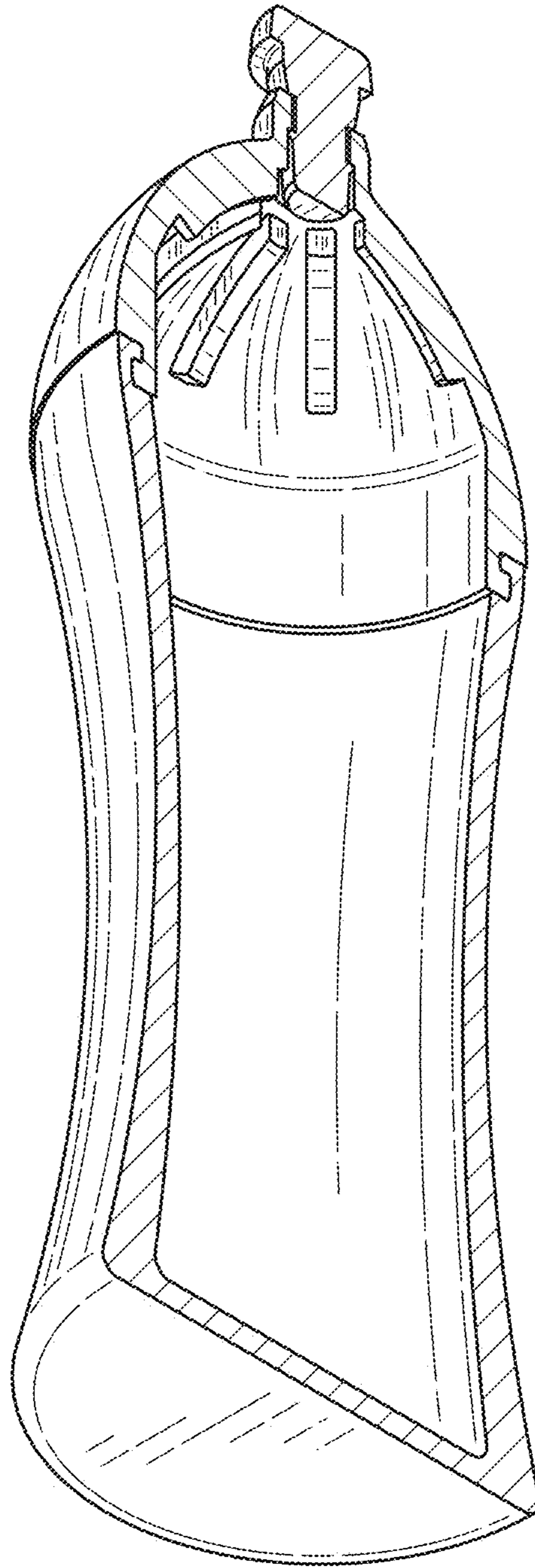
