(57) **CLAIM**

The ornamental design for a motor car, as shown and described.

**DESCRIPTION**

1. Motor car

**1.1** is a top, front and left side perspective view of a motor car showing our new design;

**1.2** is a front elevation view thereof;

**1.3** is a rear elevation view thereof;

**1.4** is a right side elevation view thereof;

**1.5** is a left side elevation view thereof;

**1.6** is a top plan view thereof.

**1.1** is a top, front, and left side perspective view of a motor car embodying our new design; **1.2** is a front elevation view thereof; **1.3** is a rear elevation view thereof; **1.4** is a right side elevation view thereof; **1.5** is a left side elevation view thereof; and **1.6** is a top plan view thereof; this design is for a heavyweight article and therefore the bottom part of the article is omitted.

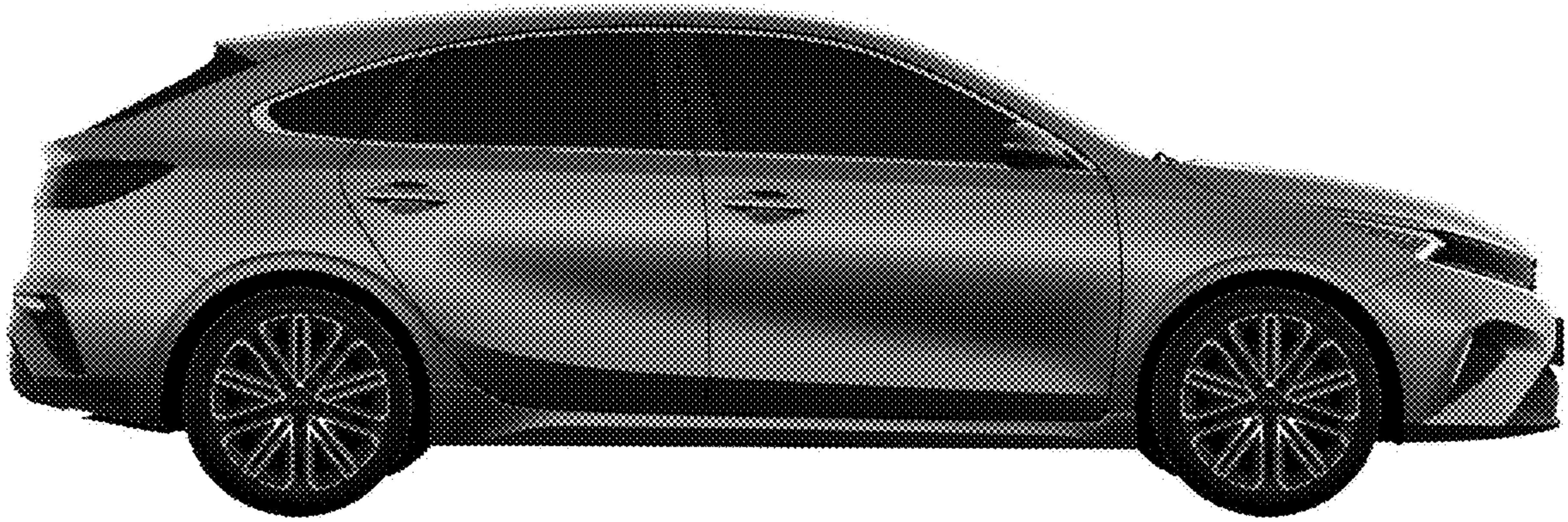

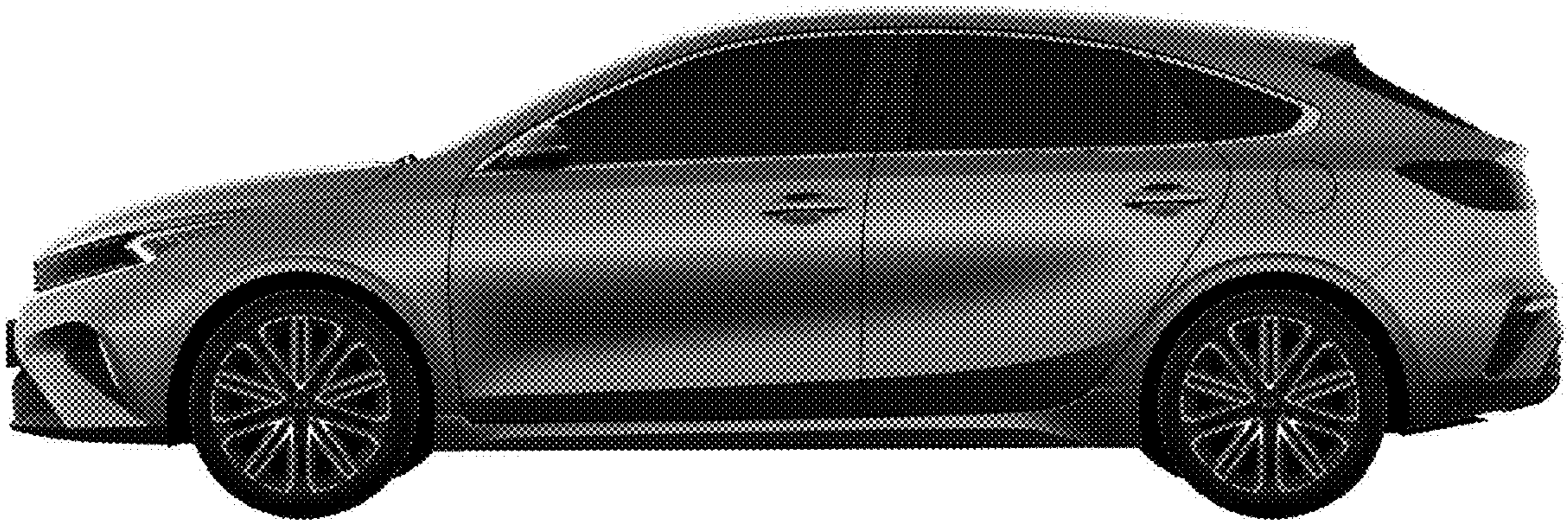
