In the drawings the broken lines depict portions of the bicycle crank arm that form no part of the claimed design.

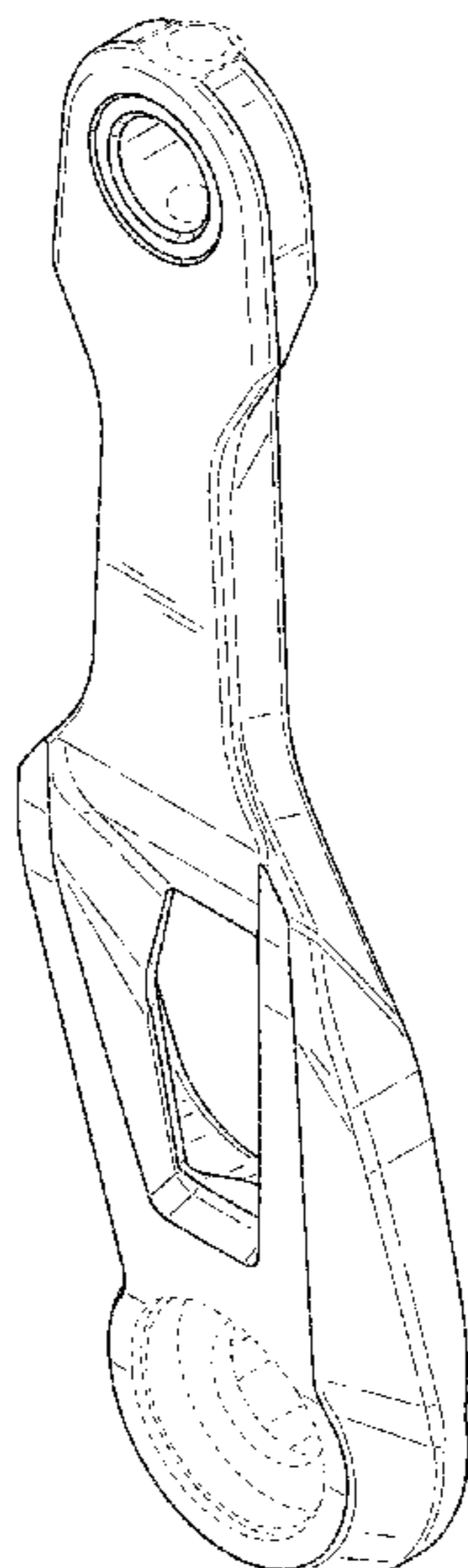

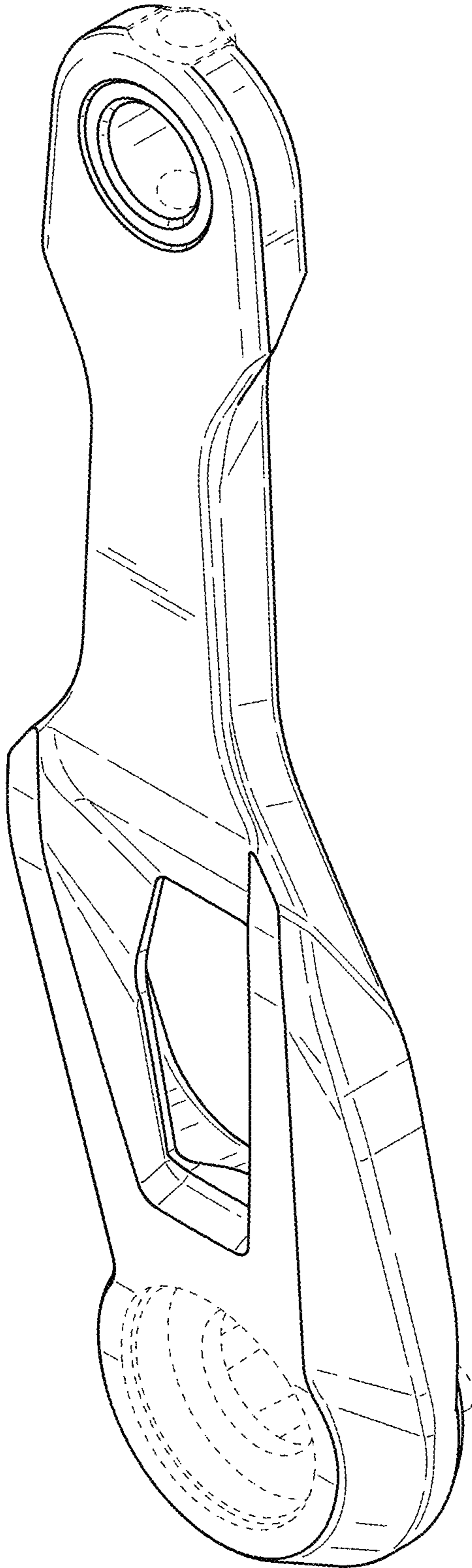

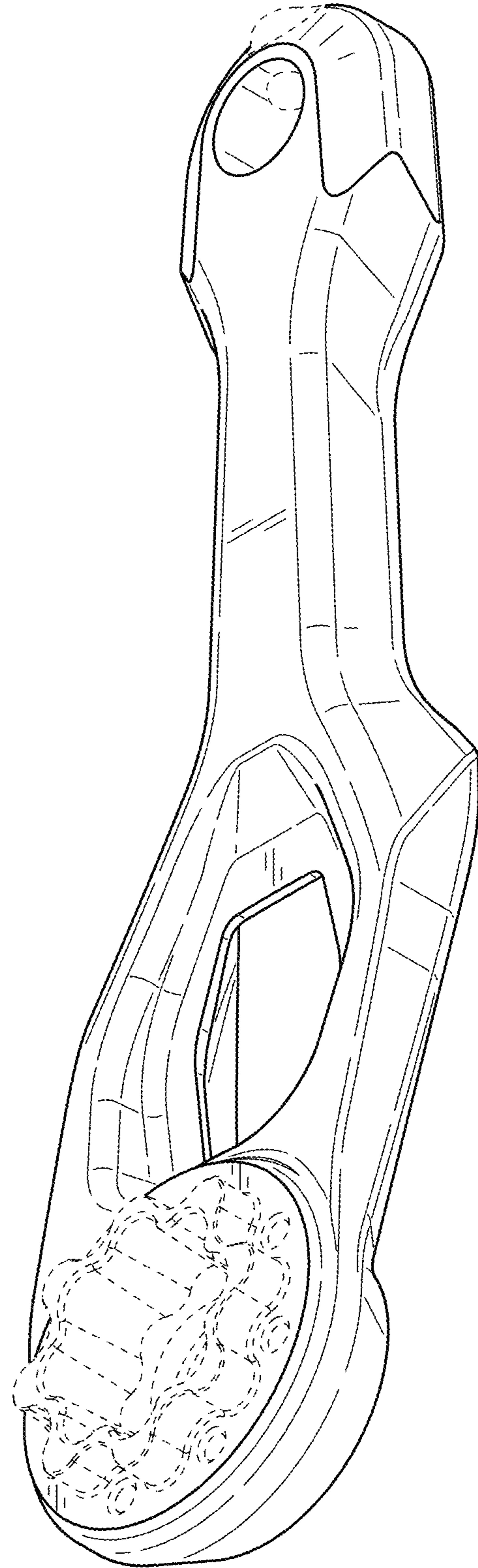

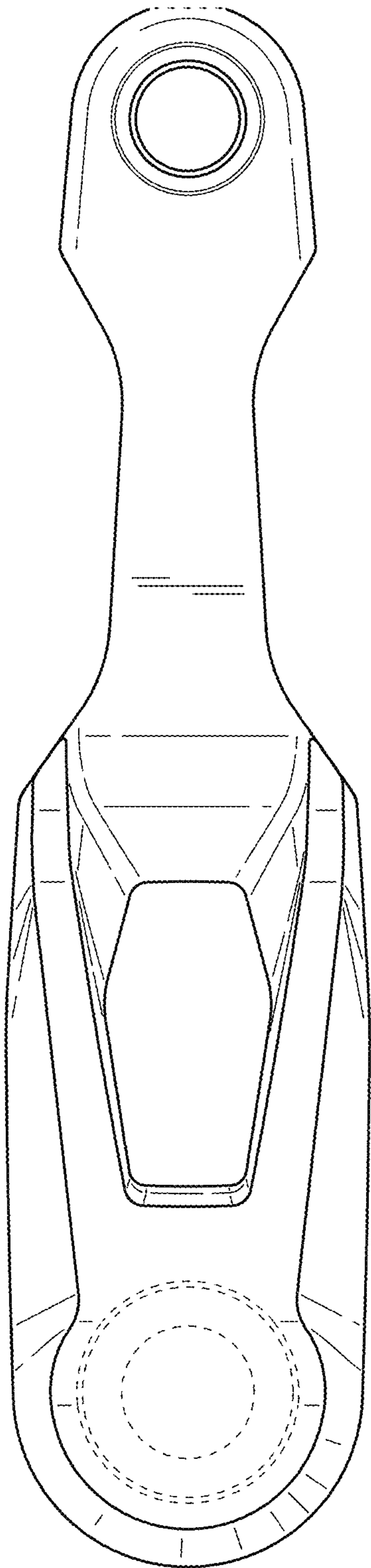

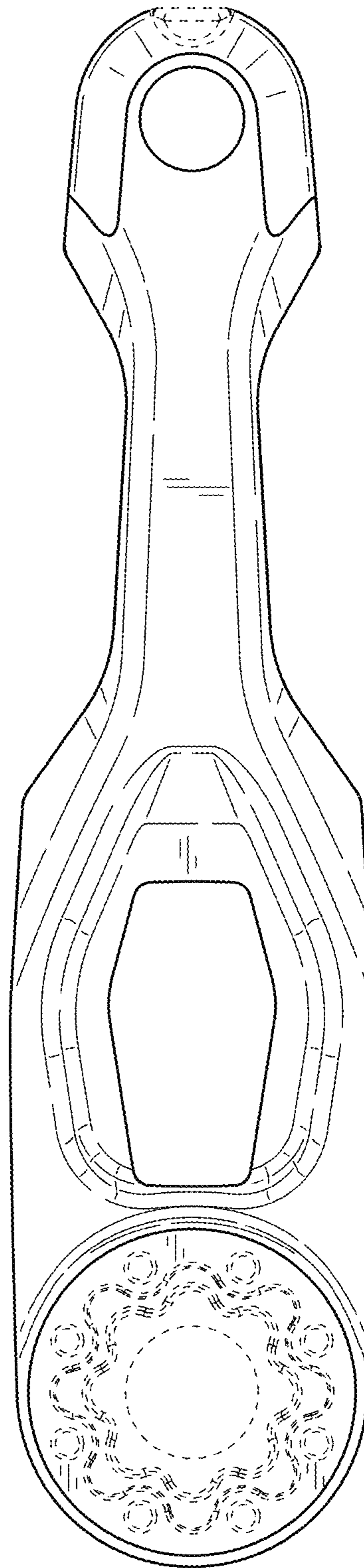

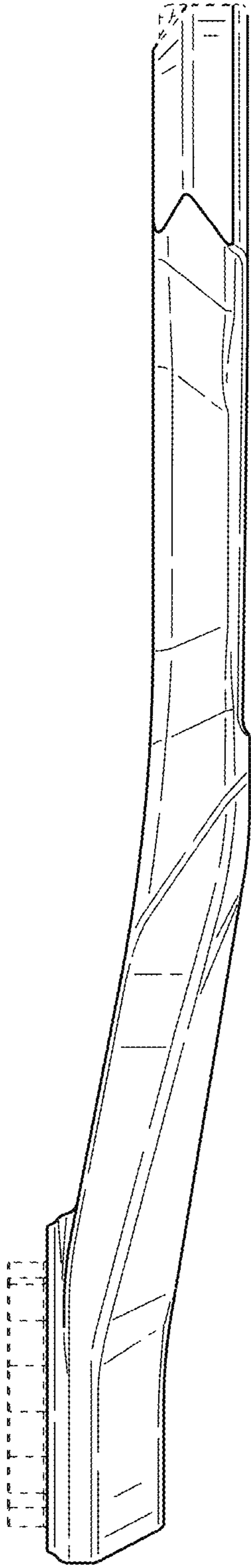

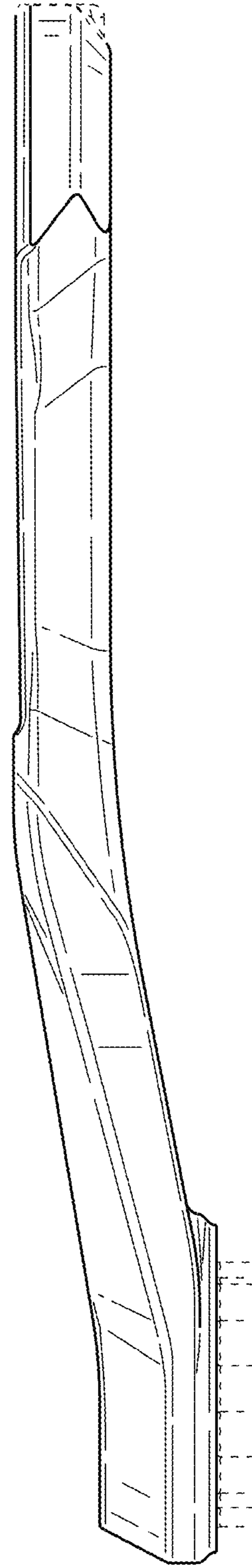

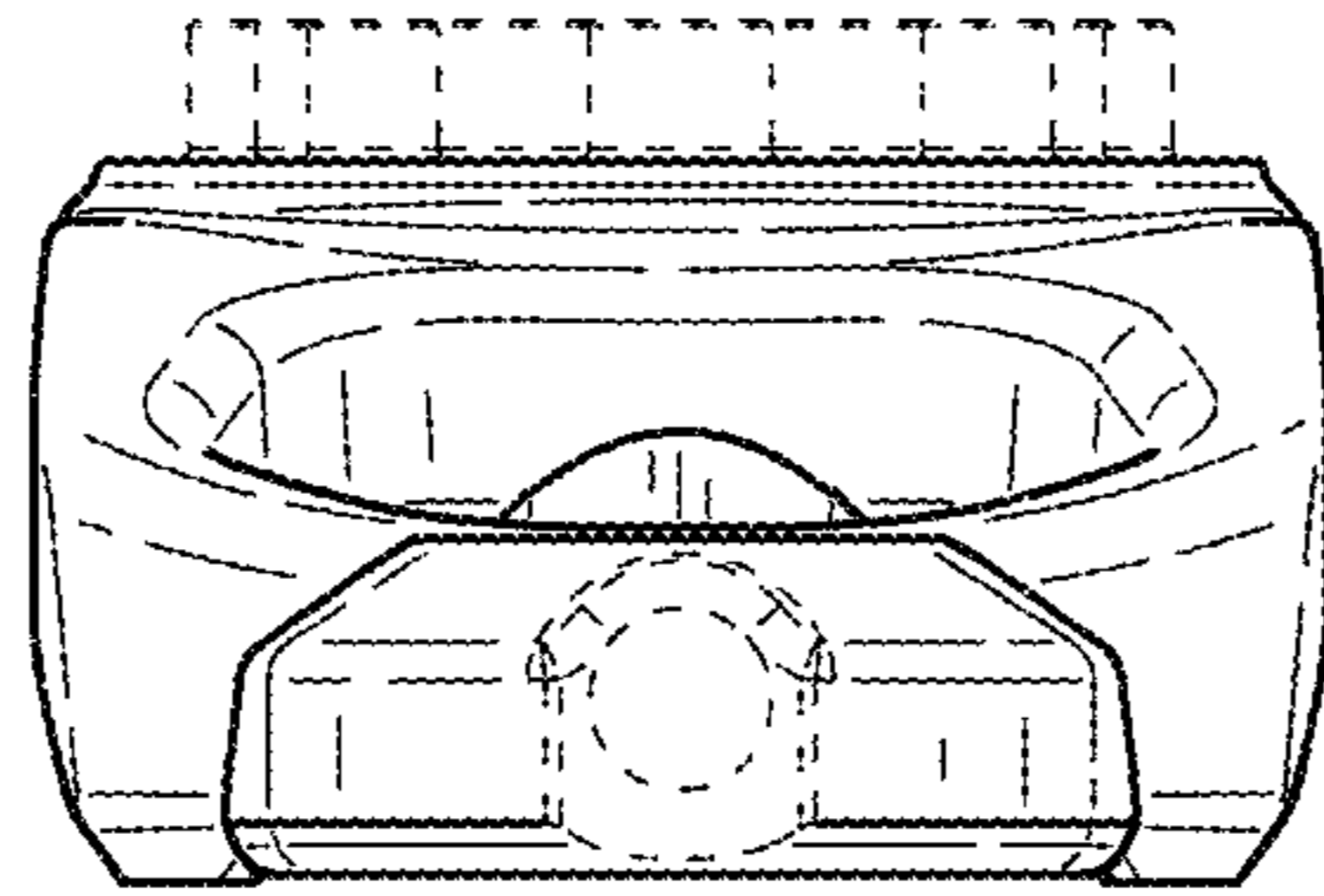

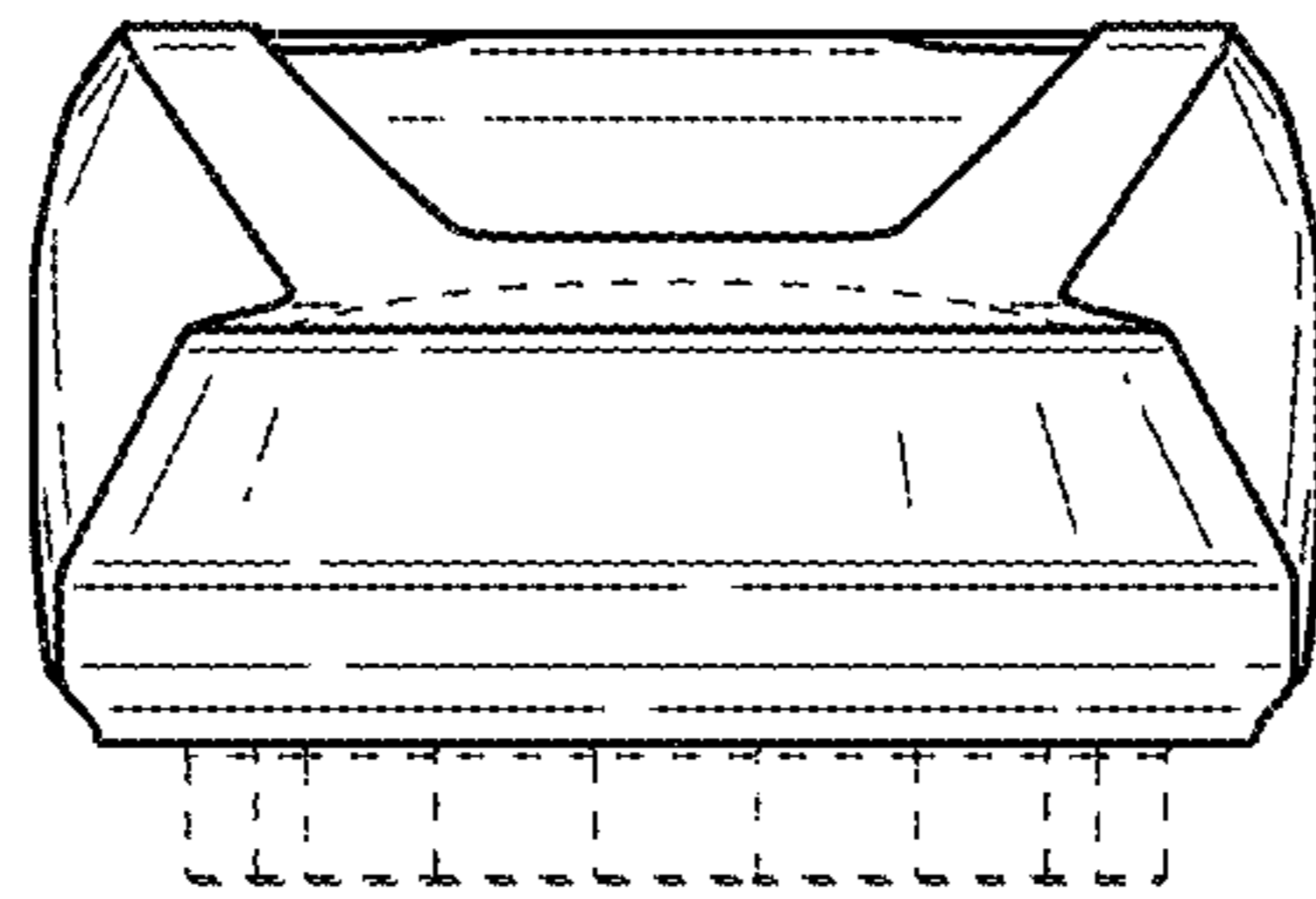
