(57) **CLAIM**

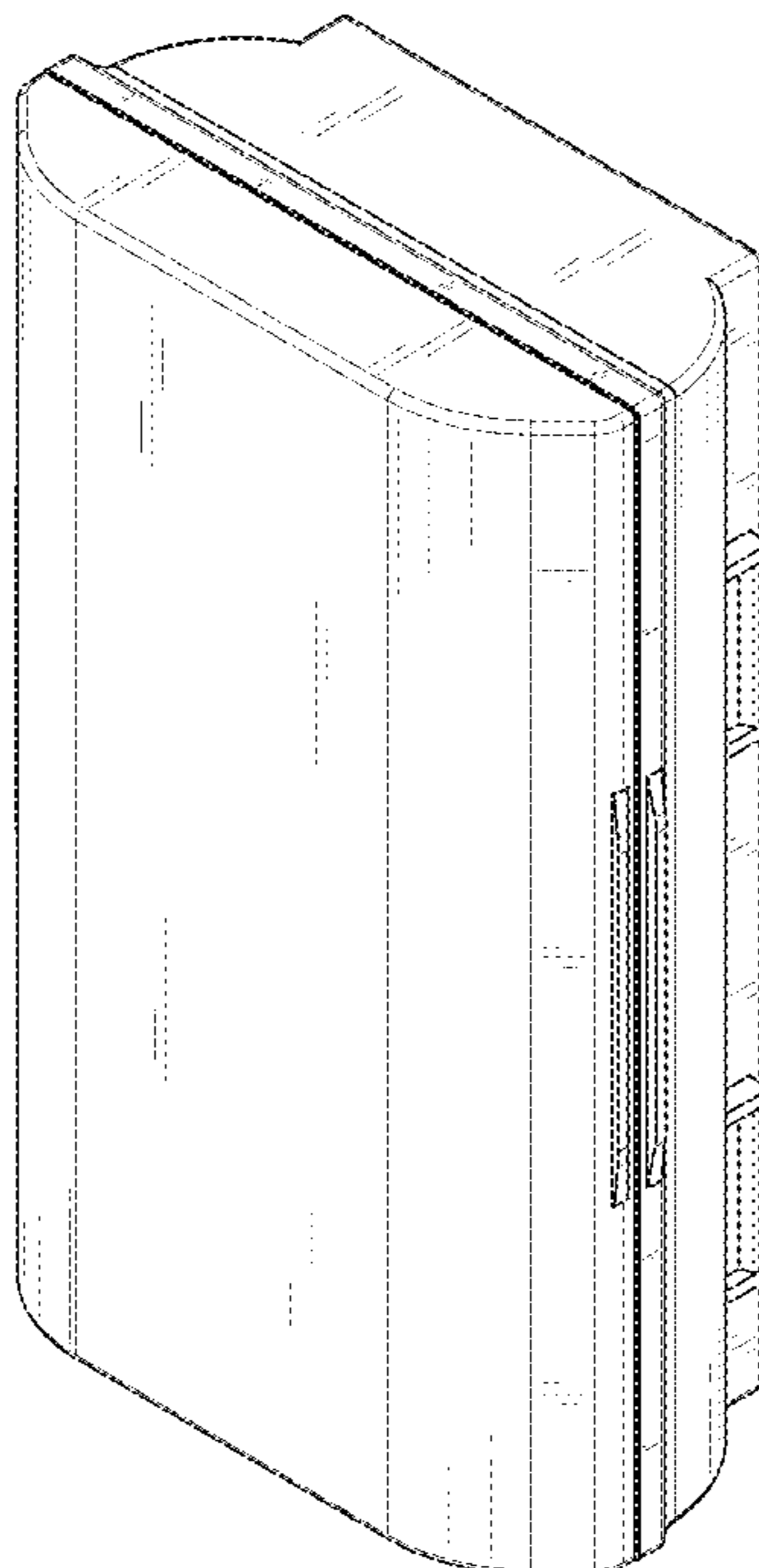
The ornamental design for a battery, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a battery showing our new design;

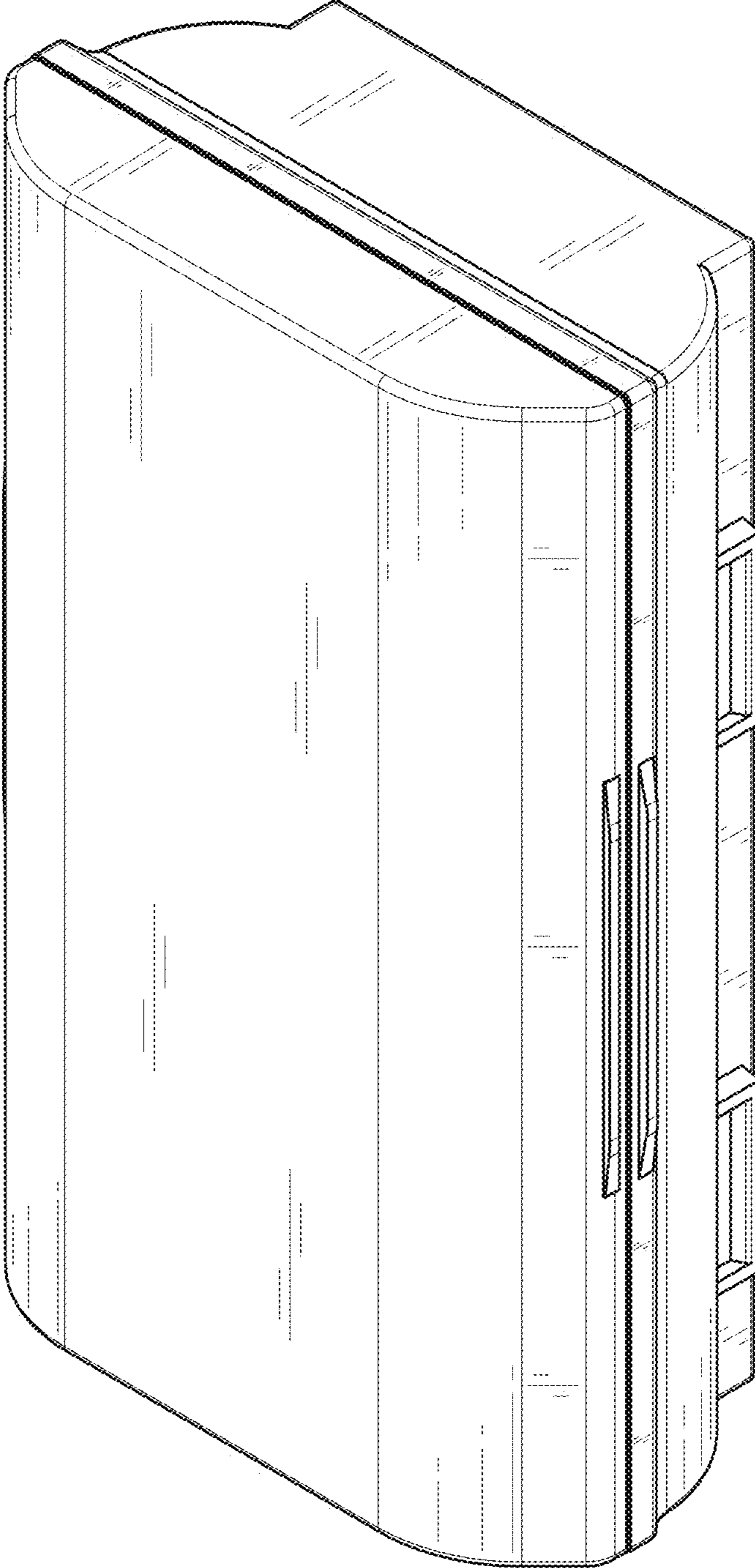

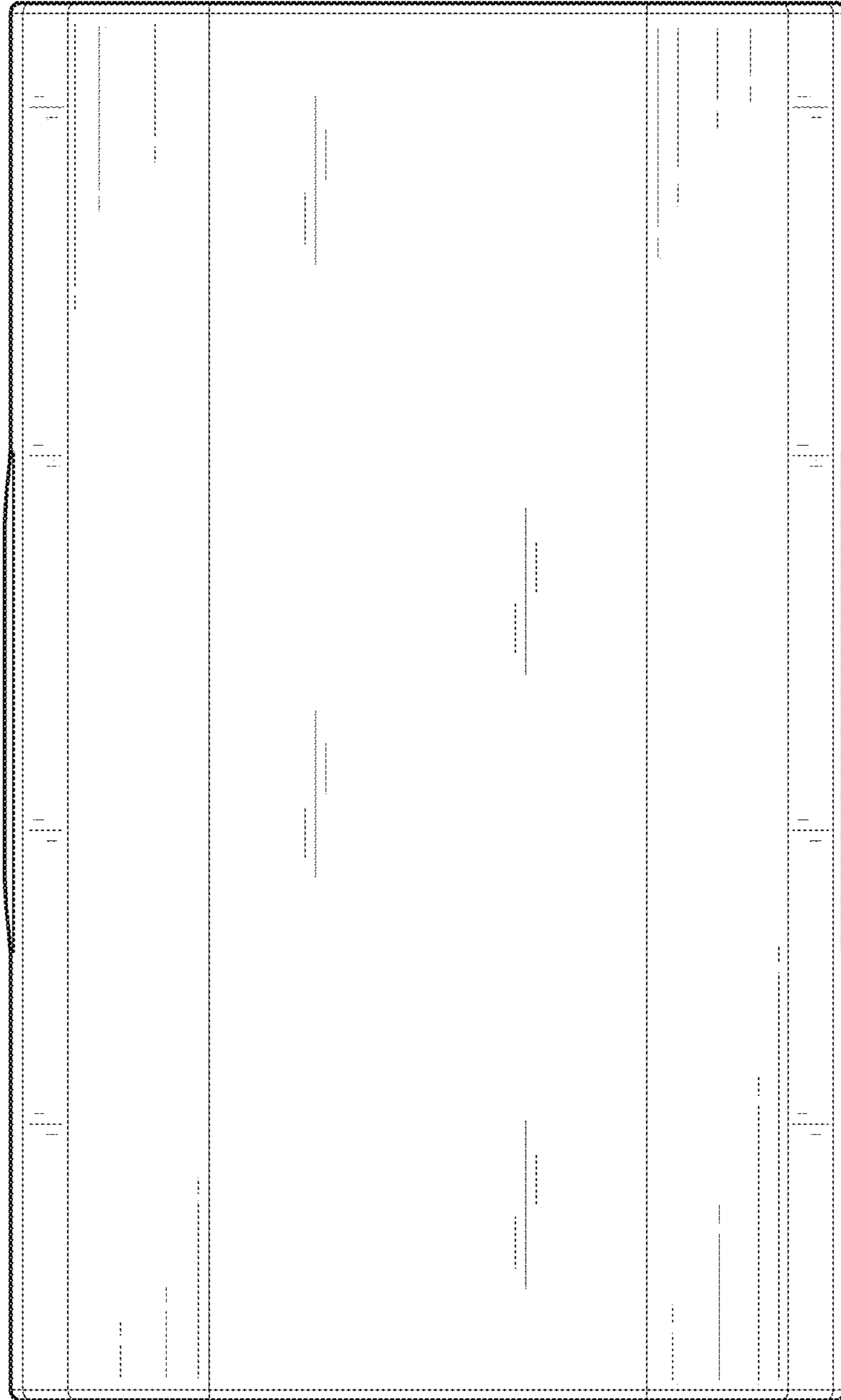

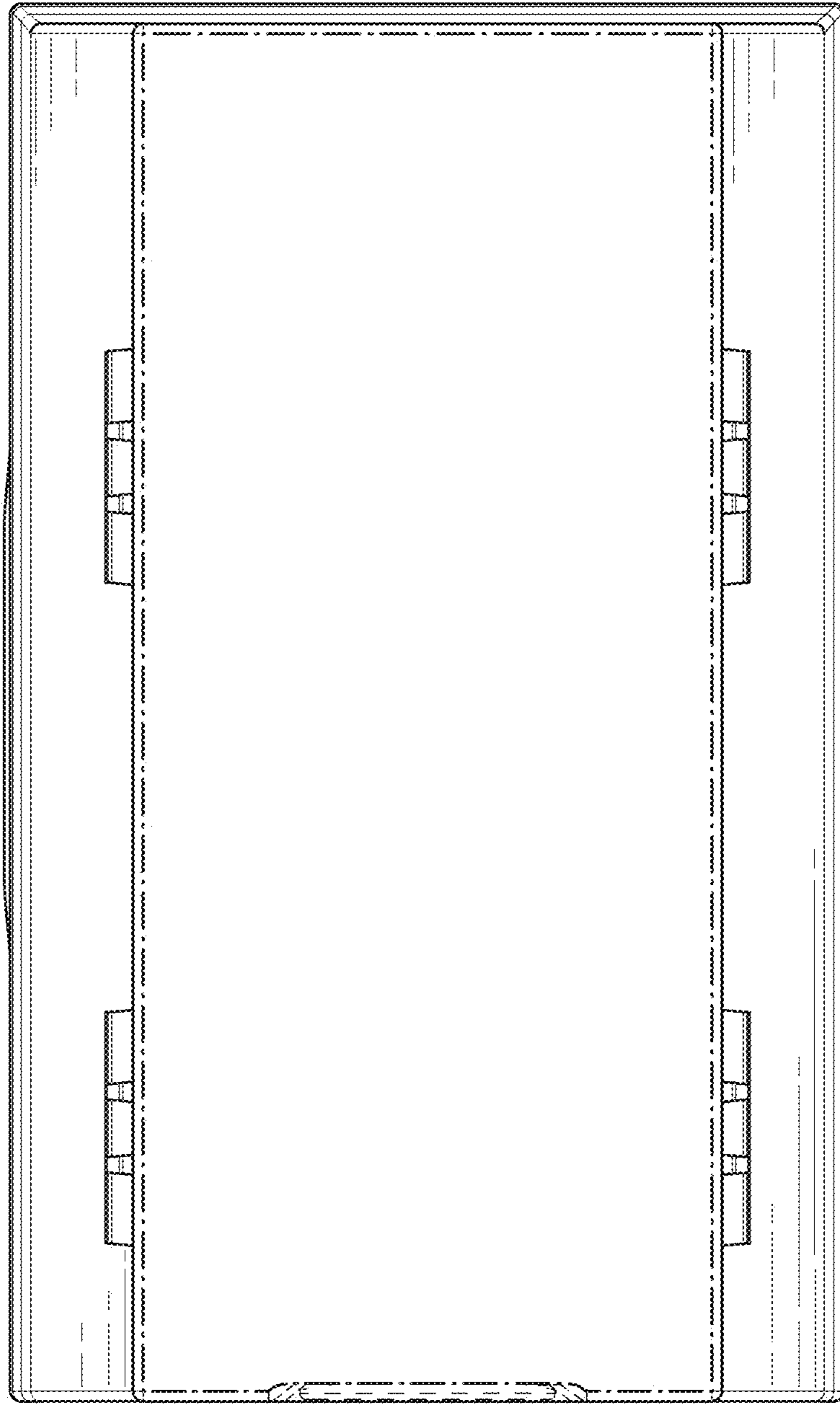

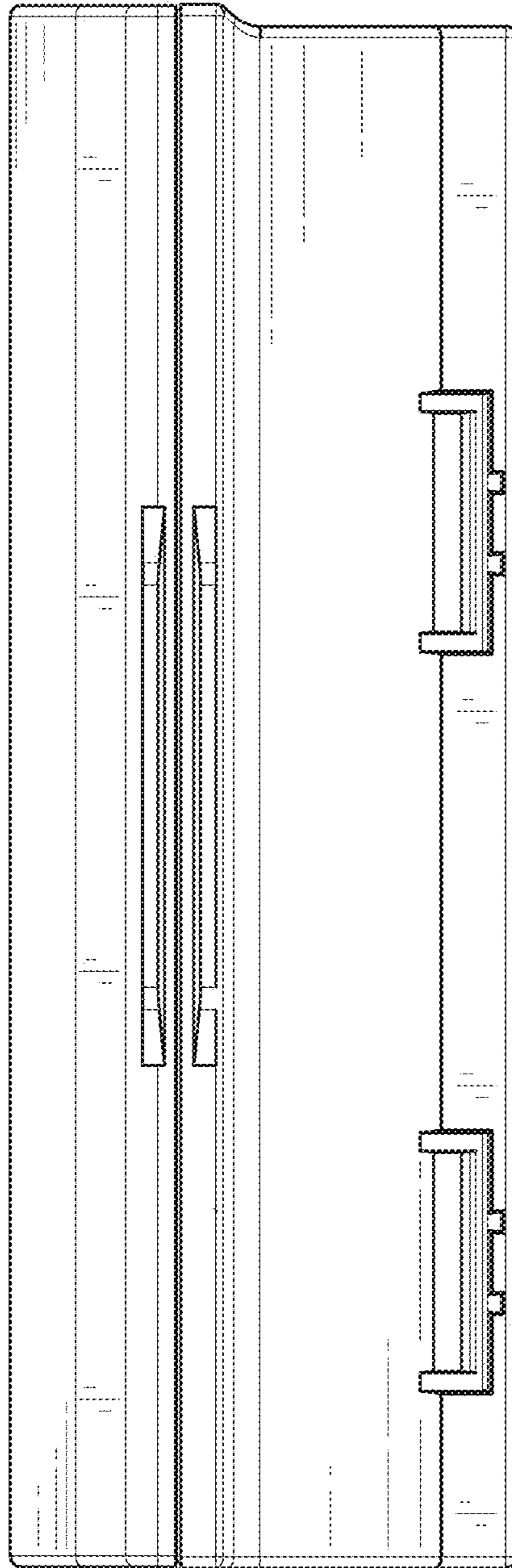

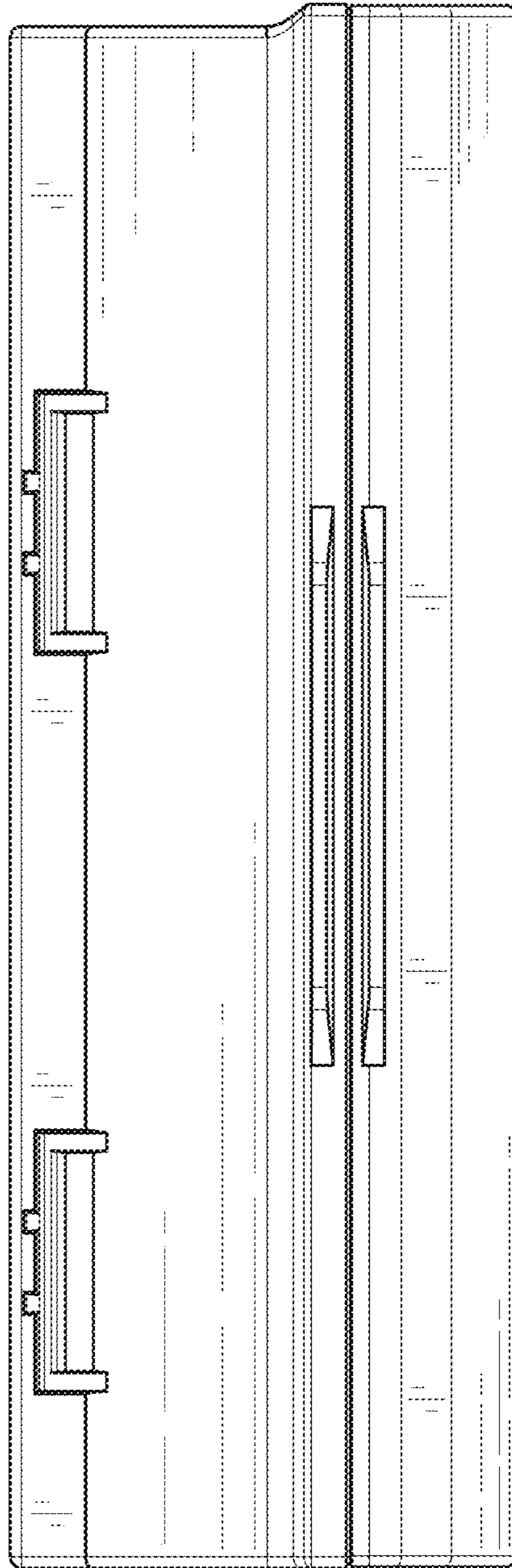

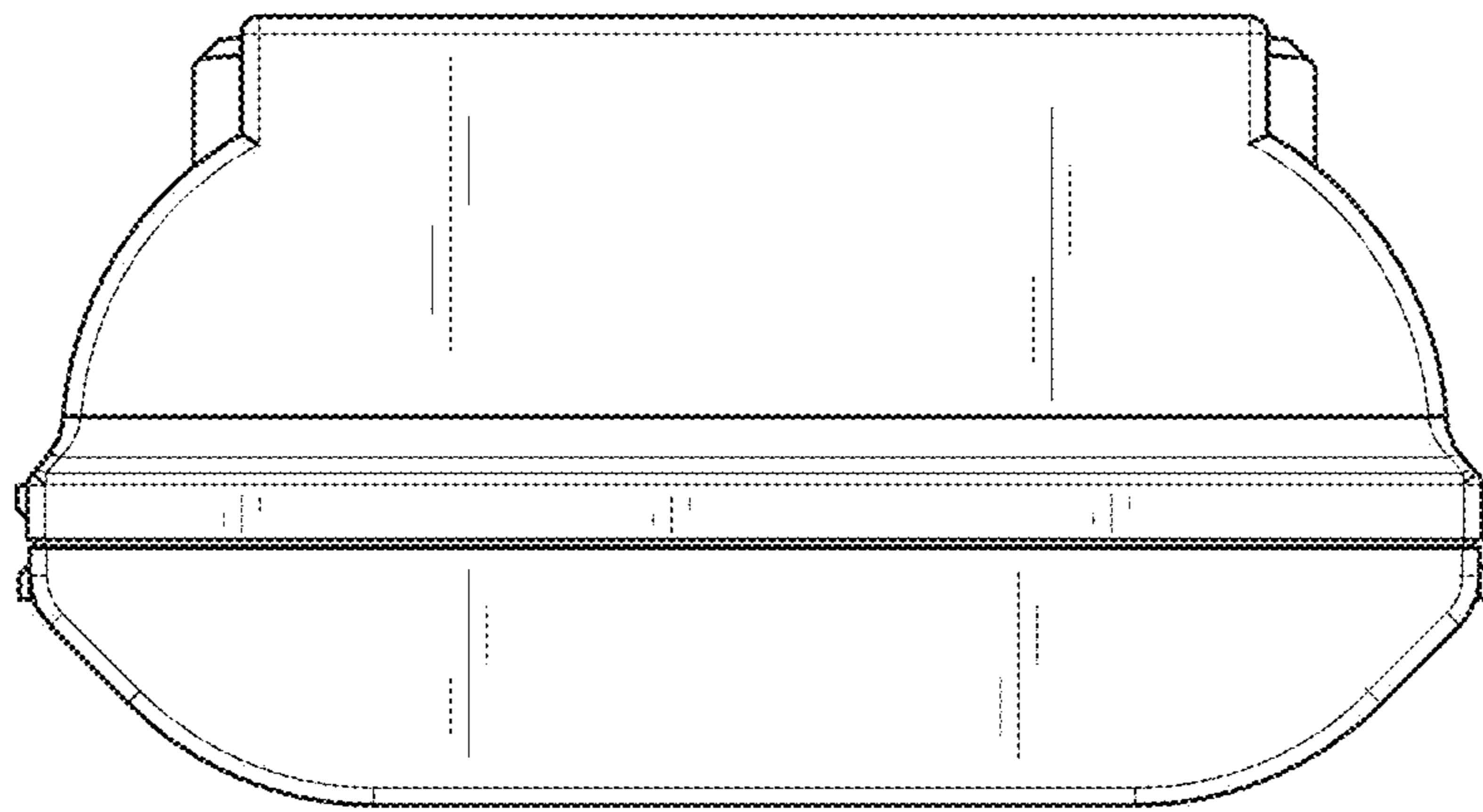

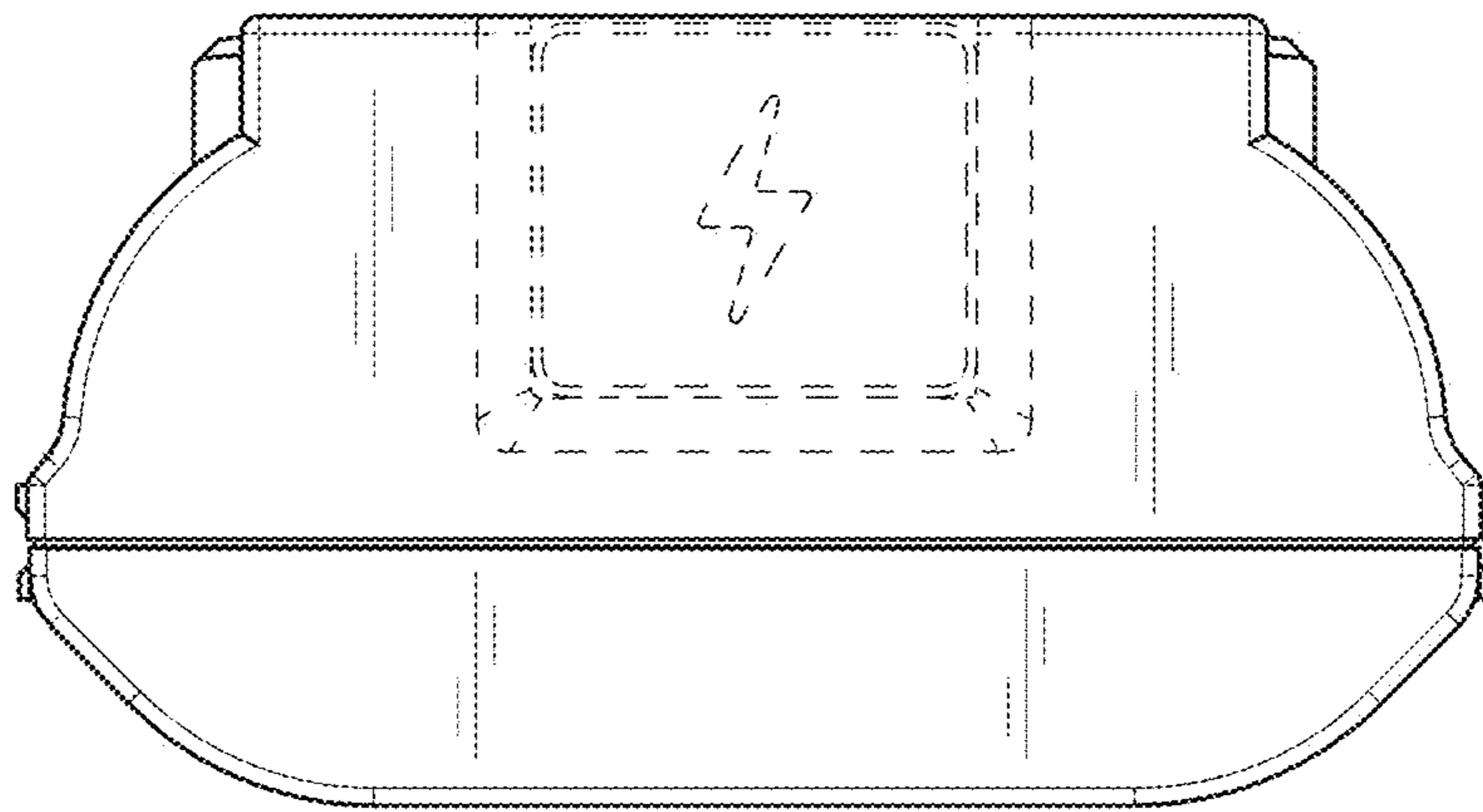
