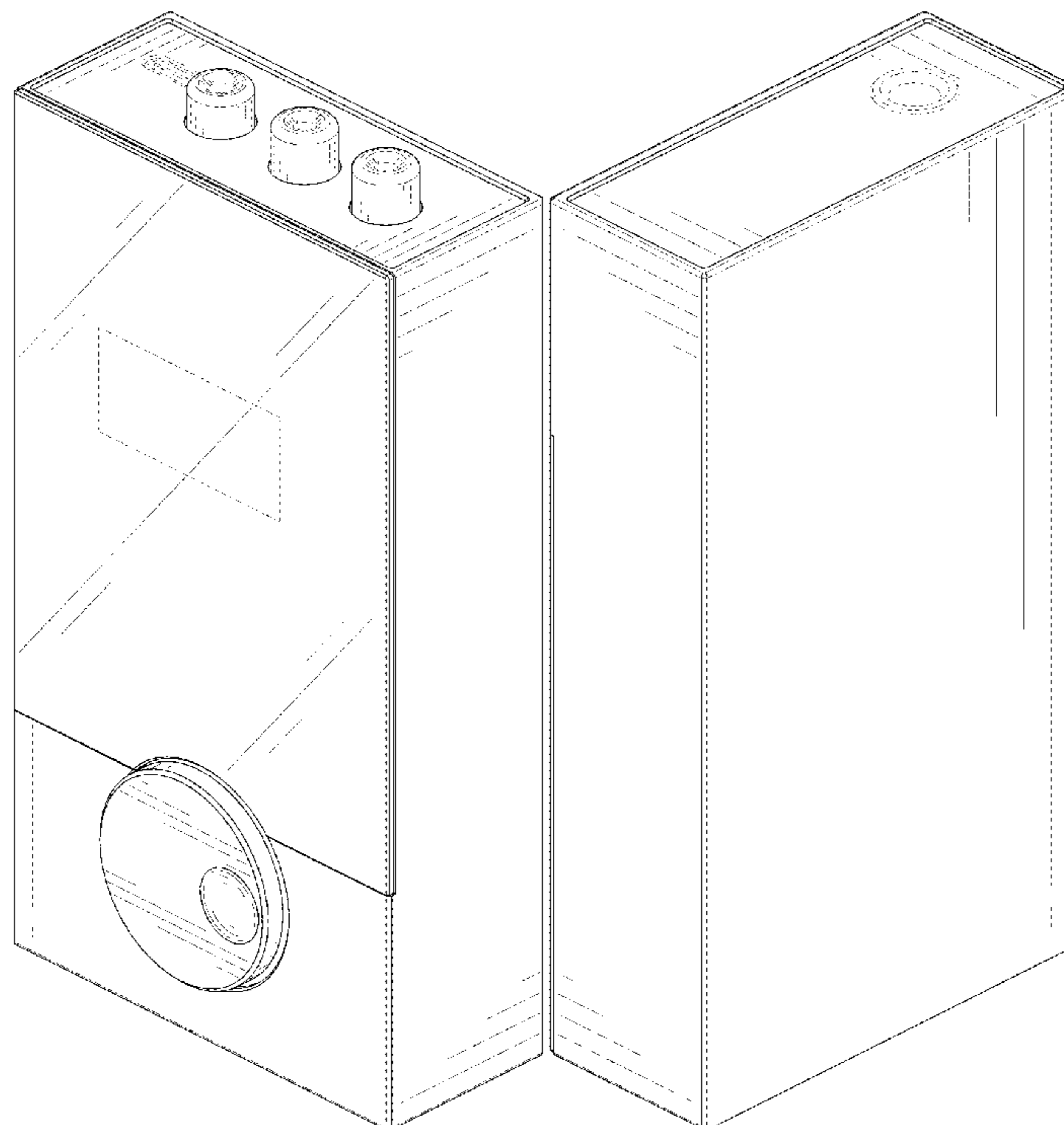
The ornamental design for a headphone amplifier, as shown and described.

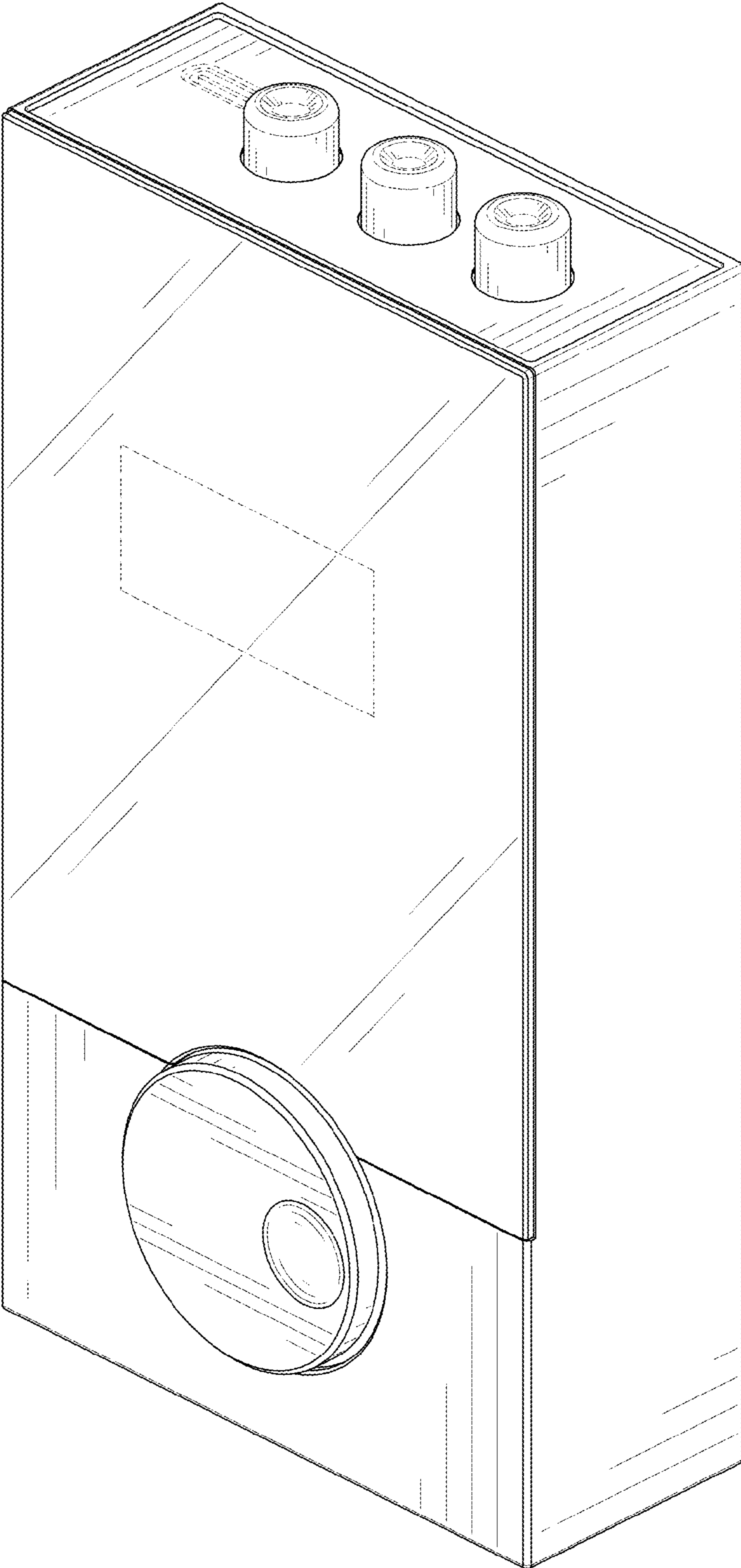

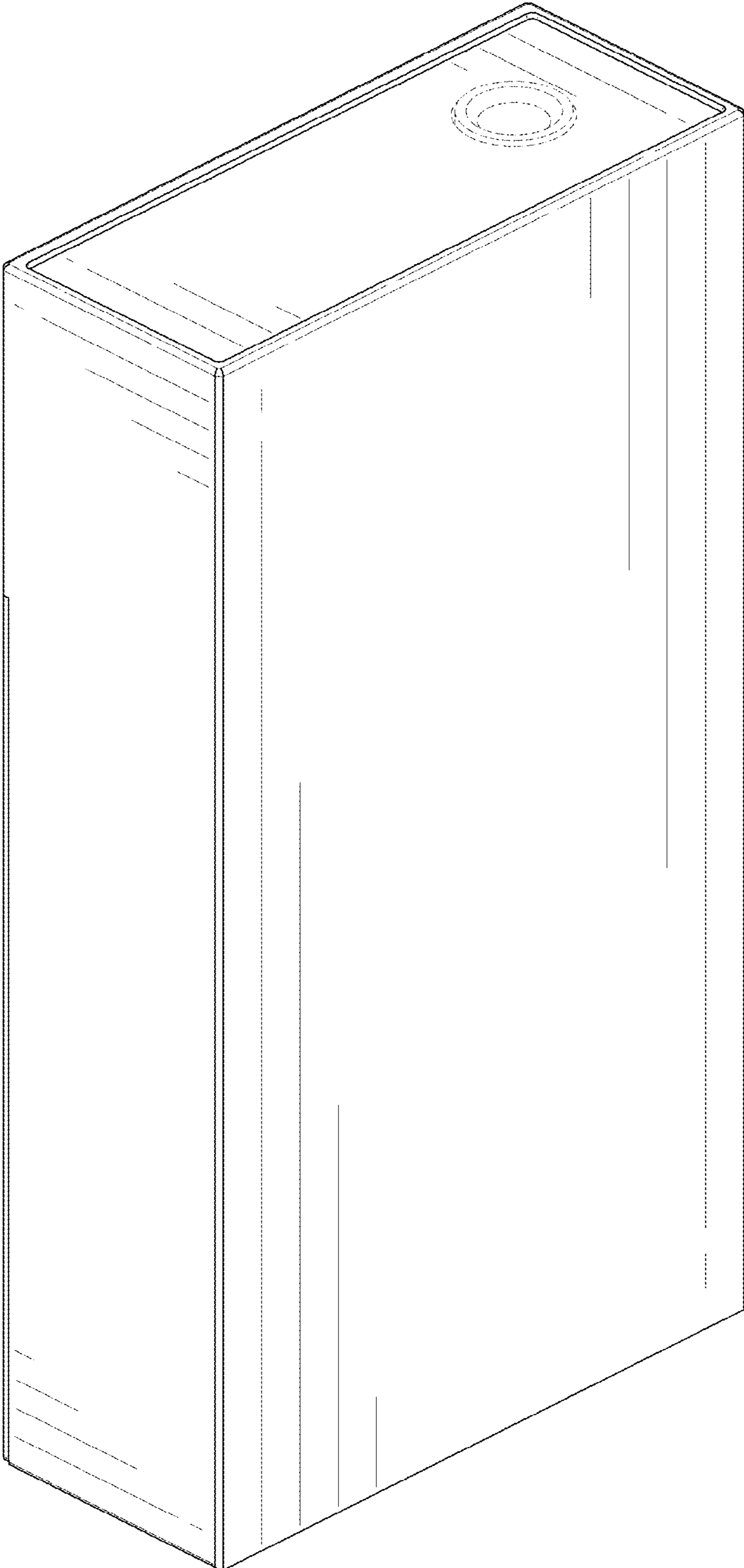

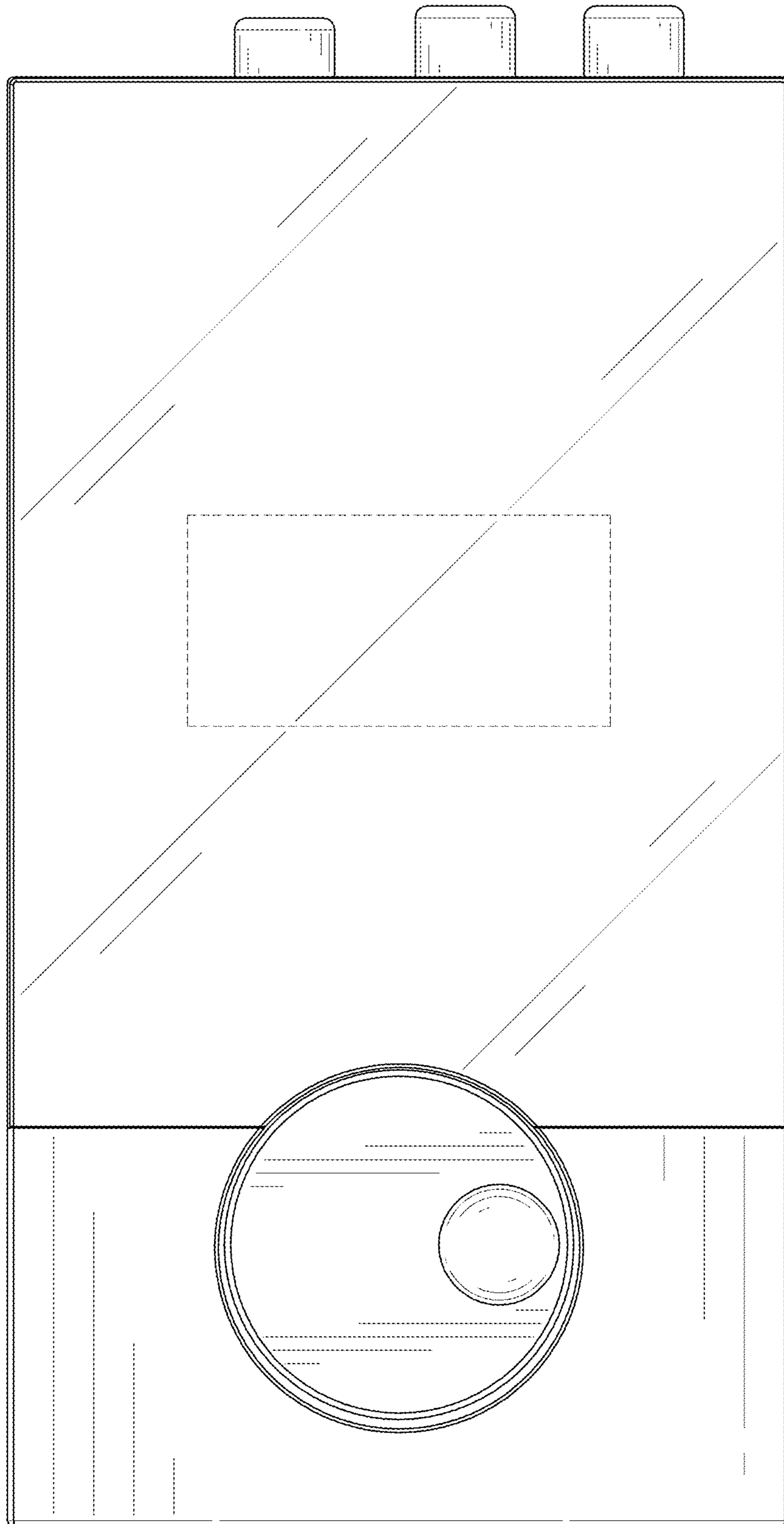

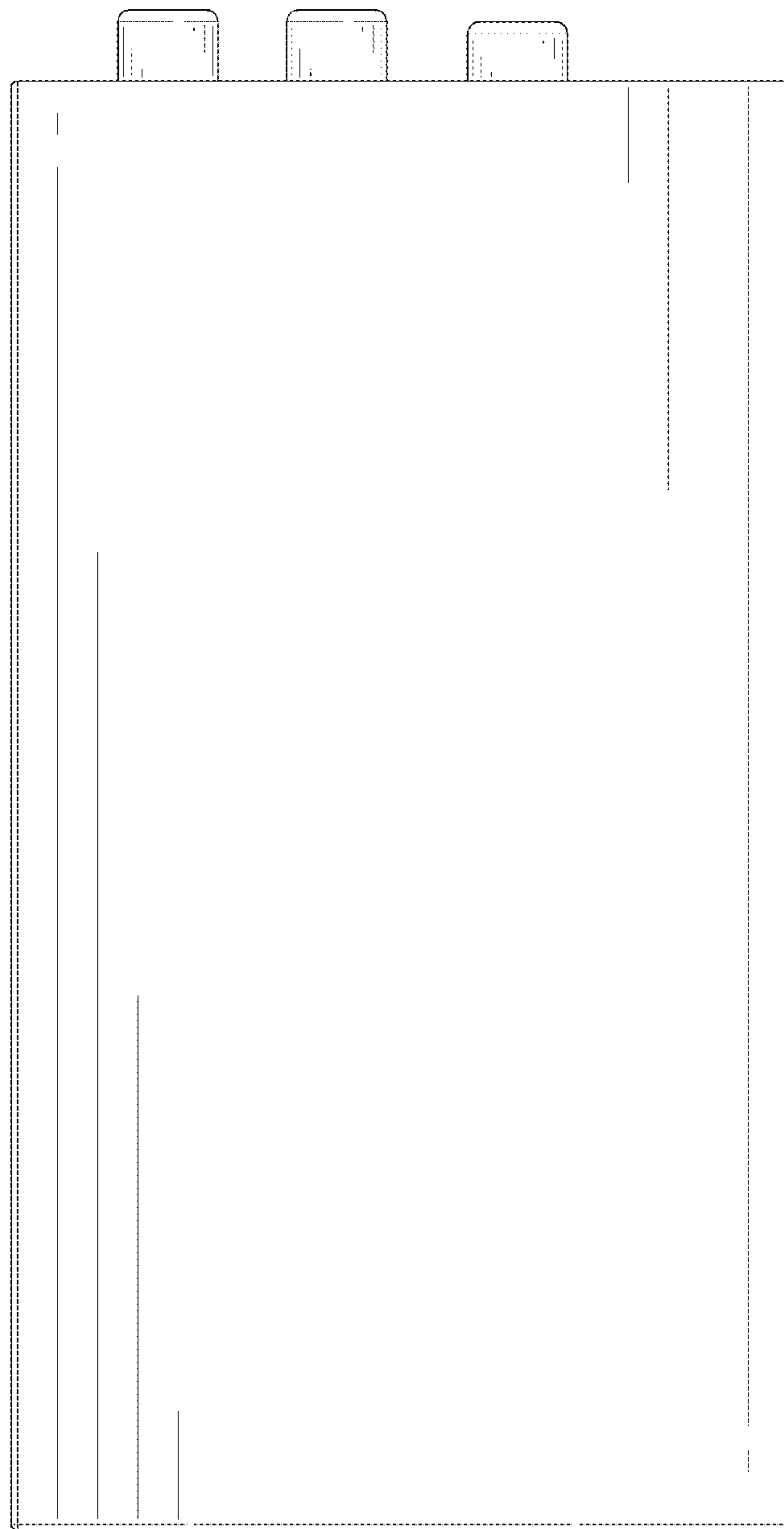

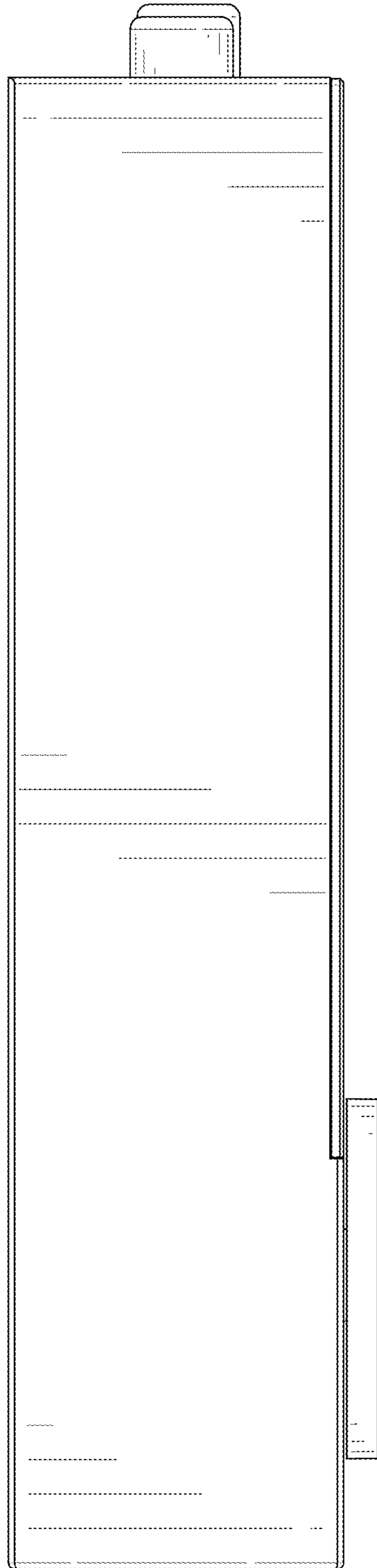

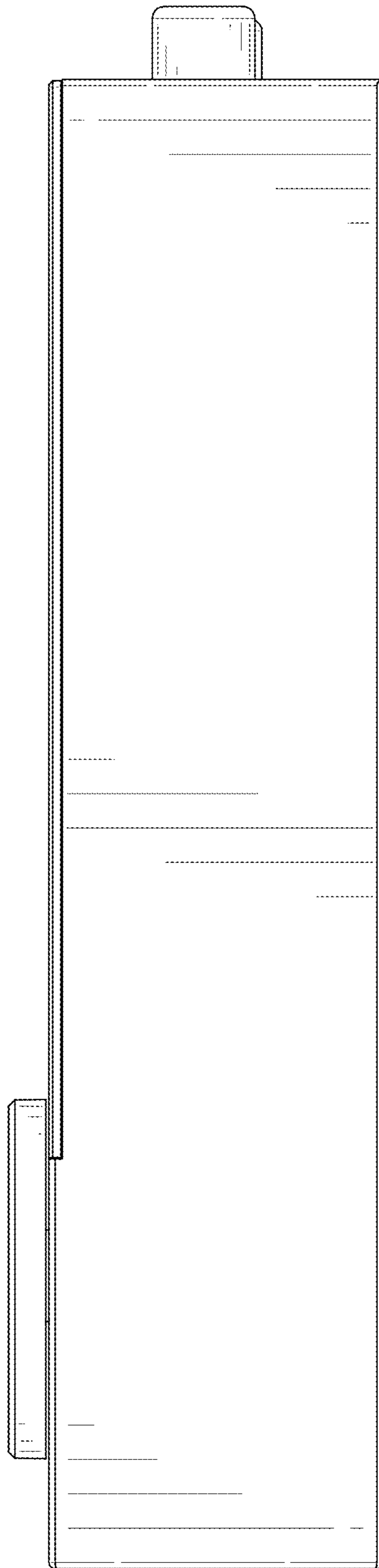

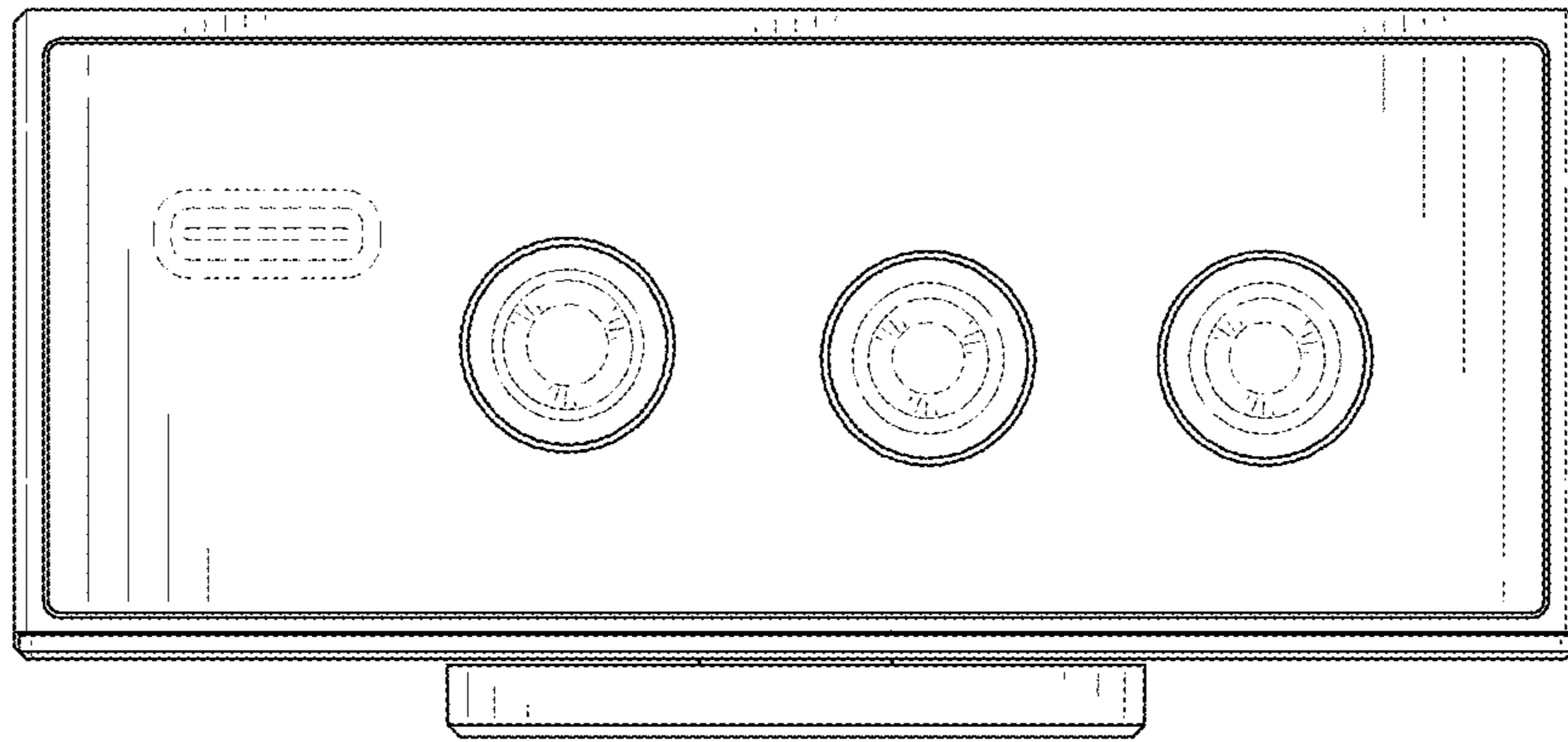

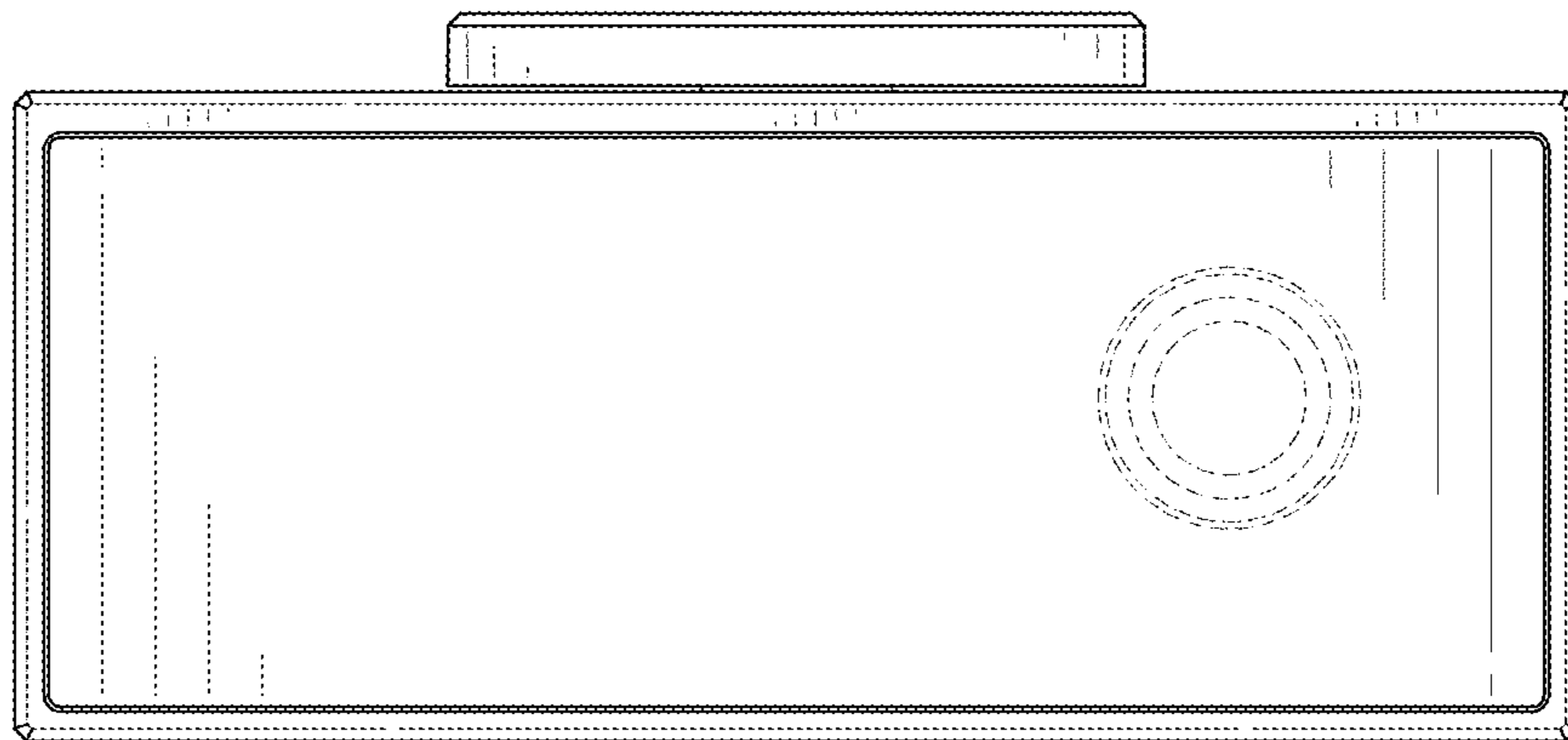
