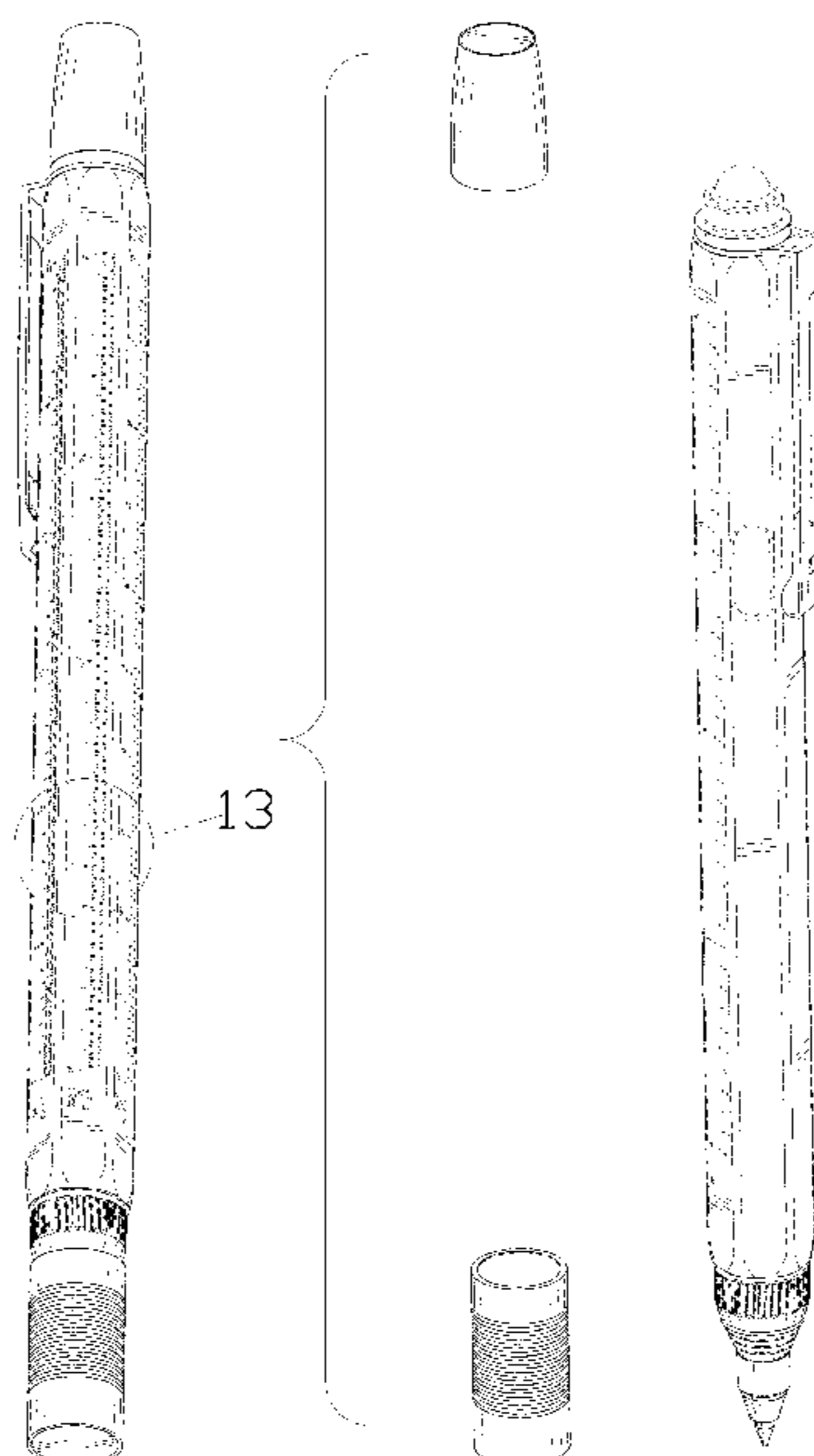
(57) **CLAIM**

The ornamental design for a multifunctional tool pen, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multifunctional tool pen showing my new design;
 FIG. 2 is another perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is a disassembled view of the multifunctional tool pen;
 FIG. 10 is a perspective view of the multifunctional tool pen in an alternate configuration of use;
 FIG. 11 is a perspective view of the multifunctional tool pen in another alternative configuration of use;
 FIG. 12 is an enlarged view of portion 12 shown in FIG. 1;

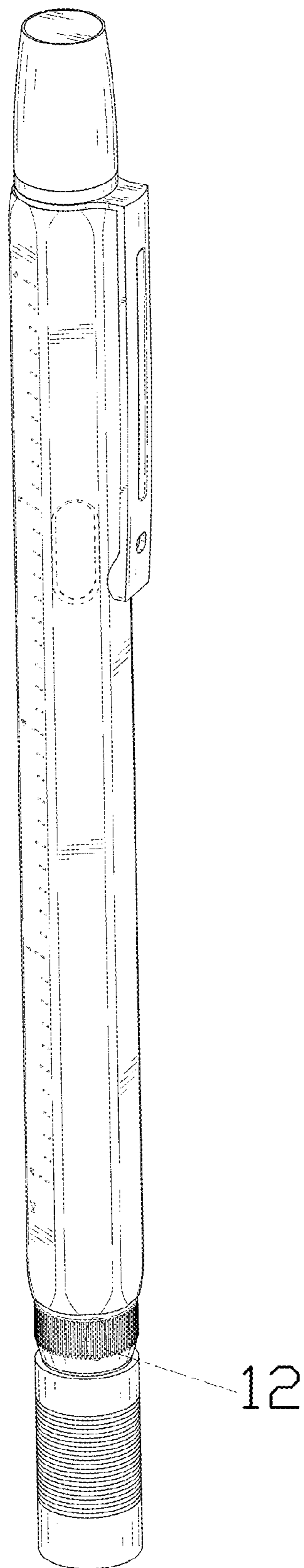

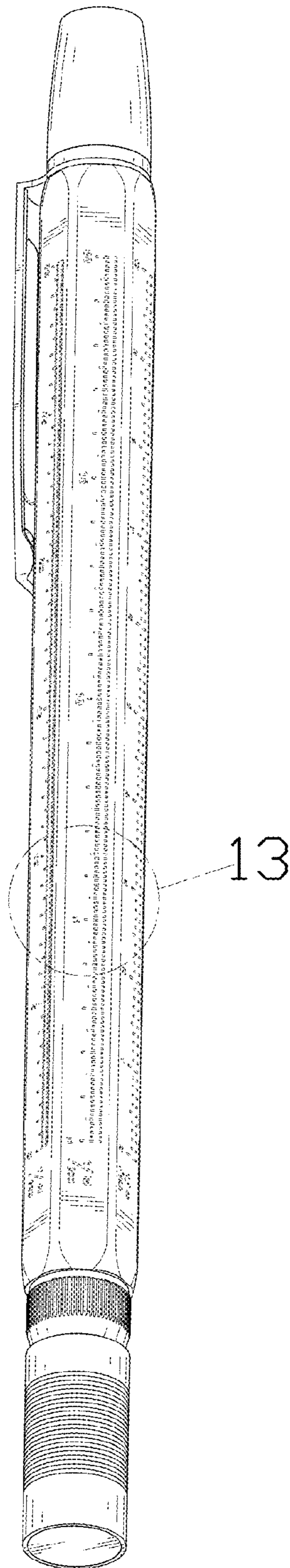

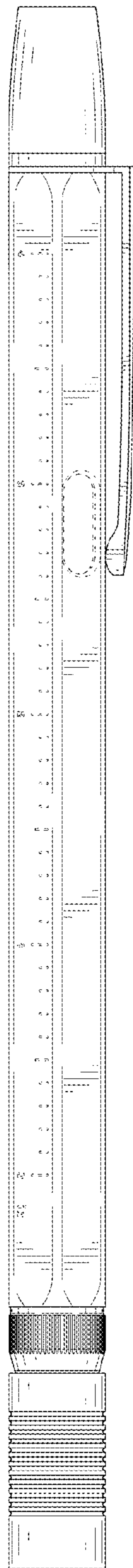

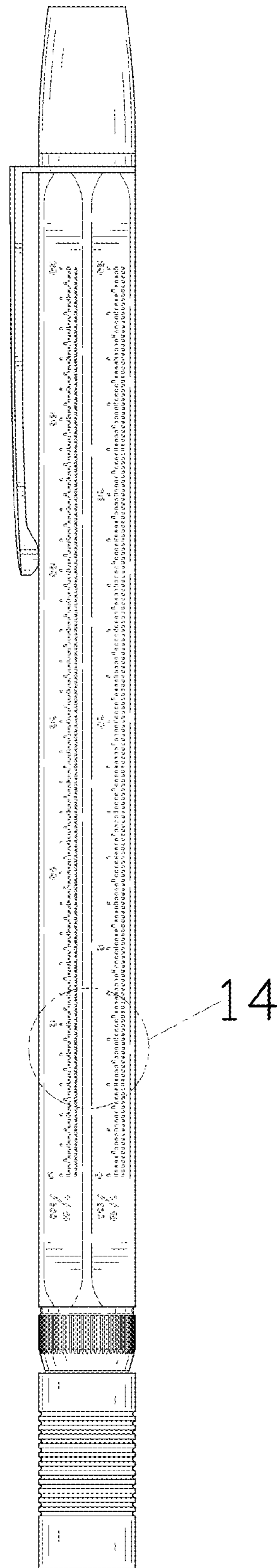

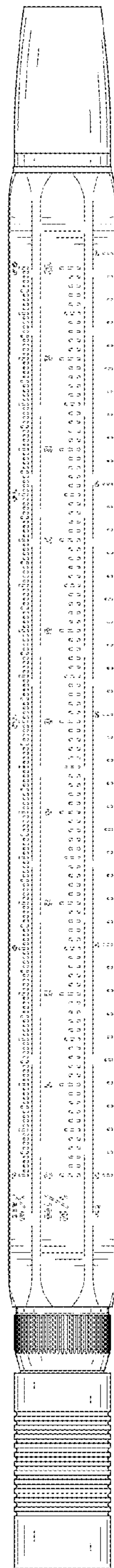

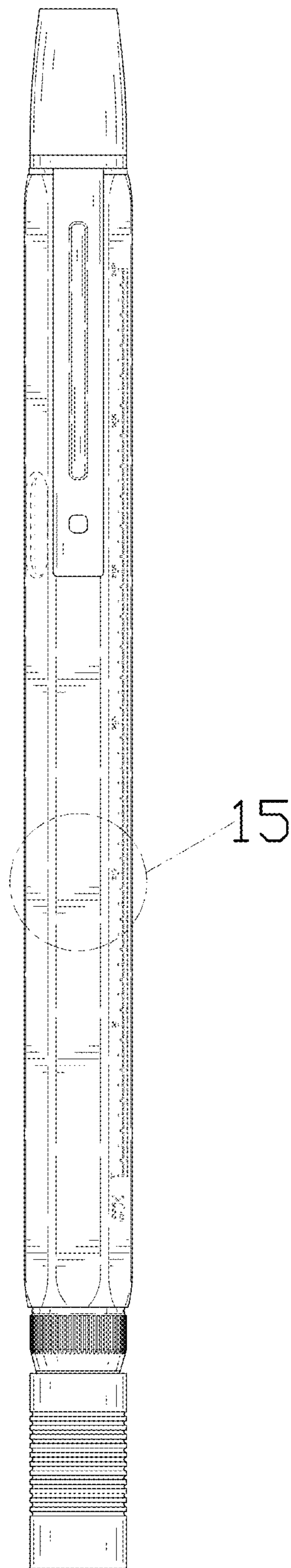

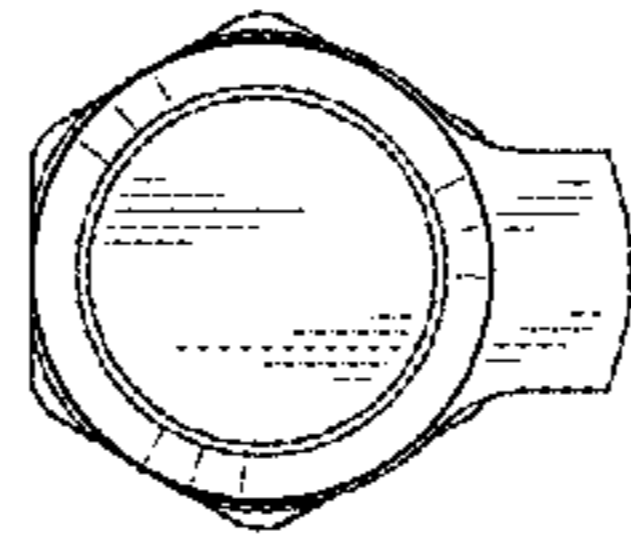

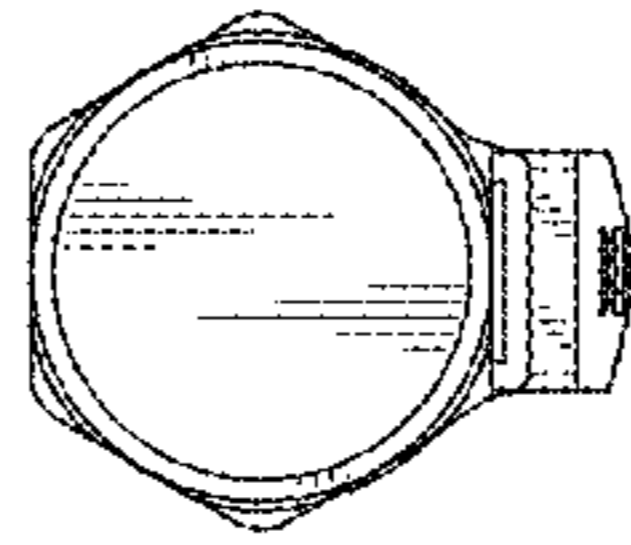

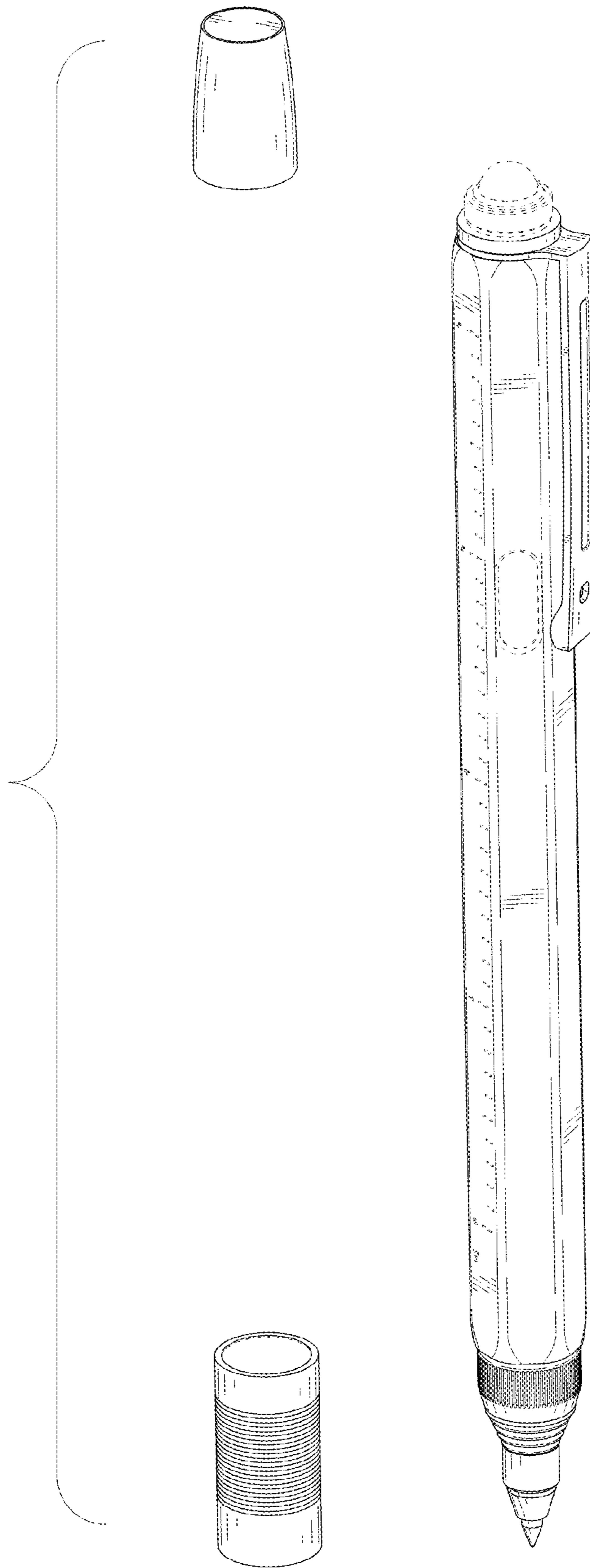

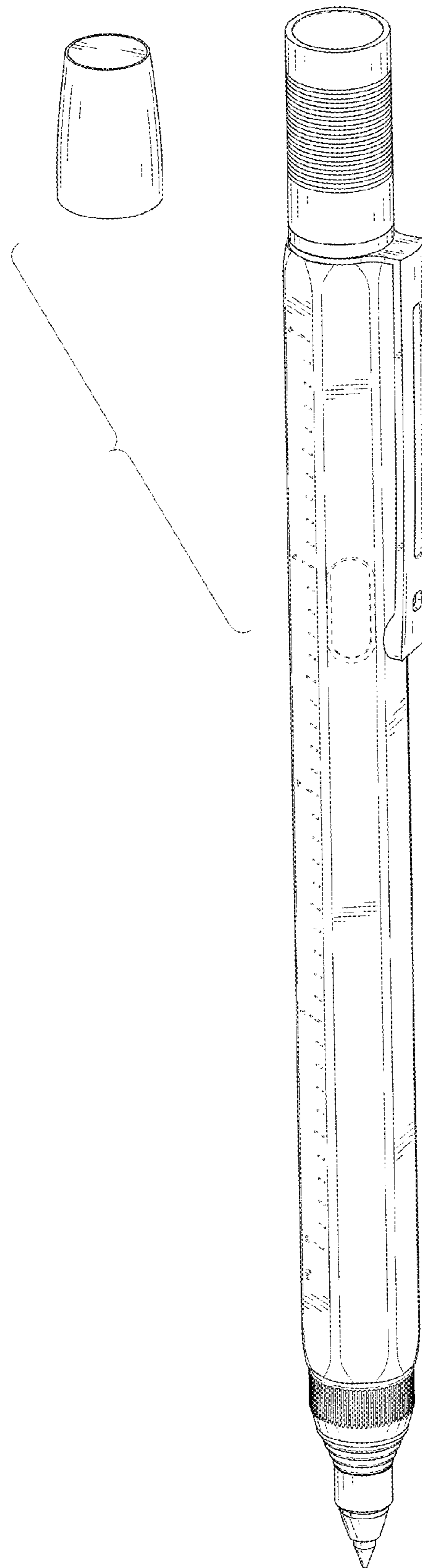

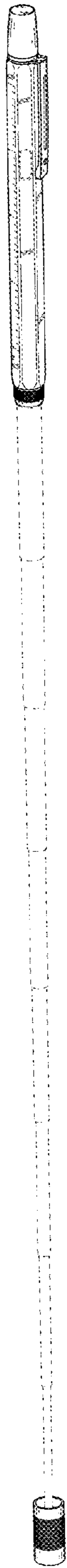

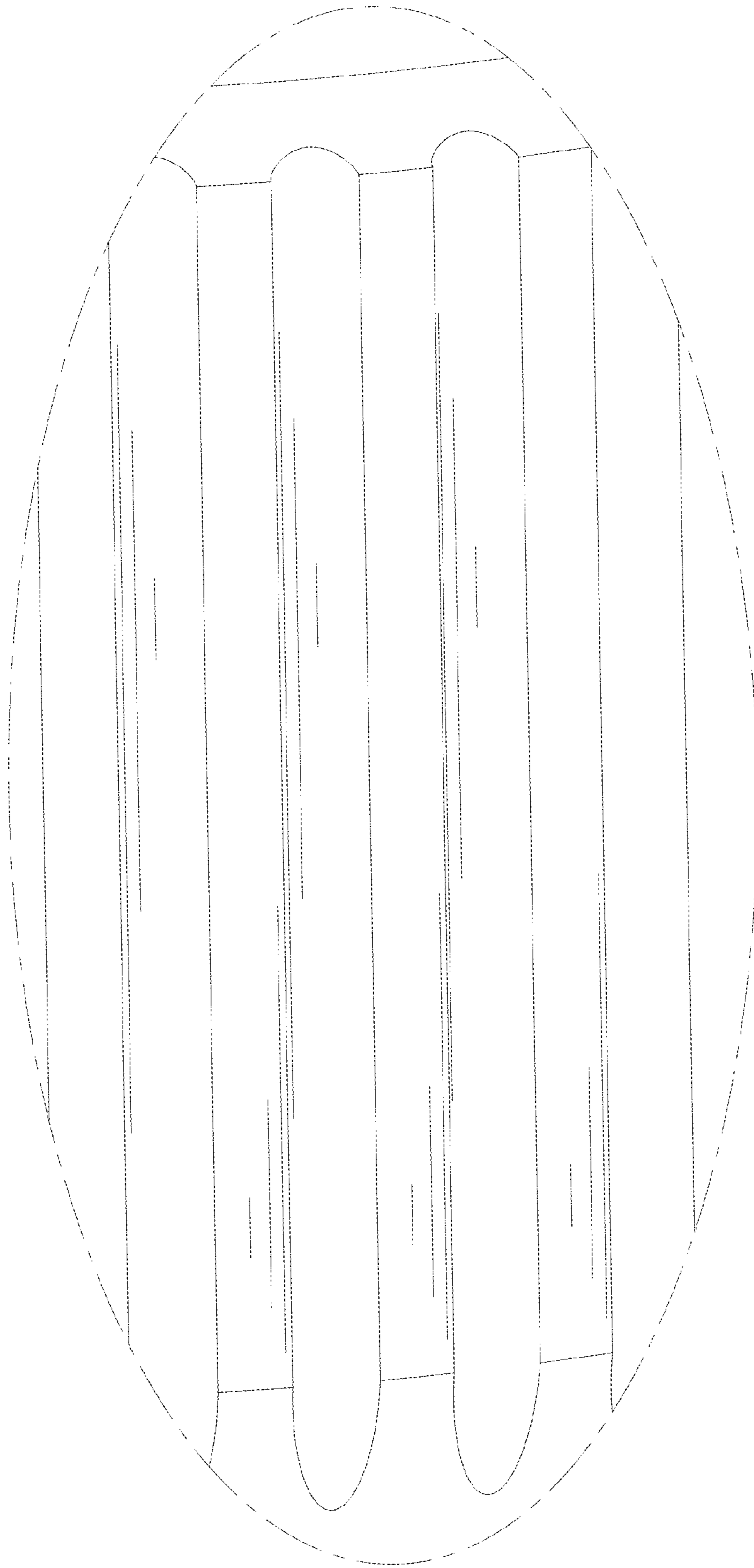

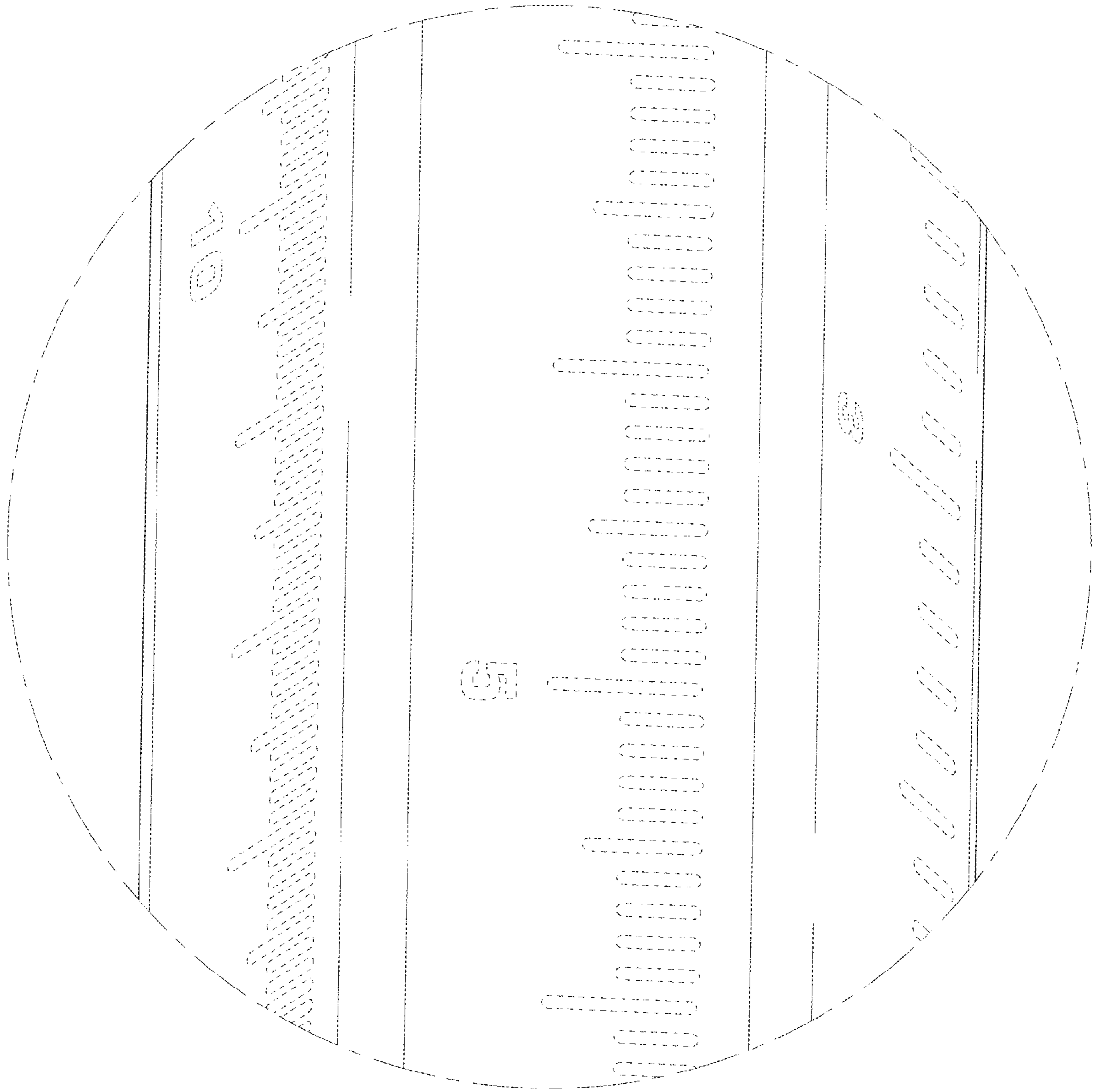

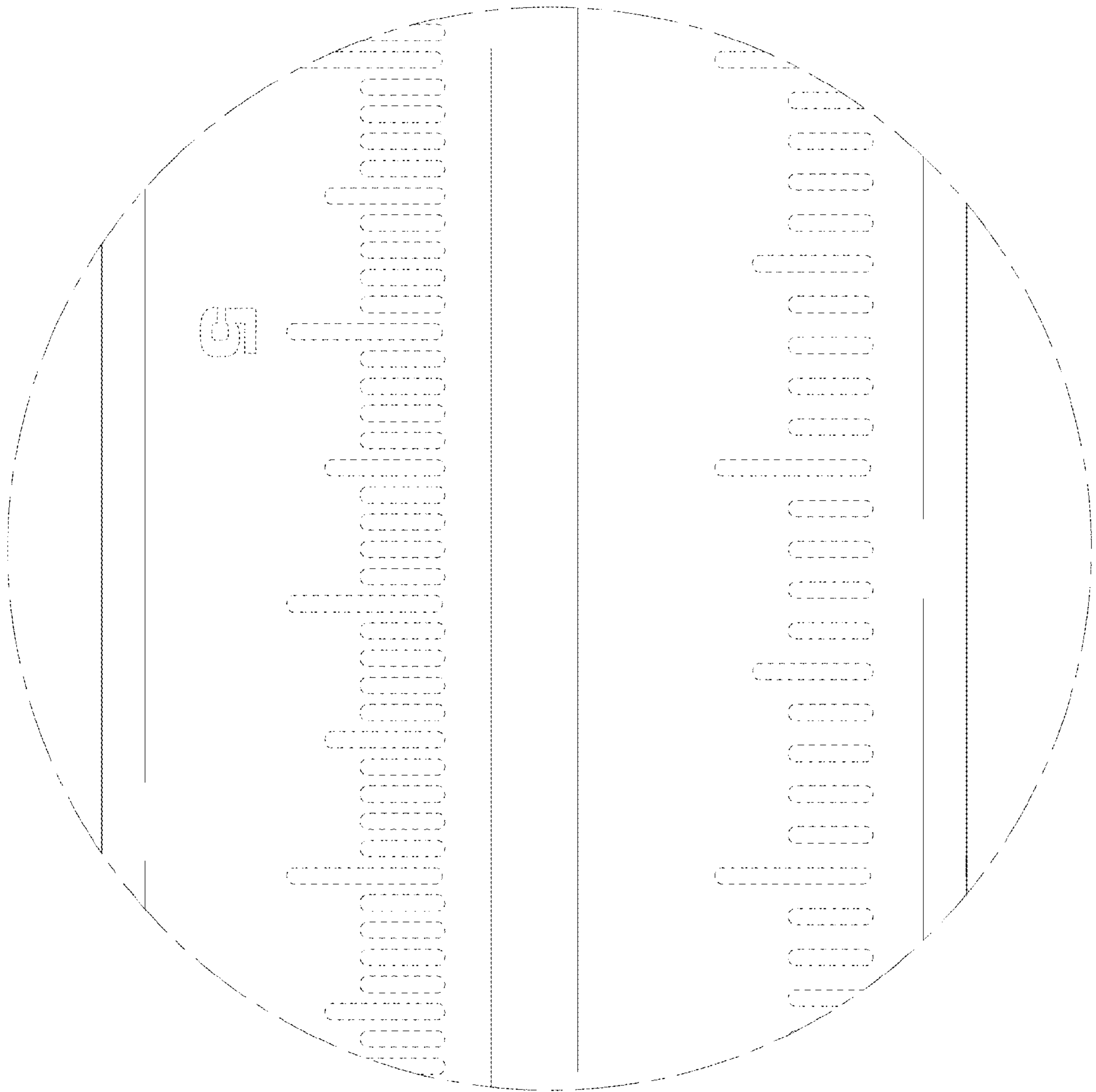

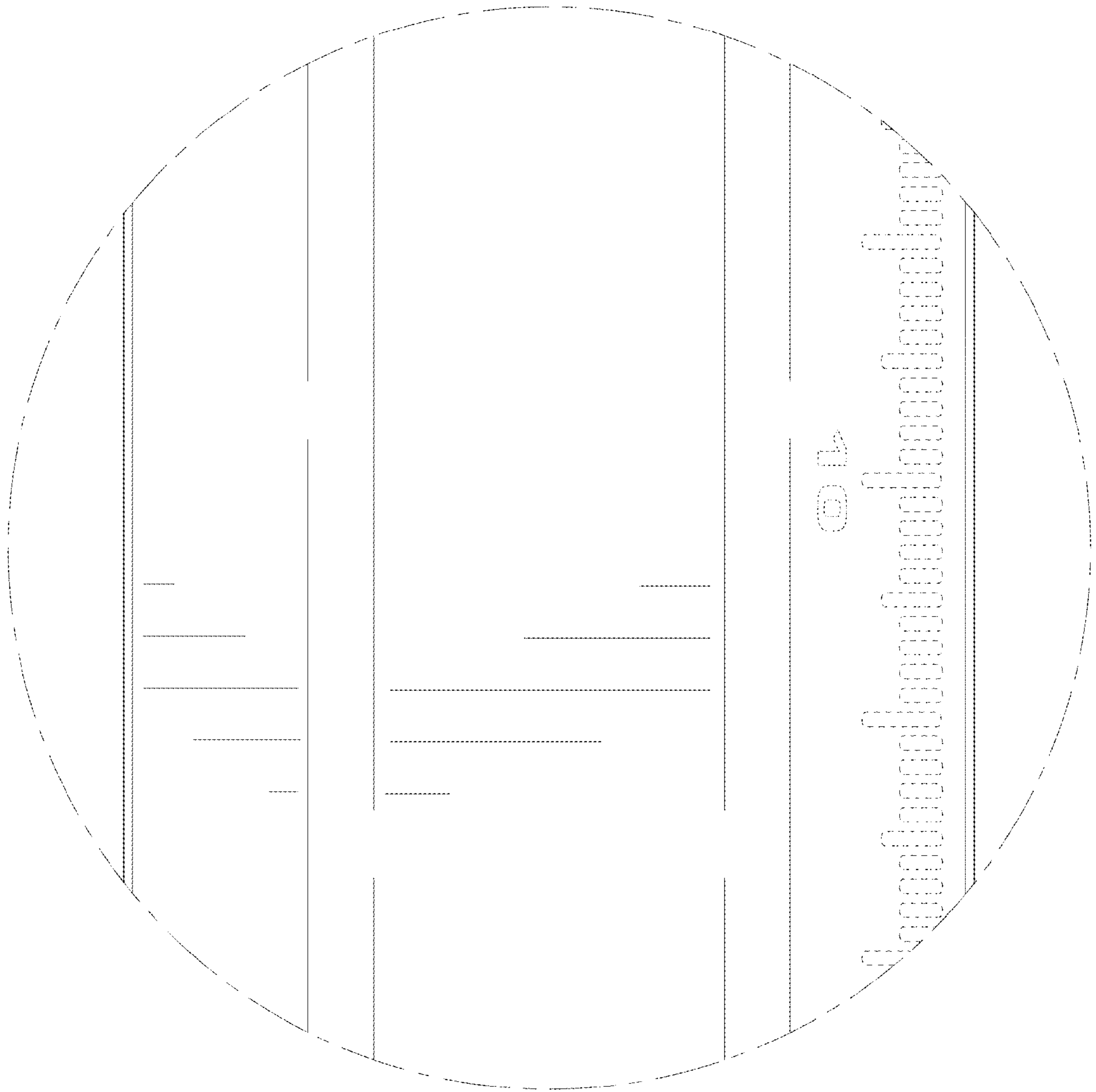
