(57) **CLAIM**

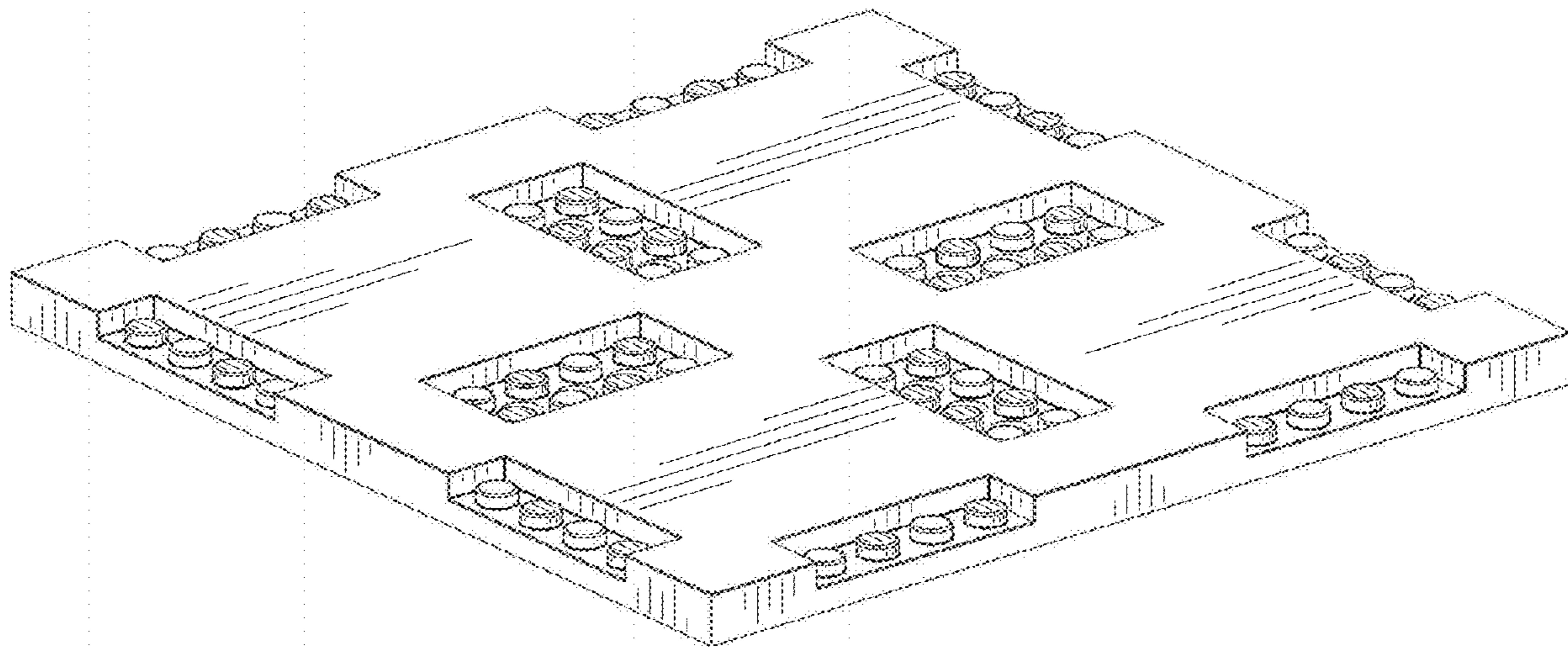
The ornamental design for an element for a toy building set, as shown and described.

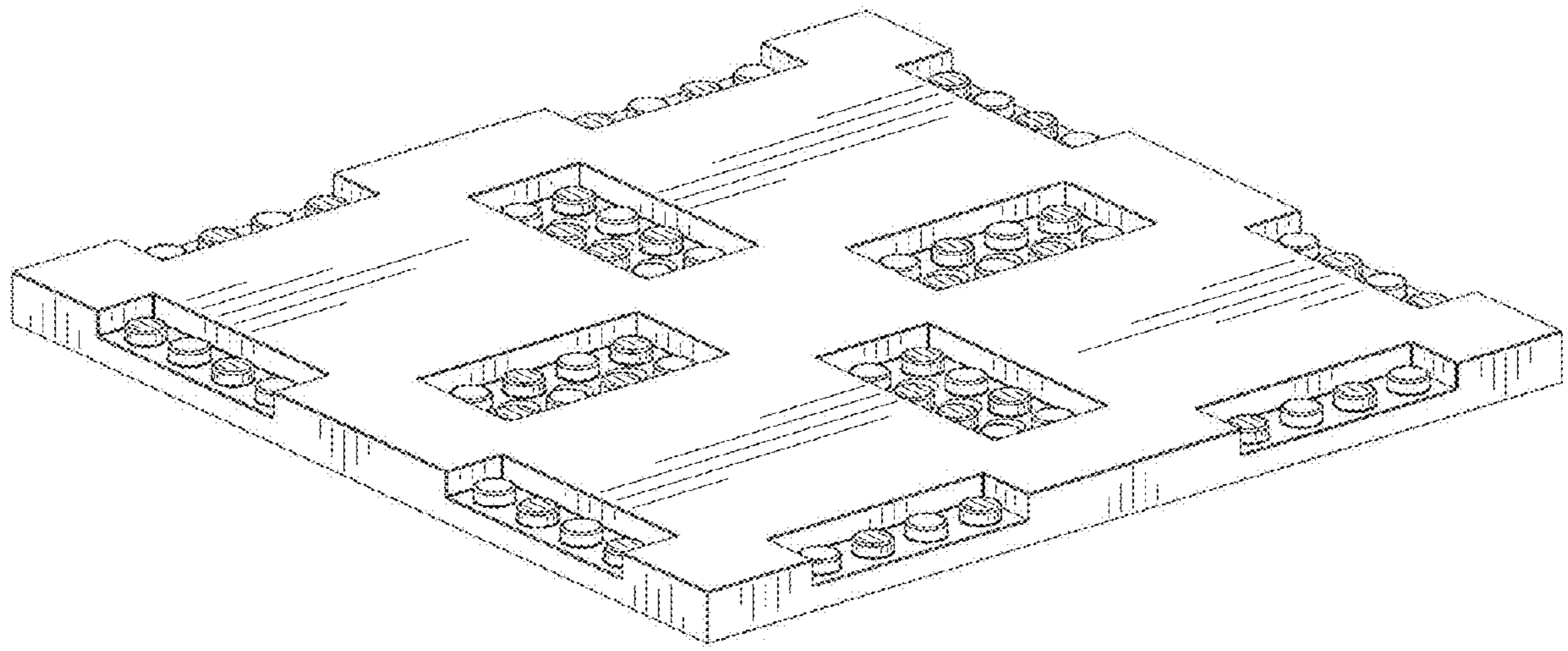

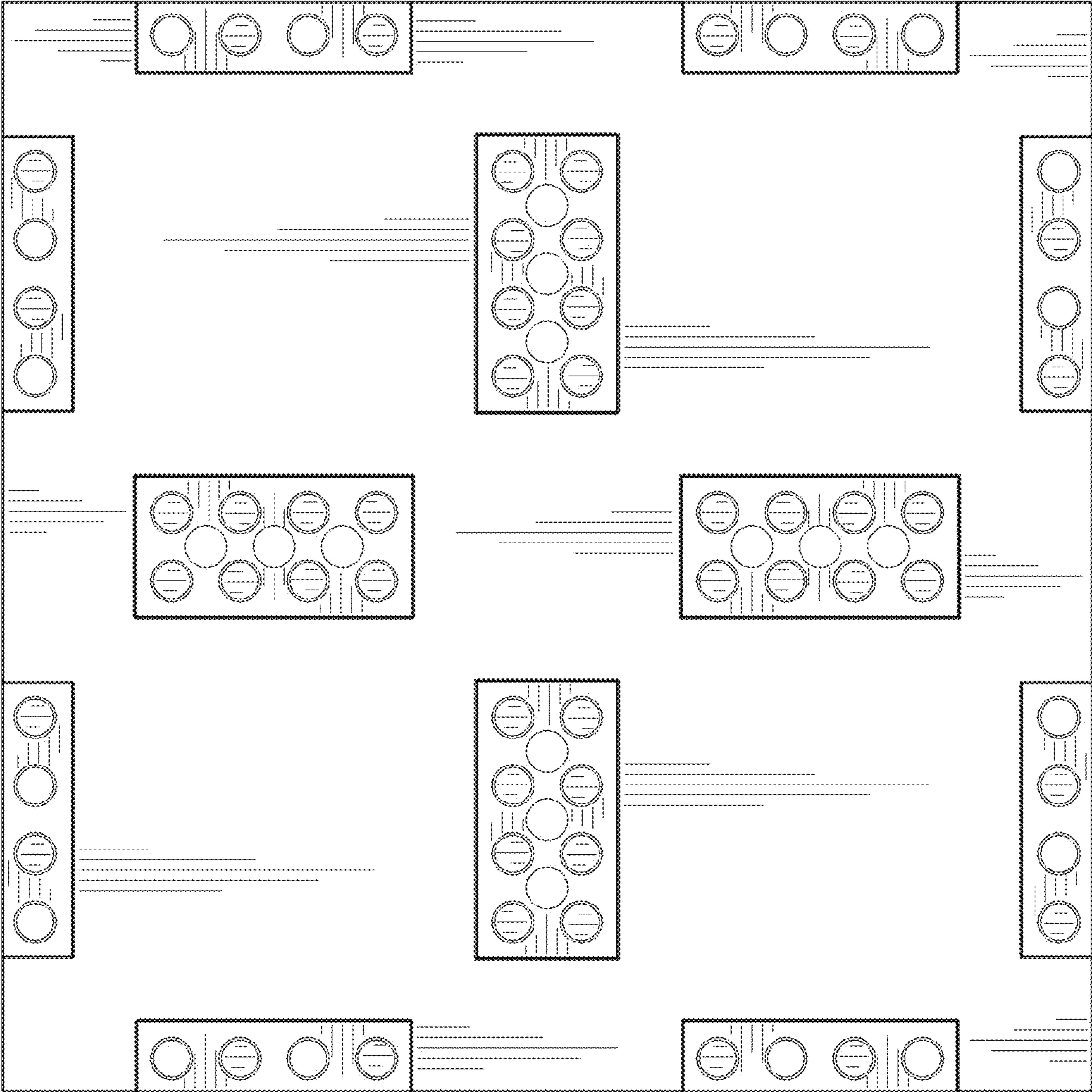

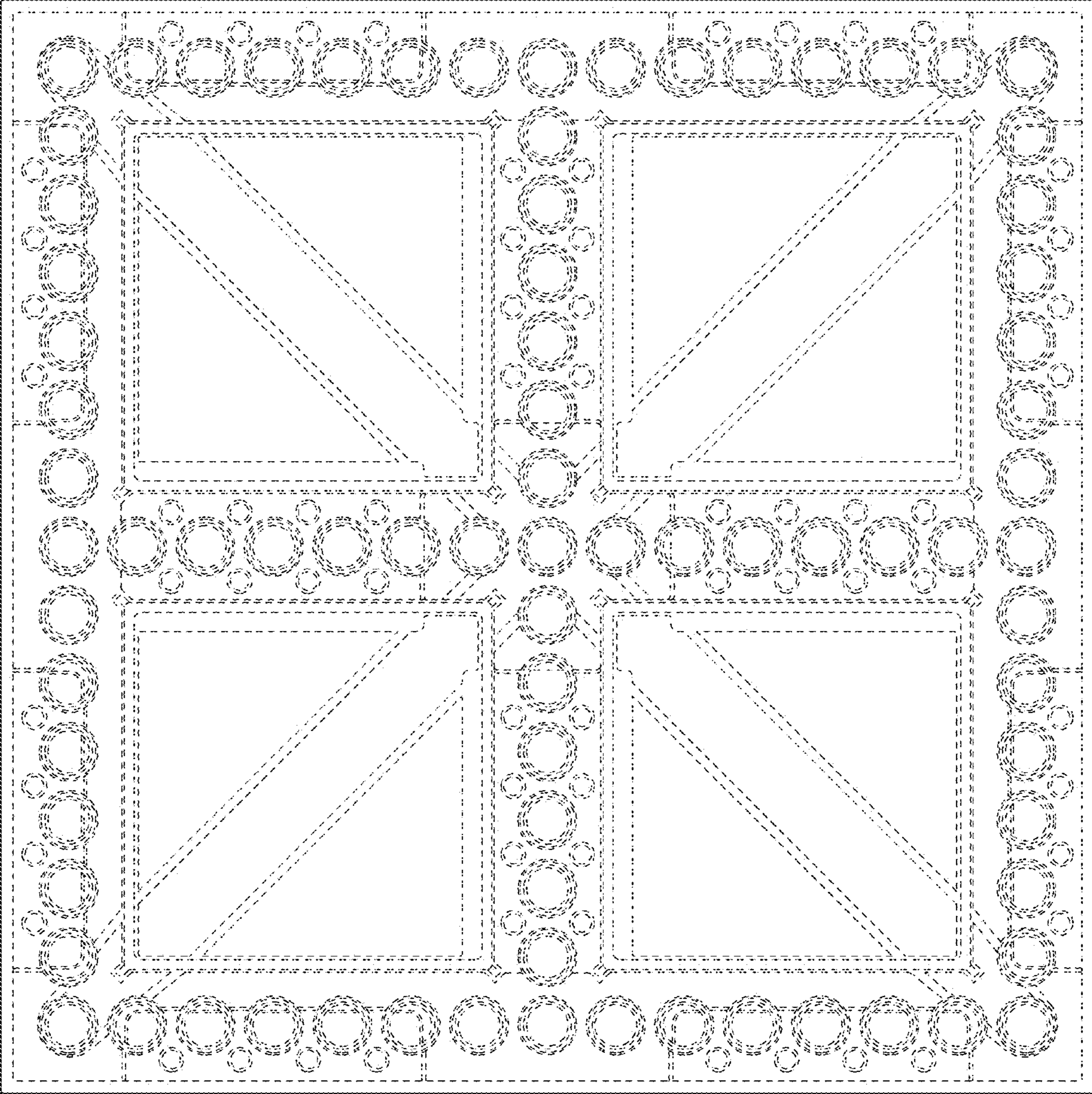
