**DESCRIPTION**

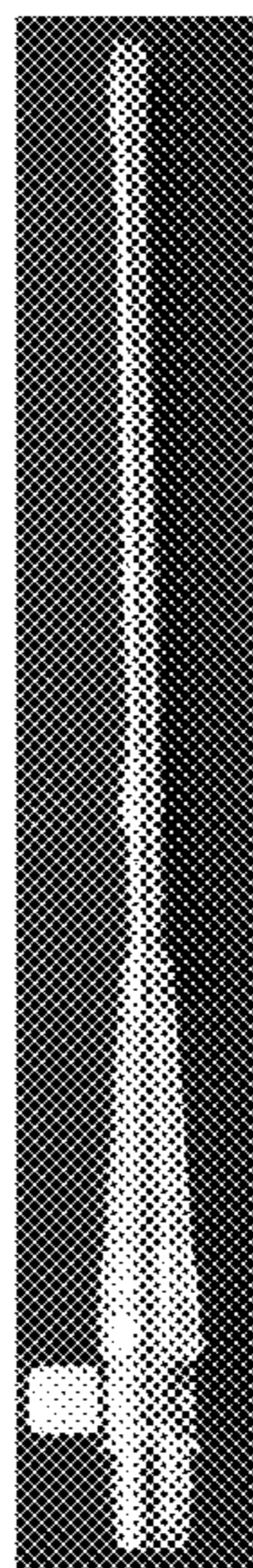
FIG. 1 is a right side elevation view of a new design for a cannula;

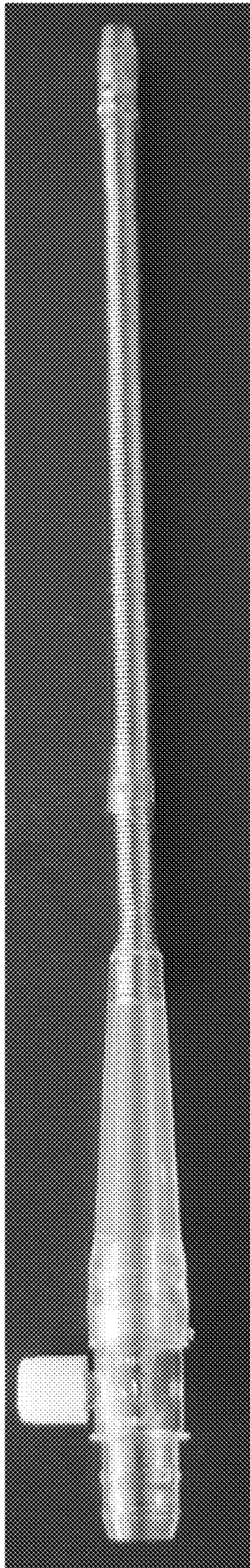

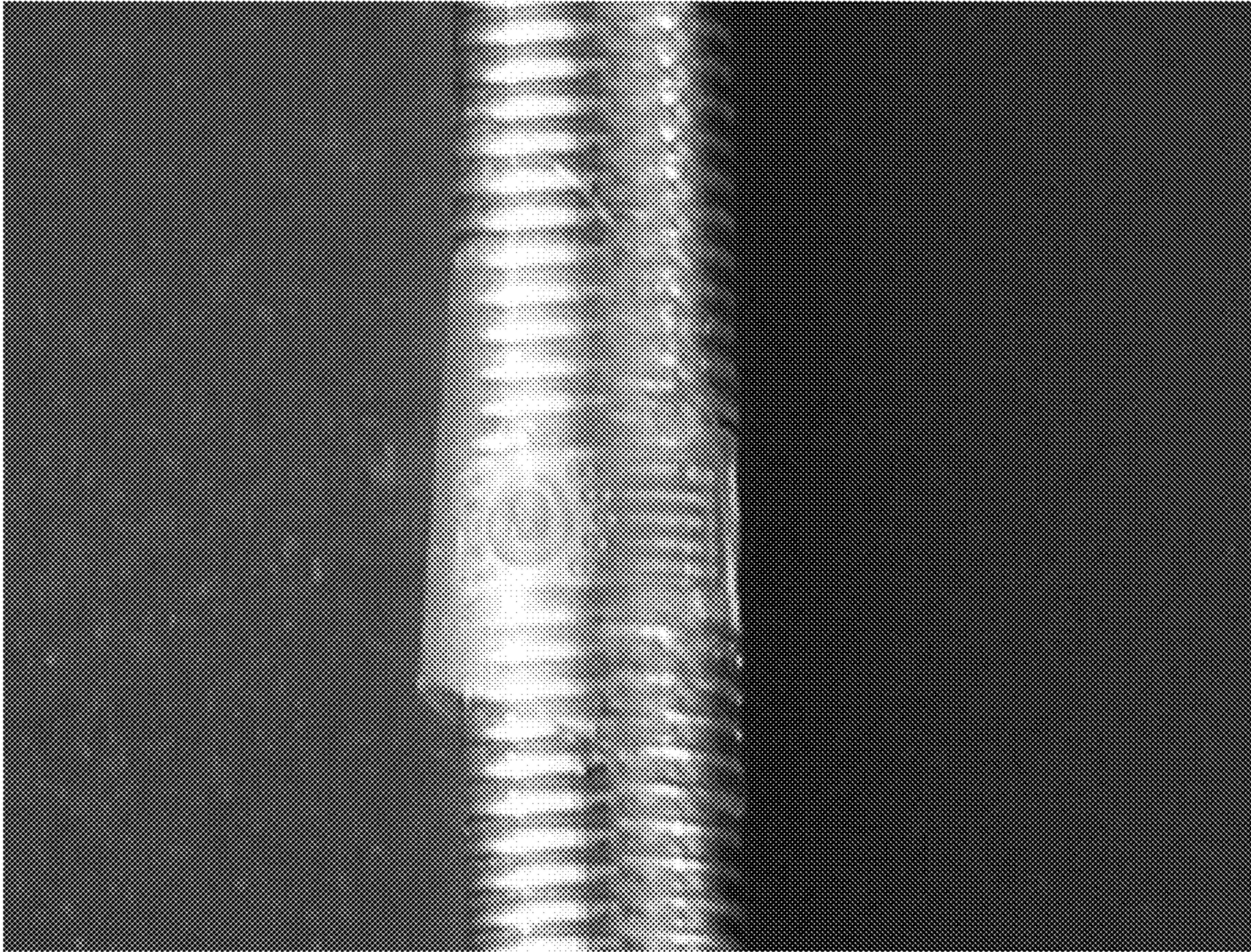

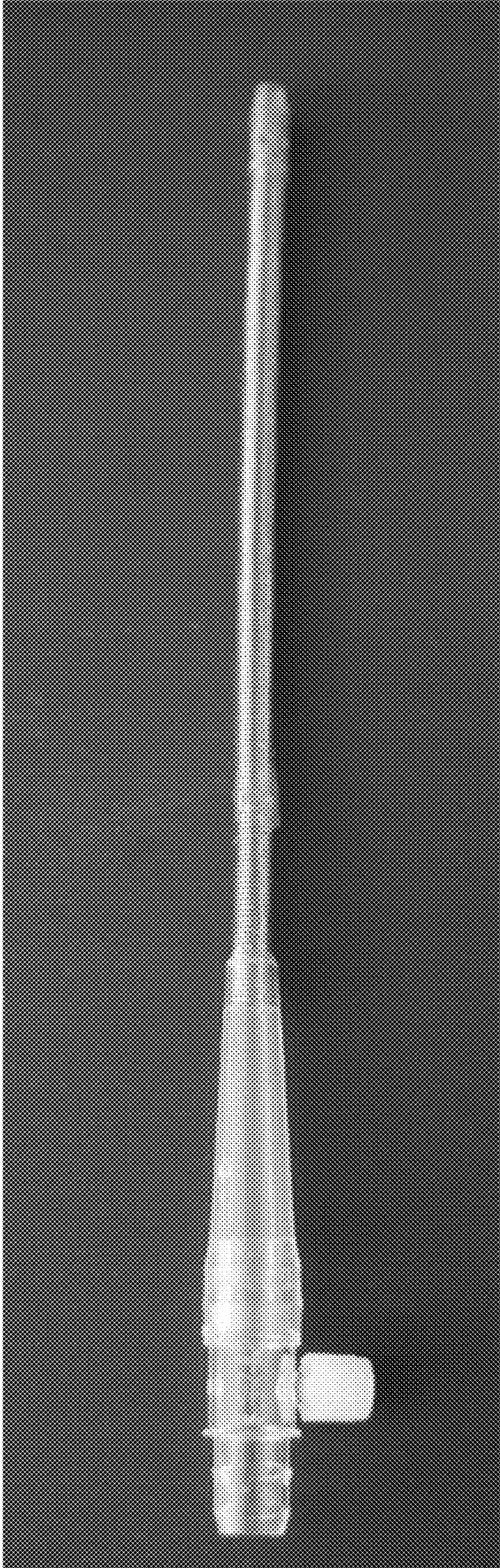

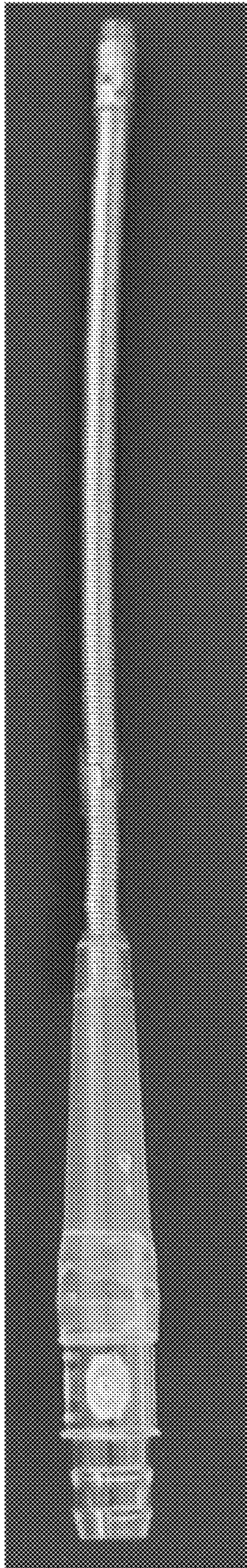

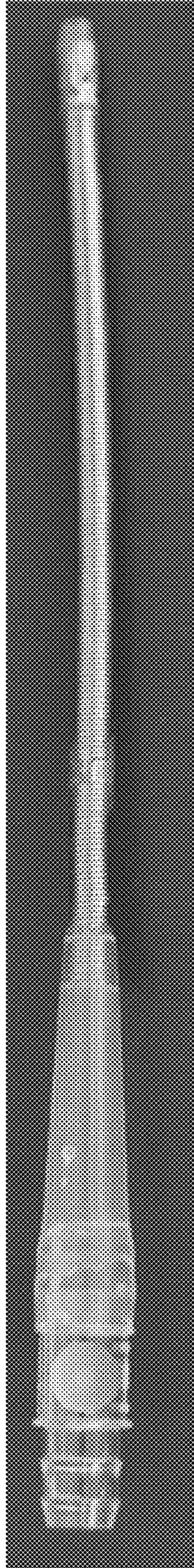

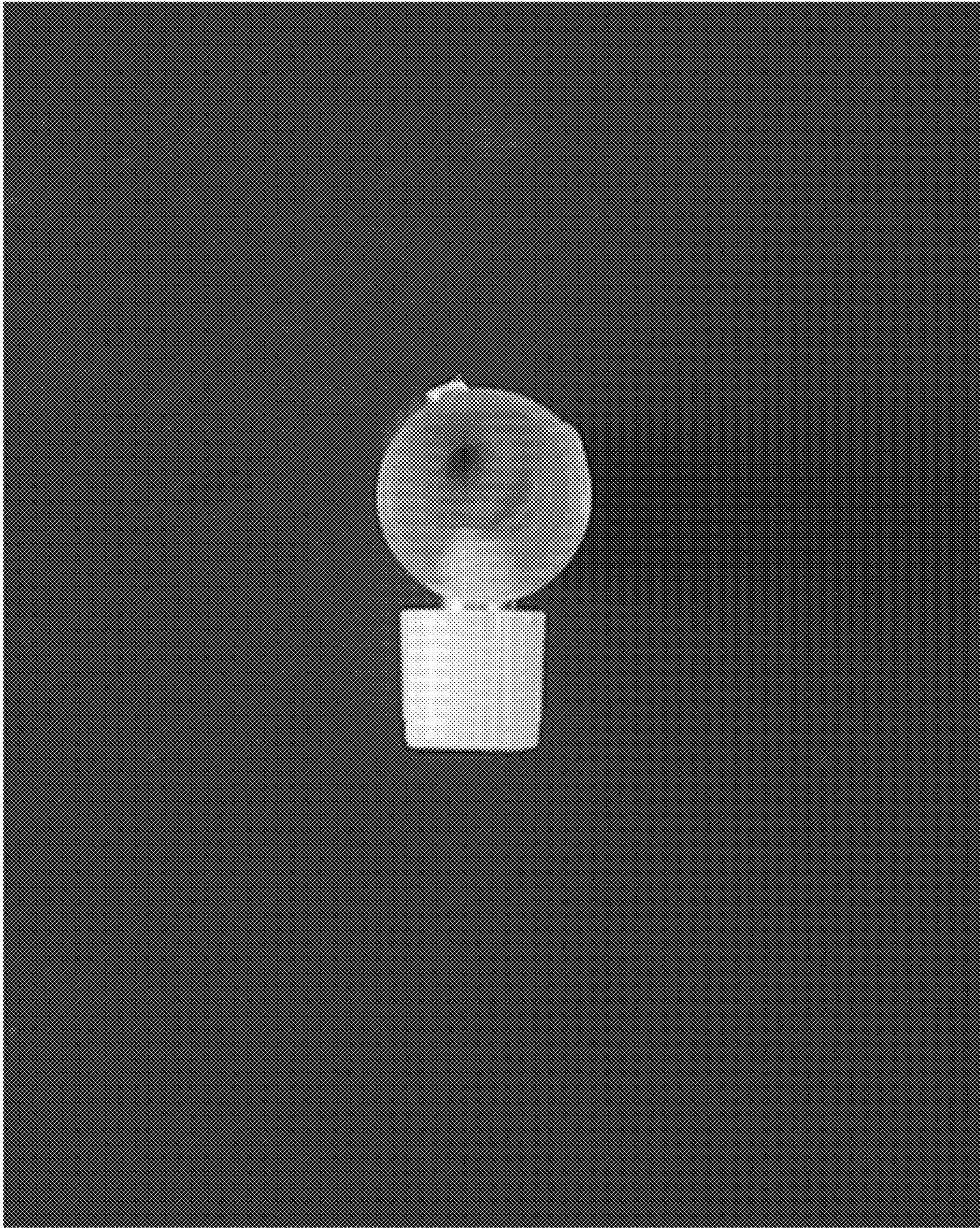

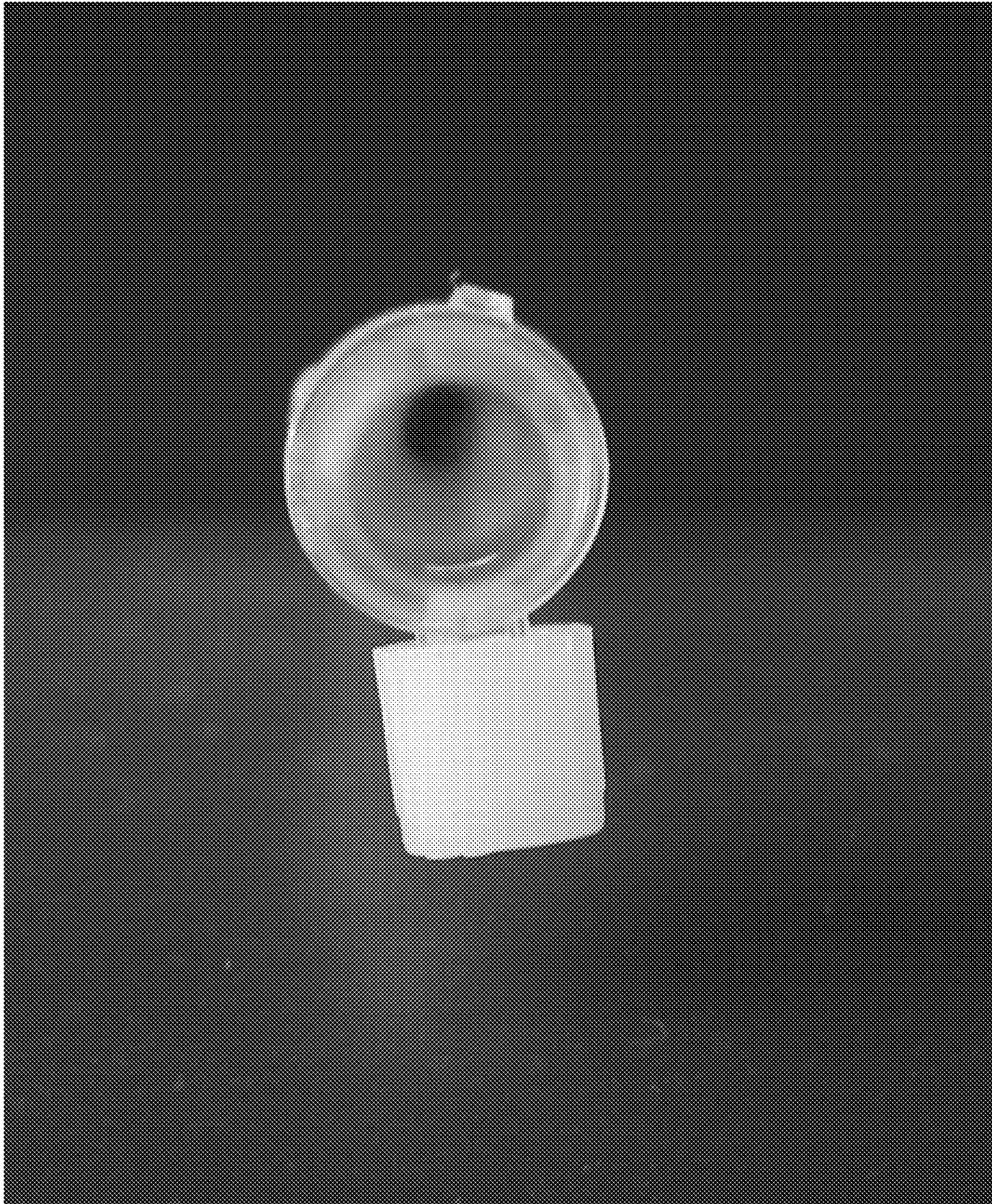
