FIG. 7 is a reduced top perspective view thereof, wherein the razor blade and the razor cartridge are attached onto the shaver handle.

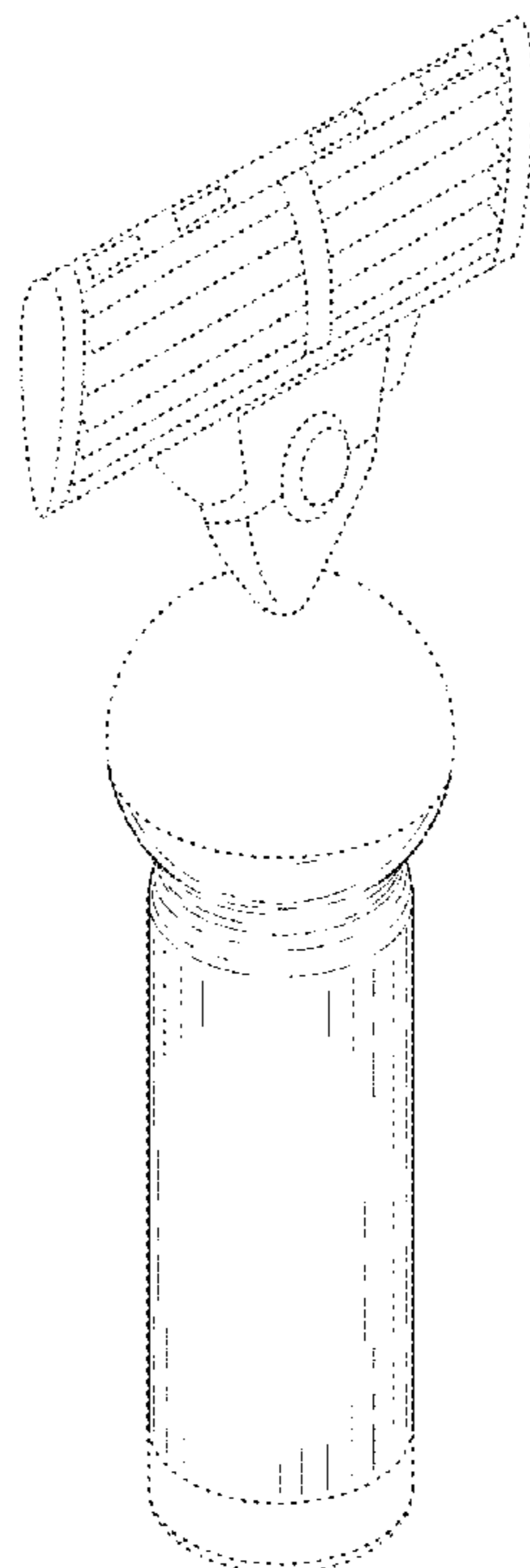

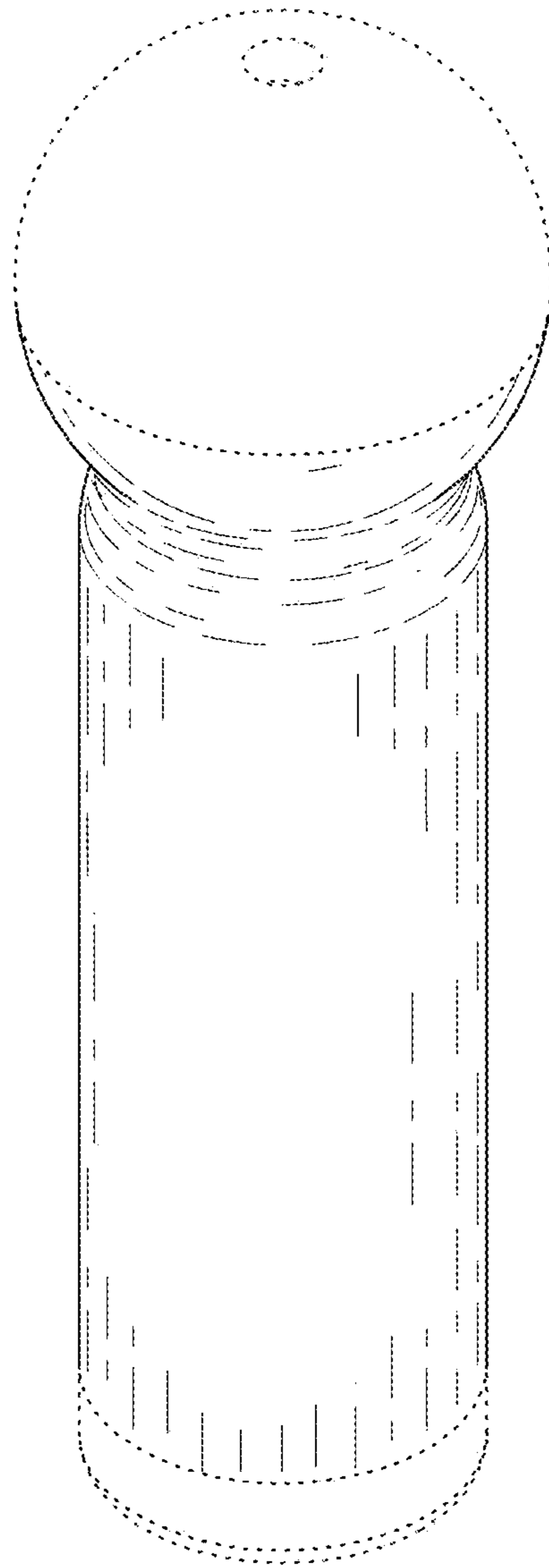

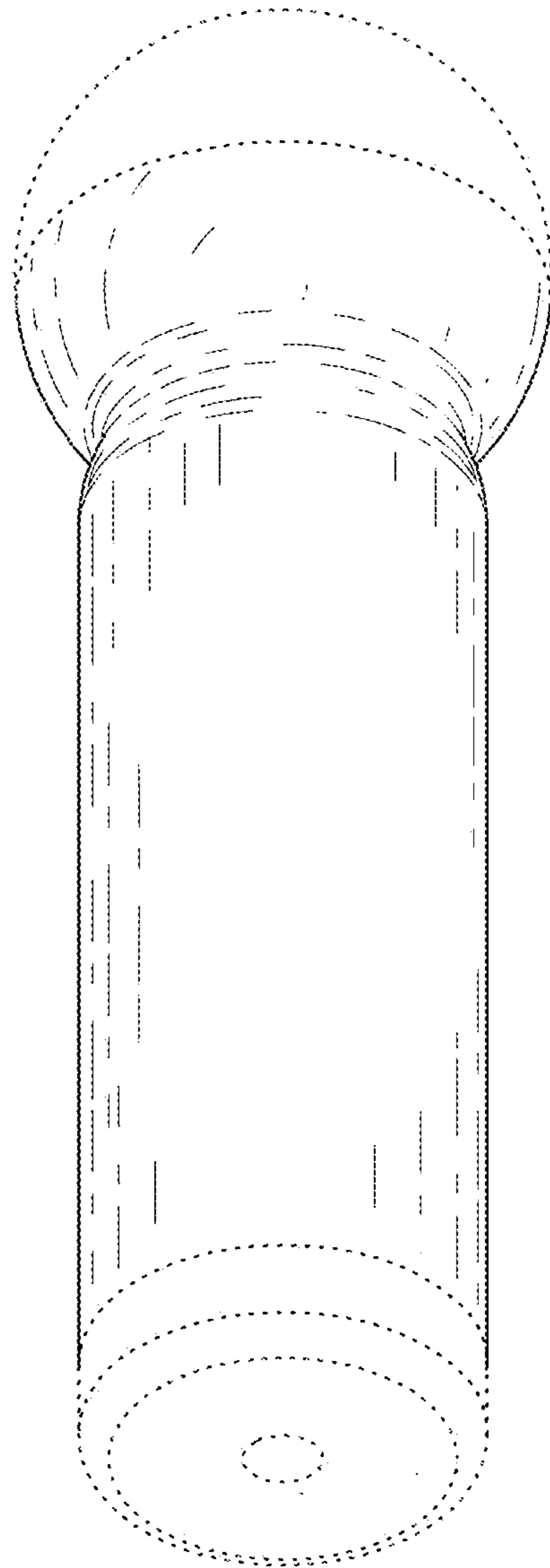

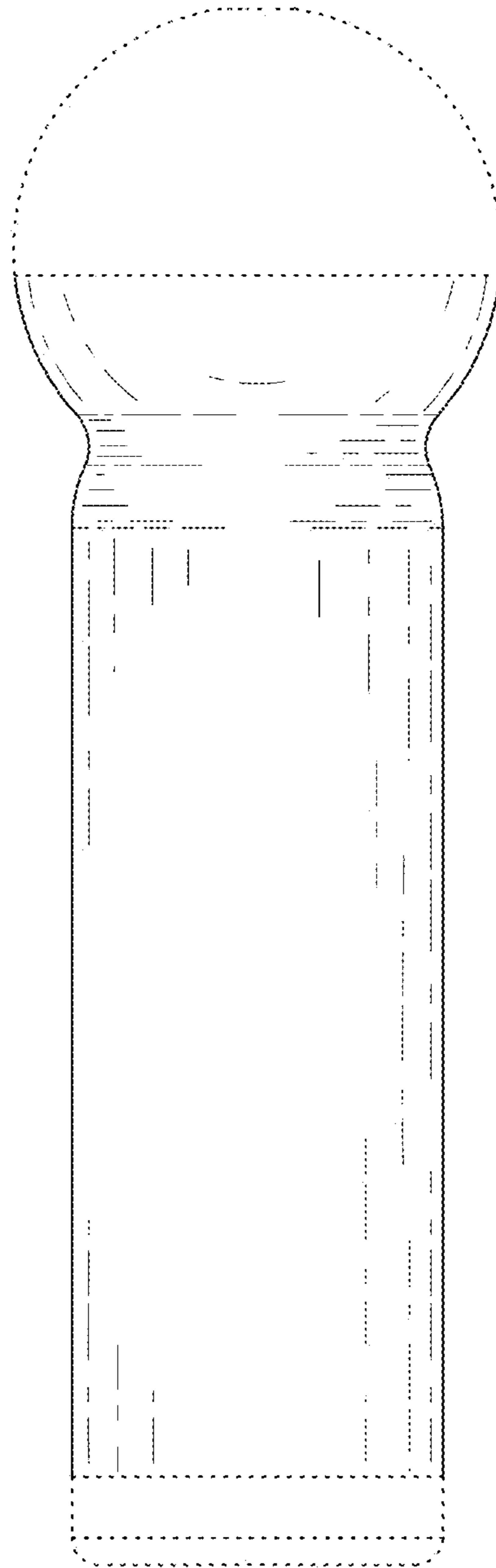

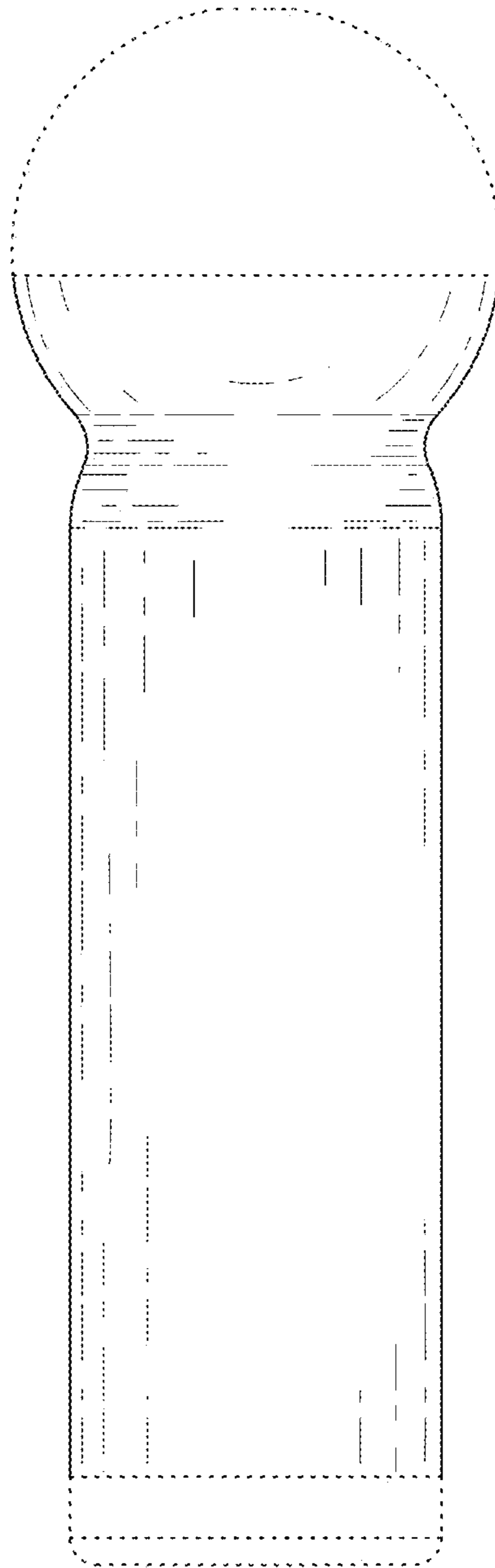

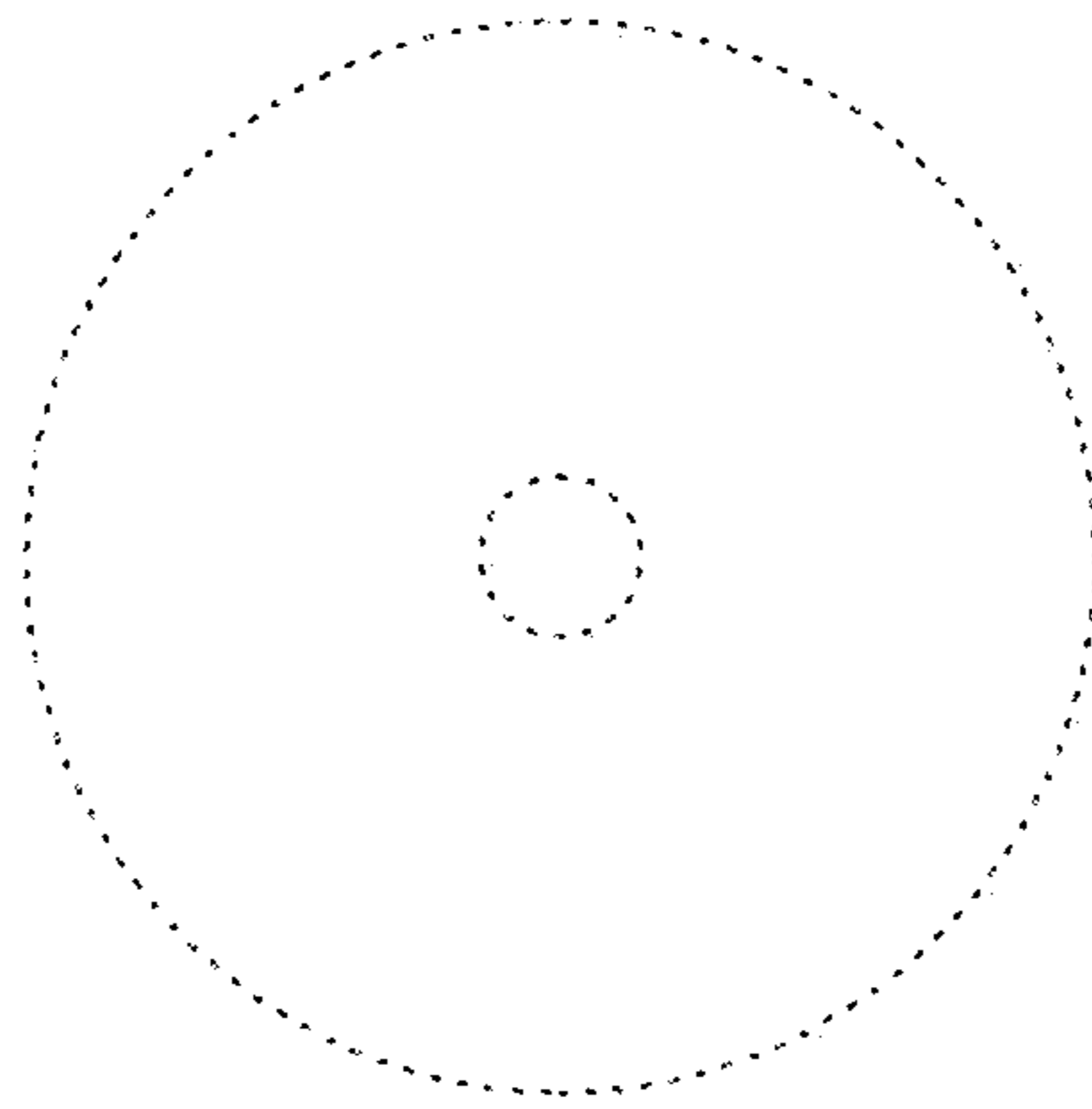

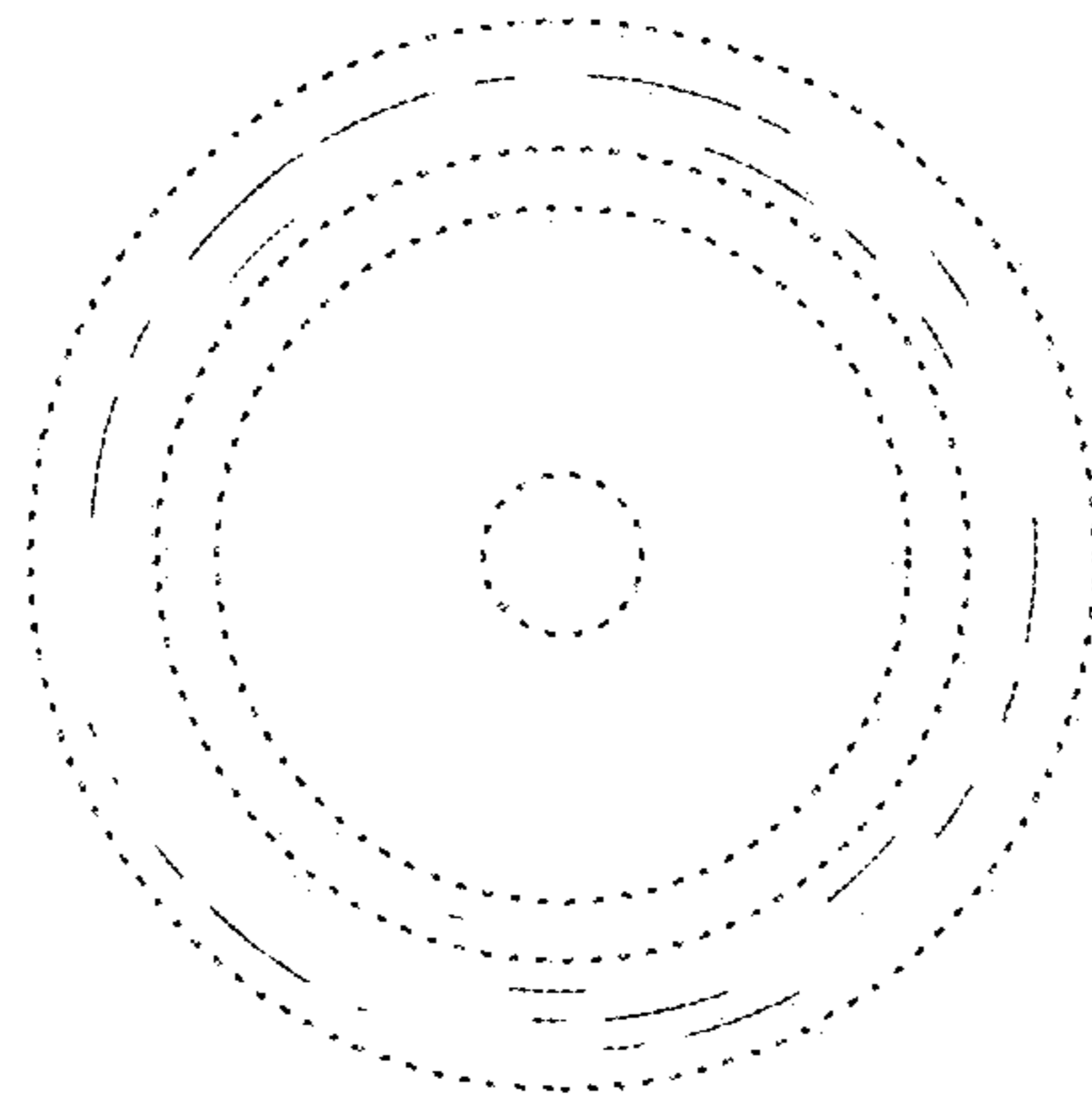

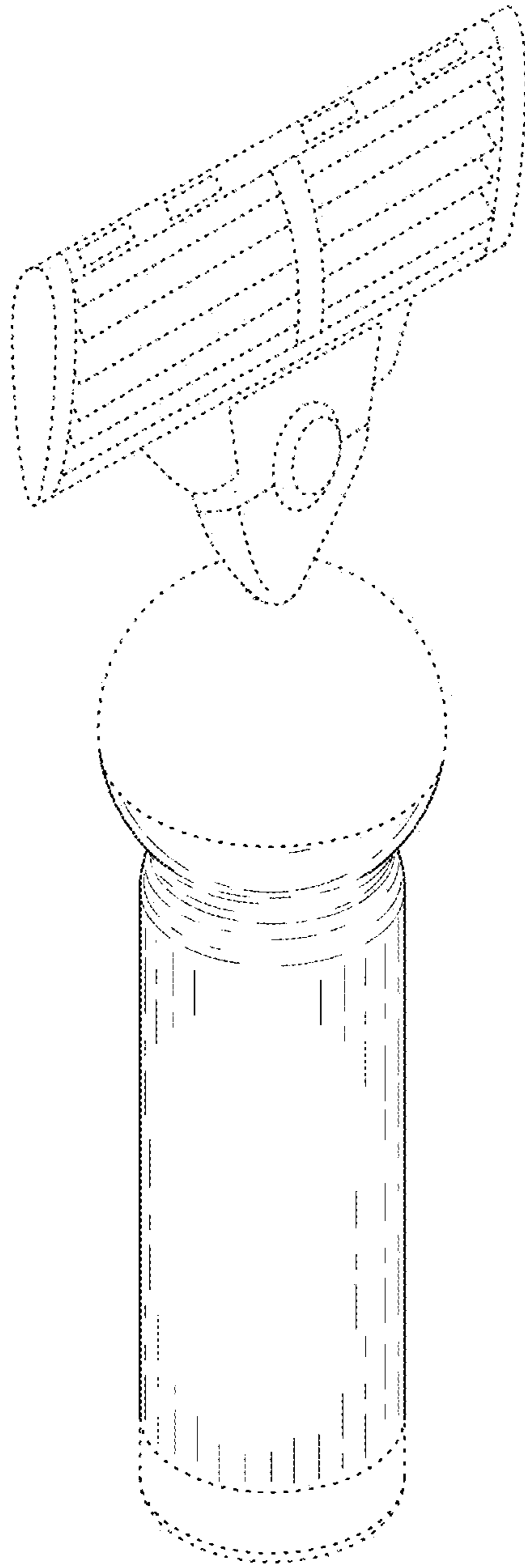
