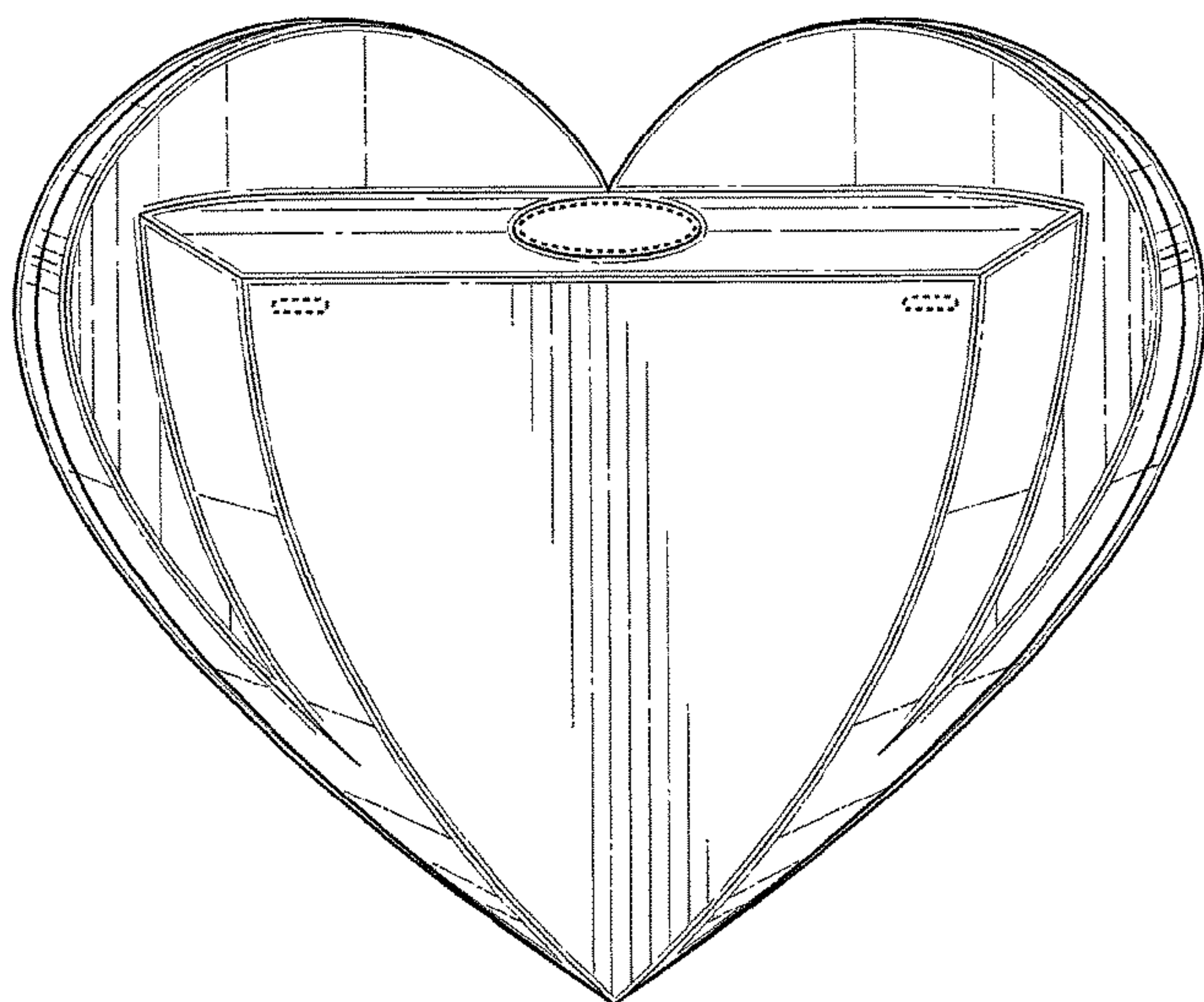
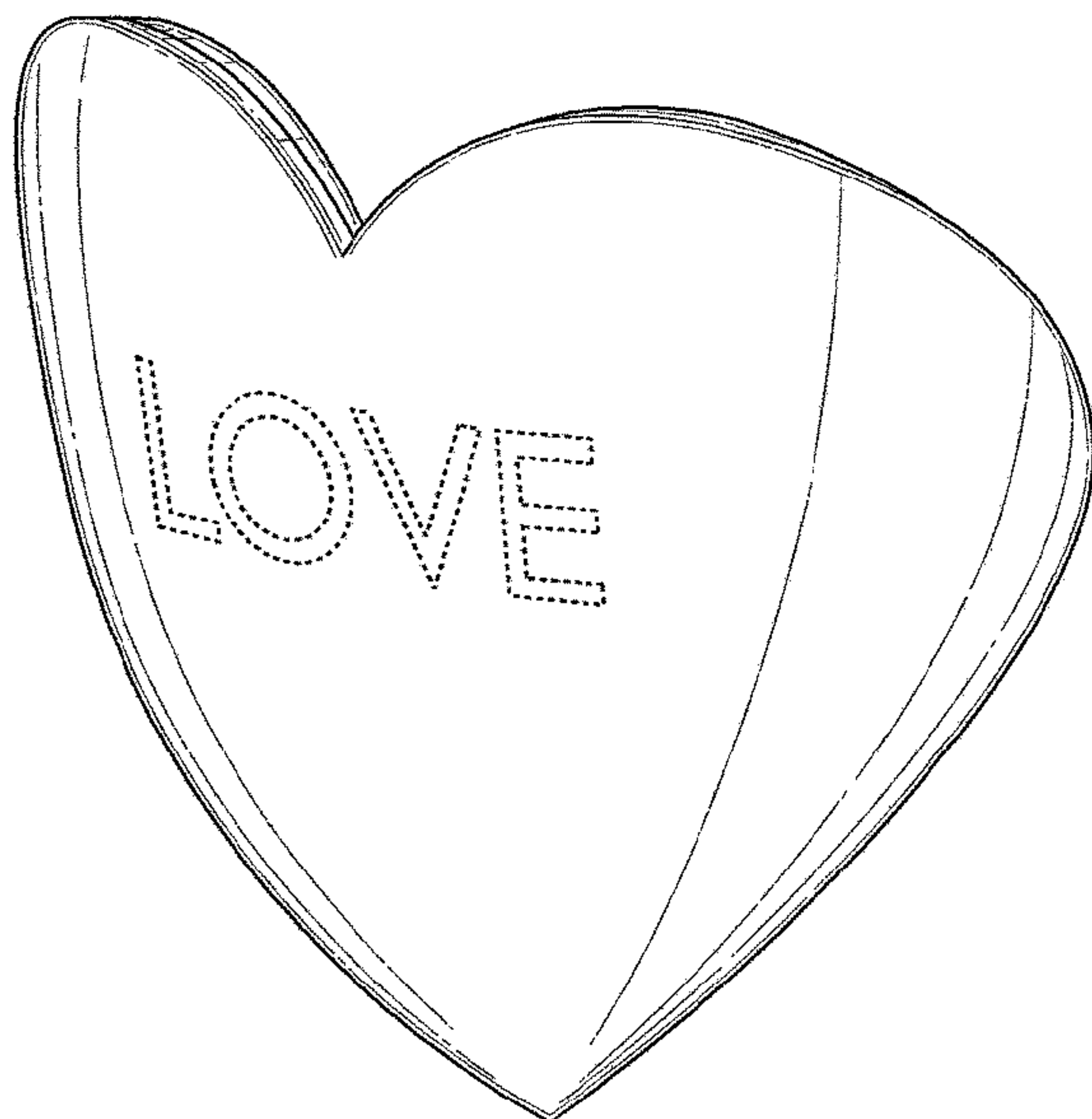
(57) **CLAIM**

The ornamental design for a decorative hanging cremation urn, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of a decorative hanging cremation urn, showing our new design; FIG. 2 is a rear, left side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken line showing in the figures of the word “LOVE” forms no part of the claimed design. The broken lines depict portions of the decorative hanging cremation urn that form no part of the claimed design.

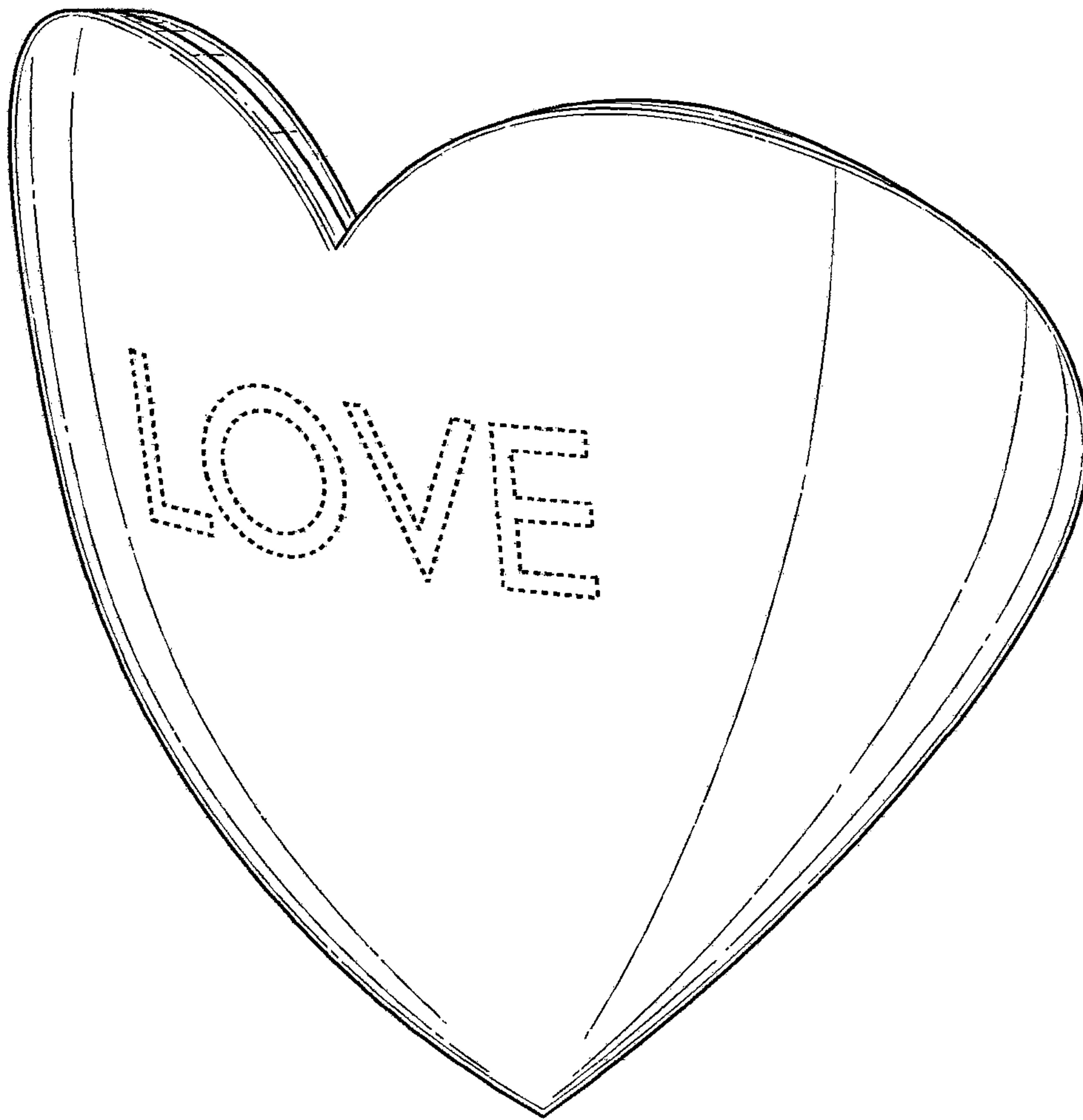

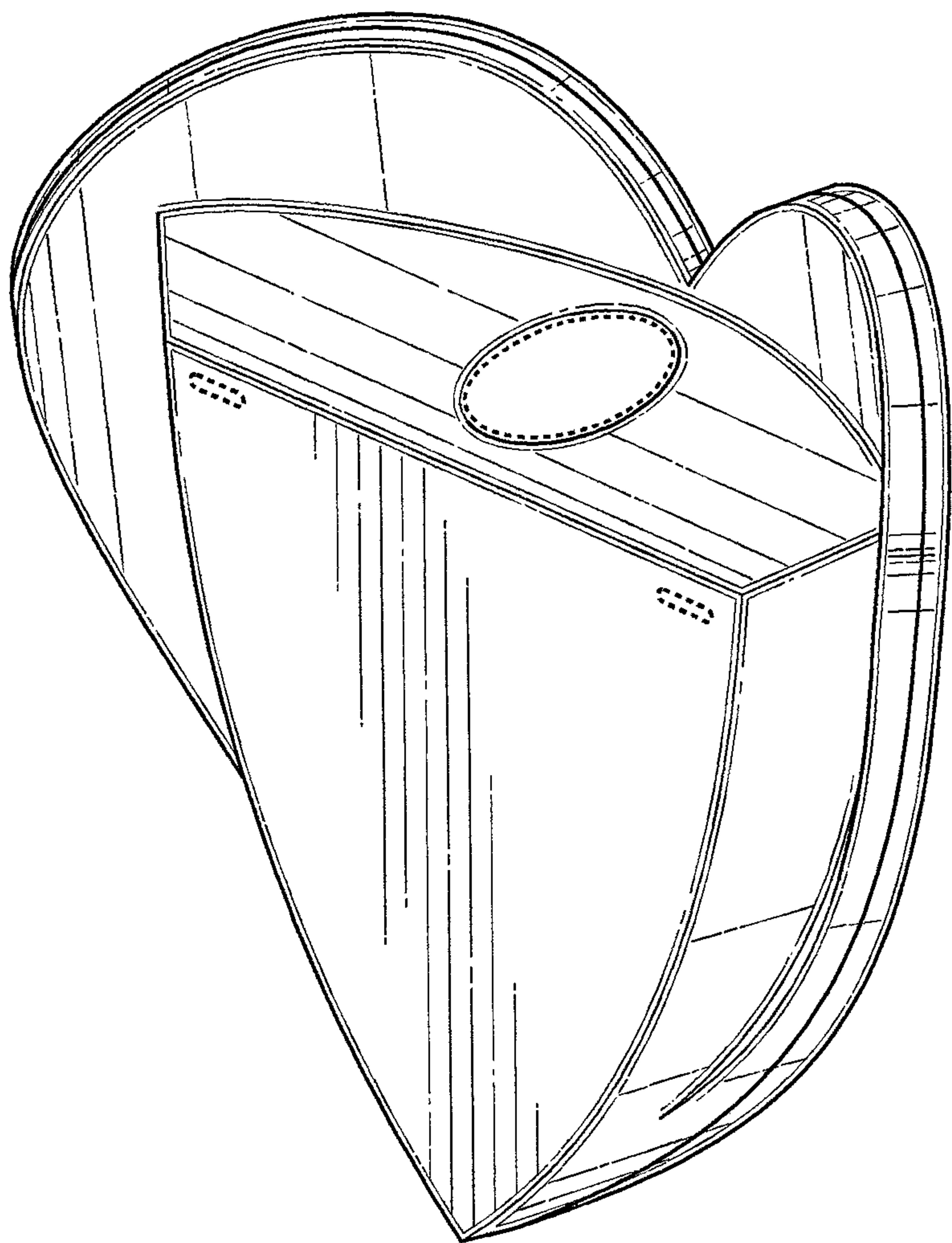

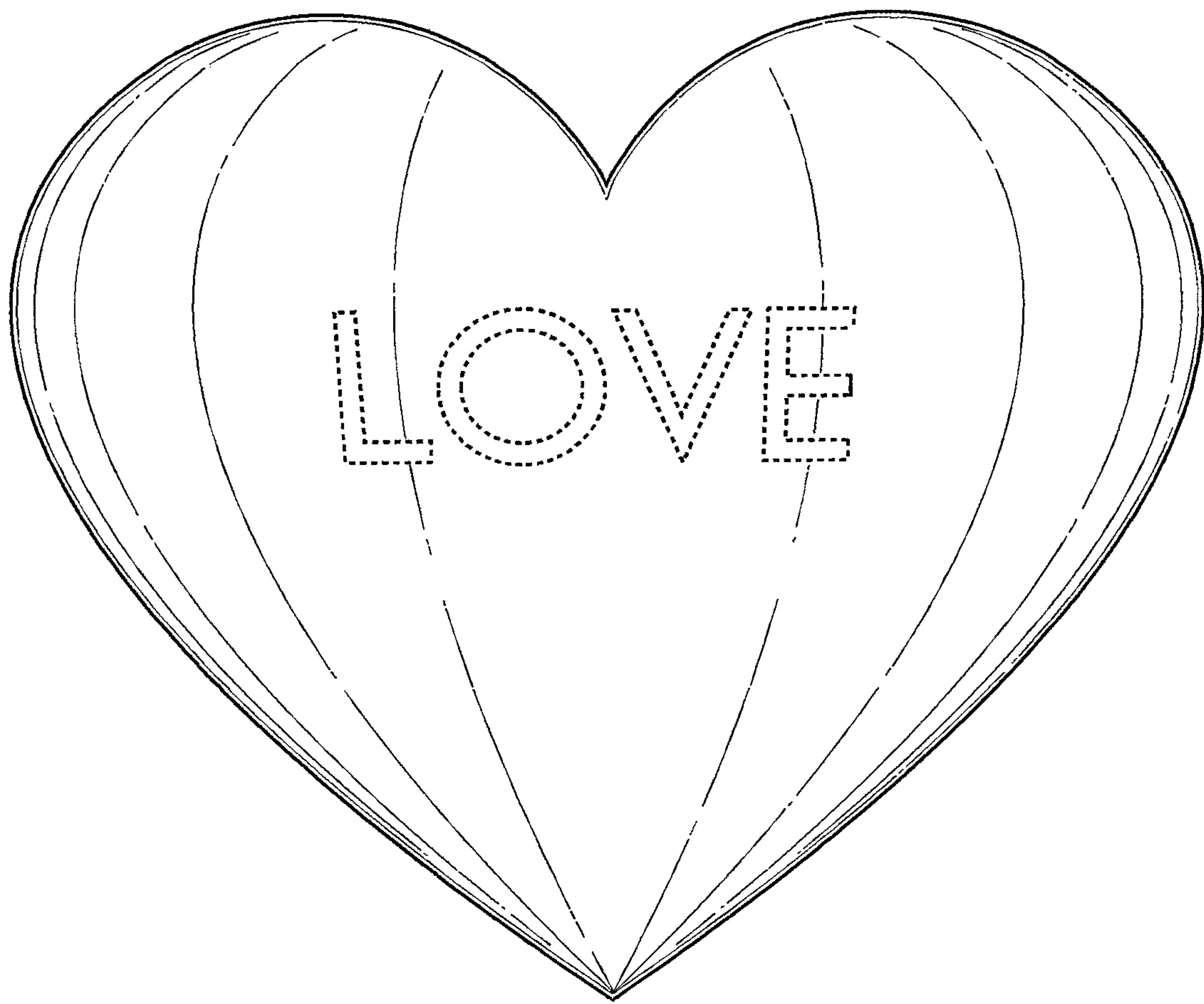

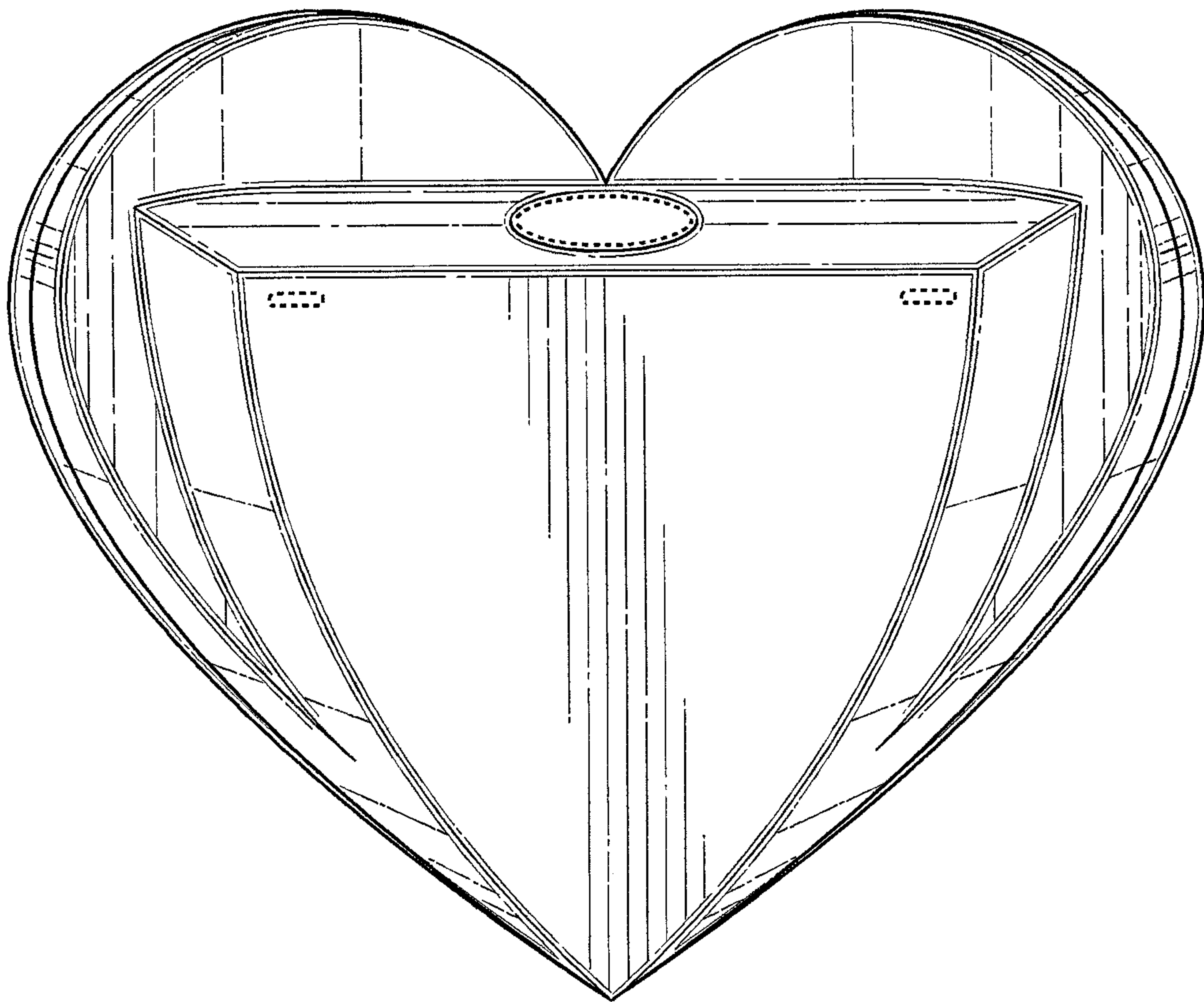

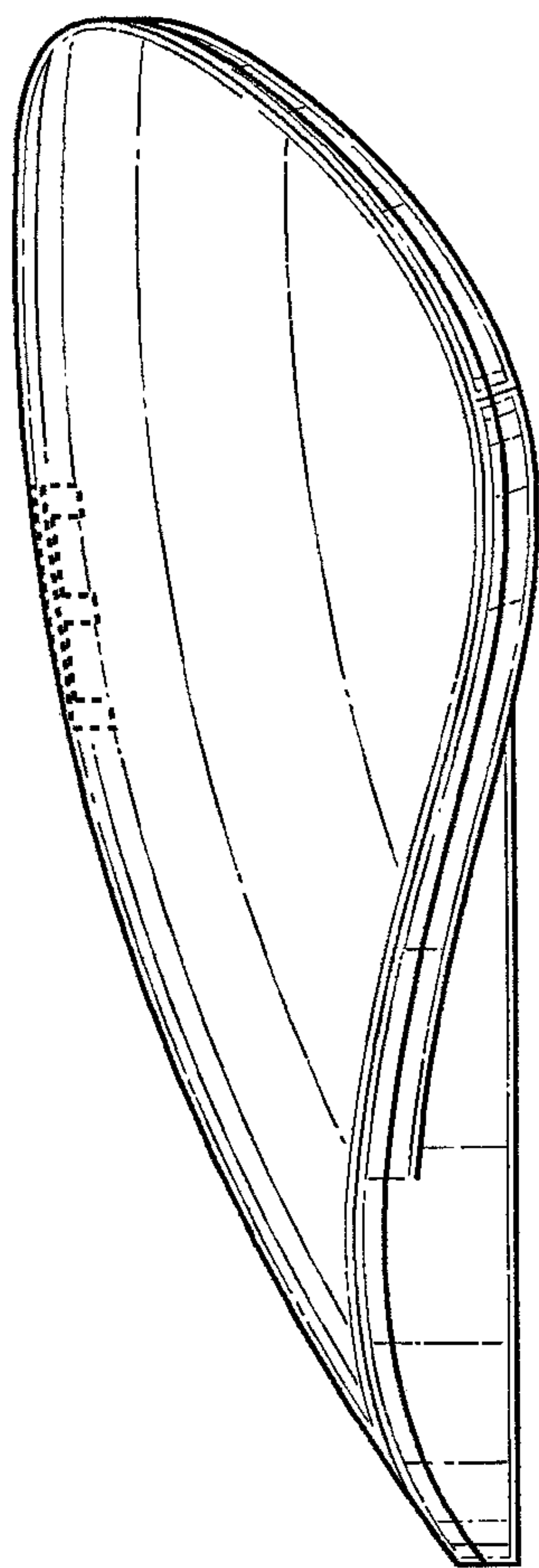

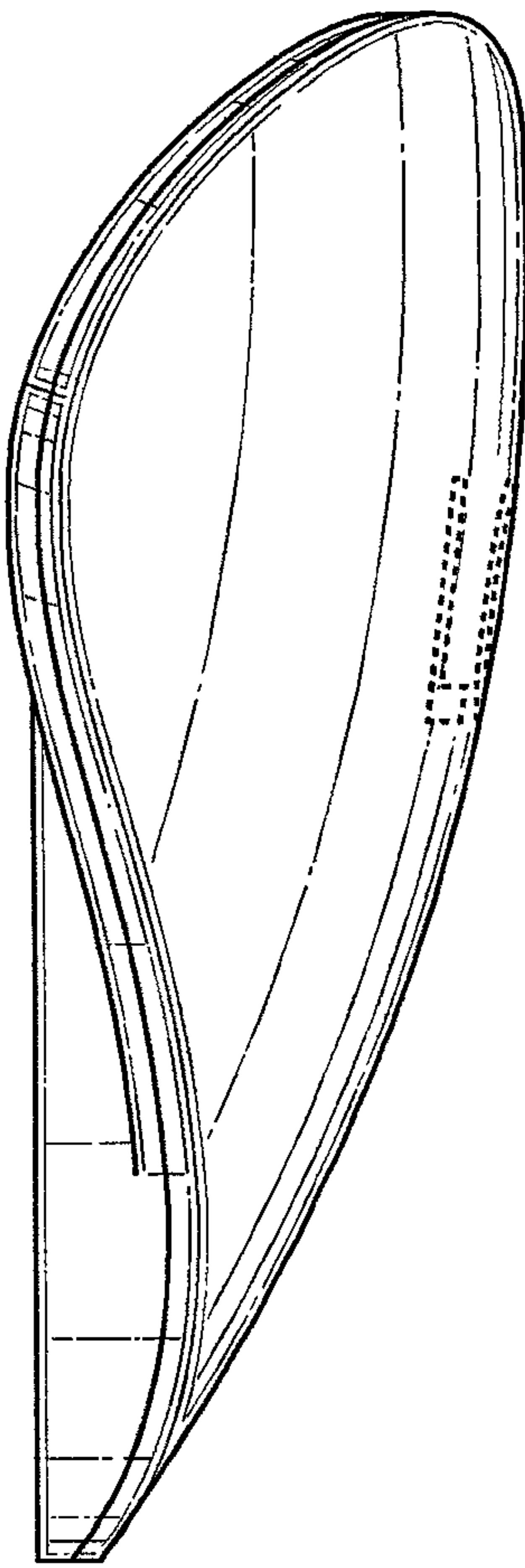

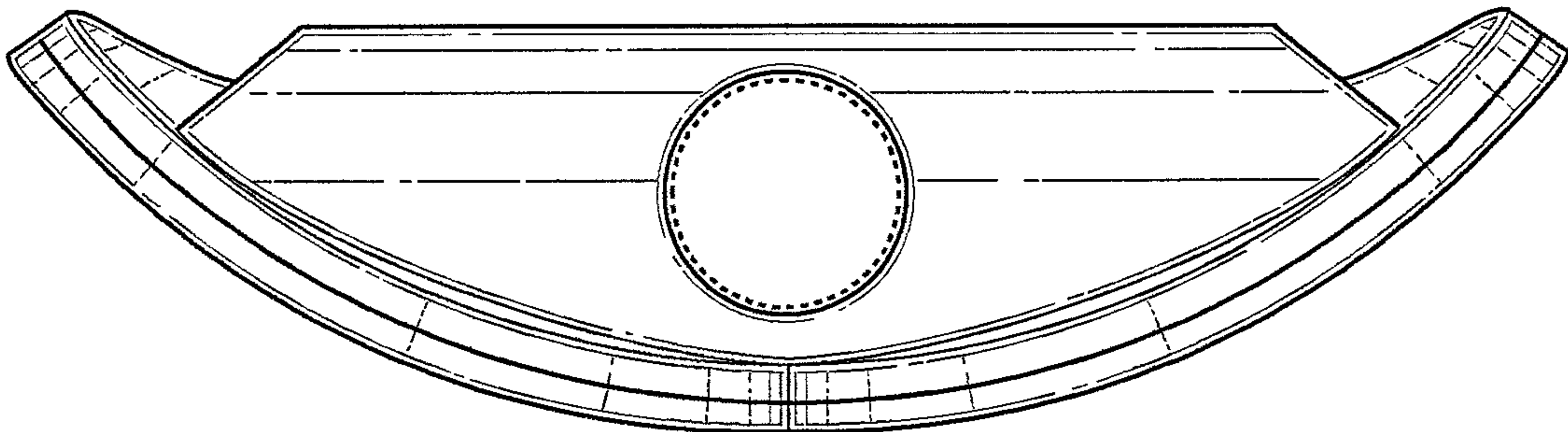

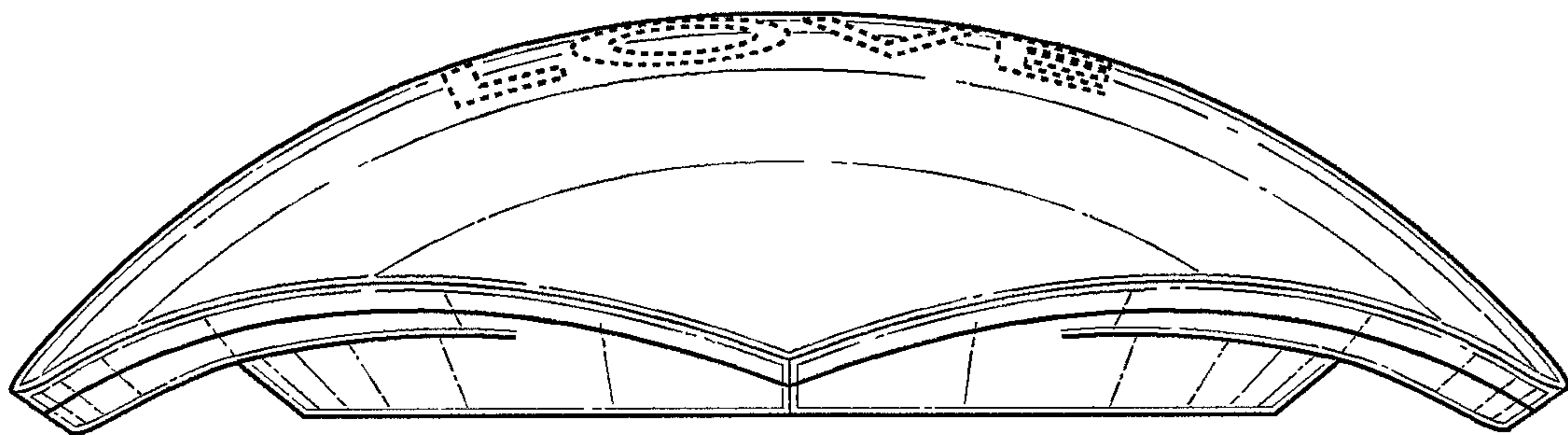
