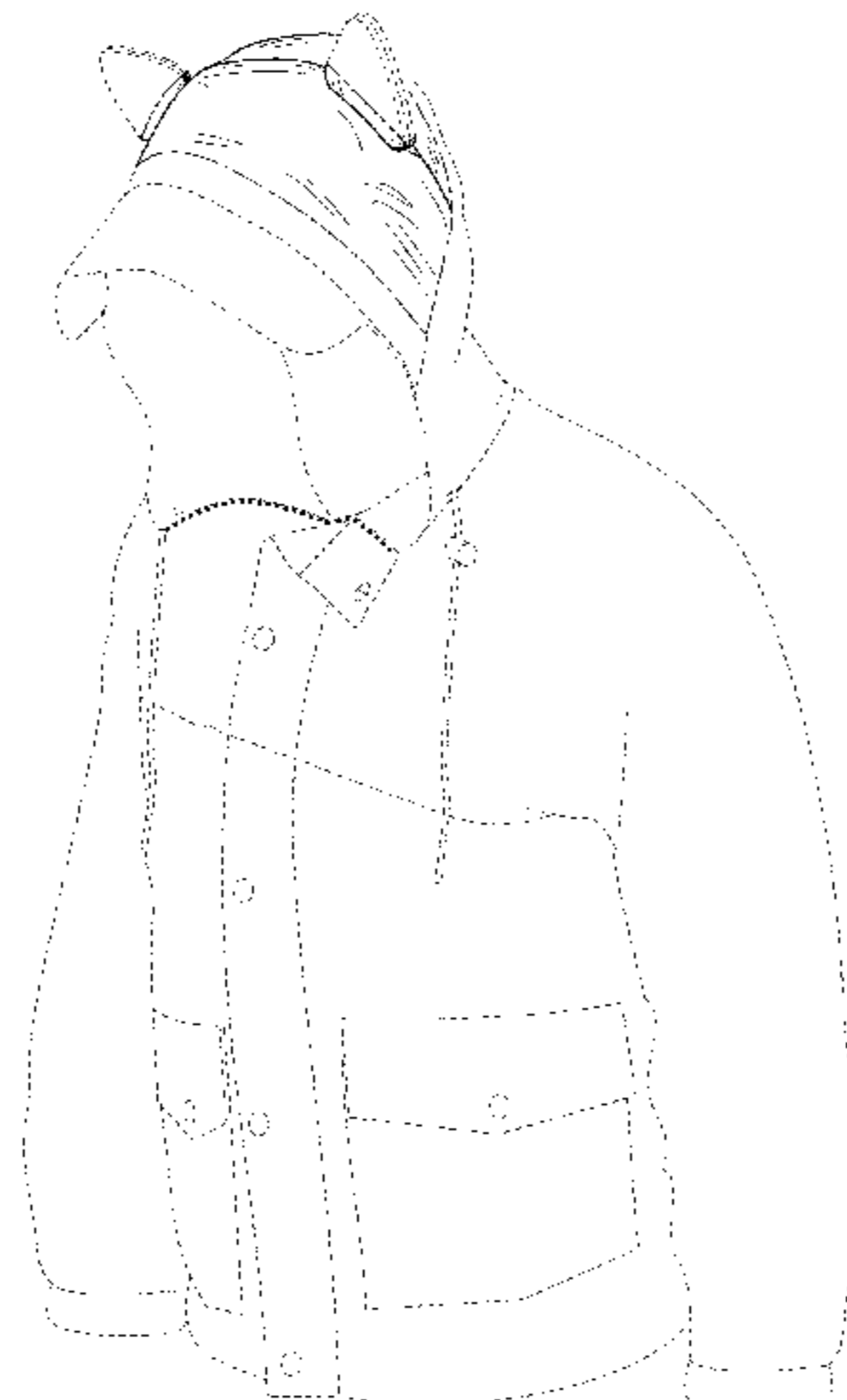
(57) **CLAIM**

The ornamental design for a hooded jacket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hooded jacket showing our new design;
FIG. 2 is an enlarged front perspective view thereof, shown separately for clarity of illustration;
FIG. 3 is an enlarged rear perspective view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a front perspective view of the jacket of FIG. 1, showing our new design in an alterante configuration of use;
FIG. 6 is an enlarged front perspective view thereof, shown separately for clarity of illustration;
FIG. 7 is an enlarged rear perspective view thereof;
FIG. 8 is a top plan view thereof; and,
FIG. 9 is a partial cutaway view of the enlarged front perspective view of FIG. 6.
The dot-dash broken lines adjacent to the shaded area in the figures define the boundaries of the claimed design and form no part thereof. The remainder of the broken lines in the figures illustrate portions of the hooded jacket that form no part of the claimed design.

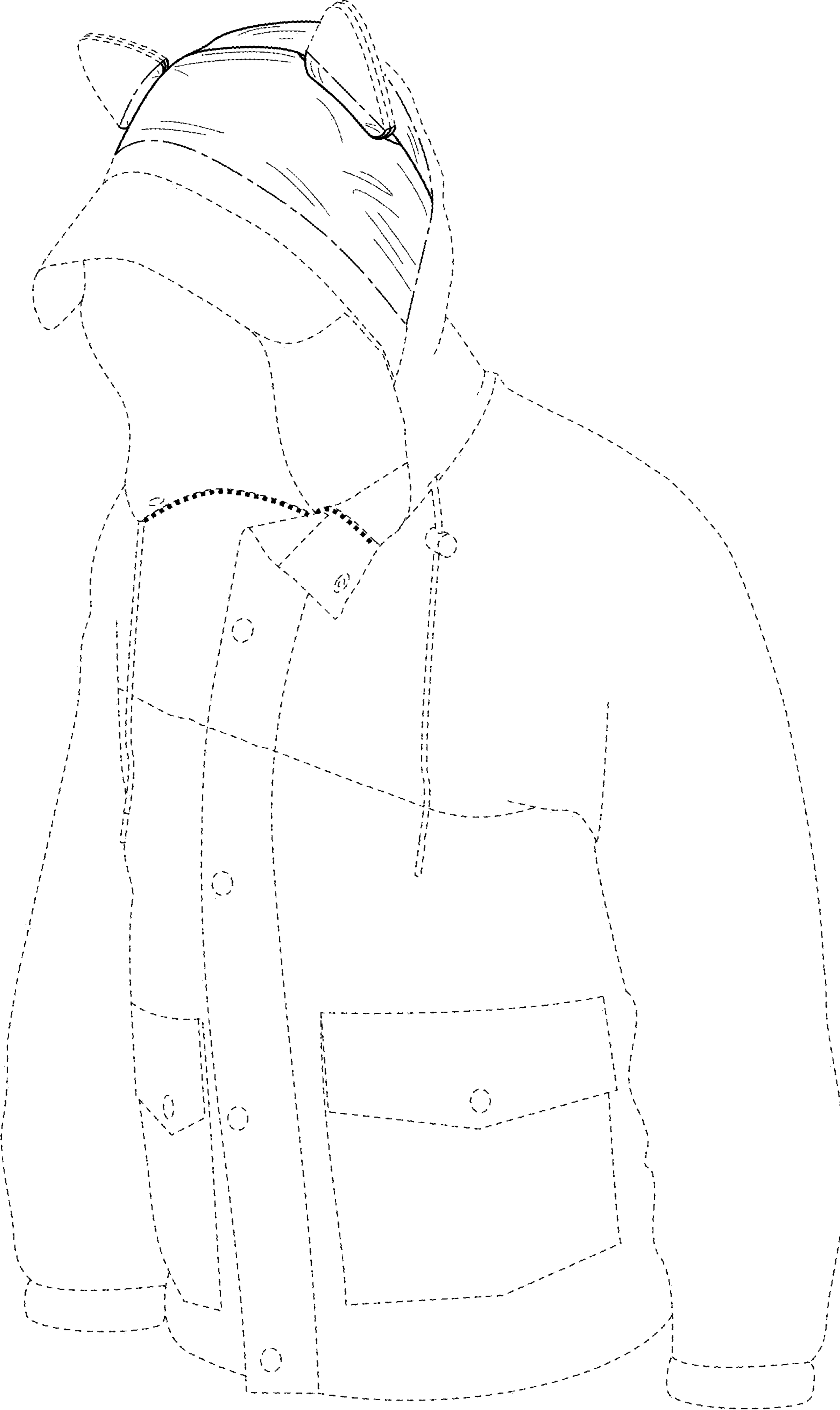

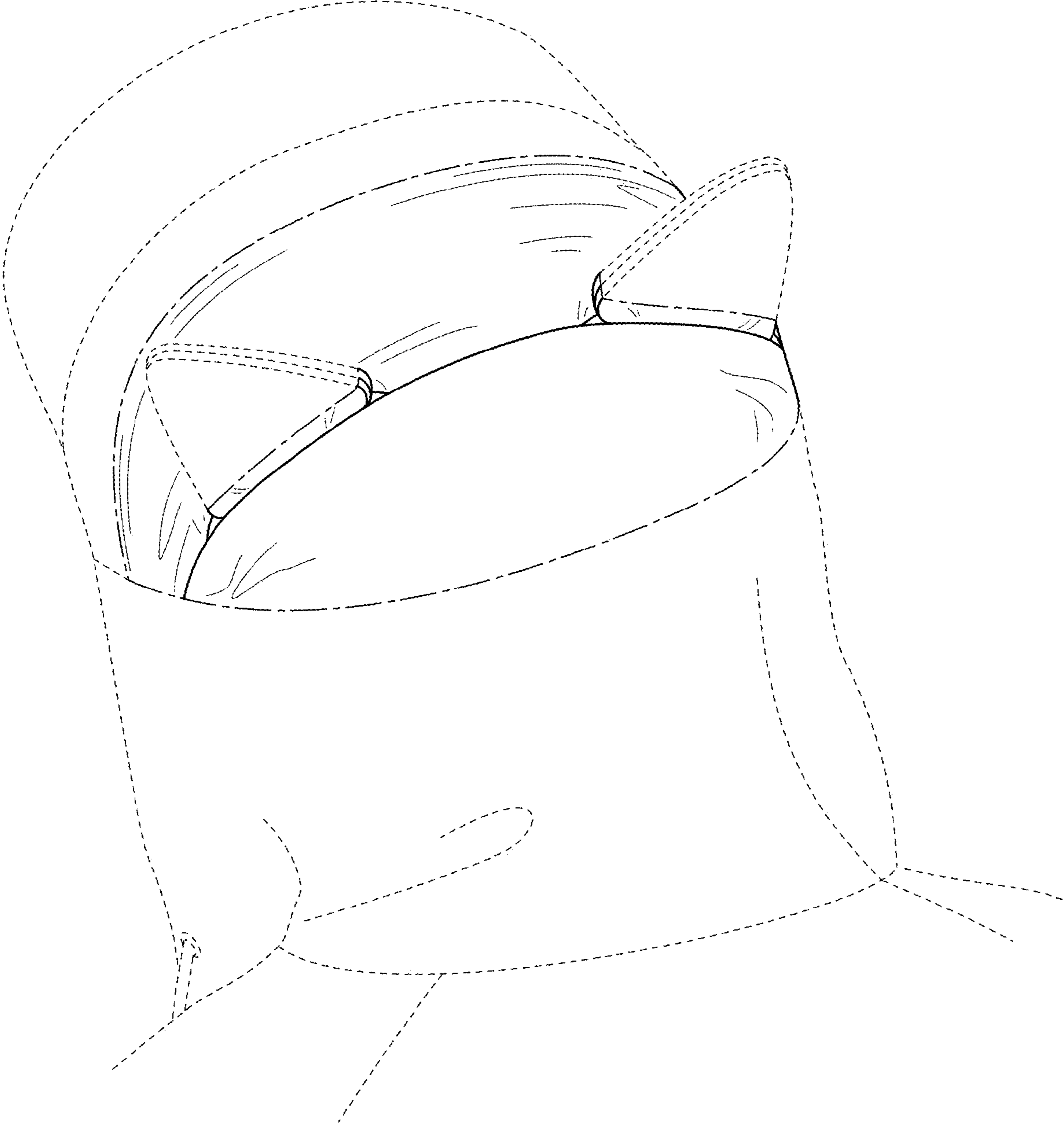

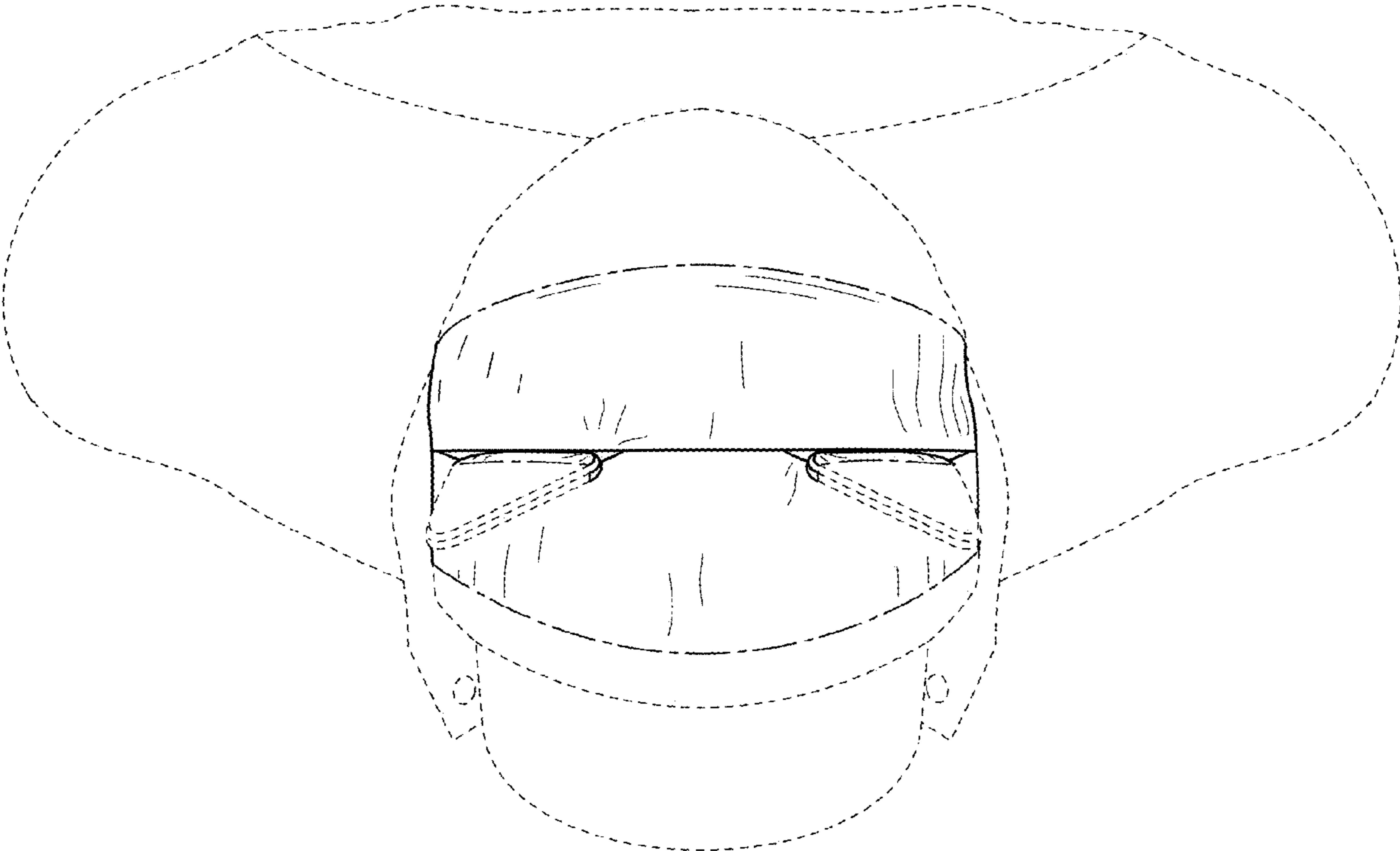

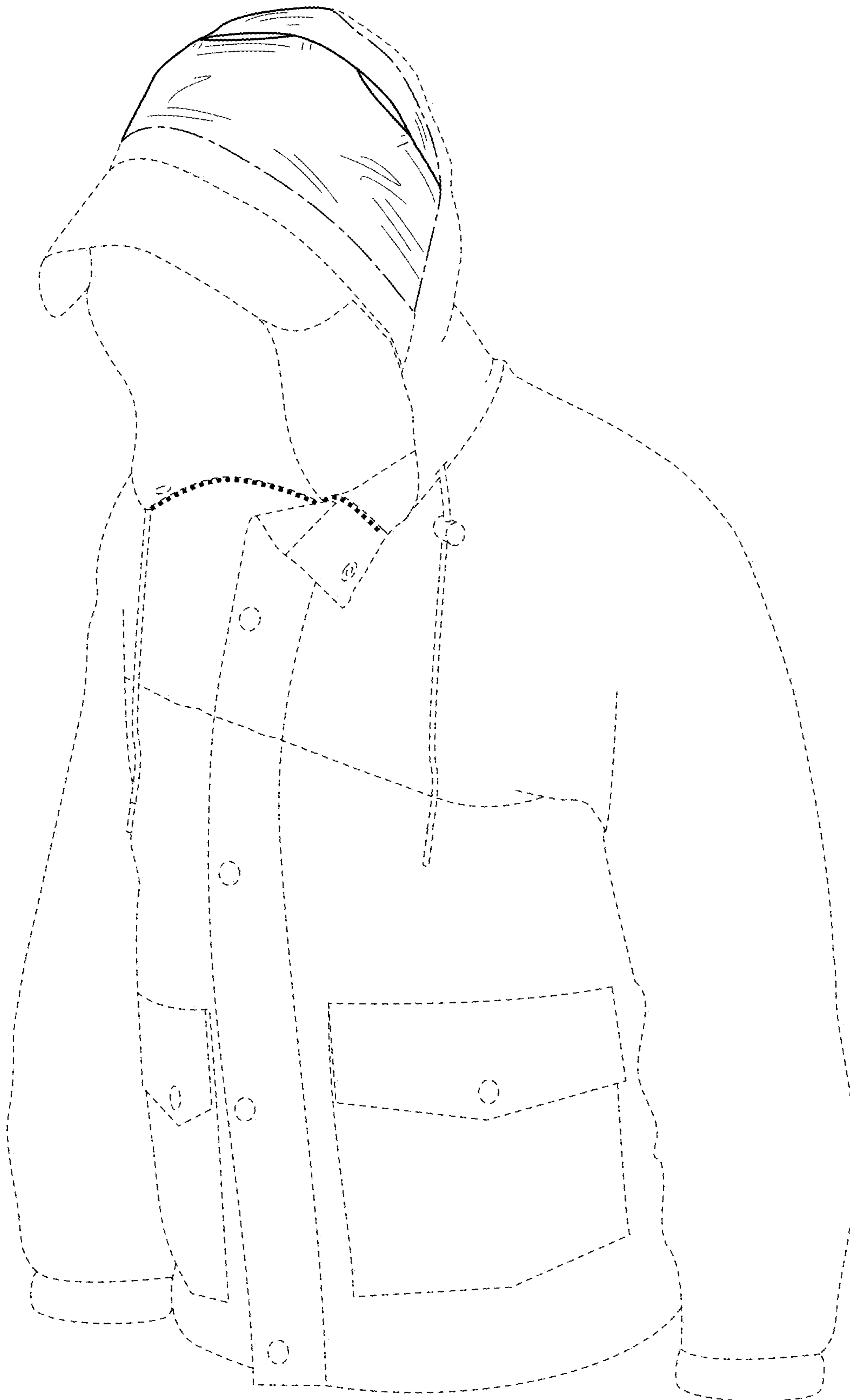

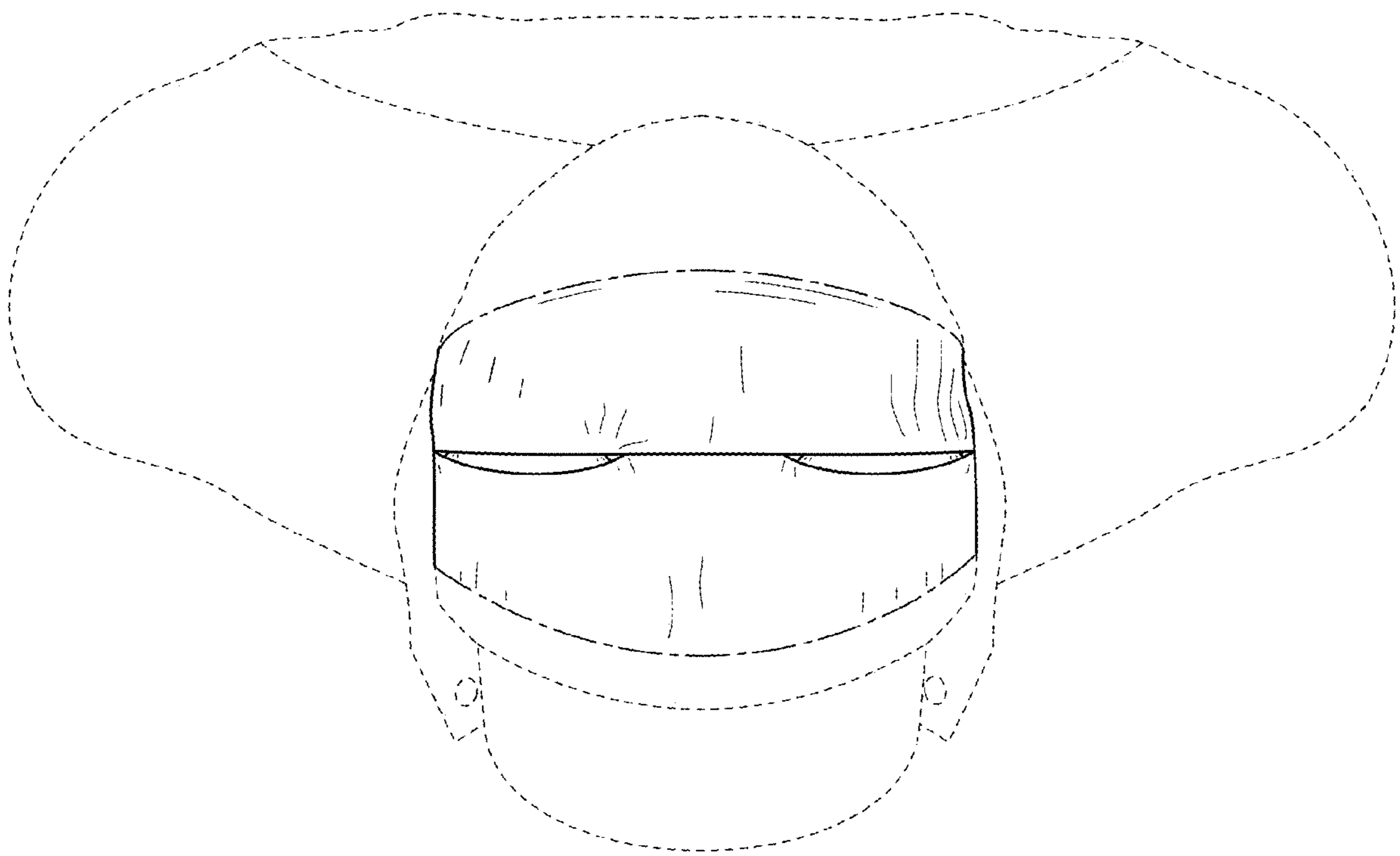

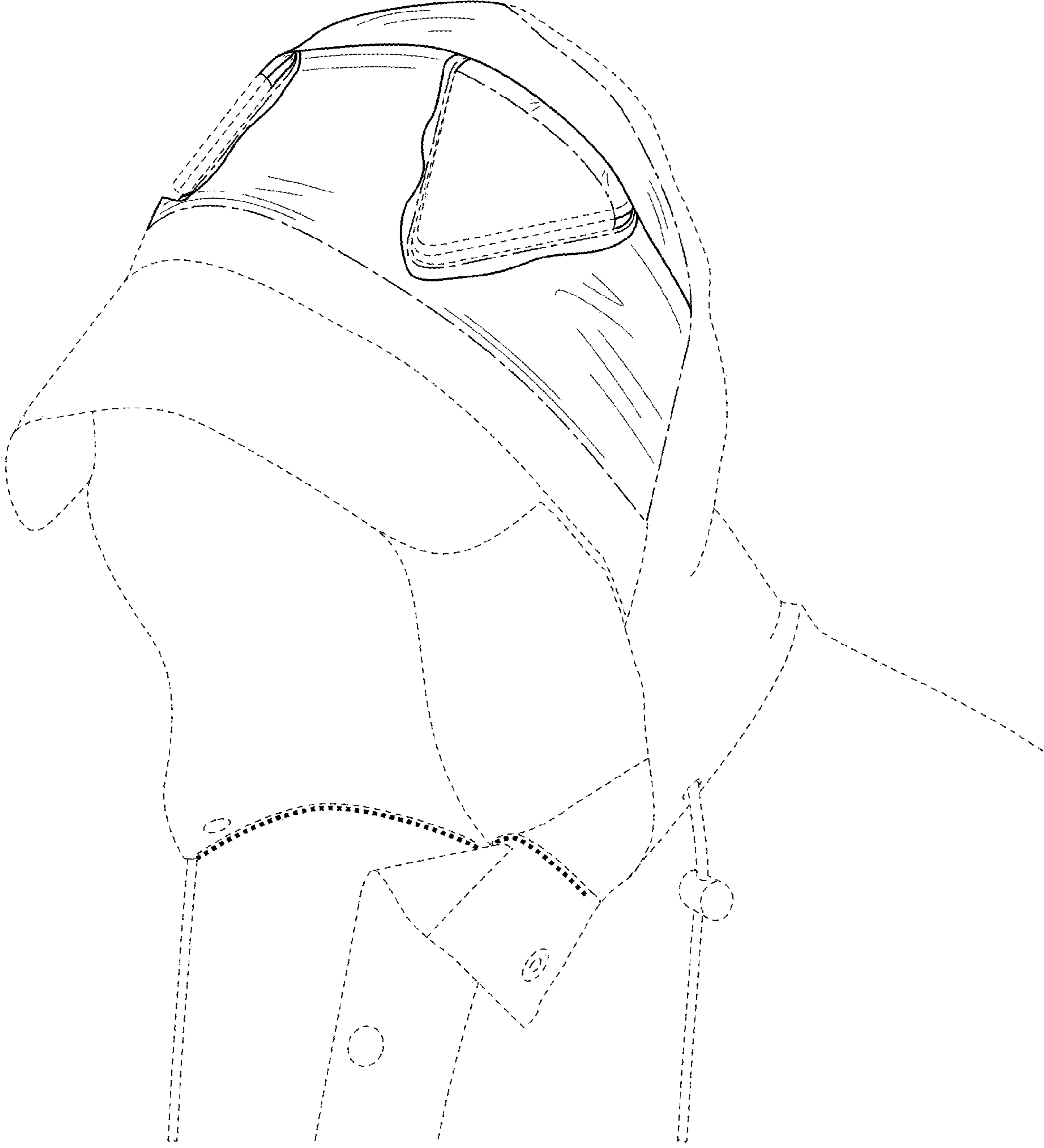
