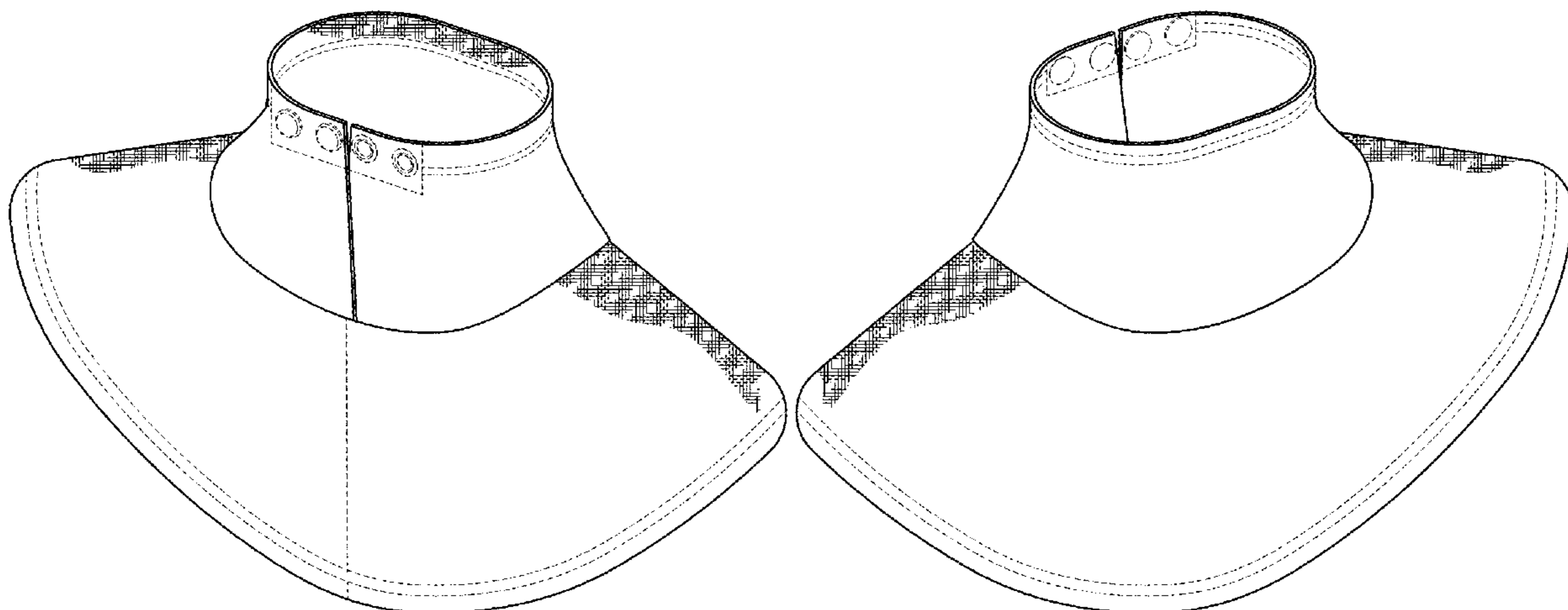
(57) **CLAIM**

The ornamental design for a neck and chest cover, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view in accordance with a neck and chest cover;
FIG. 2 is a front perspective view of the design of FIG. 1;
FIG. 3 is a rear elevation view of the design of FIG. 1;
FIG. 4 is a front elevation view of the design of FIG. 1;
FIG. 5 is a plan view of the design of FIG. 1;
FIG. 6 is a bottom view of the design of FIG. 1;
FIG. 7 is a left-side view of the design of FIG. 1;
FIG. 8 is a right-side view of the design of FIG. 1;
FIG. 9 is a rear view of the design of FIG. 1 with the neck component closed; and,
FIG. 10 is an environmental view of the design of FIG. 1. The broken lines illustrating snaps represent portions of the neck and chest cover that form no part of the claimed design. The remaining broken lines represent stitching that forms no part of the claimed design.

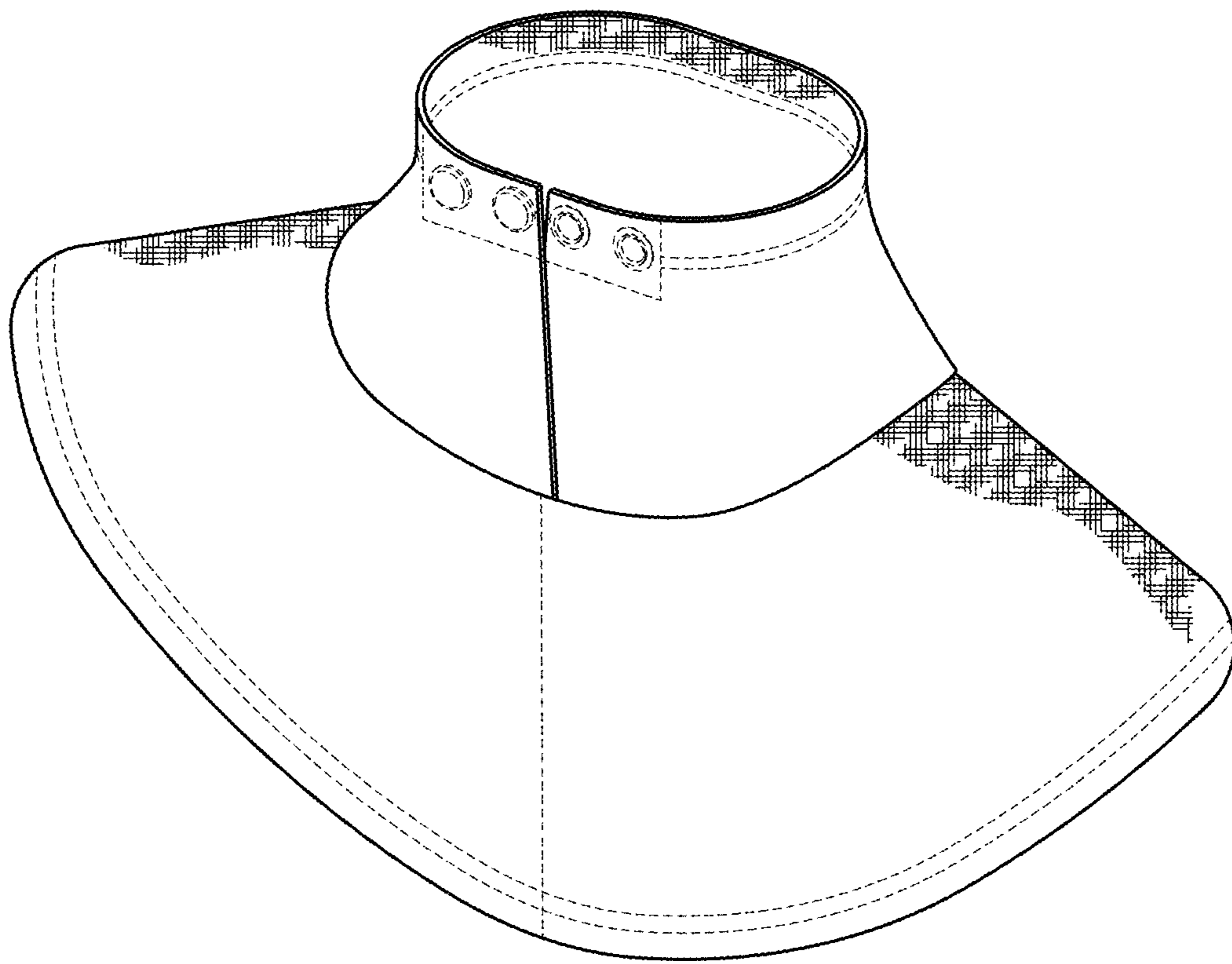

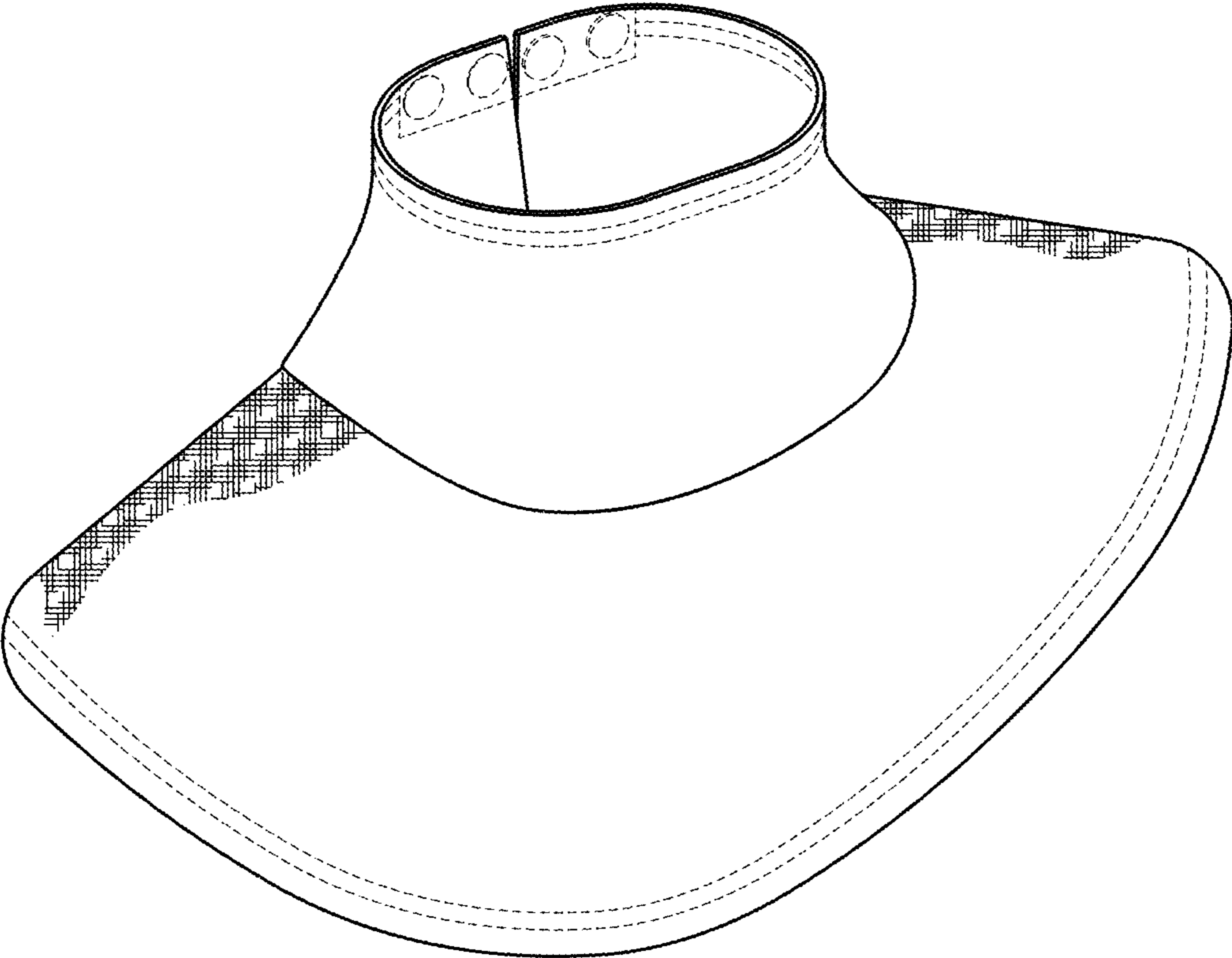

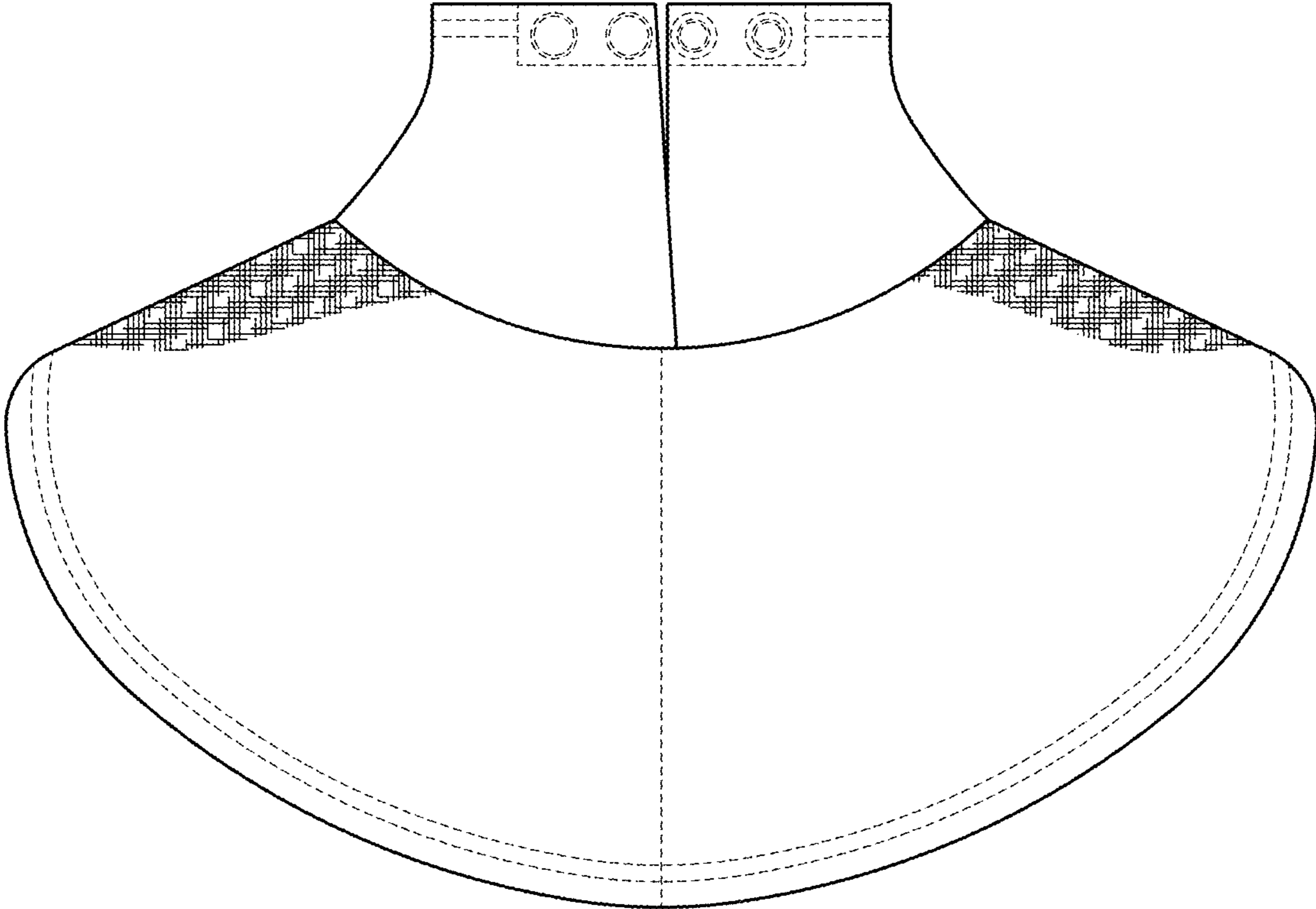

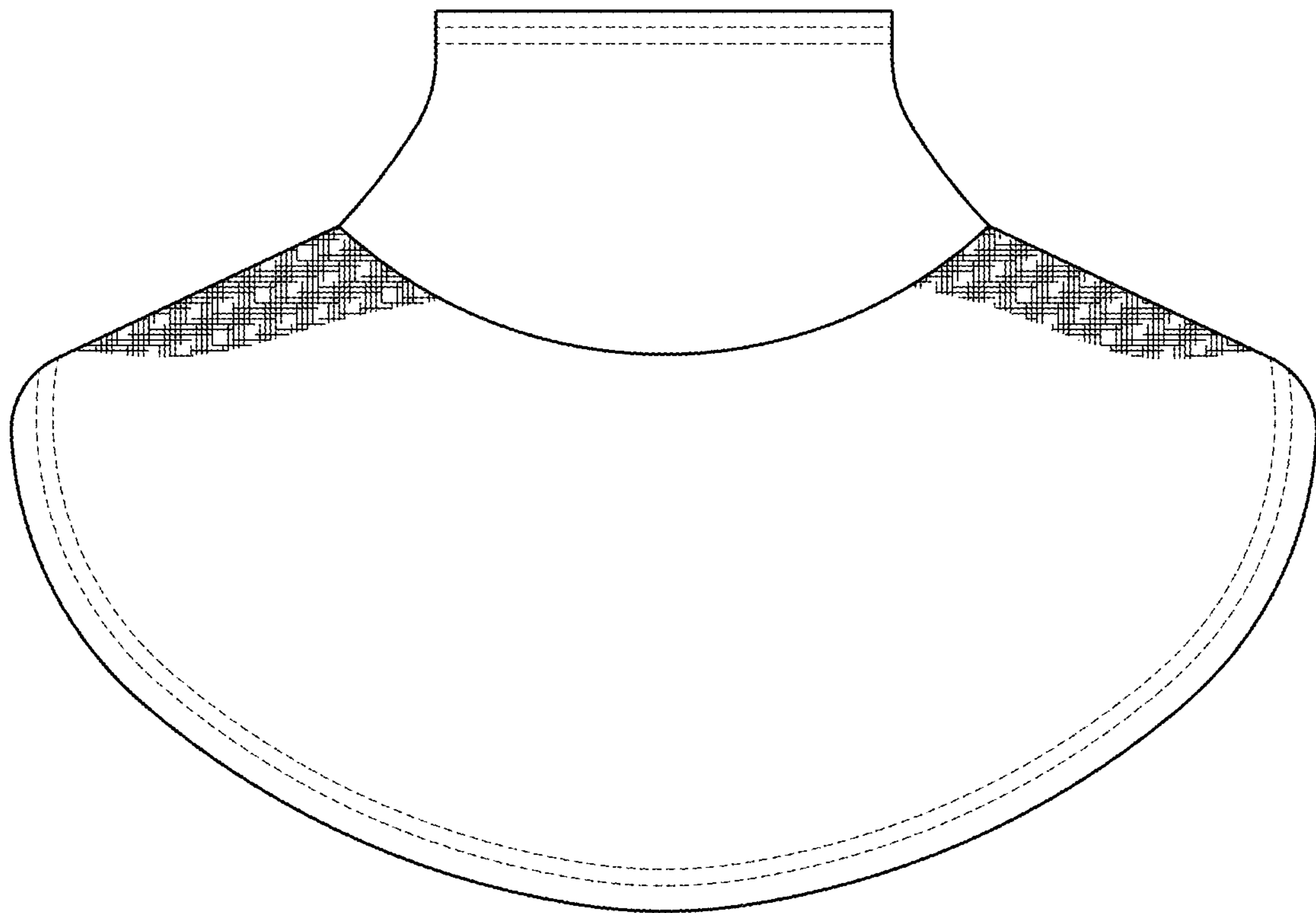

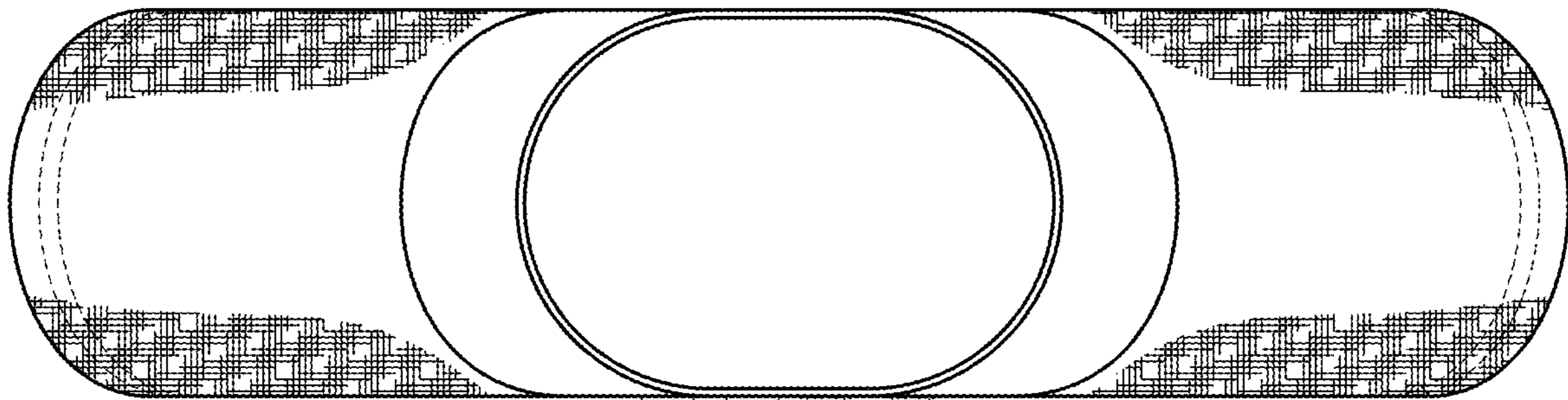

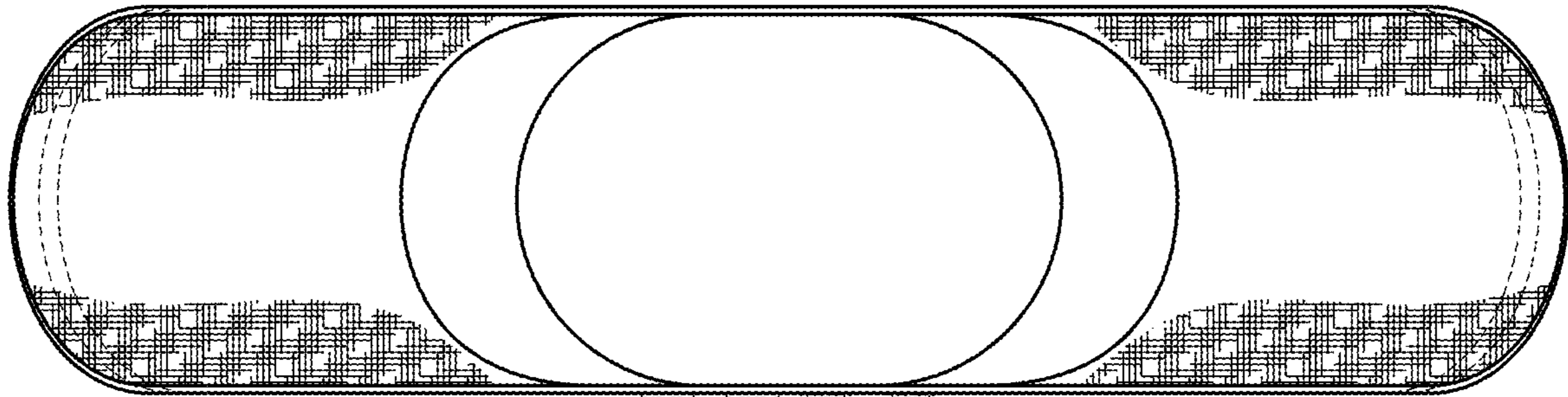

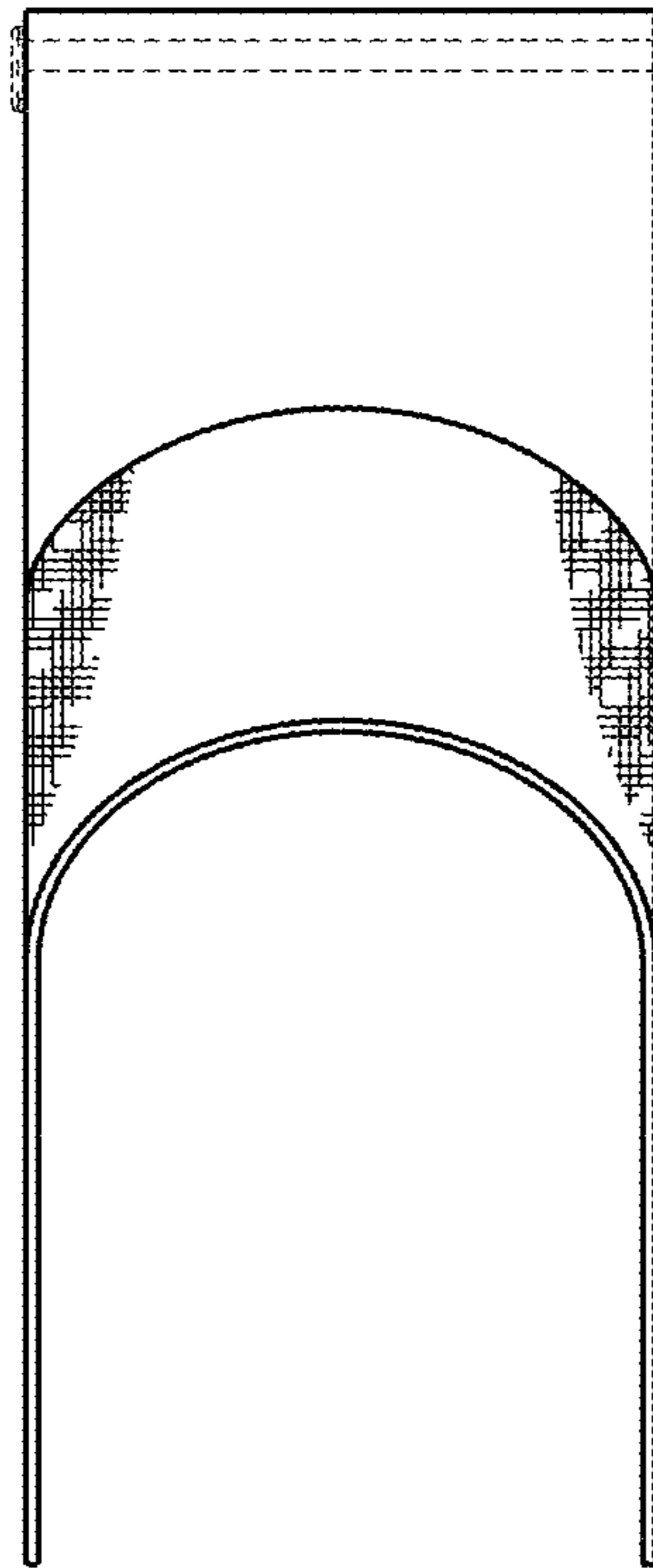

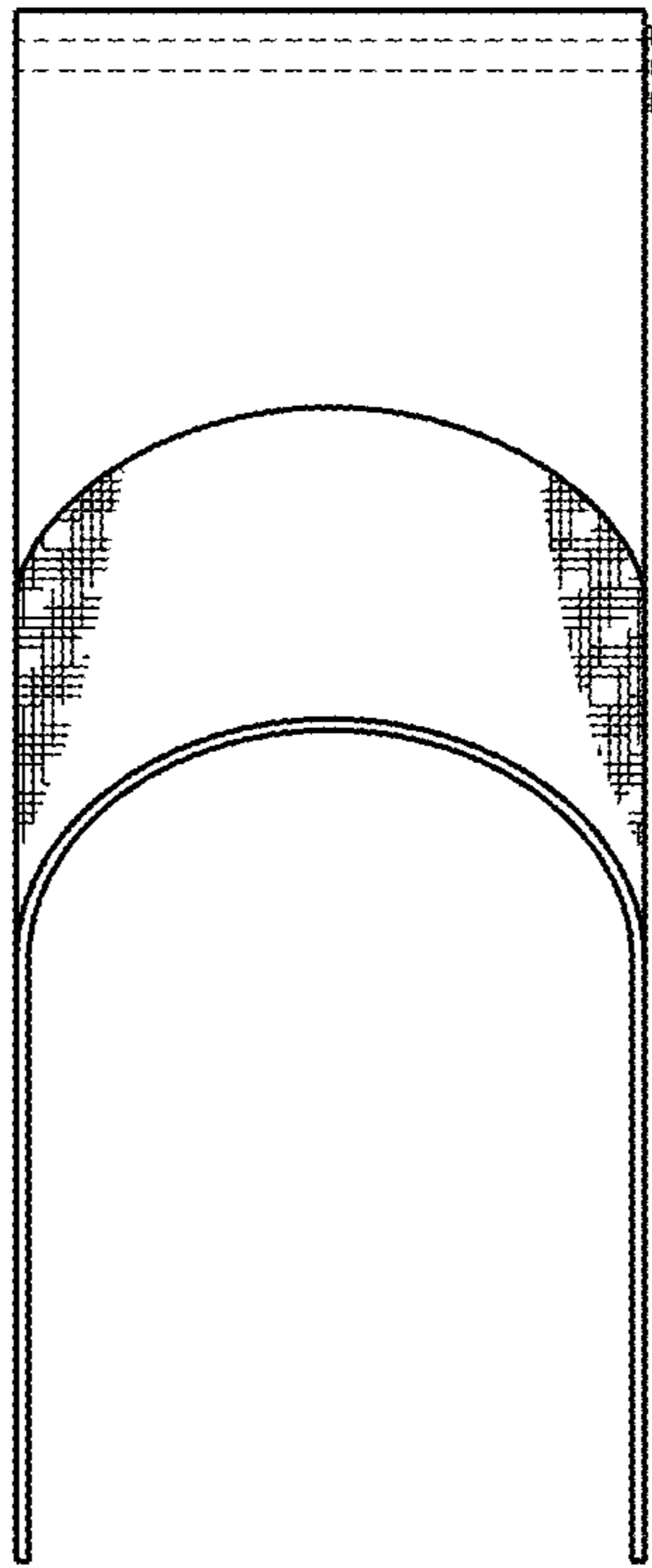

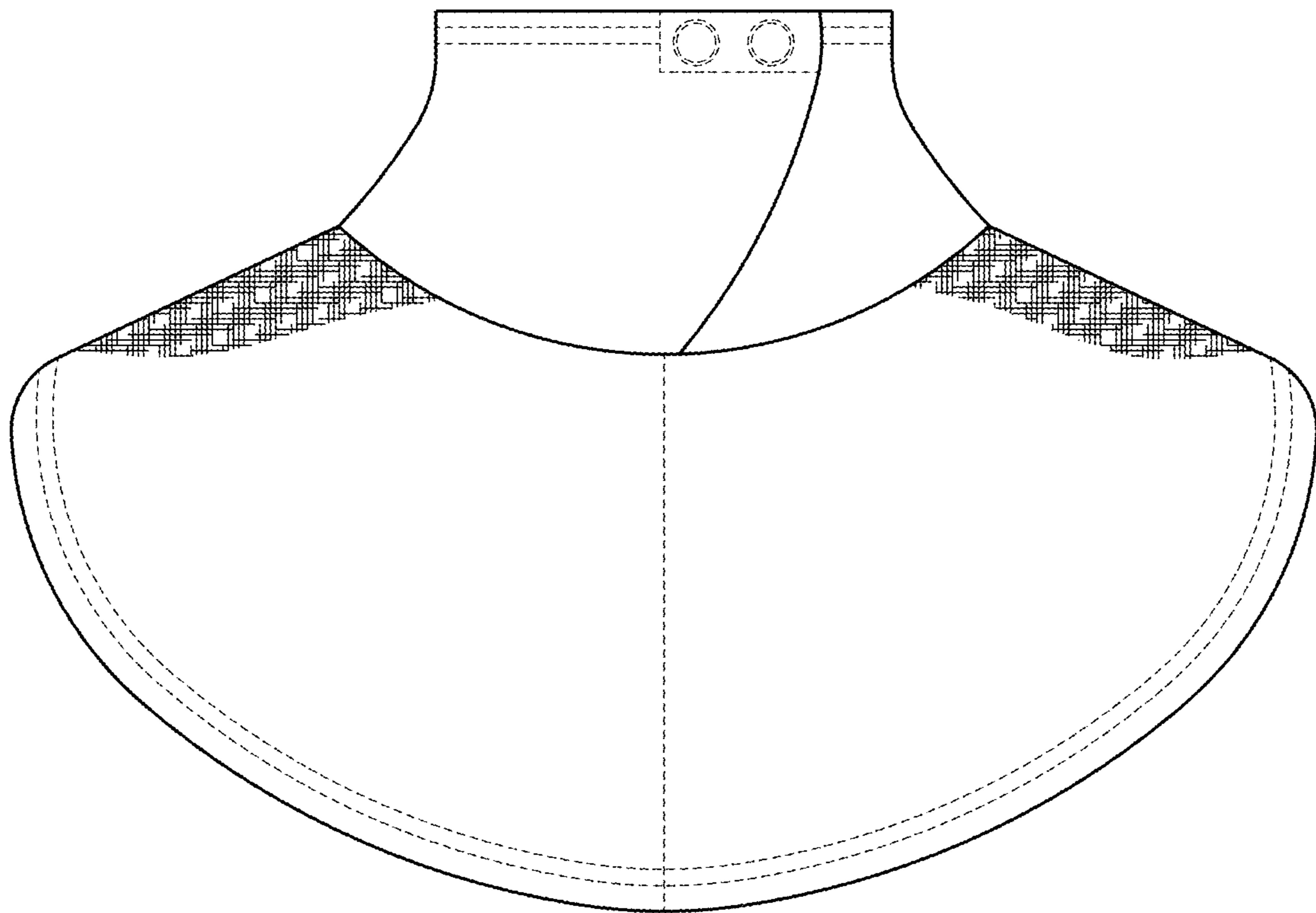

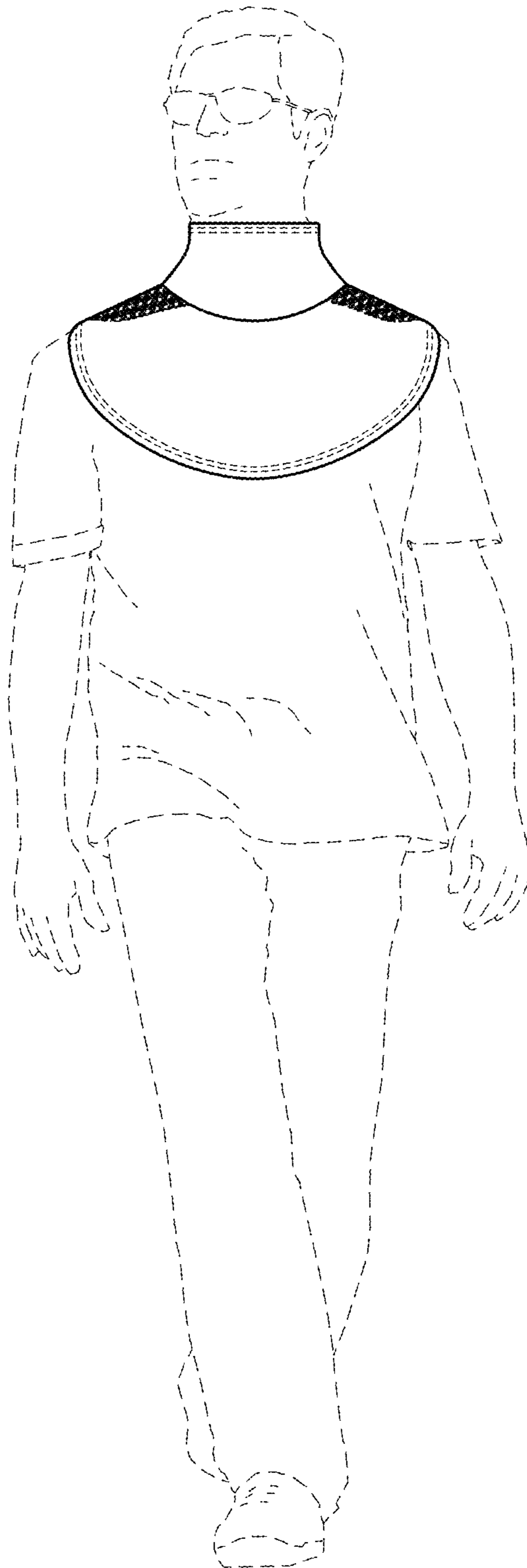
