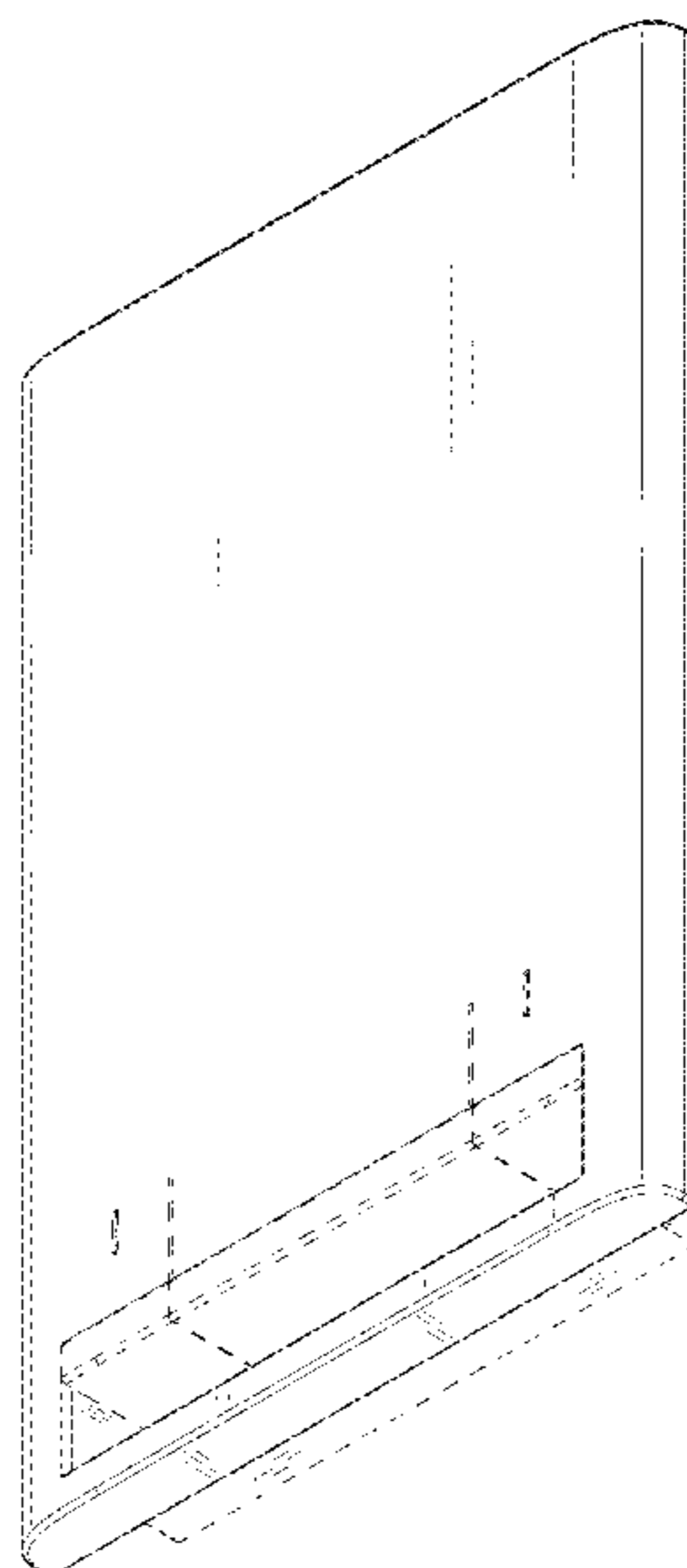
(57) **CLAIM**

The ornamental design for a hygiene product dispenser, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, raised perspective view of a hygiene product dispenser according to the invention;
FIG. 2 is a front view of the hygiene product dispenser of FIG. 1;
FIG. 3 is a rear view of the hygiene product dispenser of FIG. 1;
FIG. 4 is a right side view of the hygiene product dispenser of FIG. 1;
FIG. 5 is a left side view of the hygiene product dispenser of FIG. 1;
FIG. 6 is a top view of the hygiene product dispenser of FIG. 1;
FIG. 7 is a bottom view of the hygiene product dispenser of FIG. 1; and,

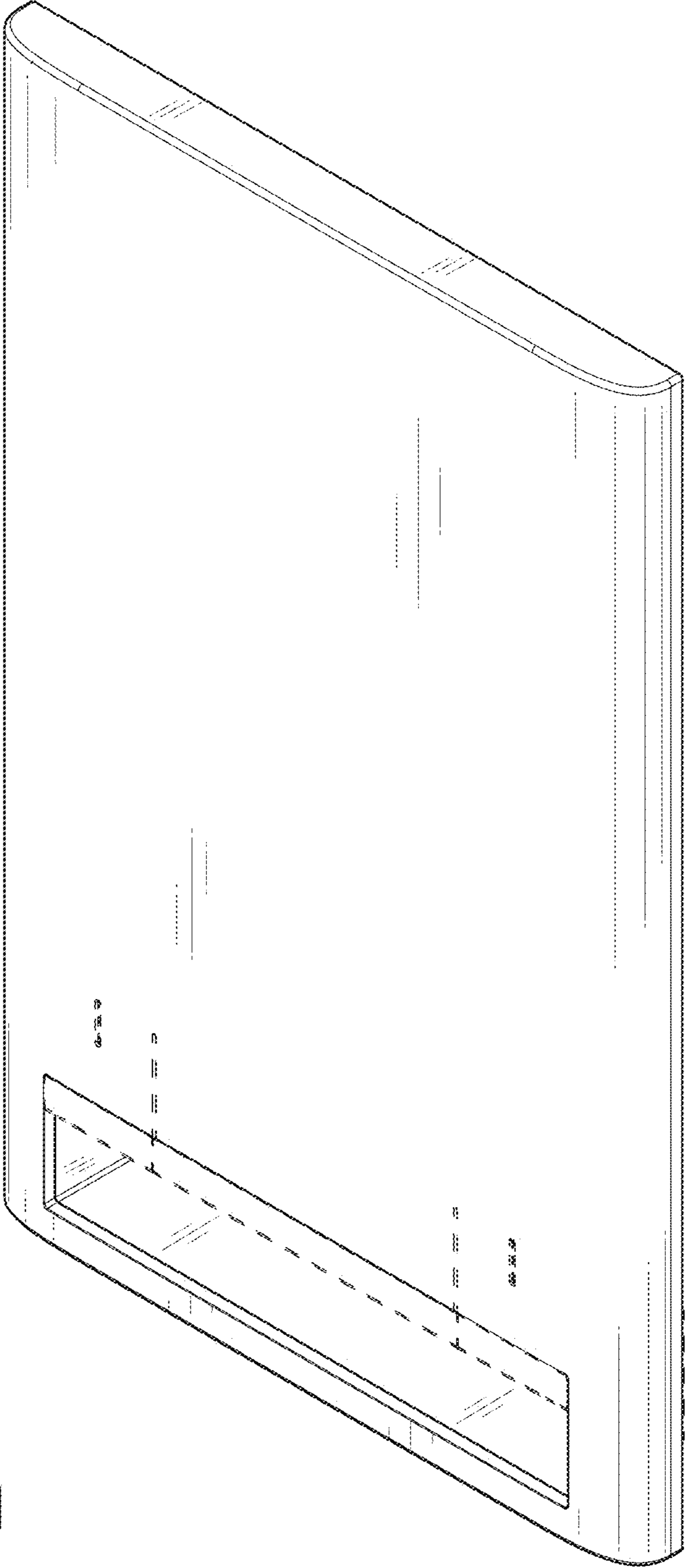

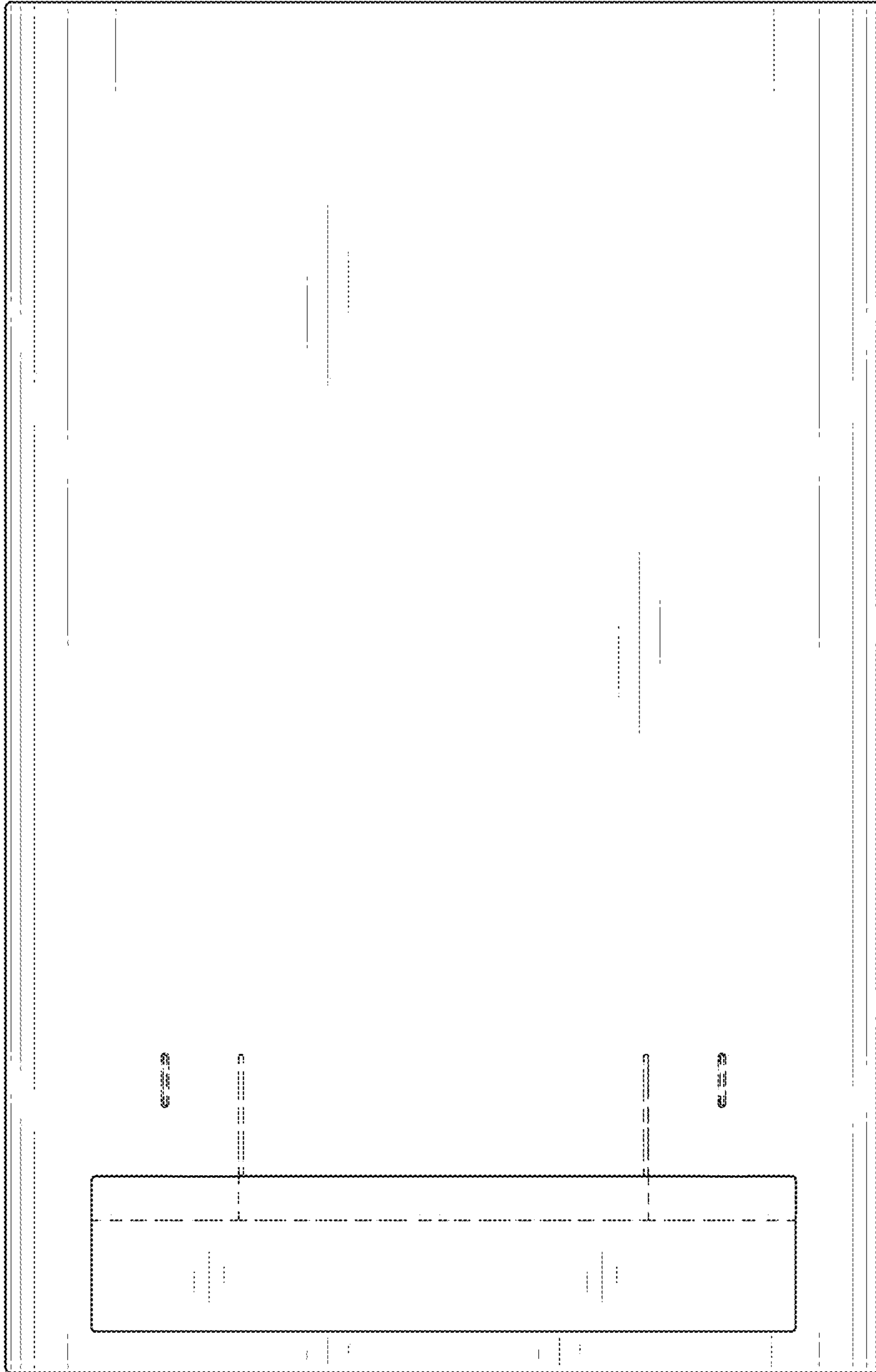

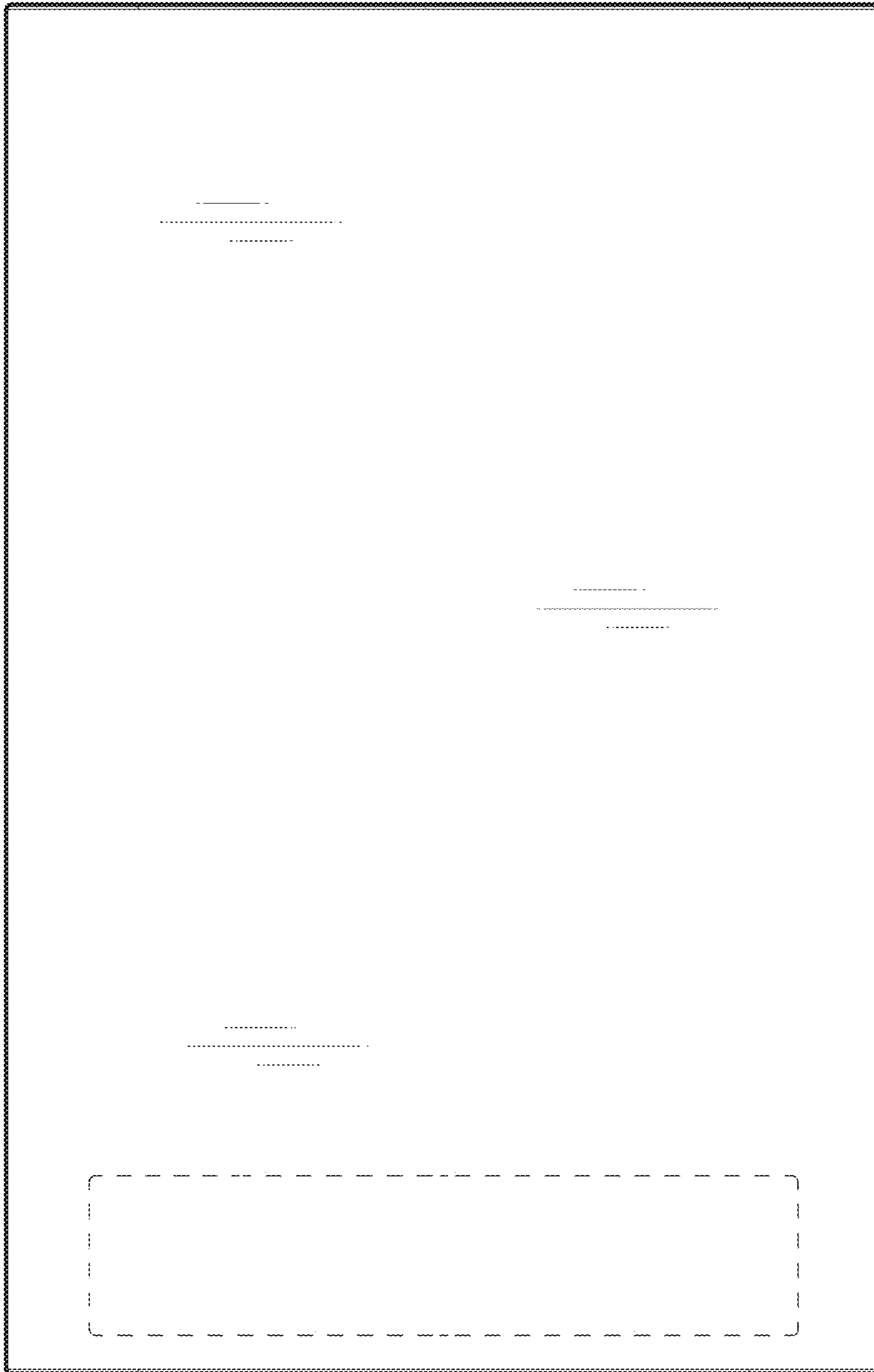

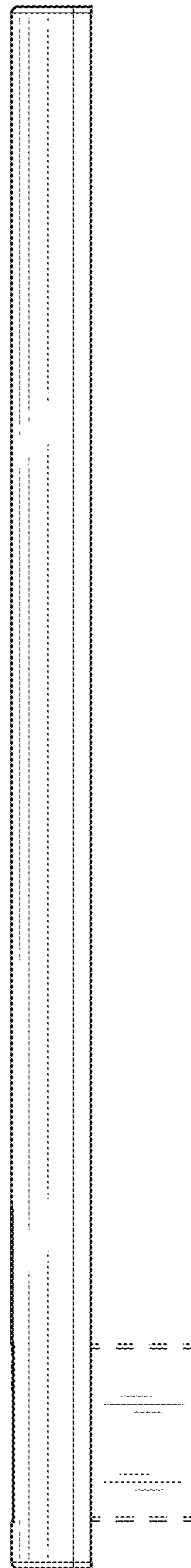

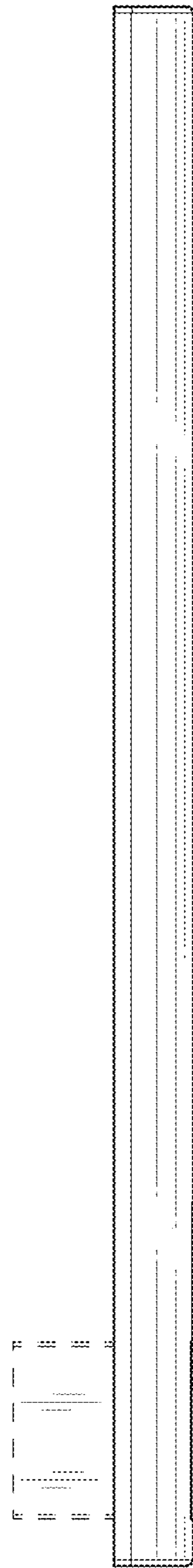

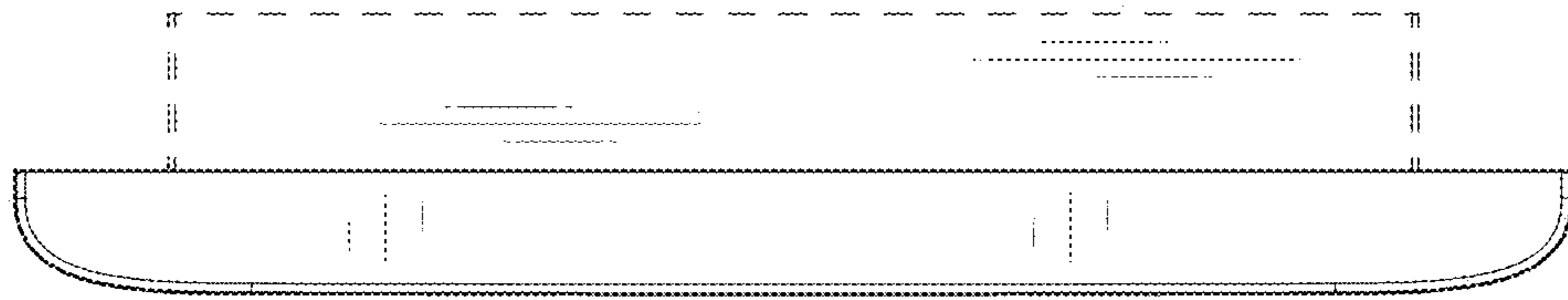

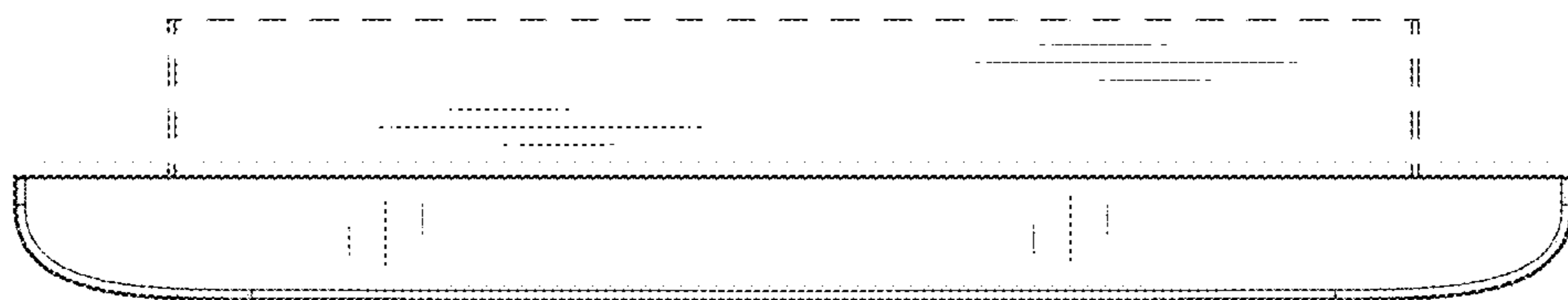

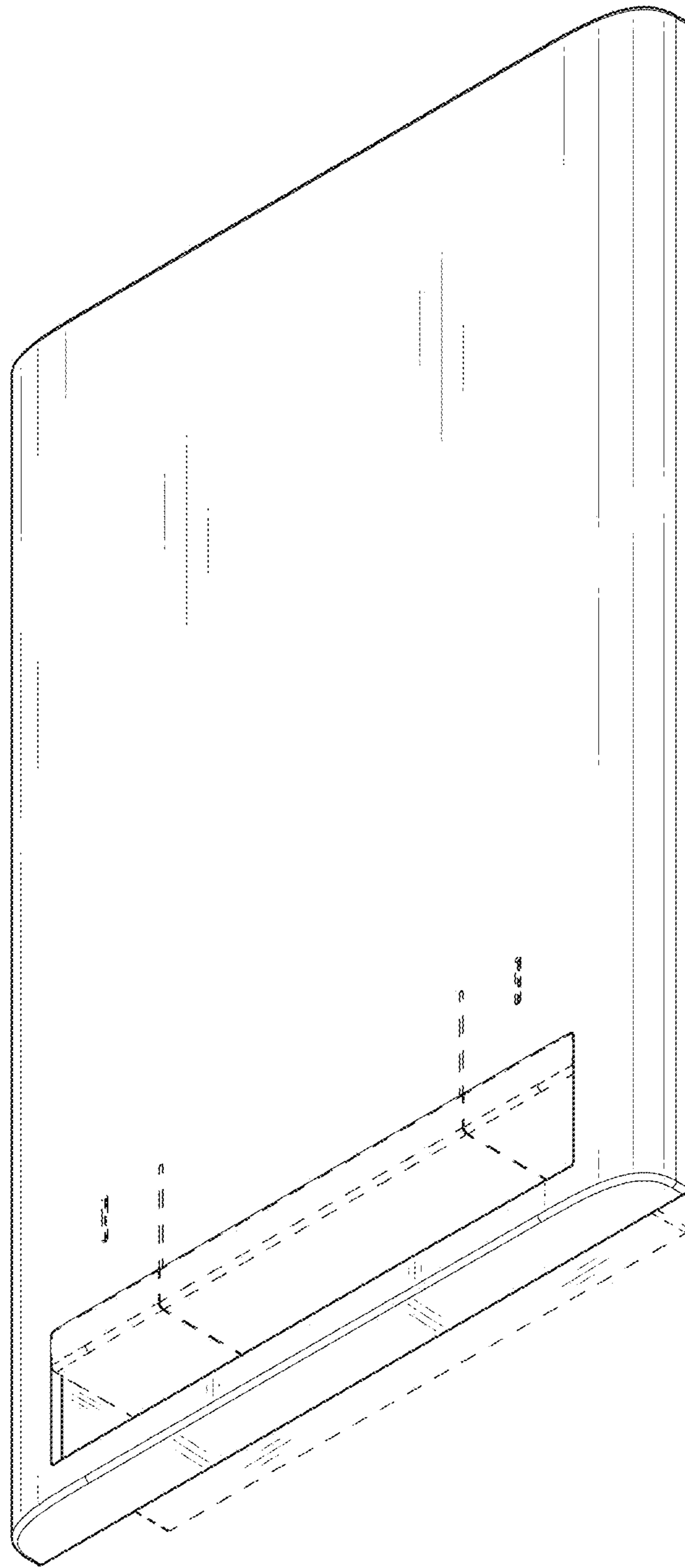
