**CLAIM**

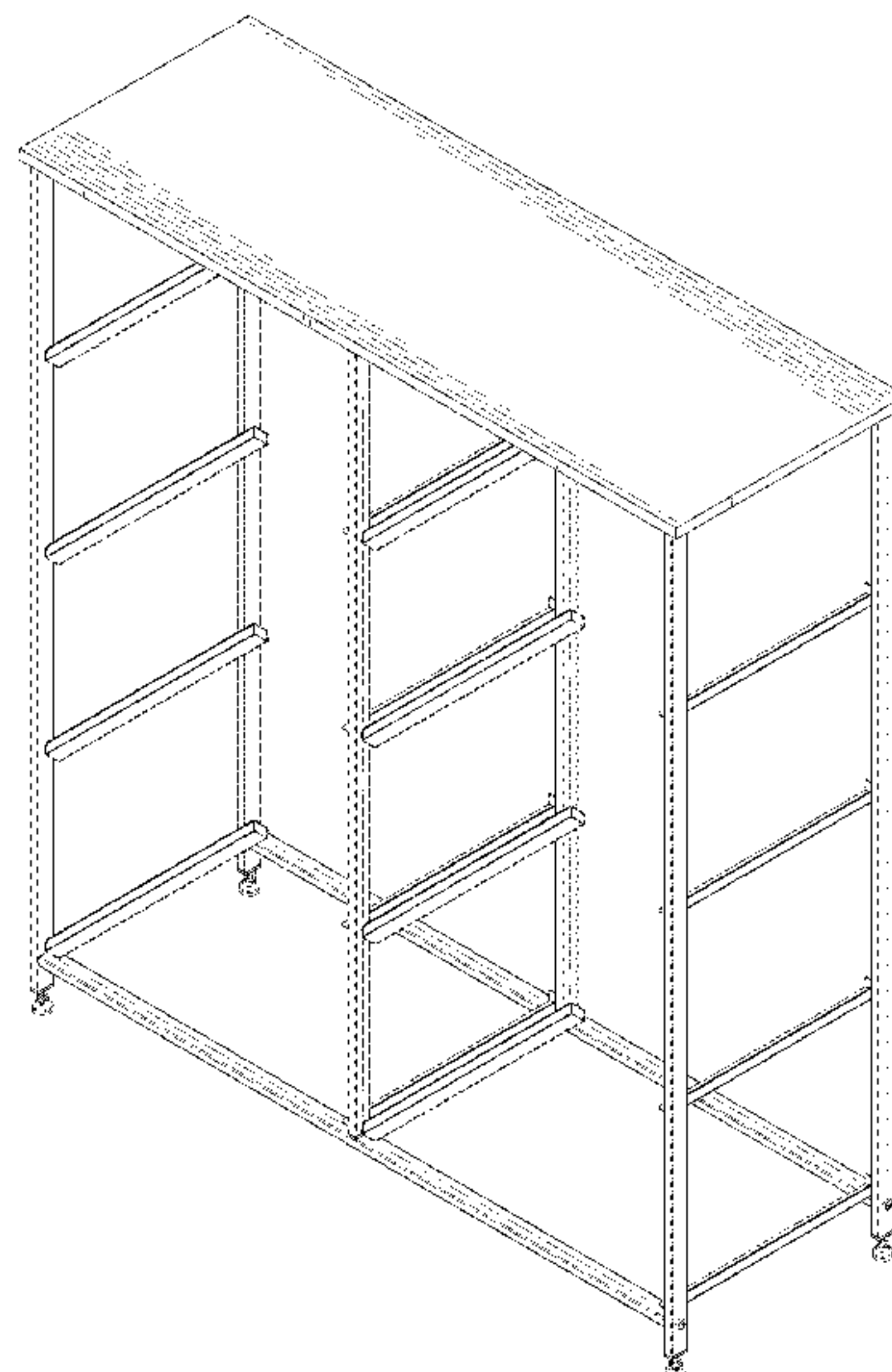
We claim the ornamental design for a drawer unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front/right/top perspective view of a drawer unit; FIG. 2 is a rear/right/bottom perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines depict portions of the drawer unit that form no part of the claimed design.

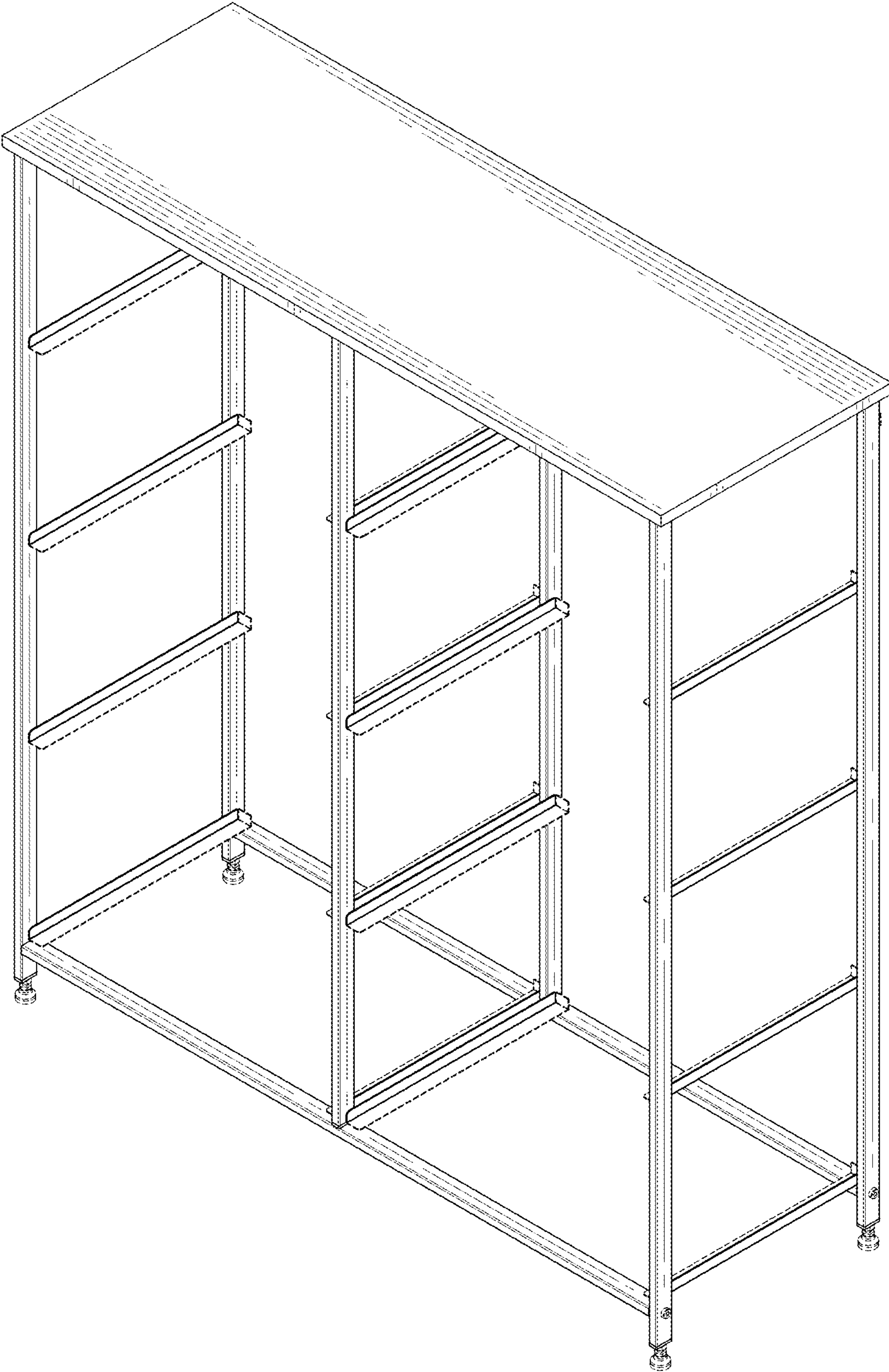

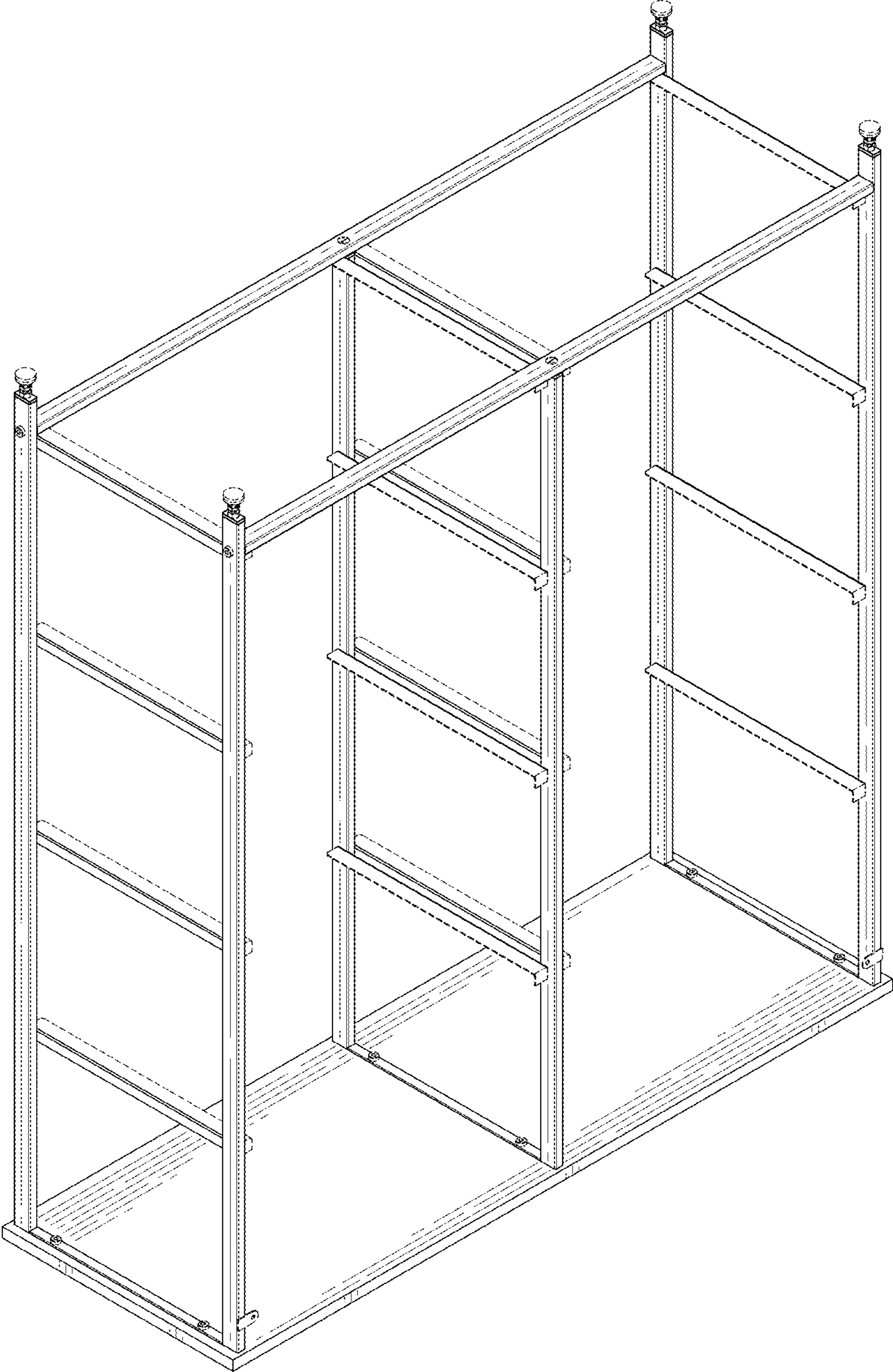

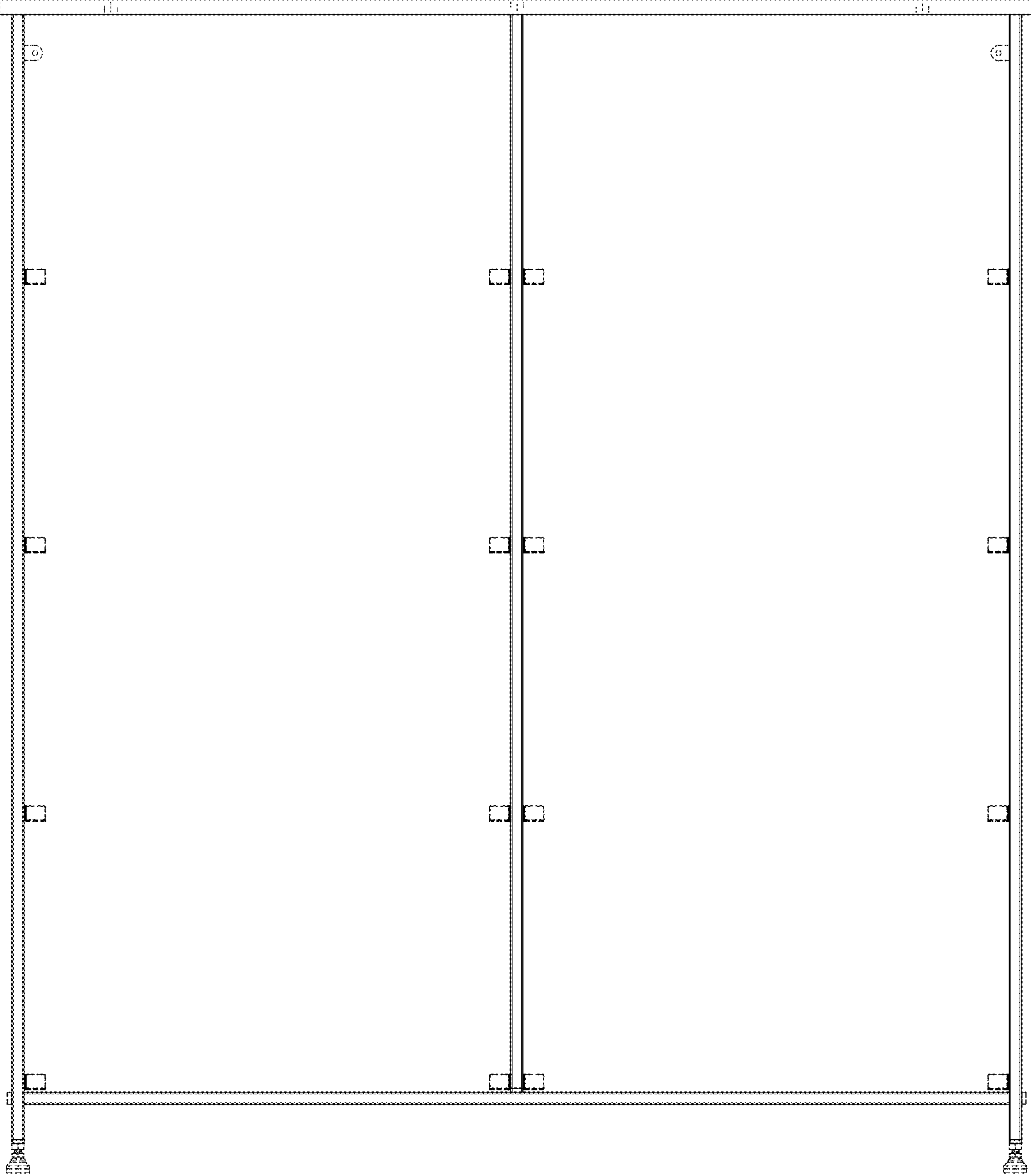

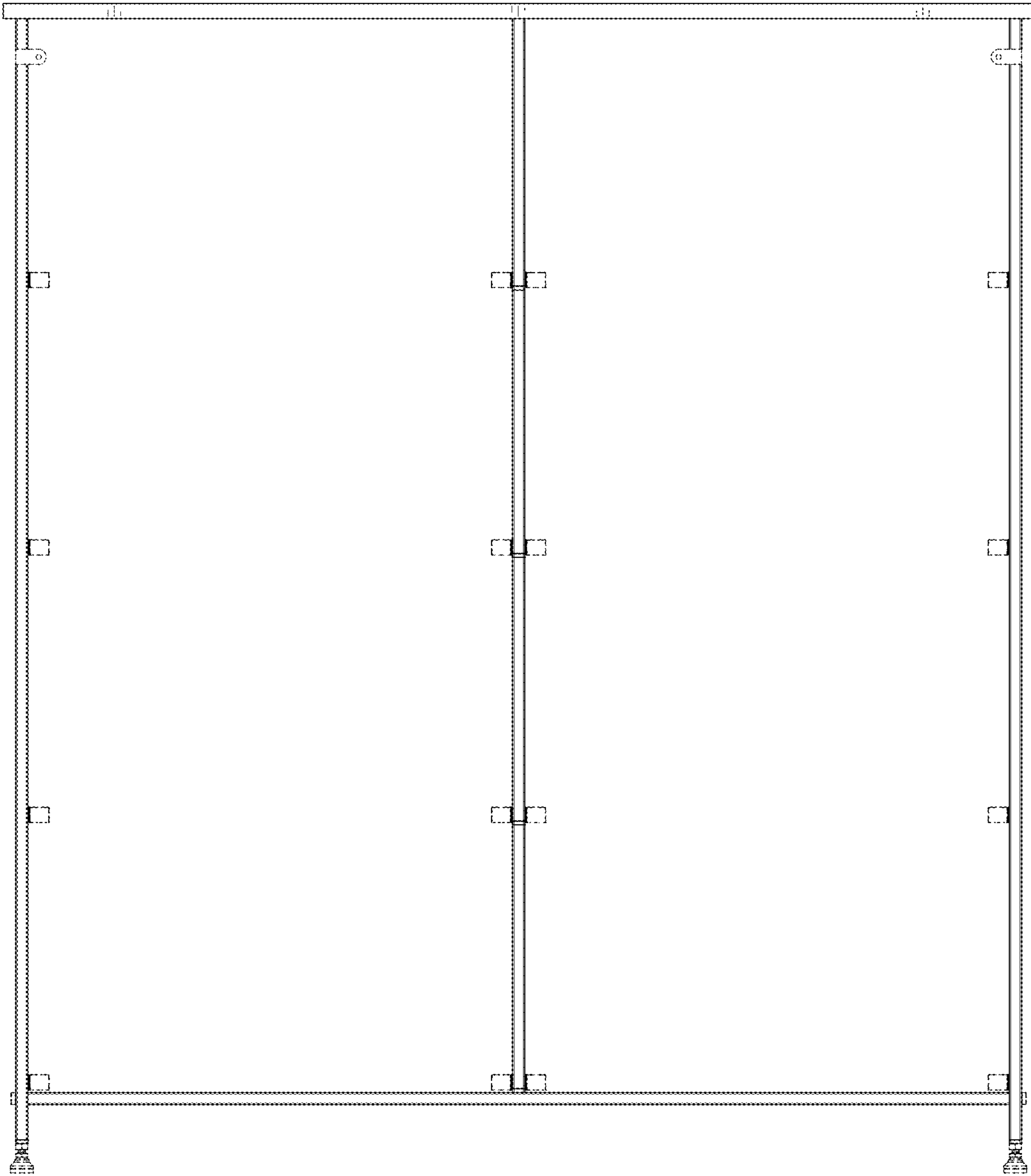

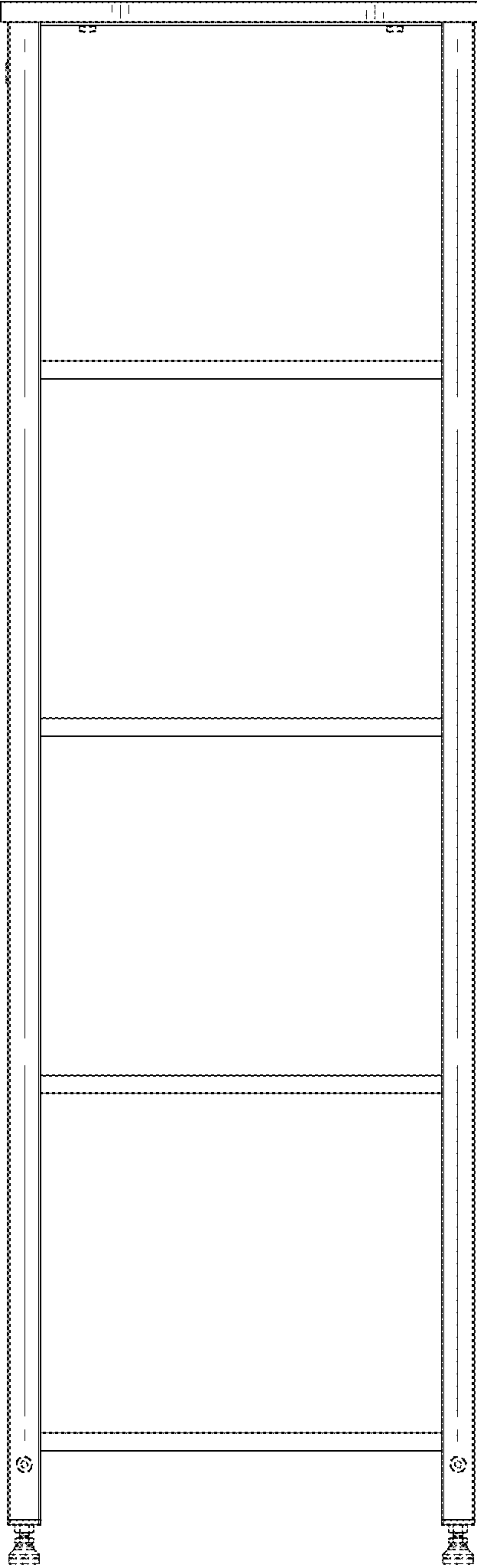

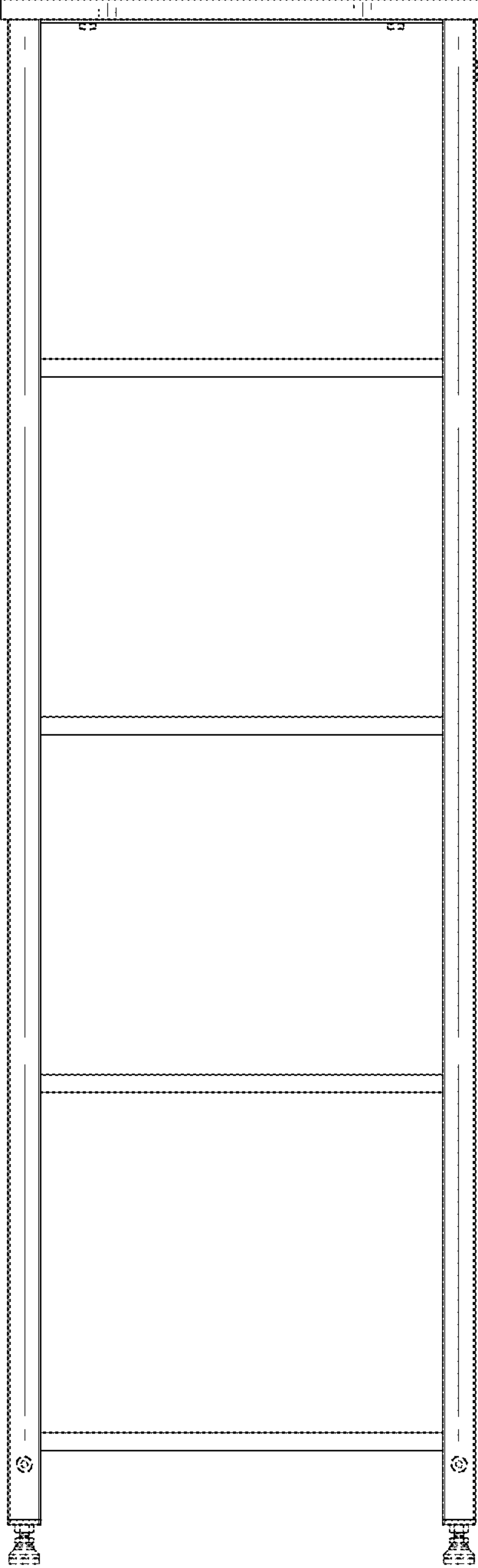

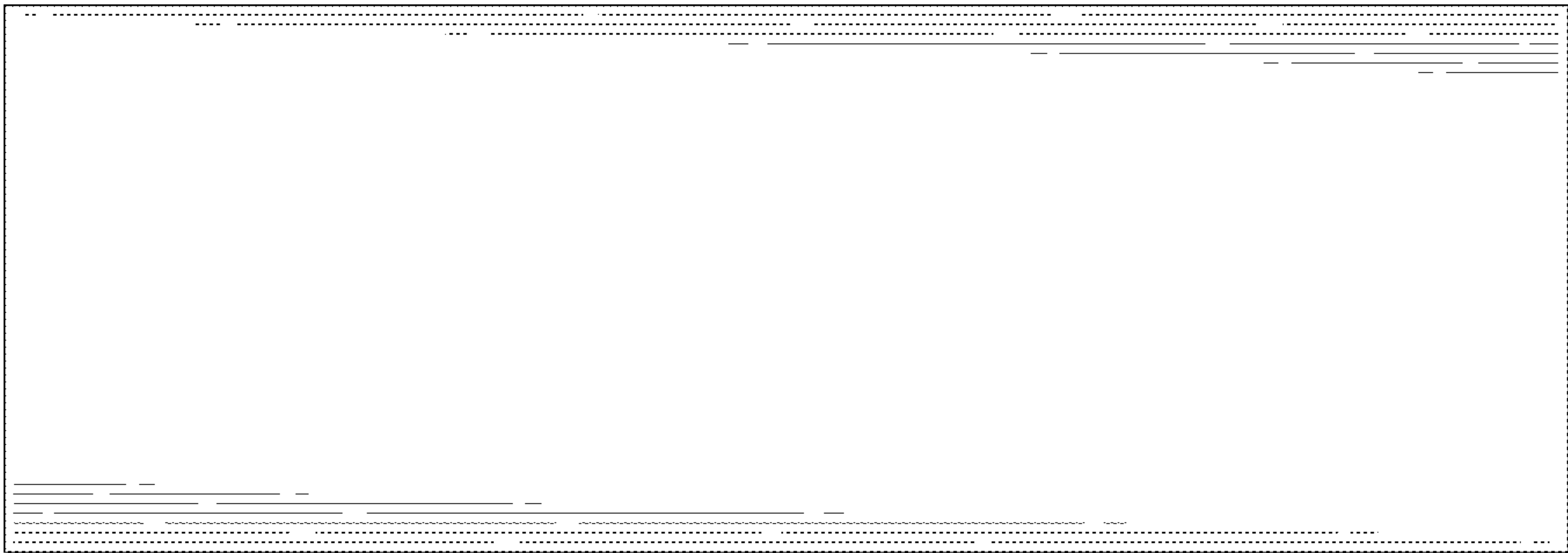

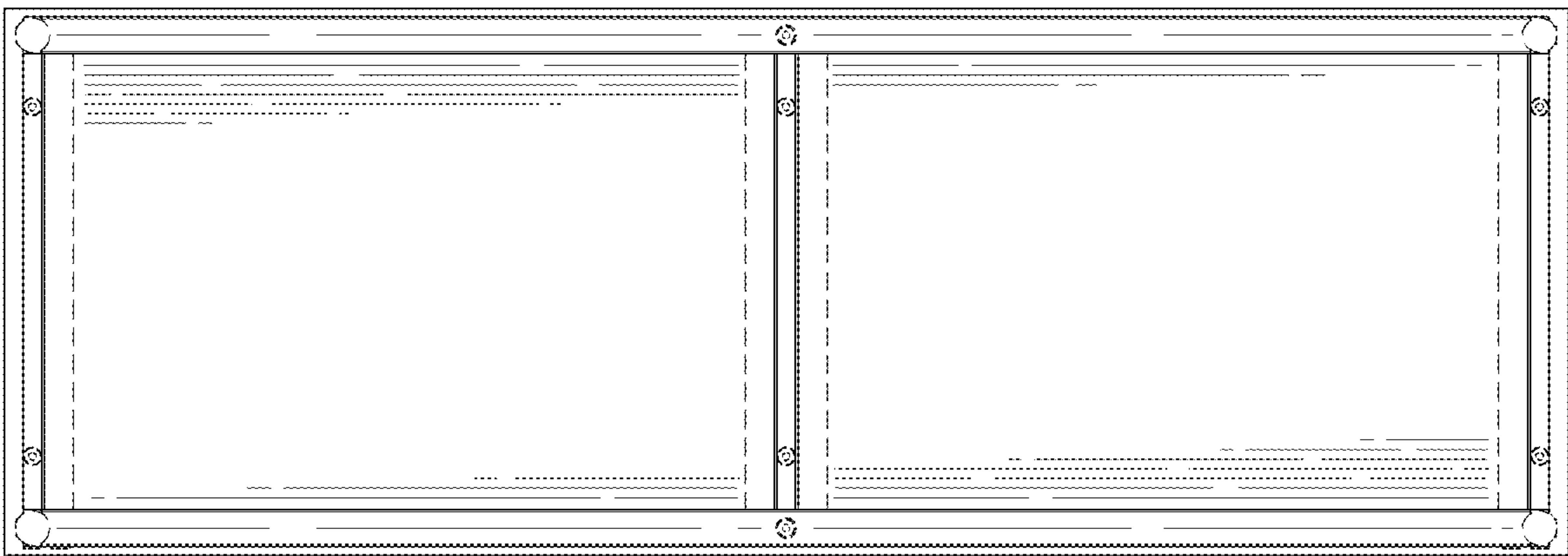
