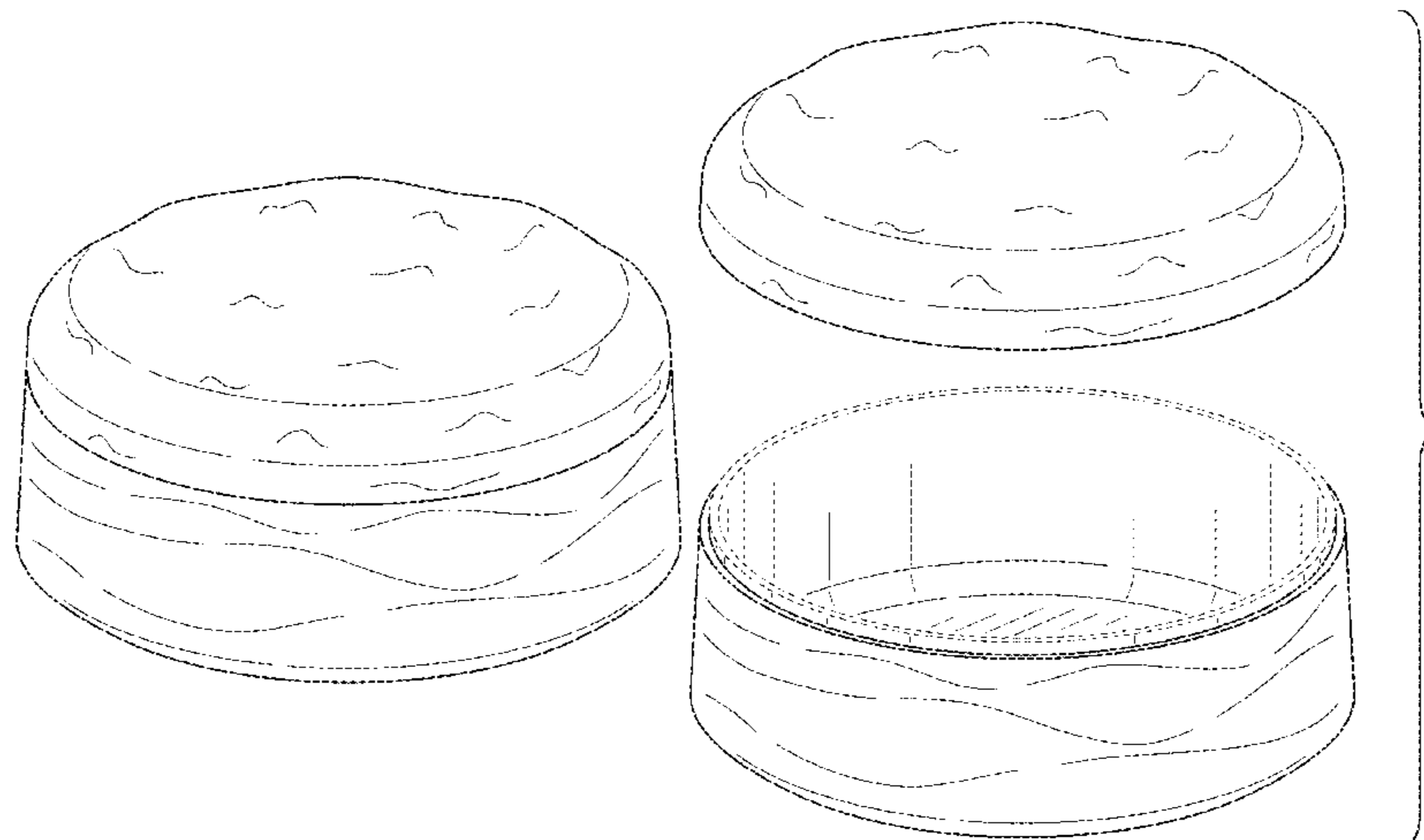
(57) **CLAIM**

The ornamental design for a container toy, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a container toy in a closed condition, showing the claimed design.

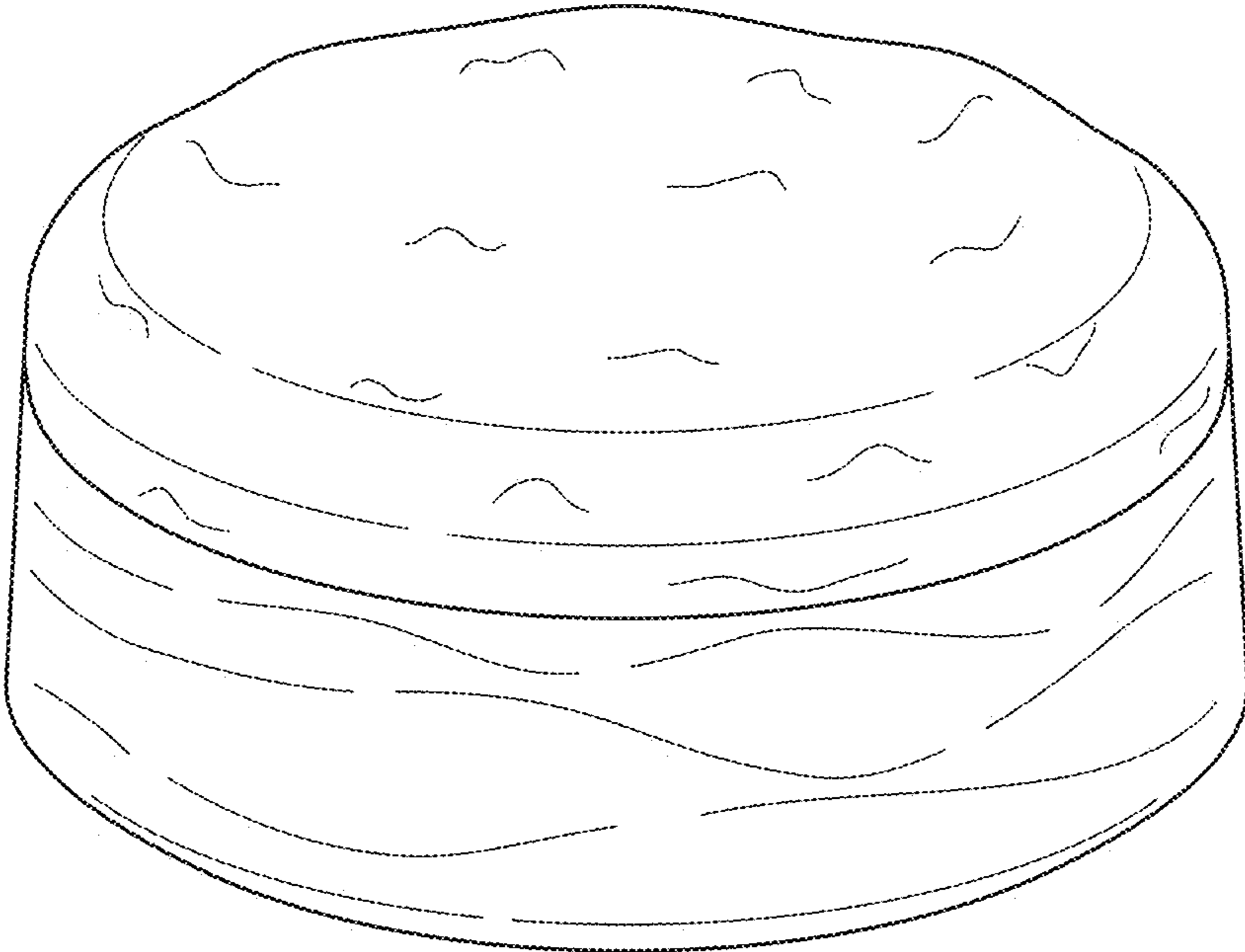

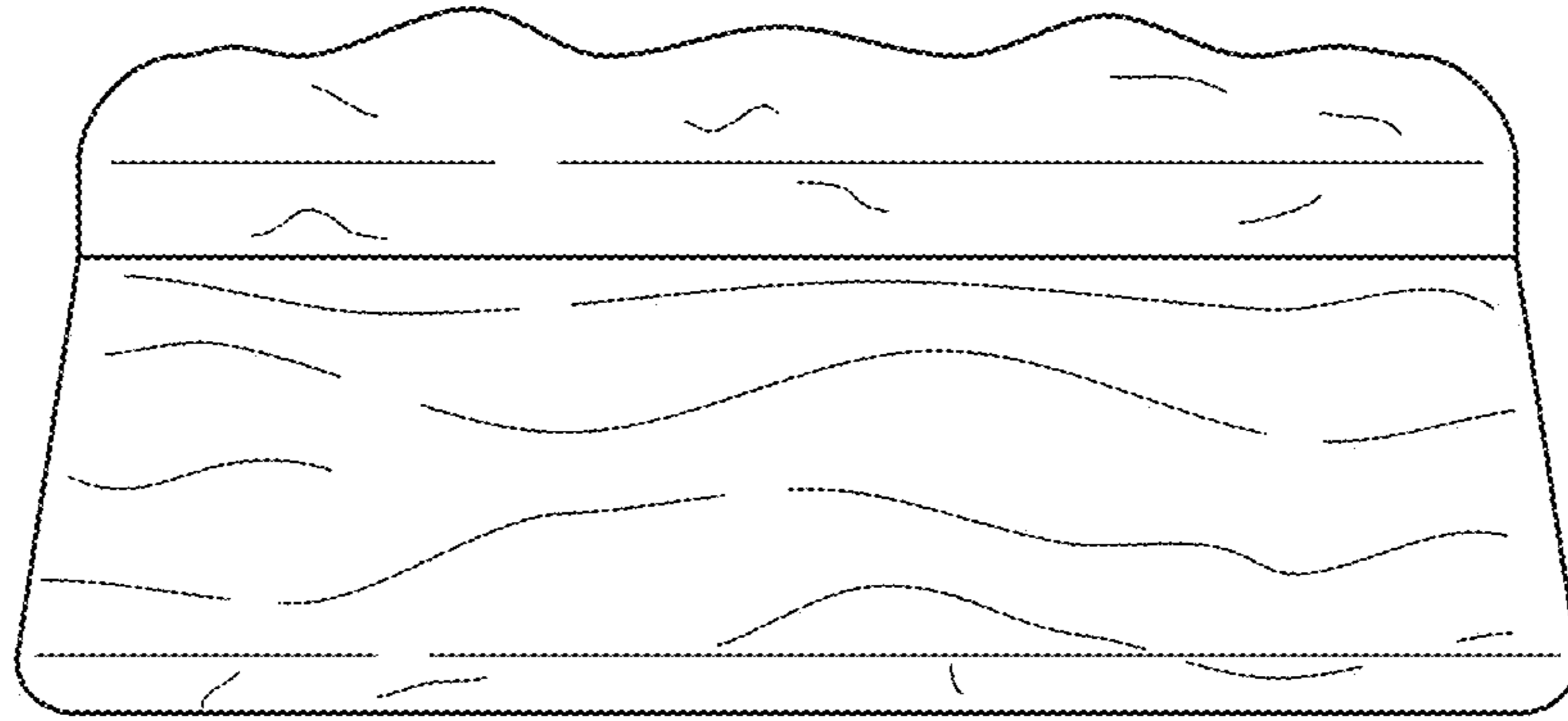

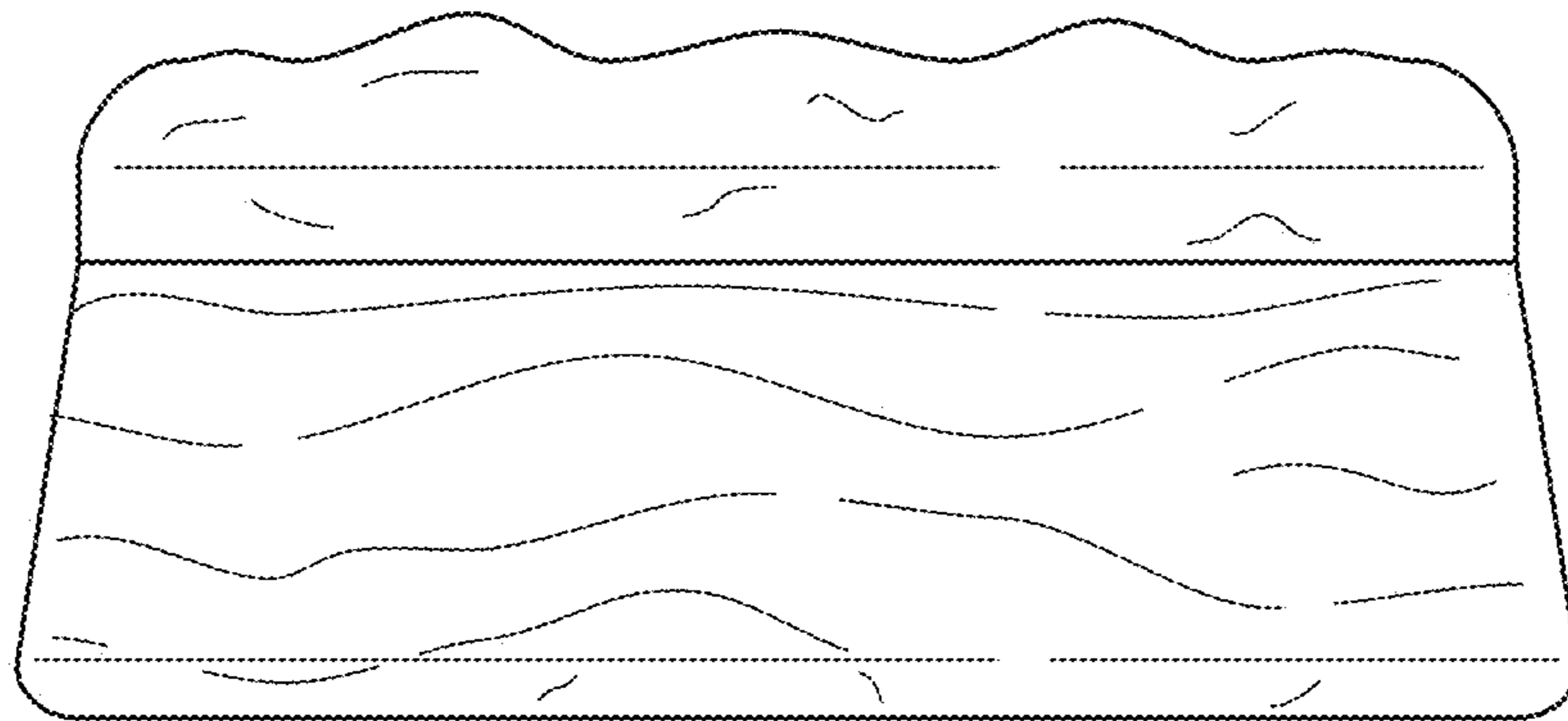

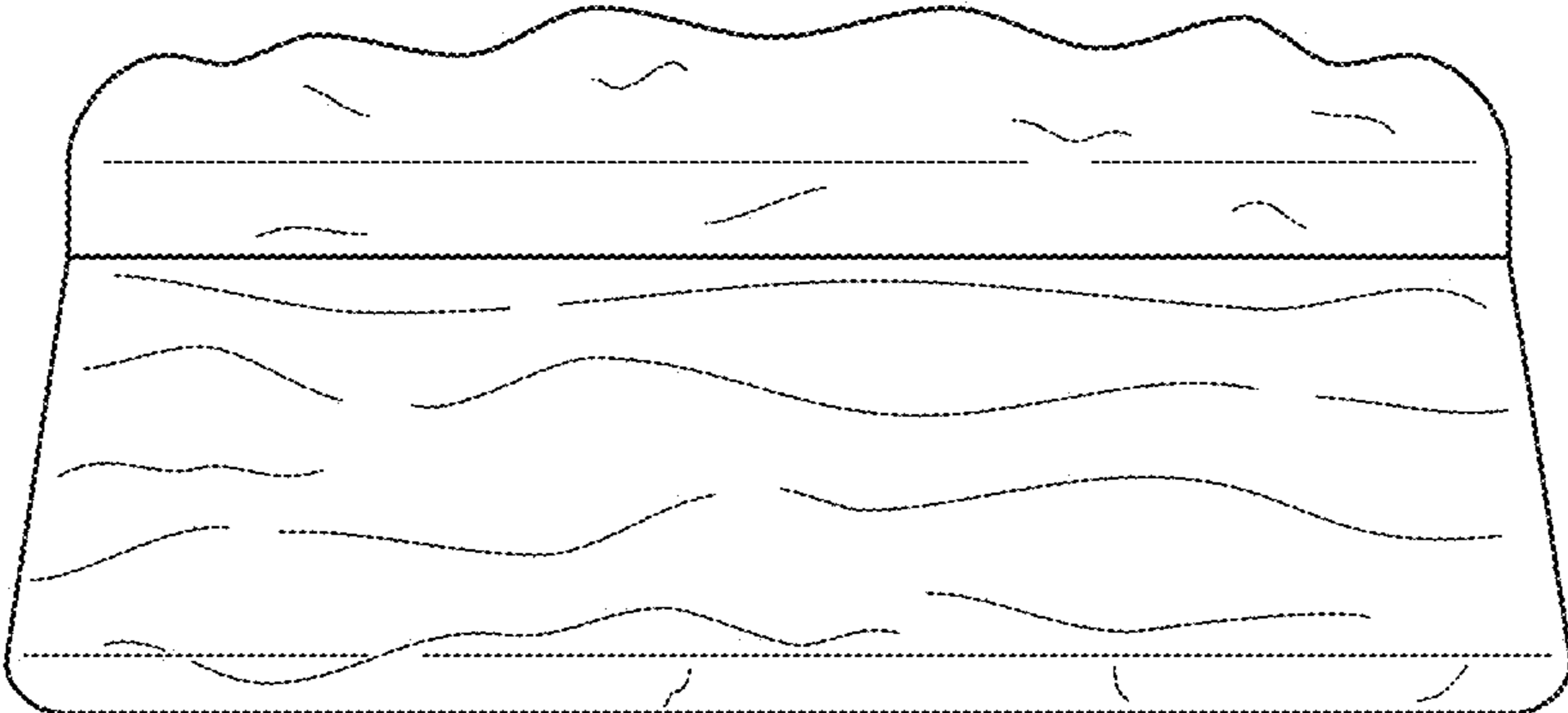

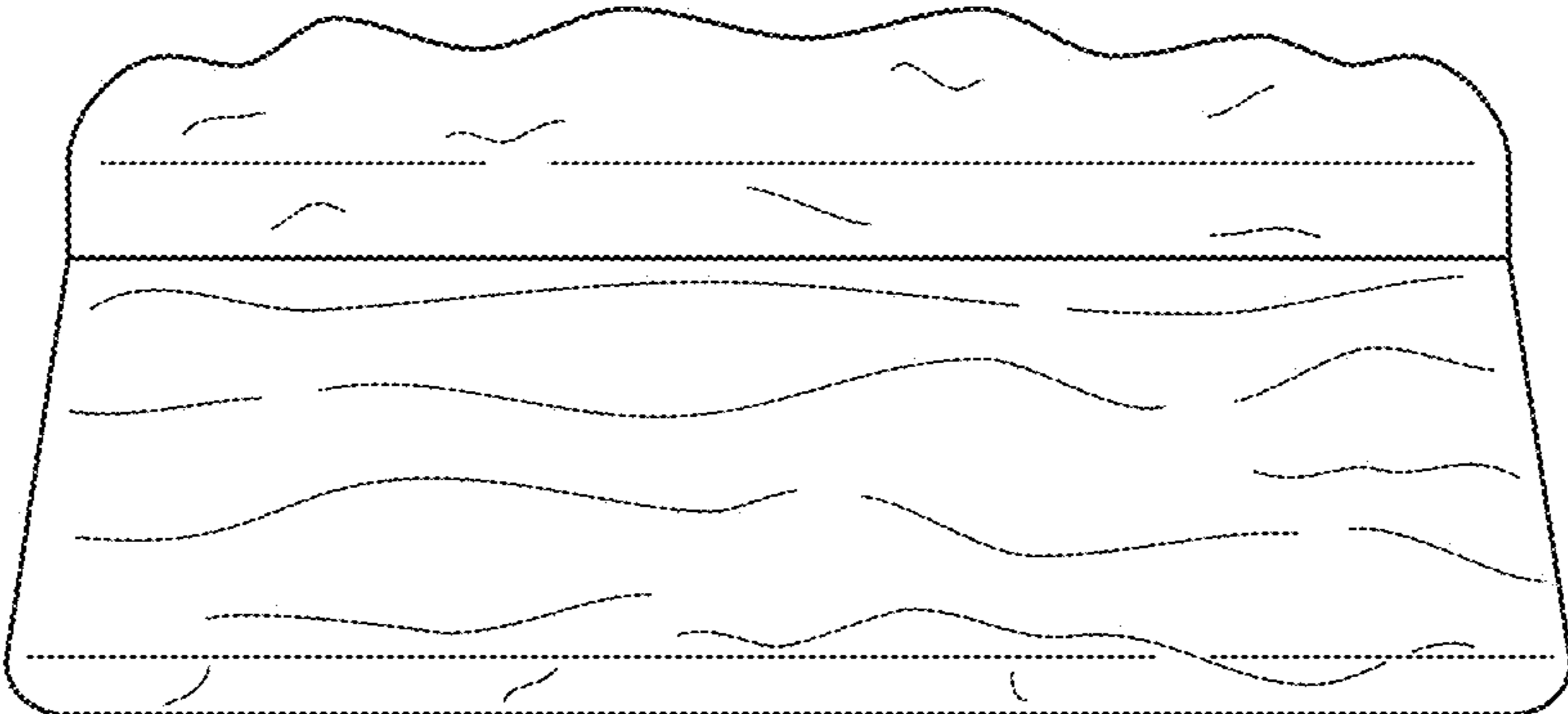

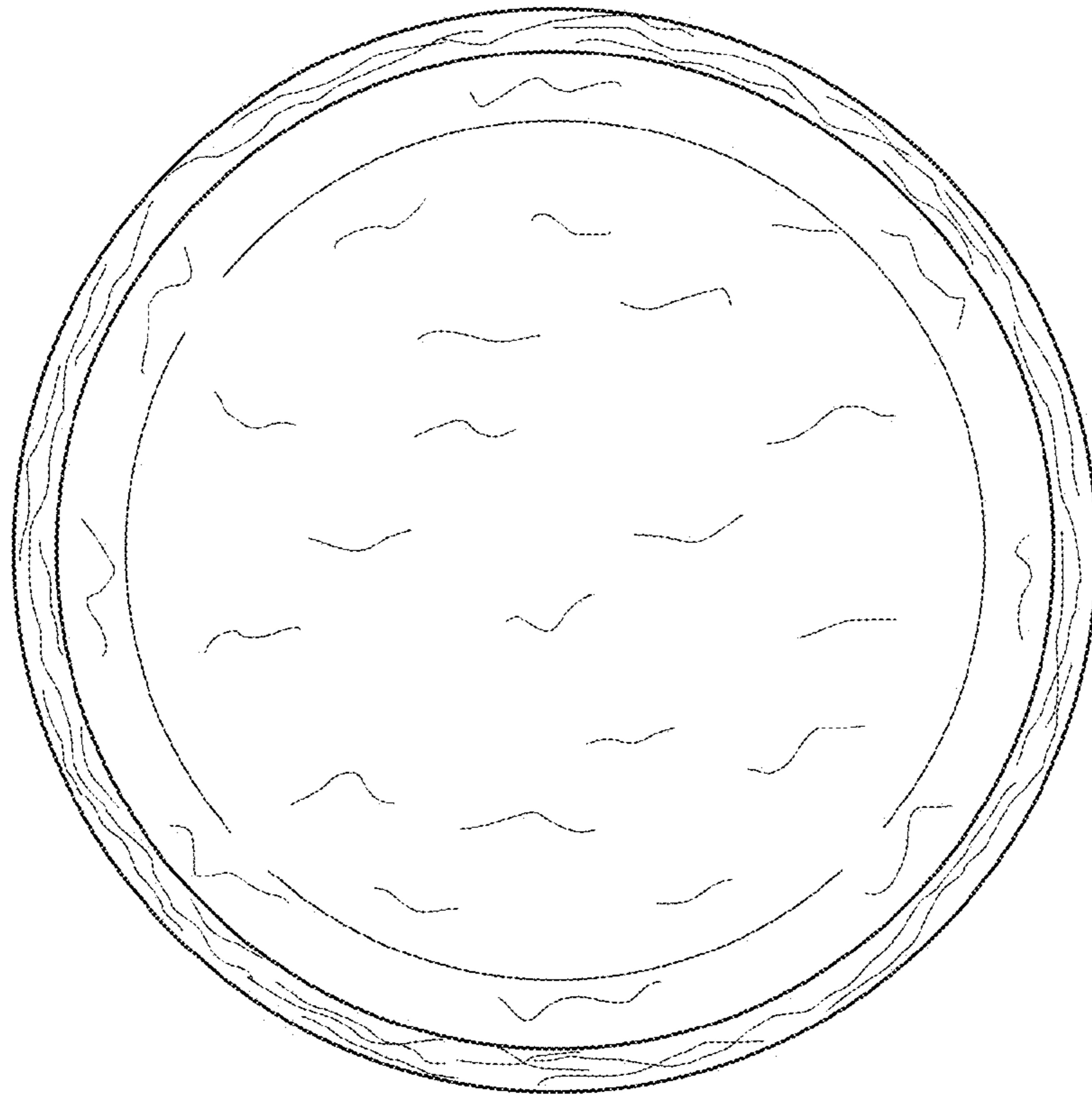

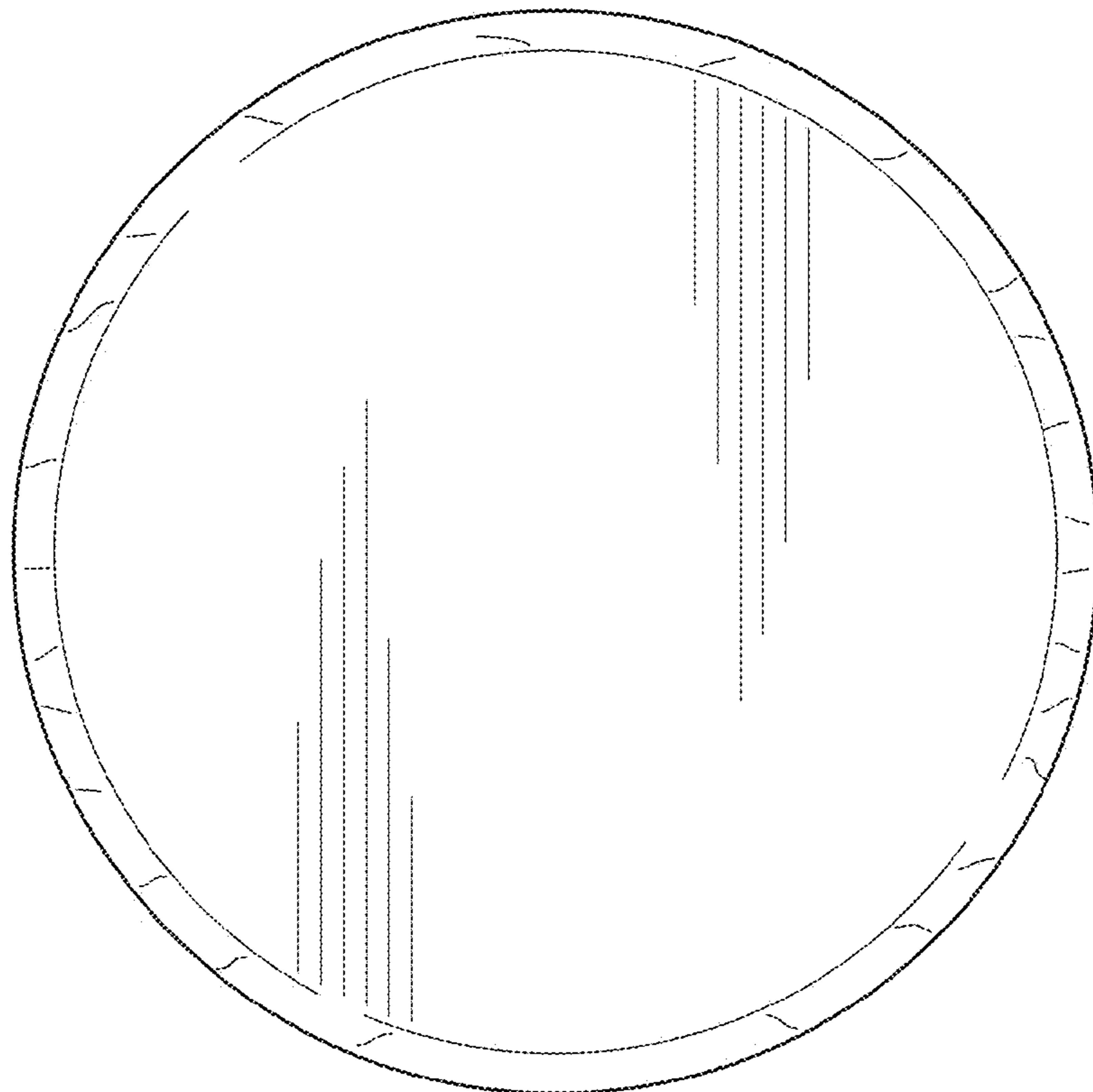

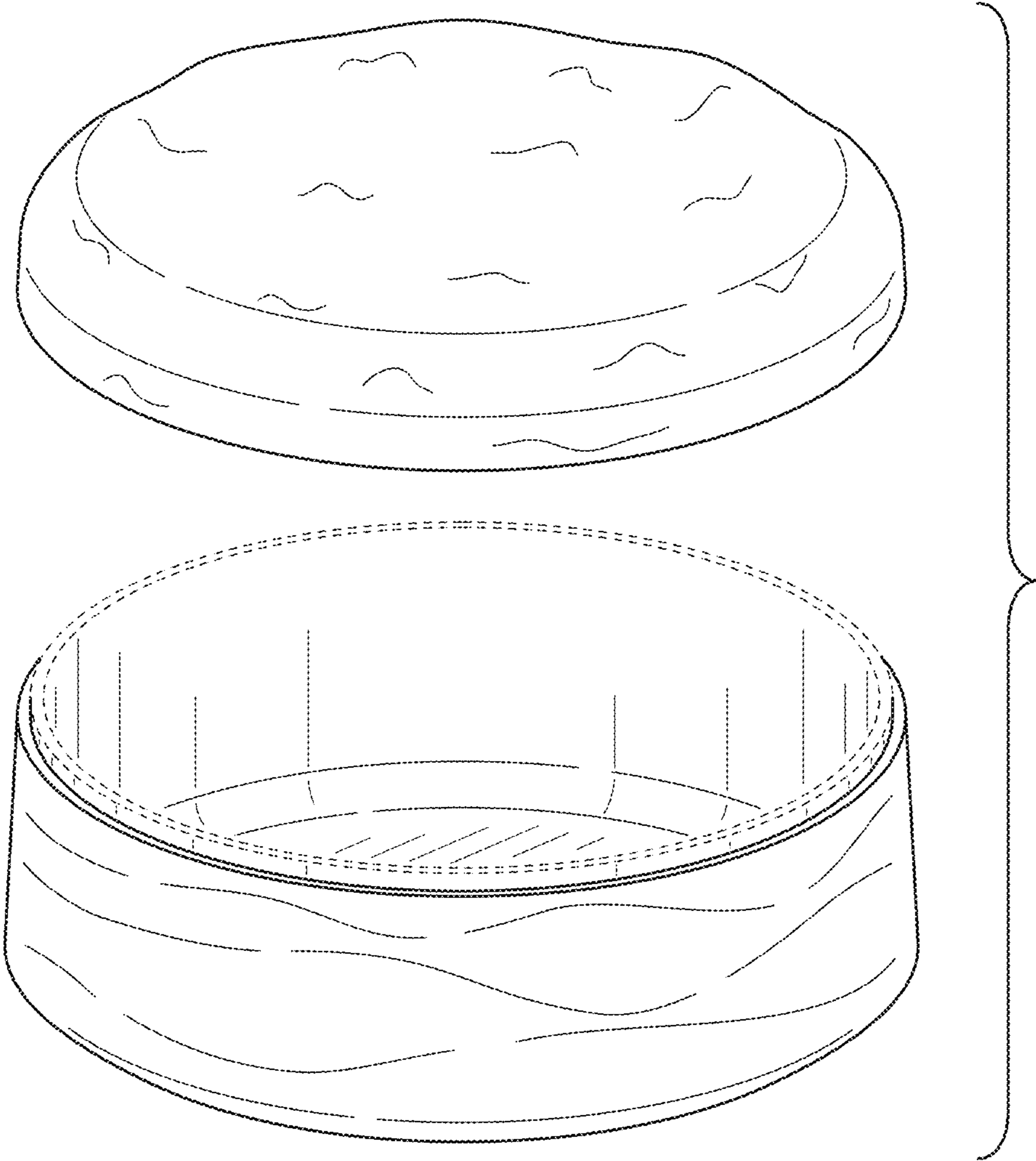
