The ornamental design for a vehicle door, as shown and described.

**DESCRIPTION**

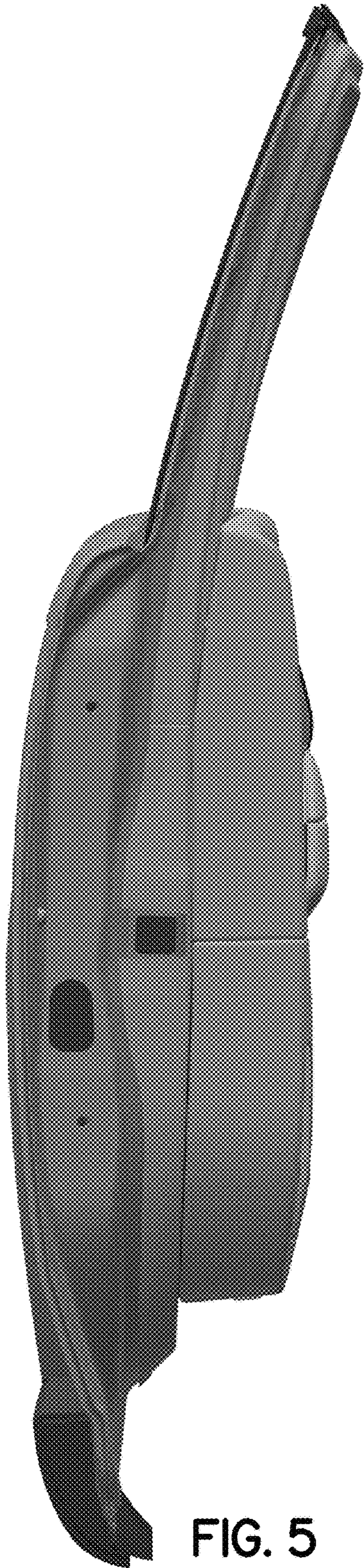

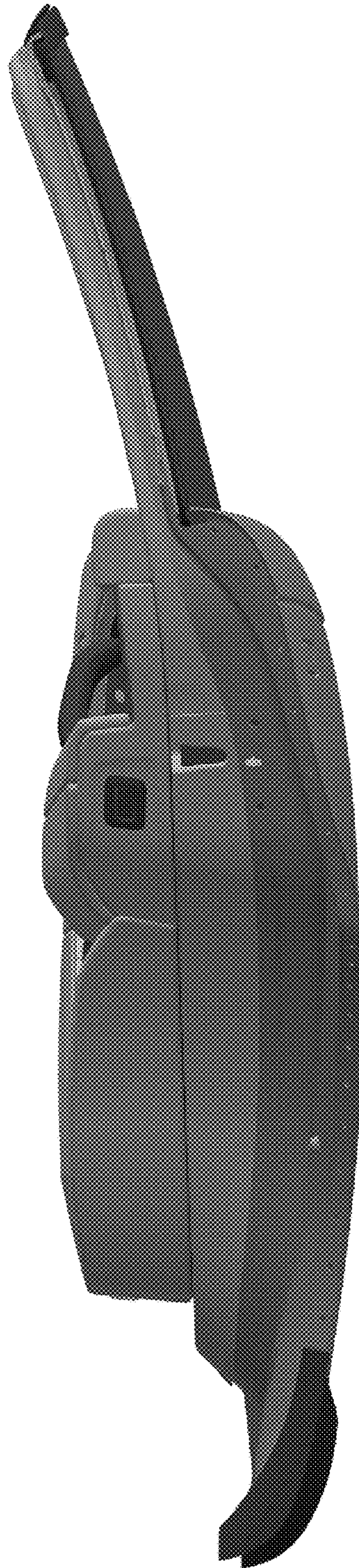

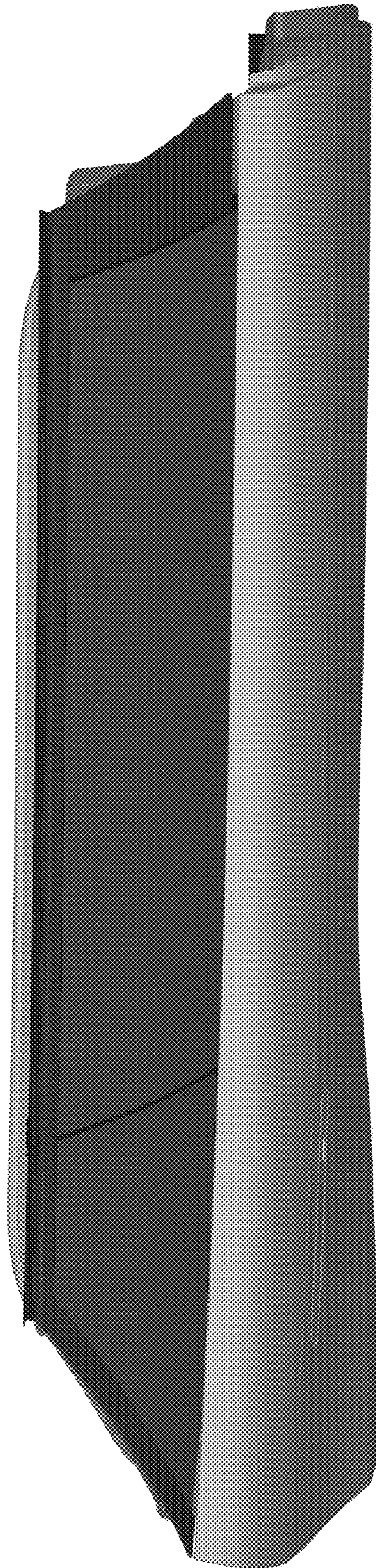

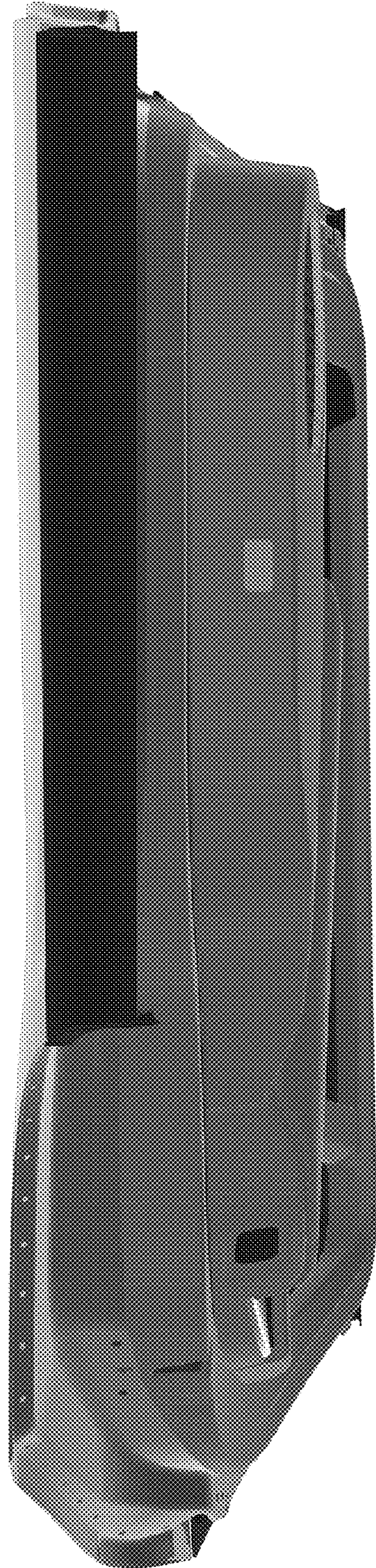
