(57) **CLAIM**

What is claimed is the ornamental design for a ball for sports, as shown and described.

**DESCRIPTION**

FIG. 3 is a front elevational view of a third embodiment shown in black;

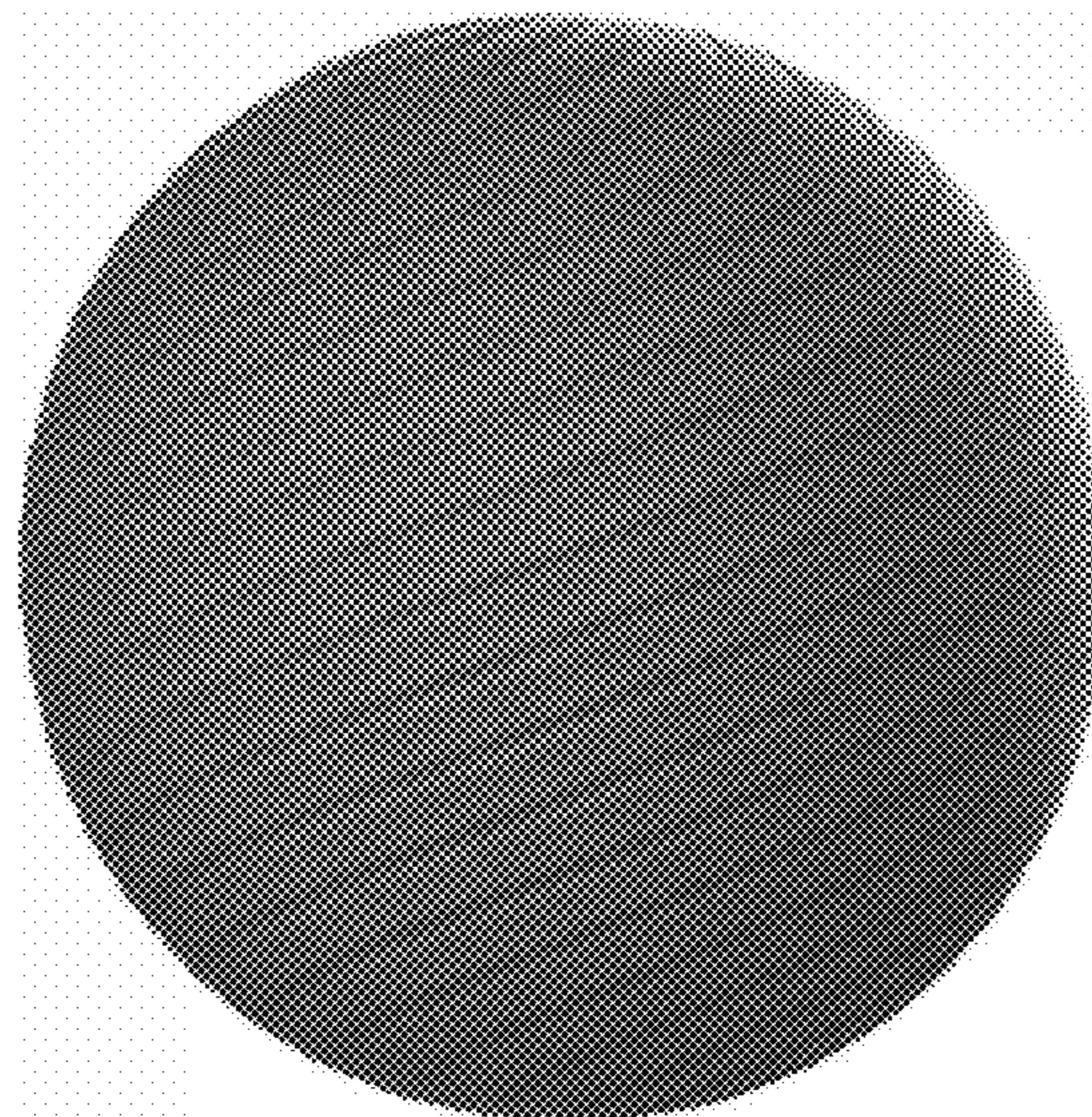
FIG. 4 is a front elevational view of a fourth embodiment shown in indigo;
