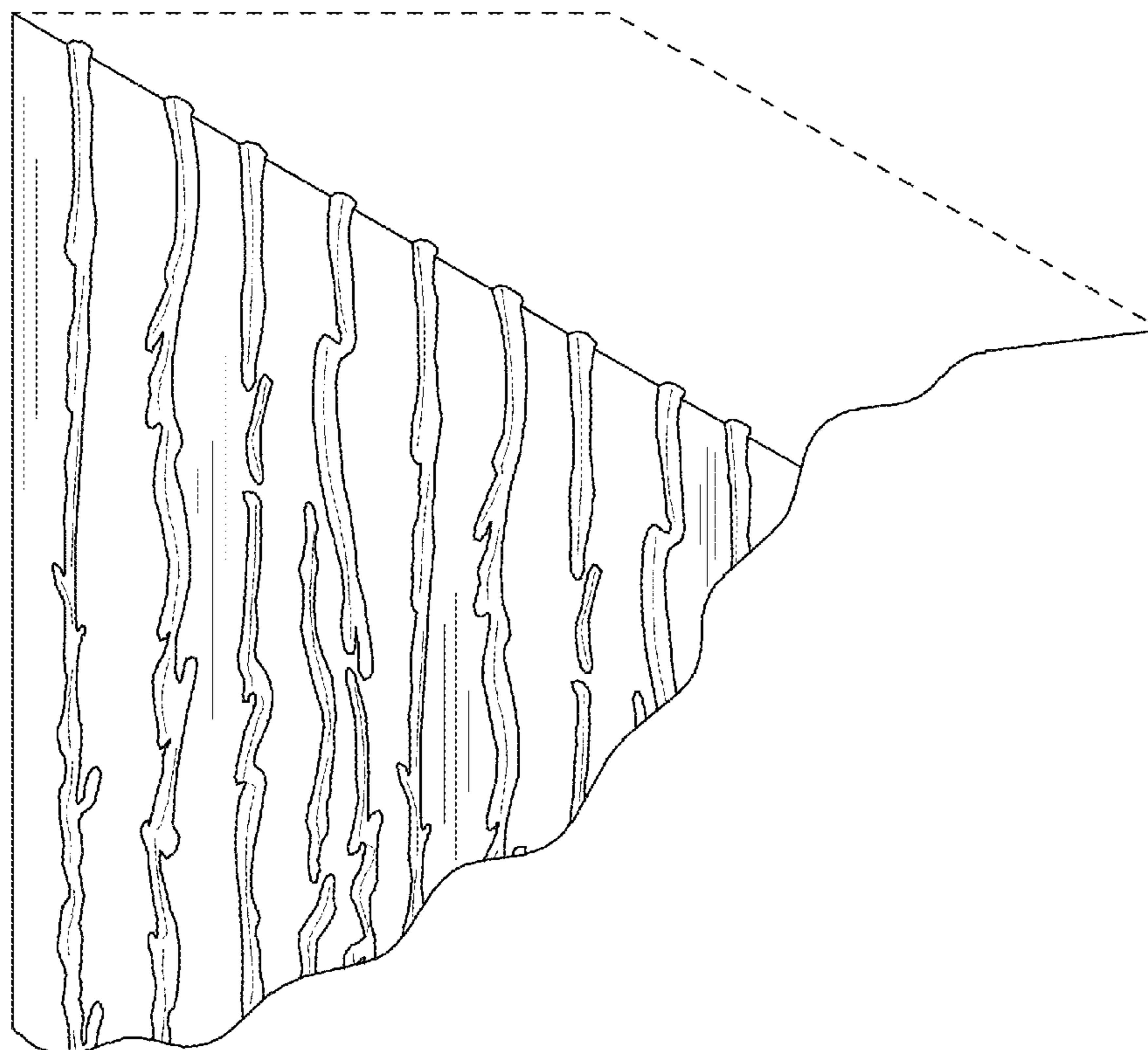
(57) **CLAIM**

The ornamental design for a composite and synthetic column and column wrap, as shown.

DESCRIPTION

FIG. 1 shows an enlarged perspective view of a portion of a composite and synthetic column and column wrap; FIG. 2 shows a perspective view thereof; FIG. 3 shows a top plan view thereof; FIG. 4 shows a front elevation view thereof; FIG. 5 shows a side elevation view thereof; FIG. 6 shows a back elevation view thereof; FIG. 7 shows a side elevation view thereof; and, FIG. 8 shows a bottom plan view thereof. The broken lines shown in FIGS. 1-3 and 8 illustrate portions of the composite and synthetic column and column wrap that form no part of the claimed design.

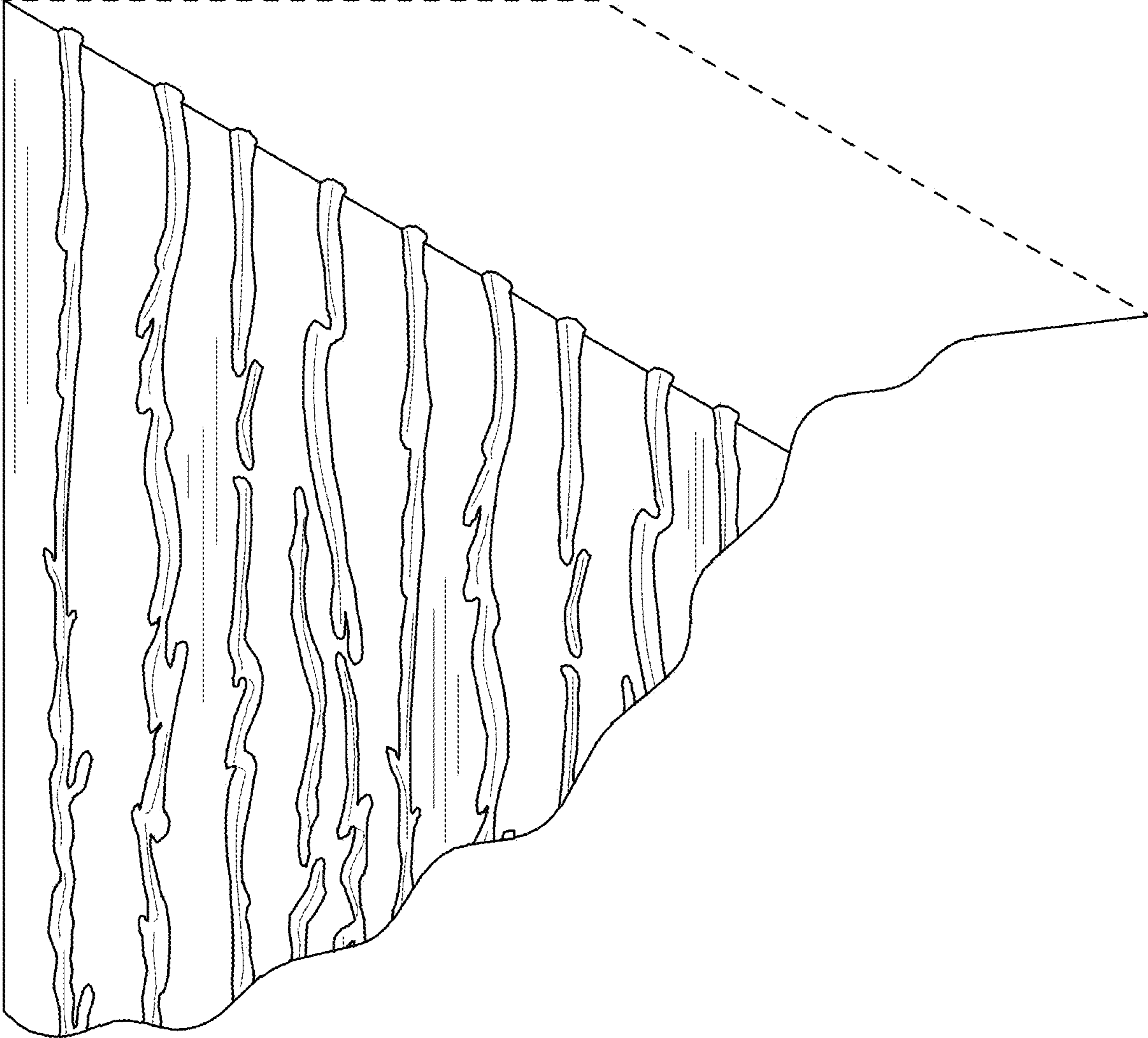

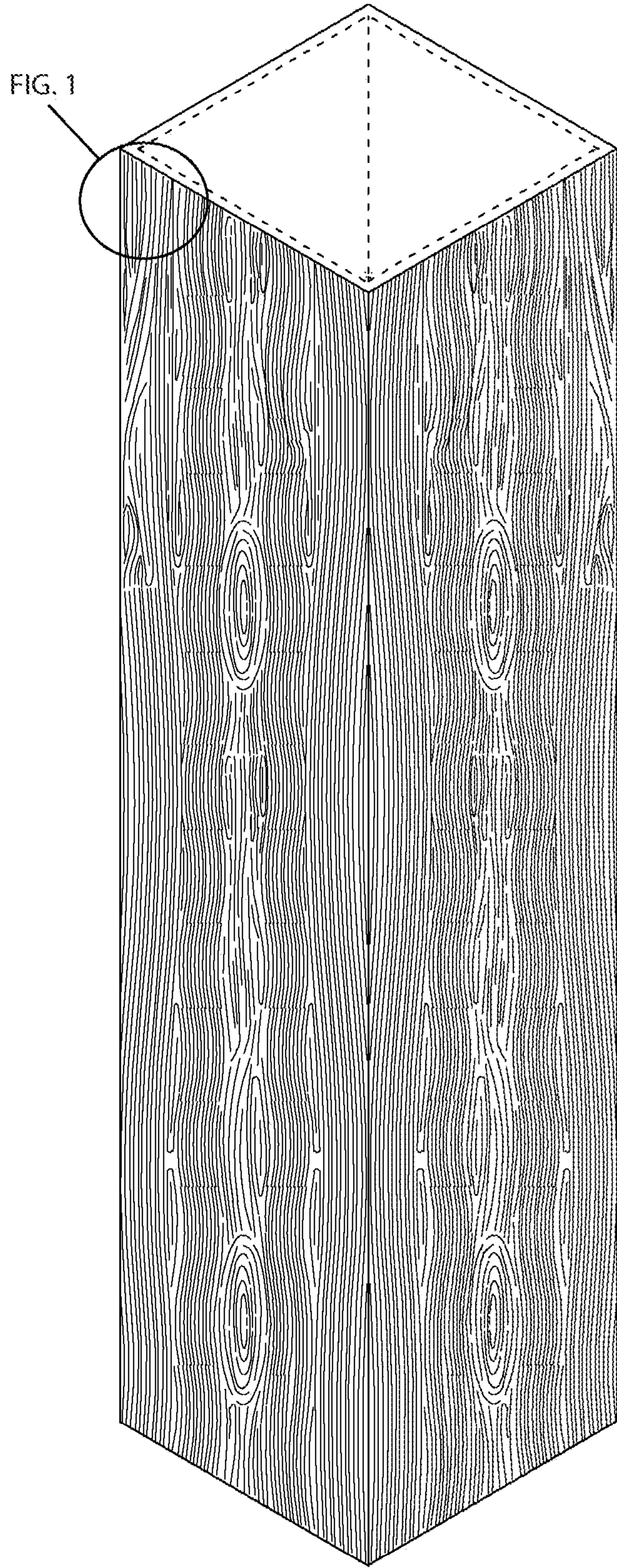

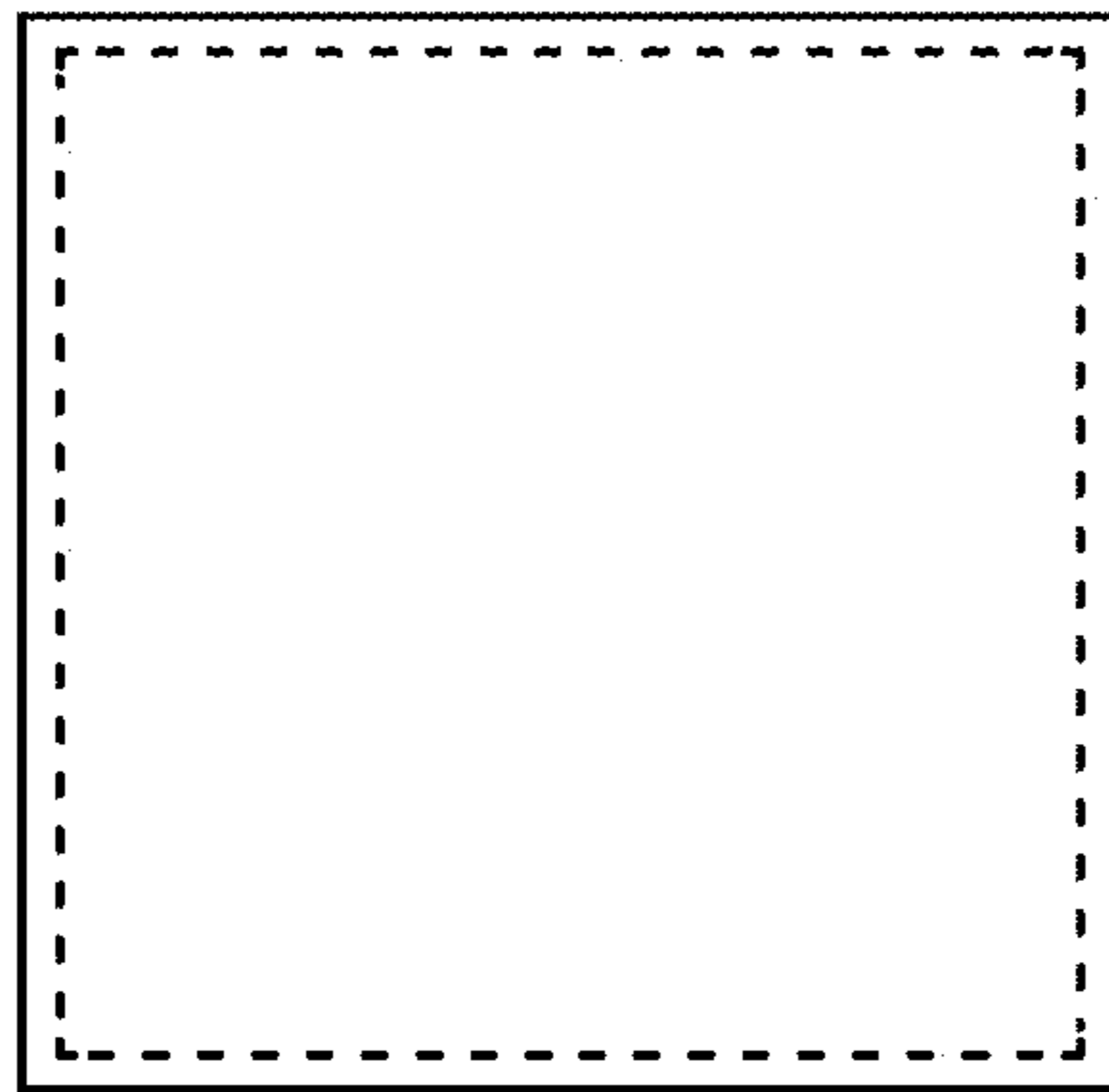

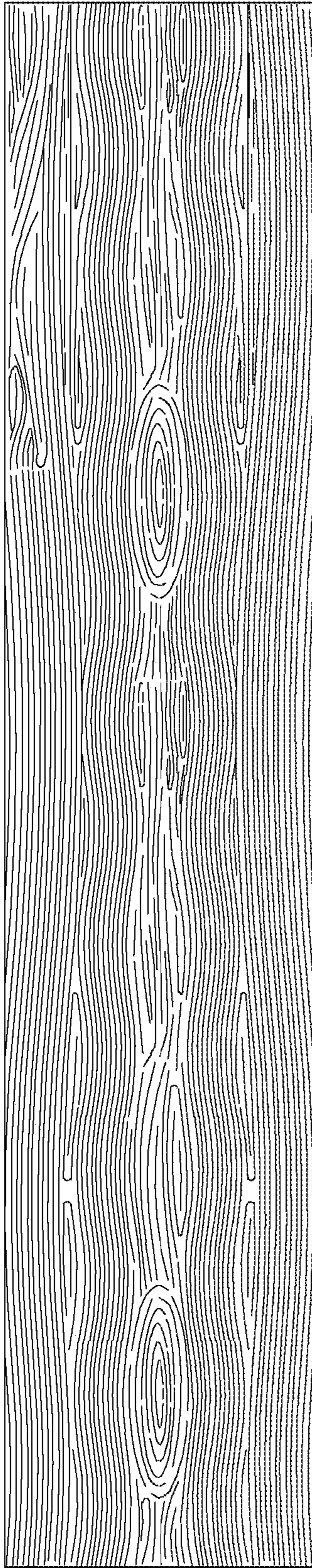

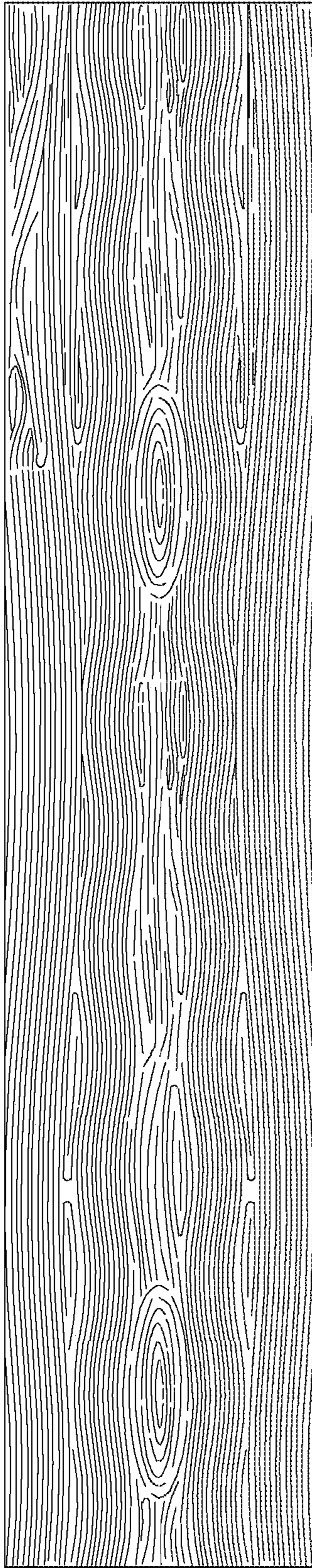

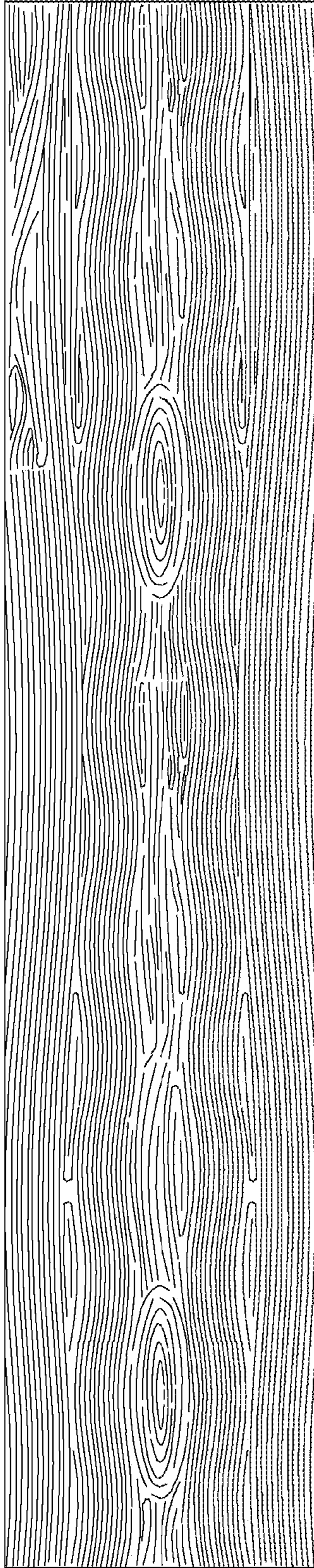

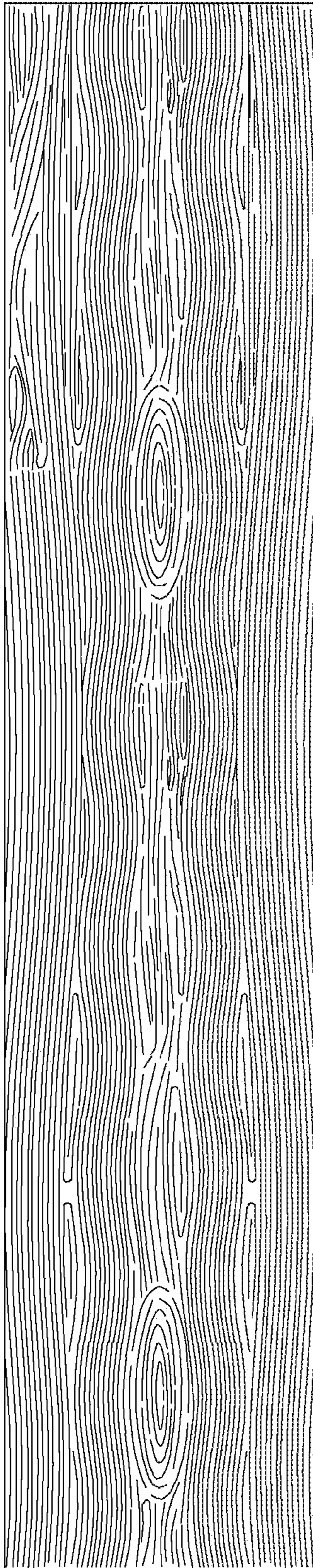

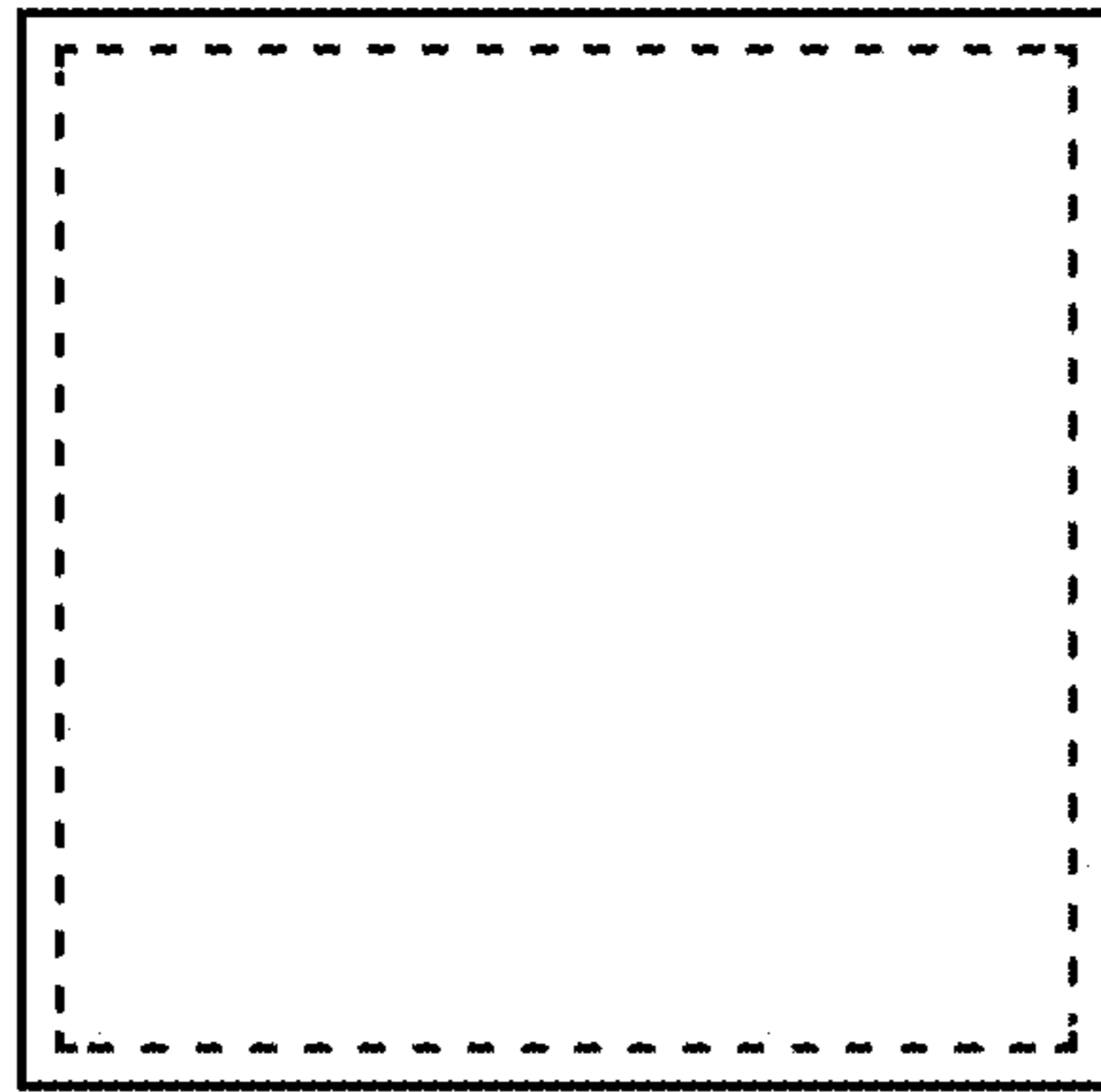
