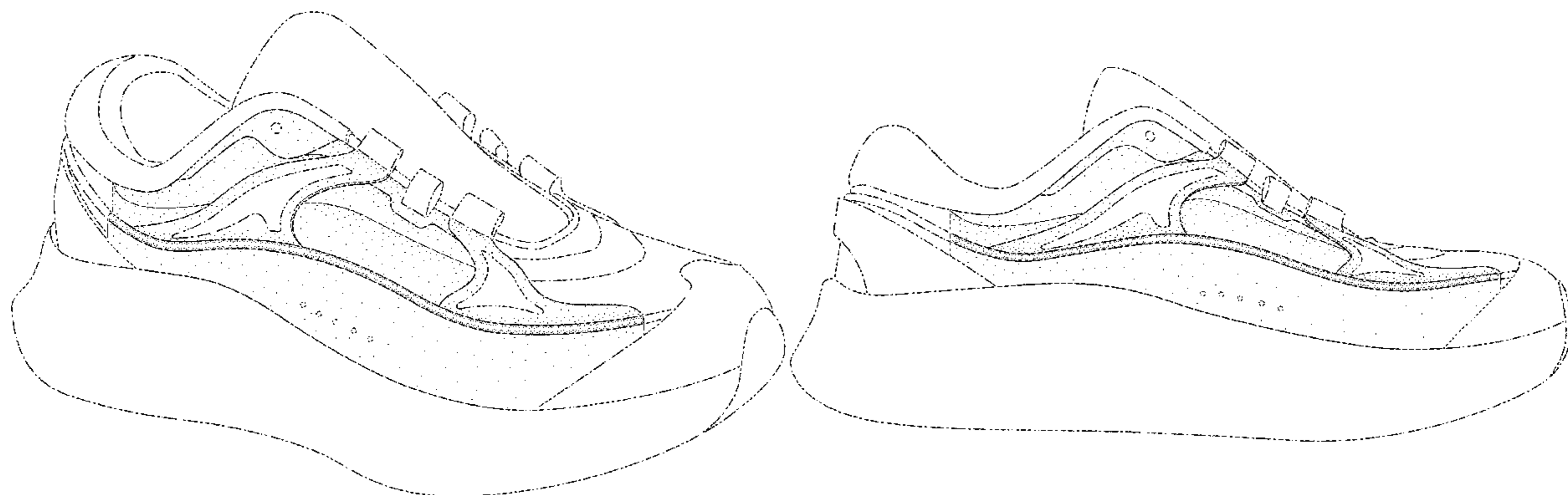
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken line showing of the two unshaded interior regions form no part of the claimed design. The broken line showing of the five small circular shaped elements on the lower panel form no part of the claimed design. The broken line showing of the circular shaped element adjacent the tongue region represents an eyelet that forms no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

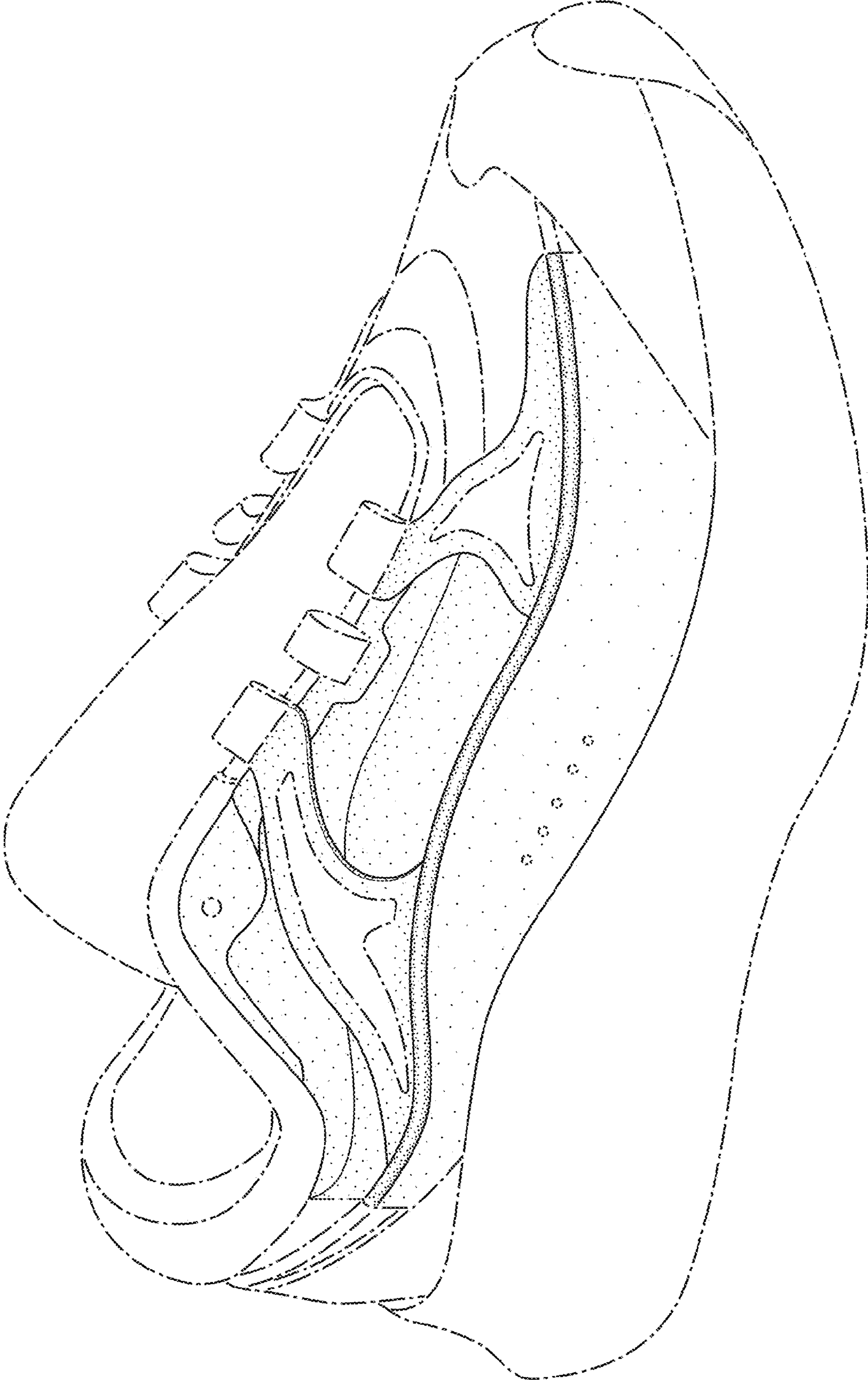

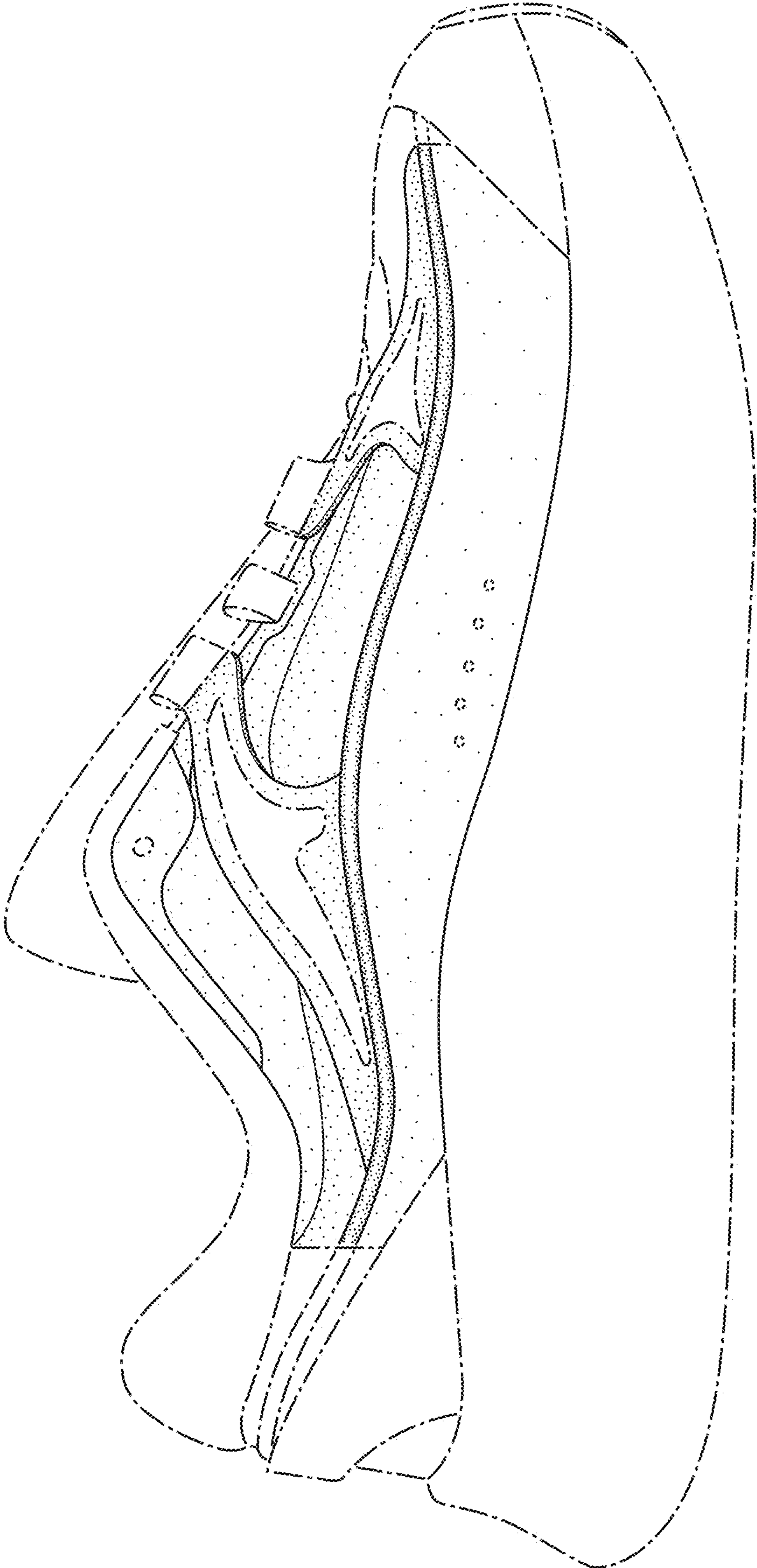

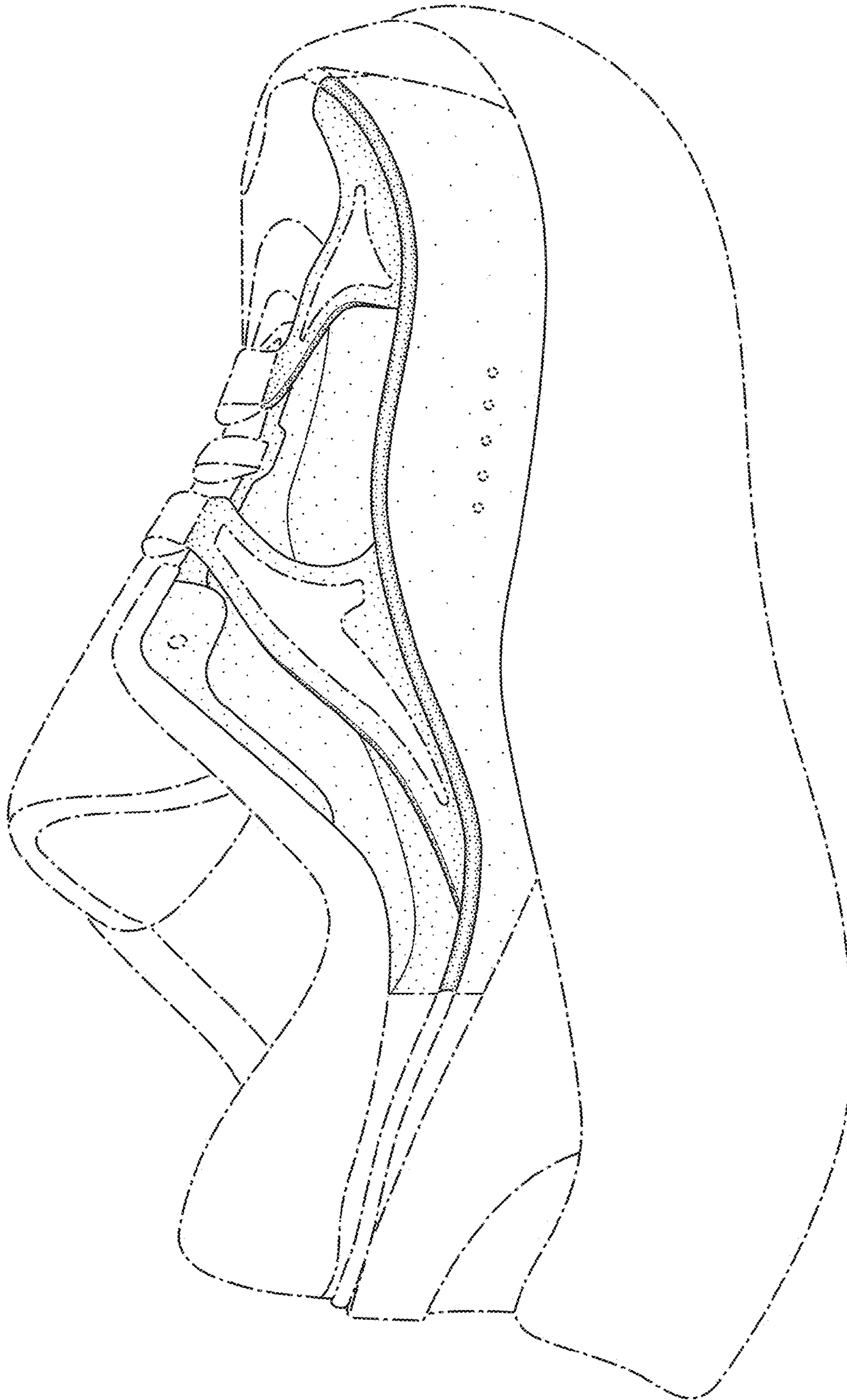
