(57) **CLAIM**

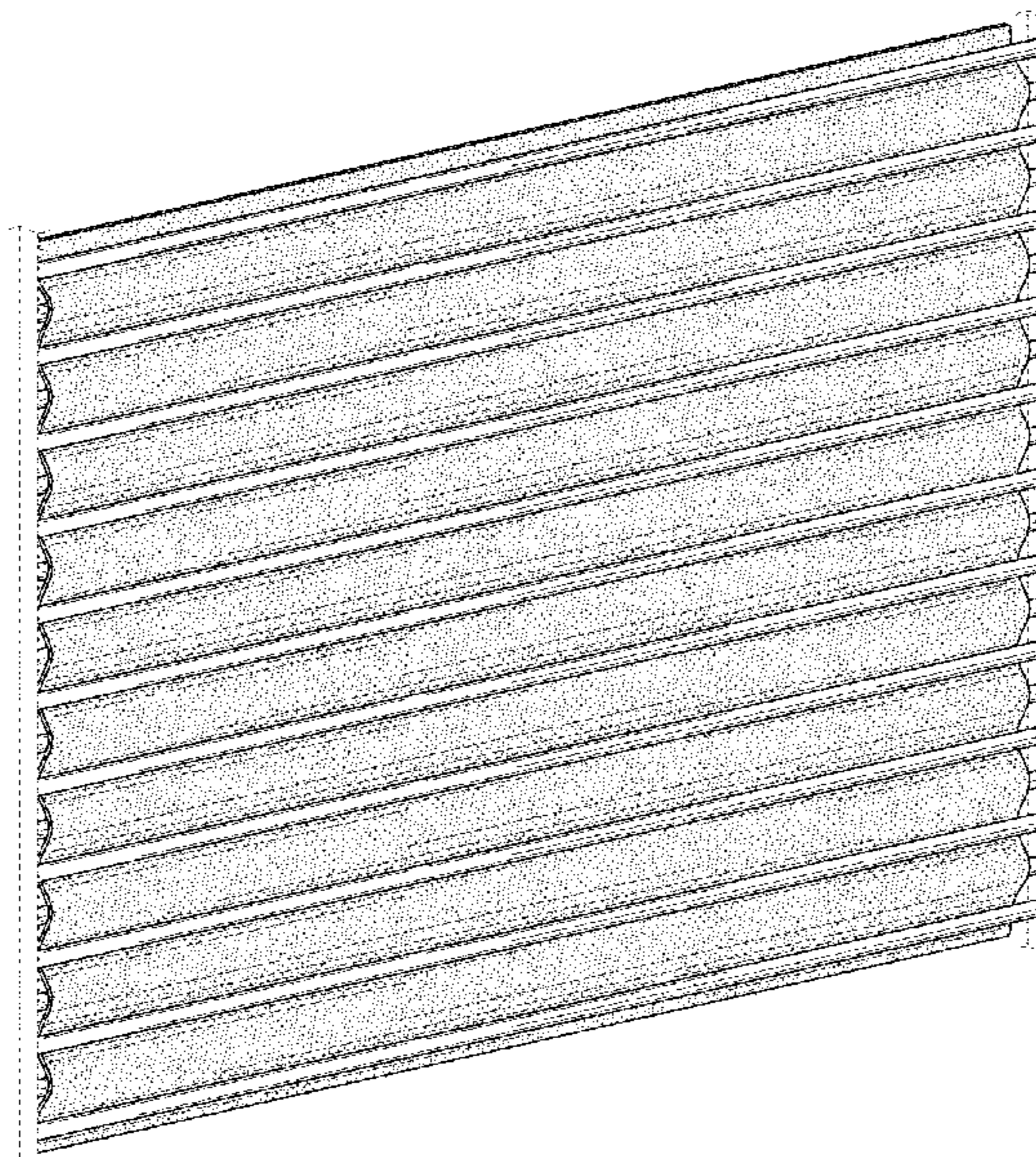
The ornamental design for a textile material with supporting rods, as shown and described.

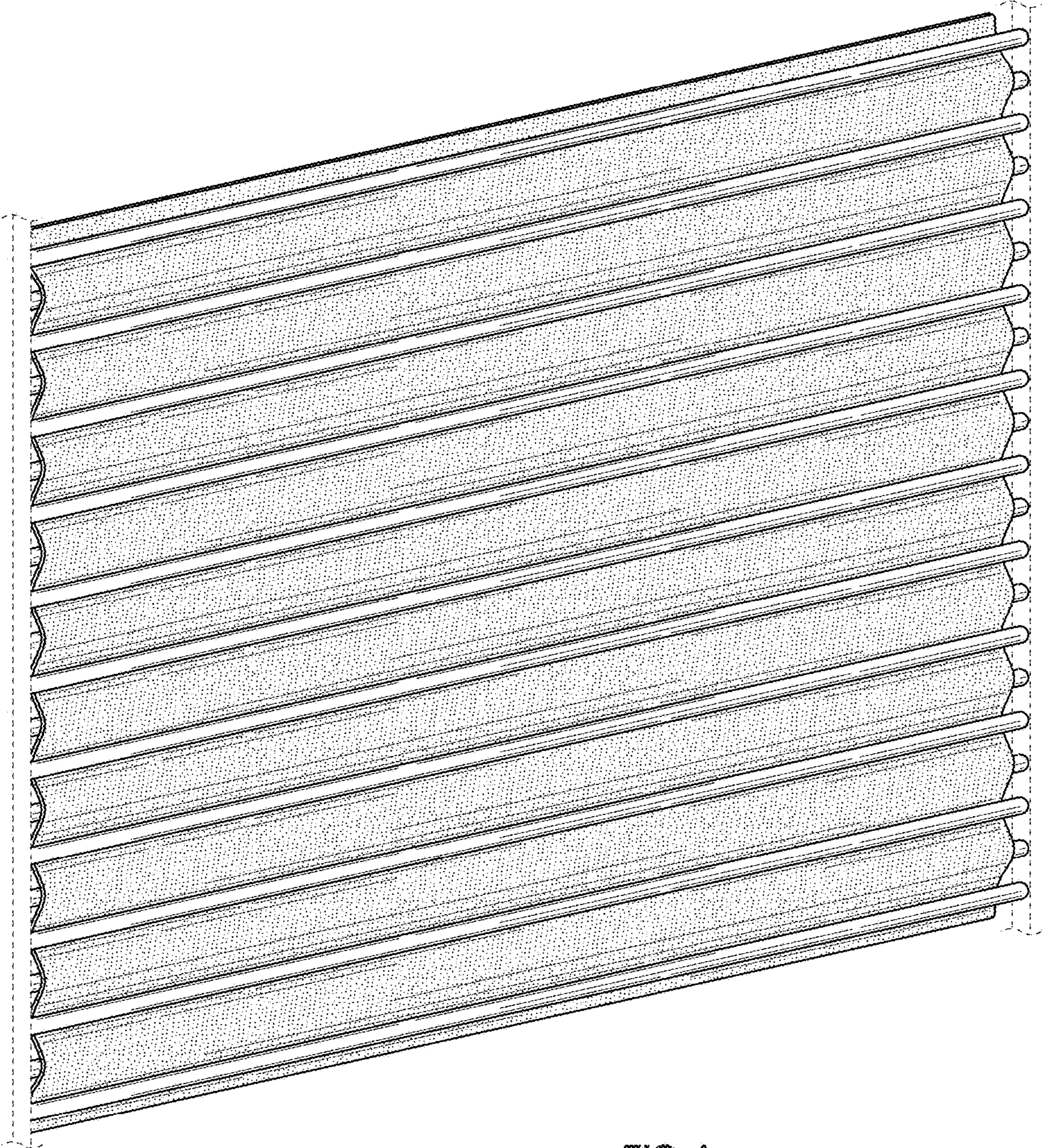

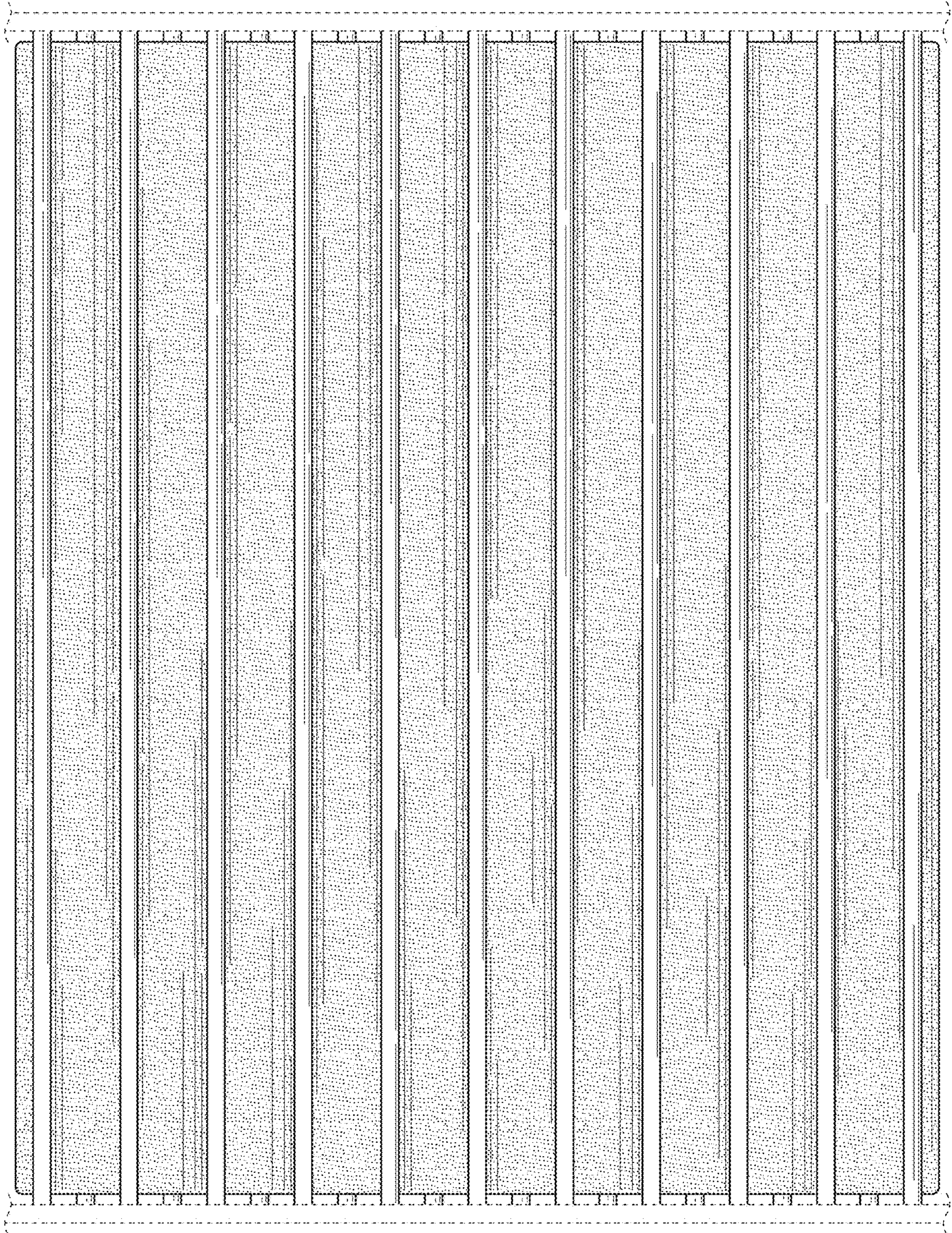

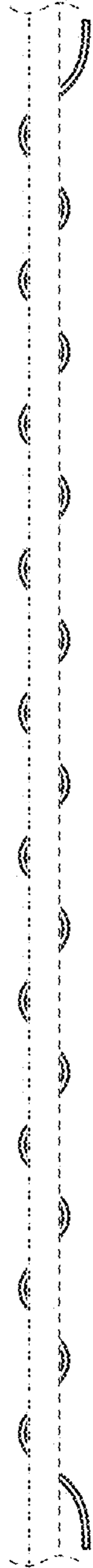

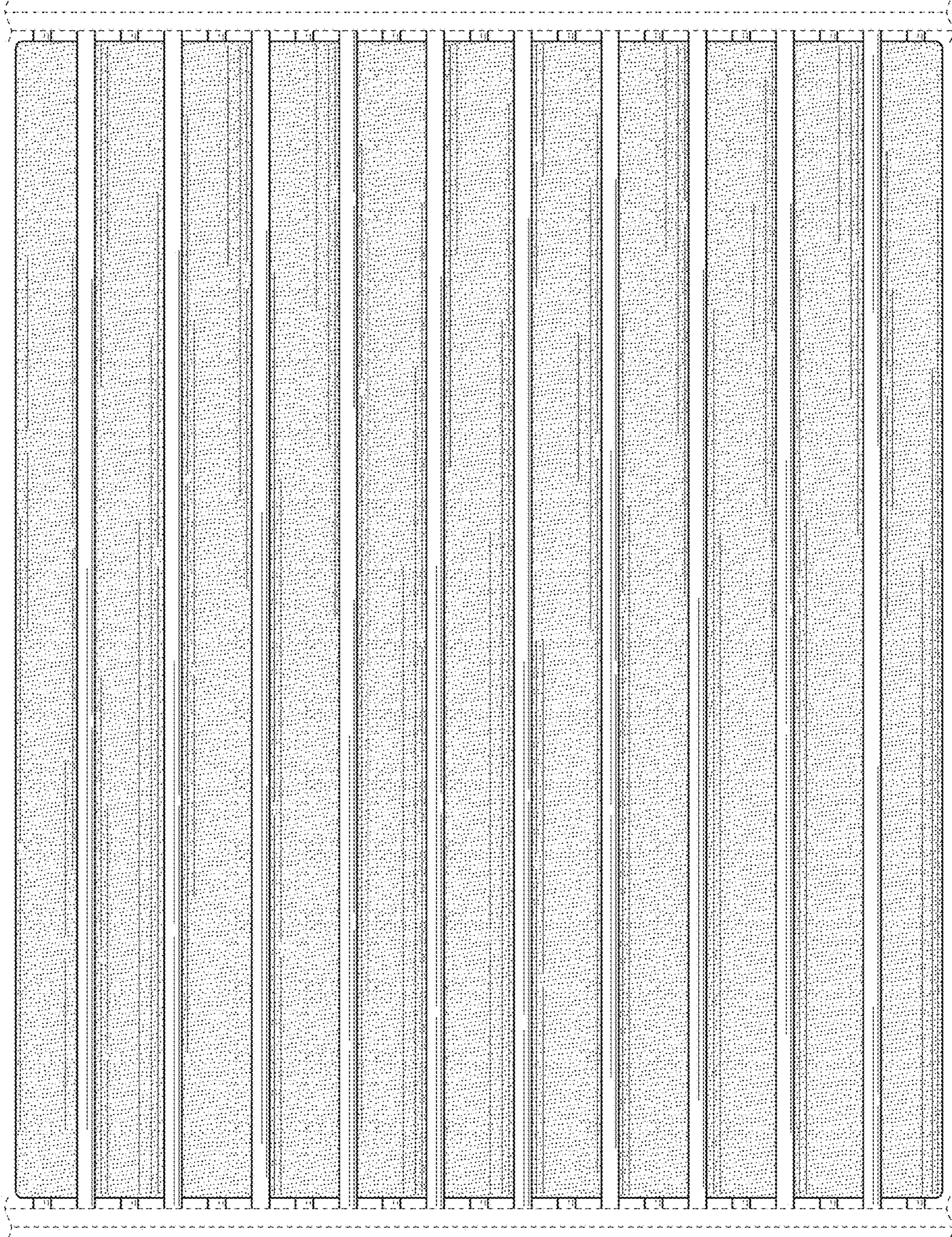
