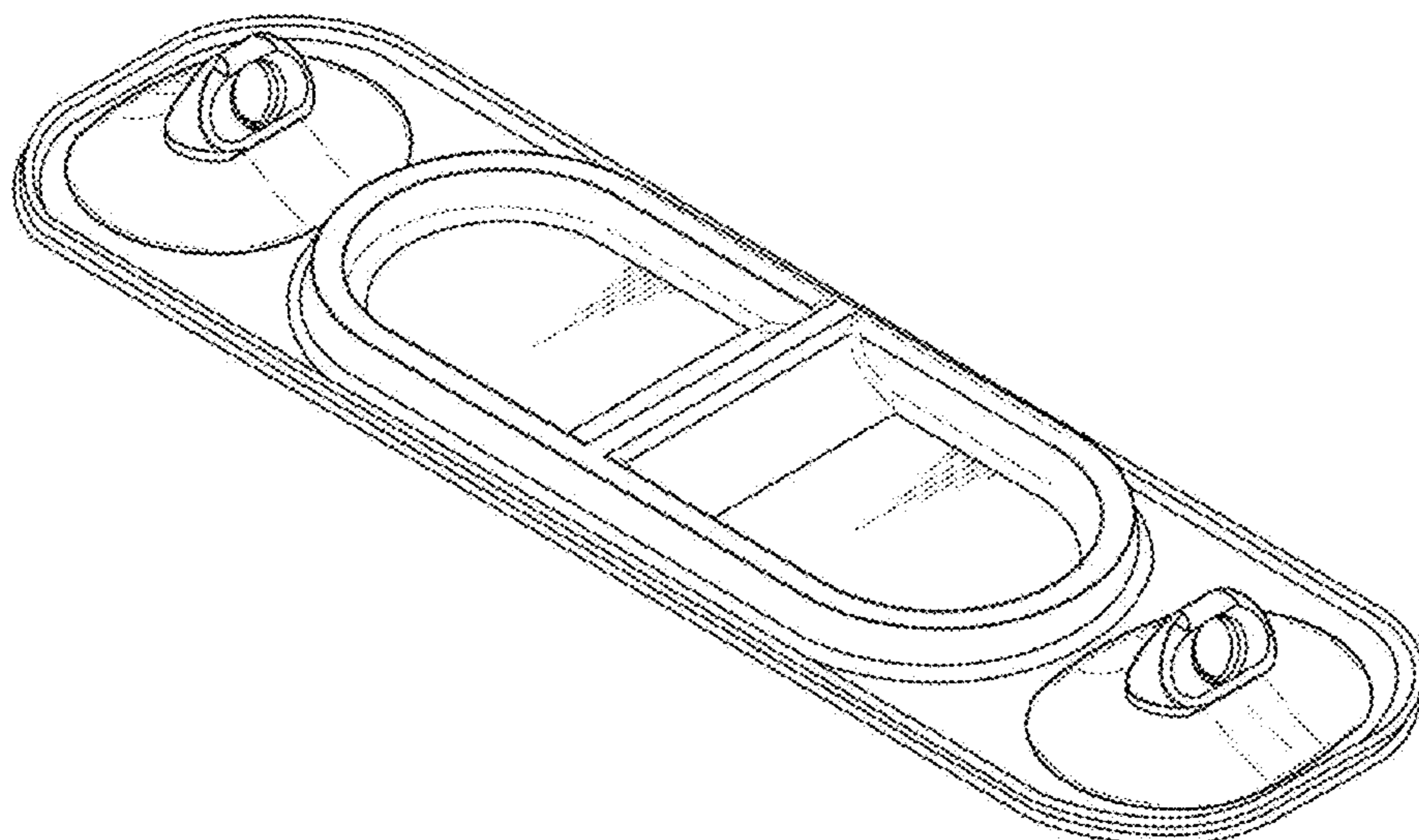
The ornamental design for a placemat, as shown and described.

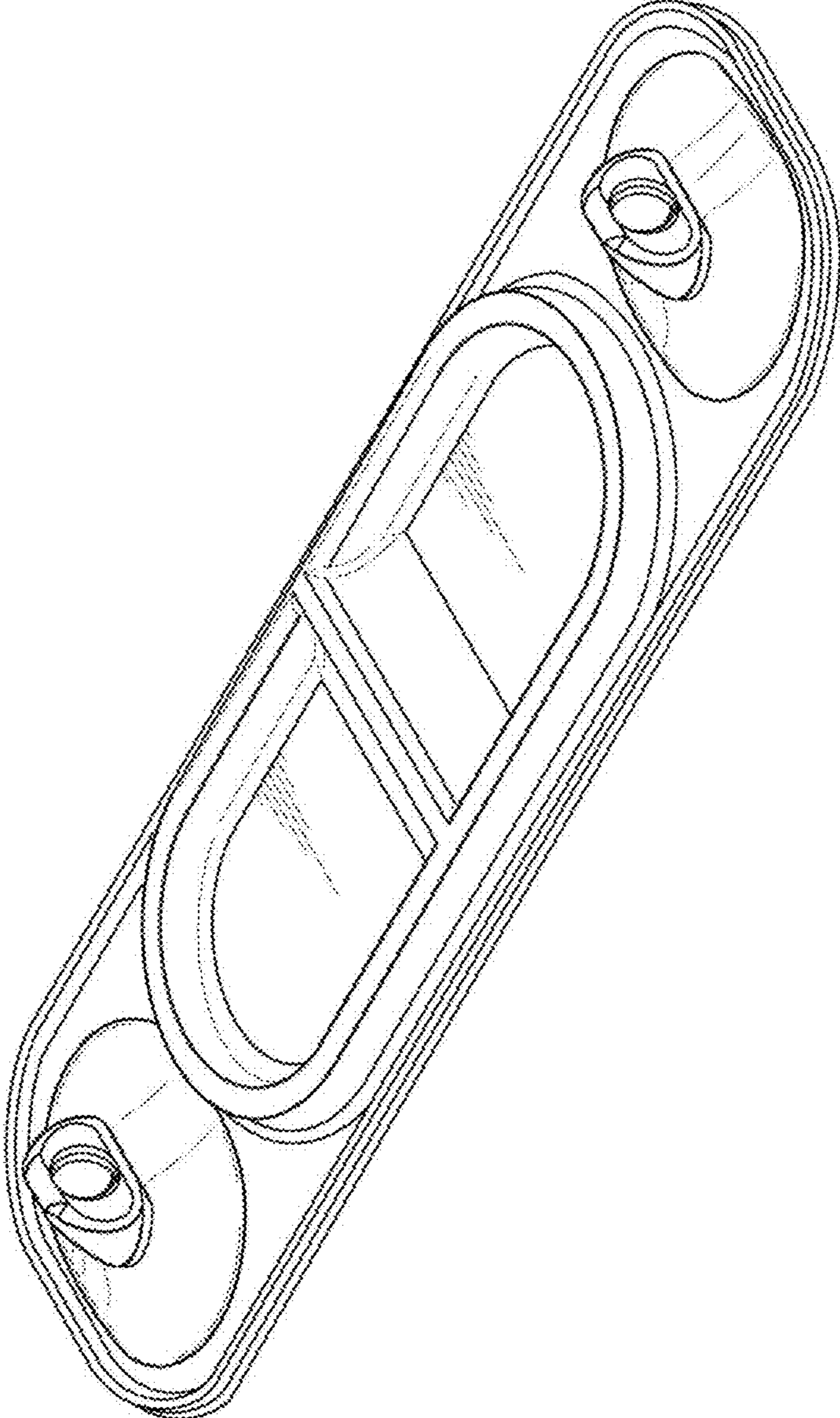

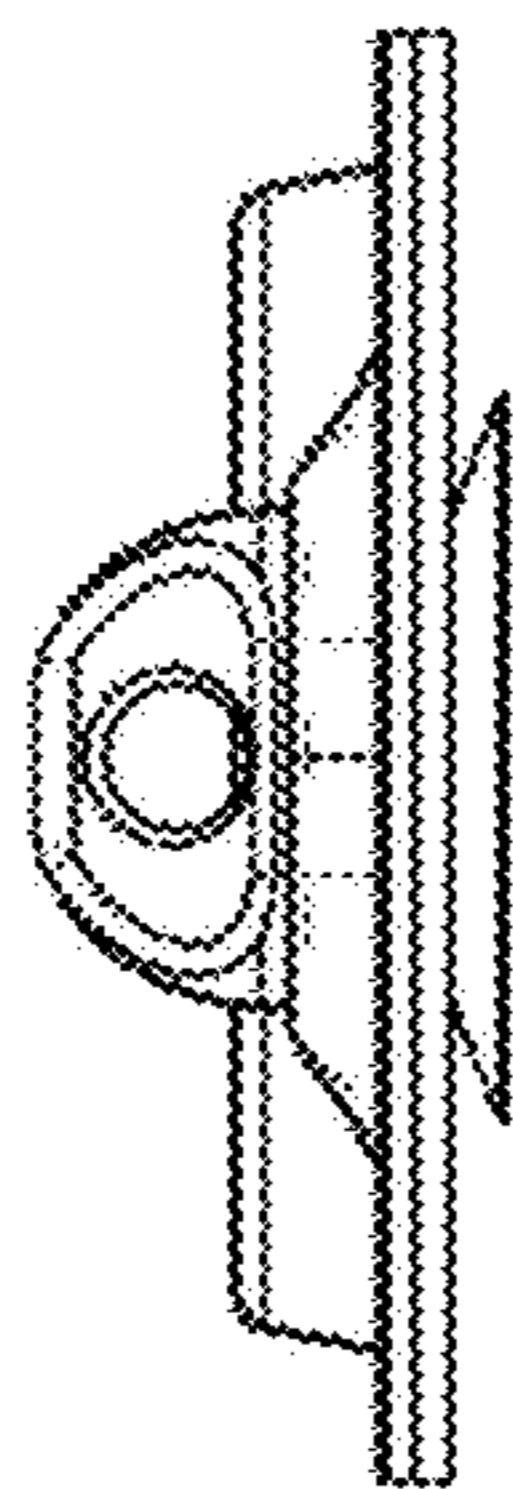

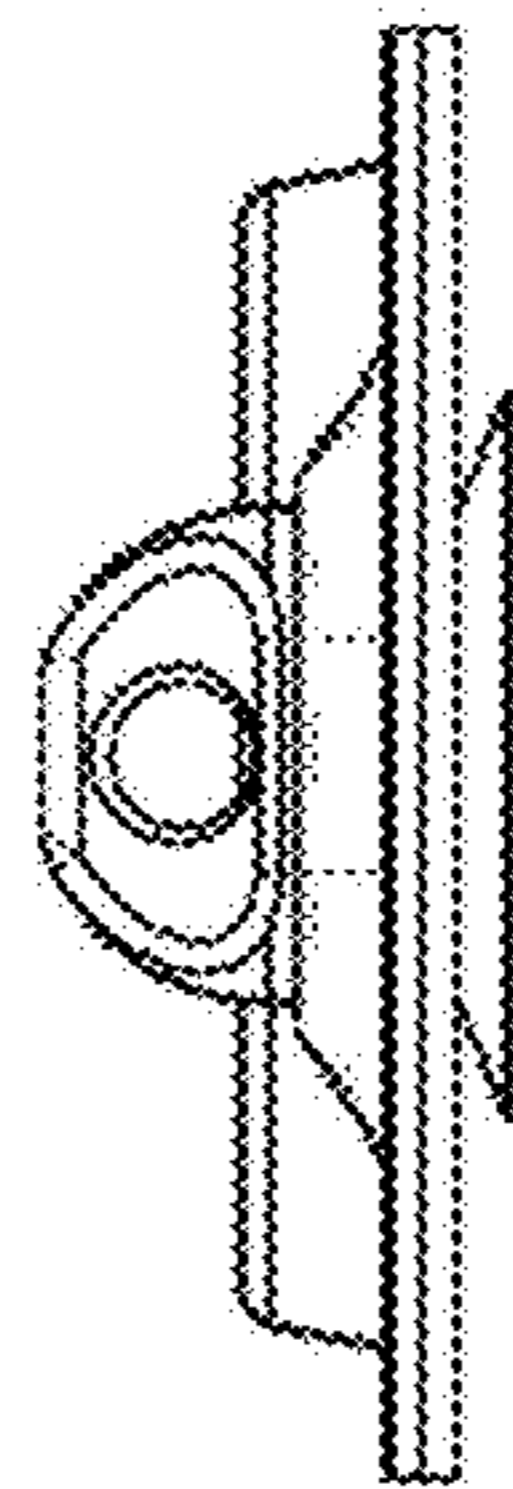

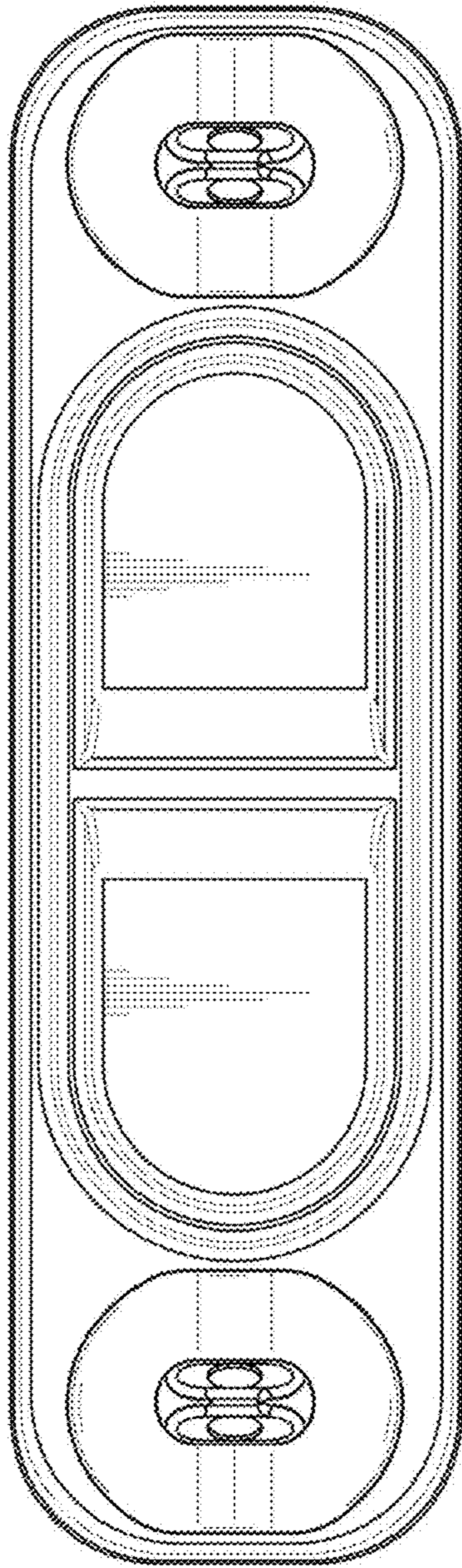

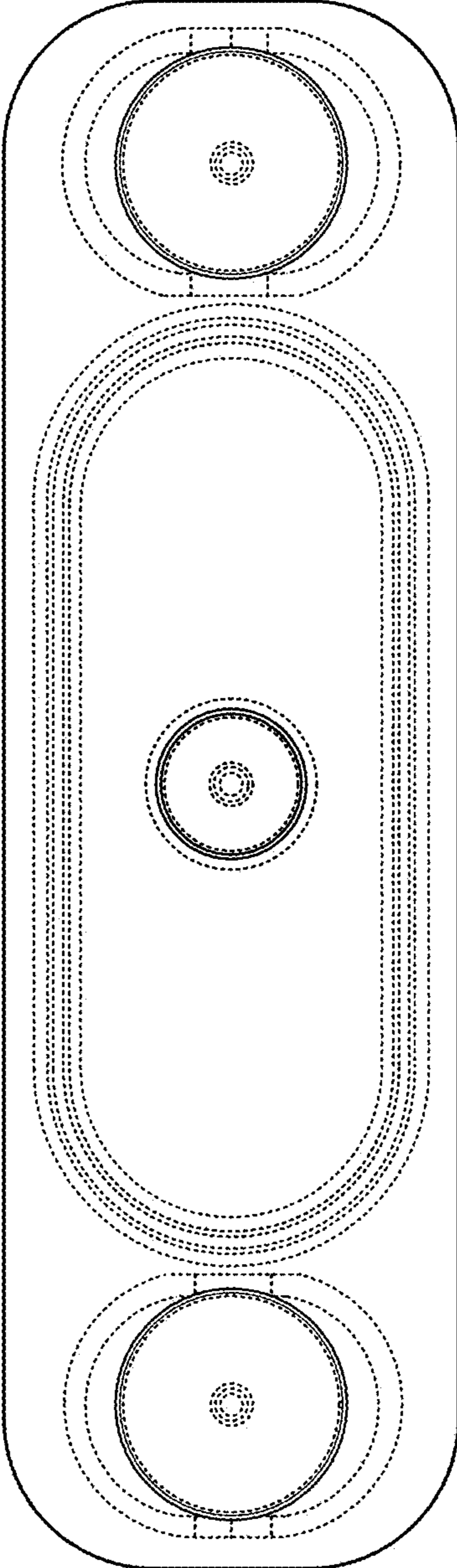
