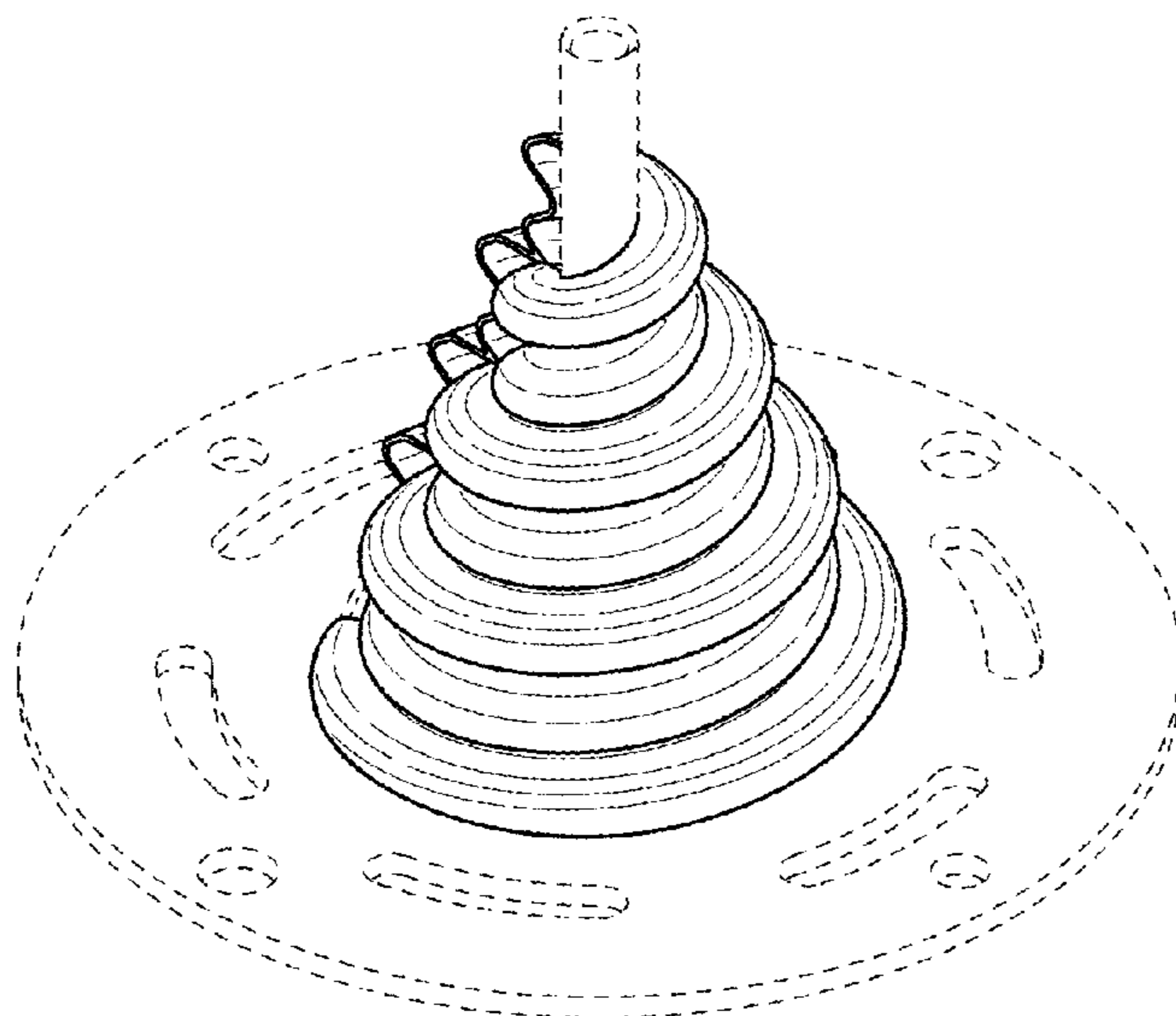
(57) **CLAIM**

The ornamental design for a cutter head for cutting food products, as shown and described.

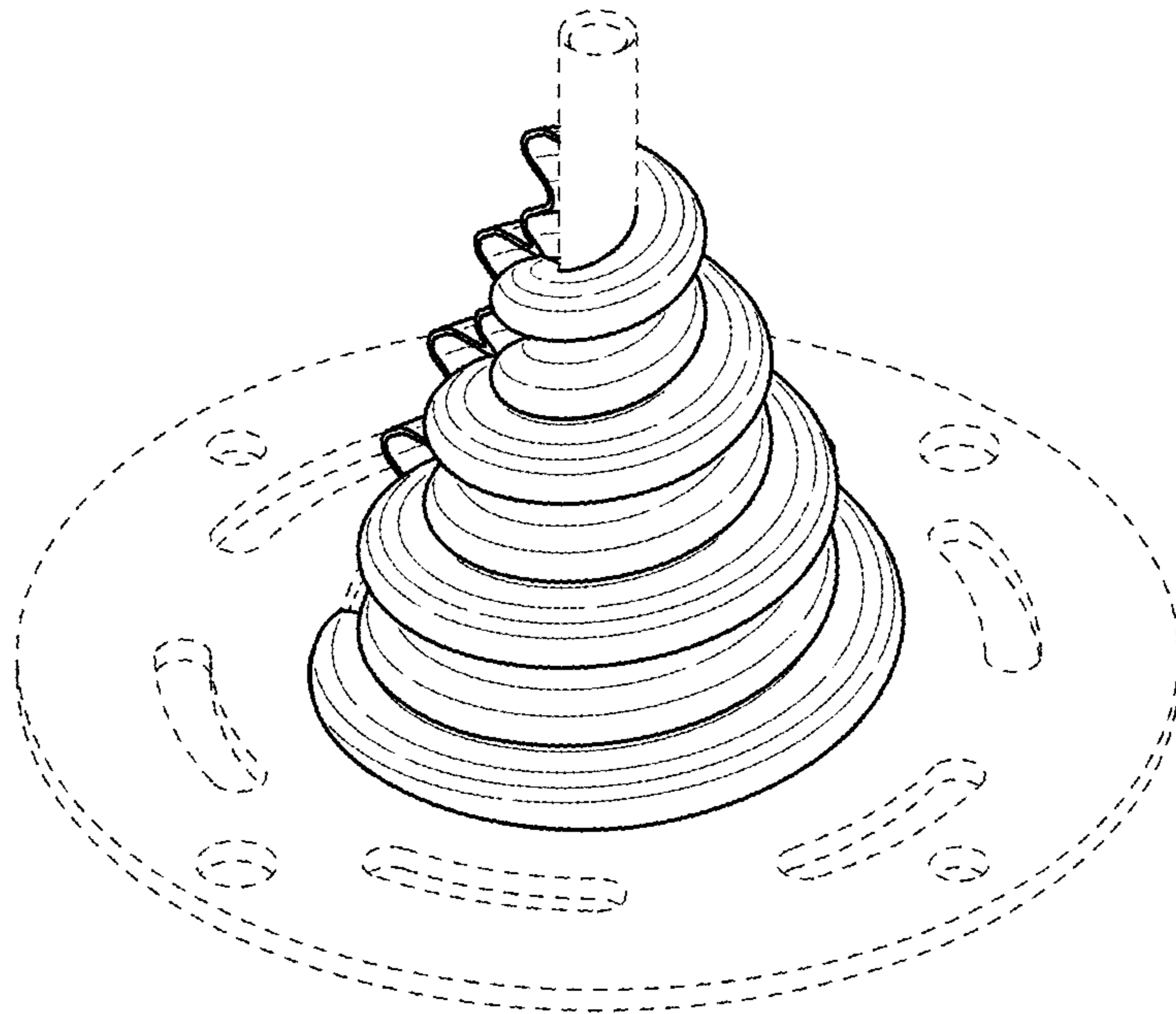

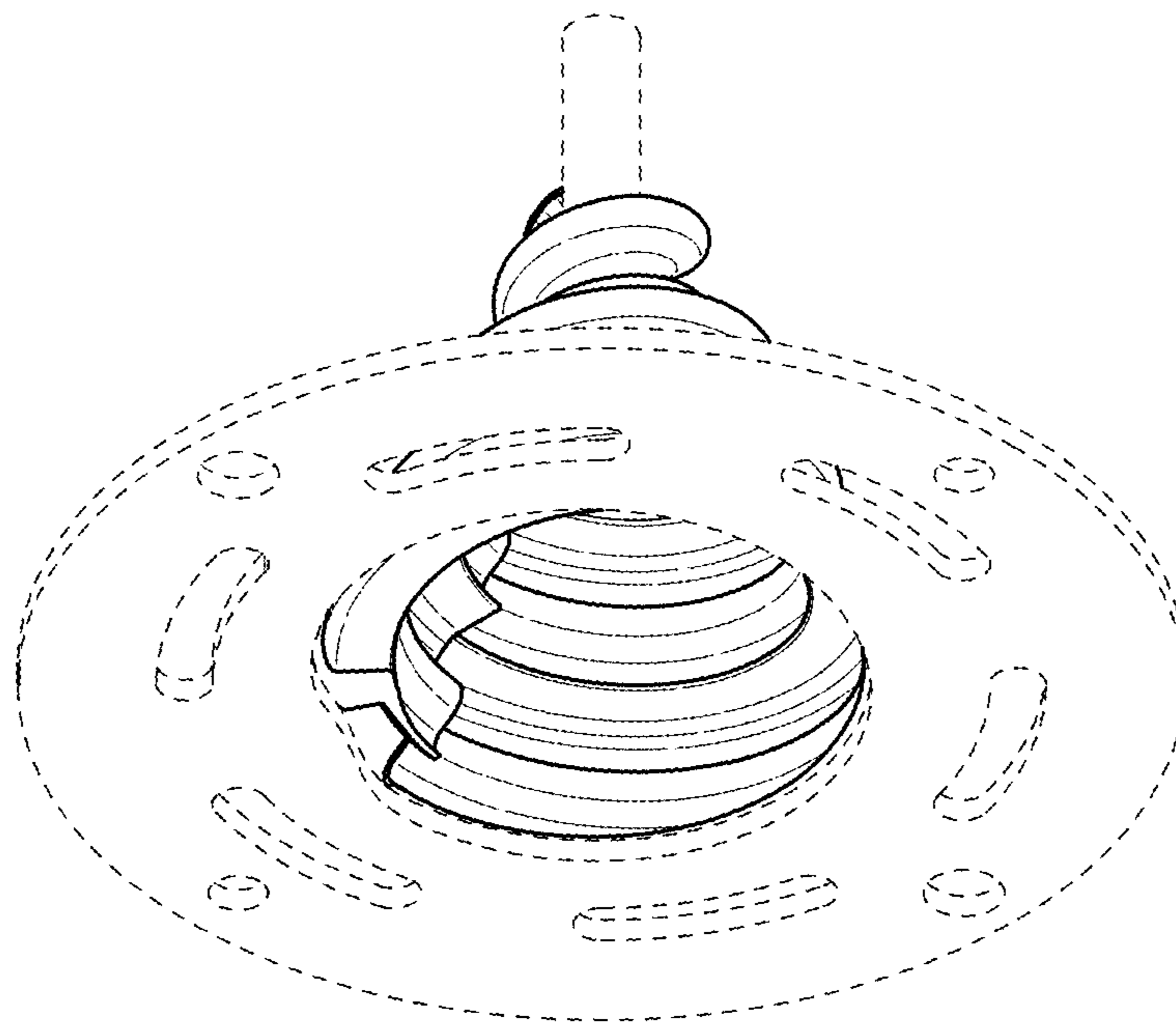

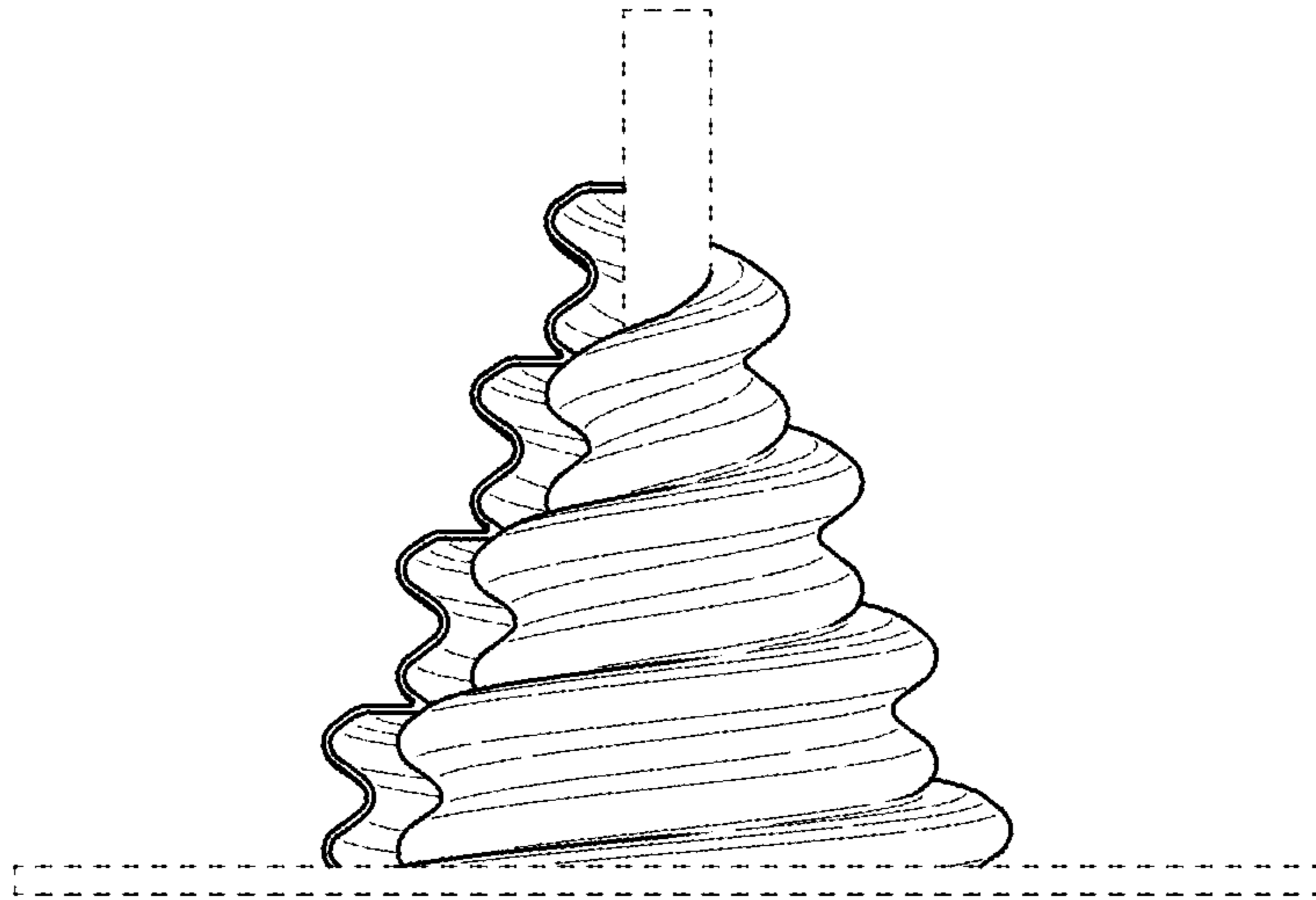

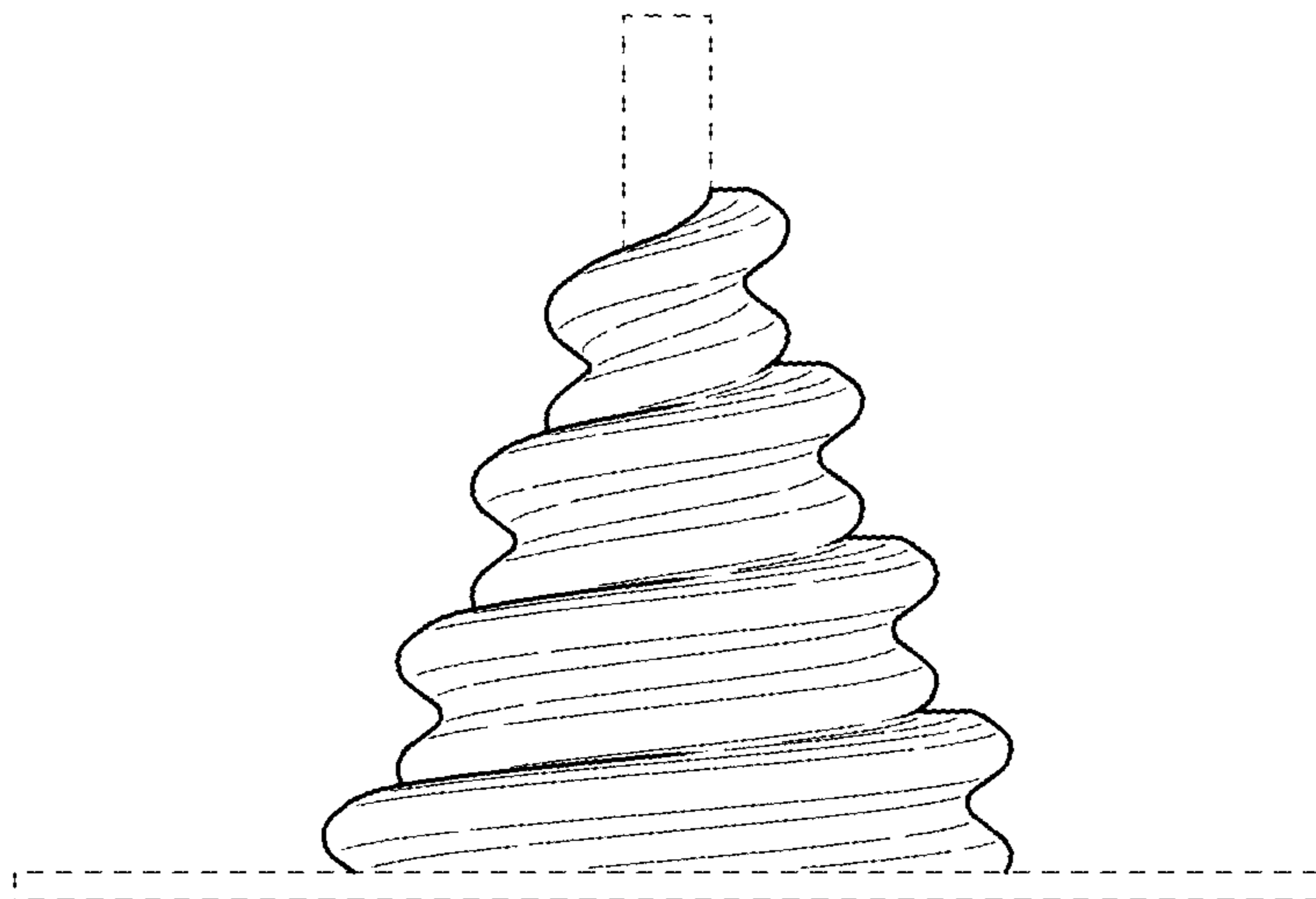

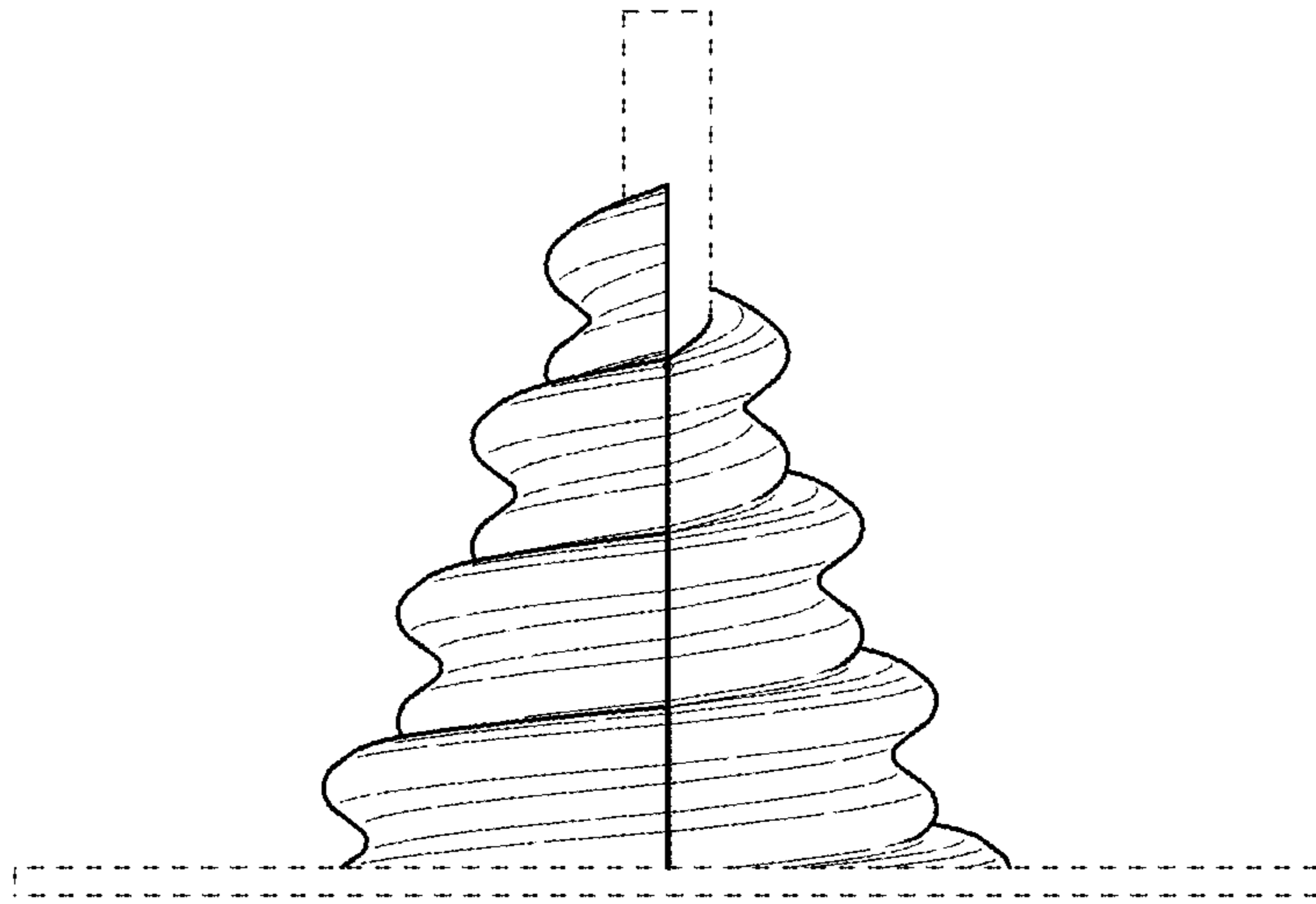

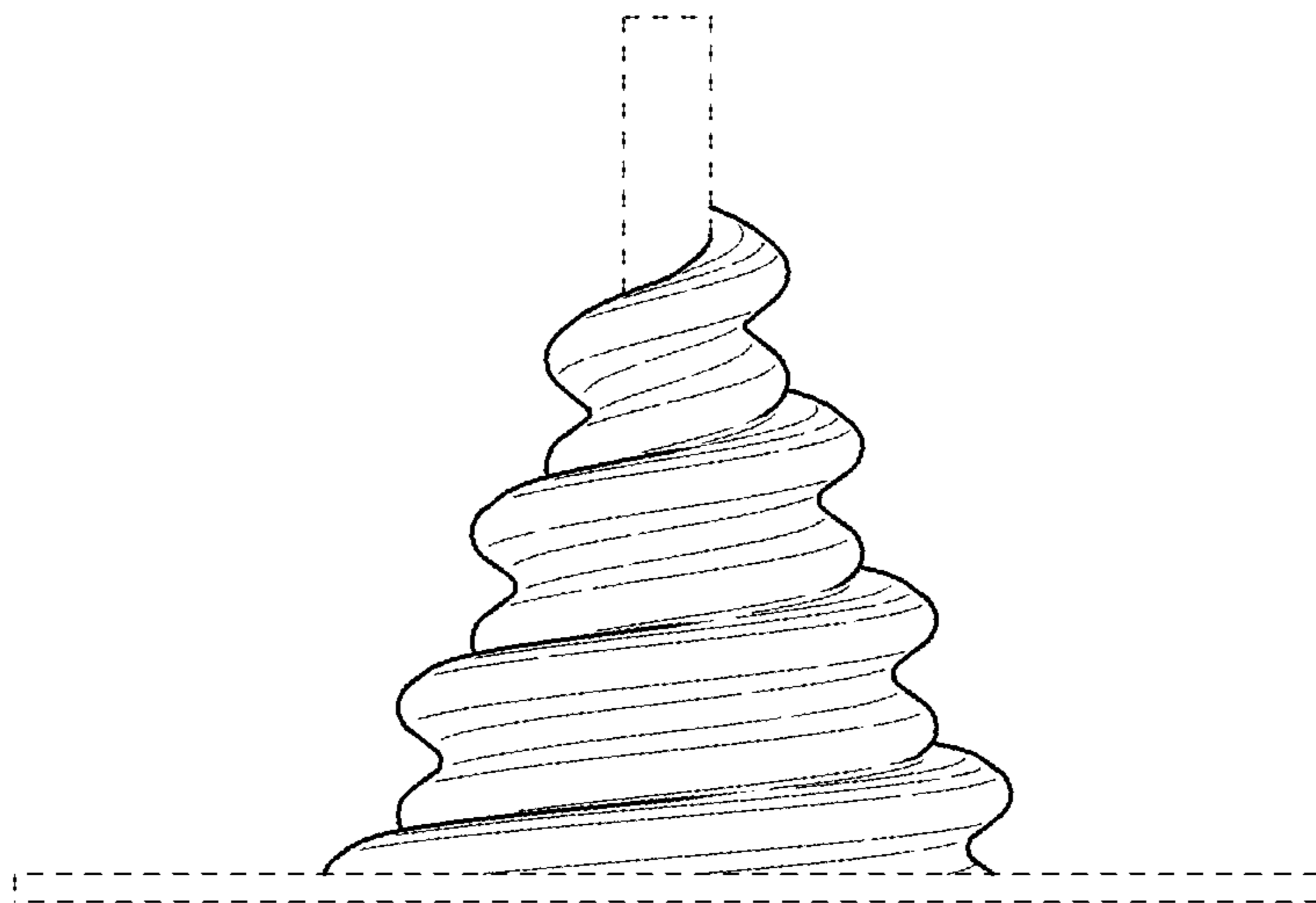

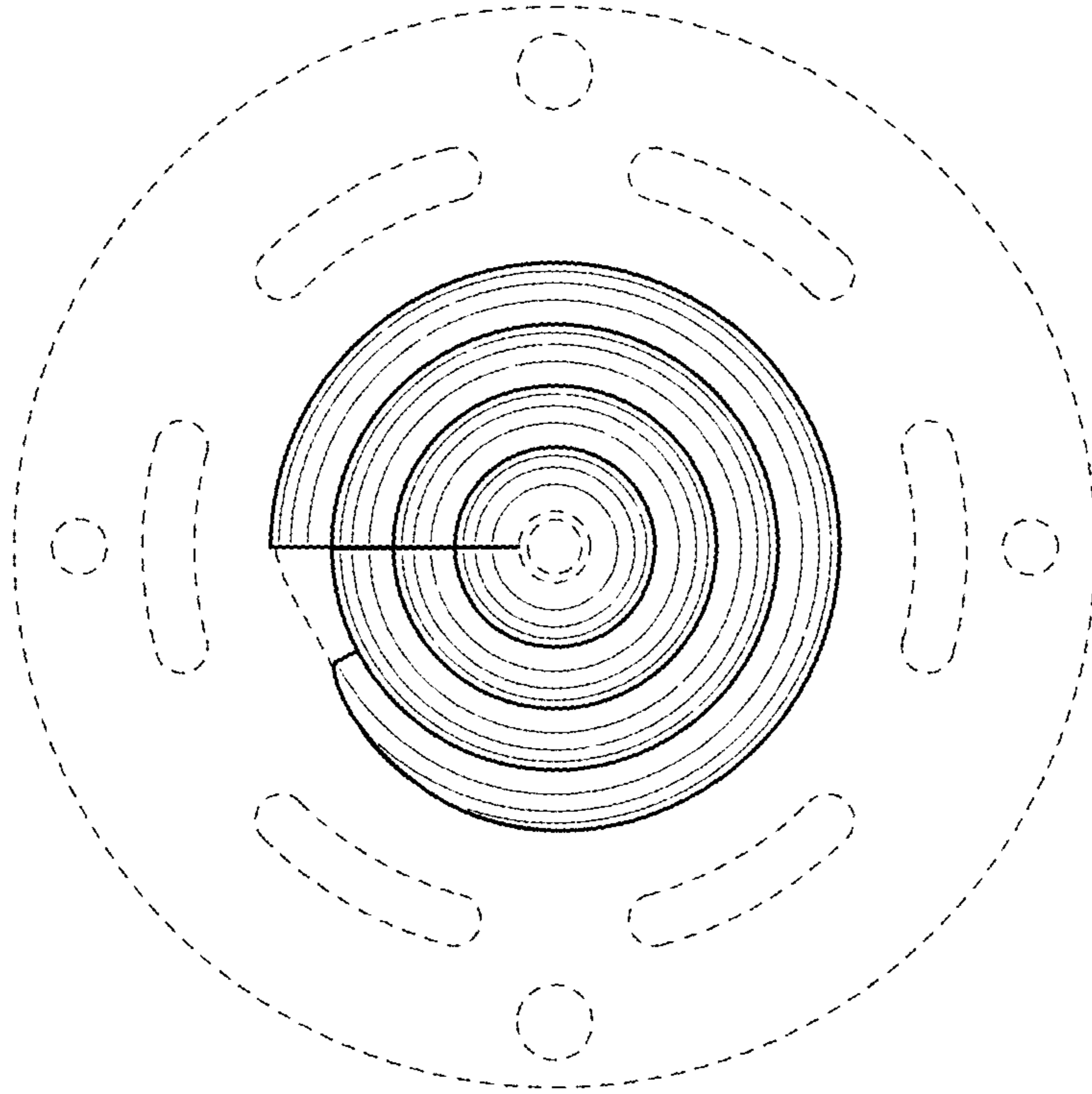

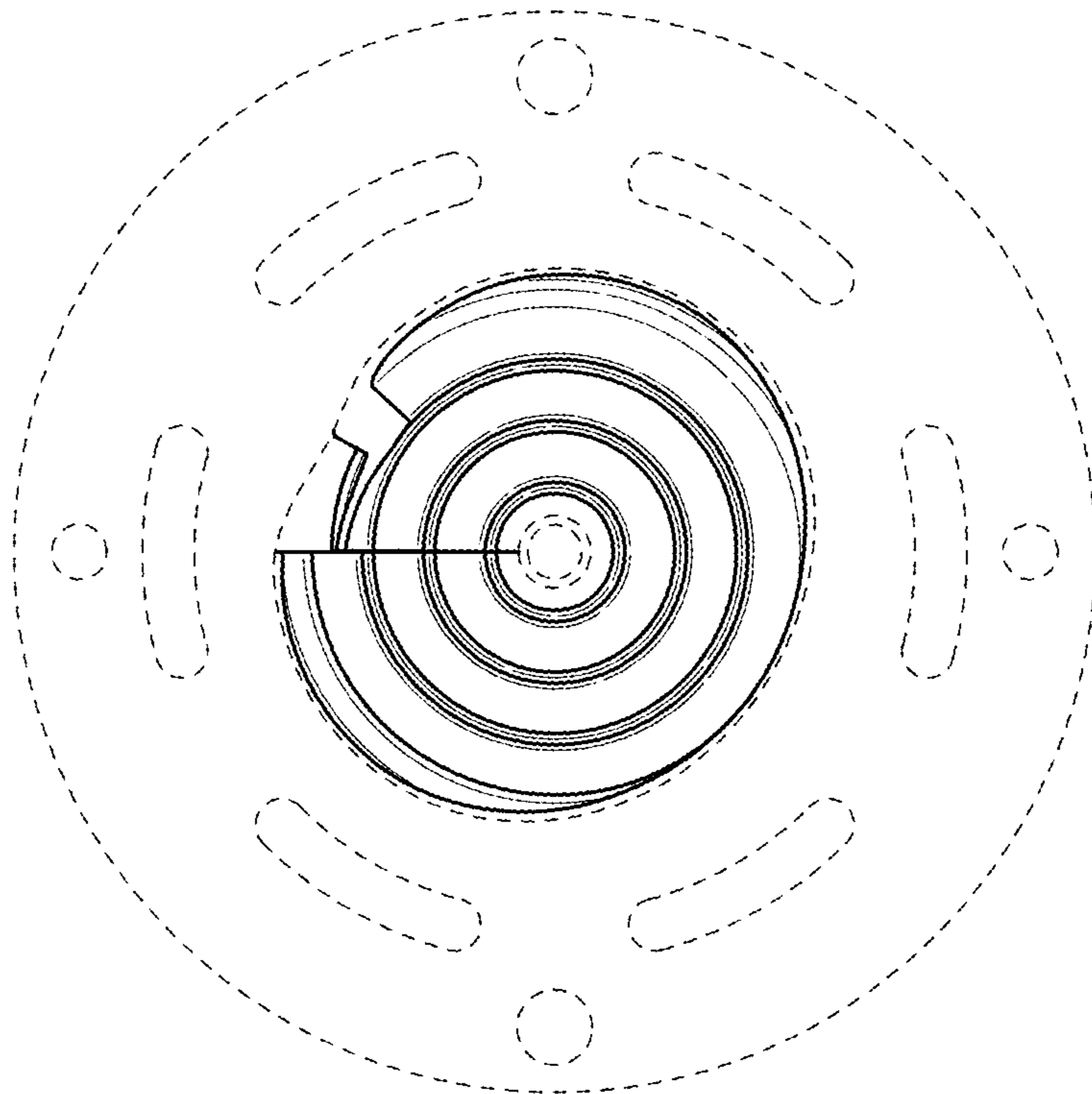

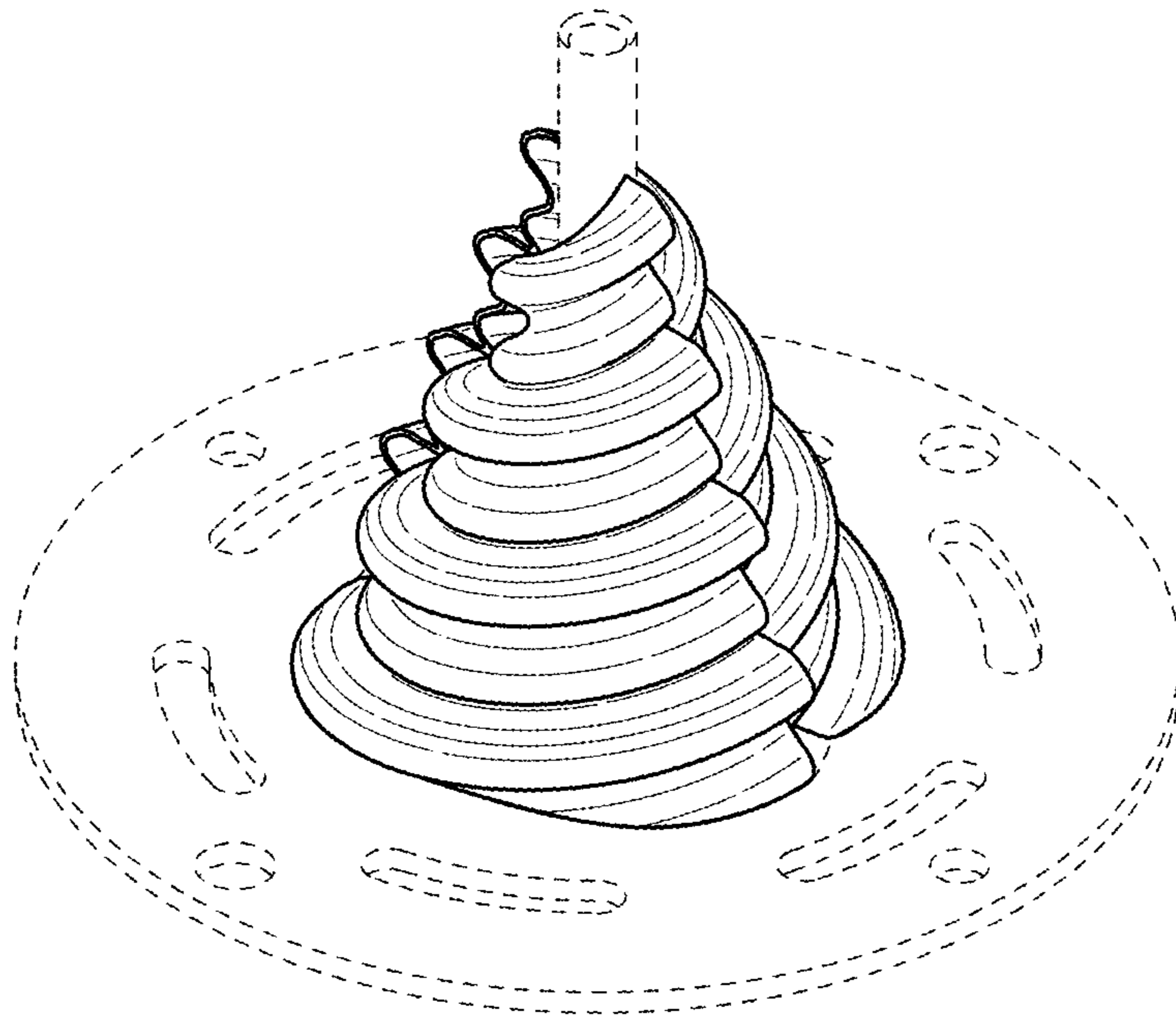

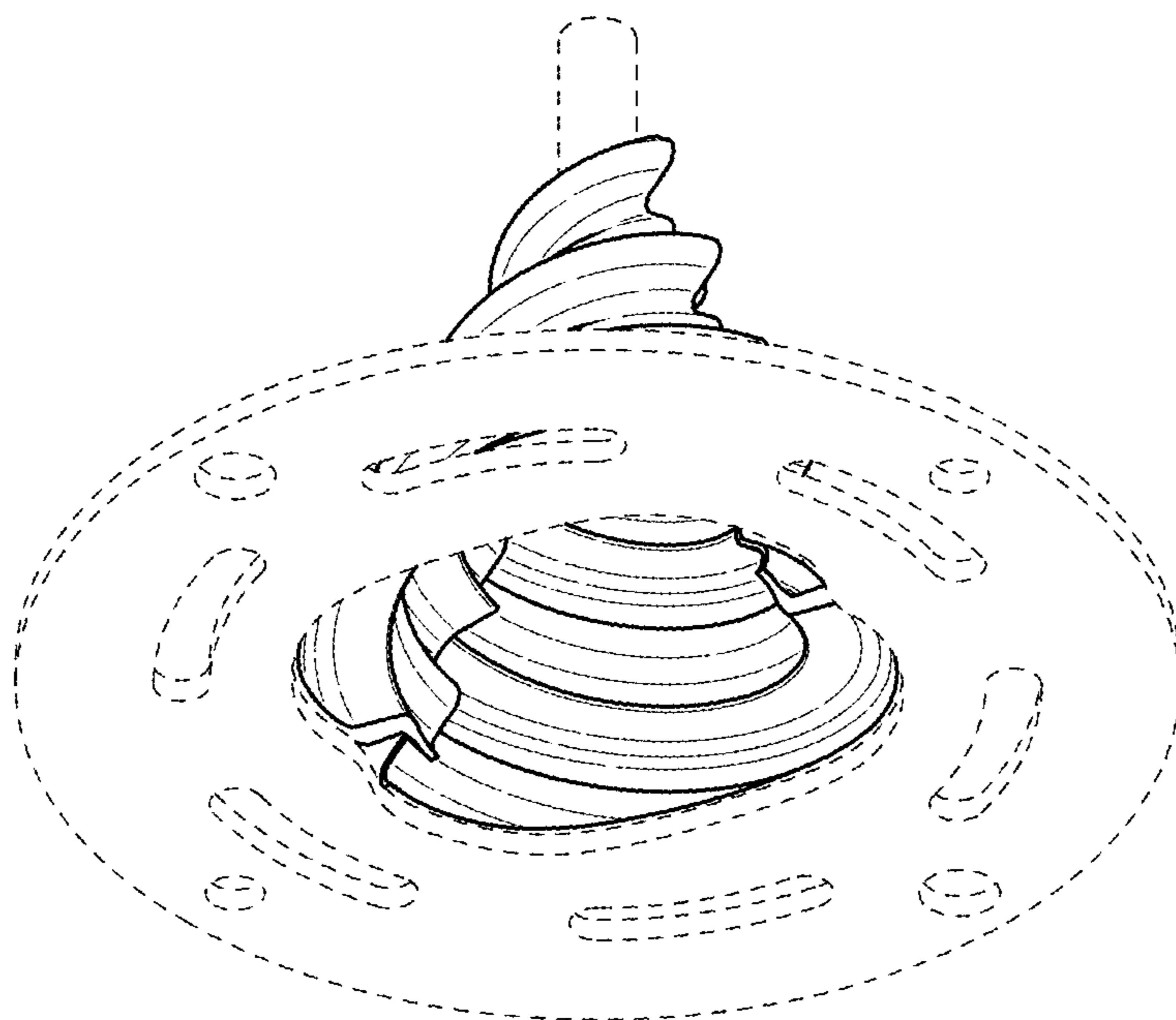

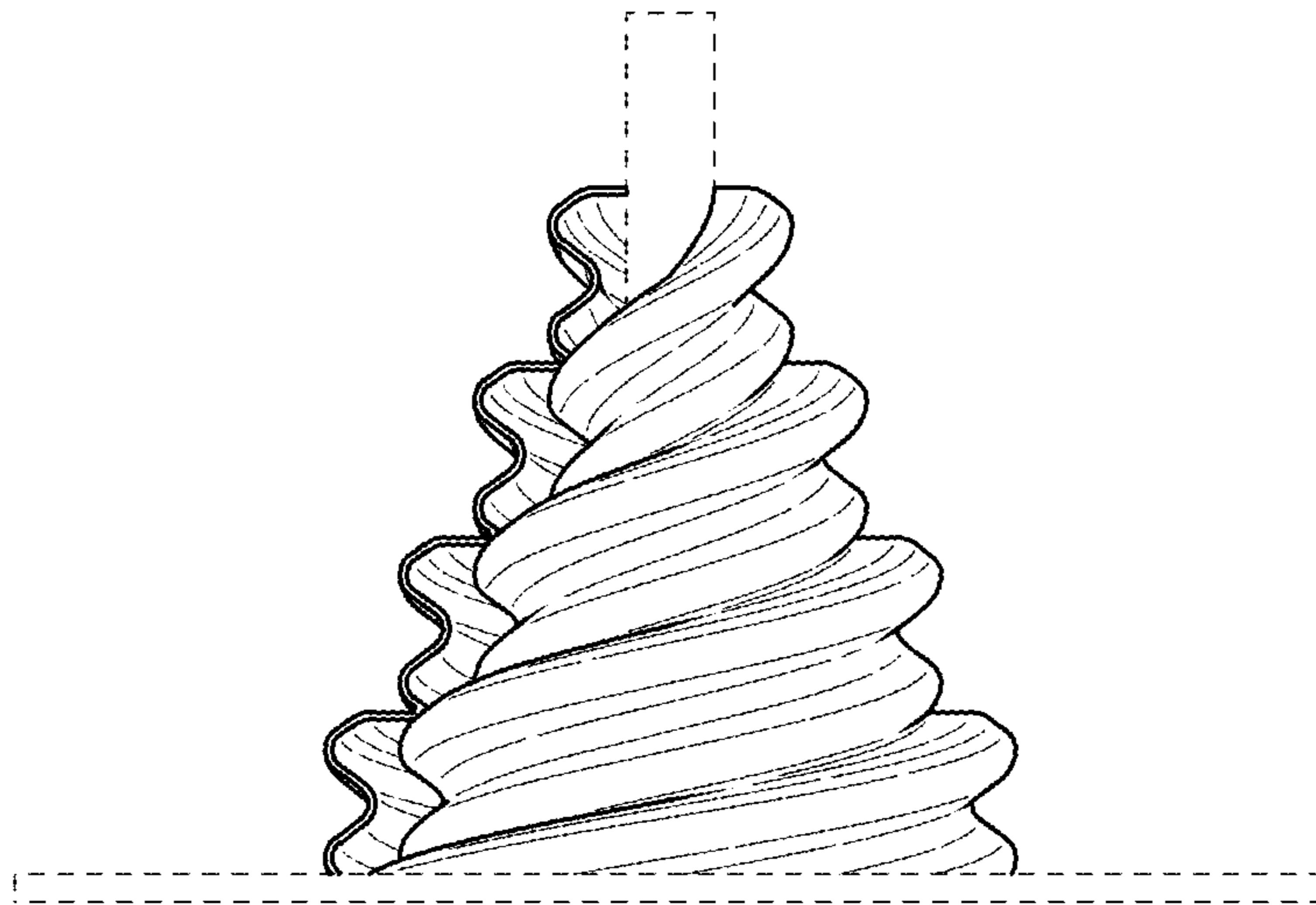

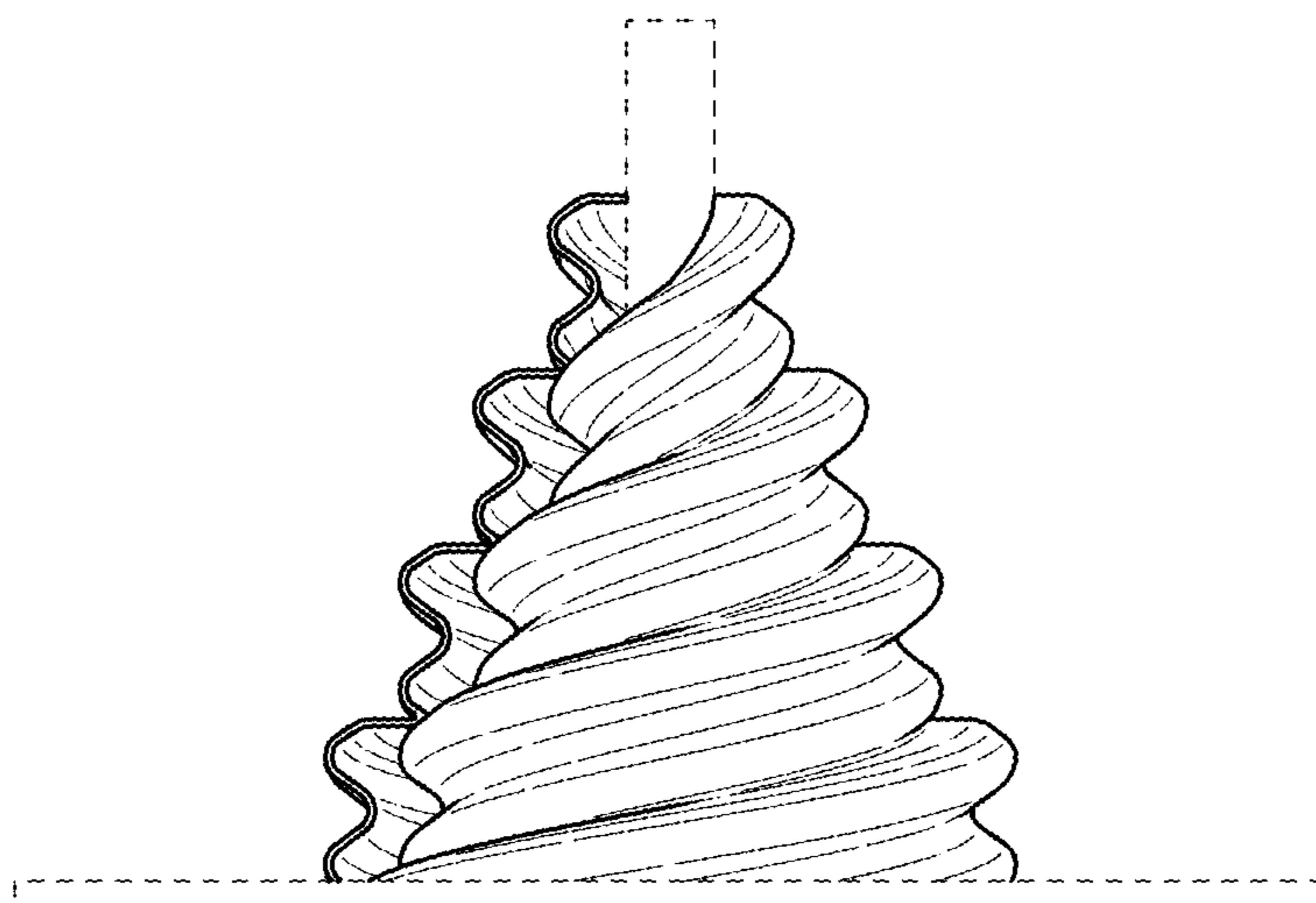

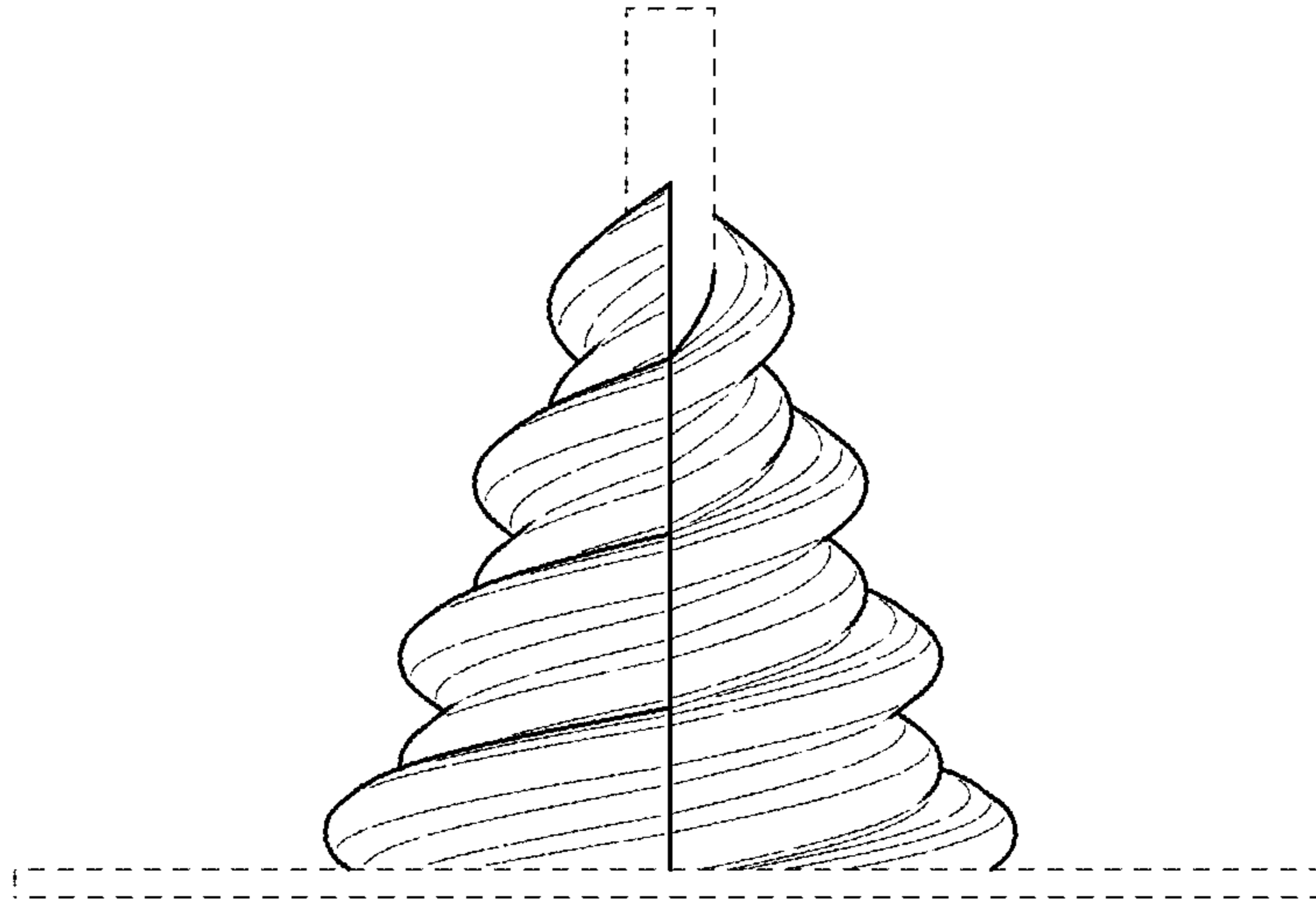

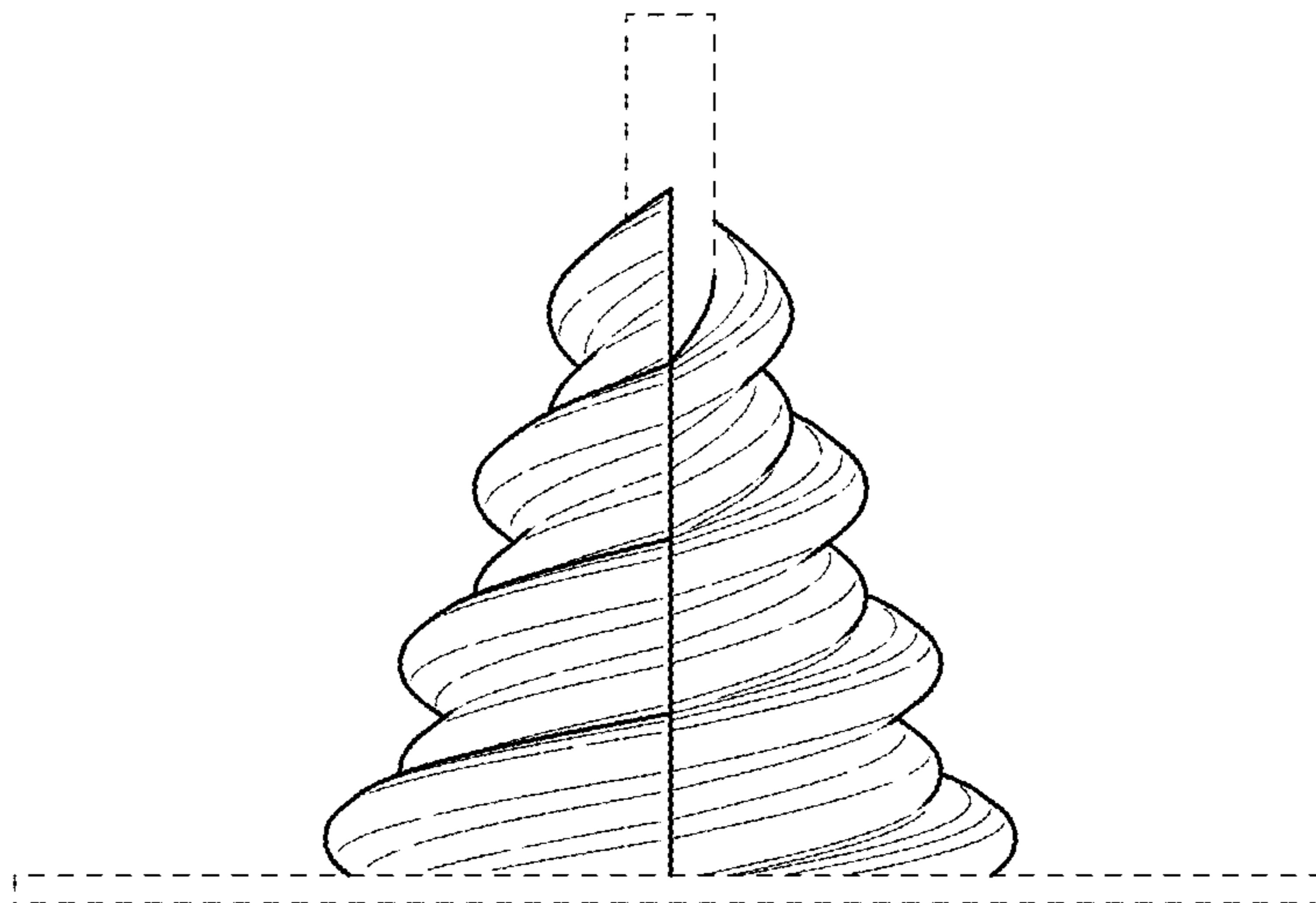

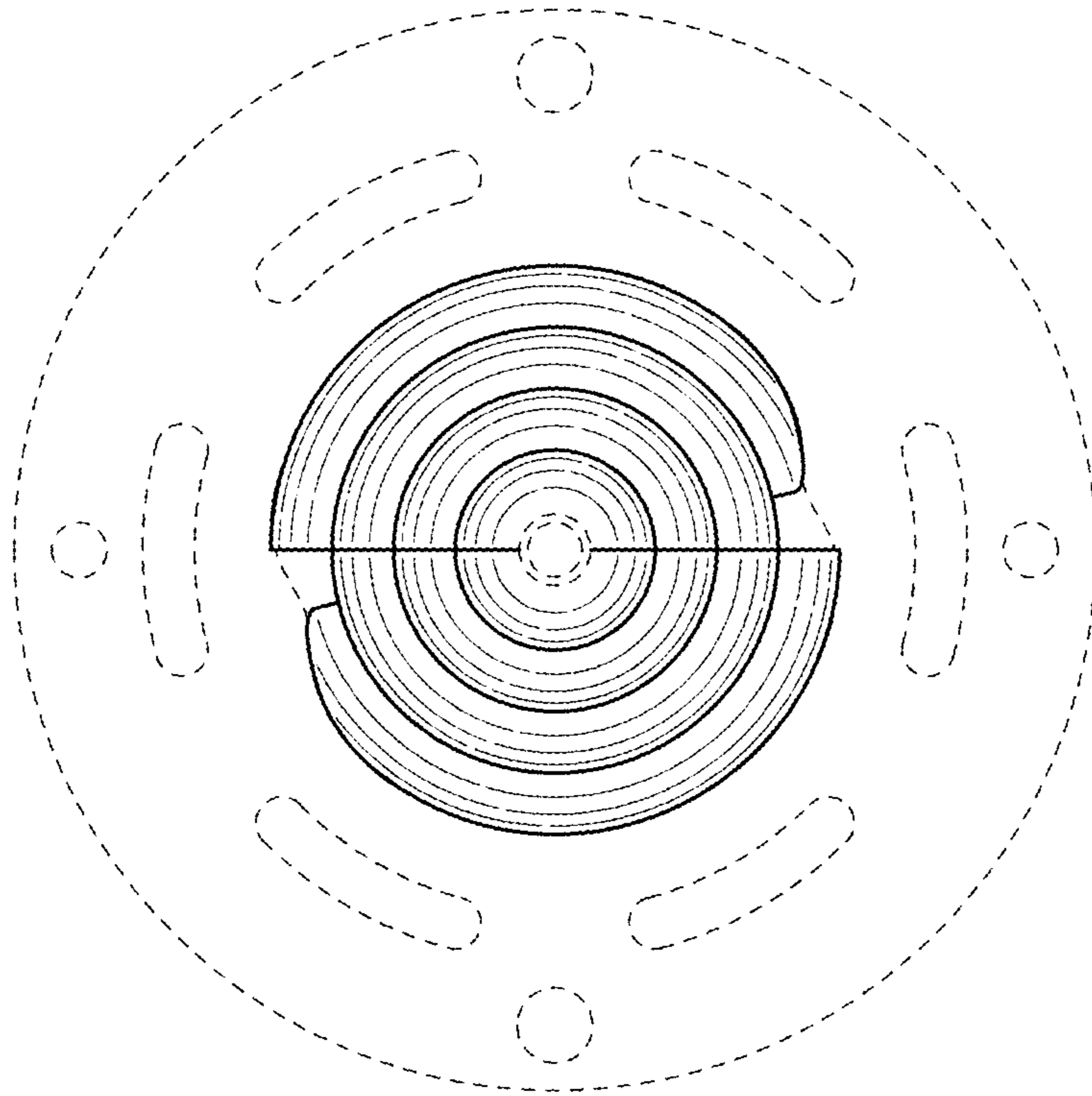

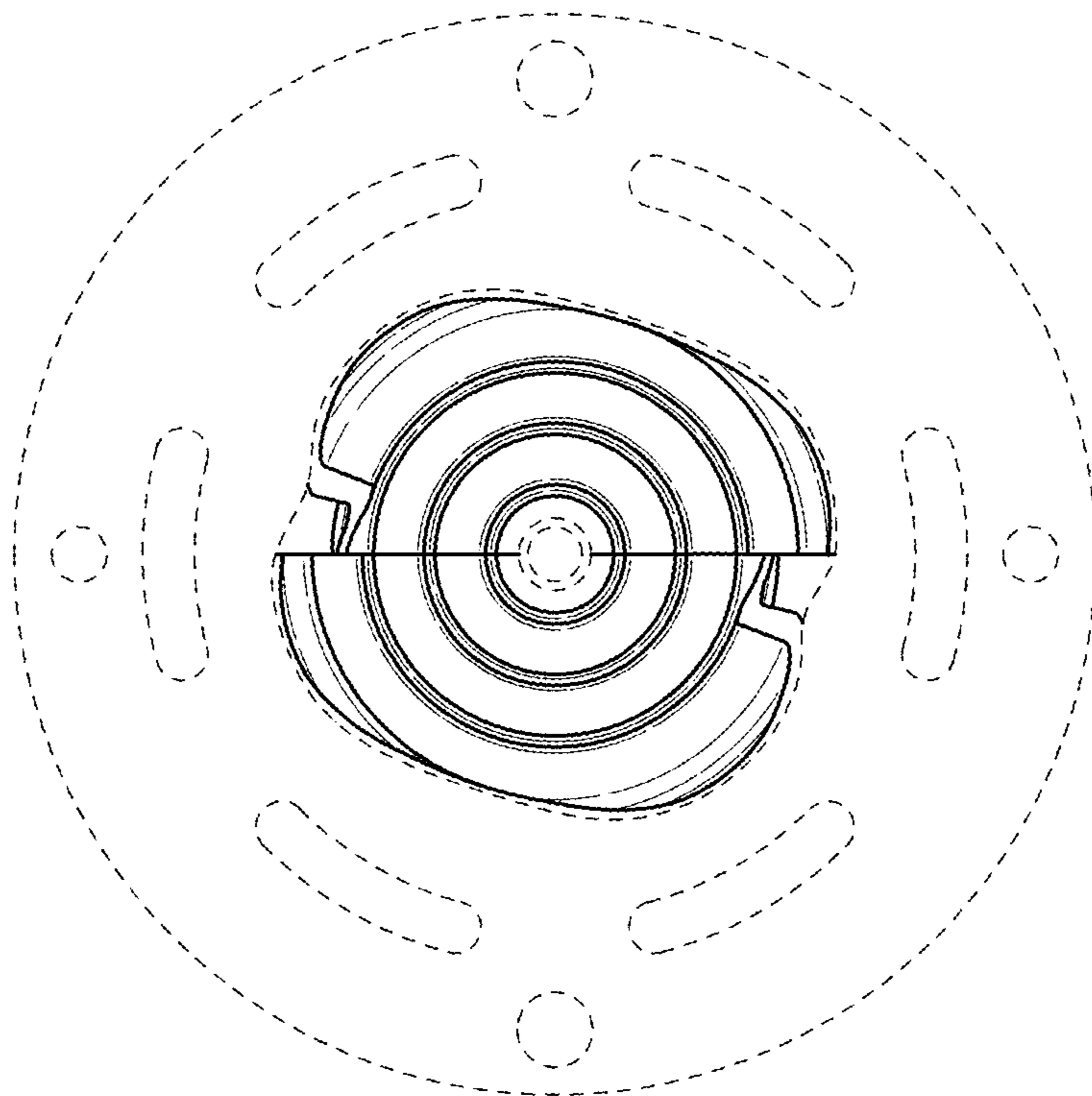

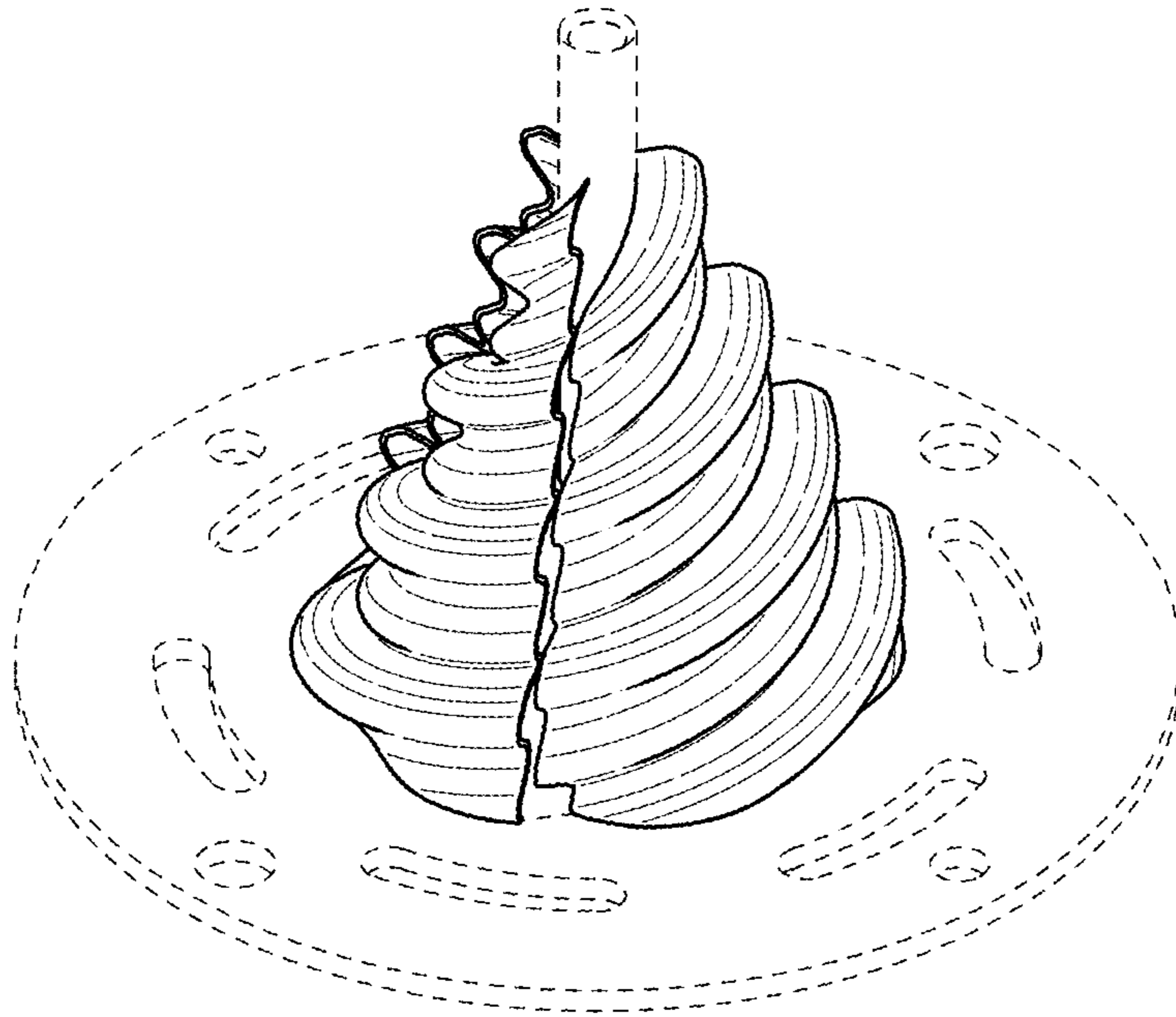

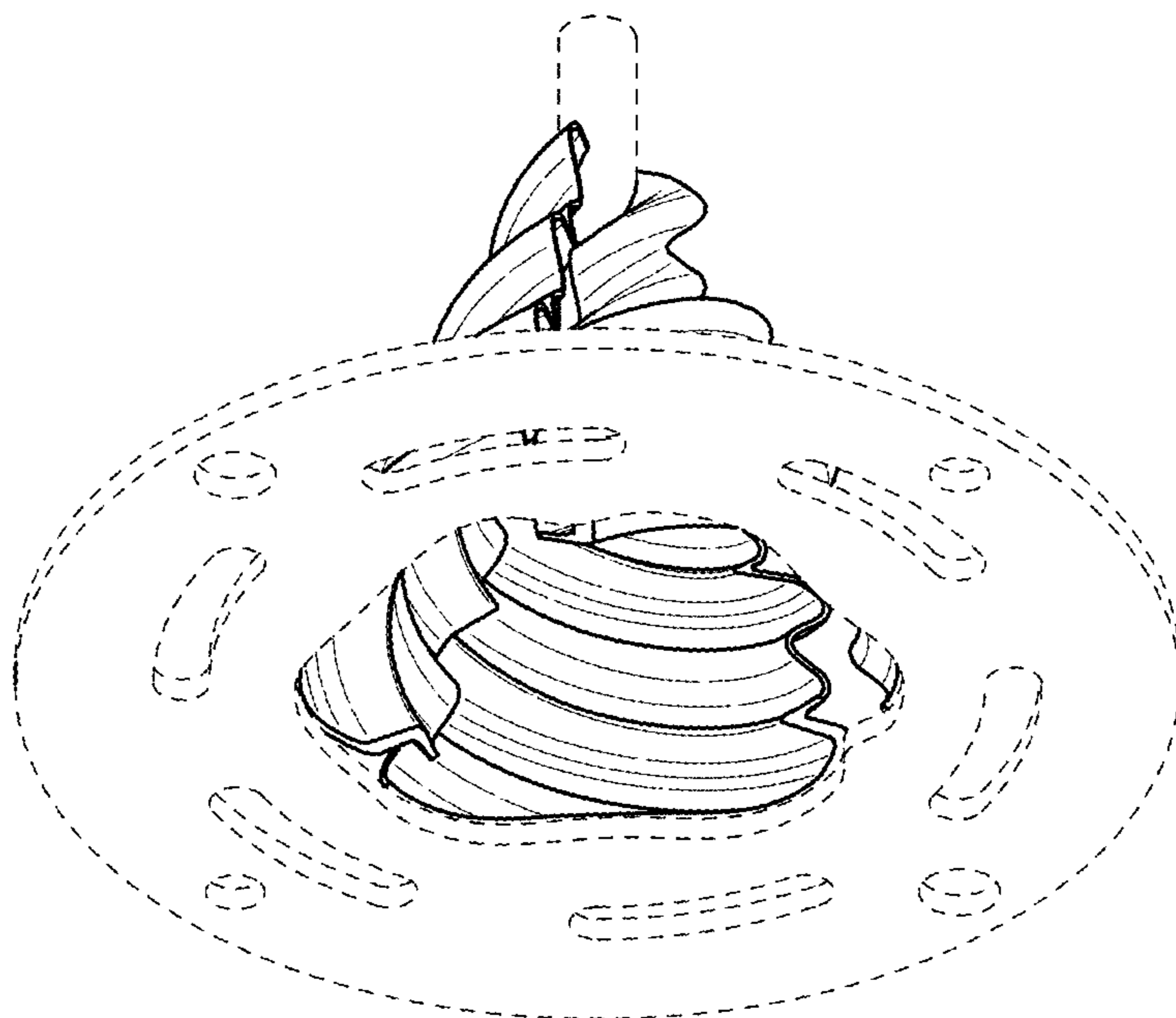

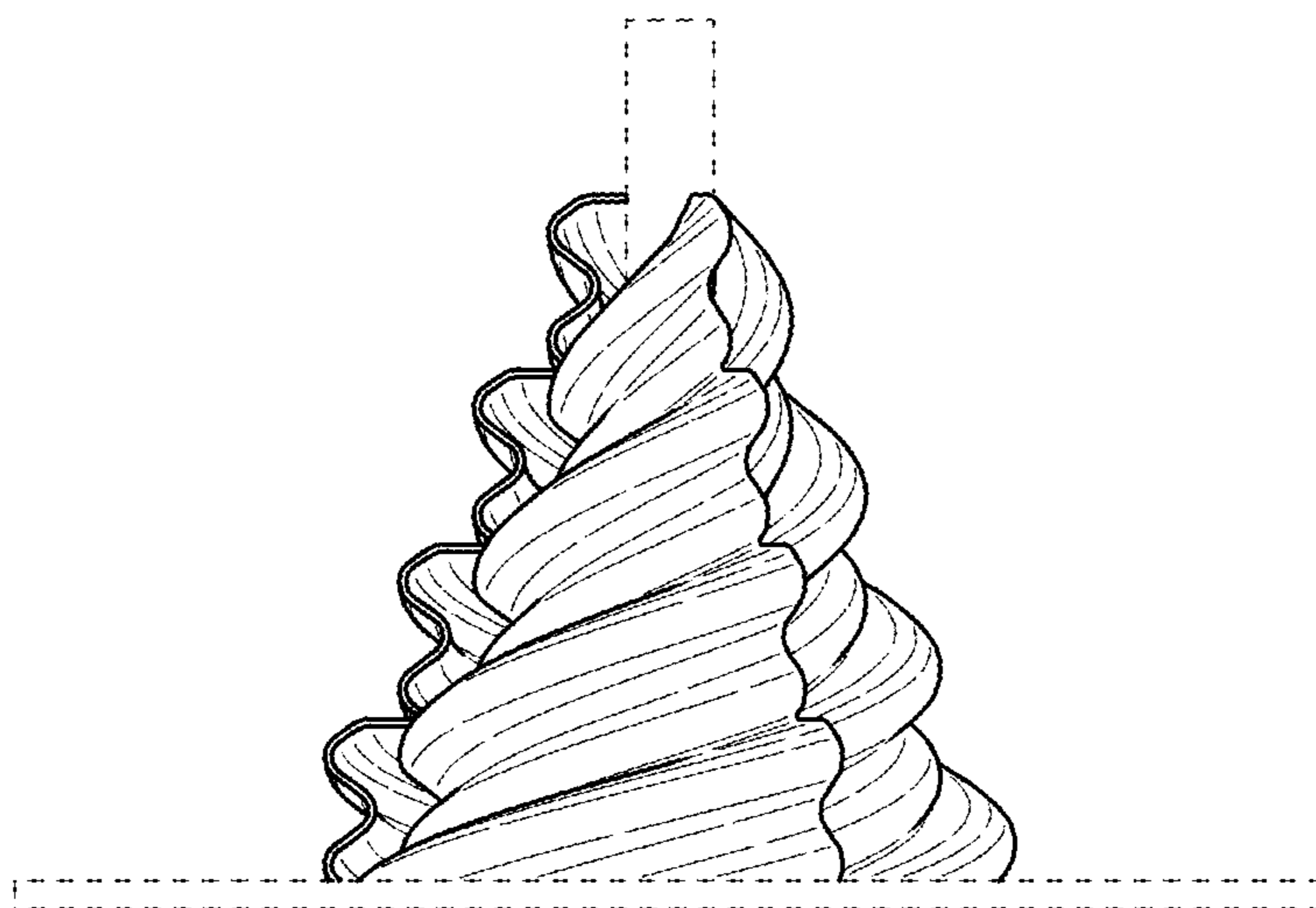

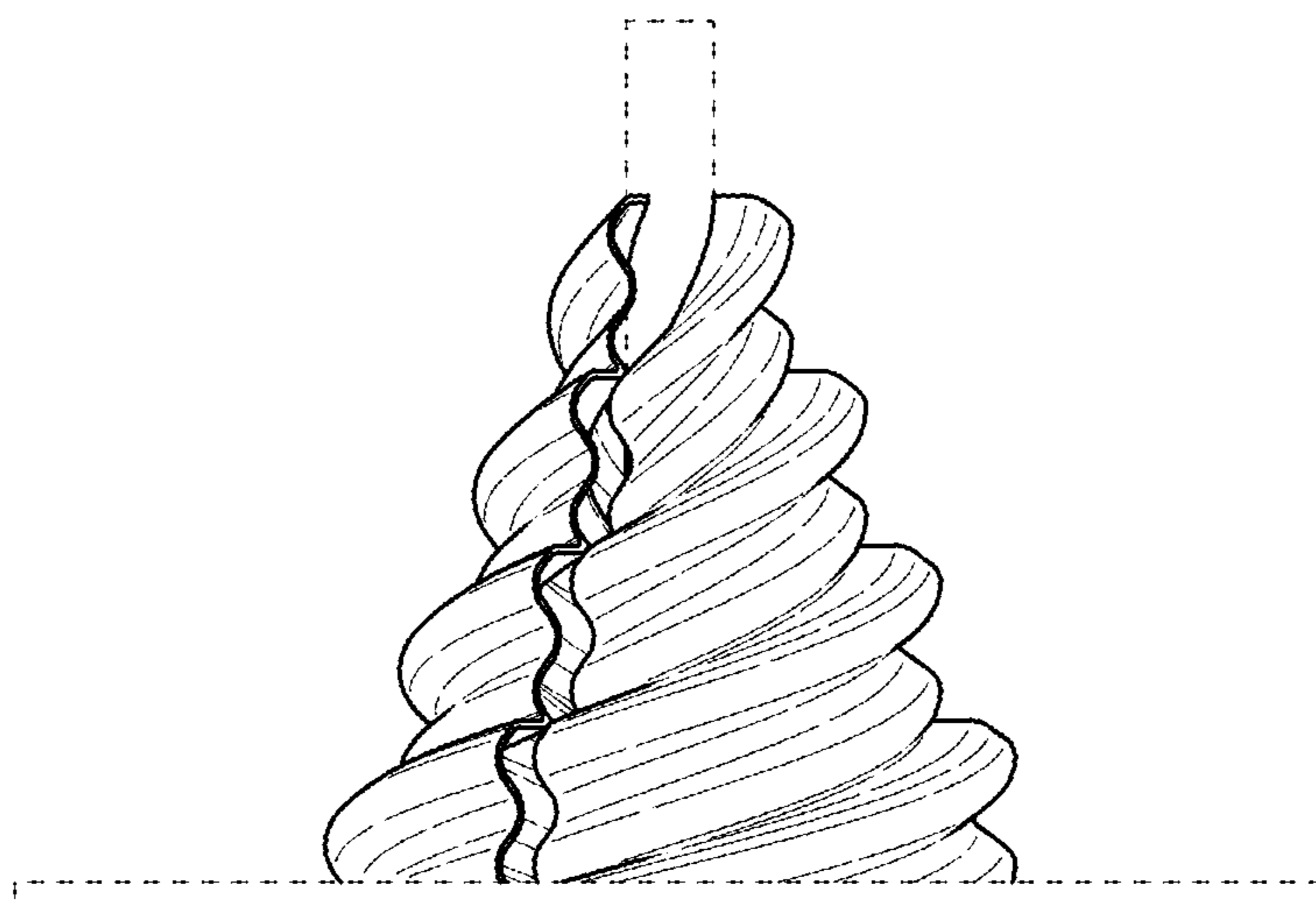

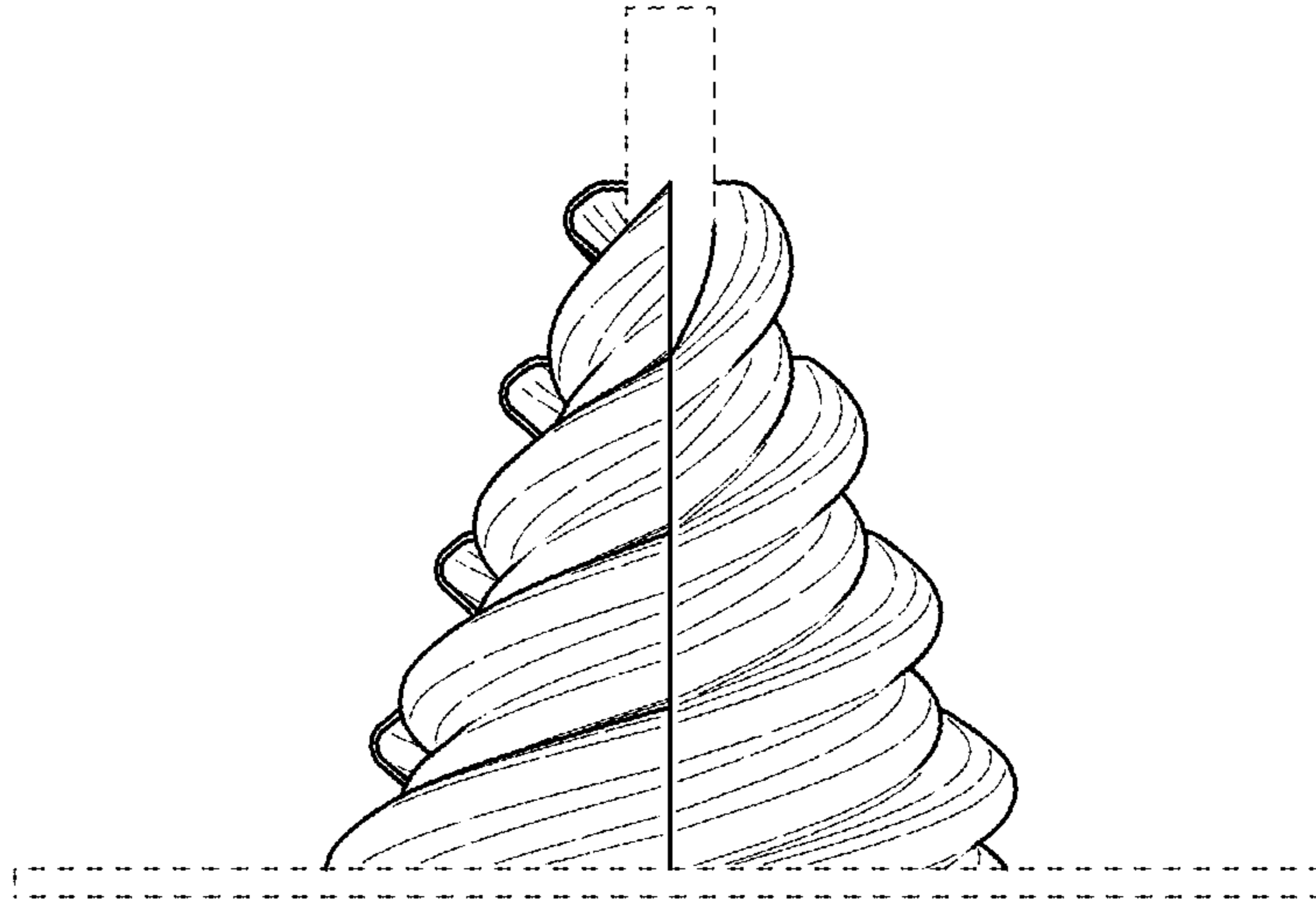

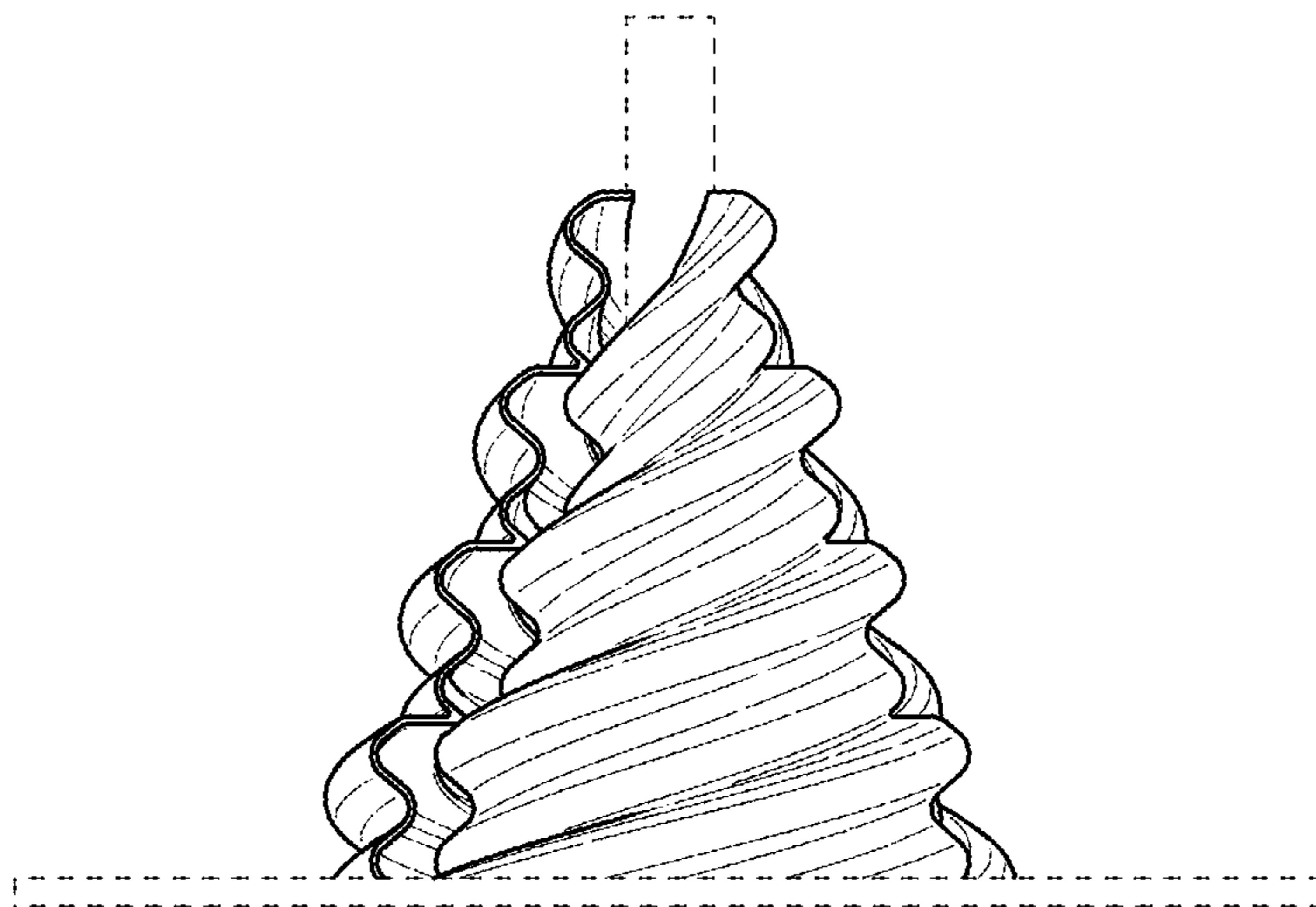

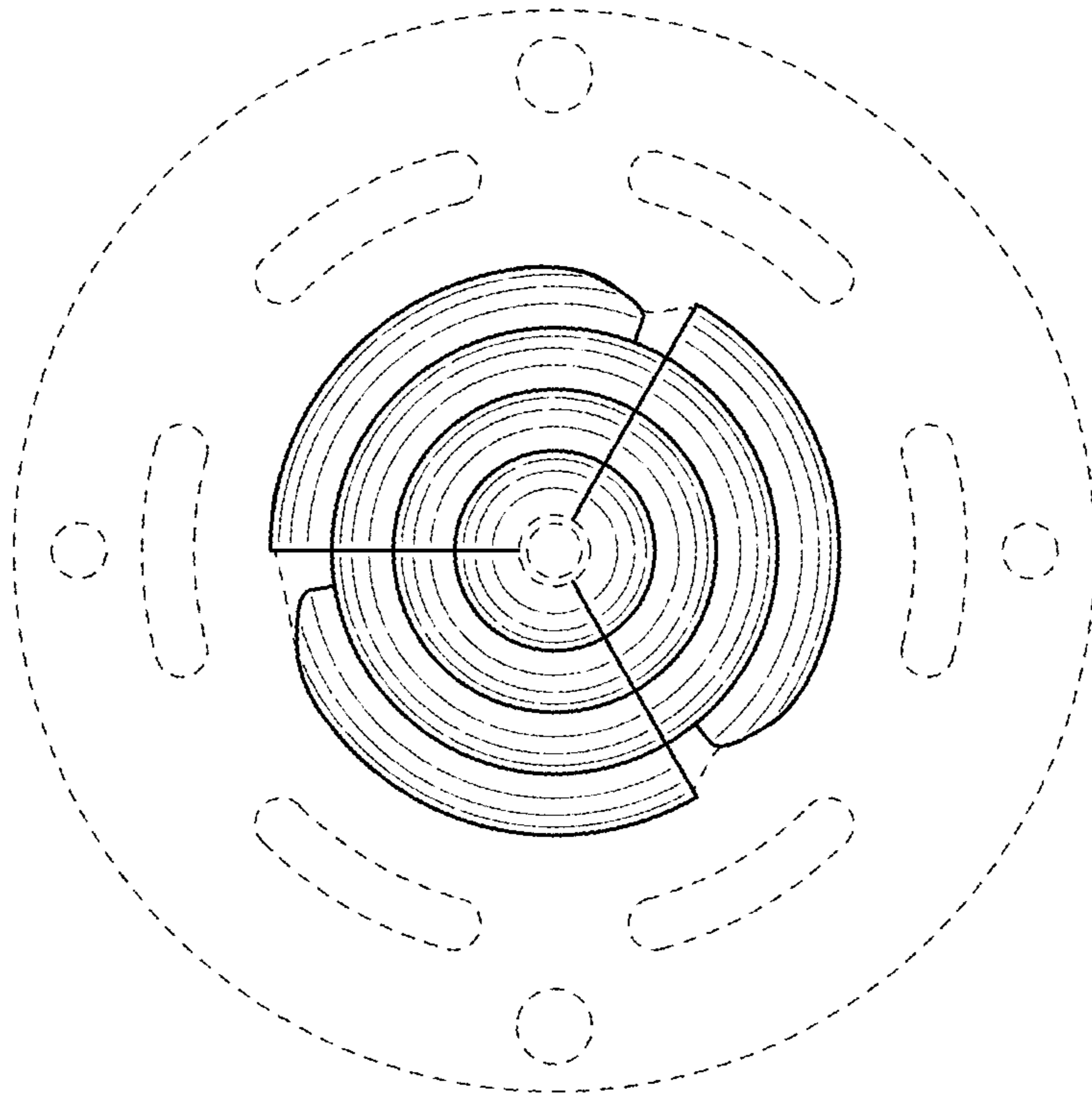

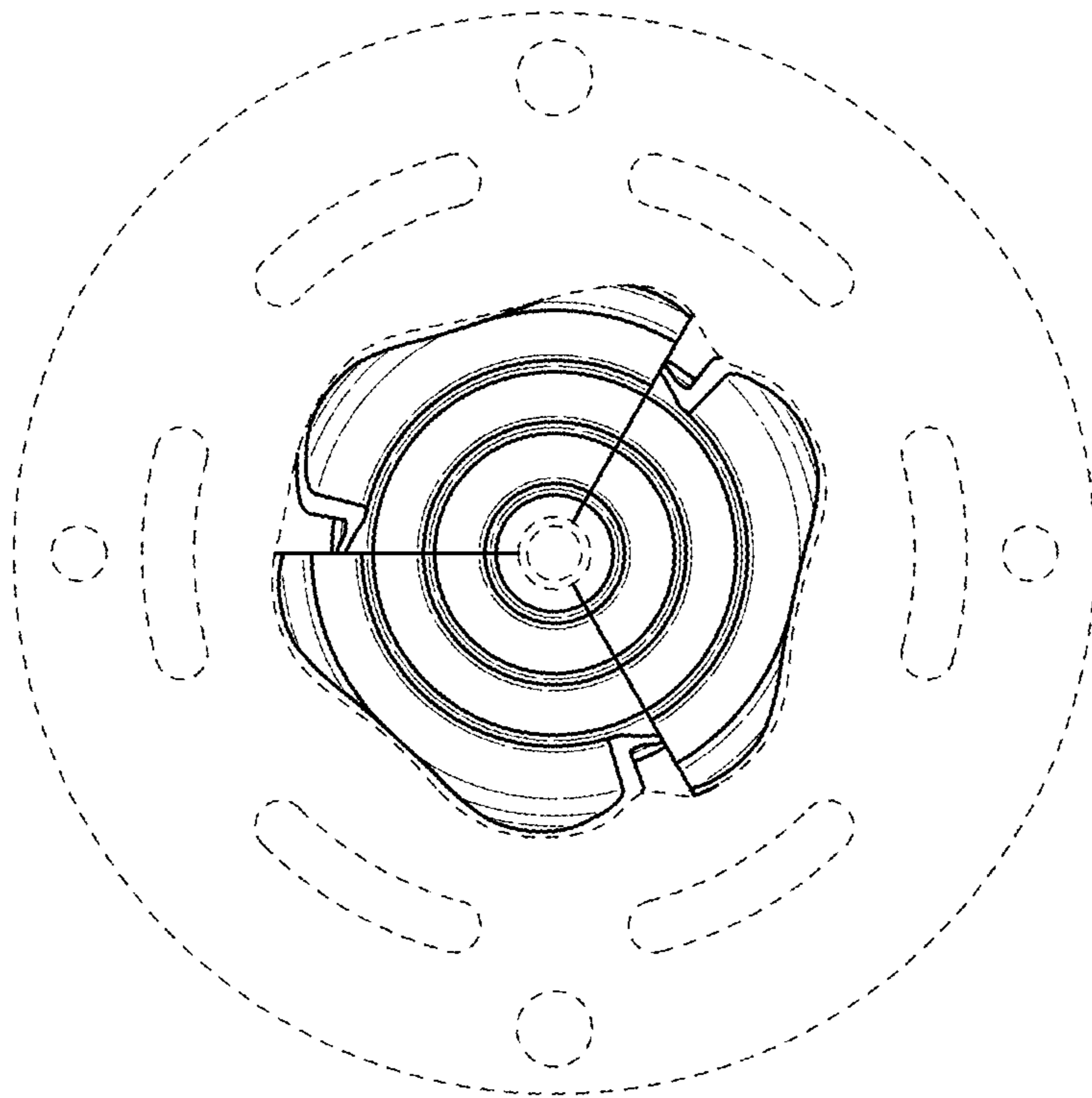
