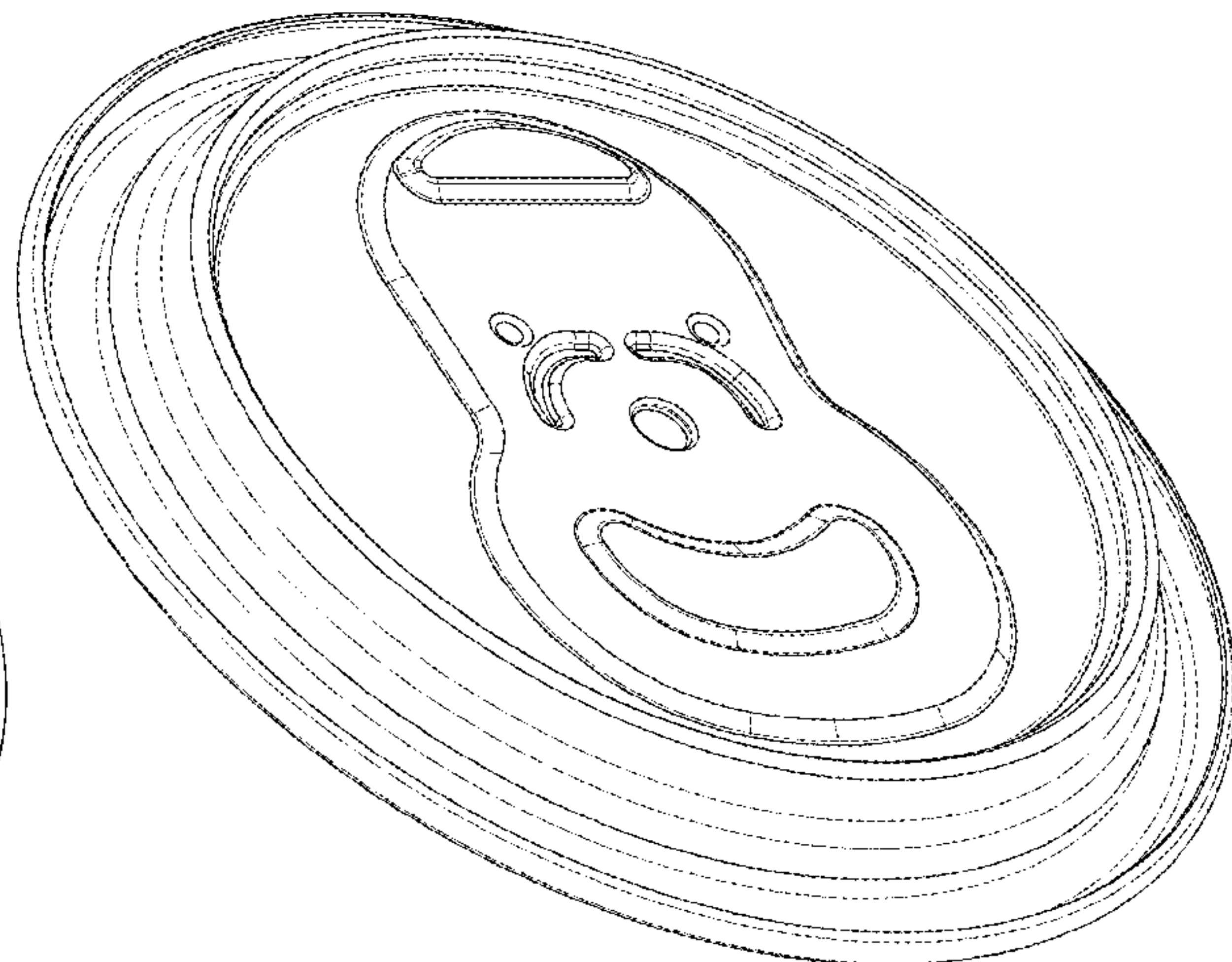
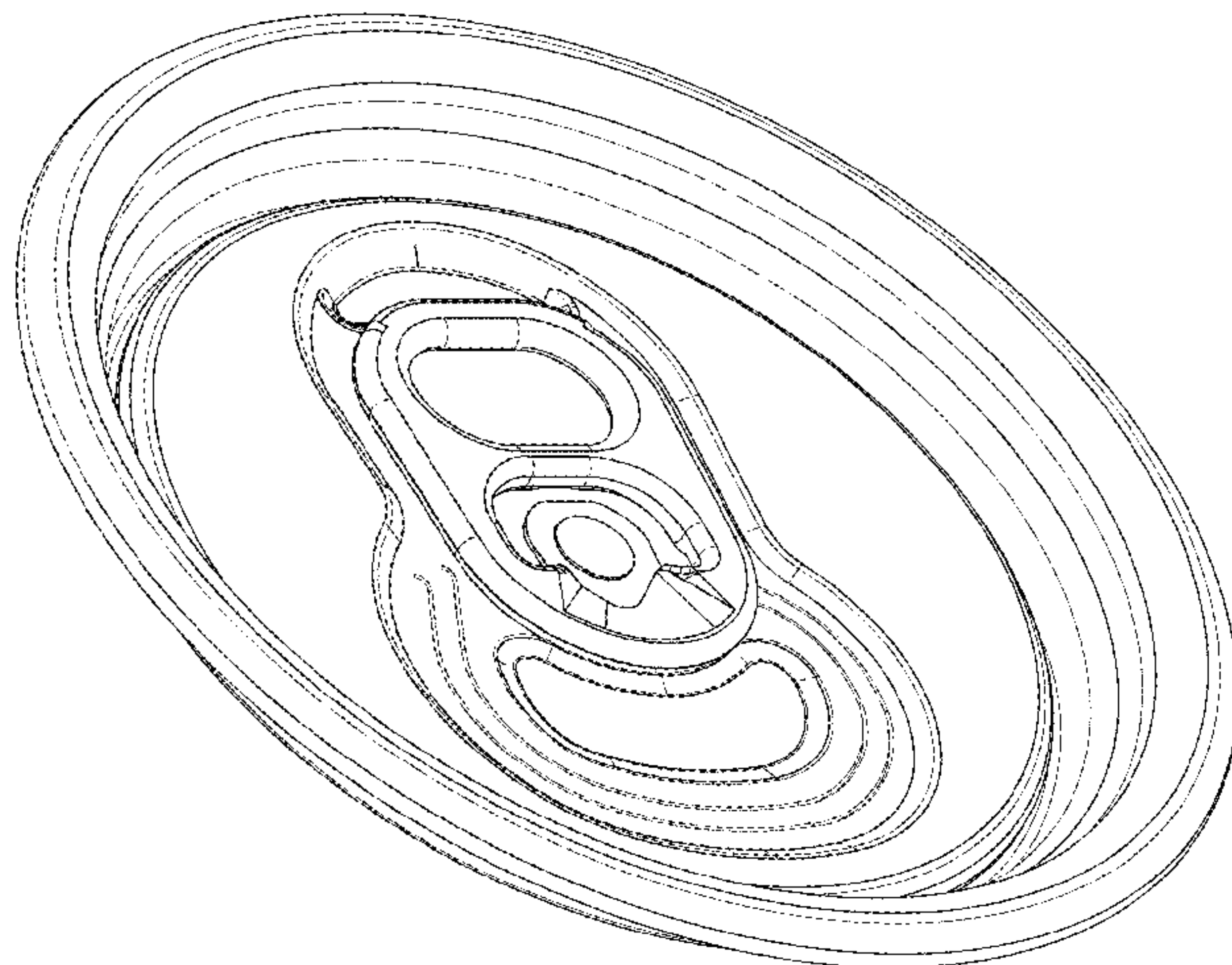
The ornamental design for a can end, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the can end;
FIG. 2 is another top perspective view of the can end;
FIG. 3 is a bottom perspective view of the can end;
FIG. 4 is another bottom perspective view of the can end;
FIG. 5 is a top plan view of the can end;
FIG. 6 is a bottom plan view of the can end;
FIG. 7 is a side elevation view of the can end; and,
FIG. 8 is section view taken in the direction of line 8-8 shown in FIG. 5.

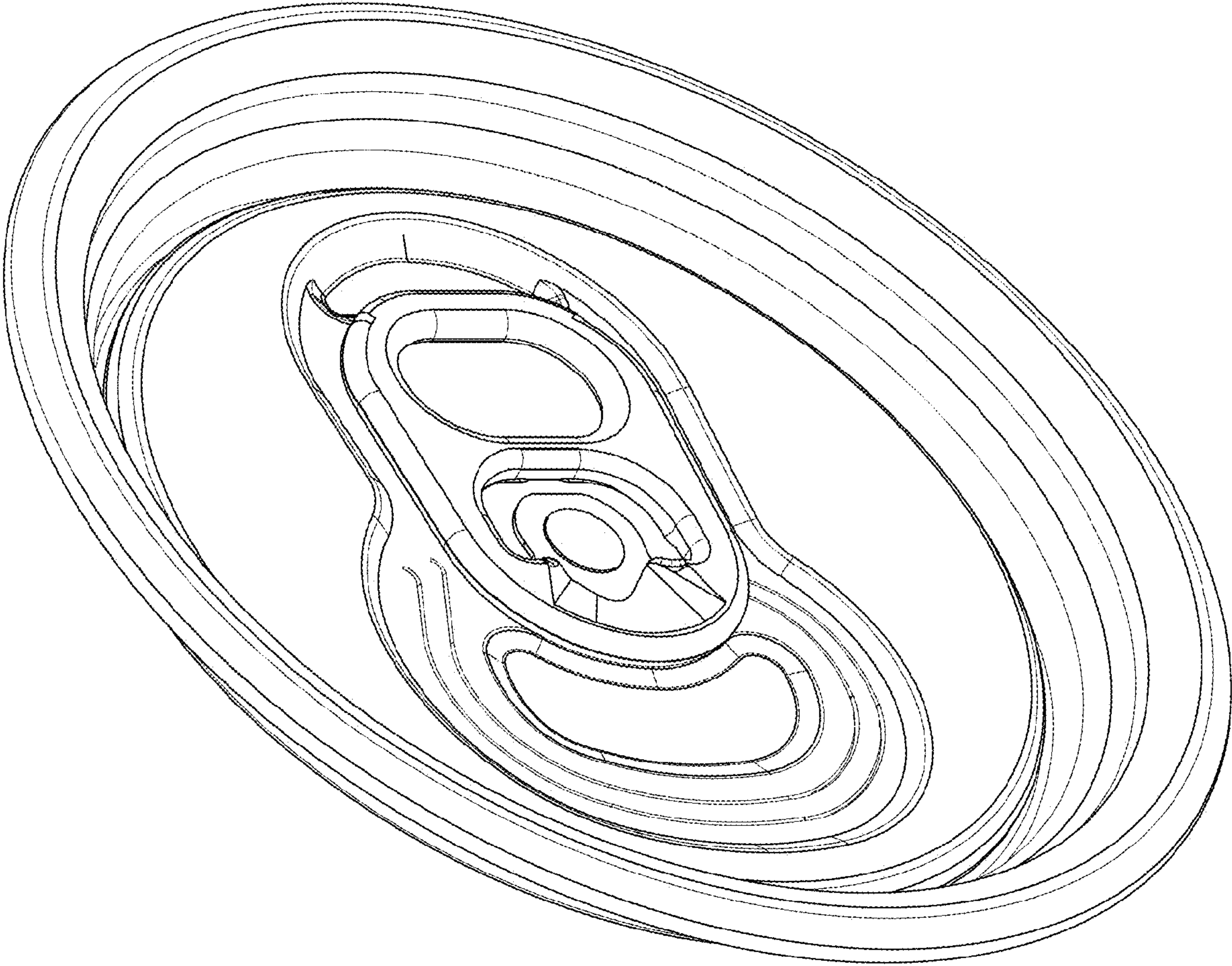

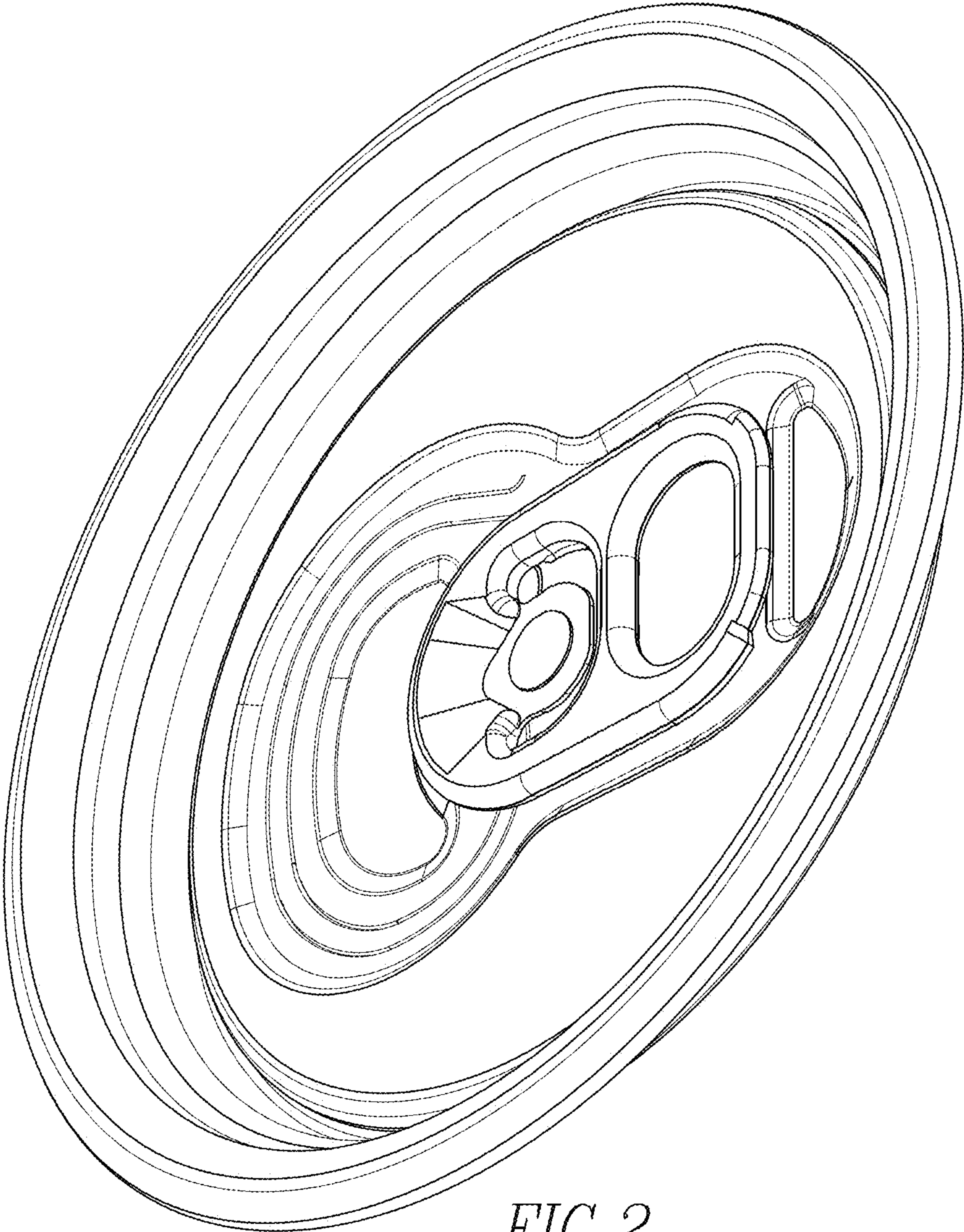

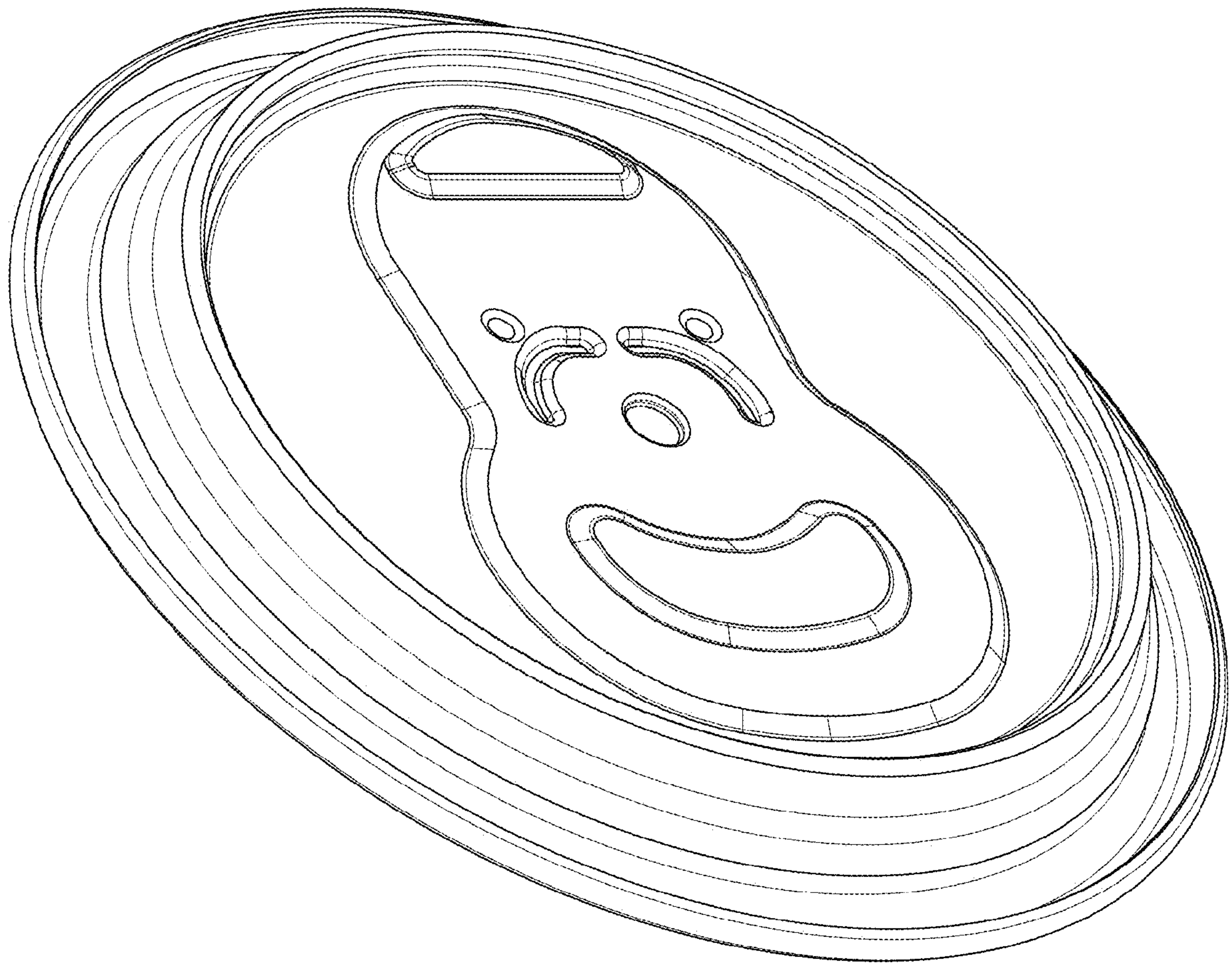

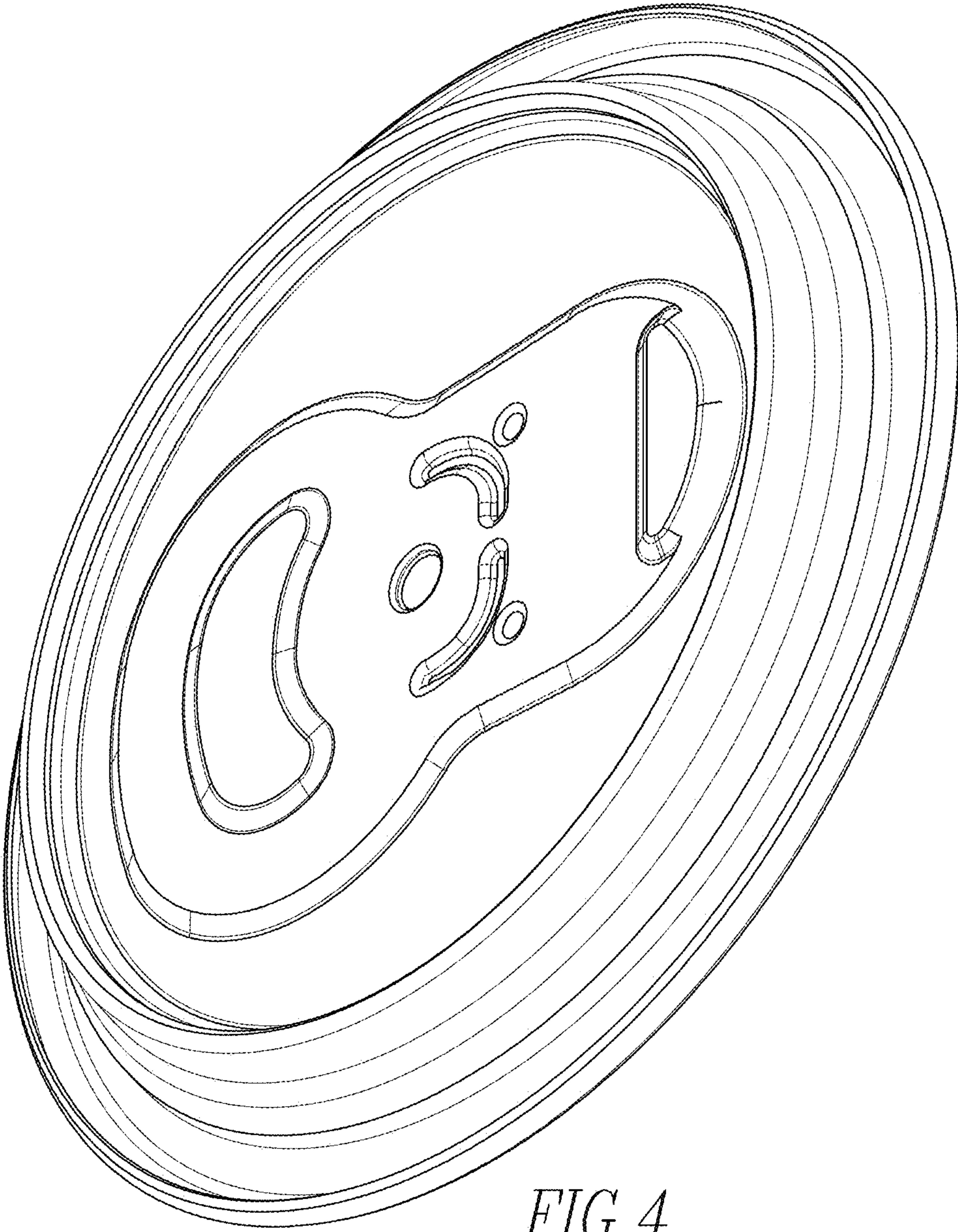

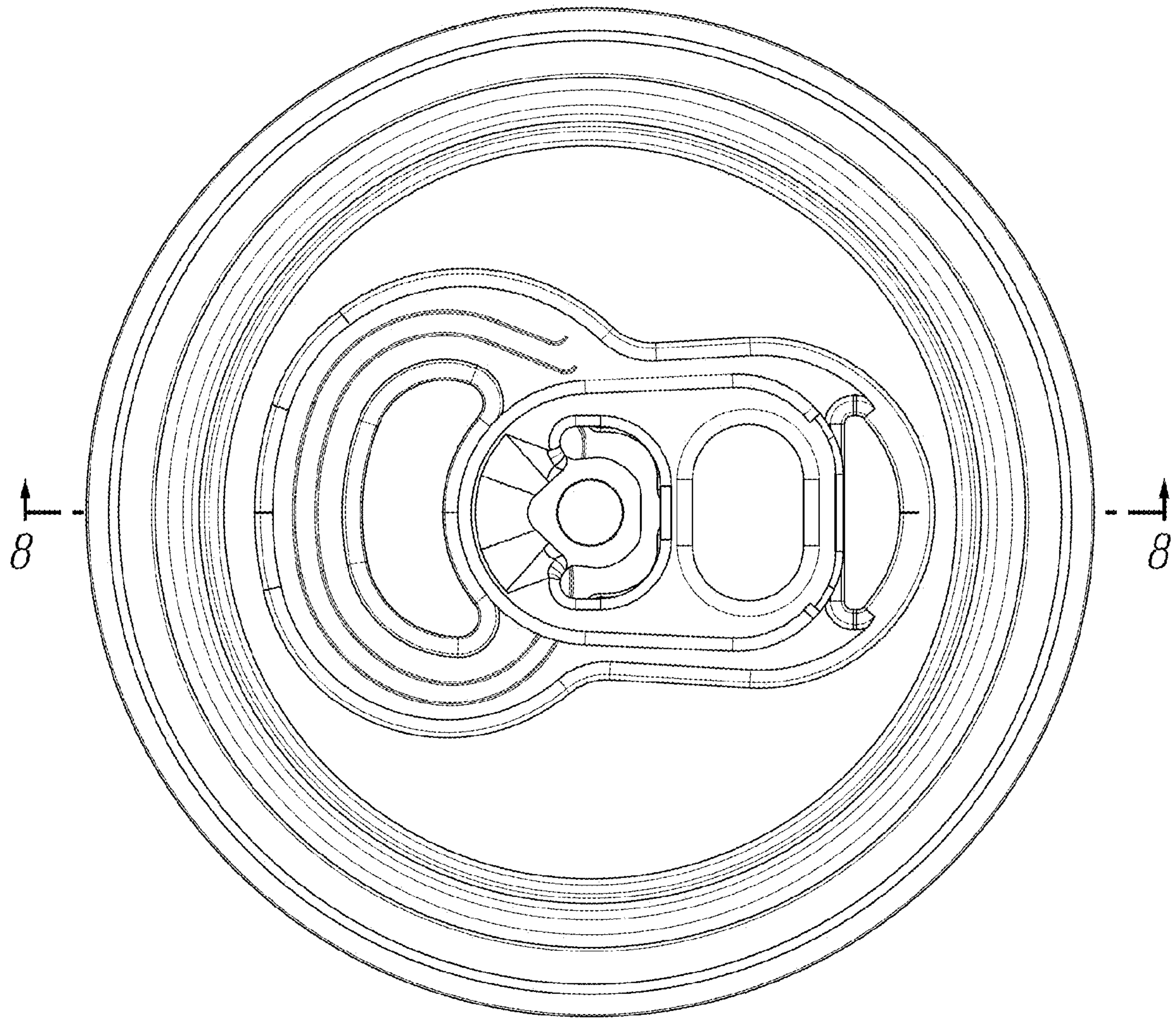

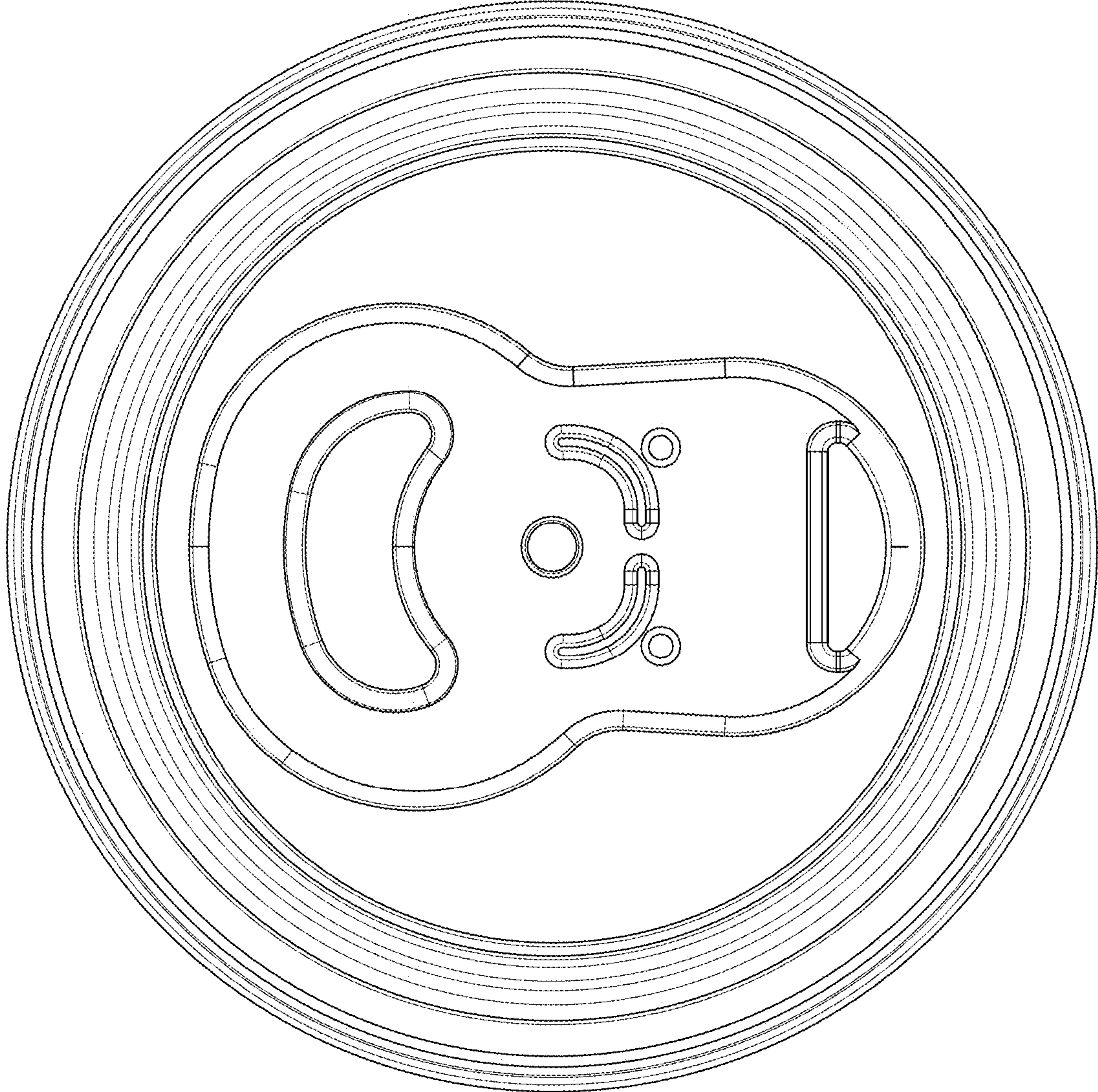

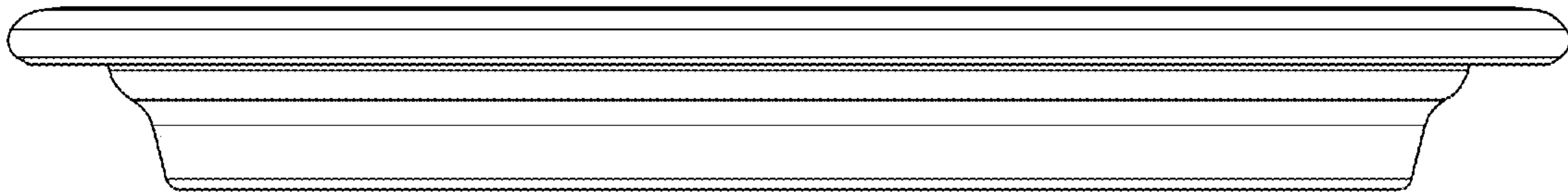

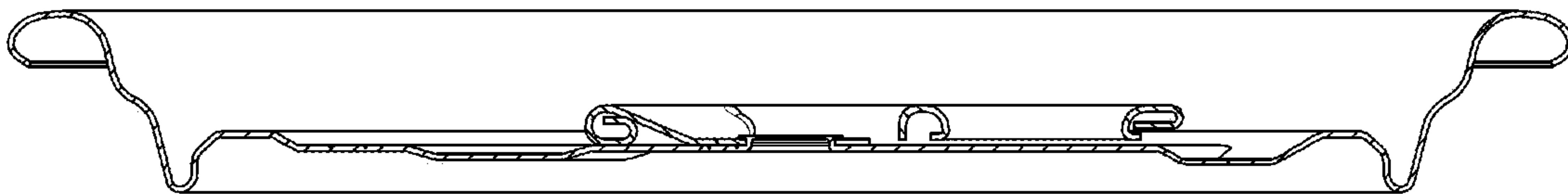
