(57) **CLAIM**

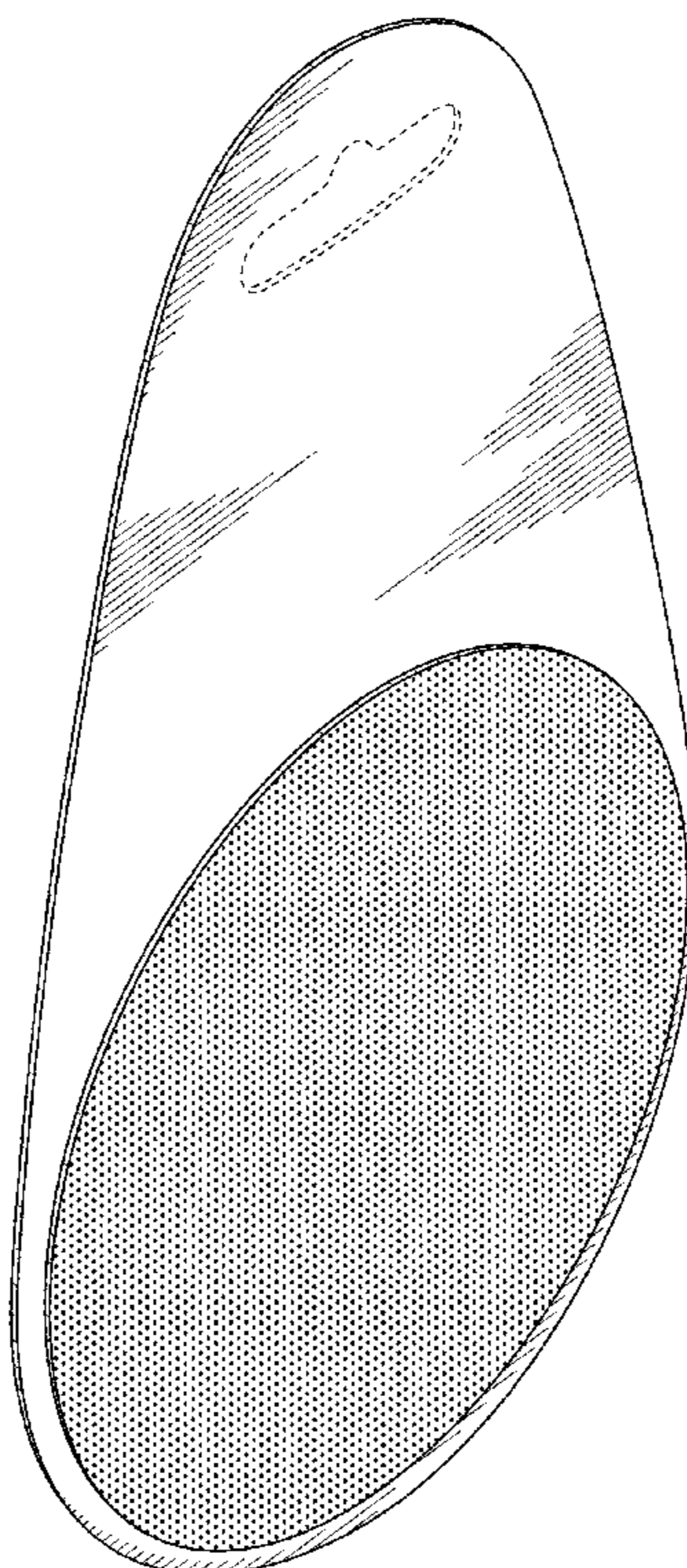
The ornamental design for a device holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a device holder showing my new design;  
FIG. 2 is a front view thereof;

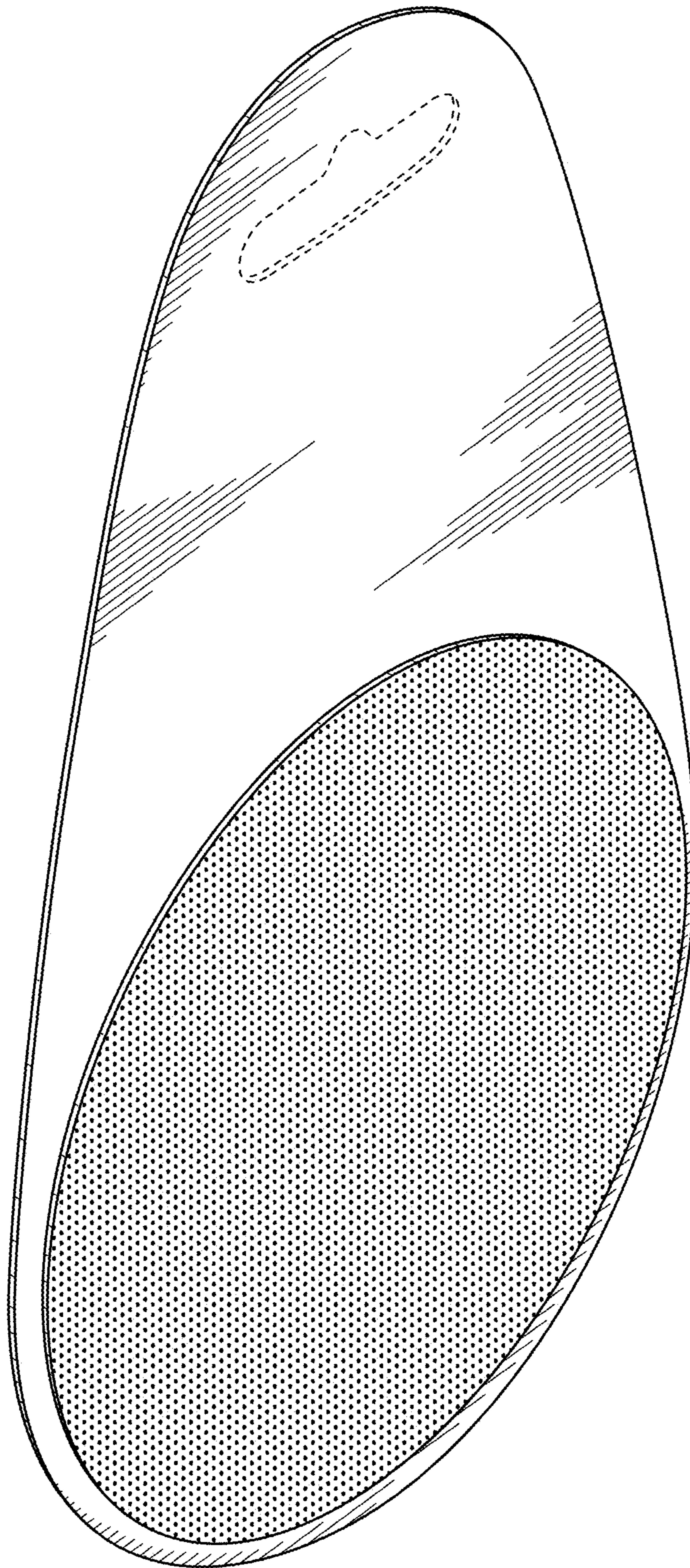

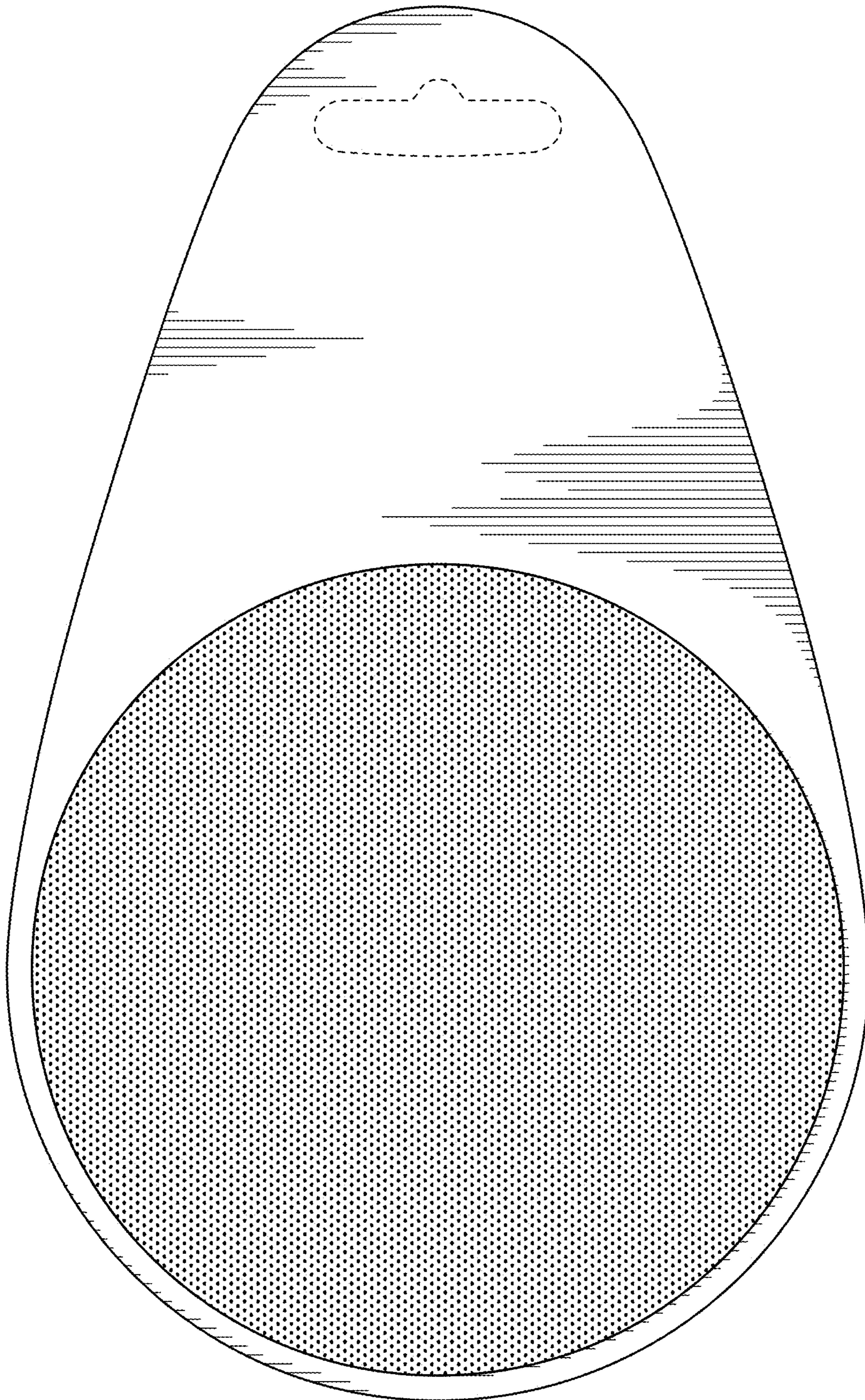

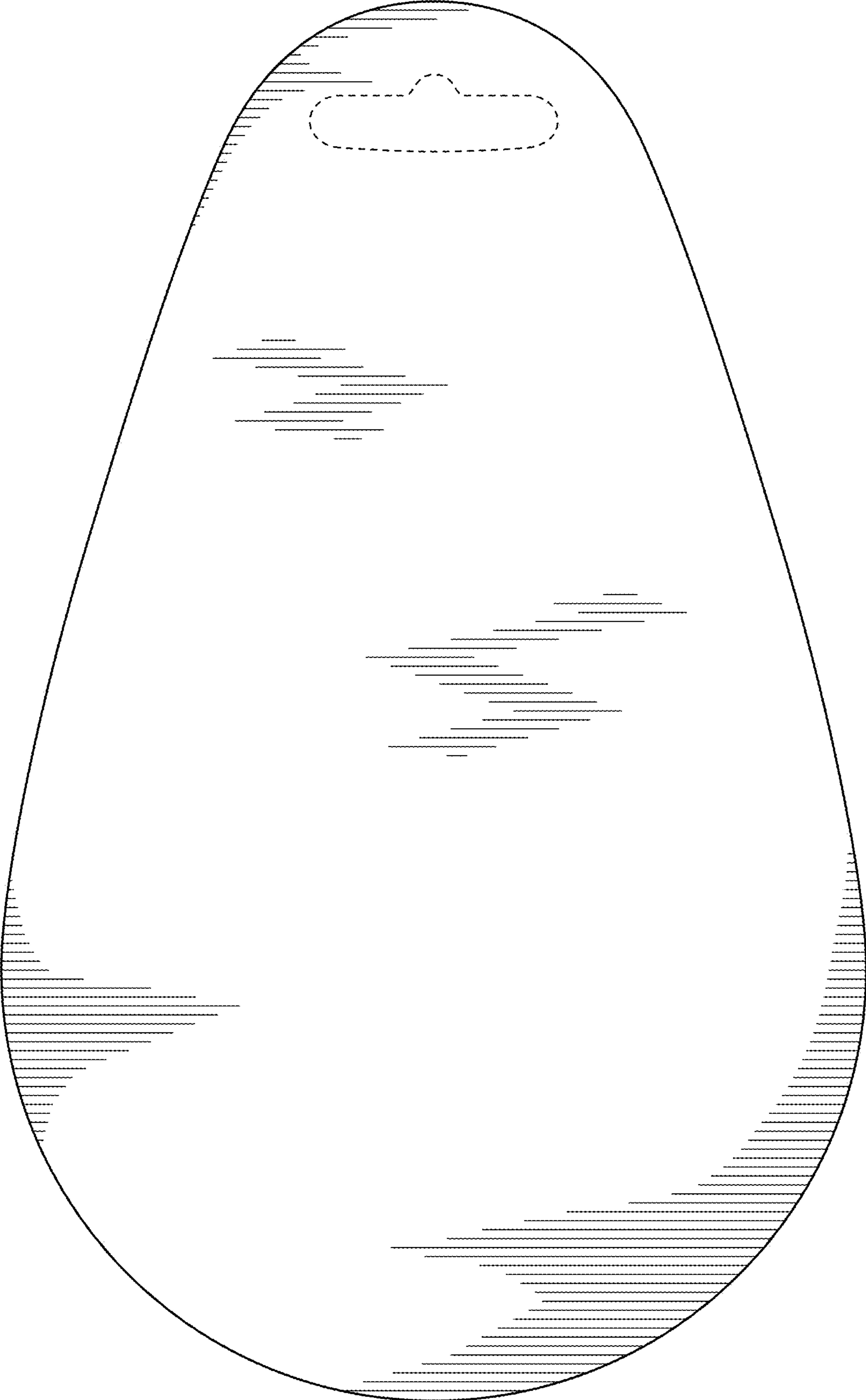
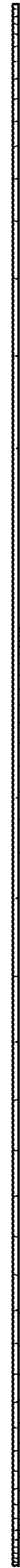


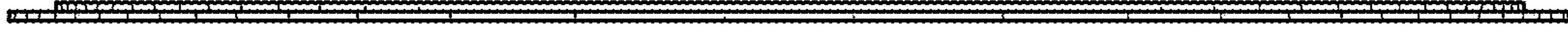

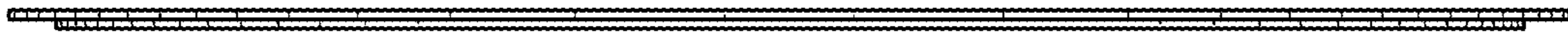
