DESCRIPTION

FIG. 4 is a rear side elevational view of the bicycle frame element of FIG. 1;

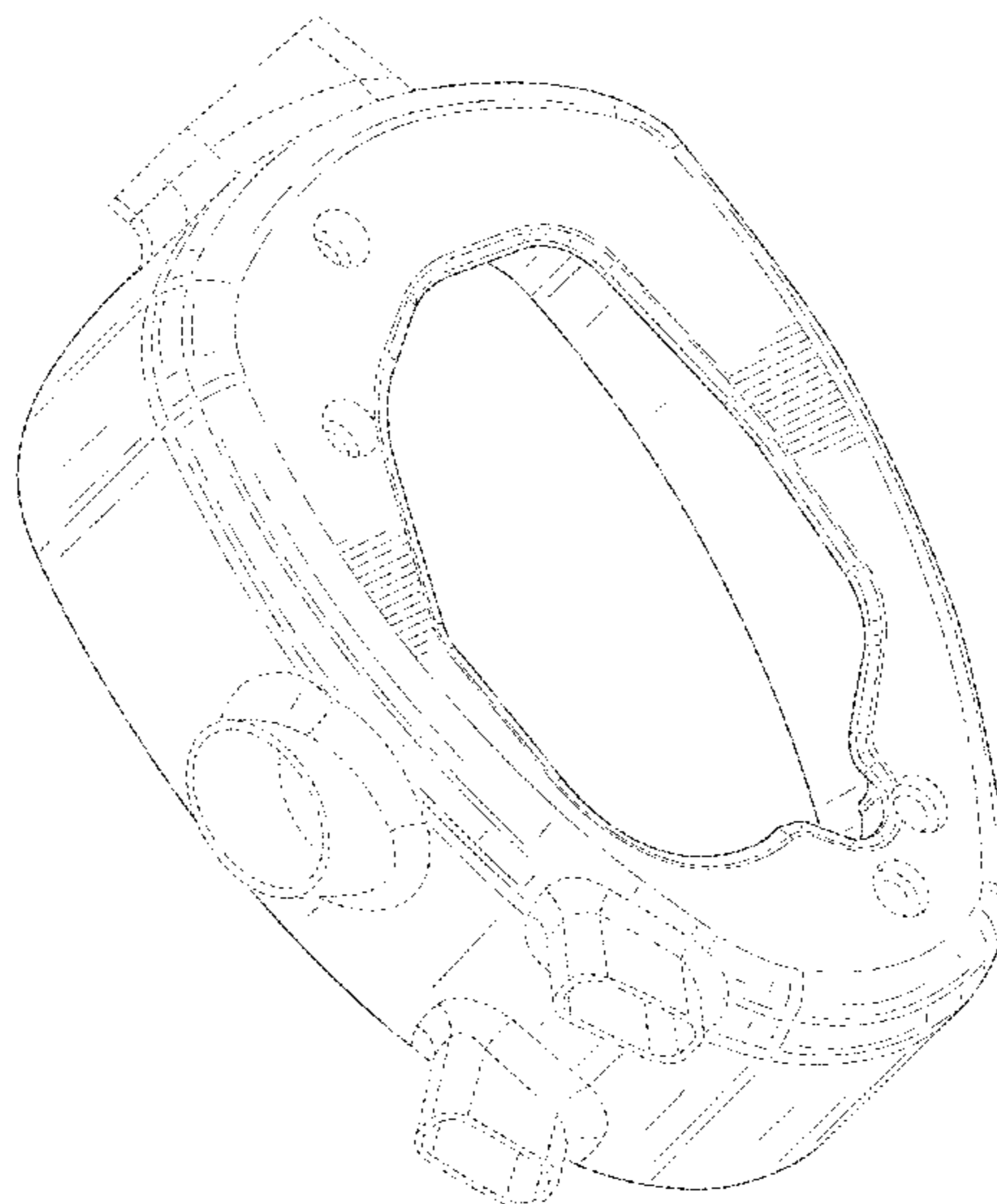
FIG. 5 is a front side elevational view of the bicycle frame element of FIG. 1;

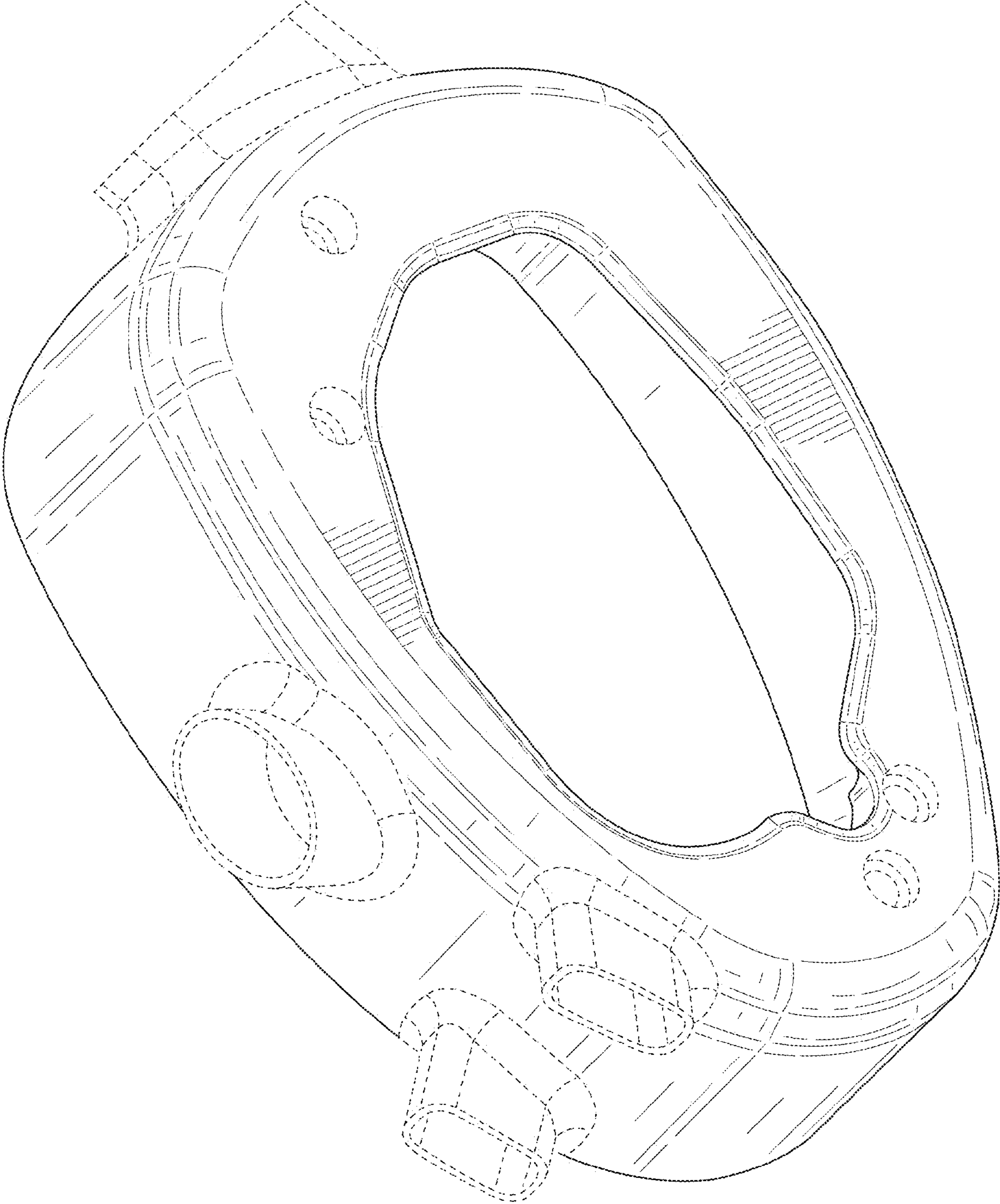

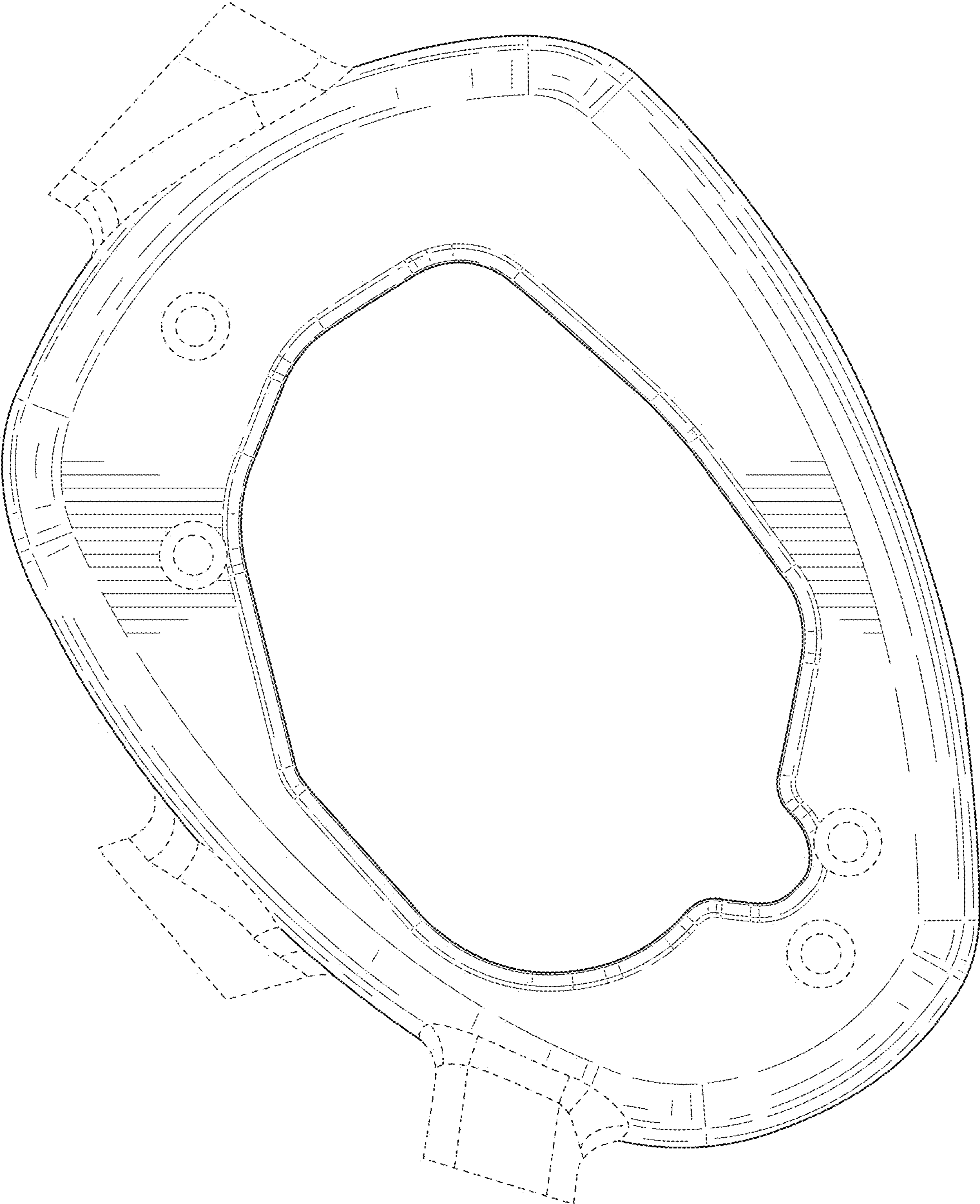

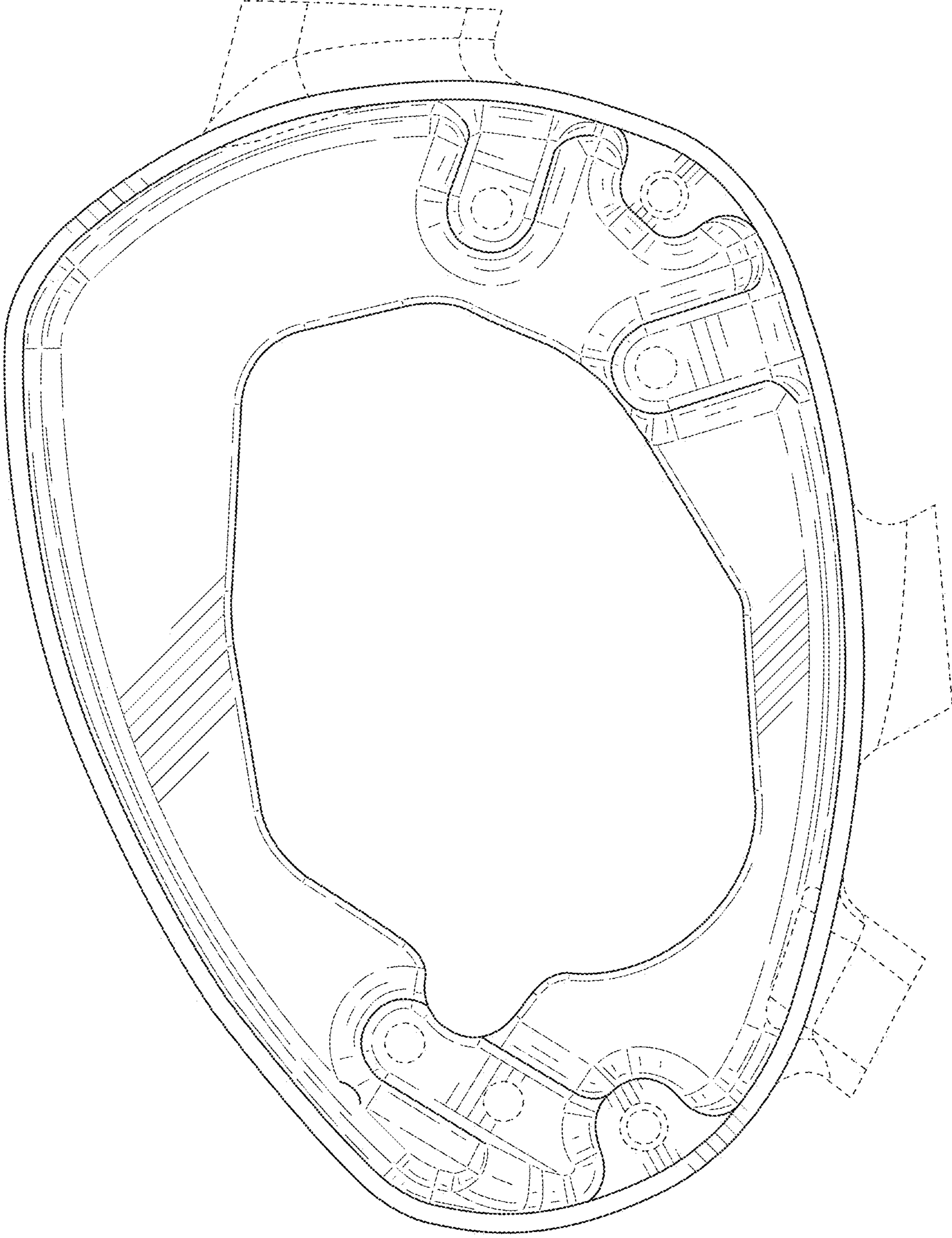

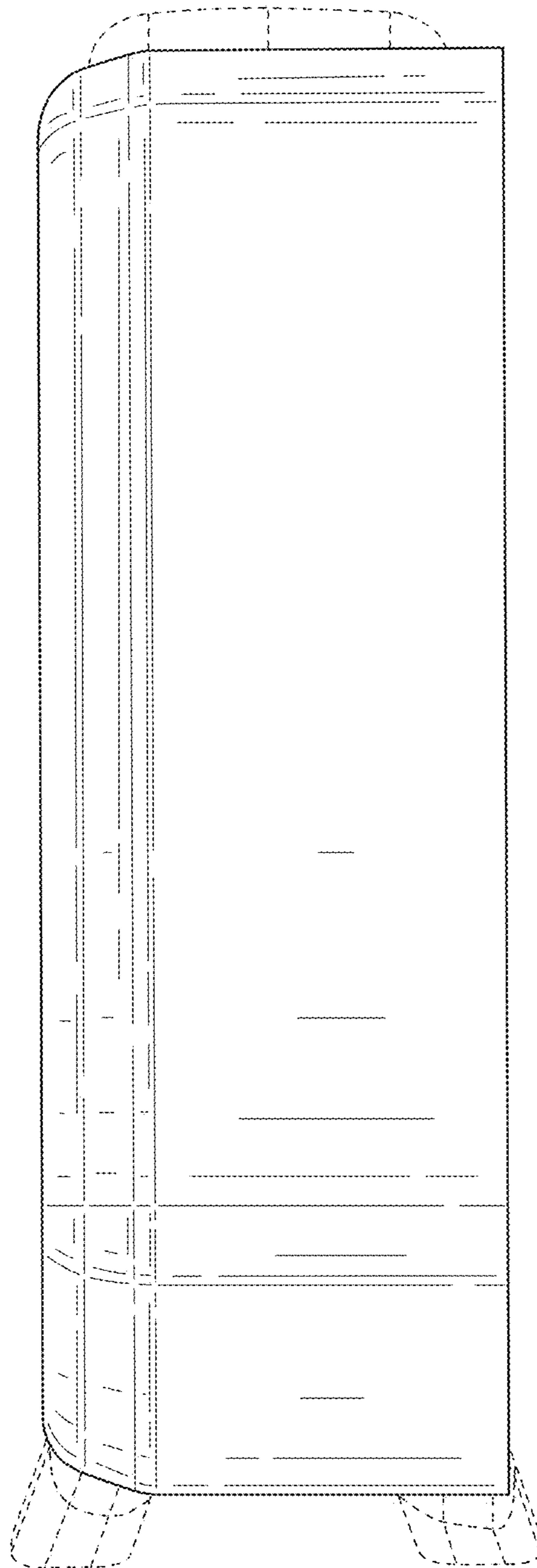

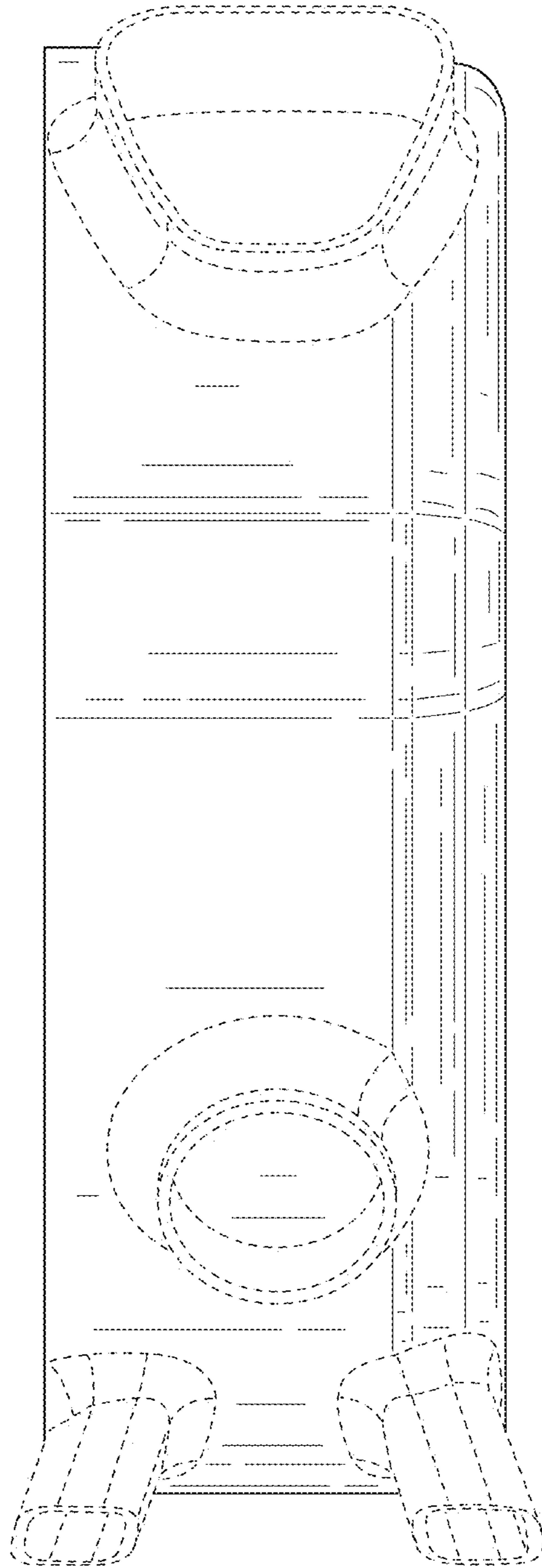

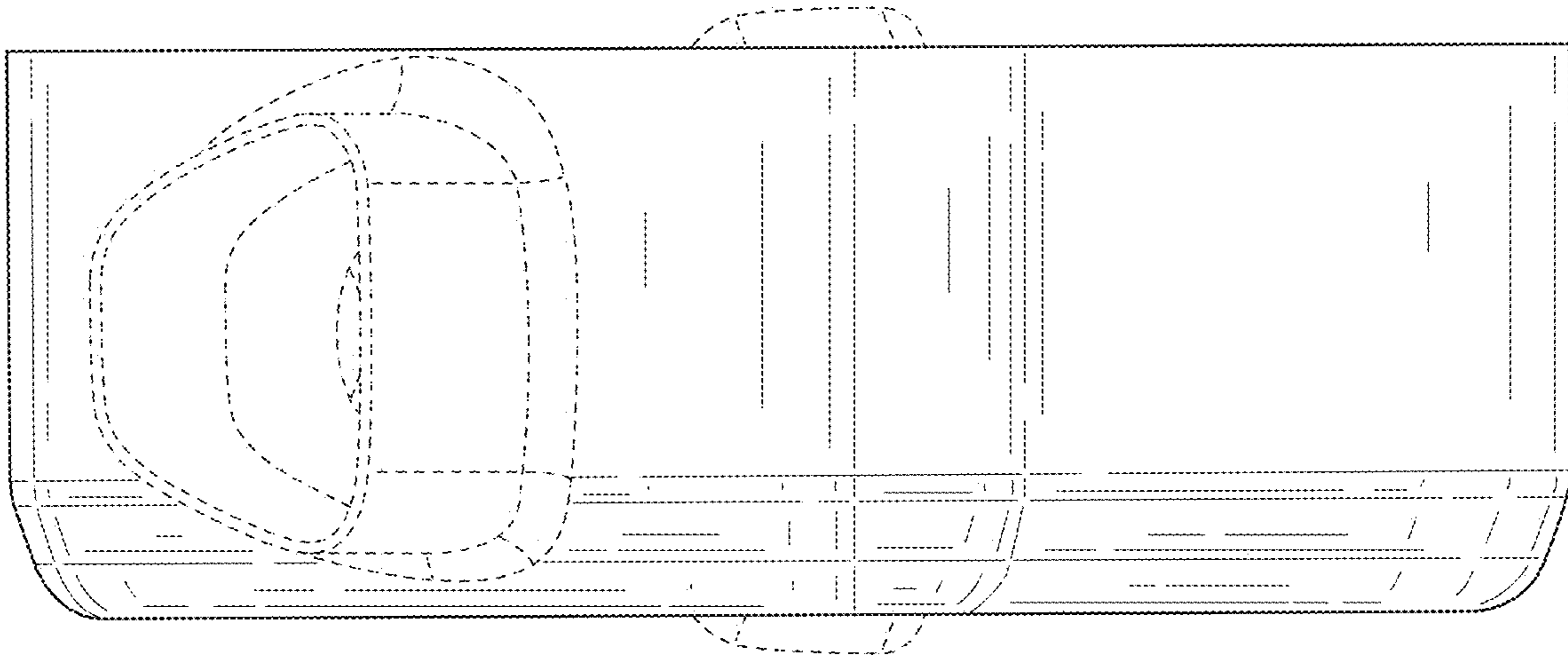

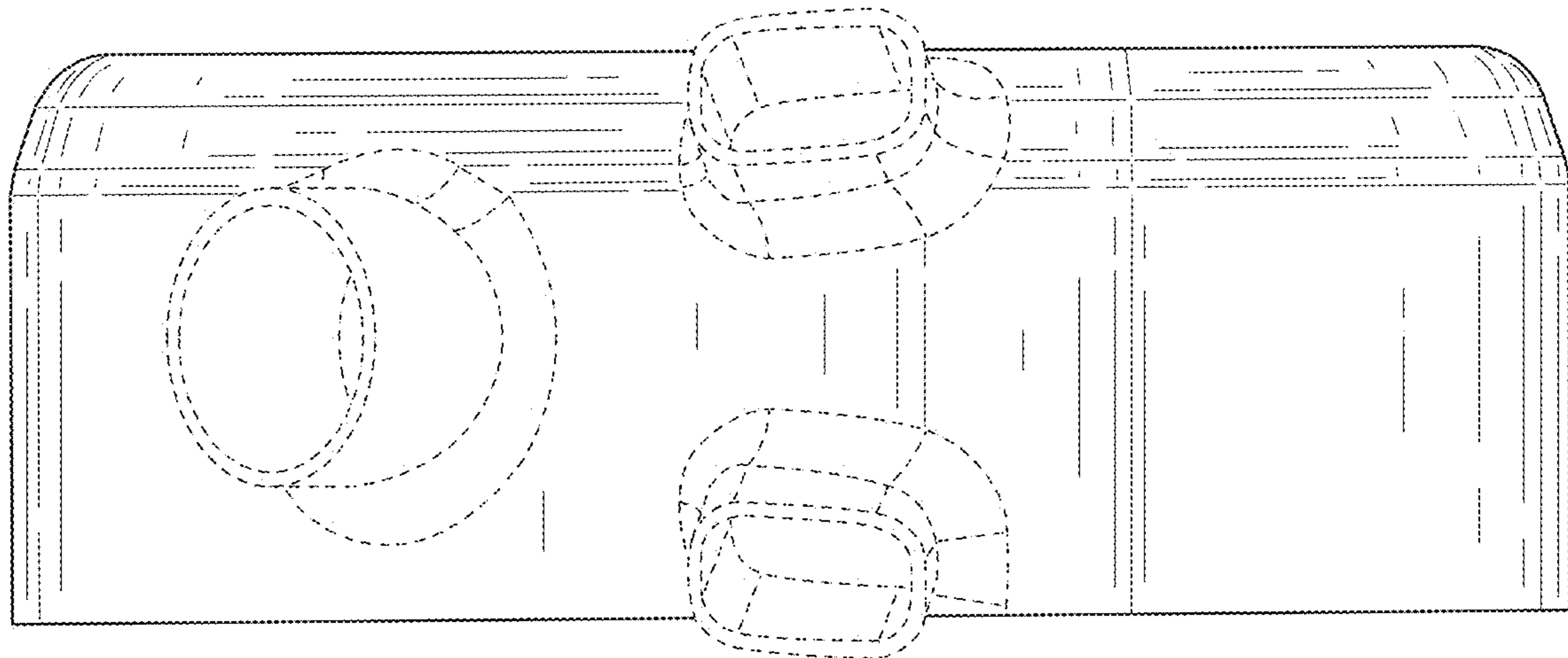
