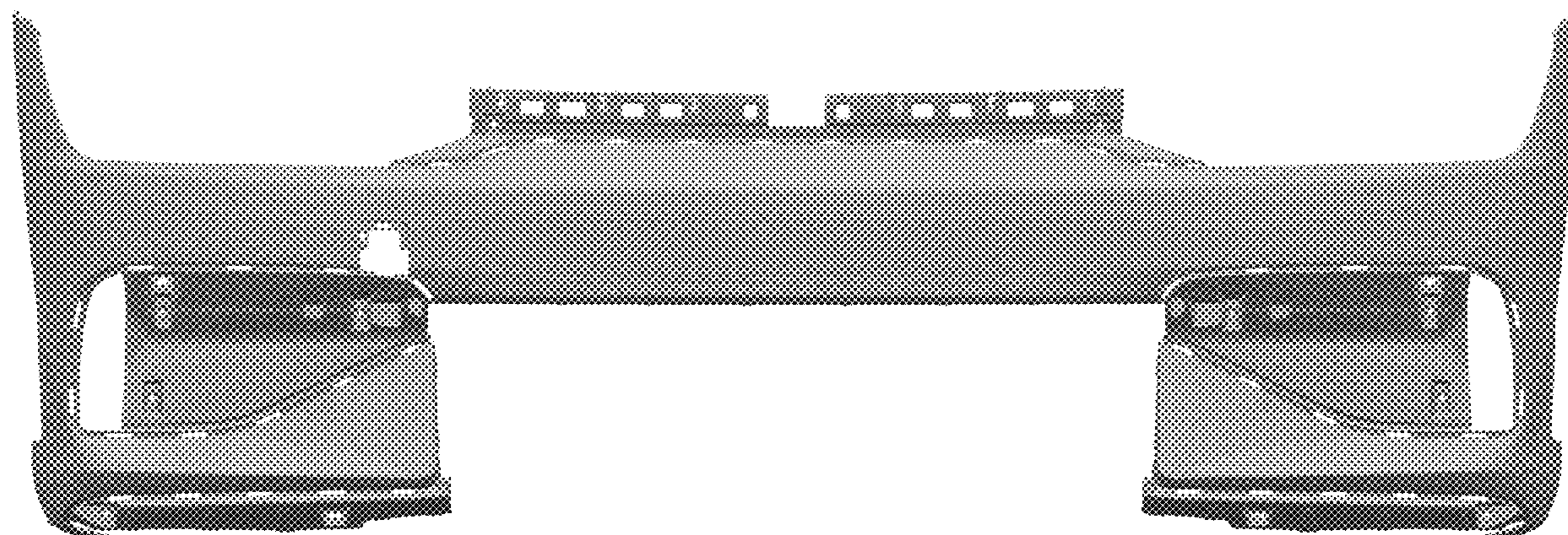

The ornamental design for a front bumper cover for automobile, as shown and described.

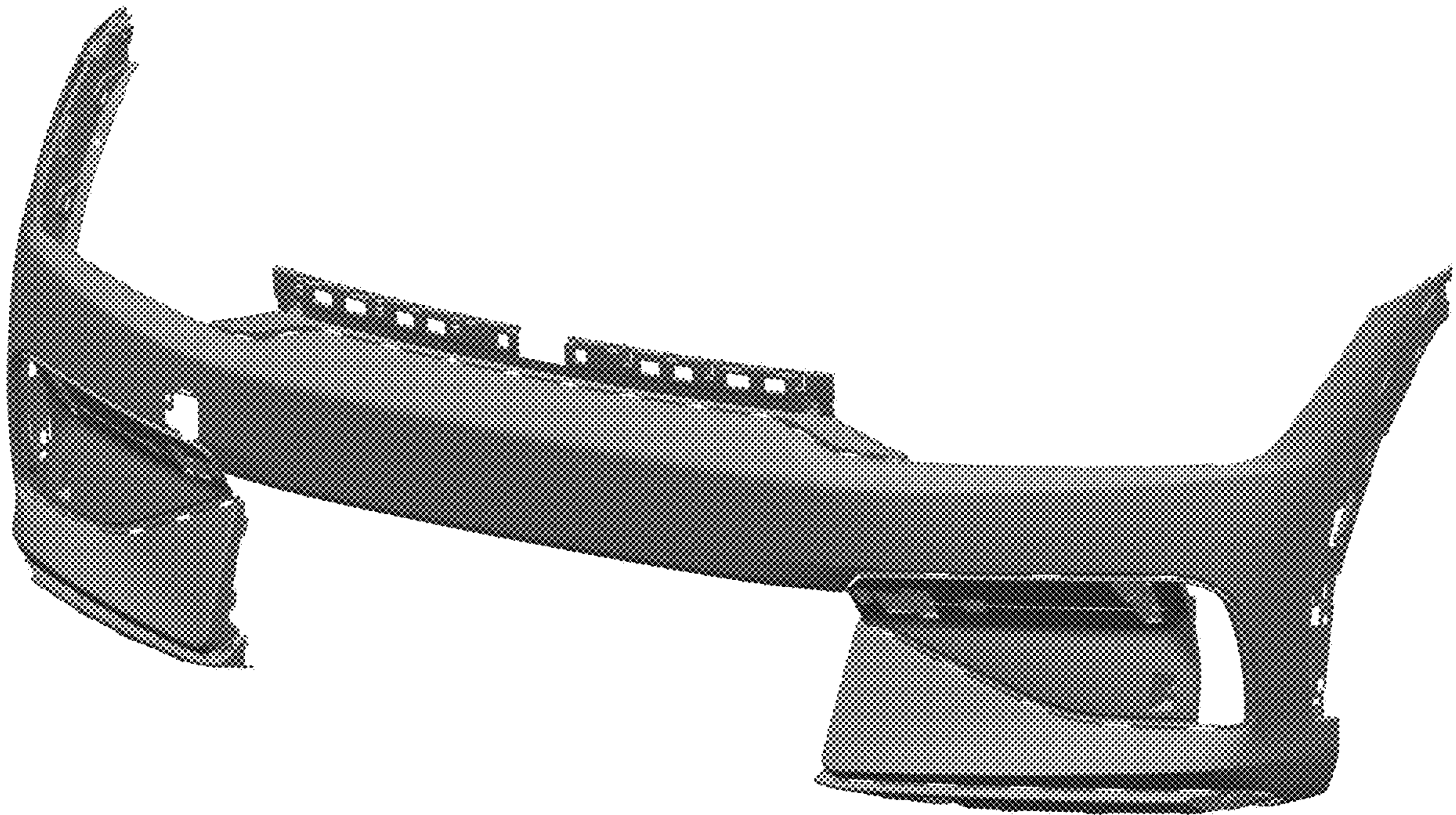
DESCRIPTION

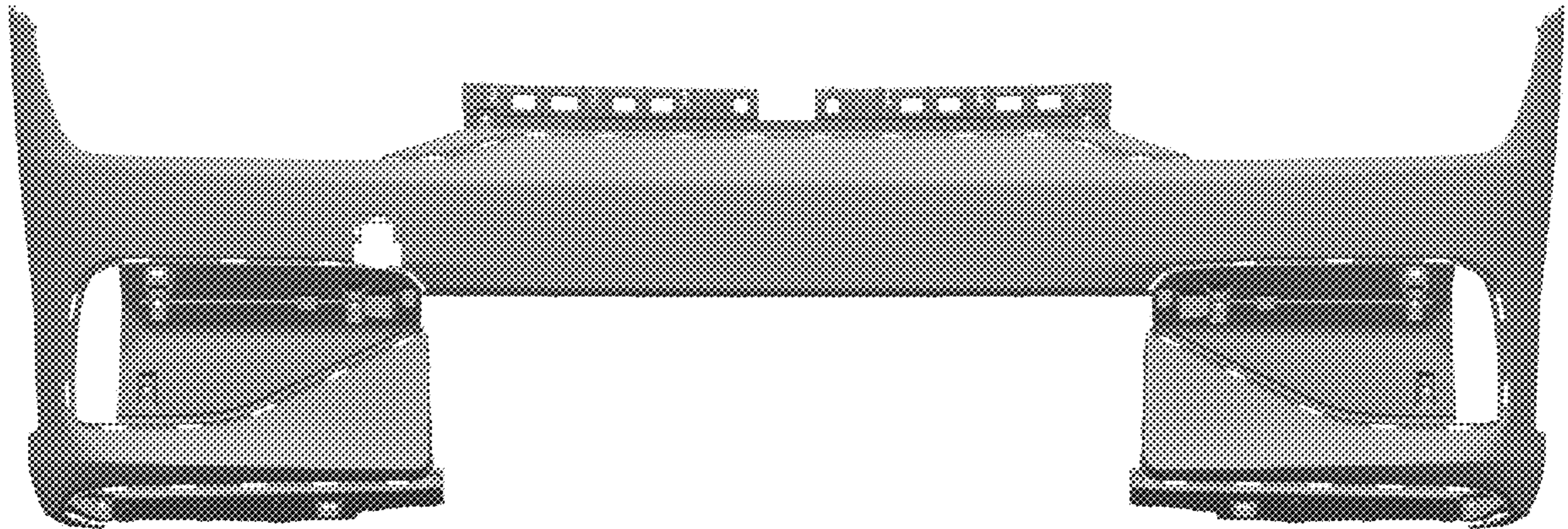

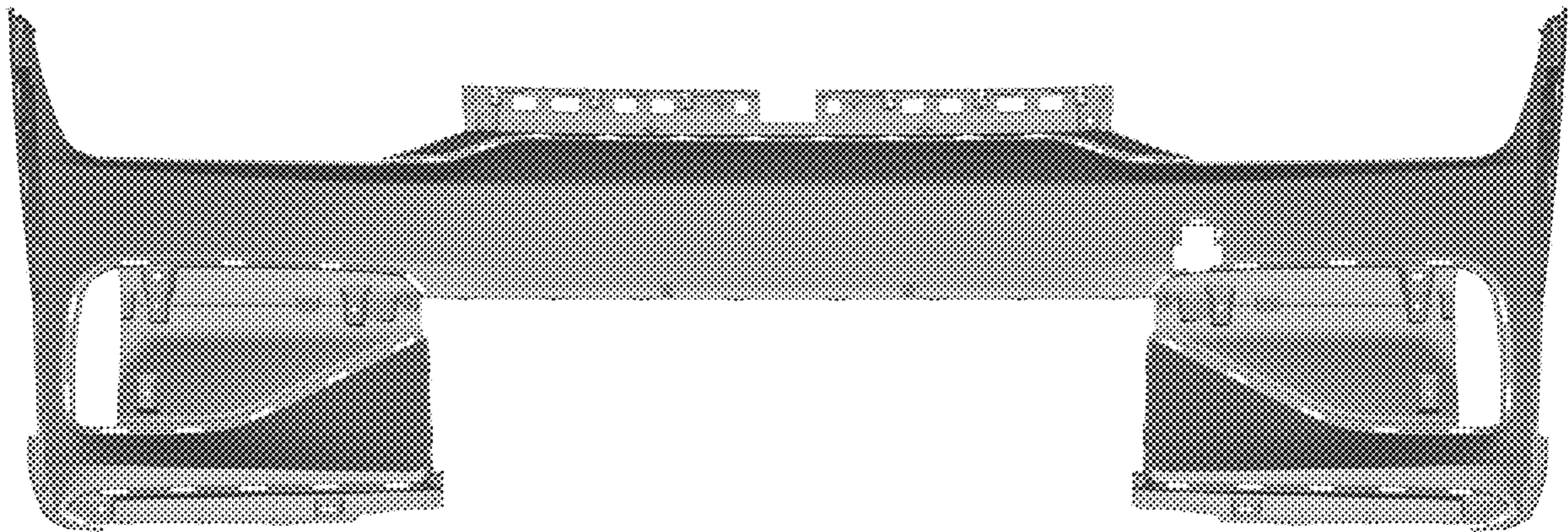

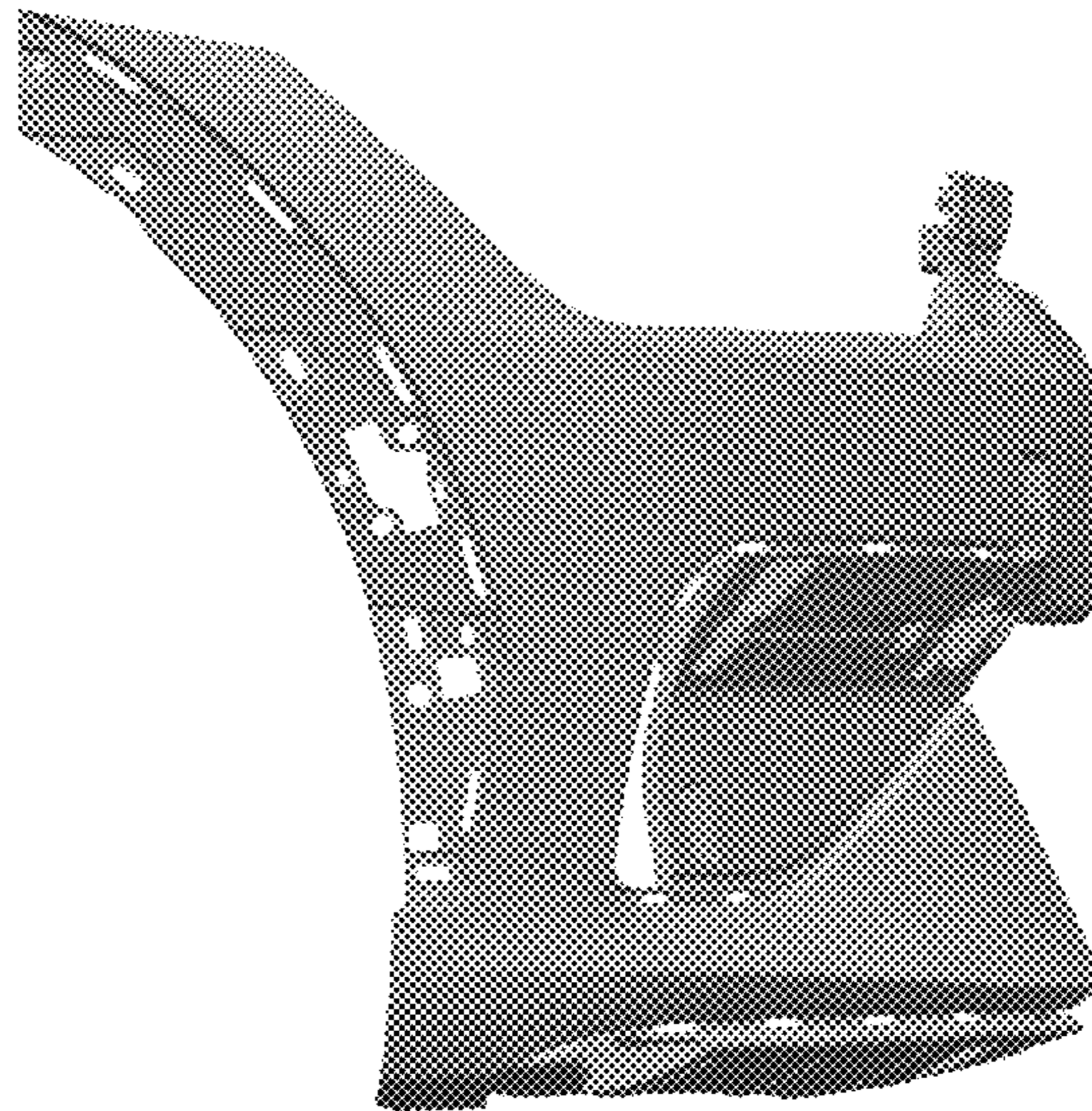

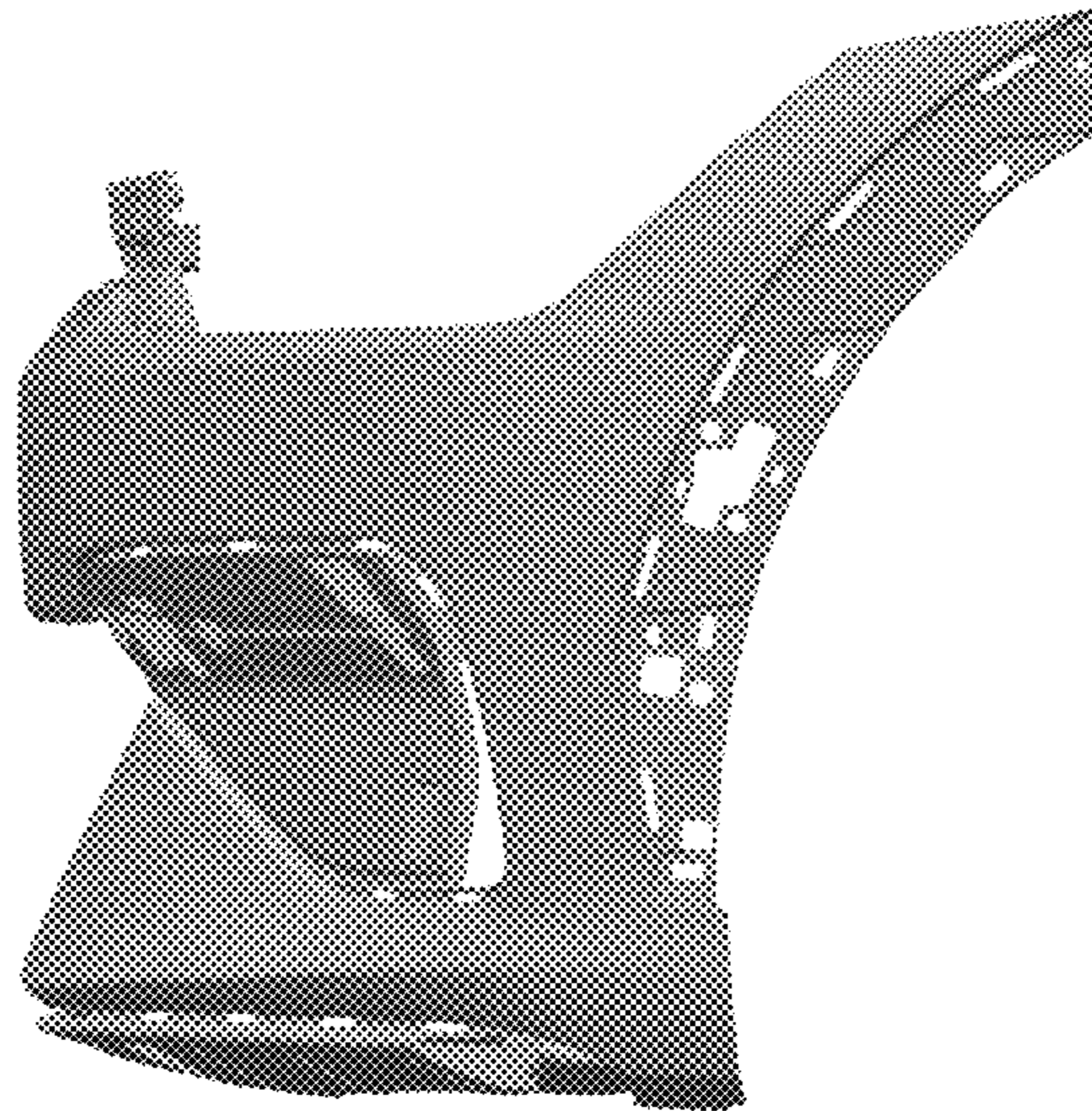

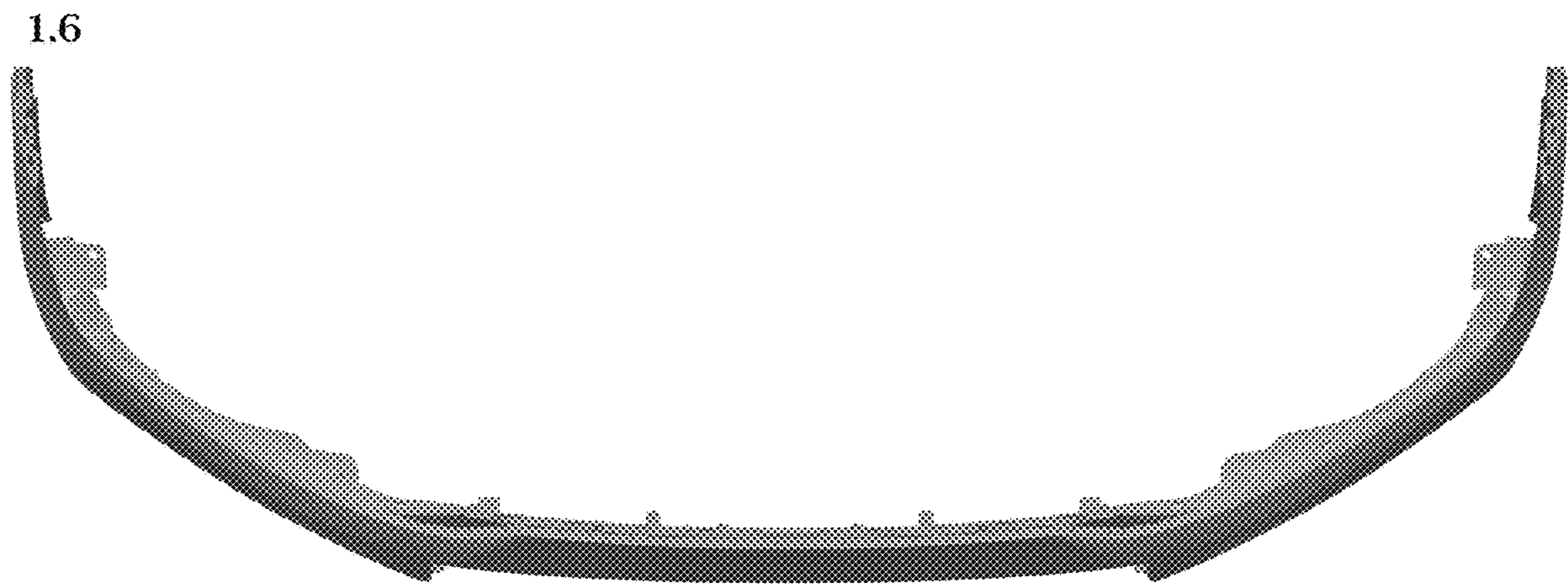
