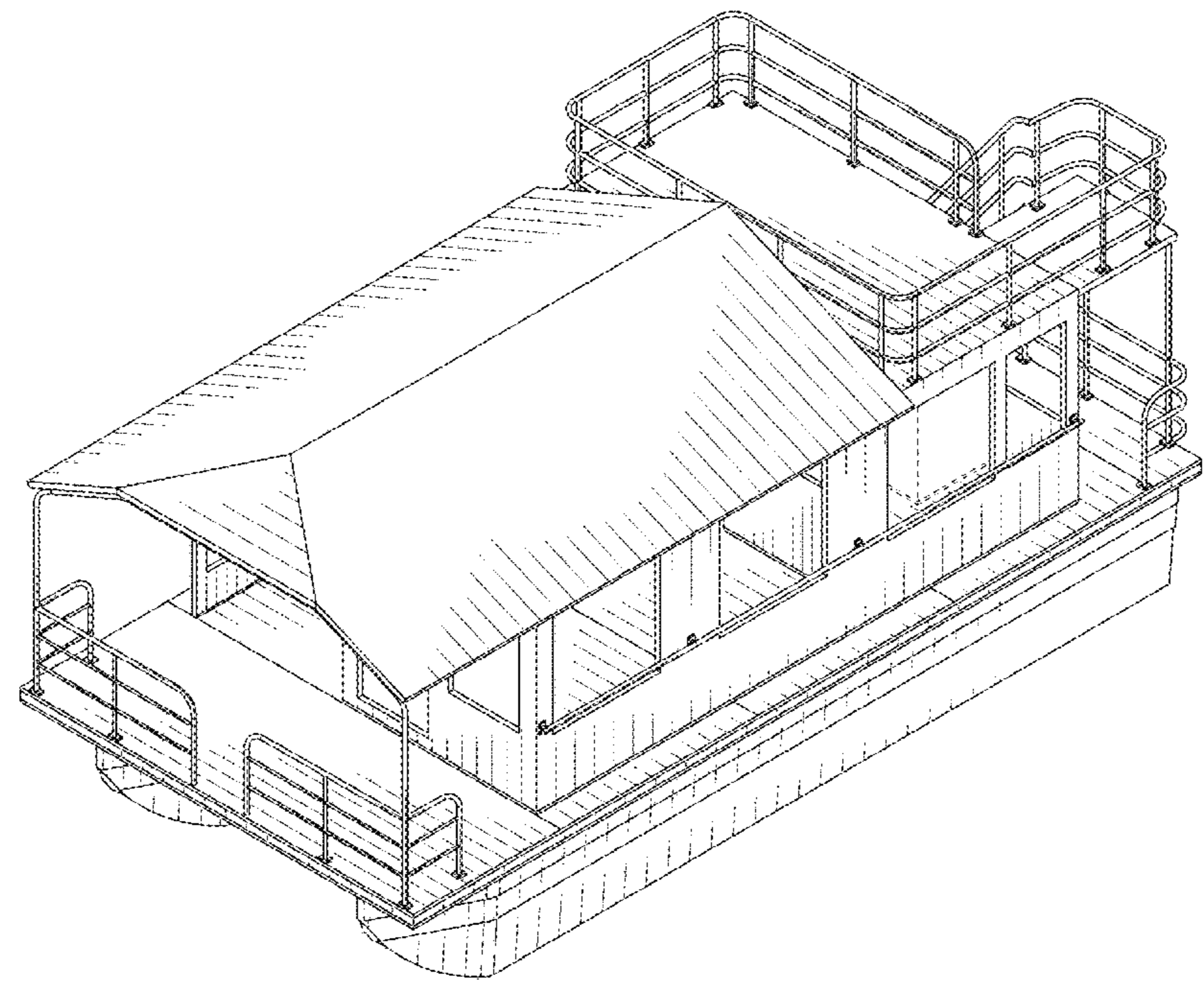

**DESCRIPTION**

FIG. 1 is a top front perspective view of the multi-level catamaran, showing the new design;  
FIG. 2 is a bottom front perspective view of the multi-level catamaran thereof;  
FIG. 3 is a front elevational view of the multi-level catamaran thereof;

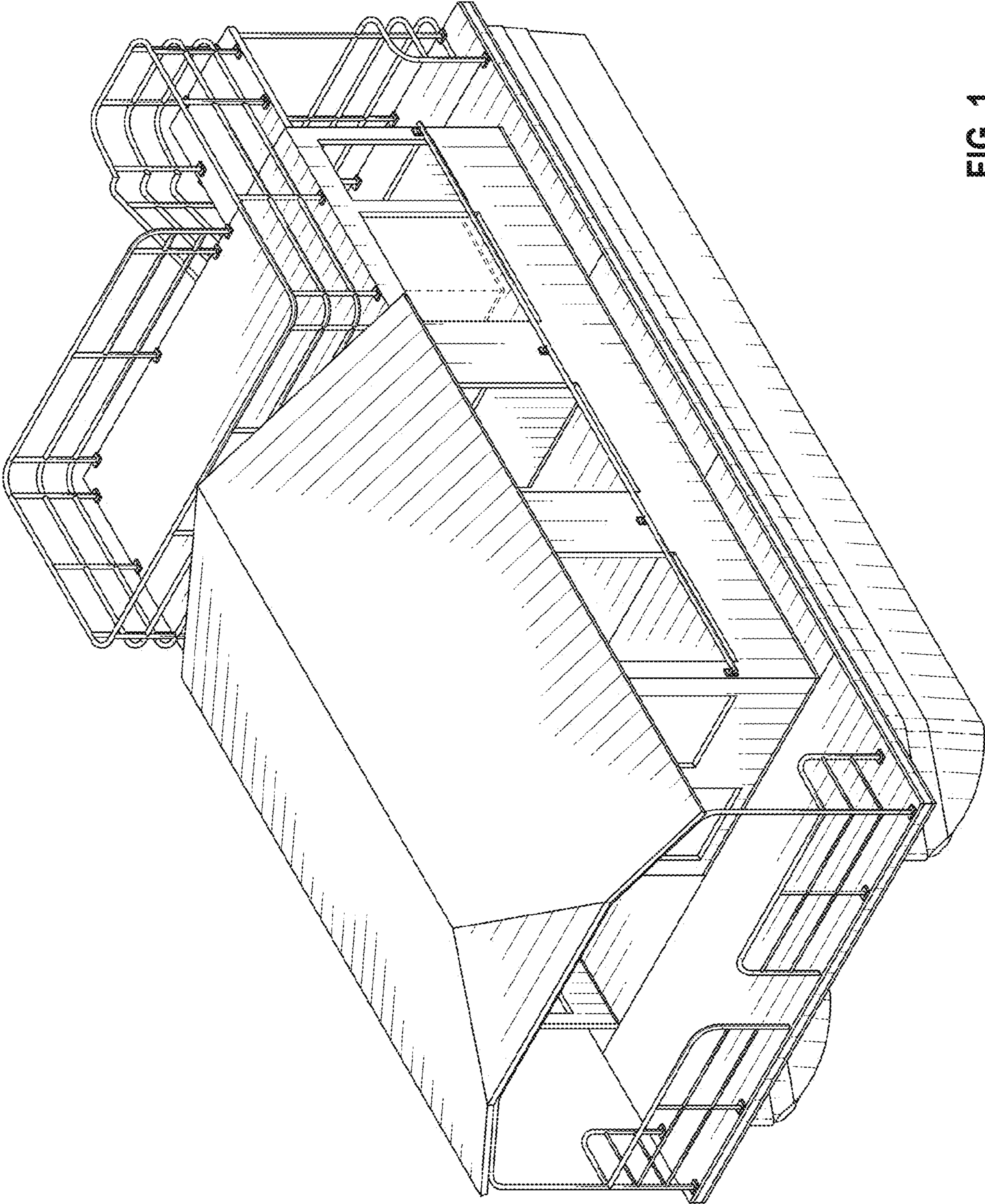

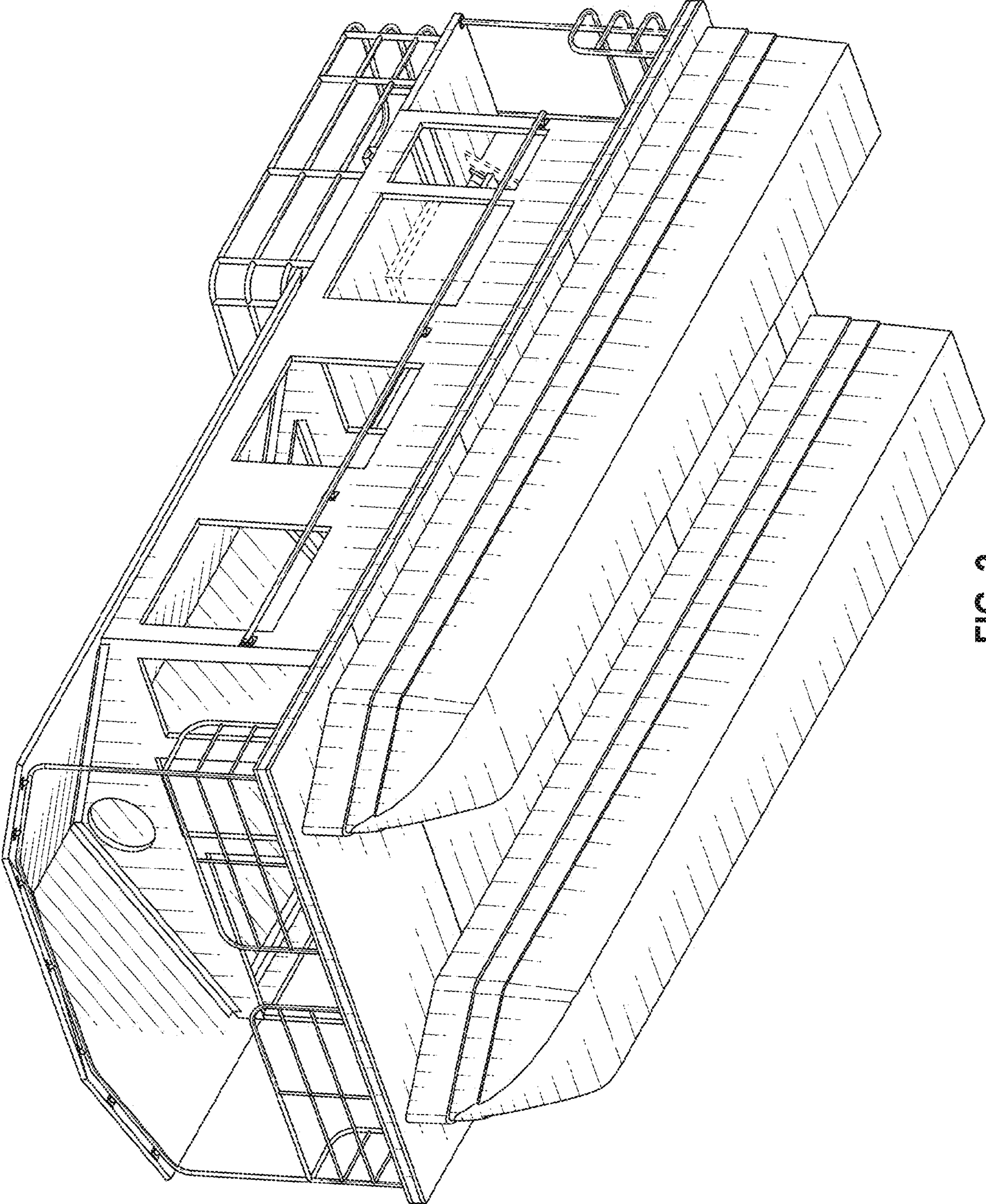

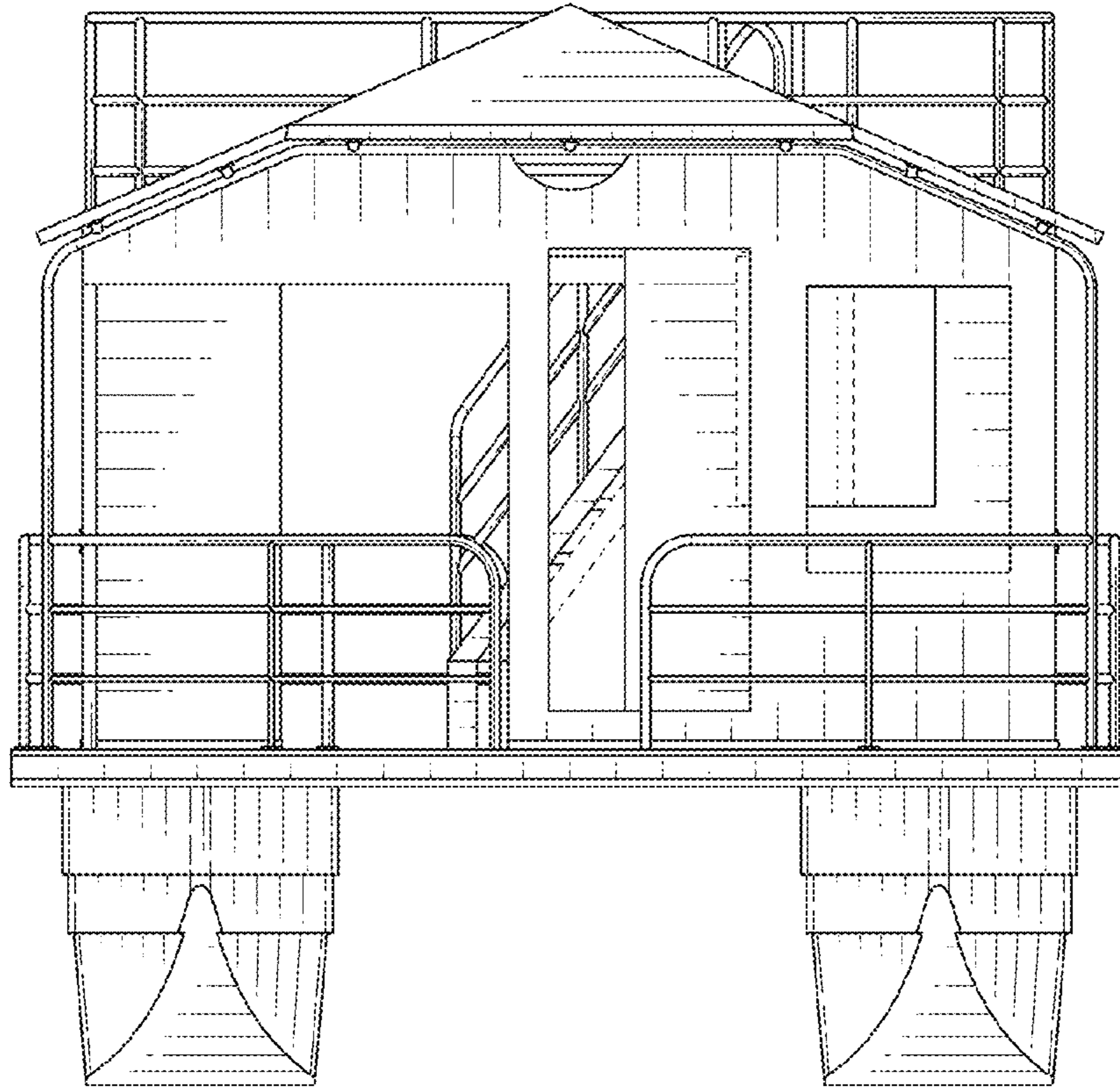

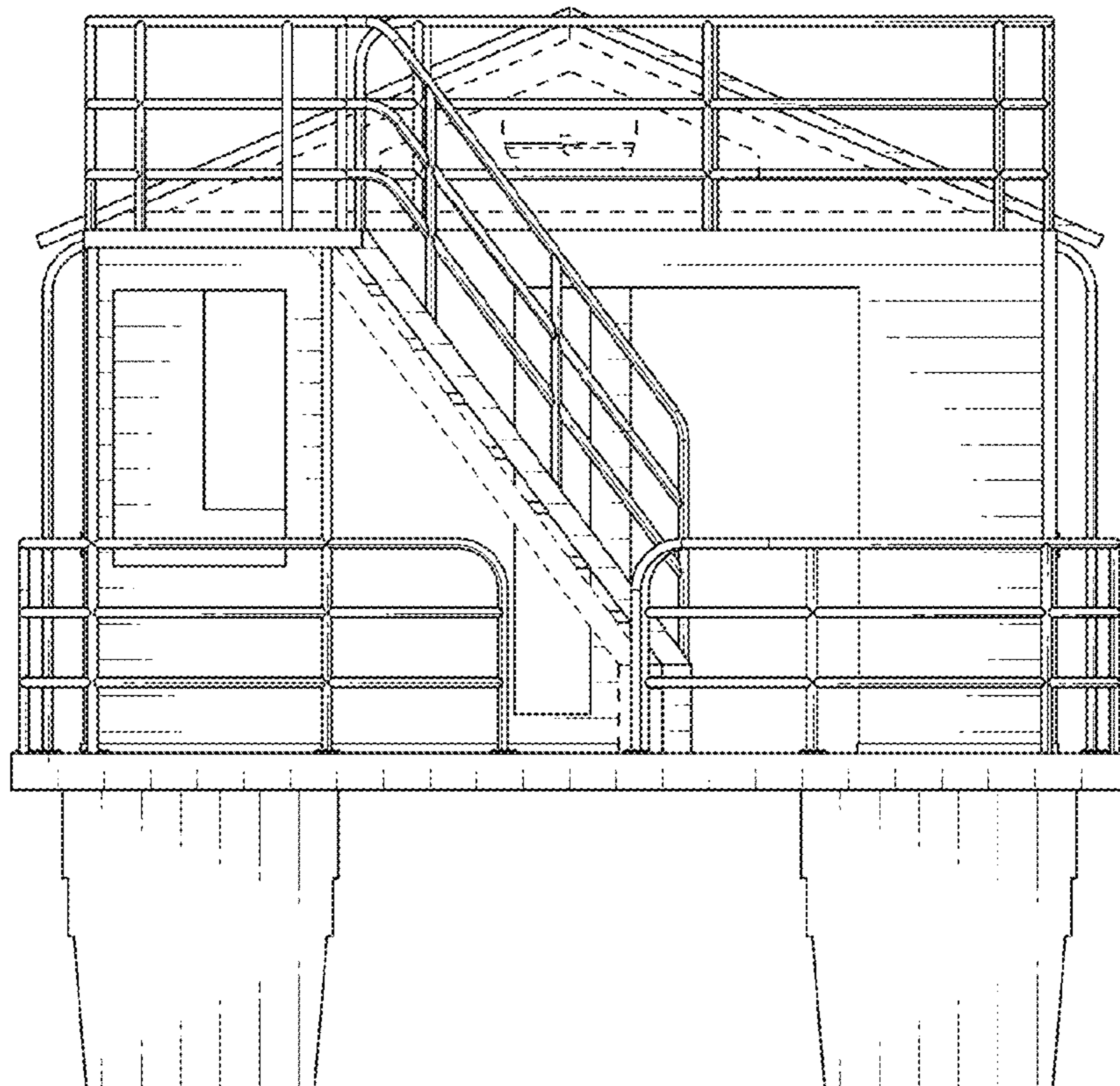

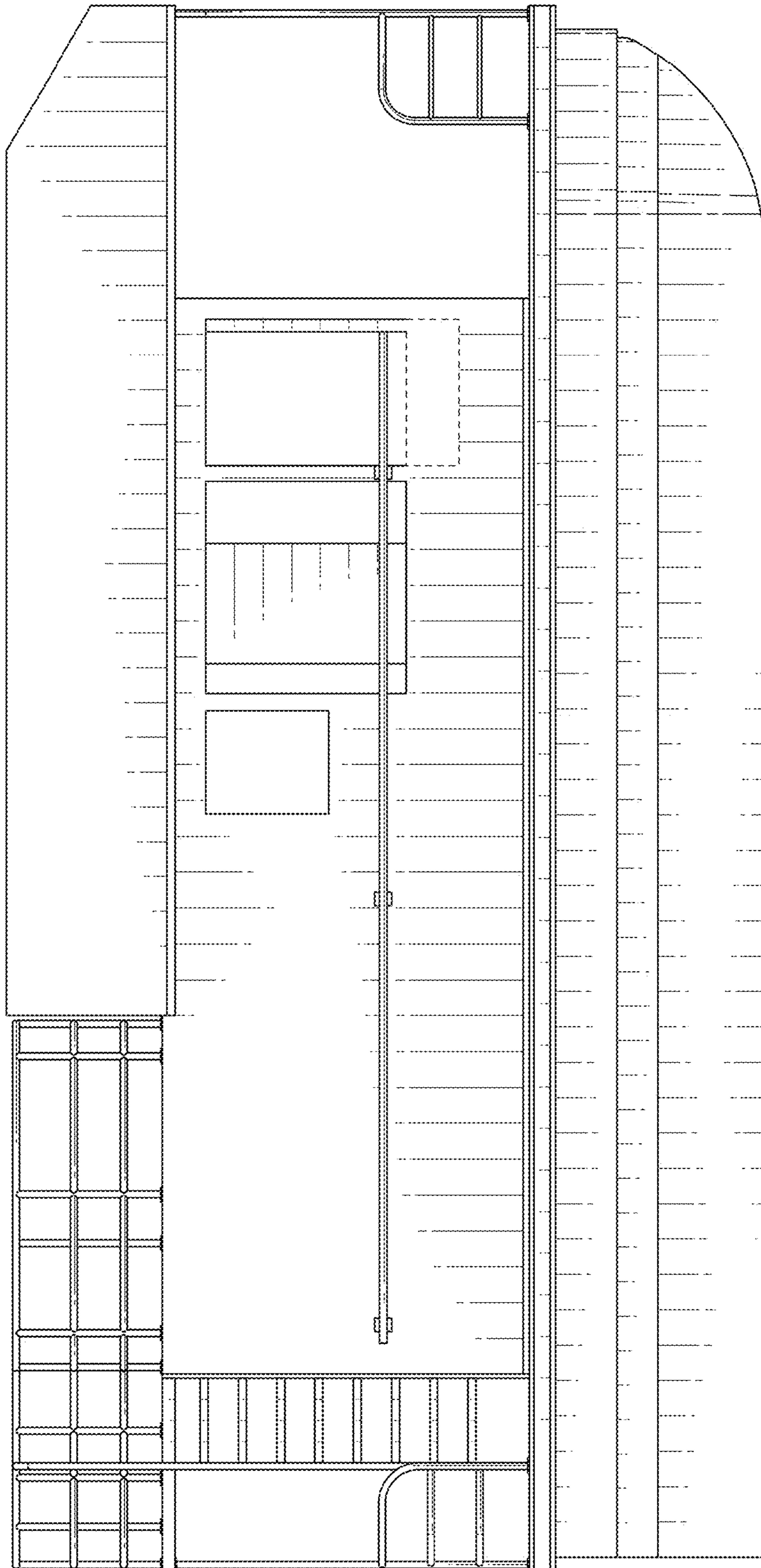

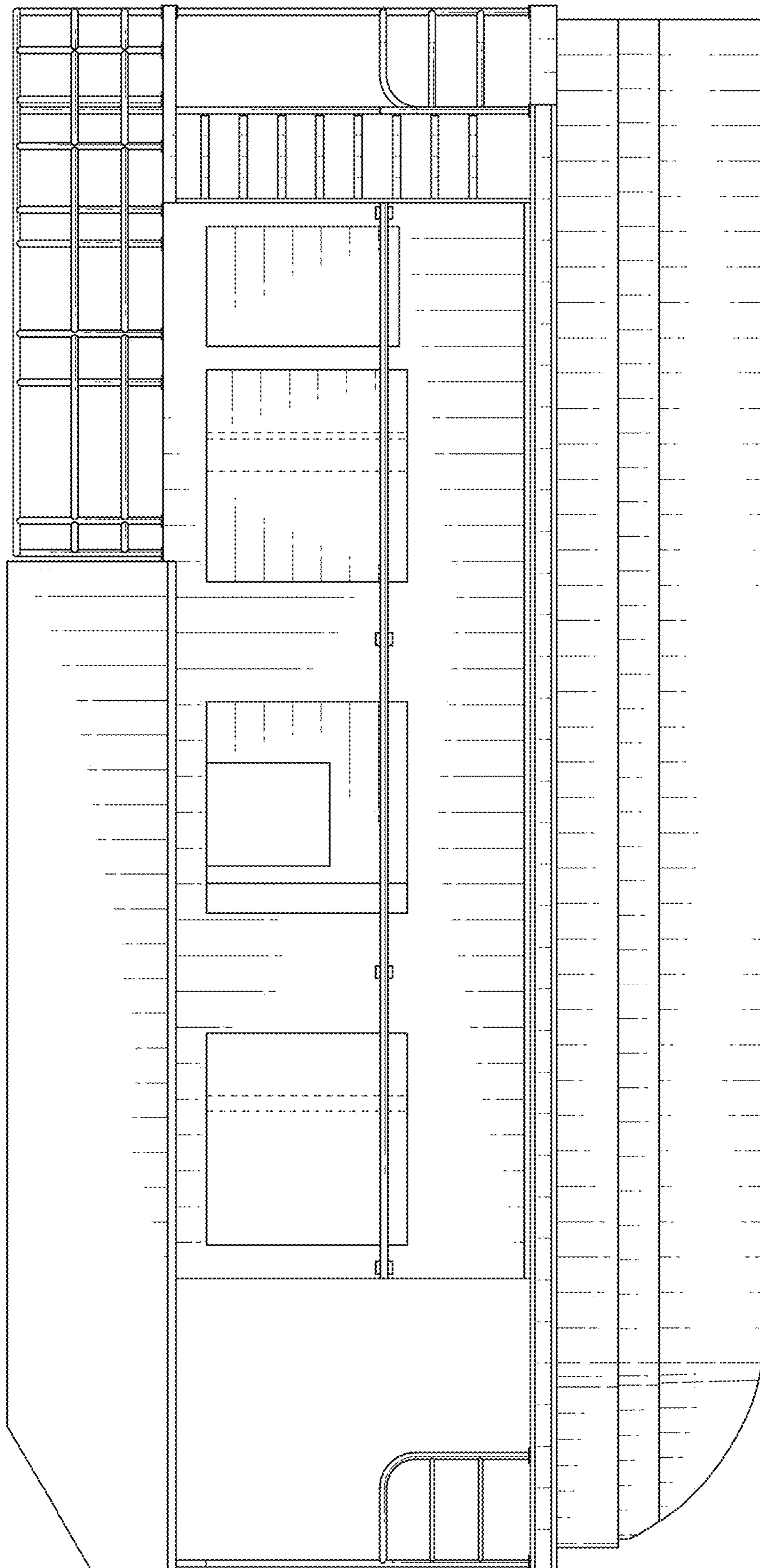

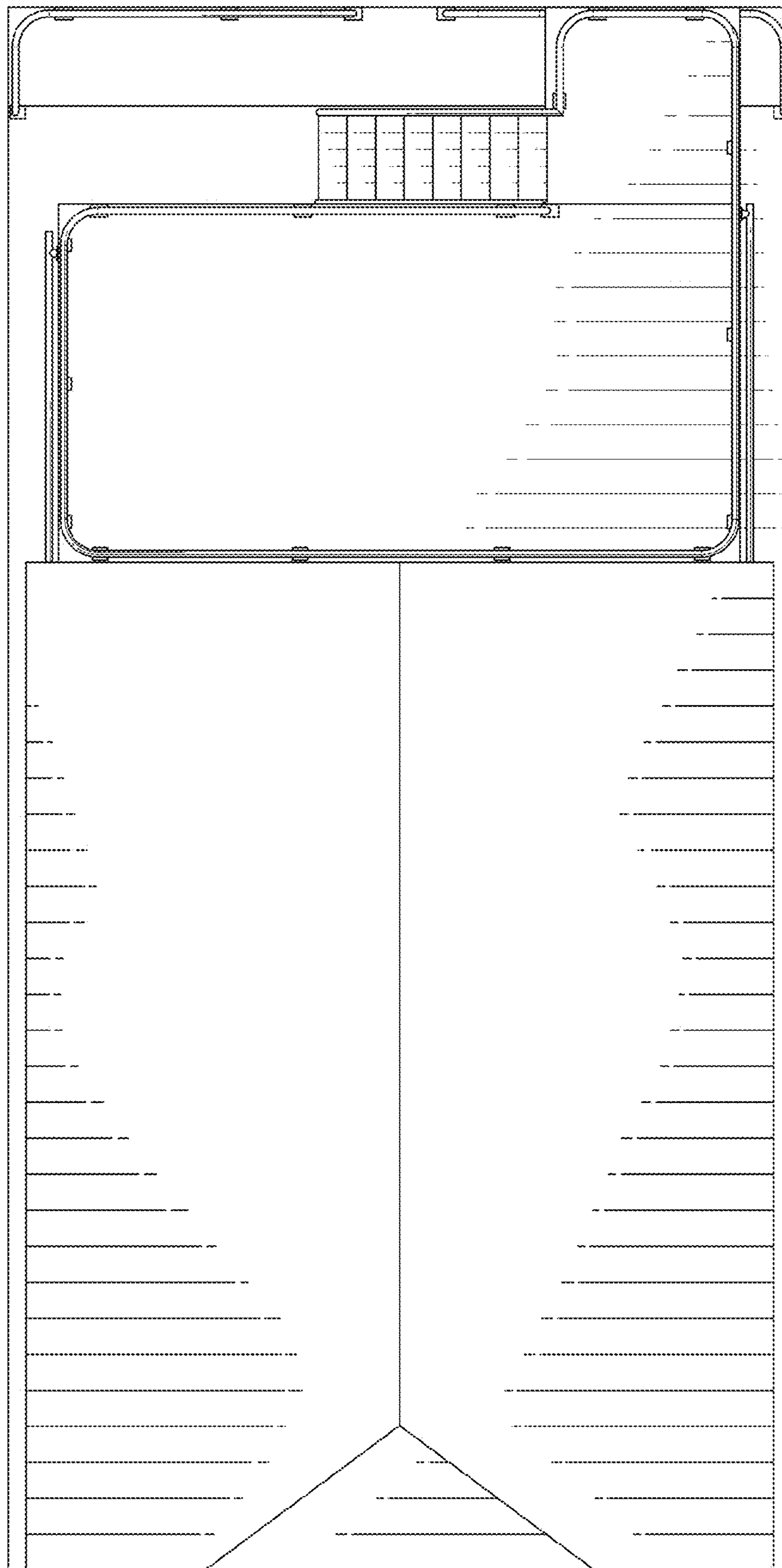

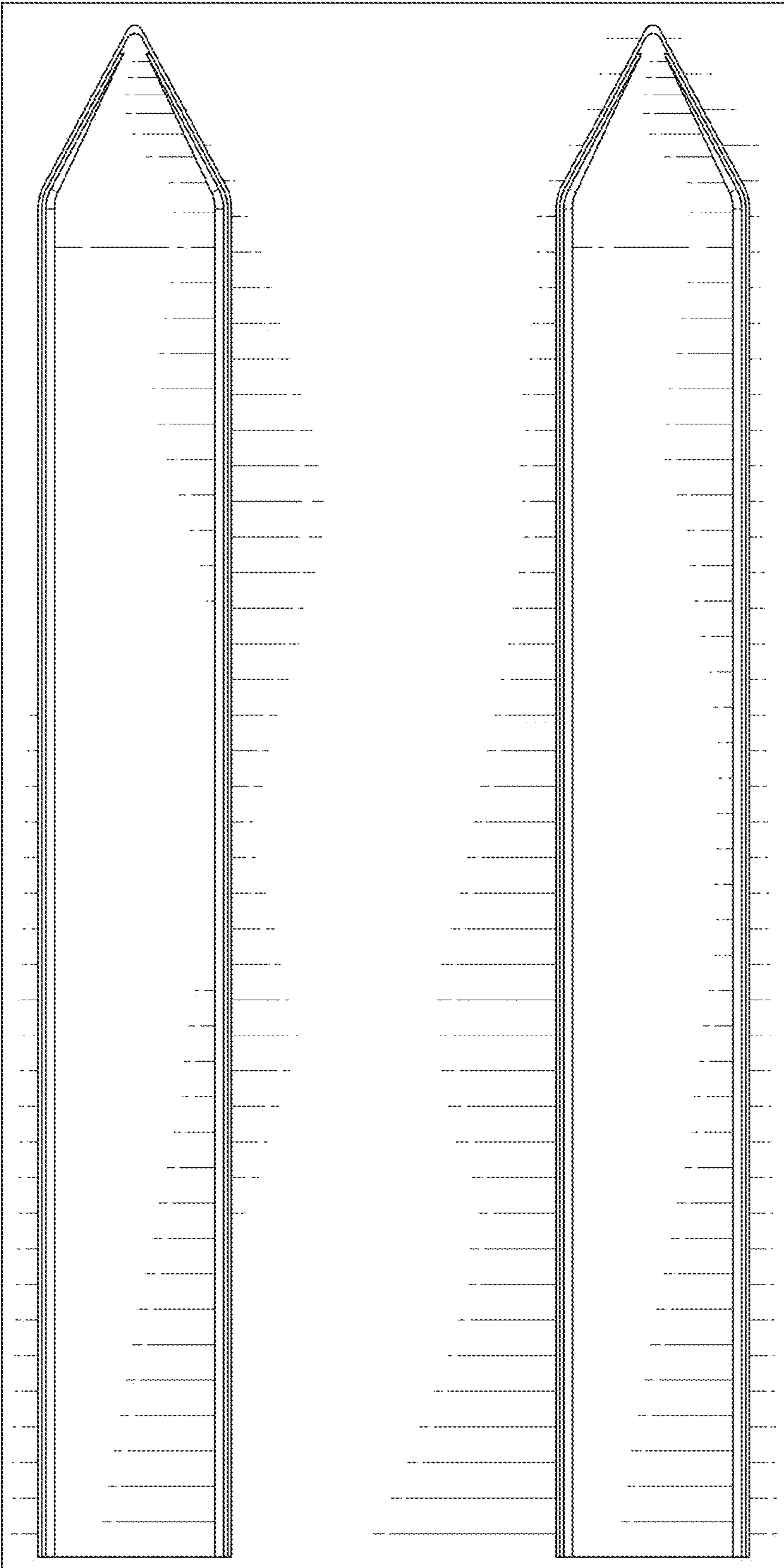
