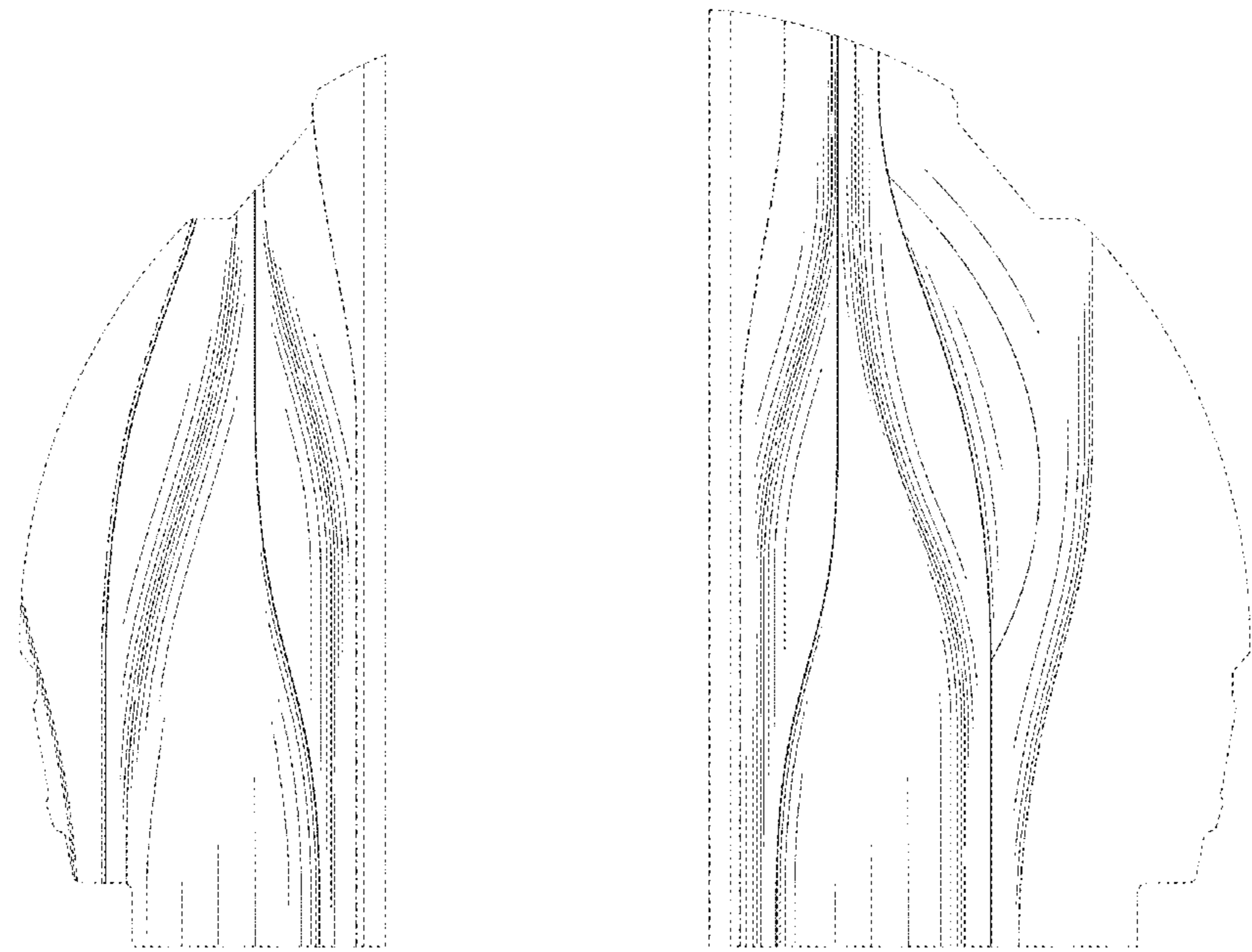
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a bulkhead for an aircraft showing our new design;
 FIG. 2 is a front view thereof;

 FIG. 4 is a first side view thereof;
 FIG. 5 is a second side view thereof;
 FIG. 6 is a top view thereof; and,

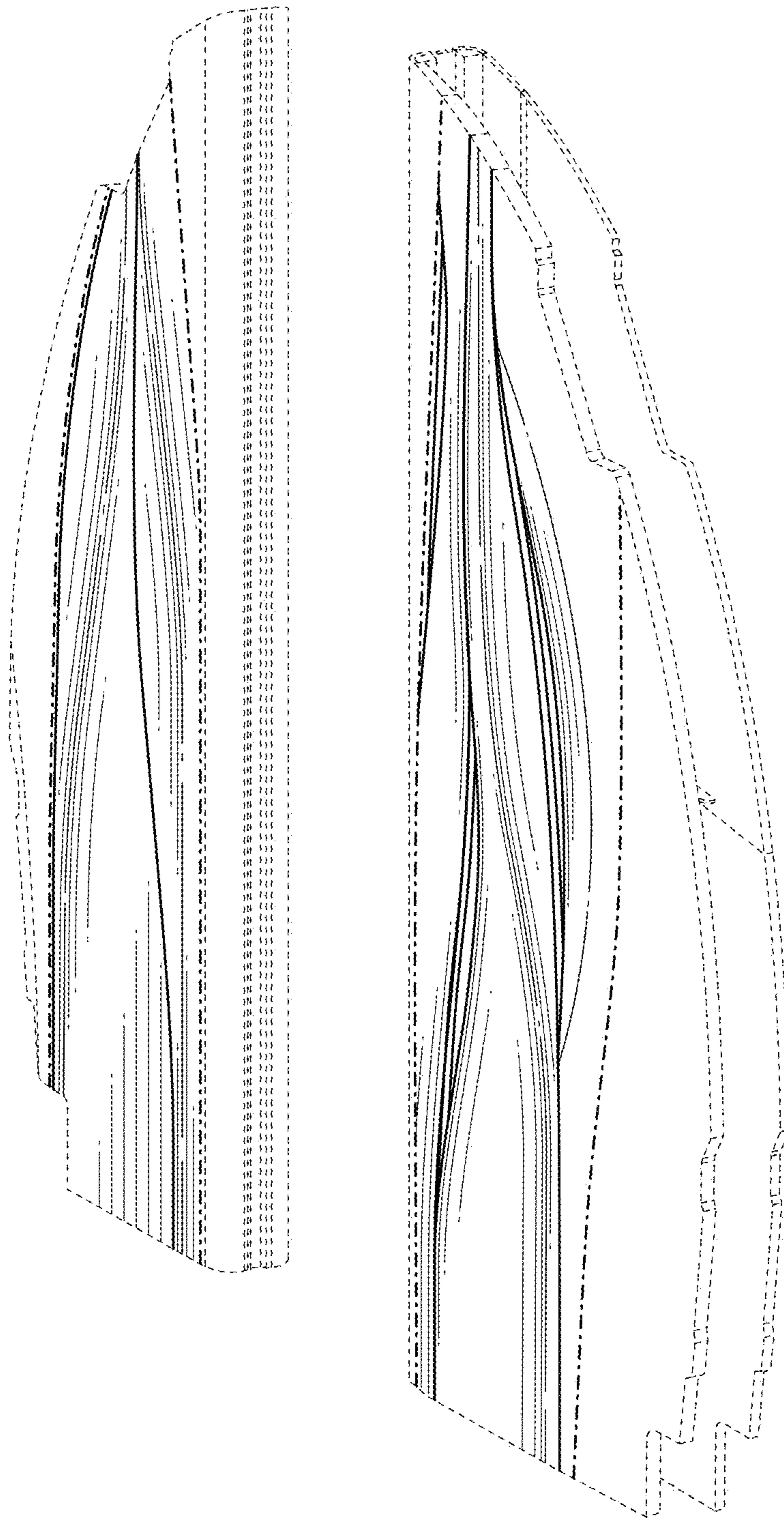

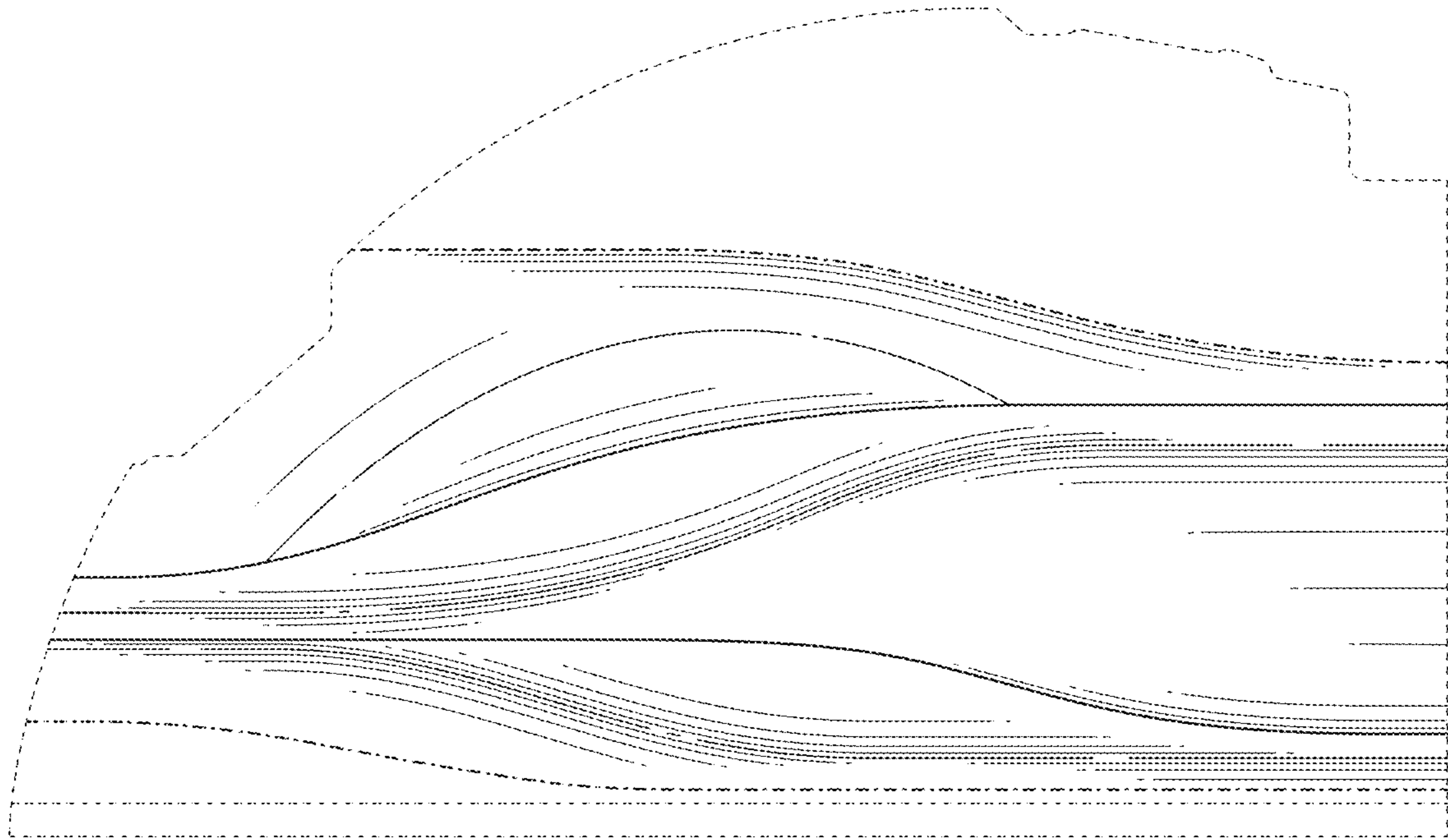
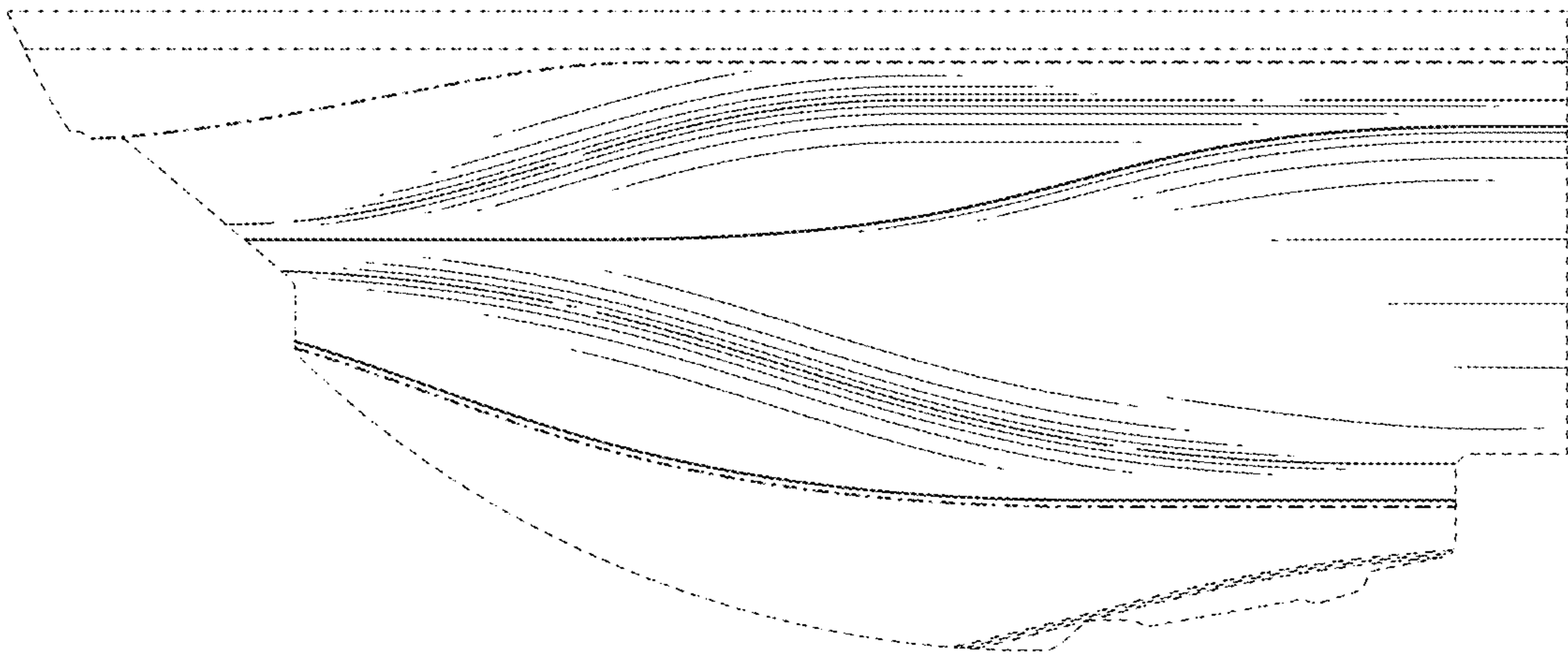

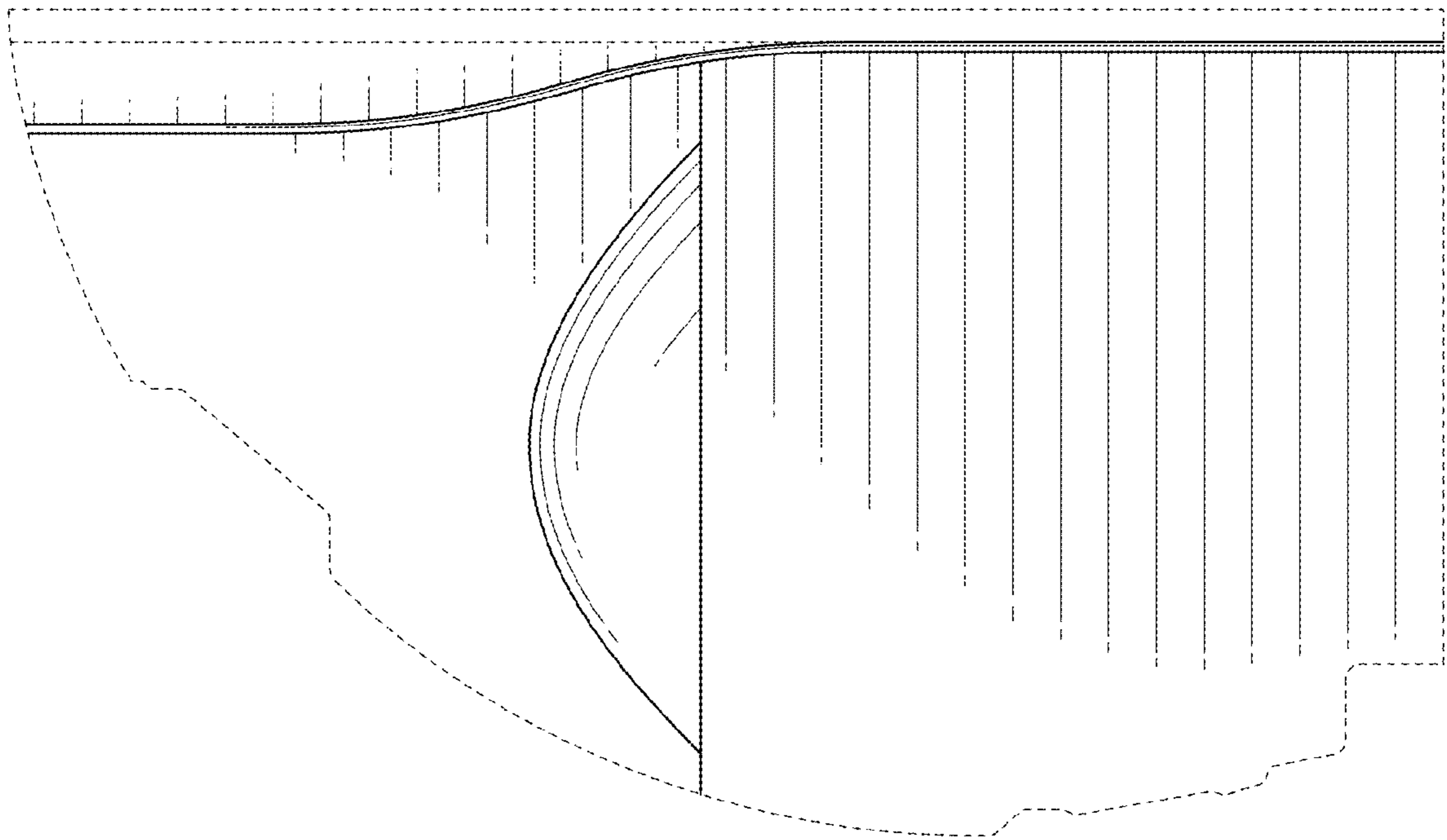
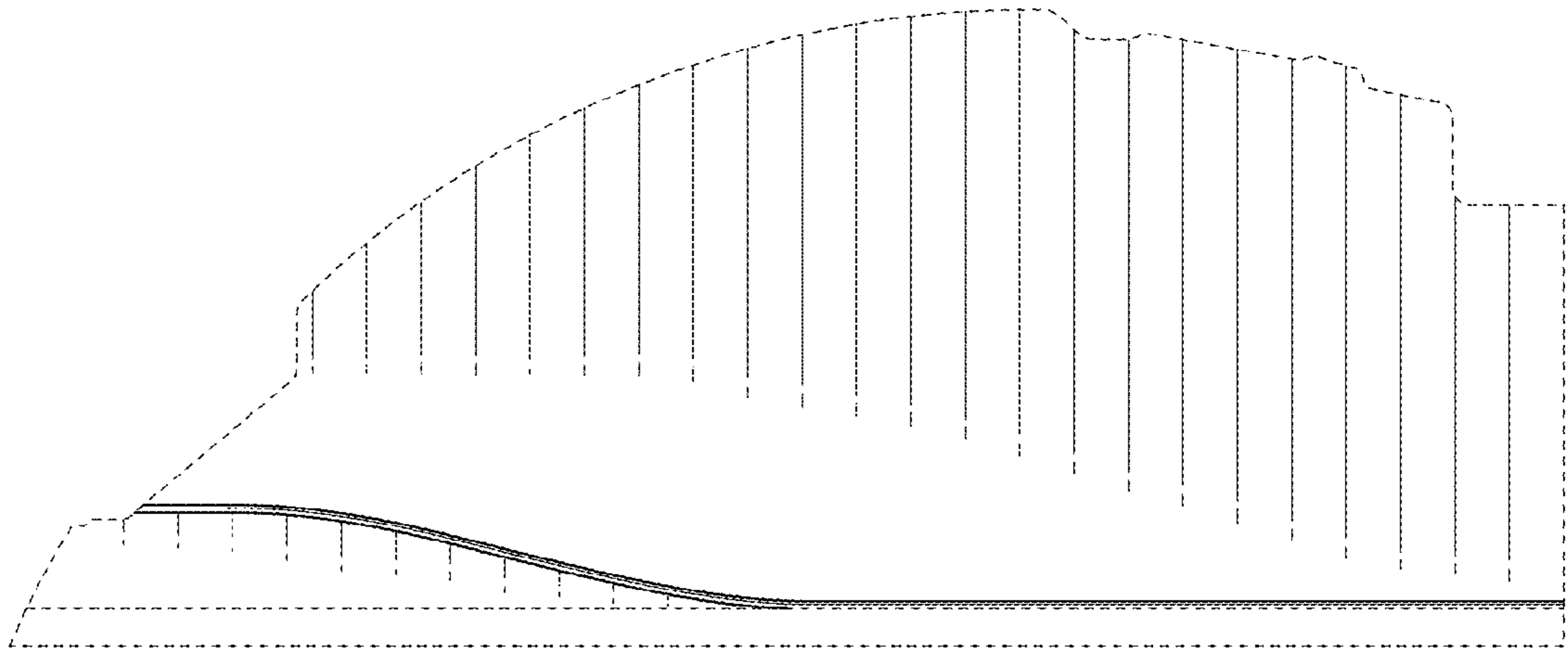

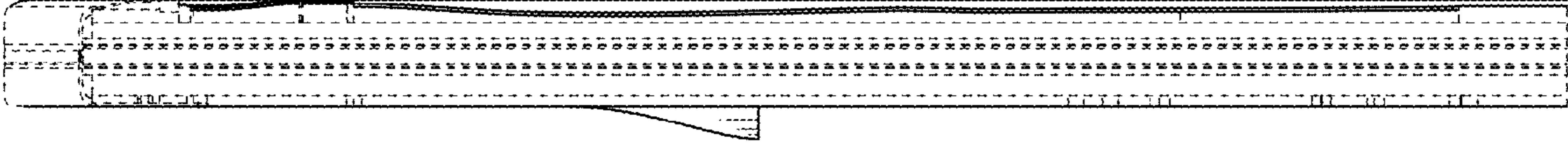

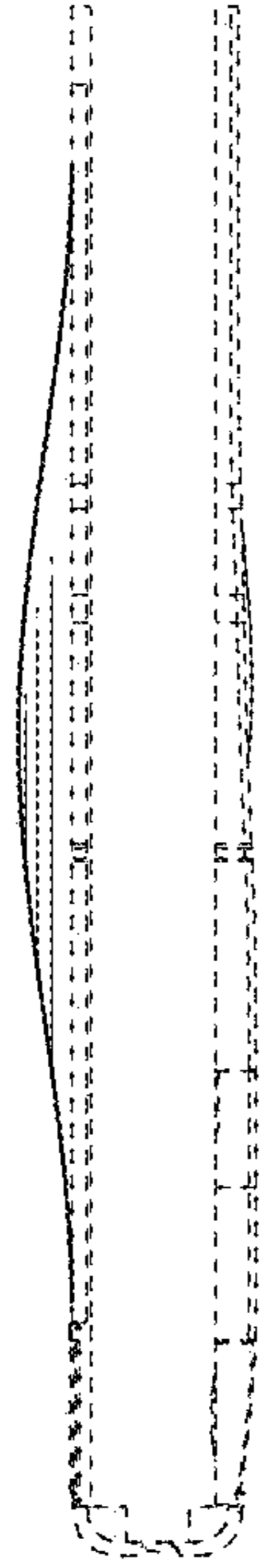

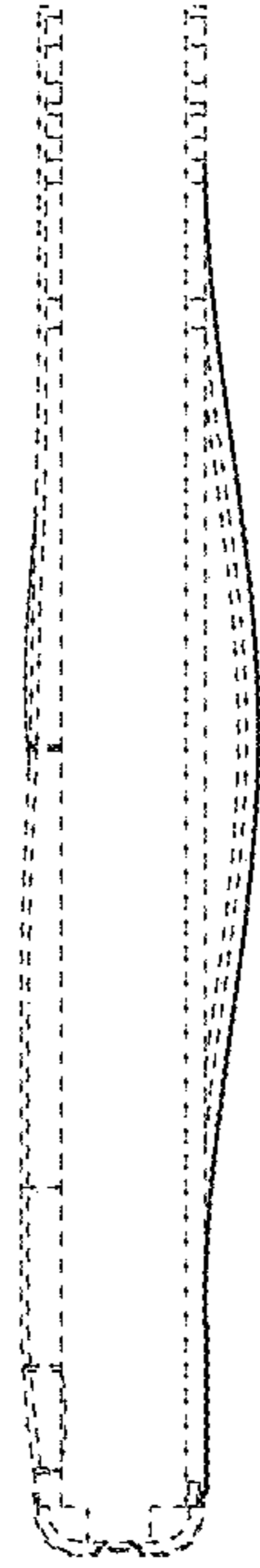
