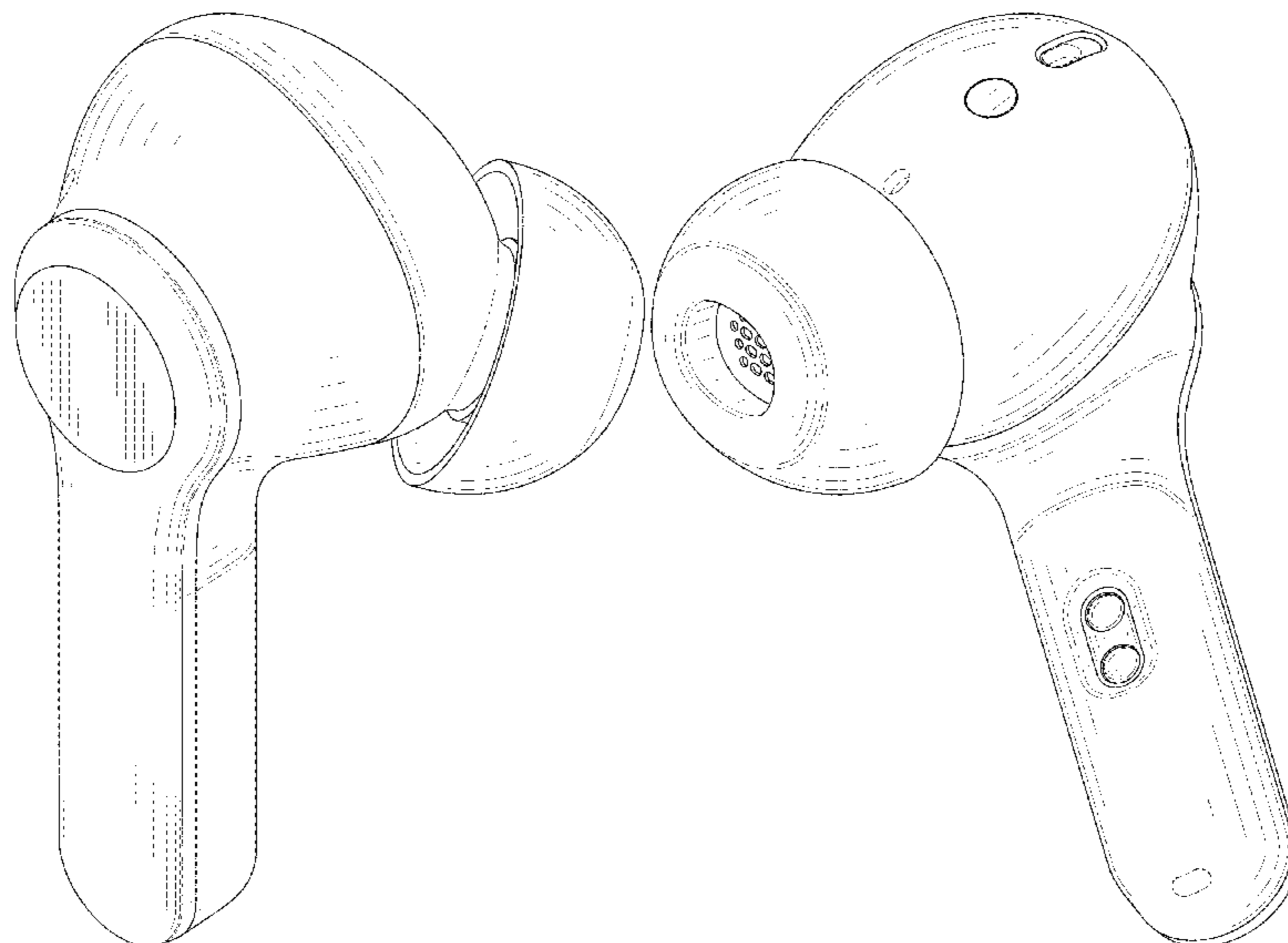
The ornamental design for a pair of earphones, as shown and described.

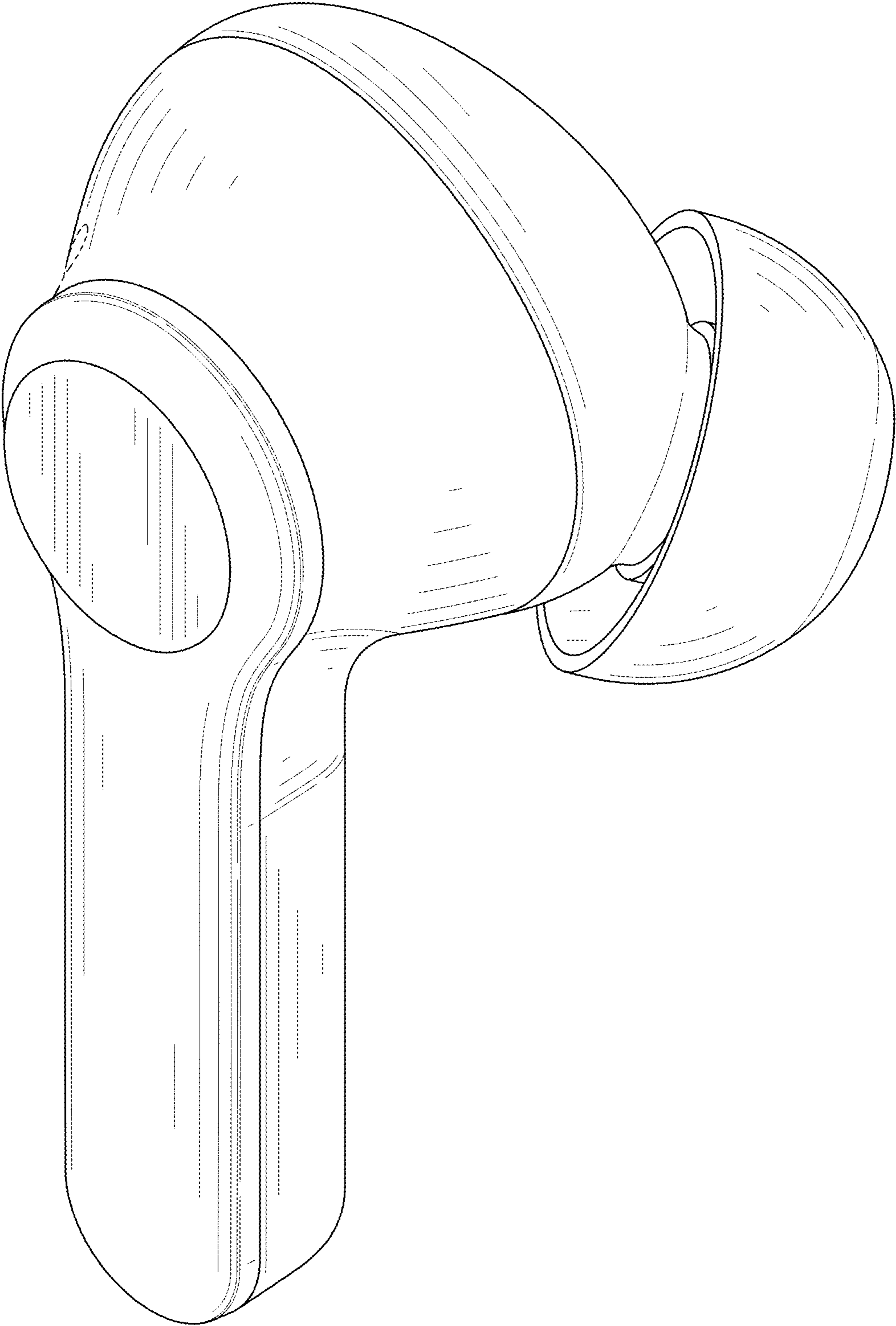

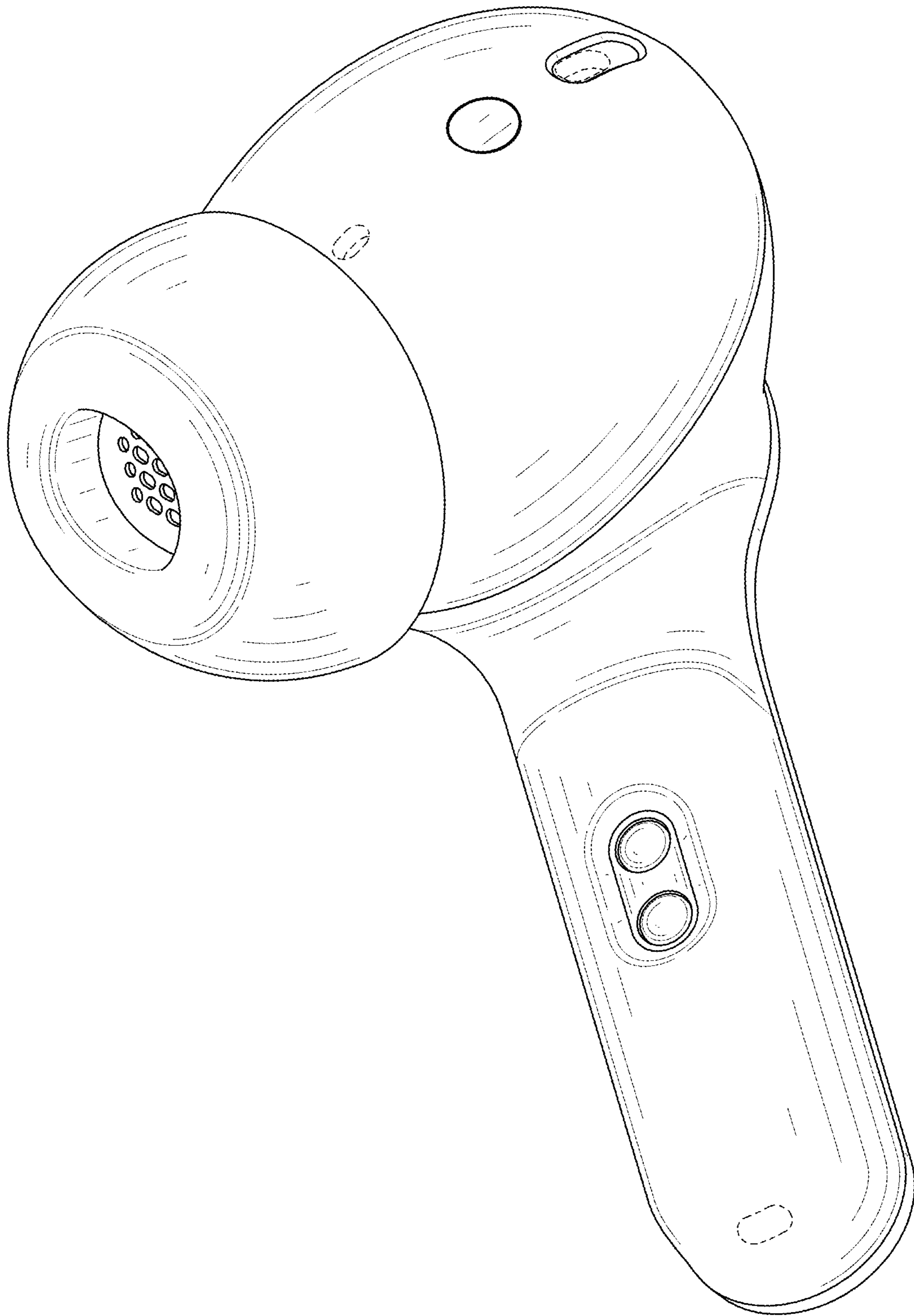

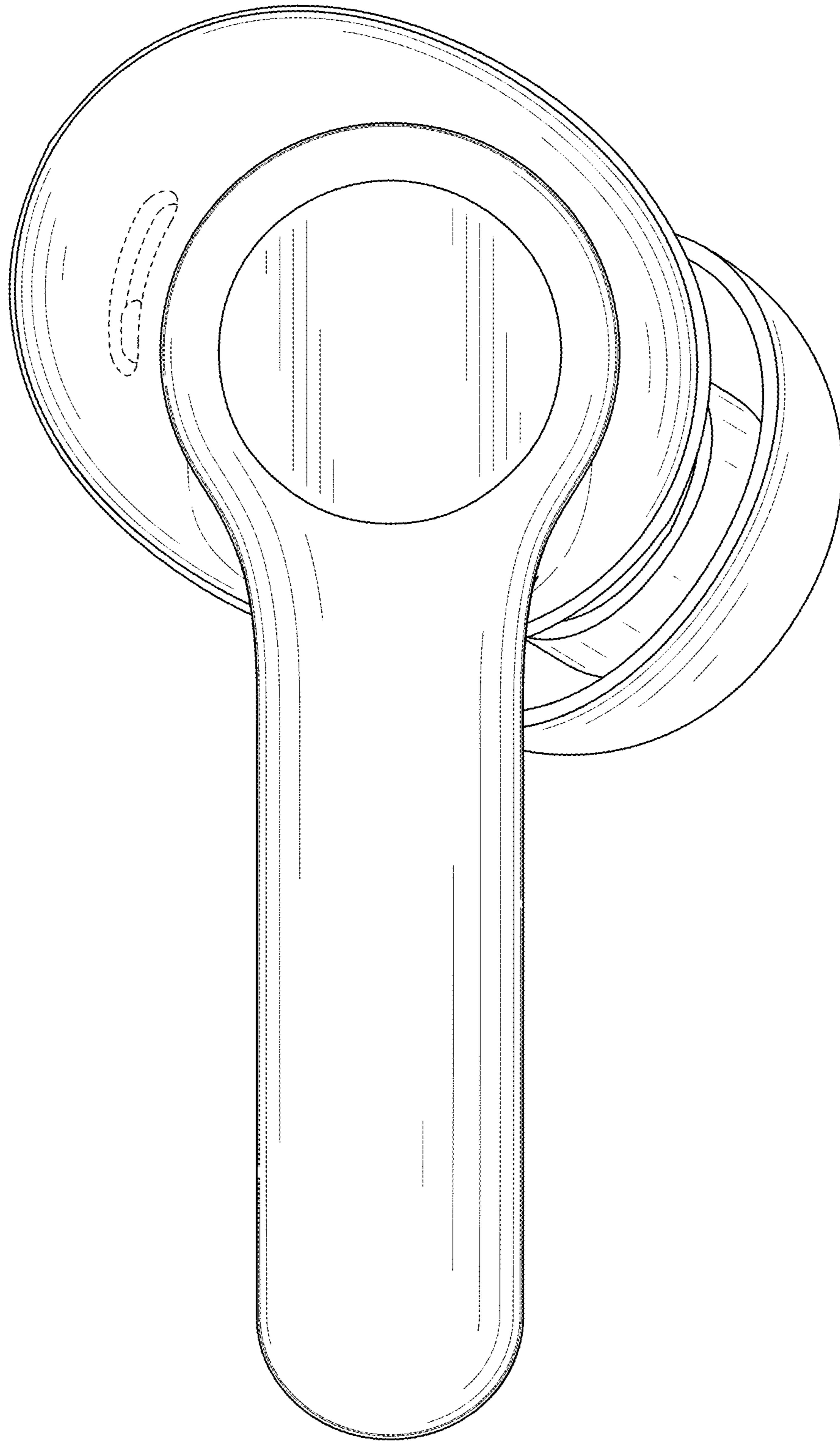

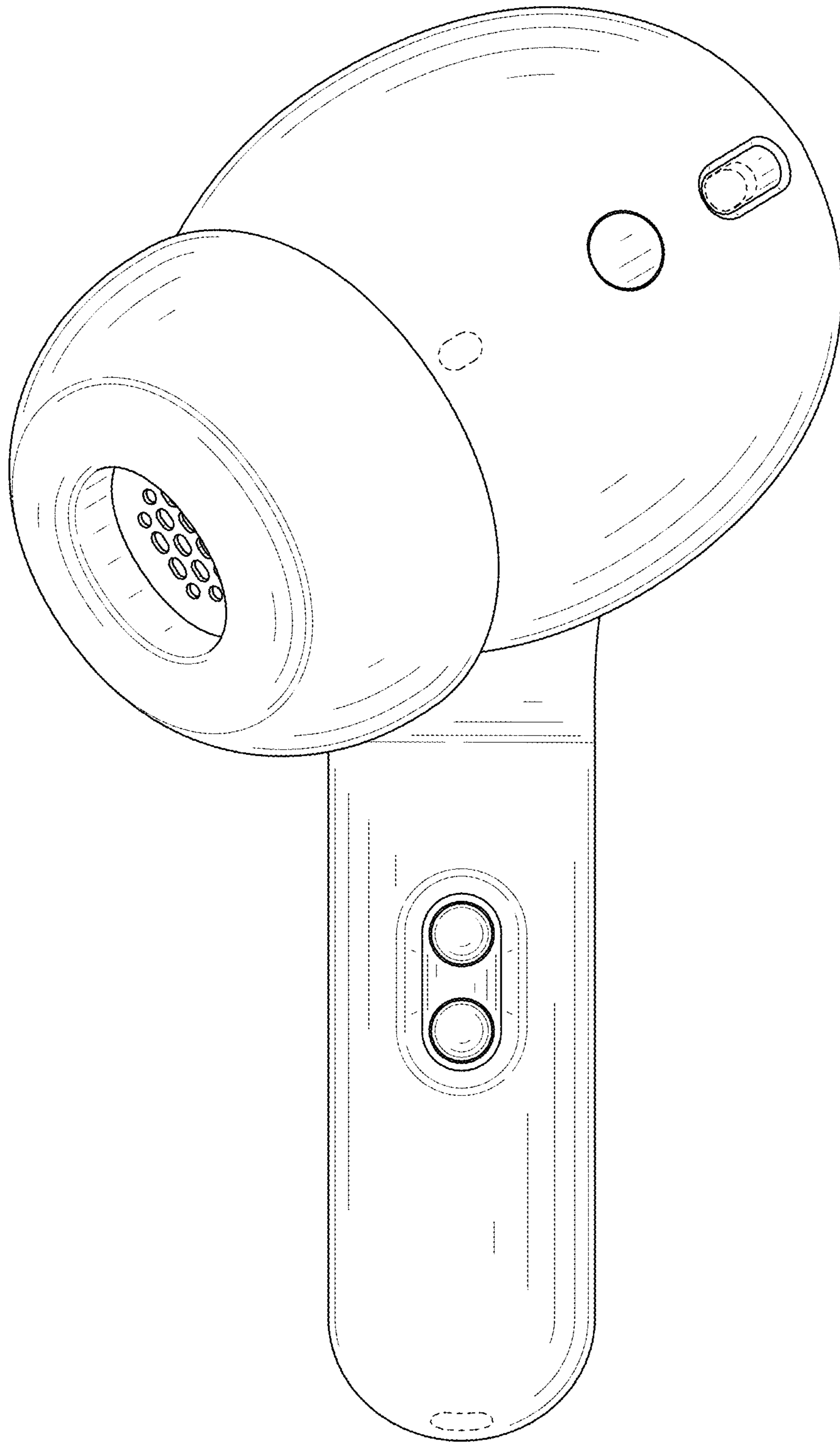

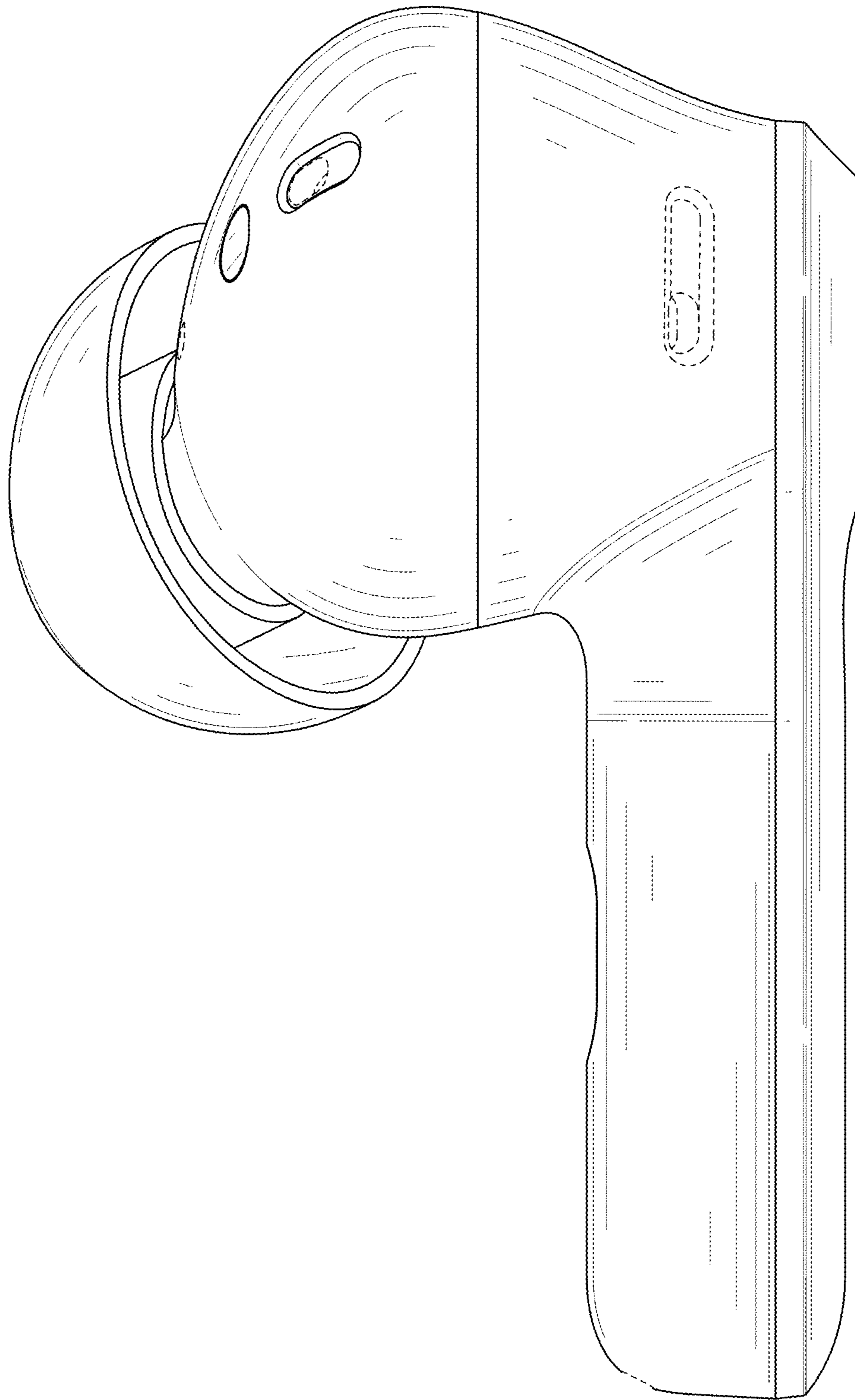

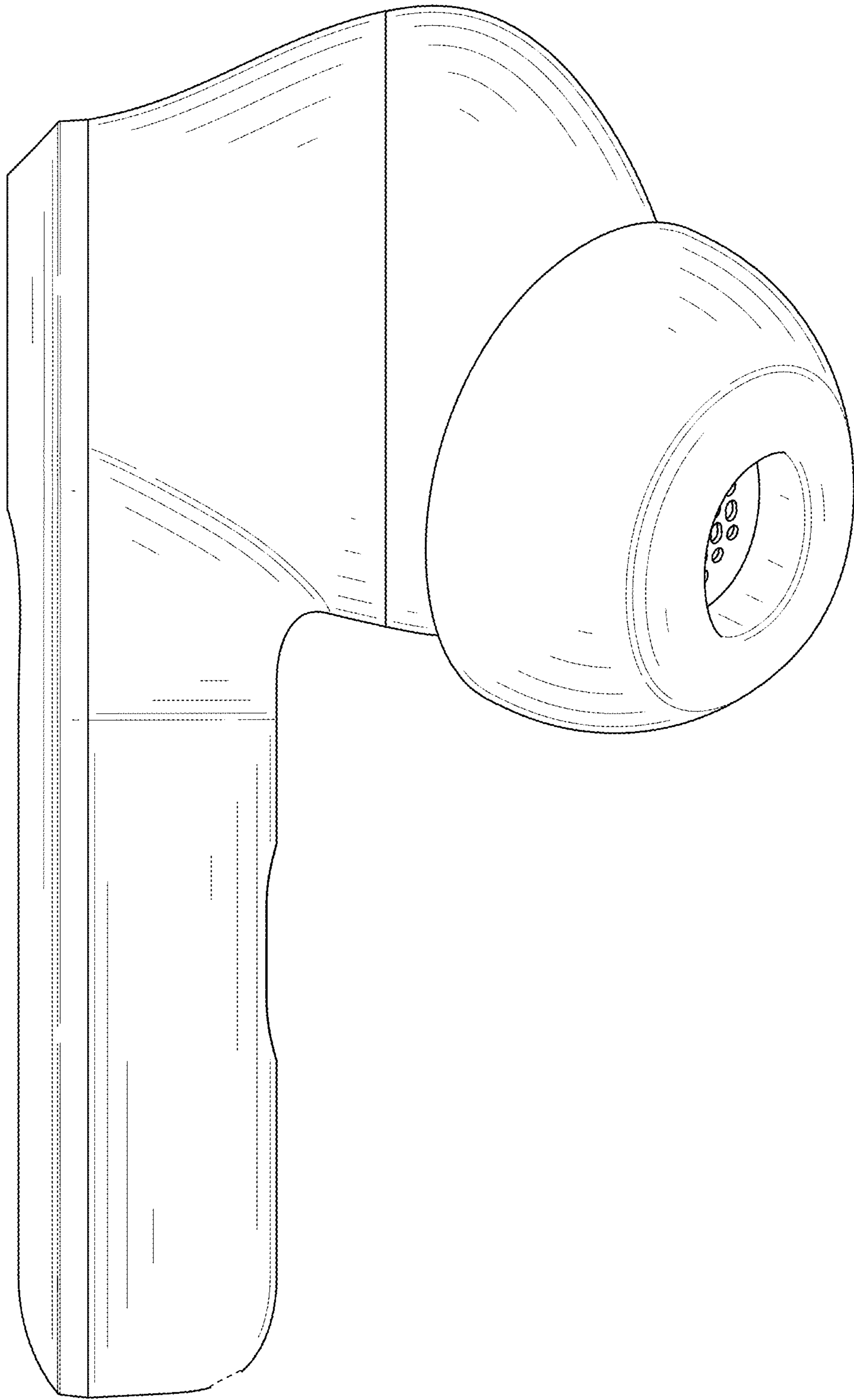

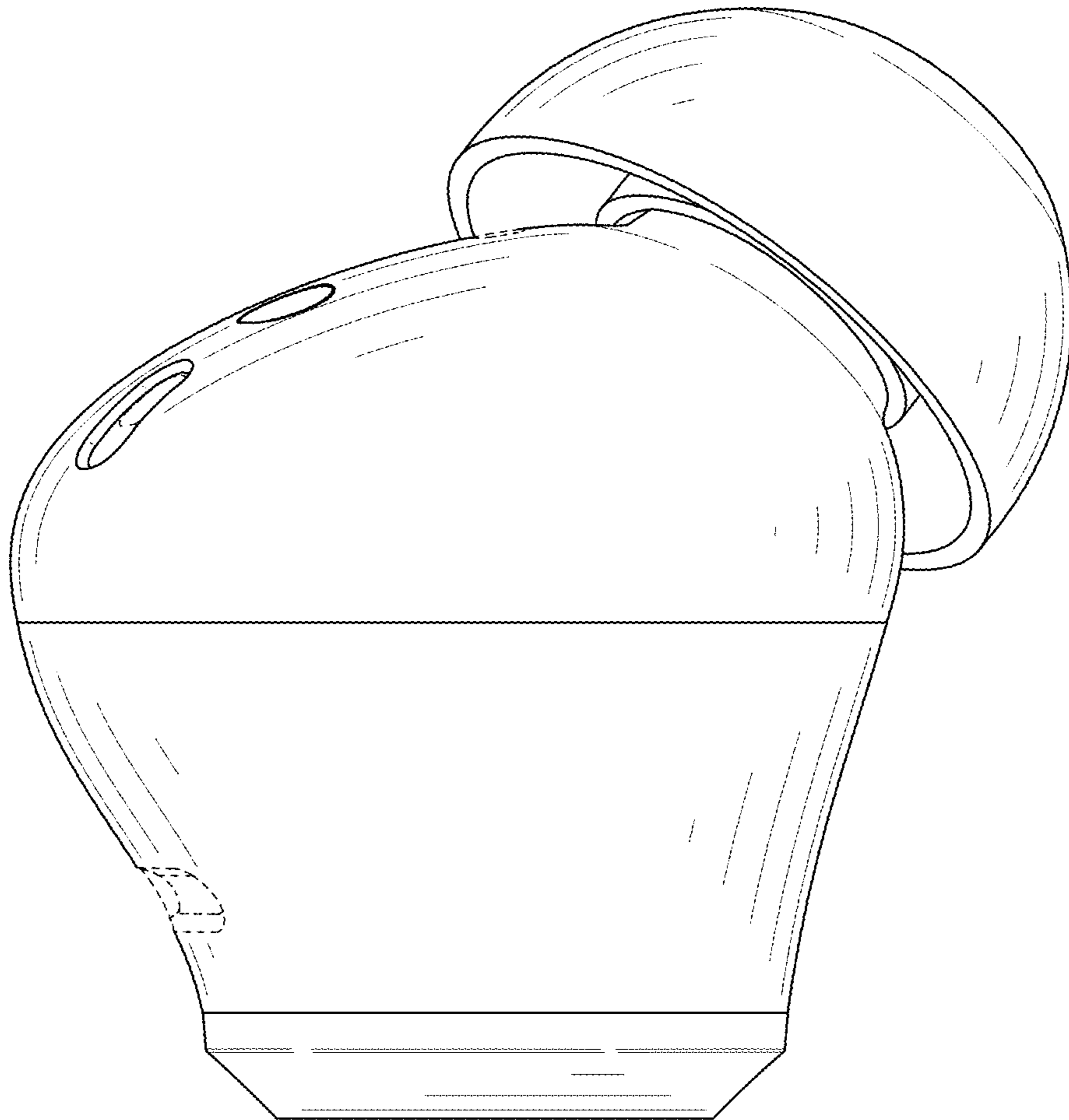

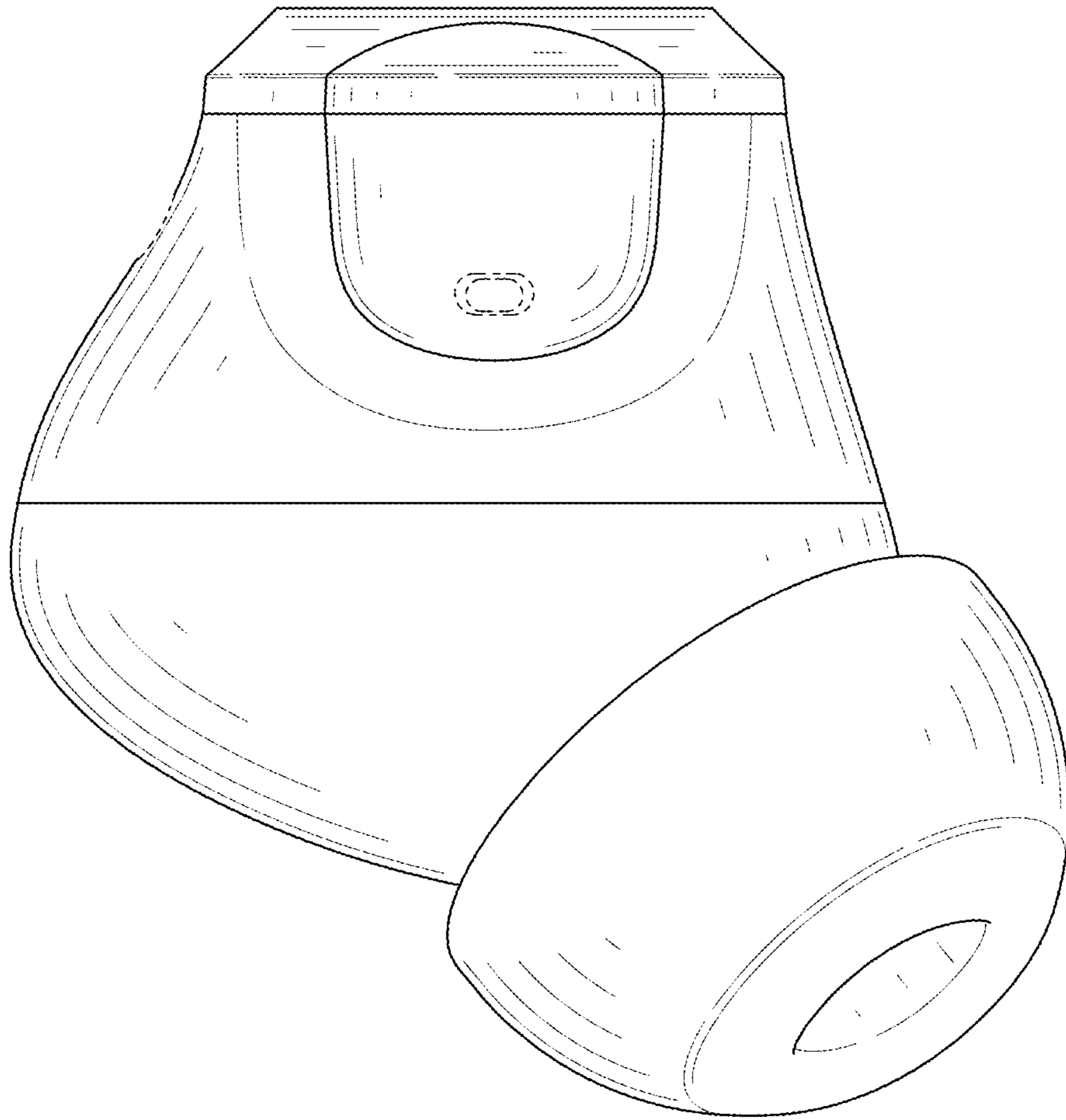

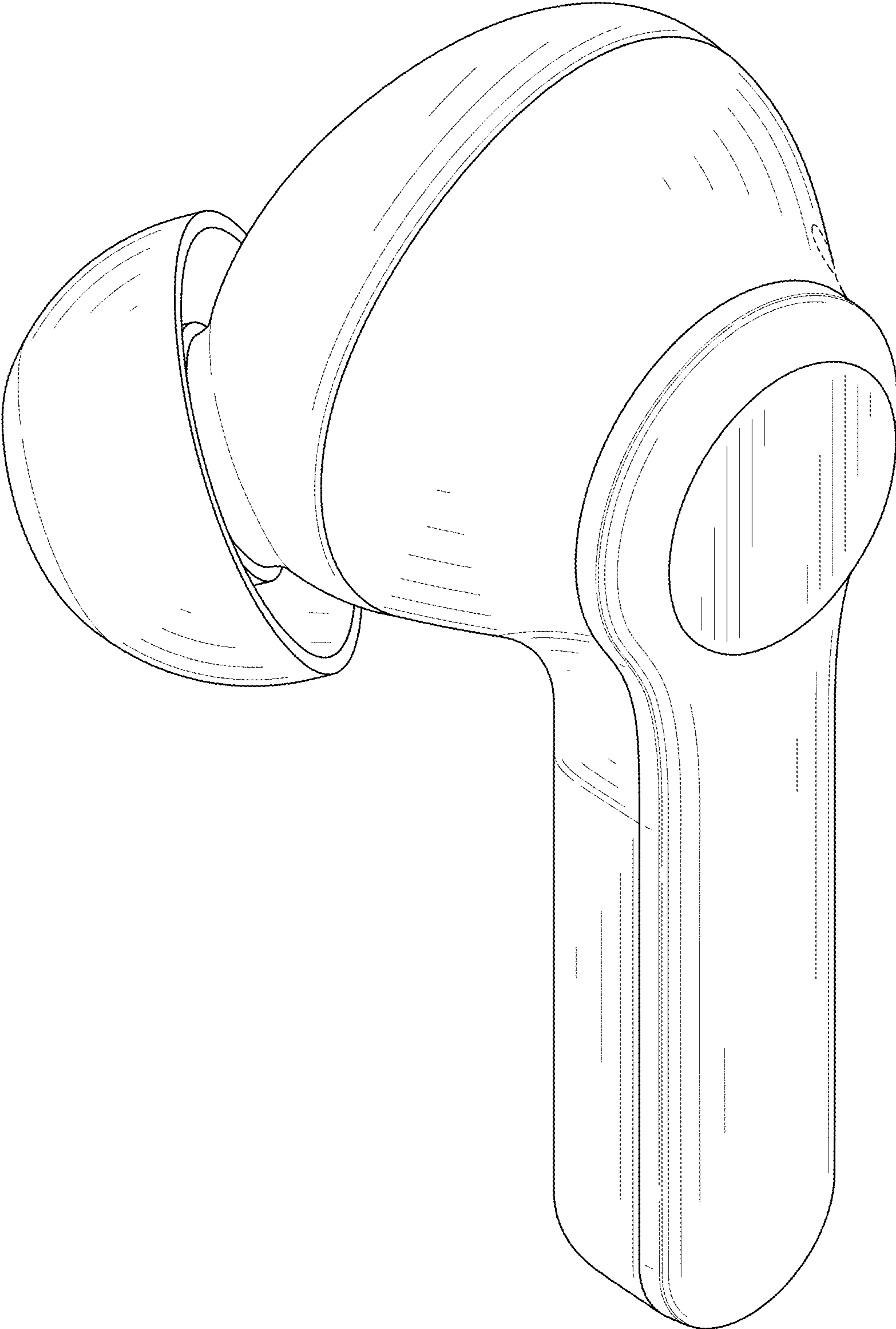

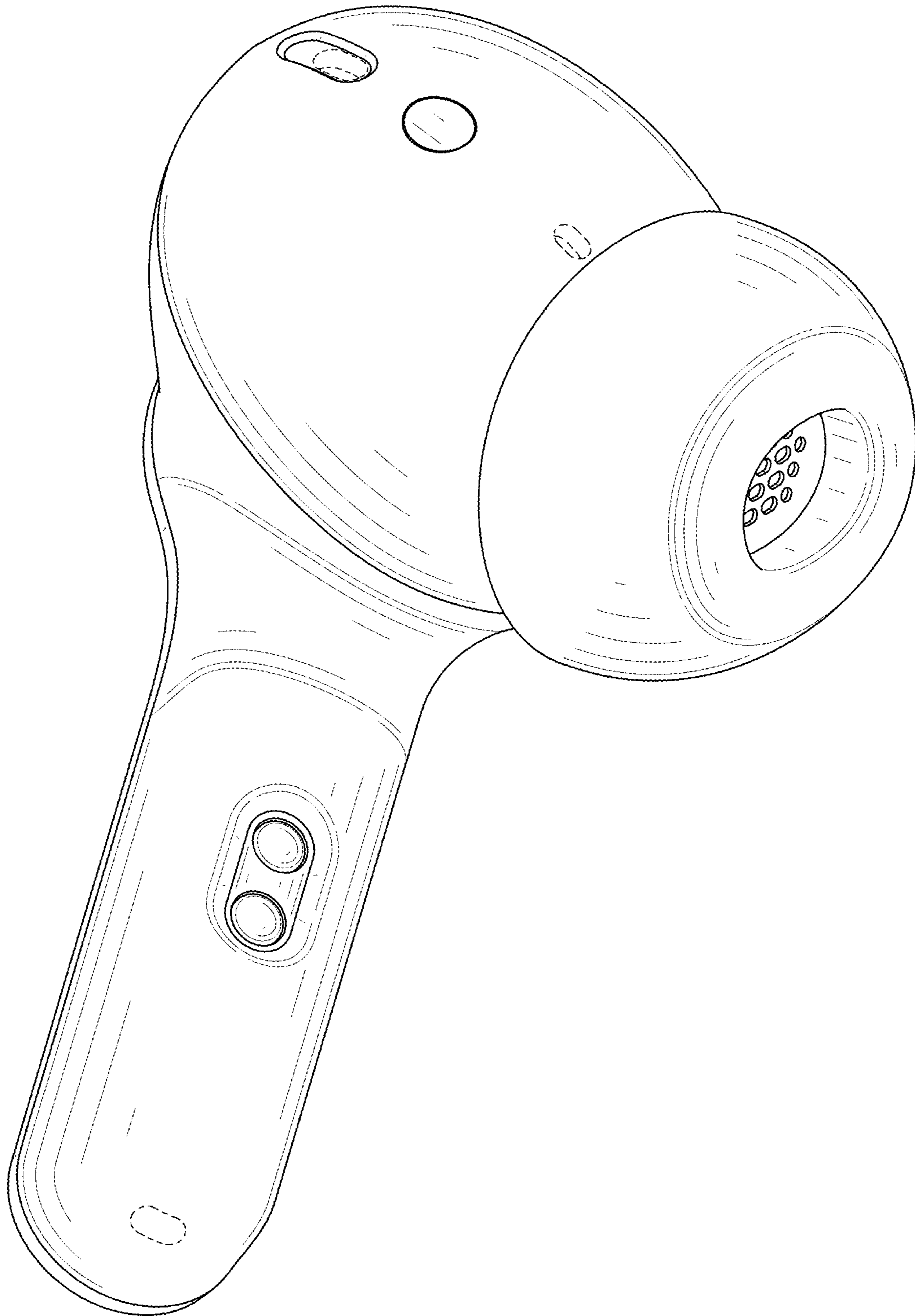

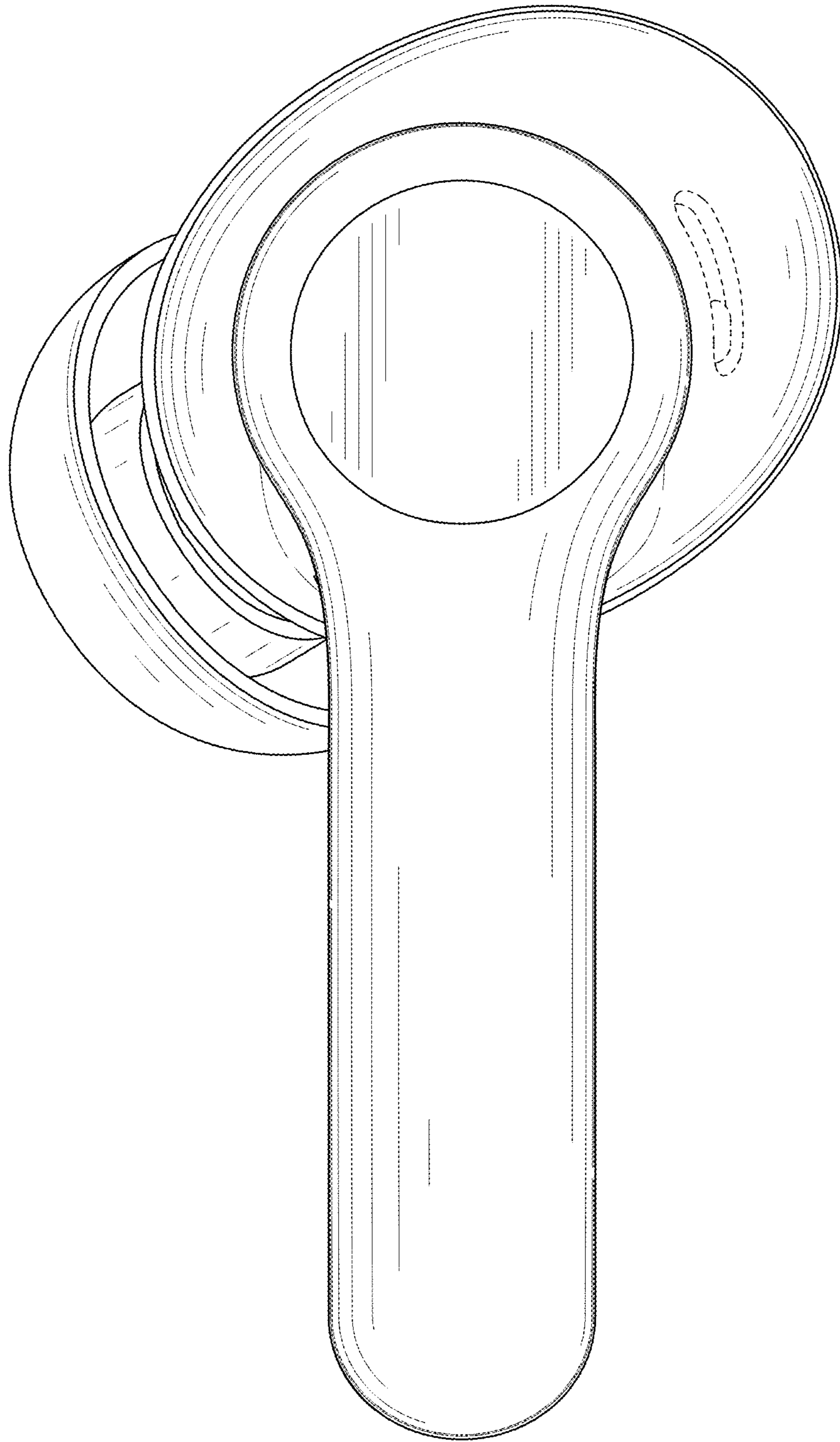

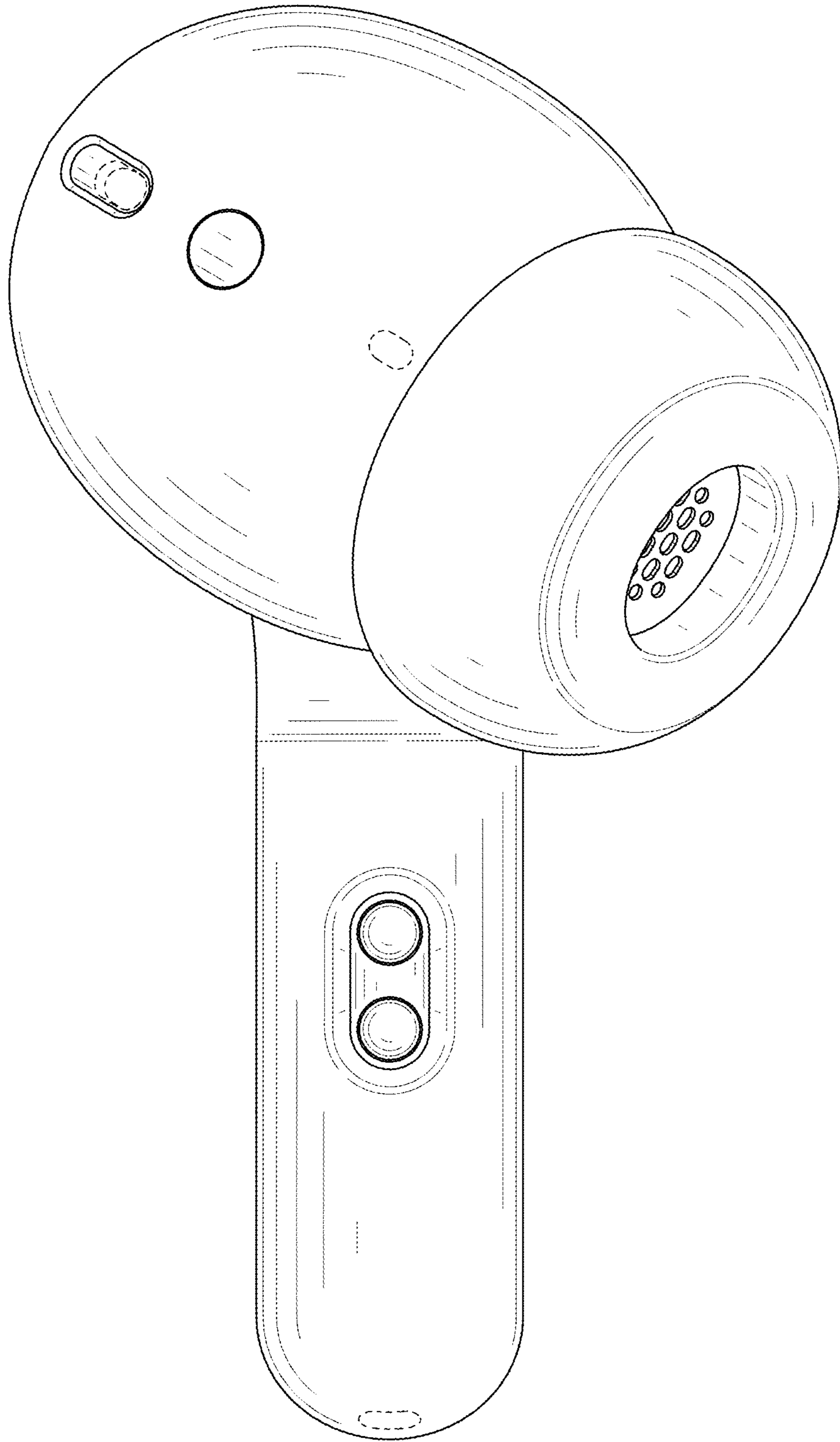

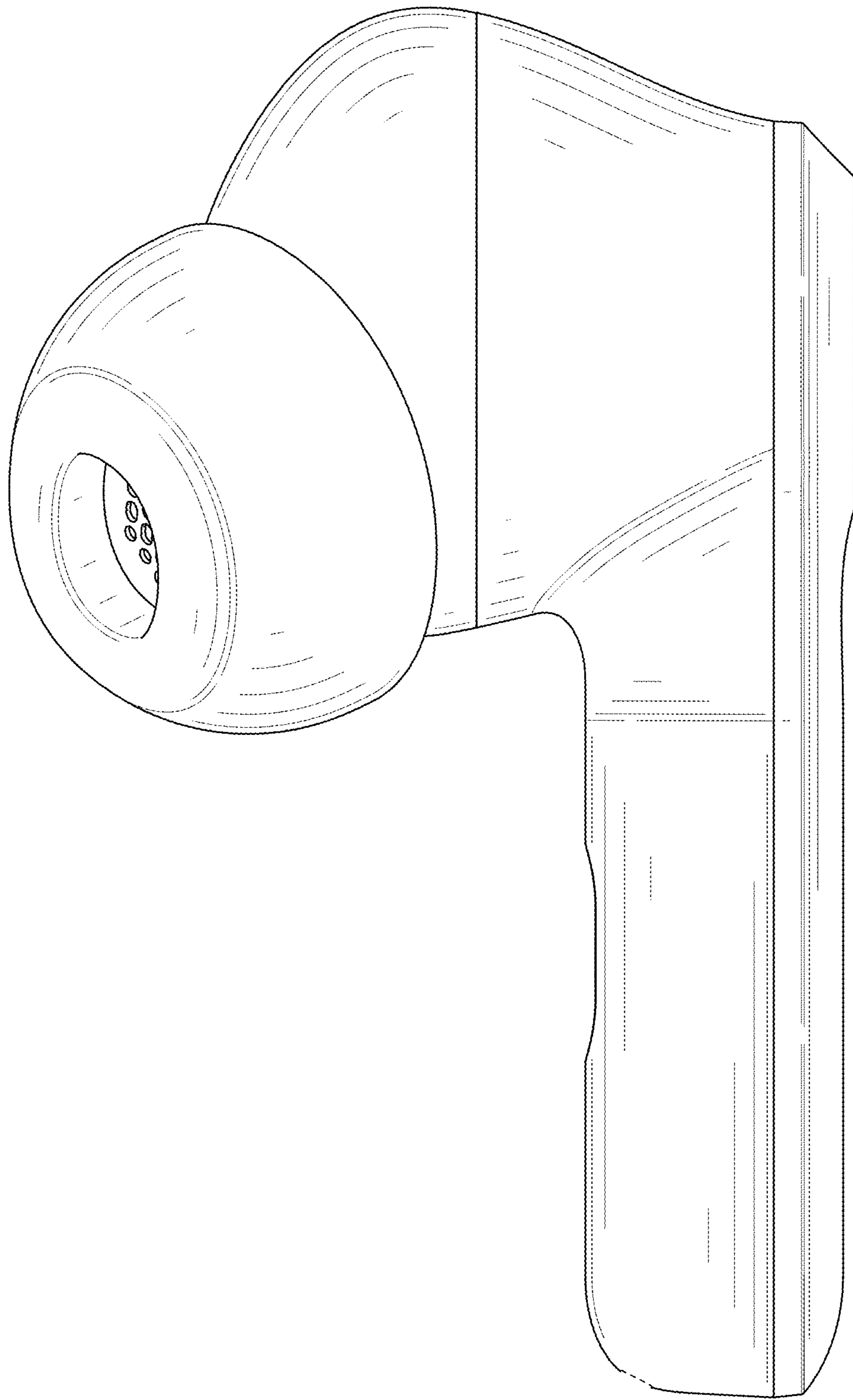

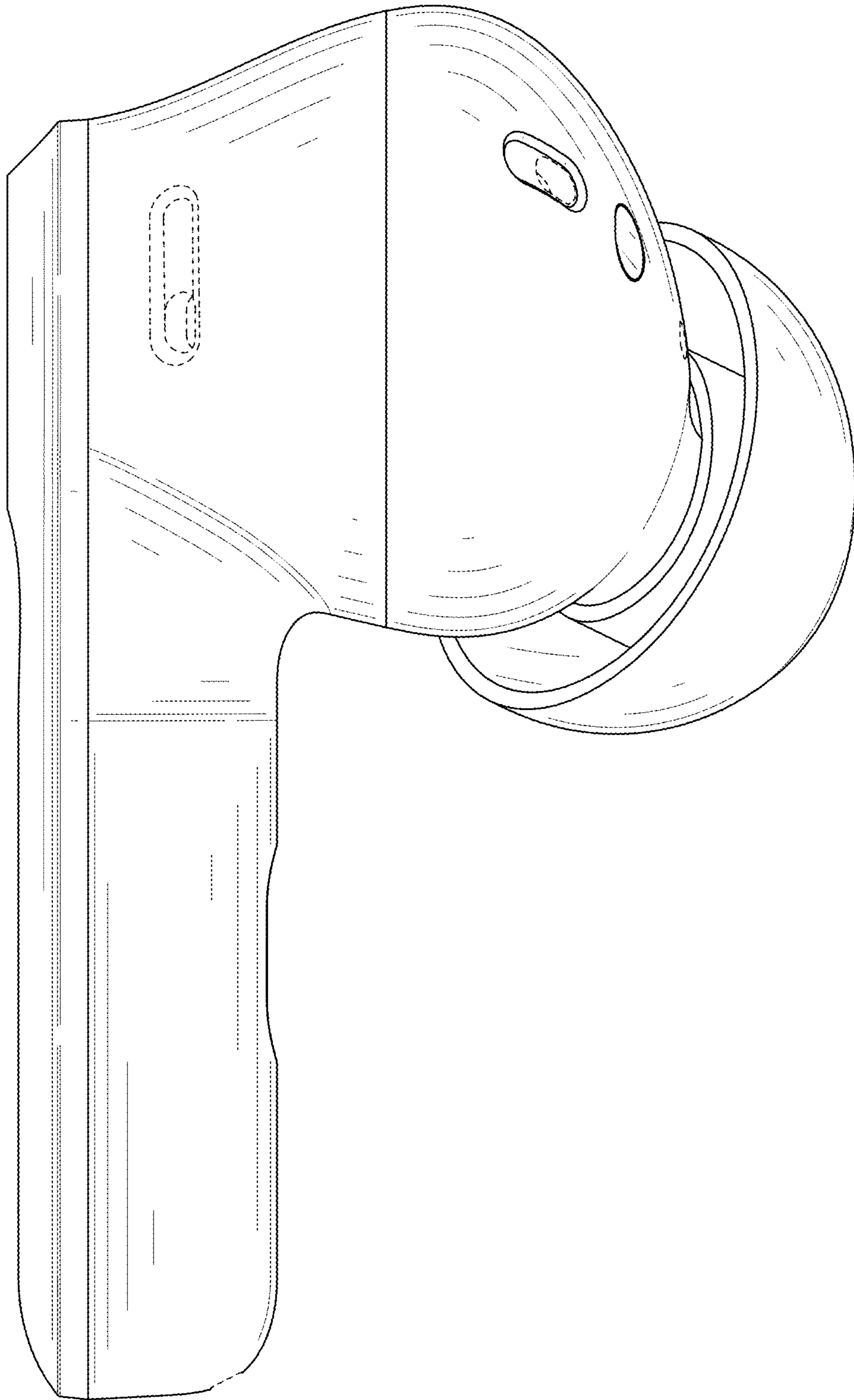

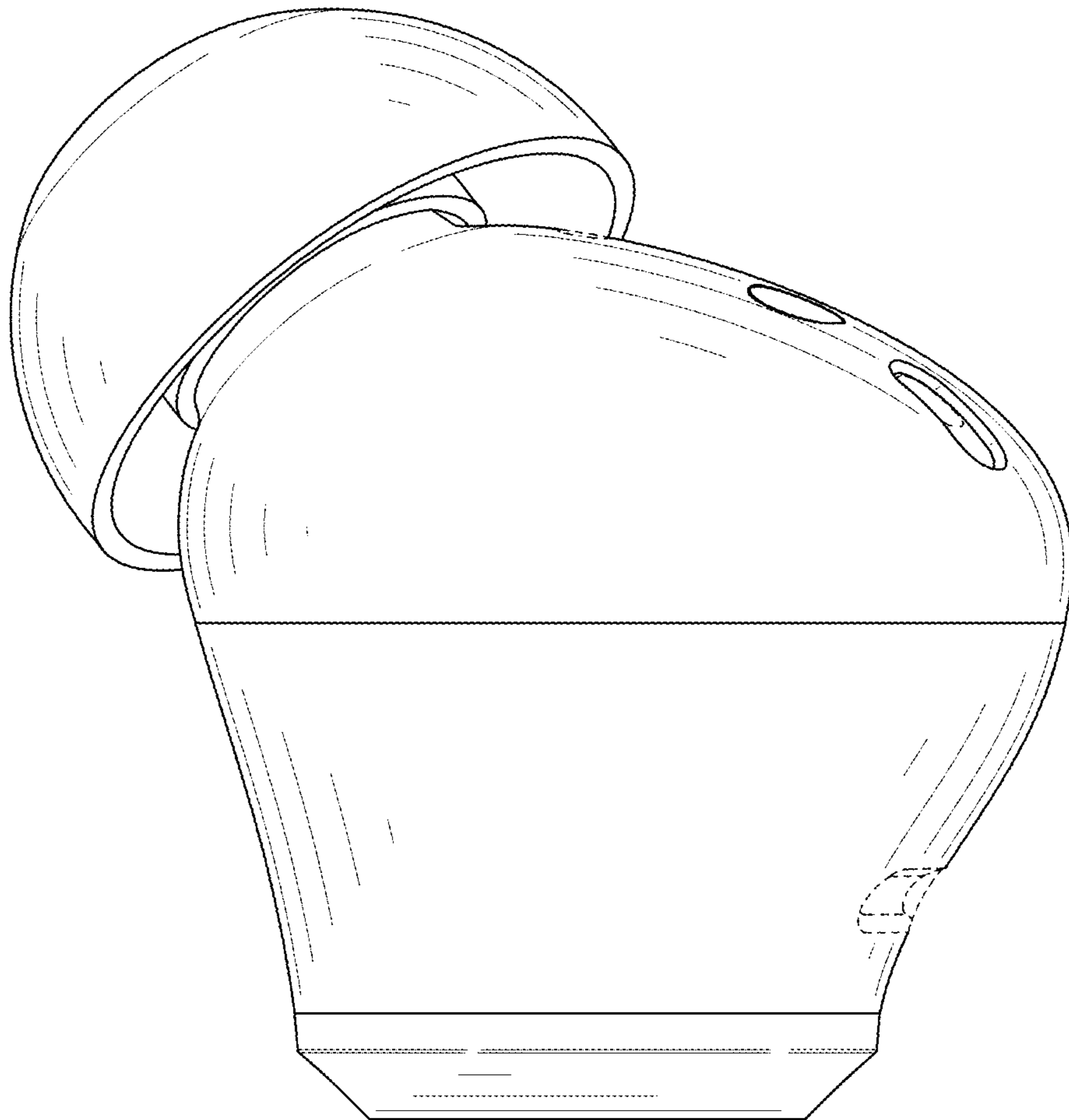

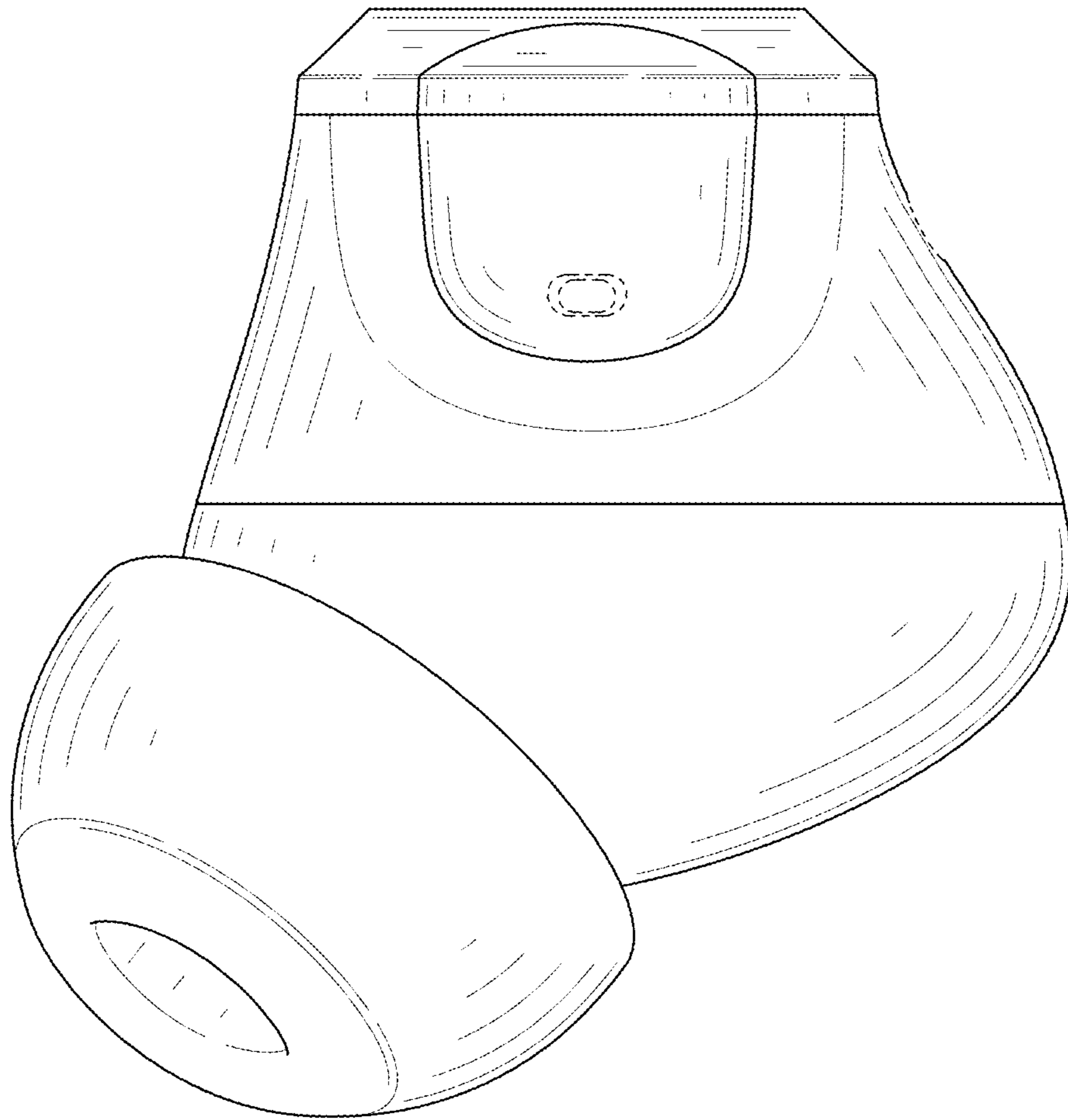
