DESCRIPTION

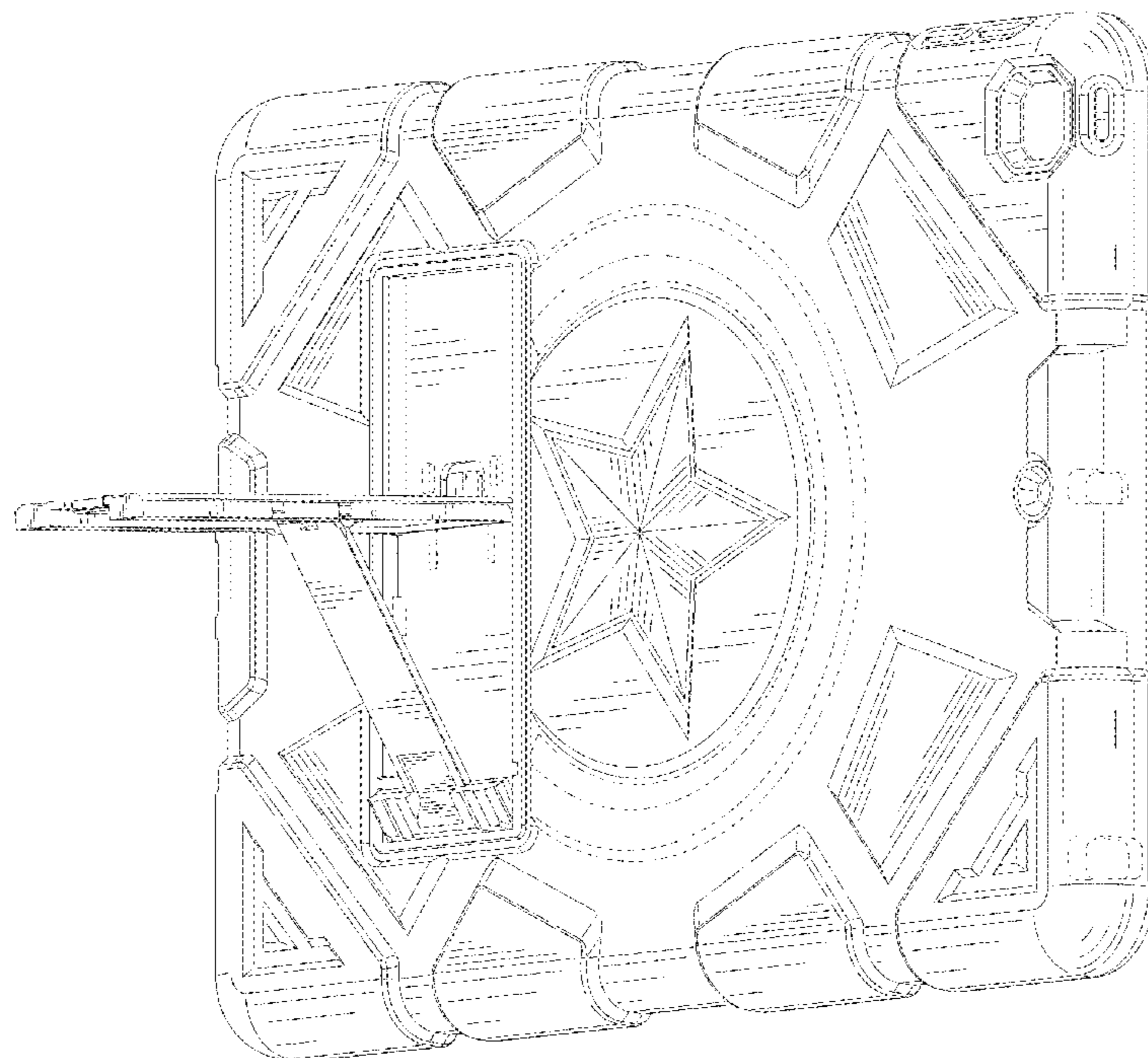
FIG. 1 is a perspective view of a tablet case showing my new design;

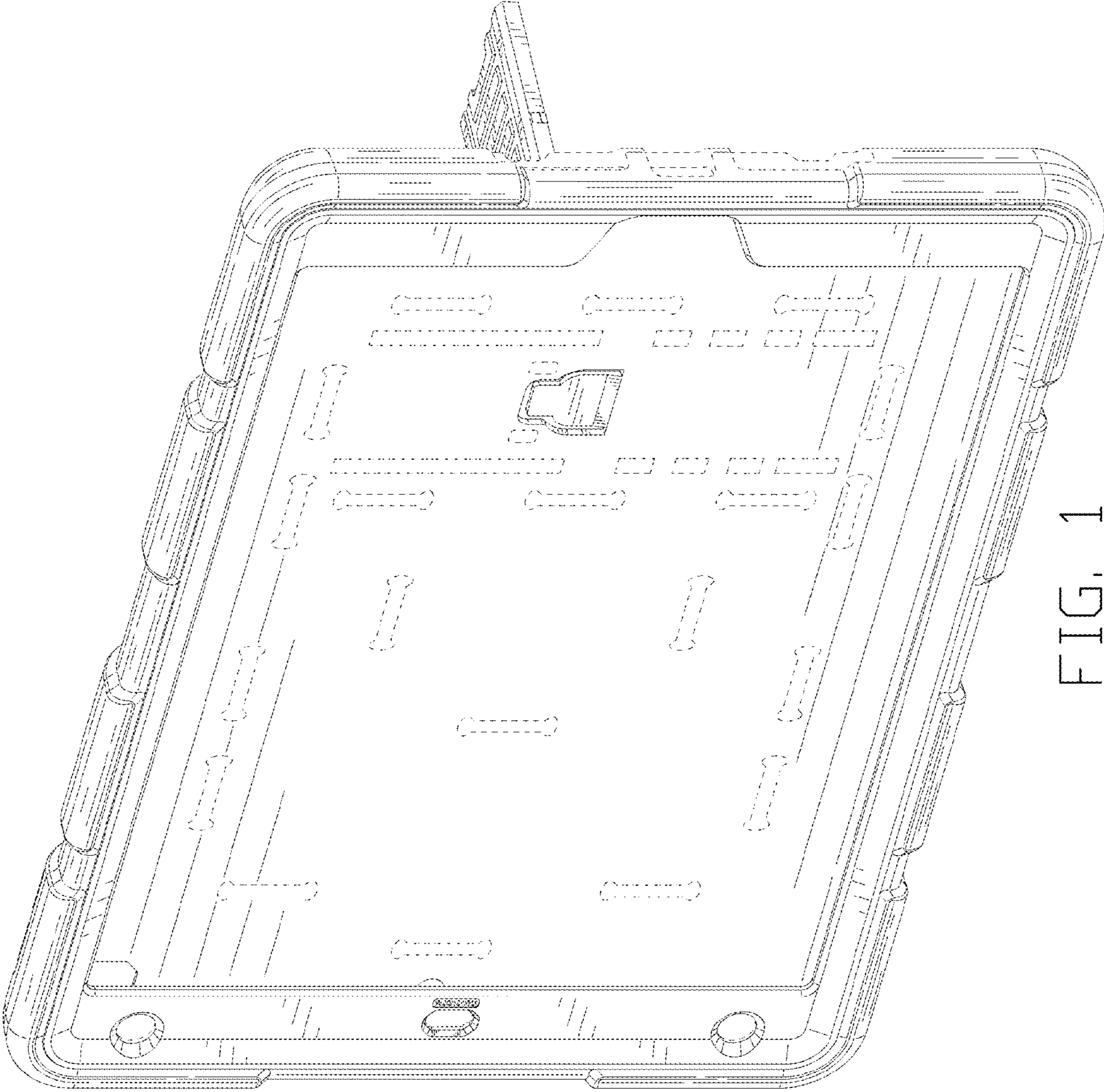

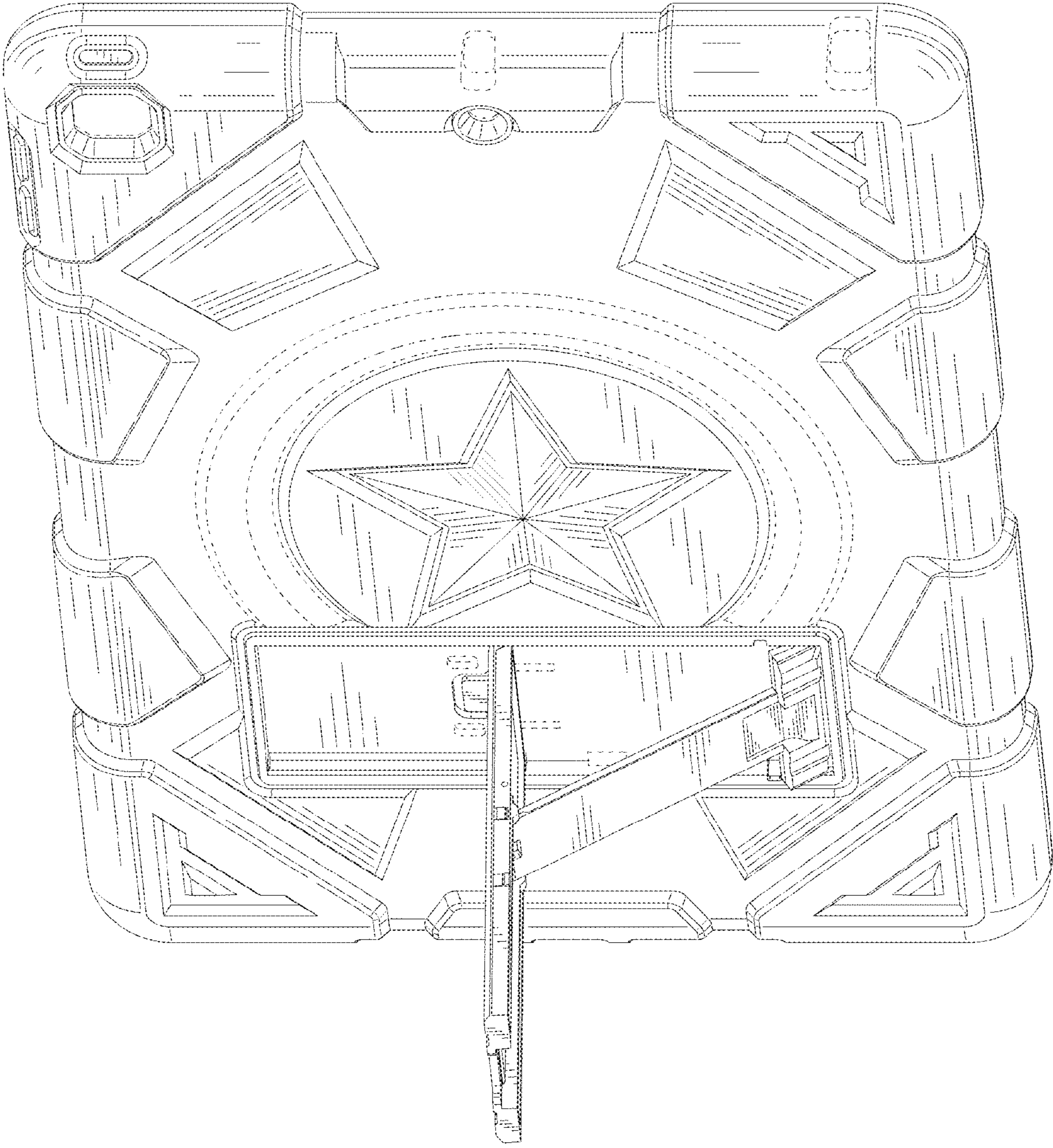

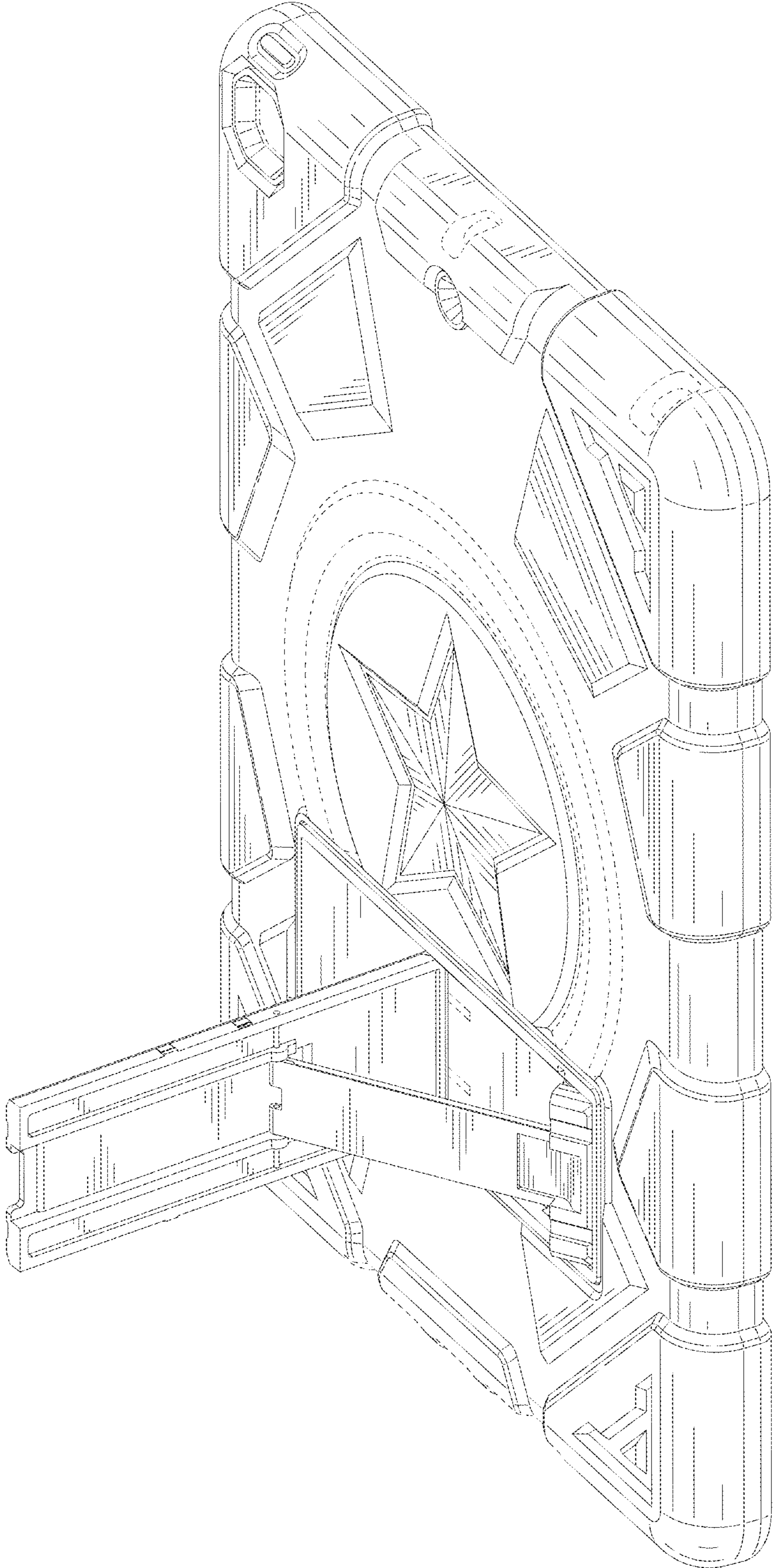

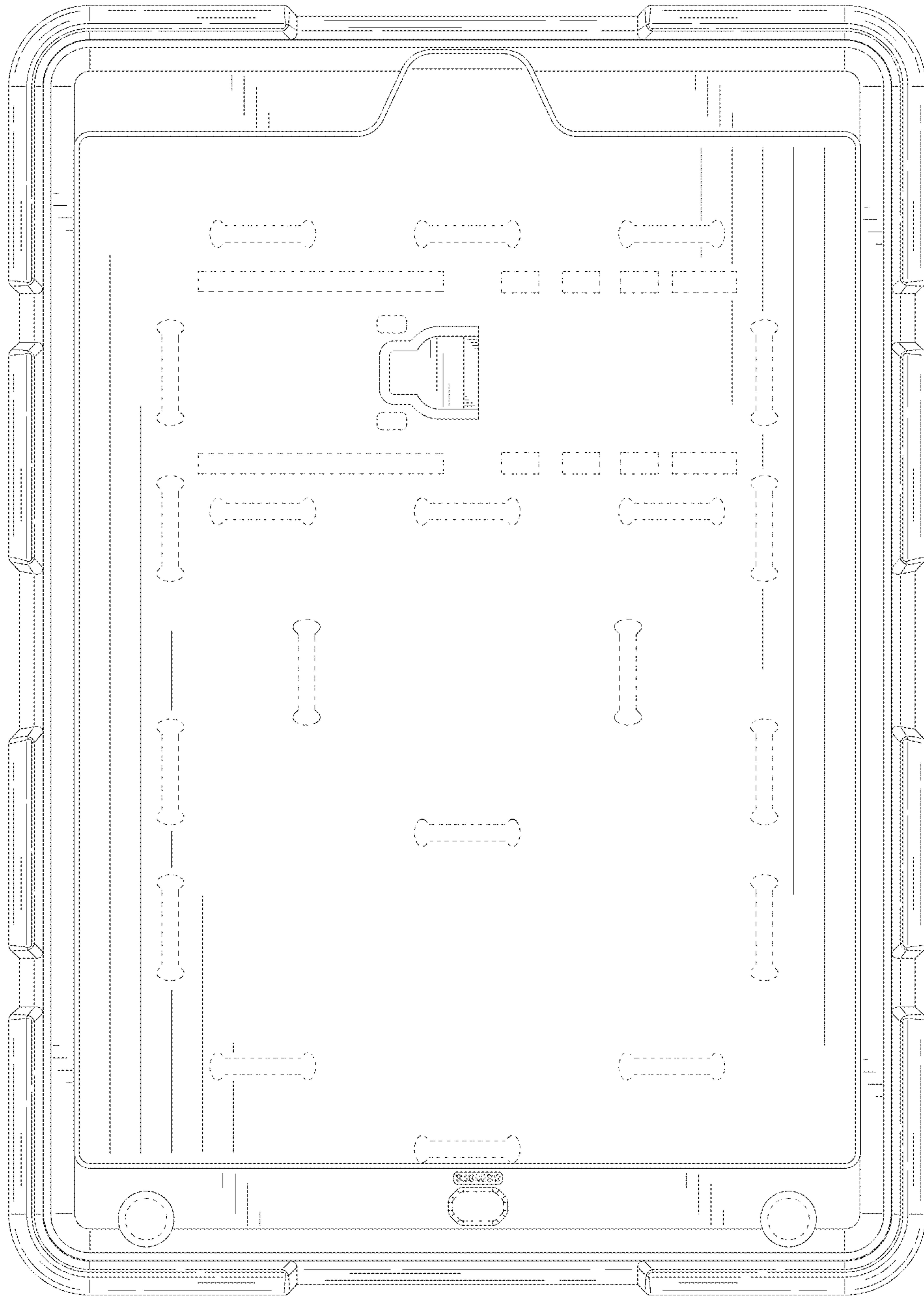

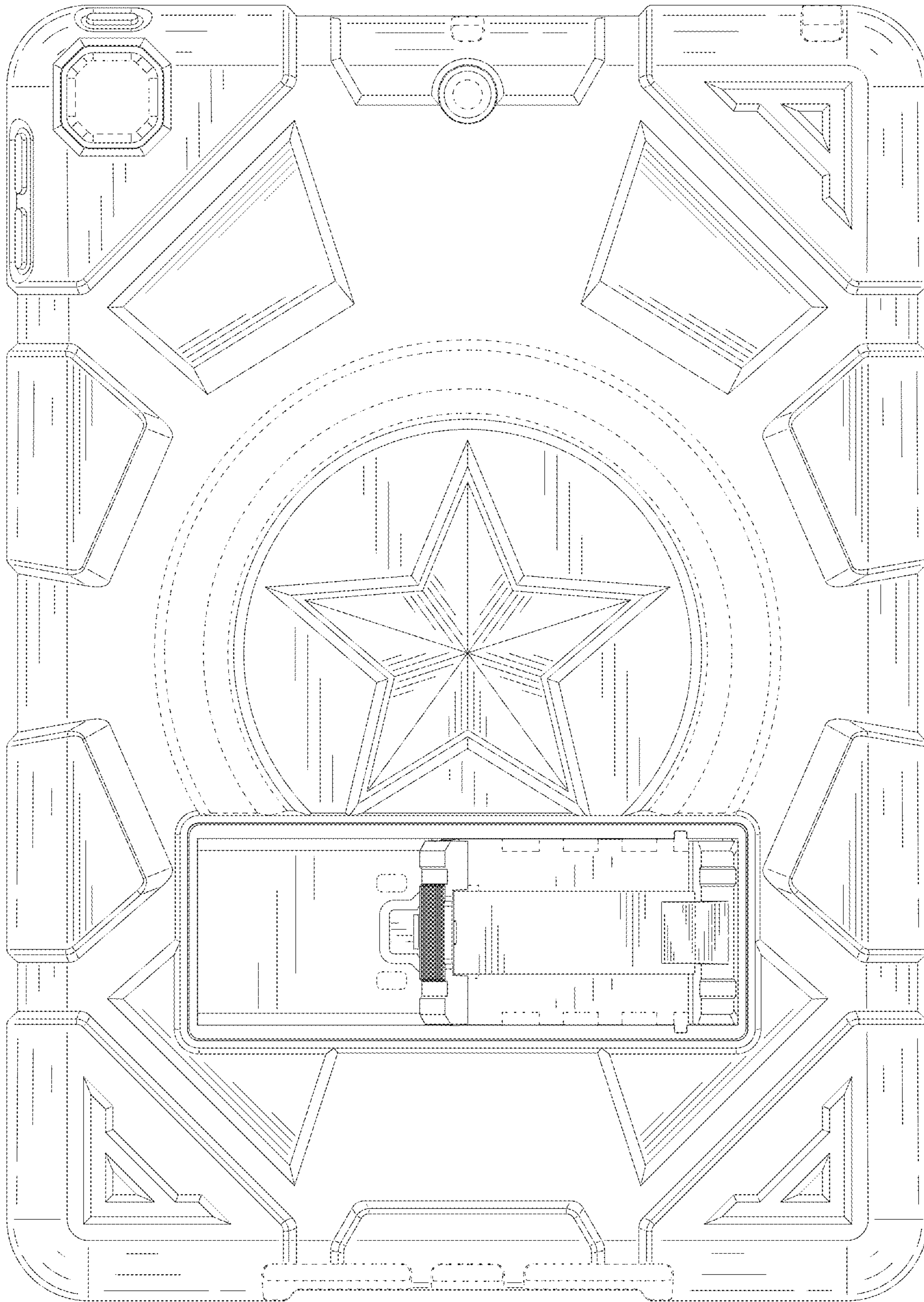

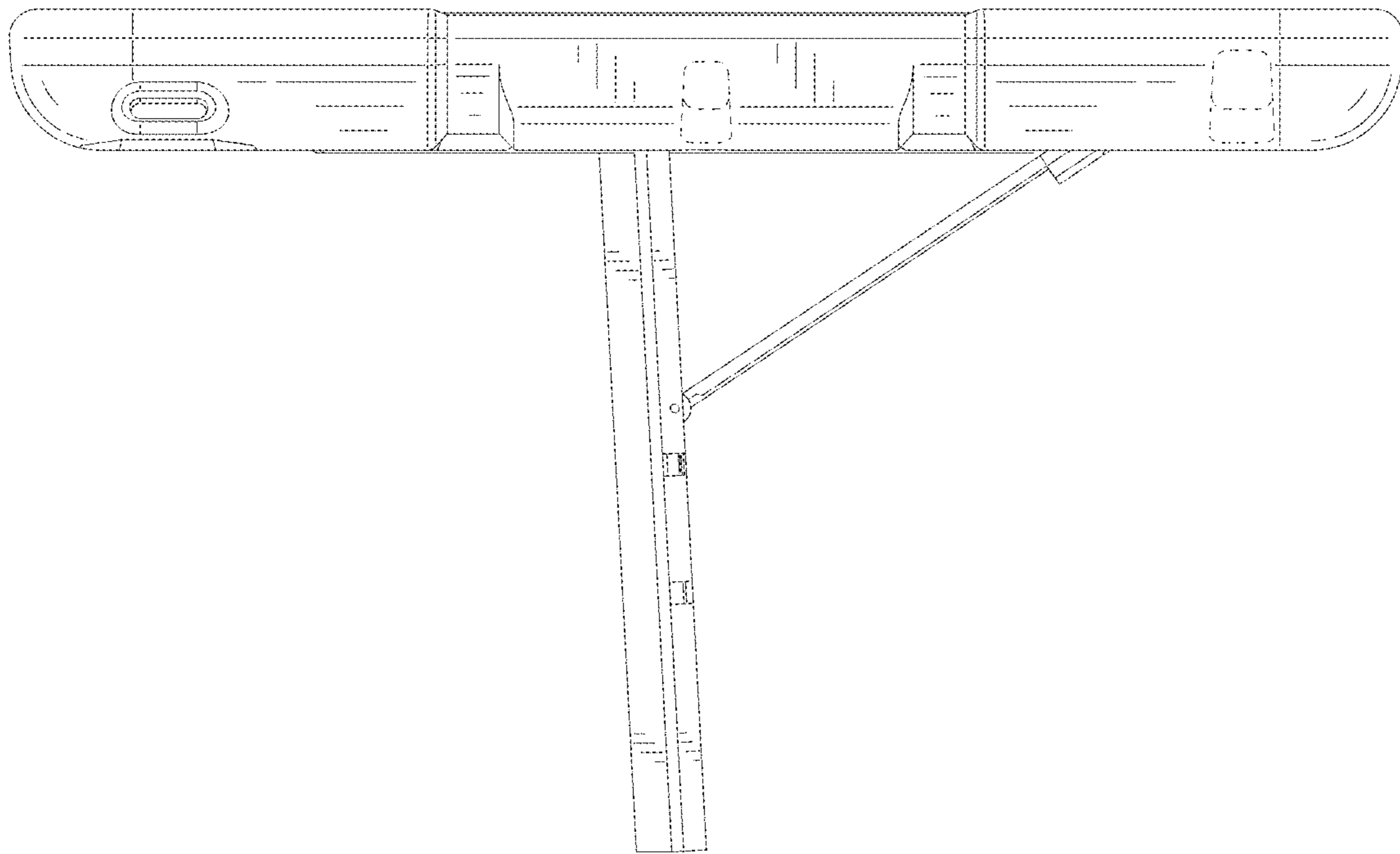

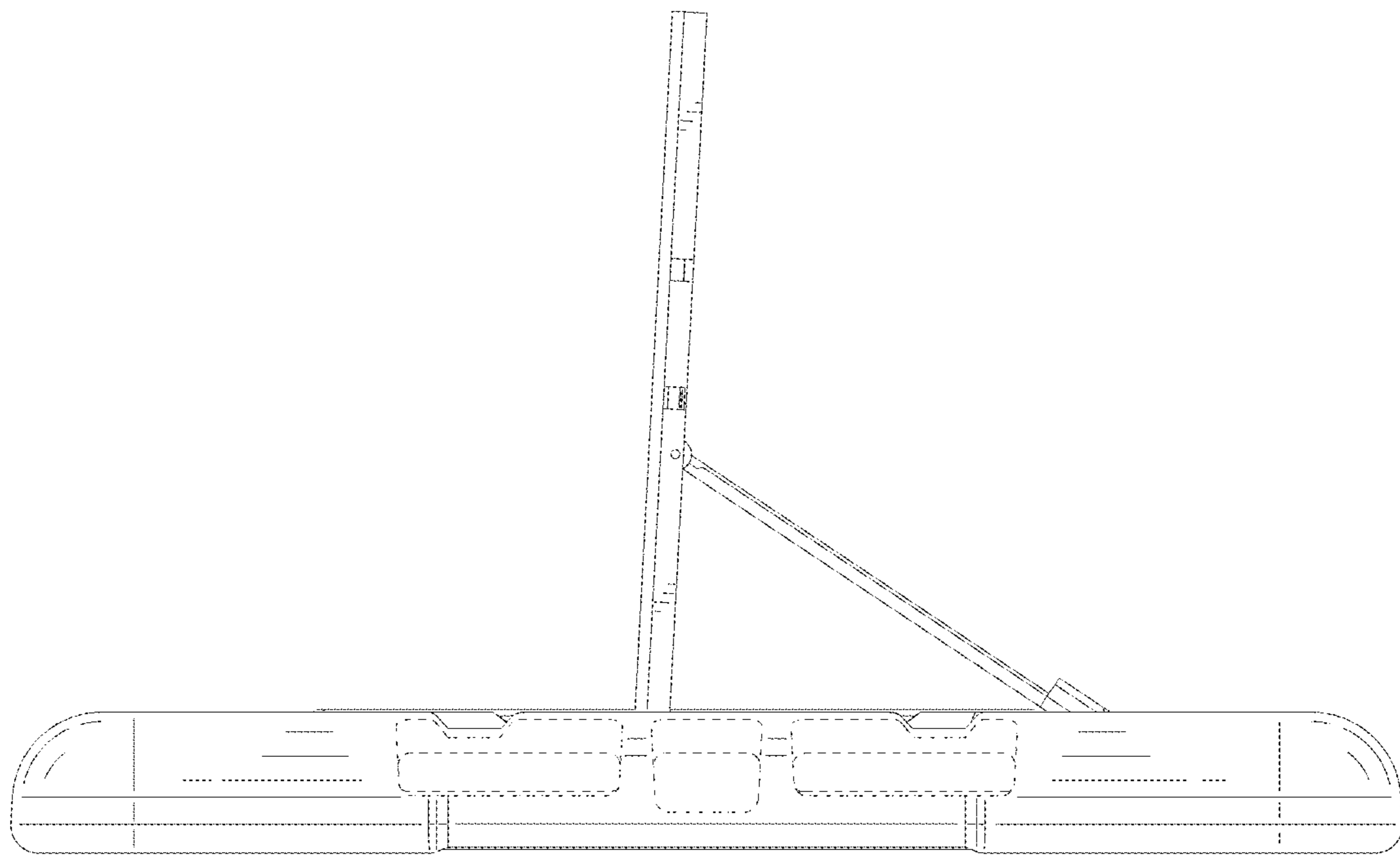

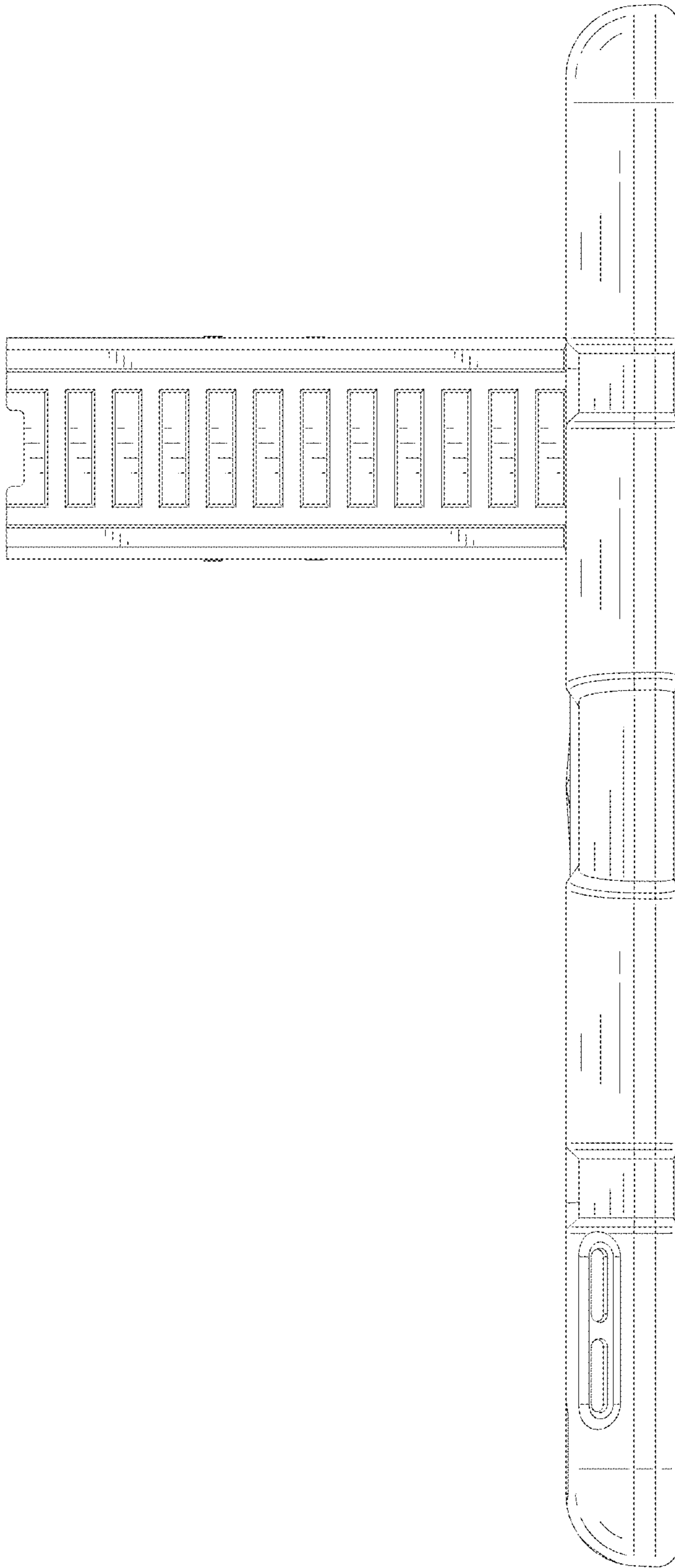

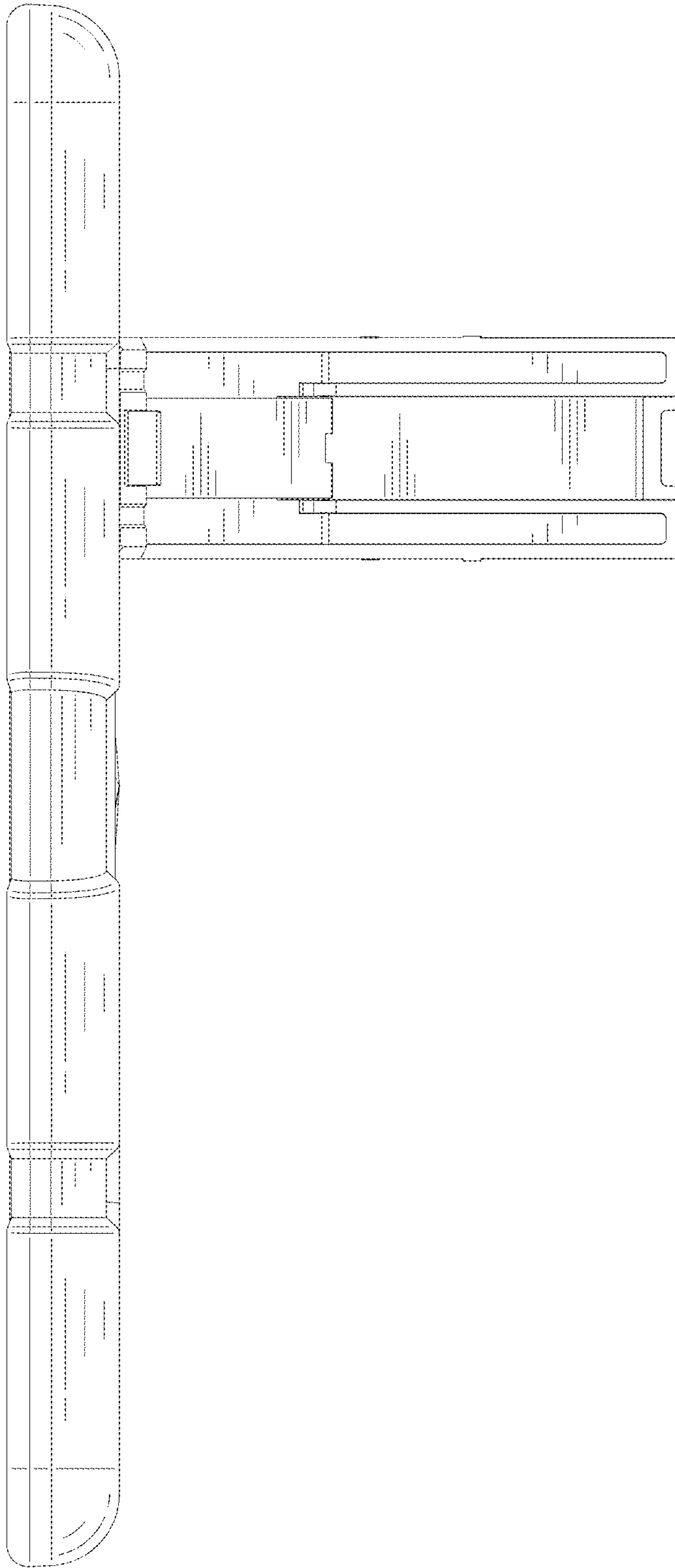
