FIG. 5 is a front view of a fifth embodiment of a display screen or portion thereof with graphical user interface showing my new design;

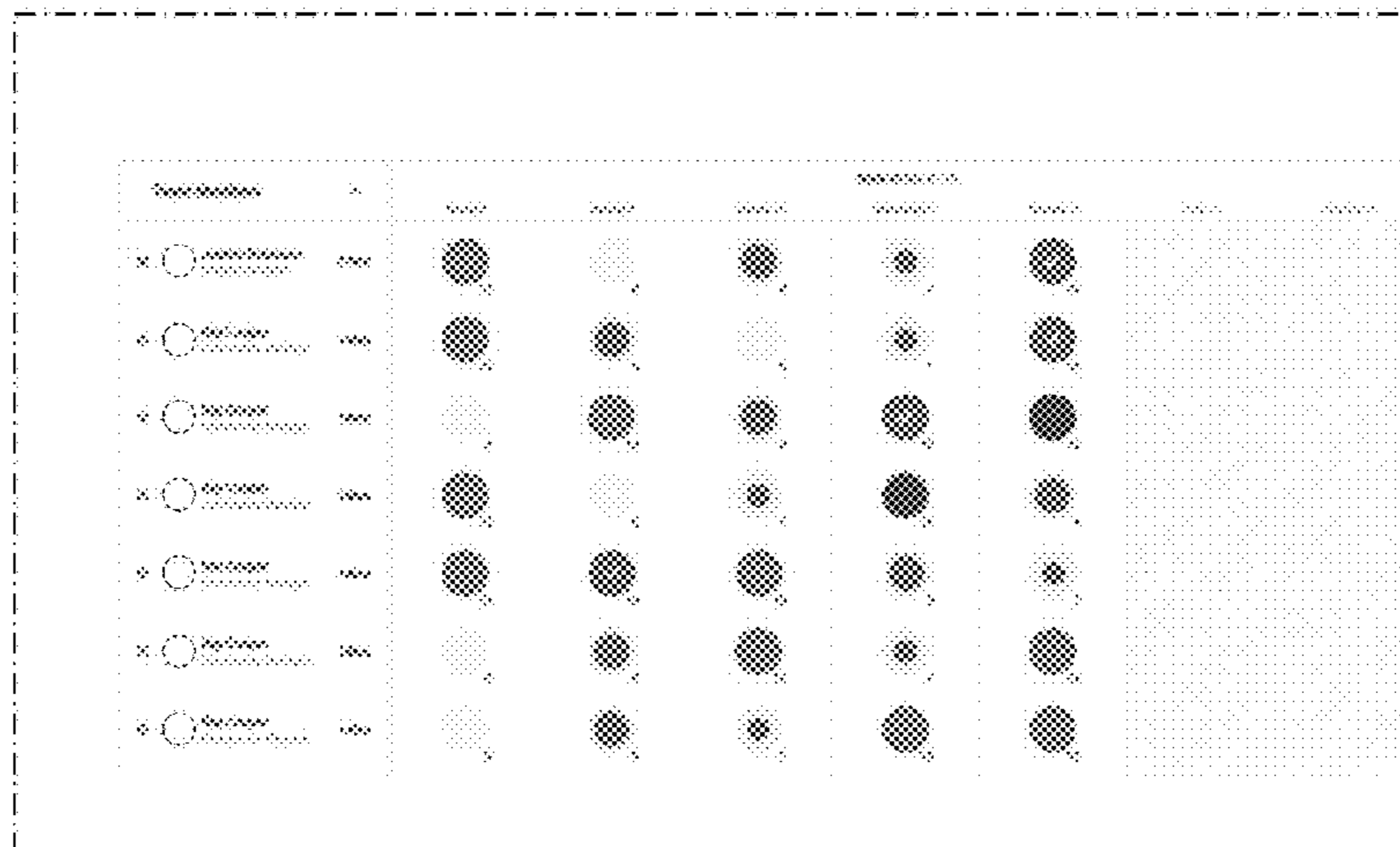
FIG. 6 is a front view of a sixth embodiment of a display screen or portion thereof with graphical user interface showing my new design;

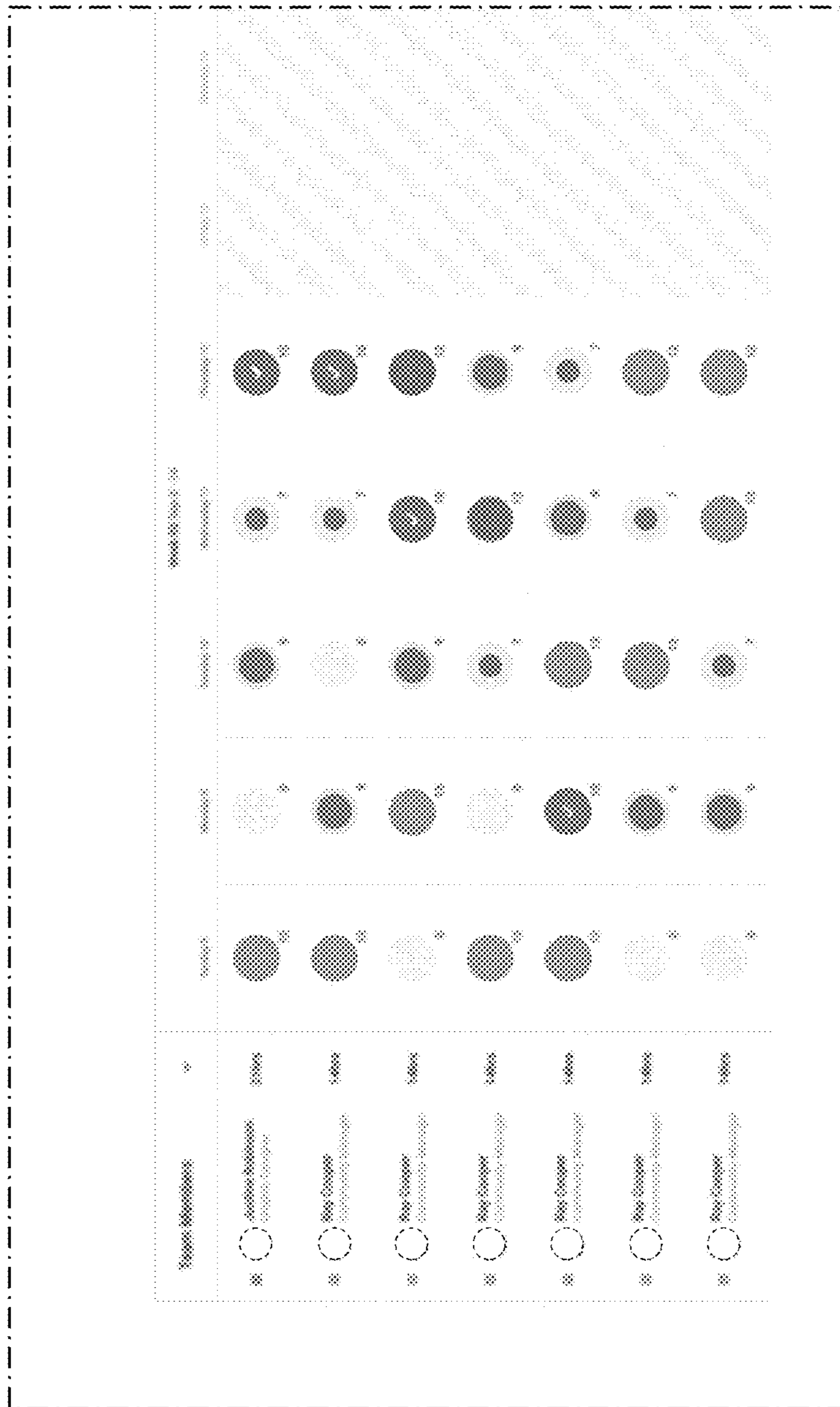

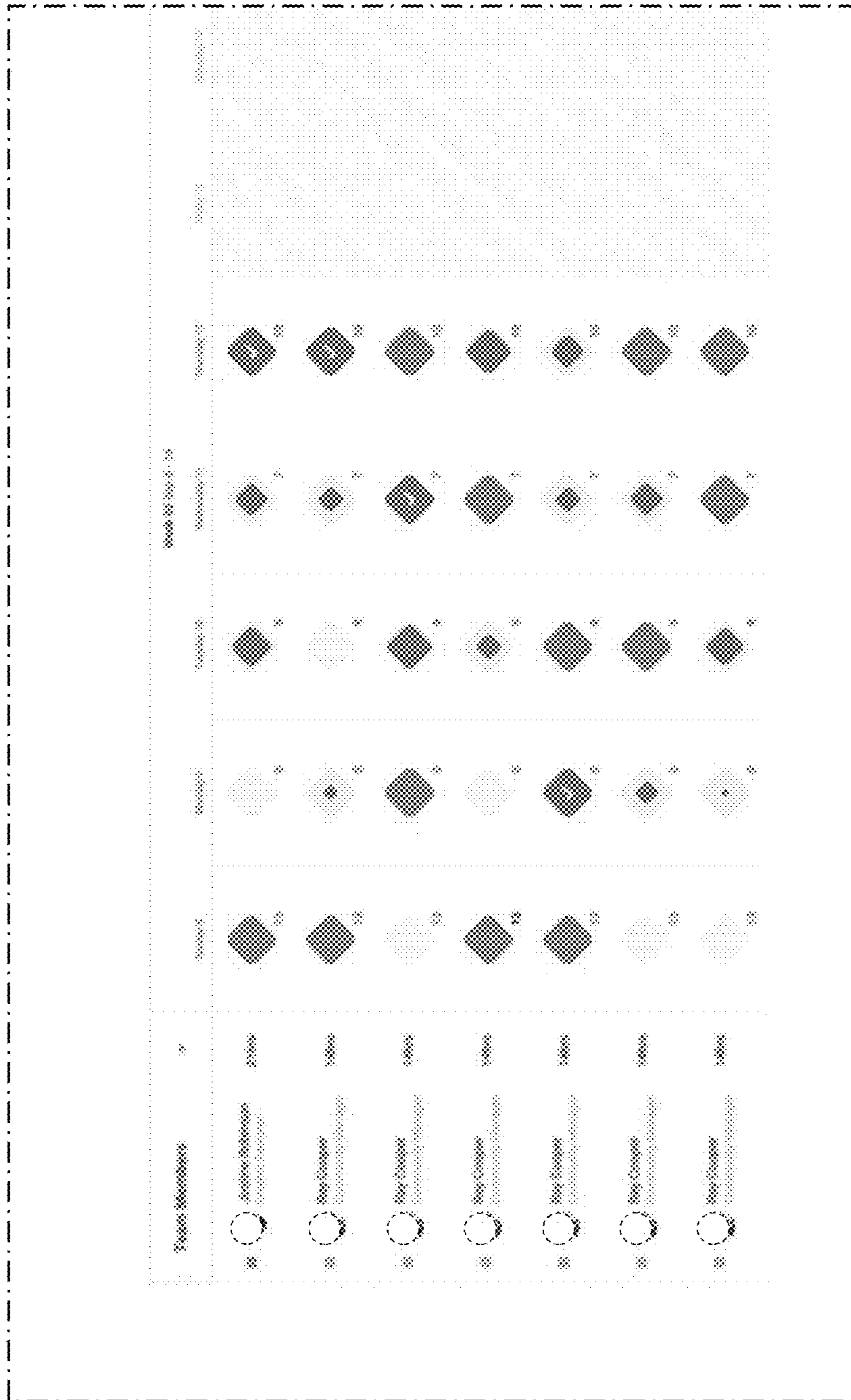

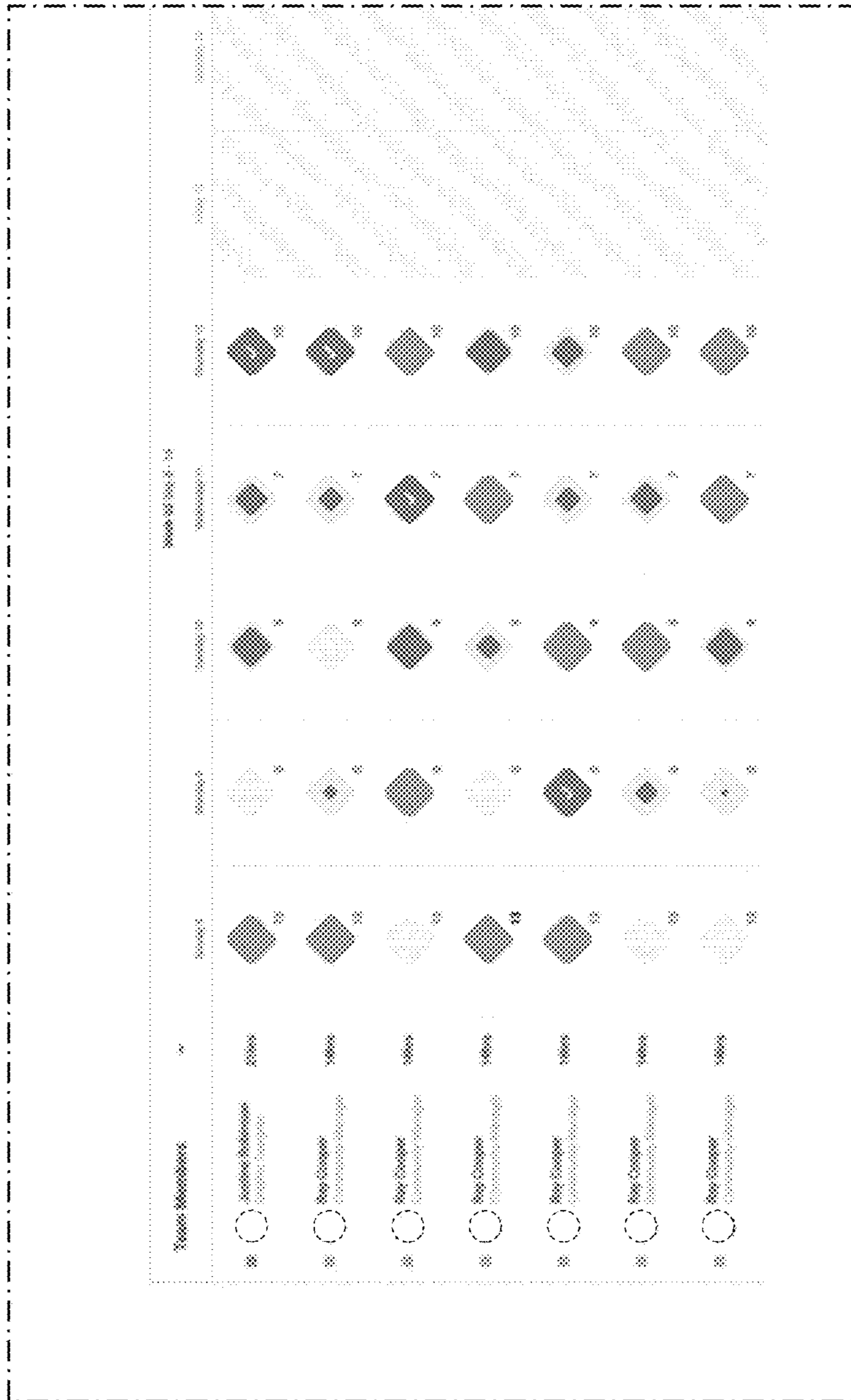

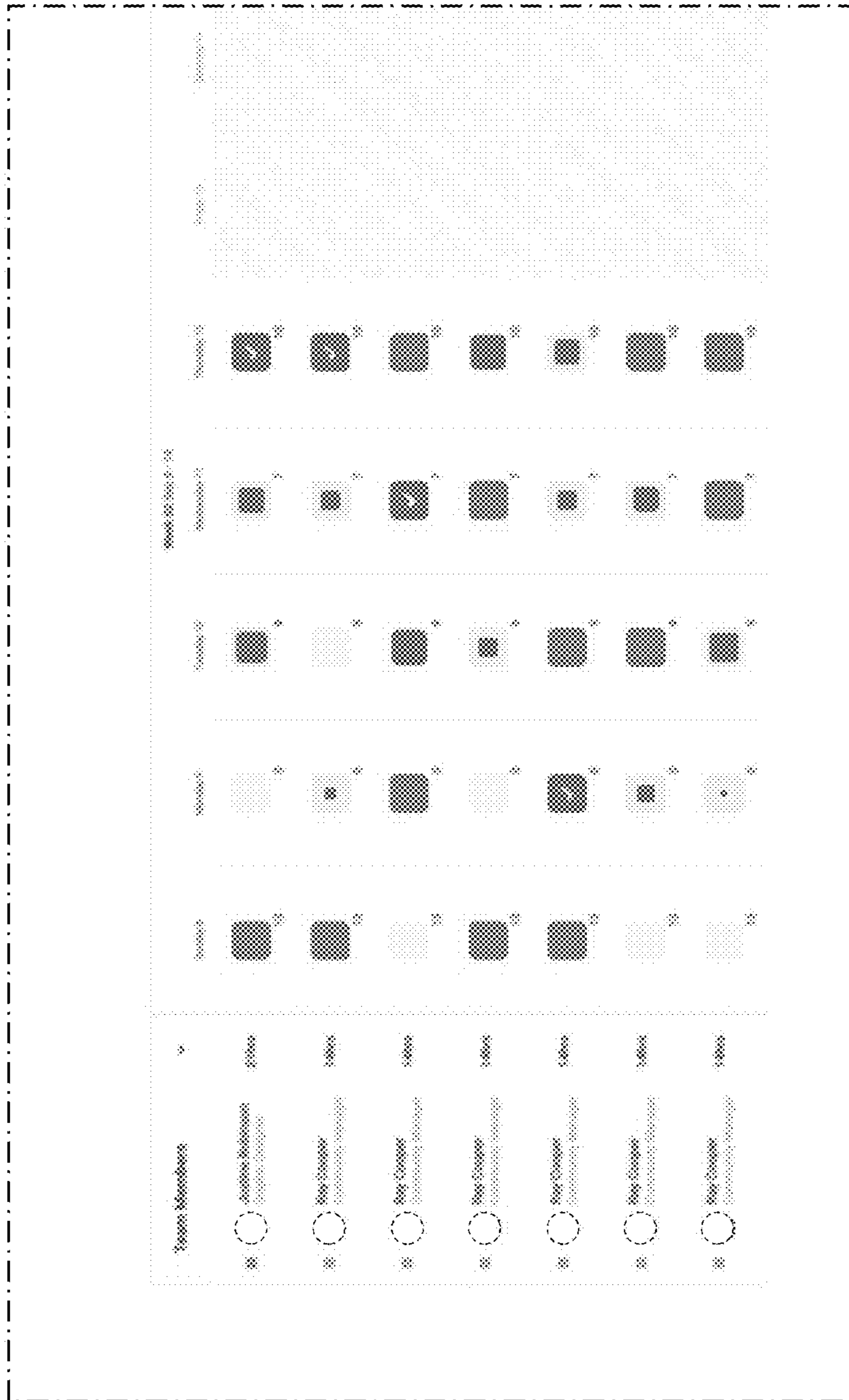

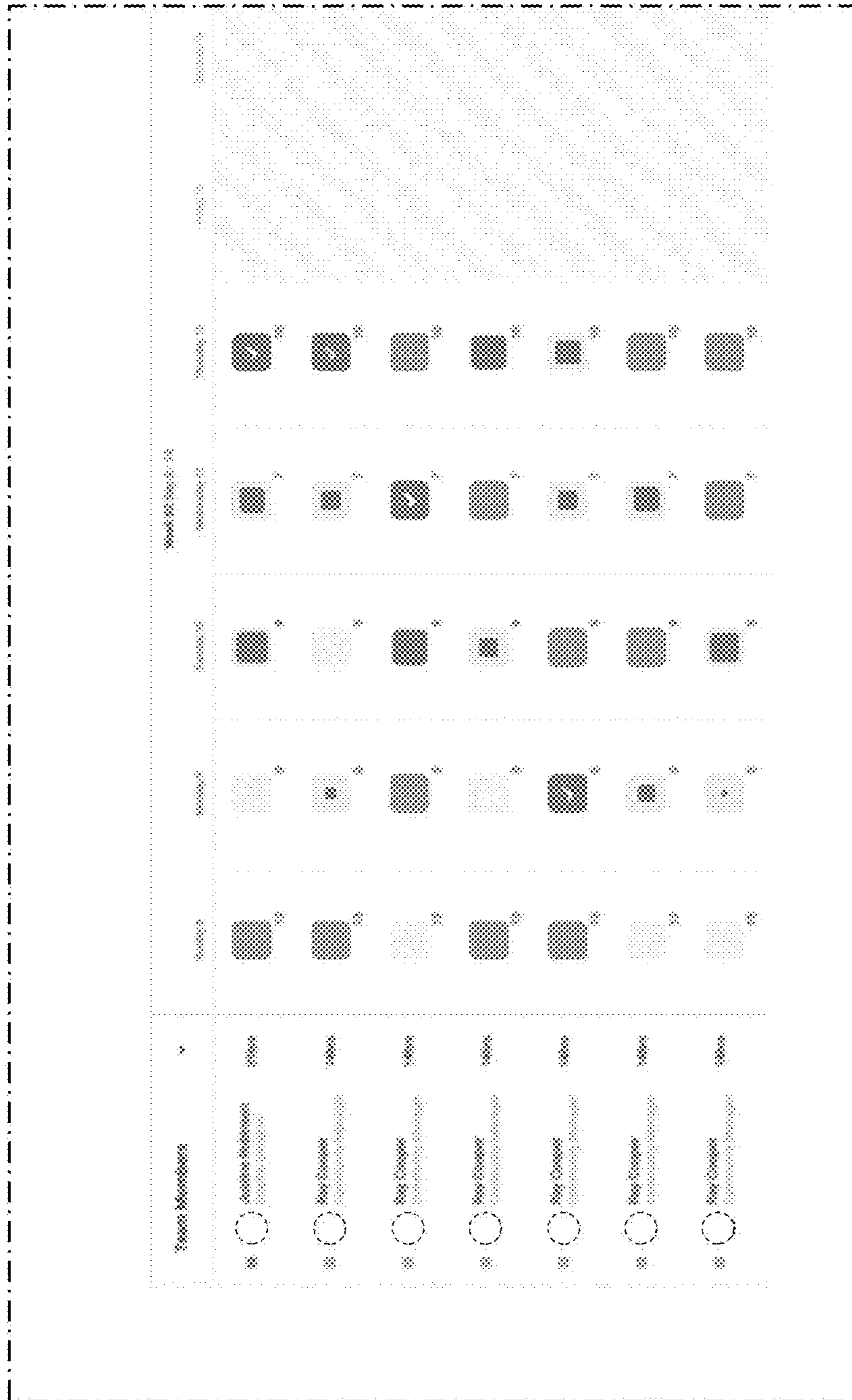

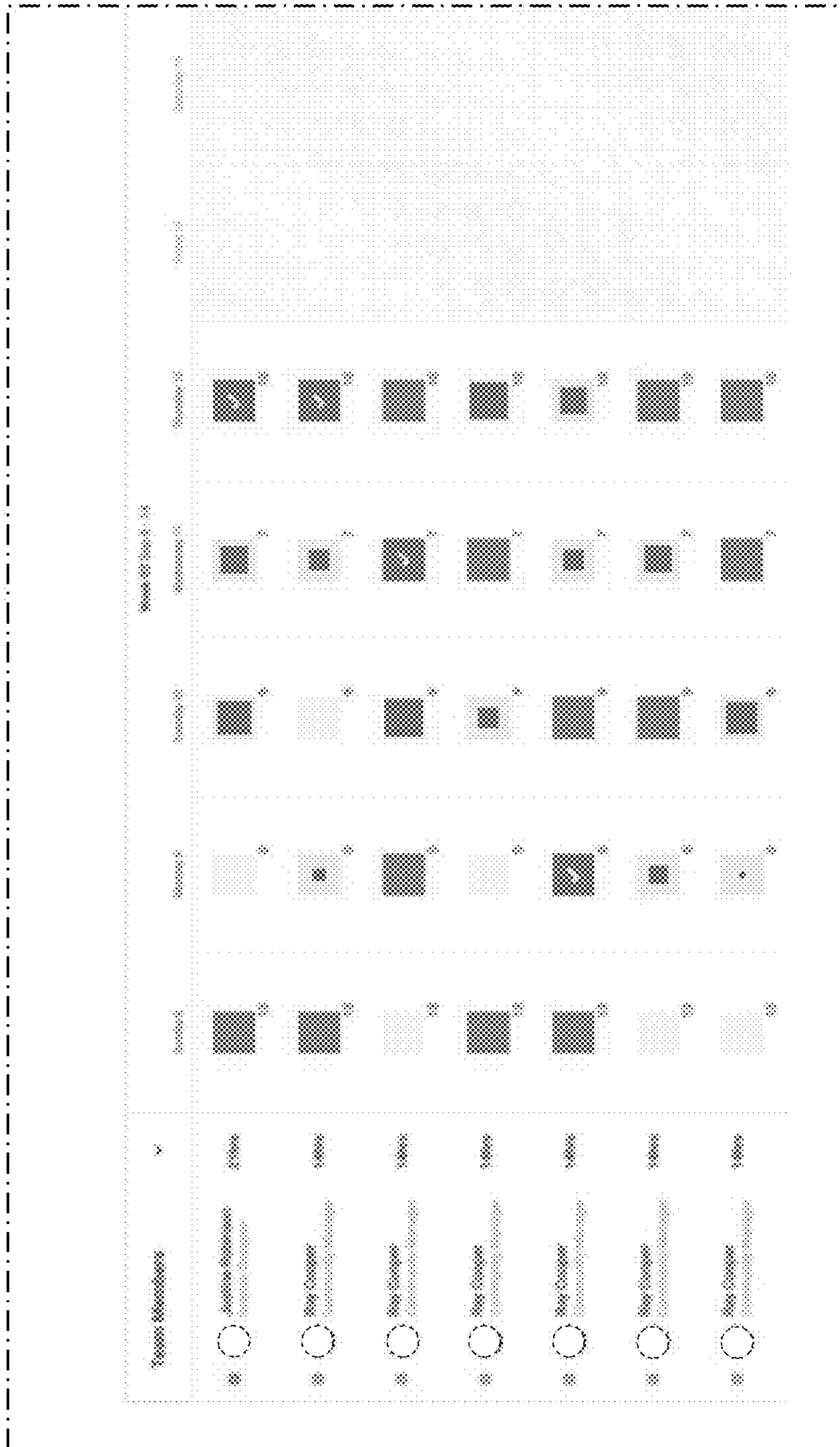

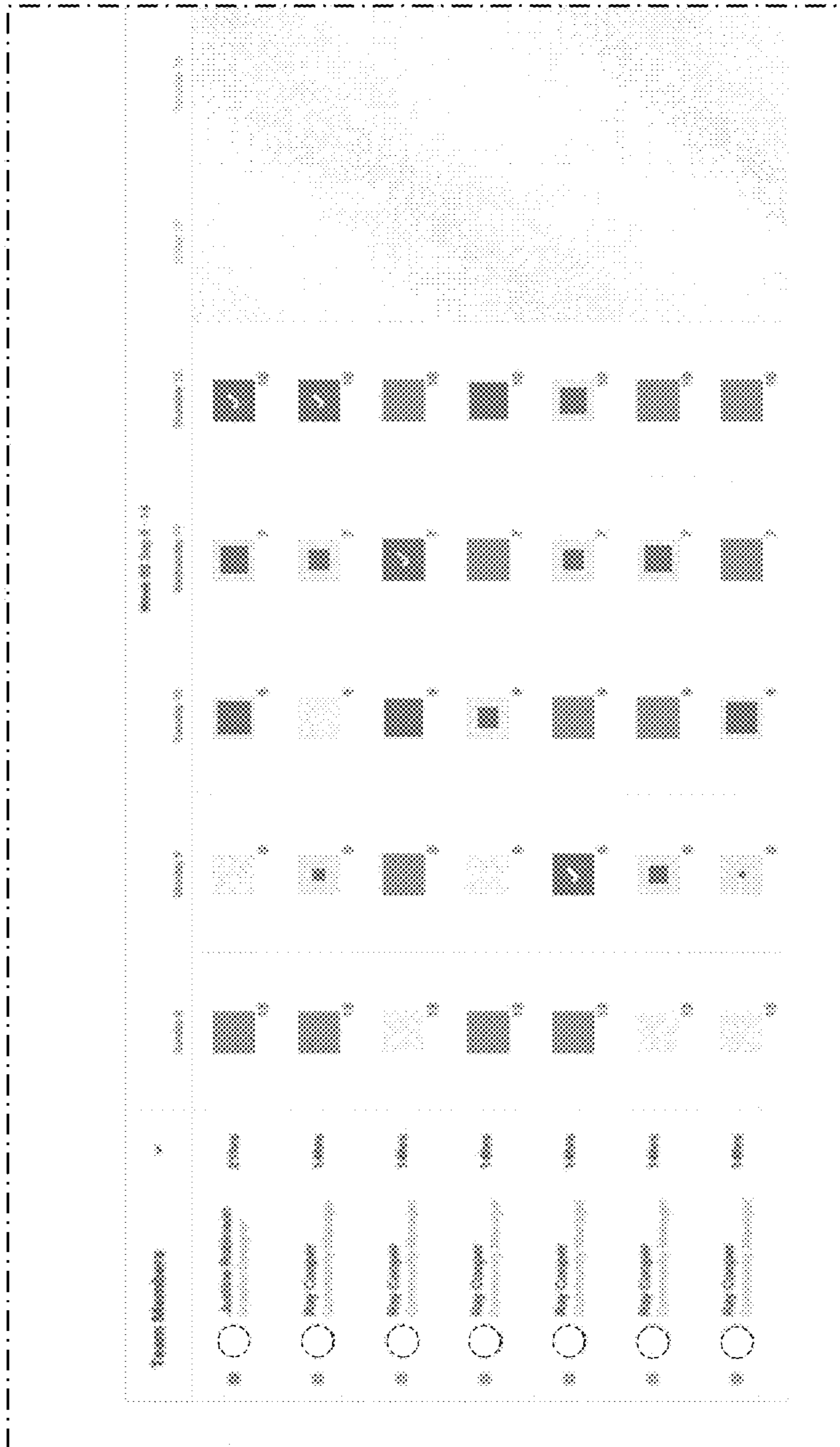
