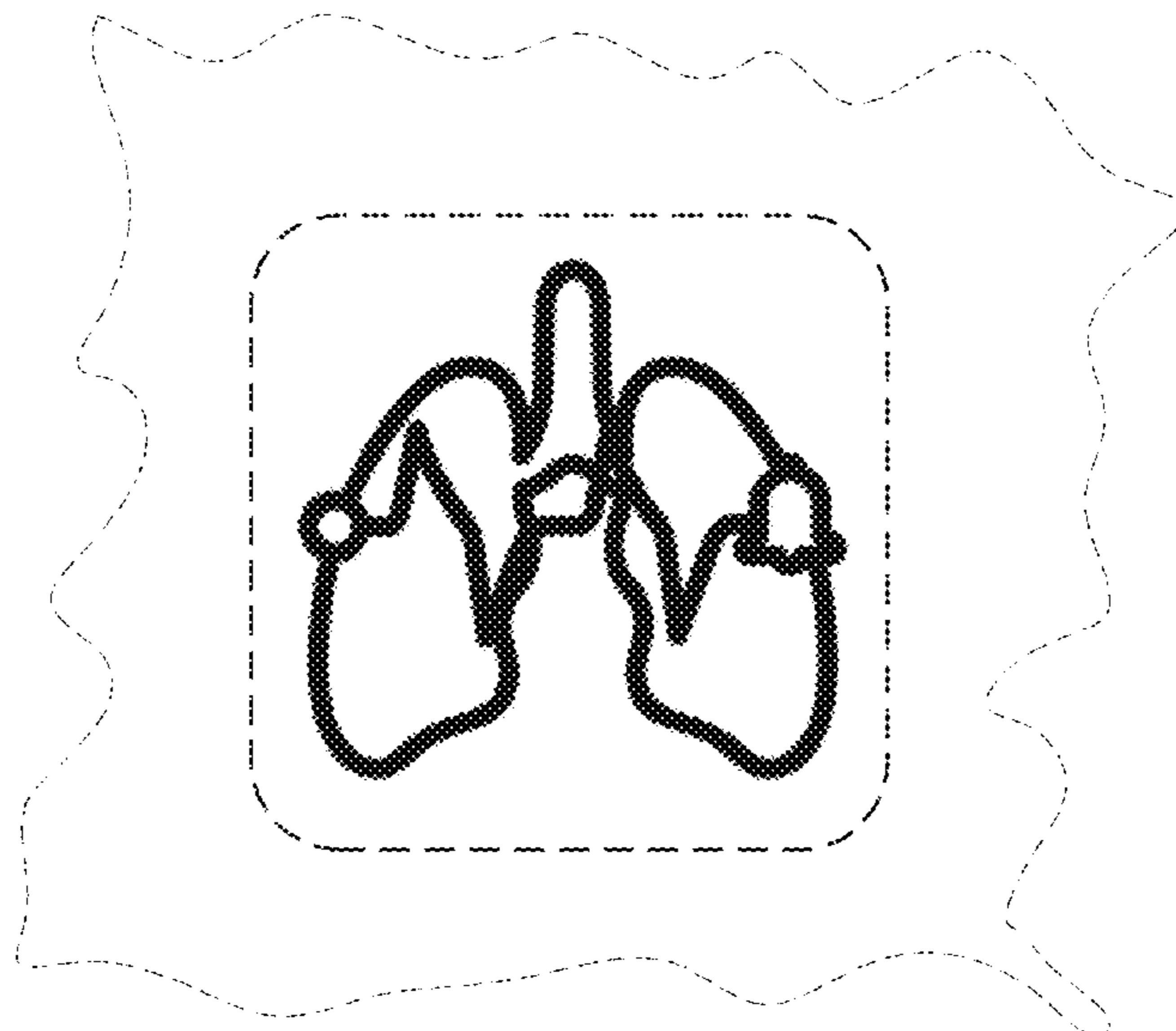
(57) **CLAIM**

The ornamental design for a display screen with graphical icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a computing device display screen with graphical icon showing our new design; FIG. 2 is a front view of a second embodiment of a display screen with graphical icon showing our new design; and, FIG. 3 is a front view of a third embodiment of a display screen with graphical icon showing our new design. The peripheral broken lines illustrate a display screen of a computing device, or portion thereof, and form no part of the claimed design. The portion of the icon shown in broken lines forms no part of the claimed design. The icon is shown arranged relatively on the illustrated display screen and drawing sheets are for the convenience of illustration, and the placement of the icon relative to the boundaries of the illustrated example display screen, or to the drawing sheet, forms no part of the claimed design.

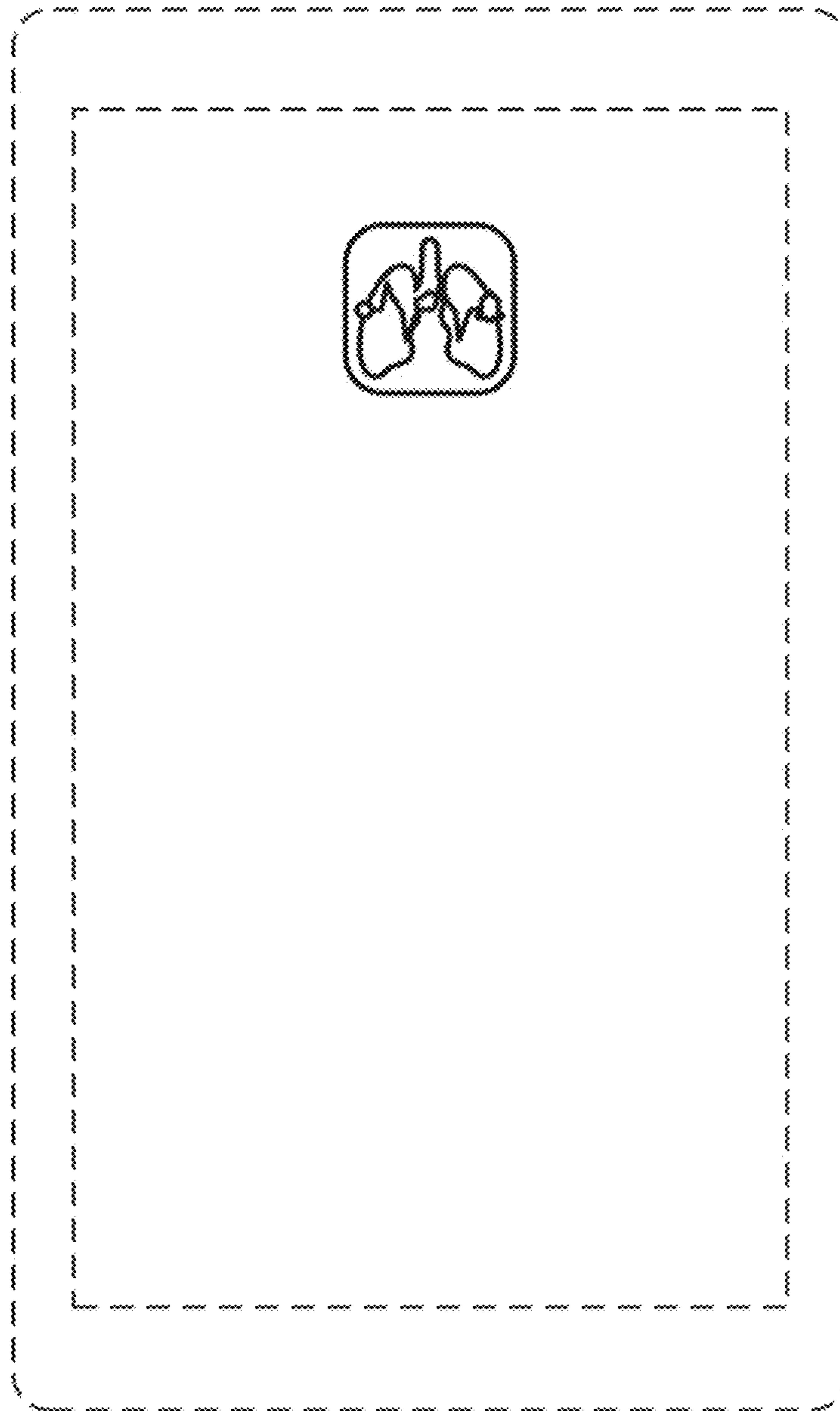

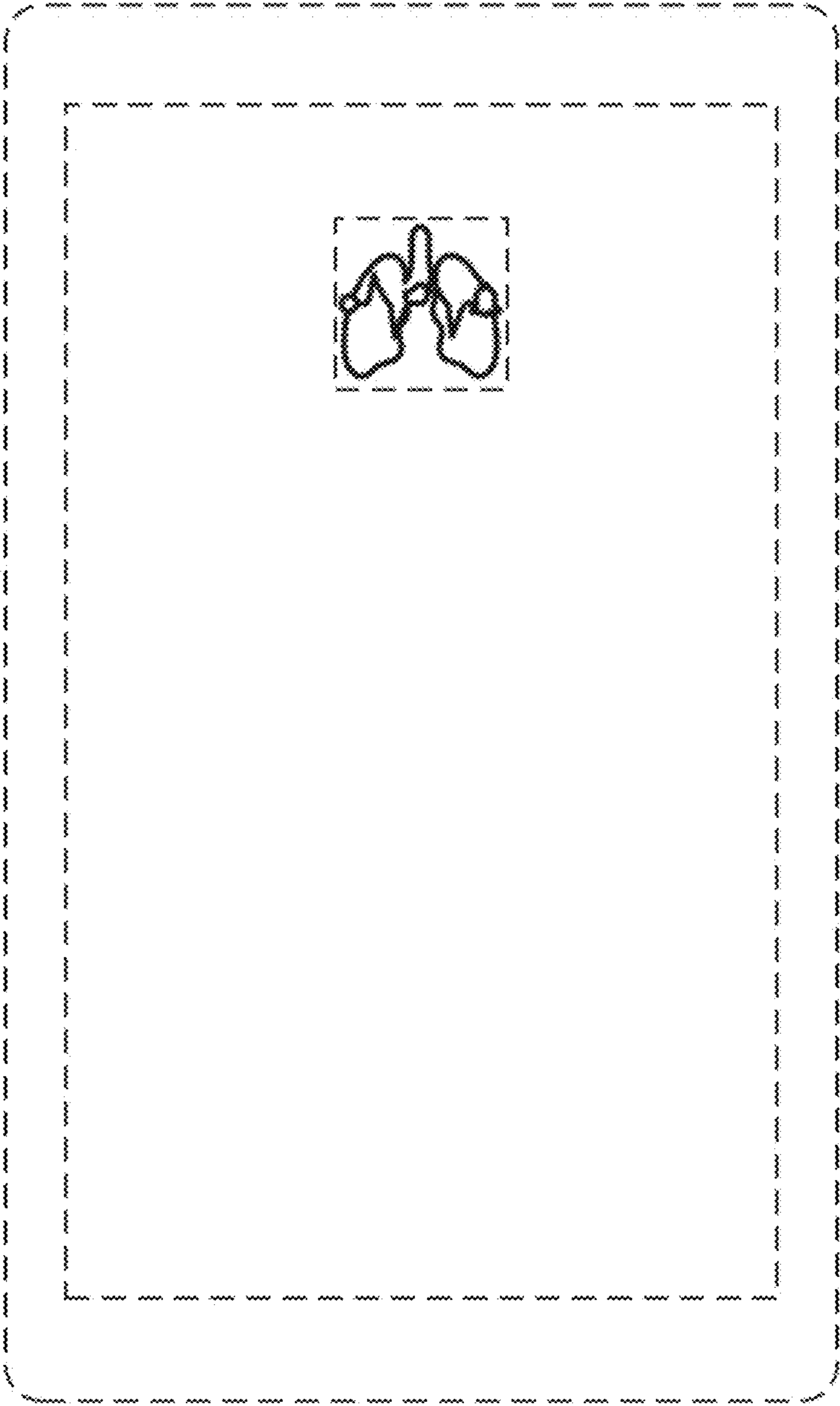

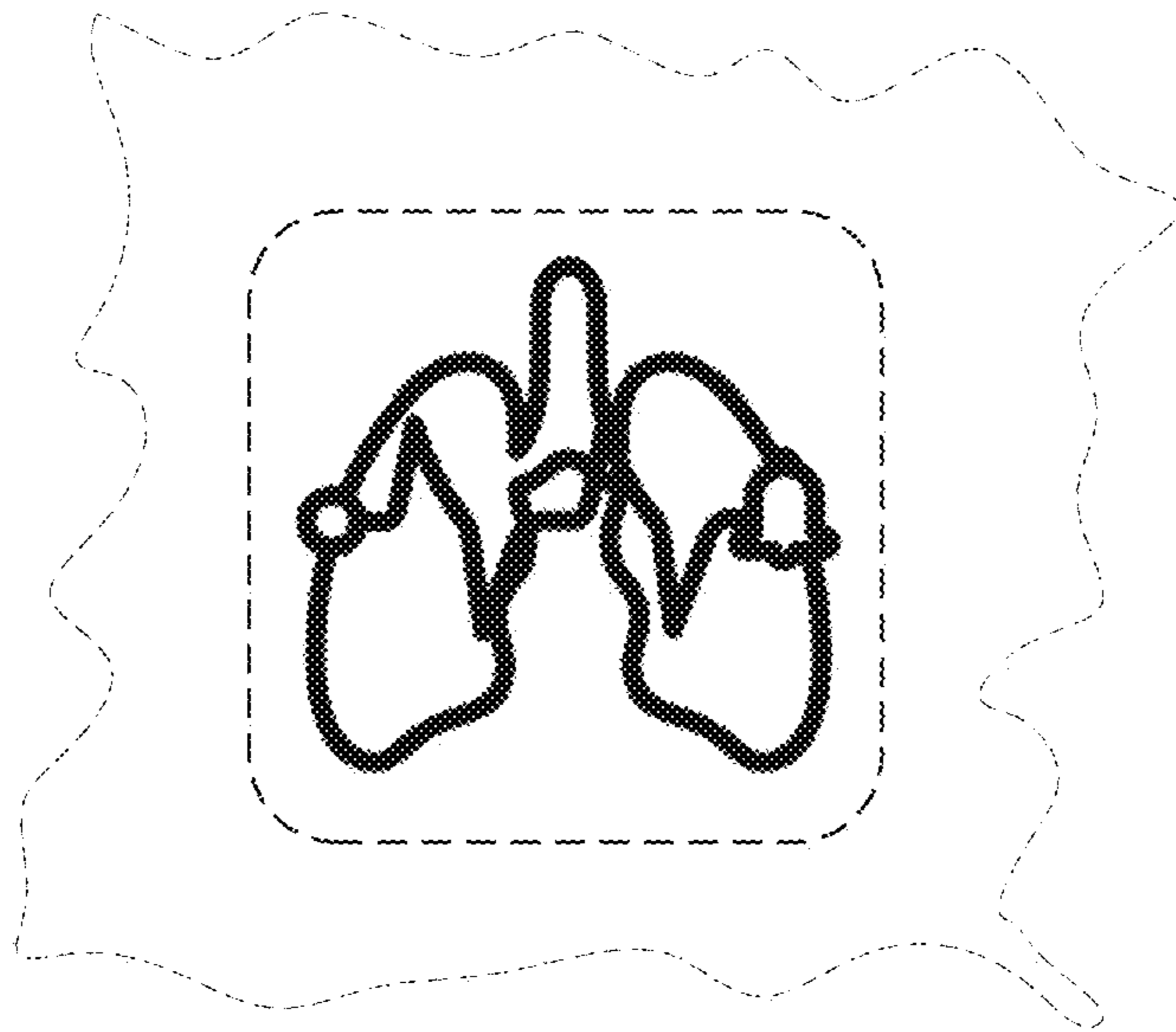
