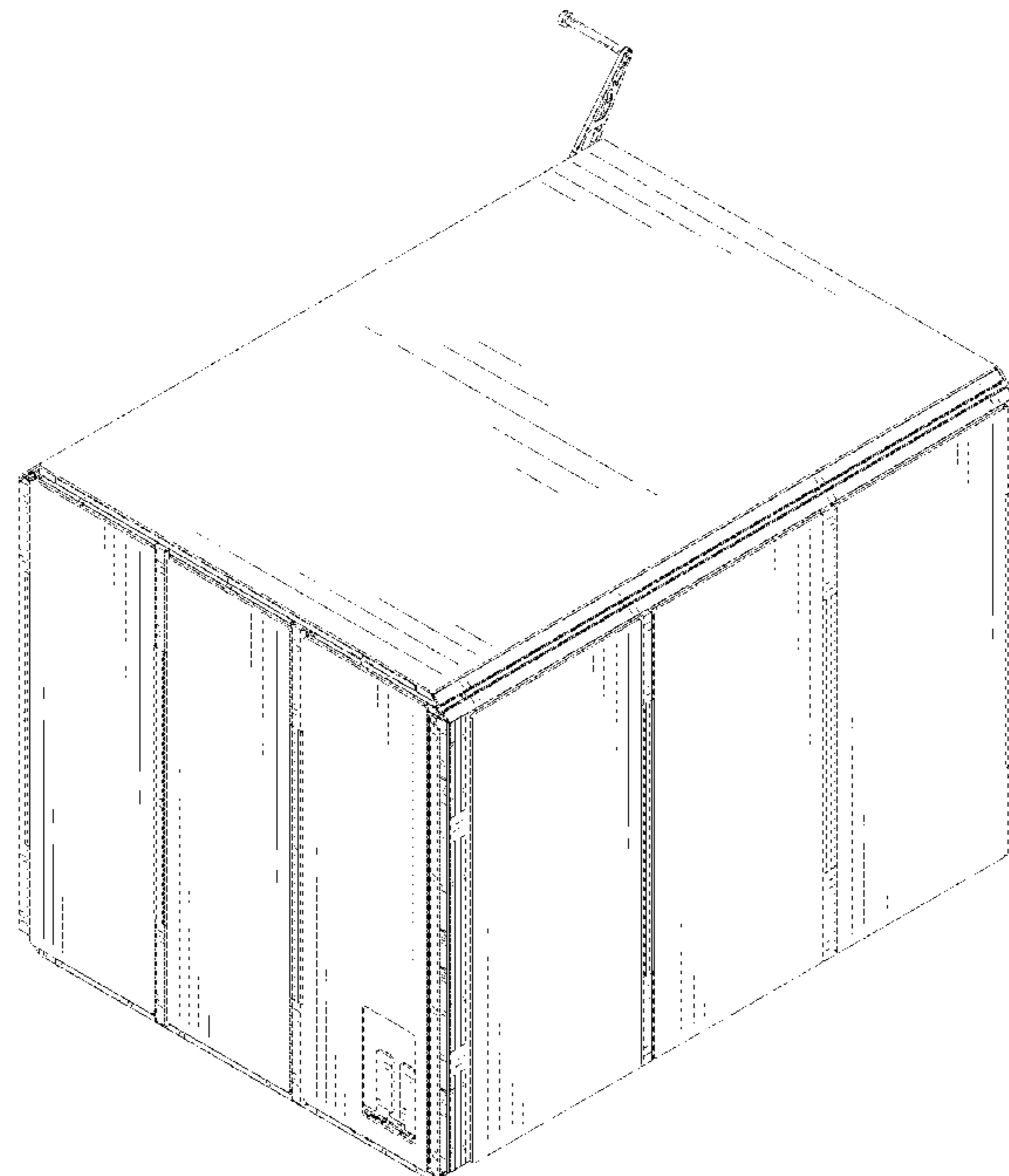
(57) **CLAIM**

The ornamental design for a three-dimensional printer housing, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a three-dimensional printer housing;
FIG. 2 is a rear perspective view thereof;

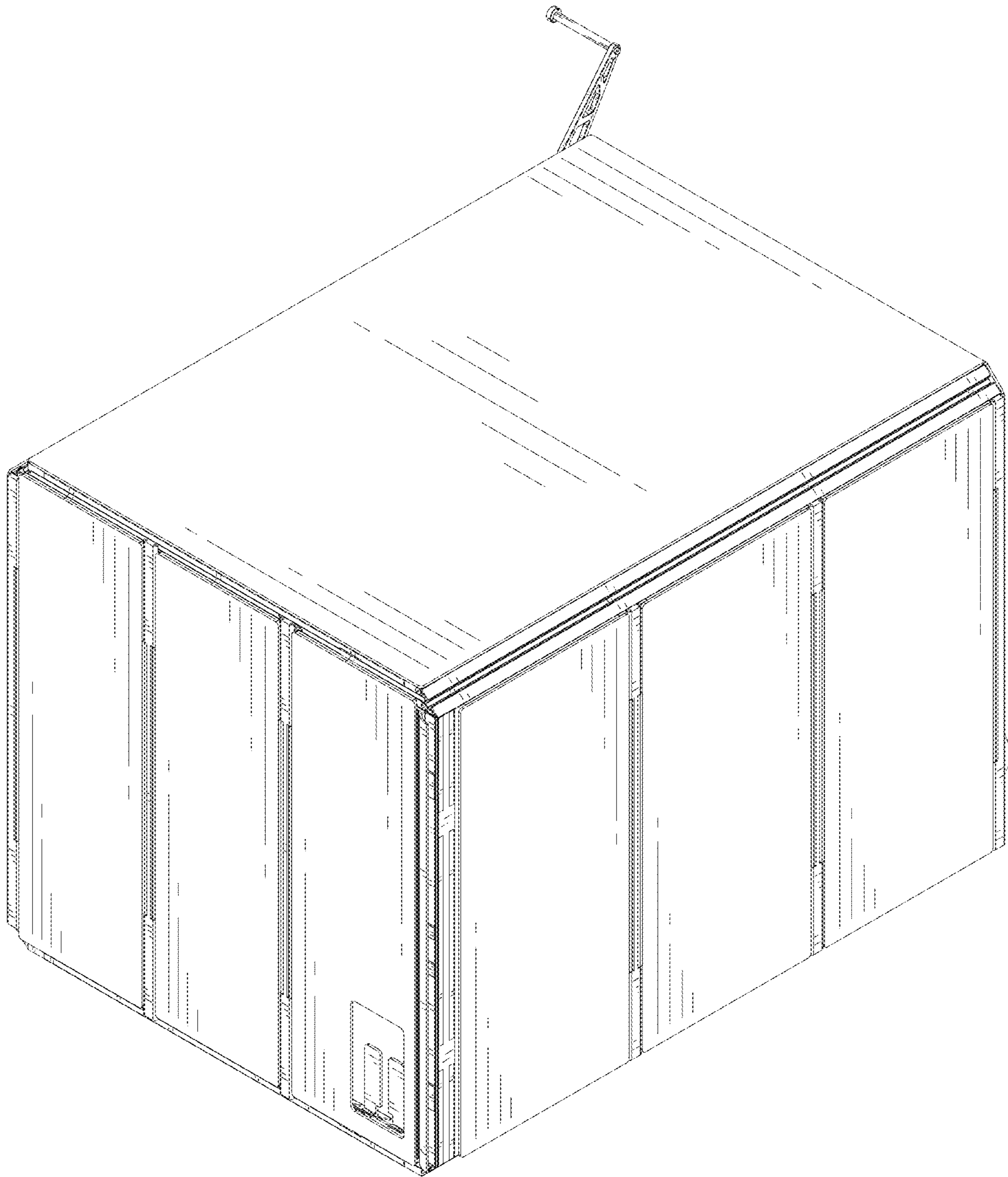

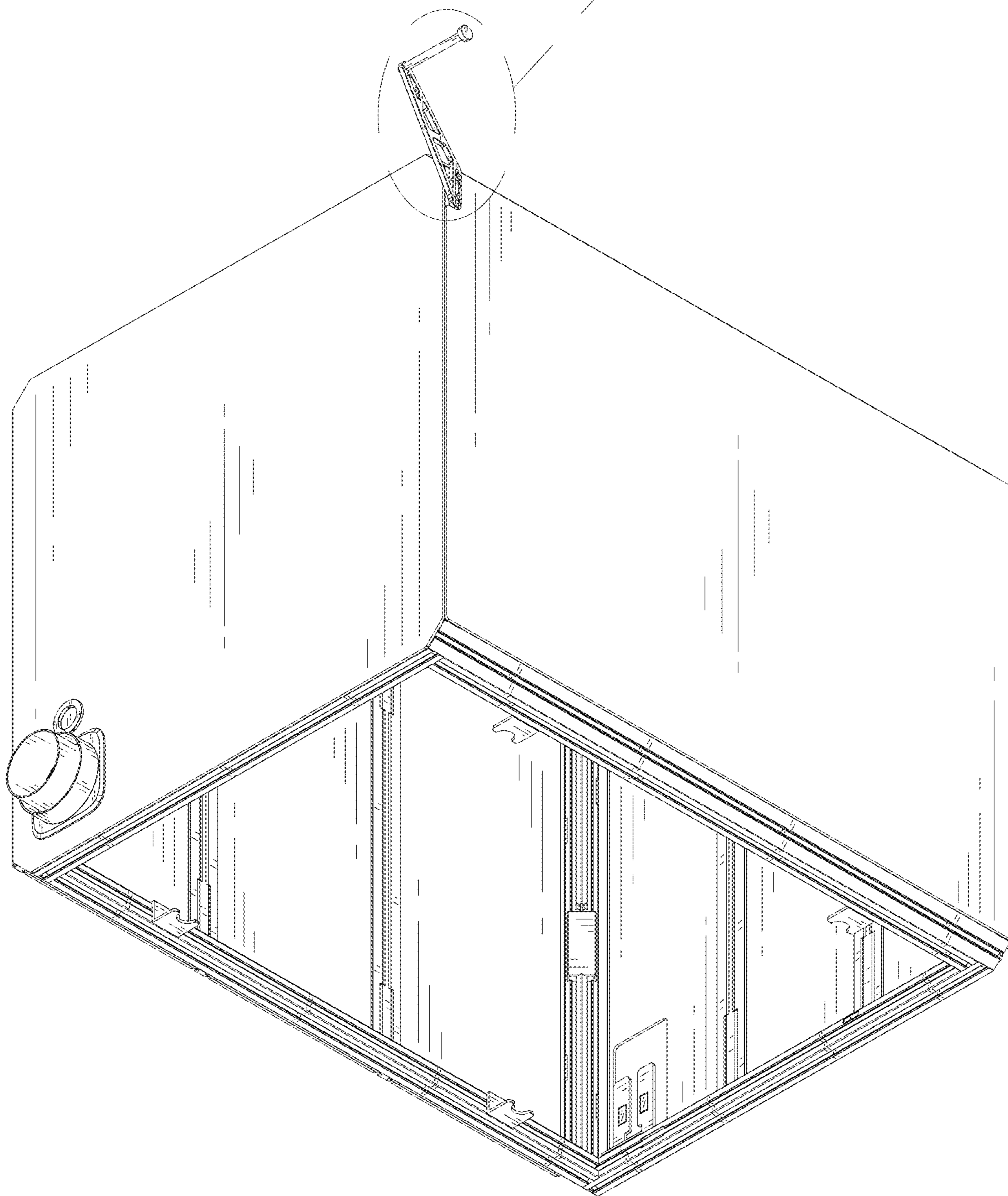

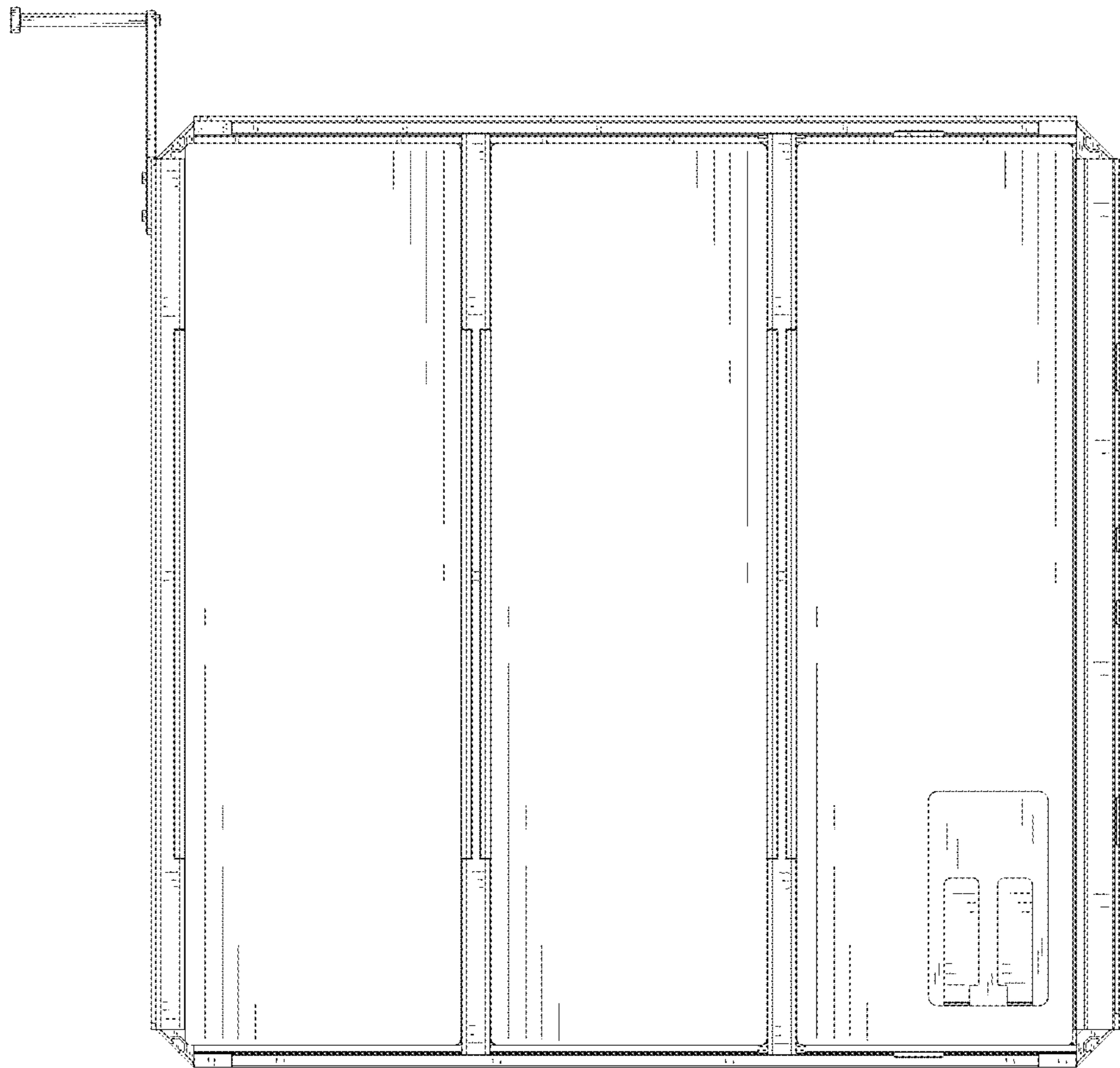

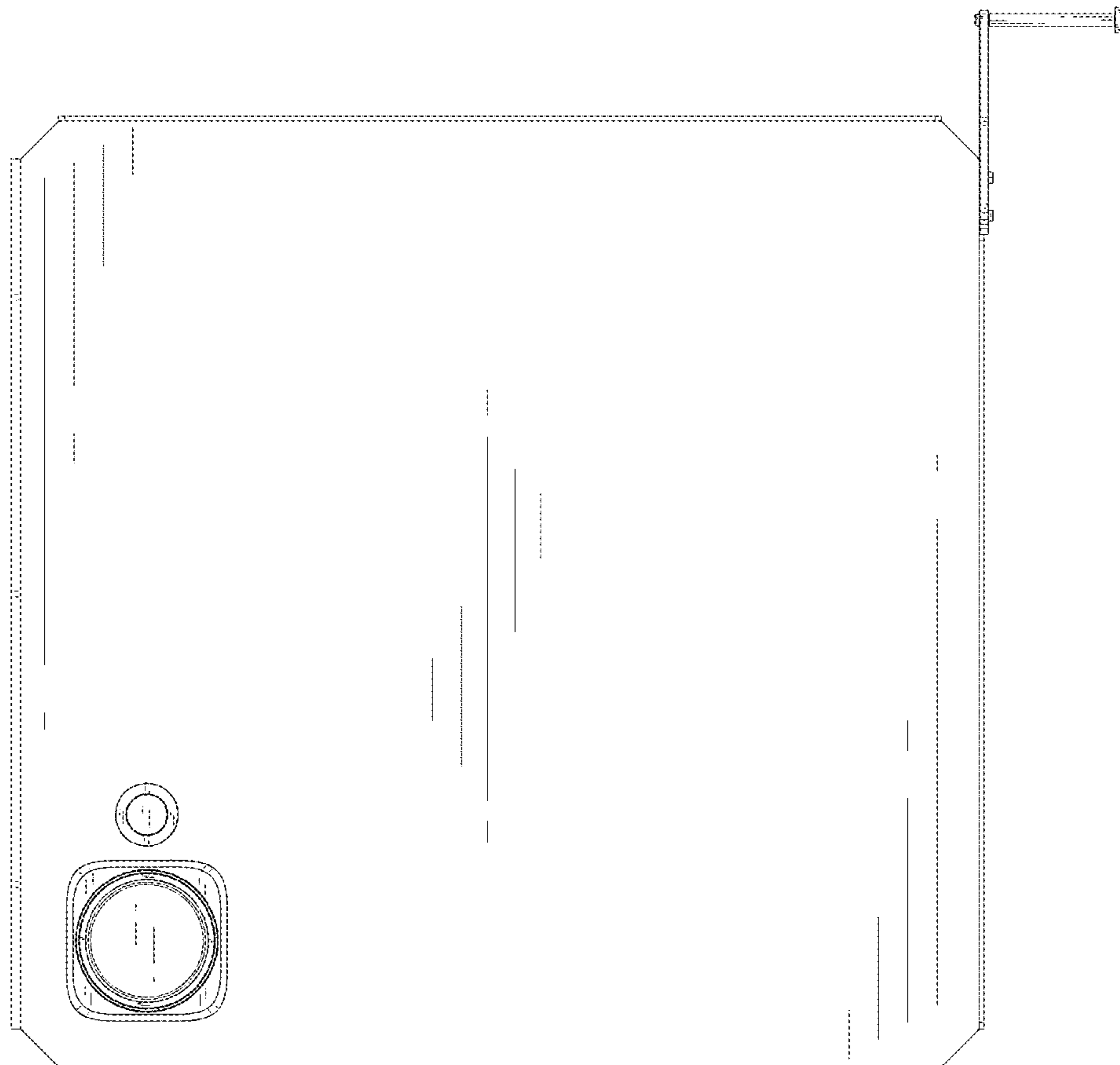

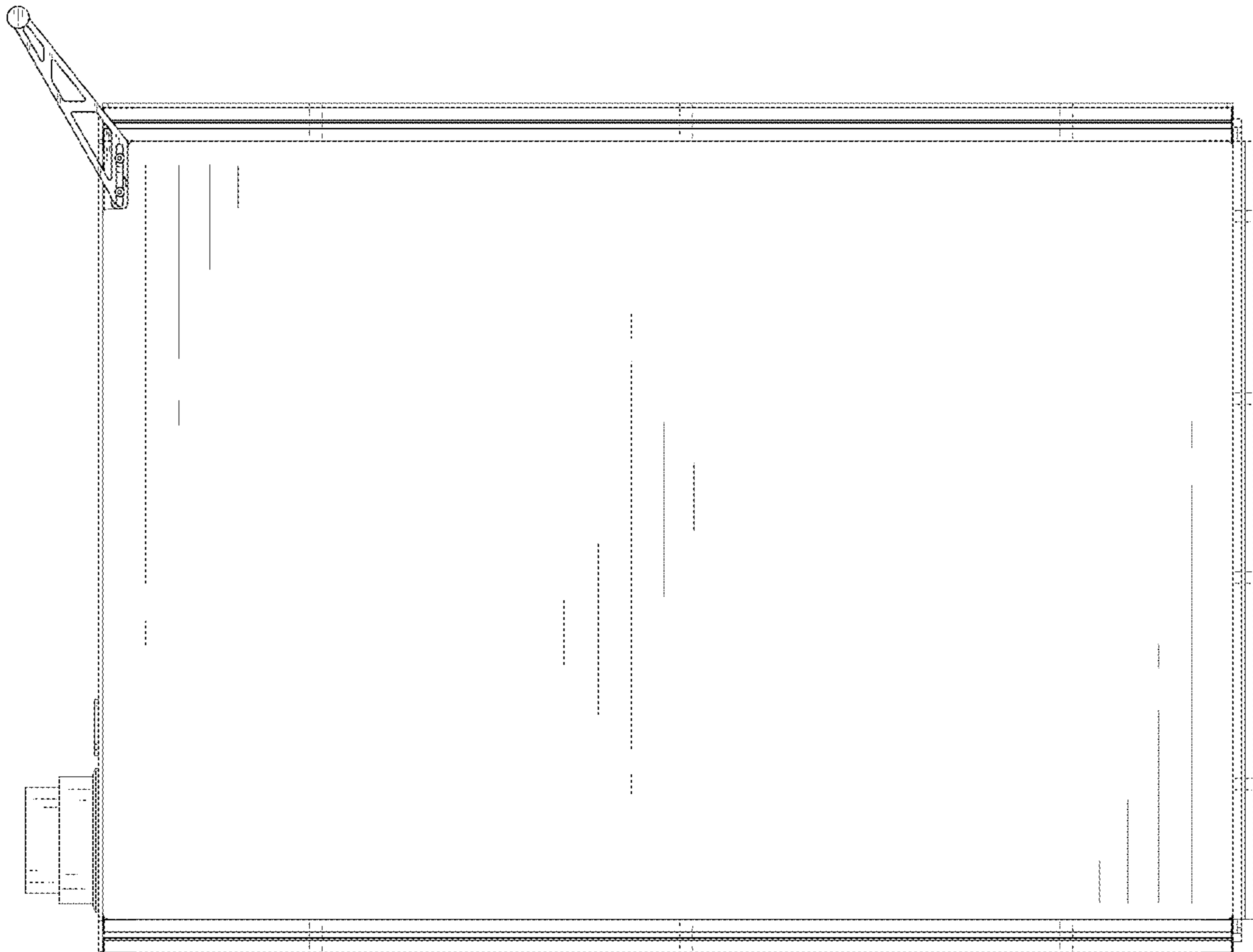

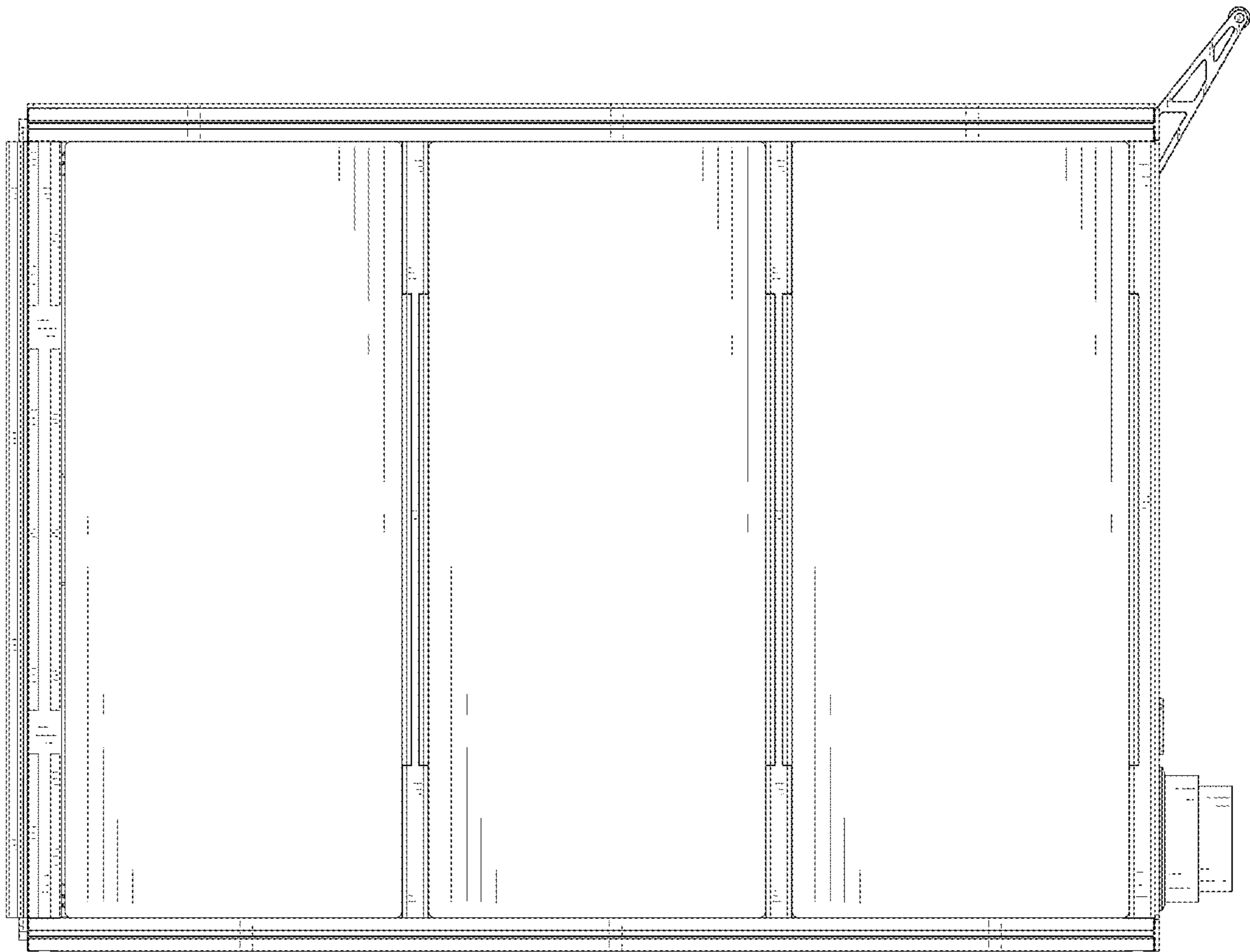

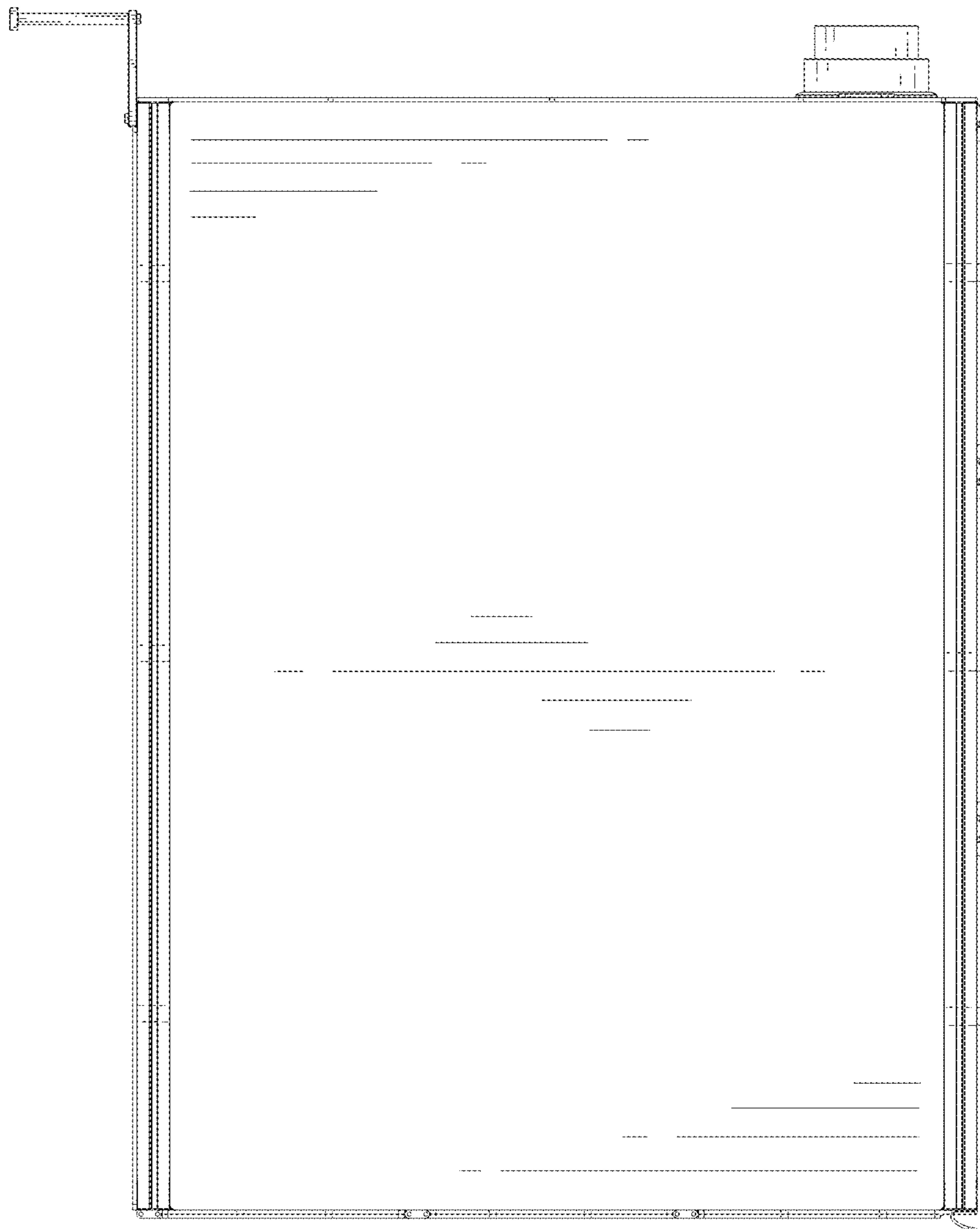

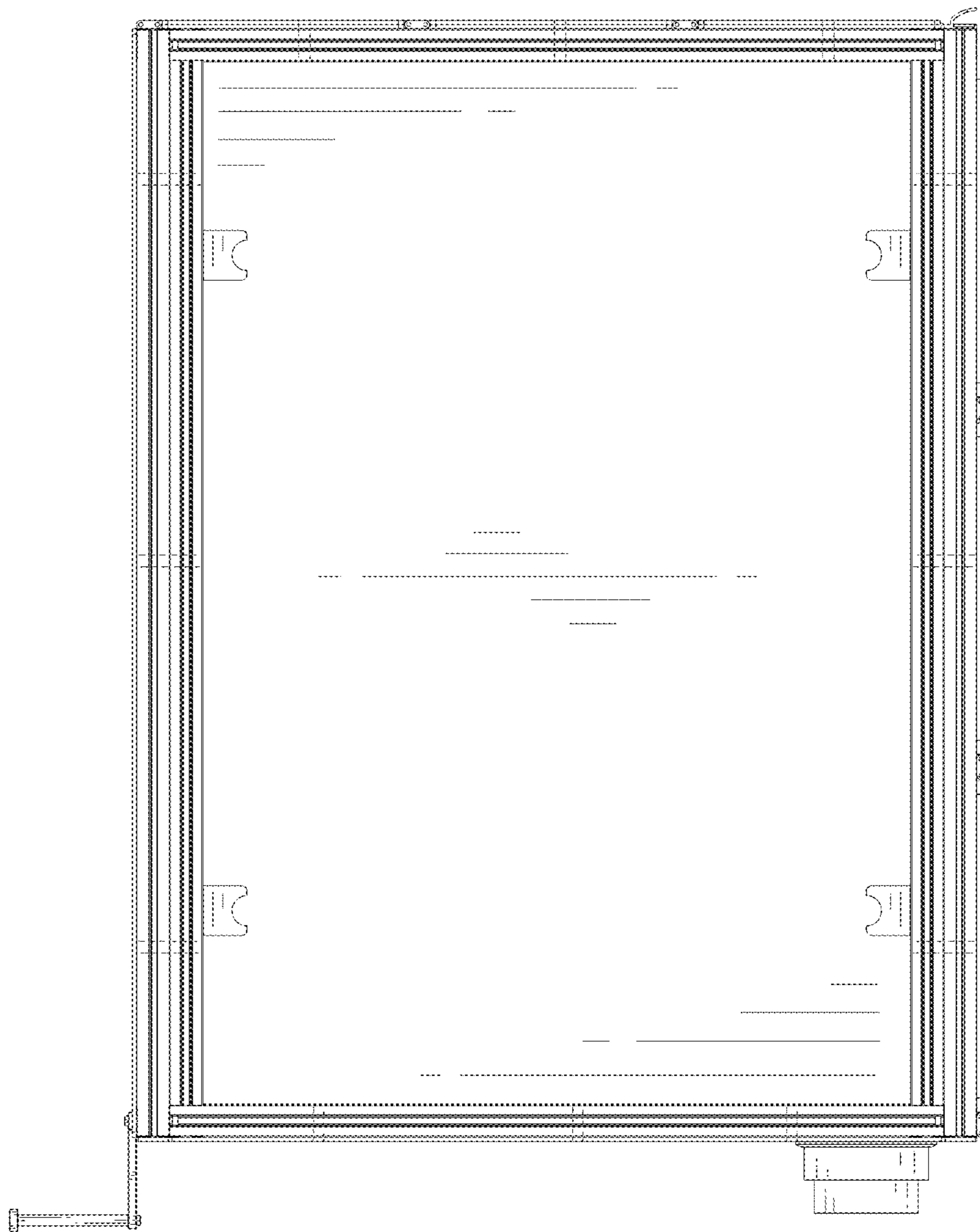

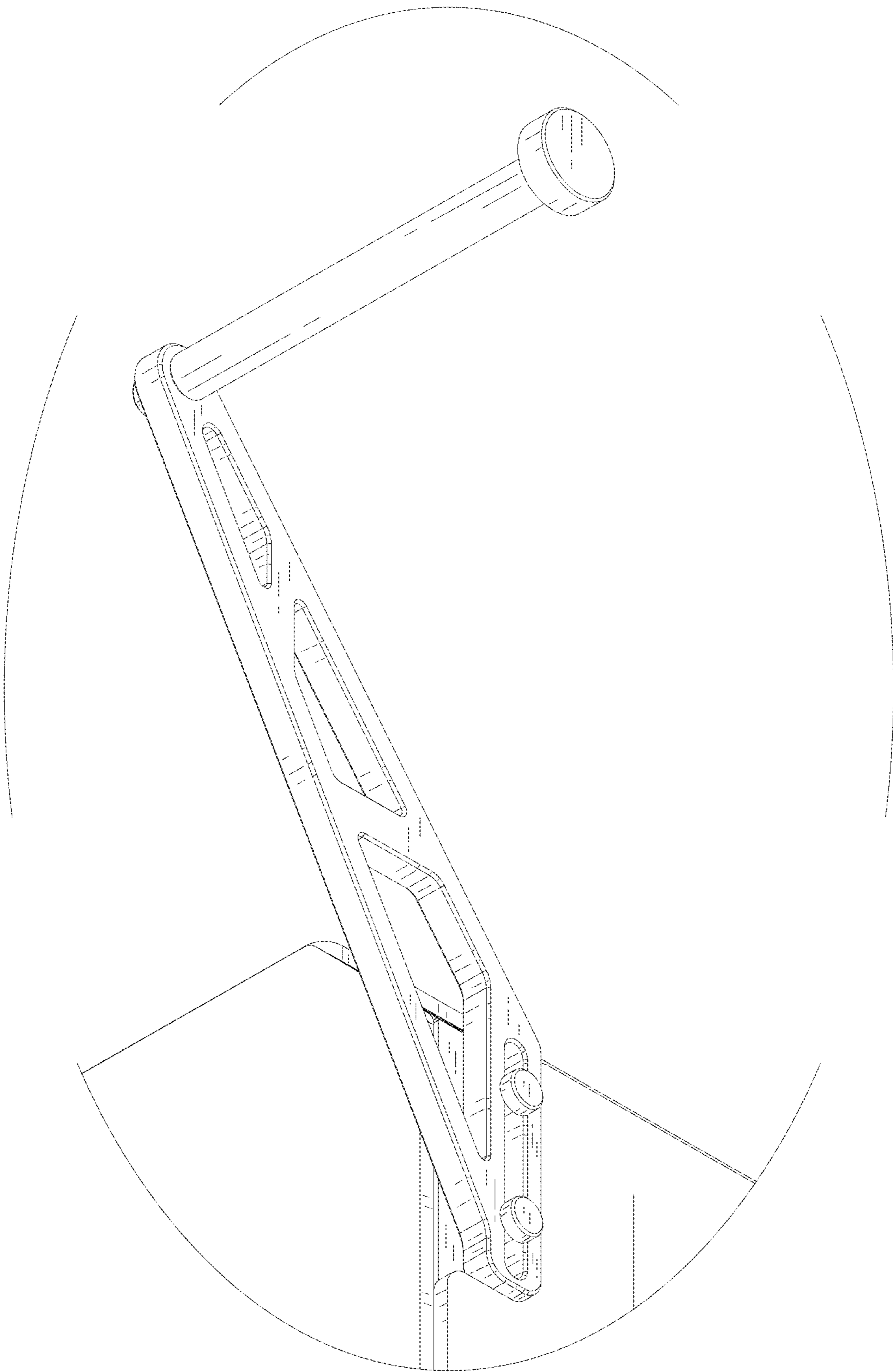
