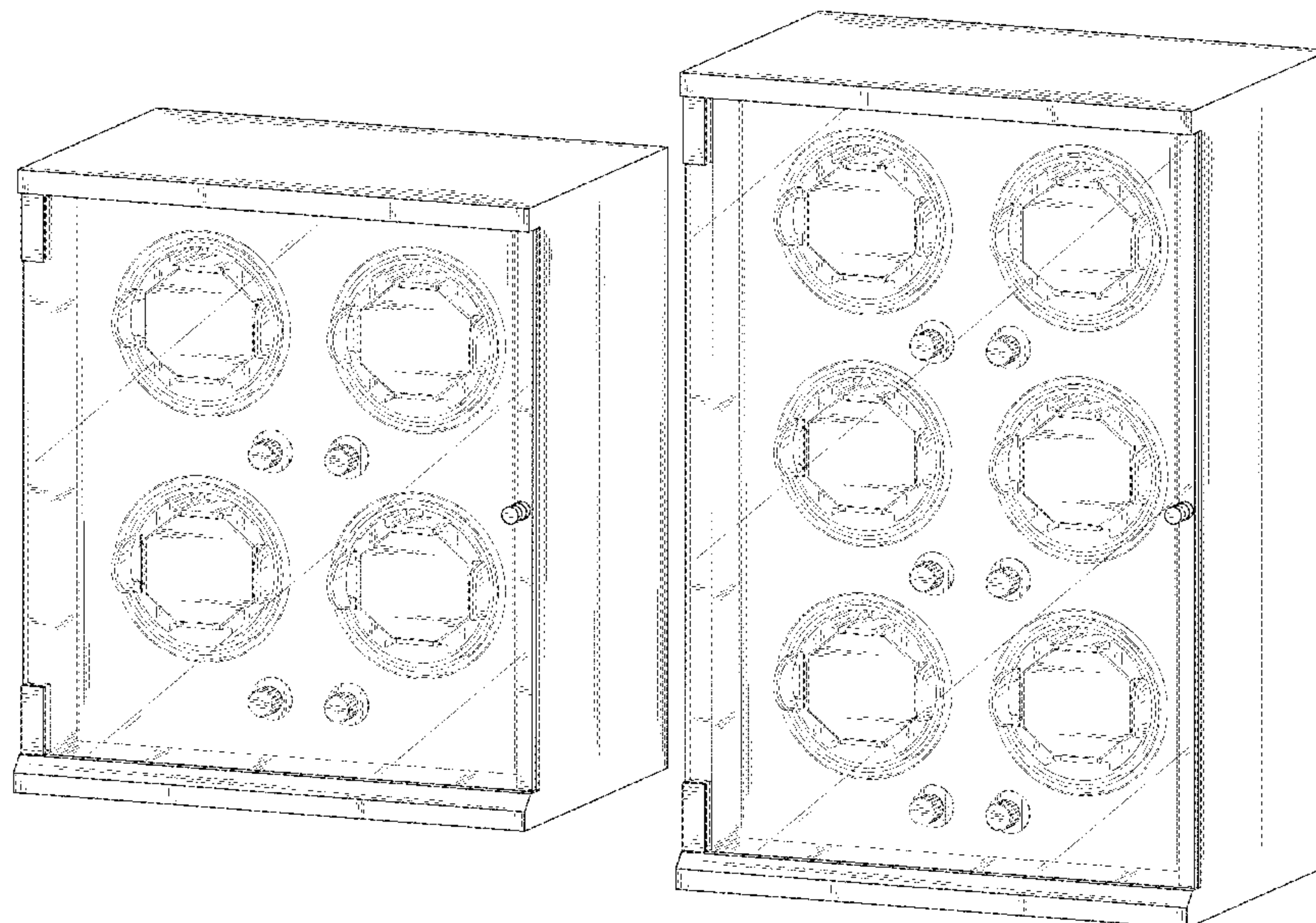
(57) **CLAIM**

The ornamental design for a winder for watches, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a winder for watches showing my new design according to a first embodiment; FIG. 2 is a rear perspective view of FIG. 1; FIG. 3 is a front elevational view of FIG. 1; FIG. 4 is a rear elevational view of FIG. 1; FIG. 5 is a left side elevational view of FIG. 1; FIG. 6 is a right side elevational view of FIG. 1; FIG. 7 is a top plan view of FIG. 1; FIG. 8 is a bottom plan view of FIG. 1; FIG. 9 is a front perspective view of a winder for watches showing my new design according to a second embodiment; FIG. 10 is a rear perspective view of FIG. 9; FIG. 11 is a front elevational view of FIG. 9; FIG. 12 is a rear elevational view of FIG. 9; FIG. 13 is a left side elevational view of FIG. 9; FIG. 14 is a right side elevational view of FIG. 9; FIG. 15 is a top plan view of FIG. 9; and, FIG. 16 is a bottom plan view of FIG. 9. The broken lines in the drawings illustrate the portions of the winder for watches which form no part of the claimed design.

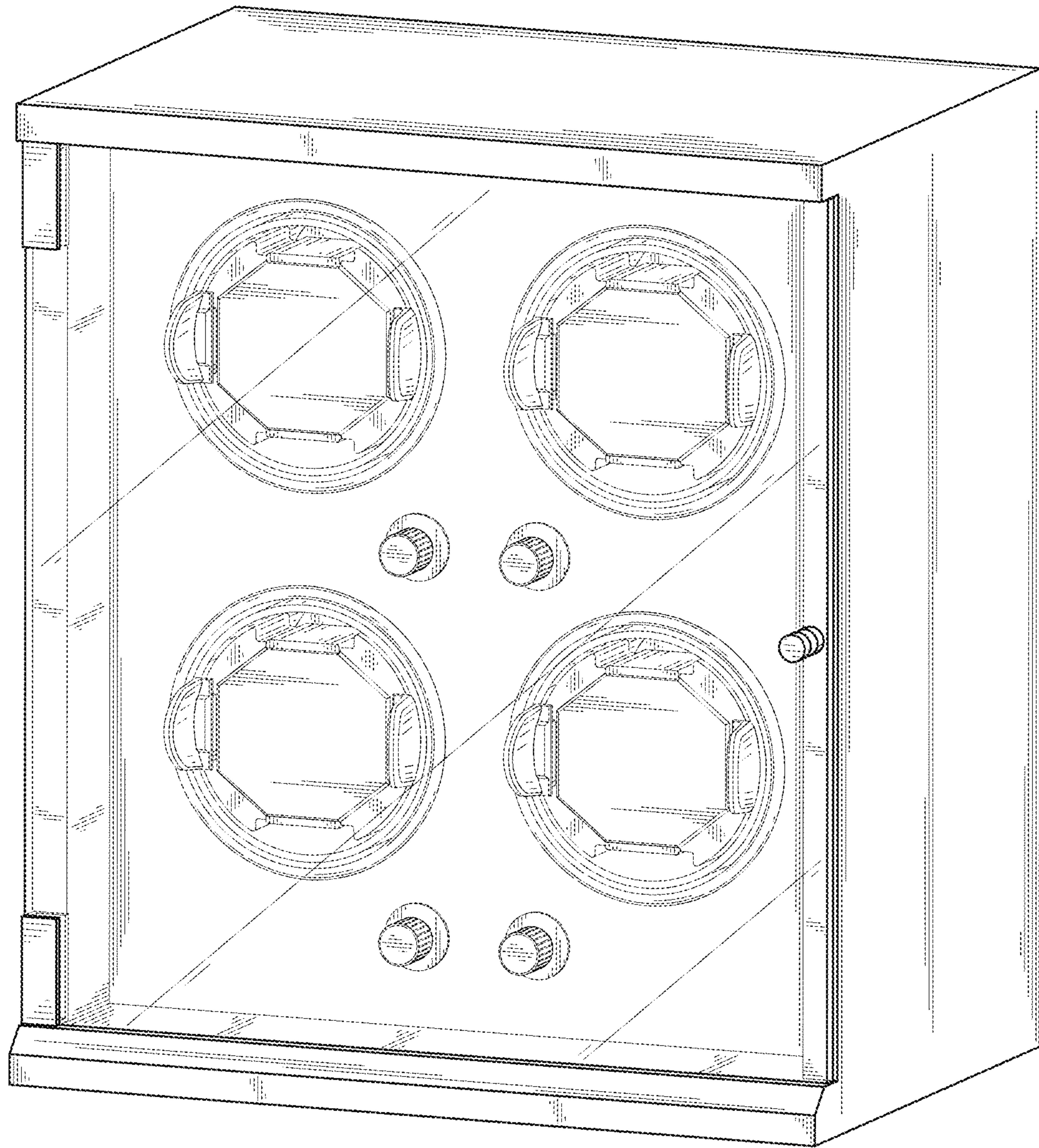

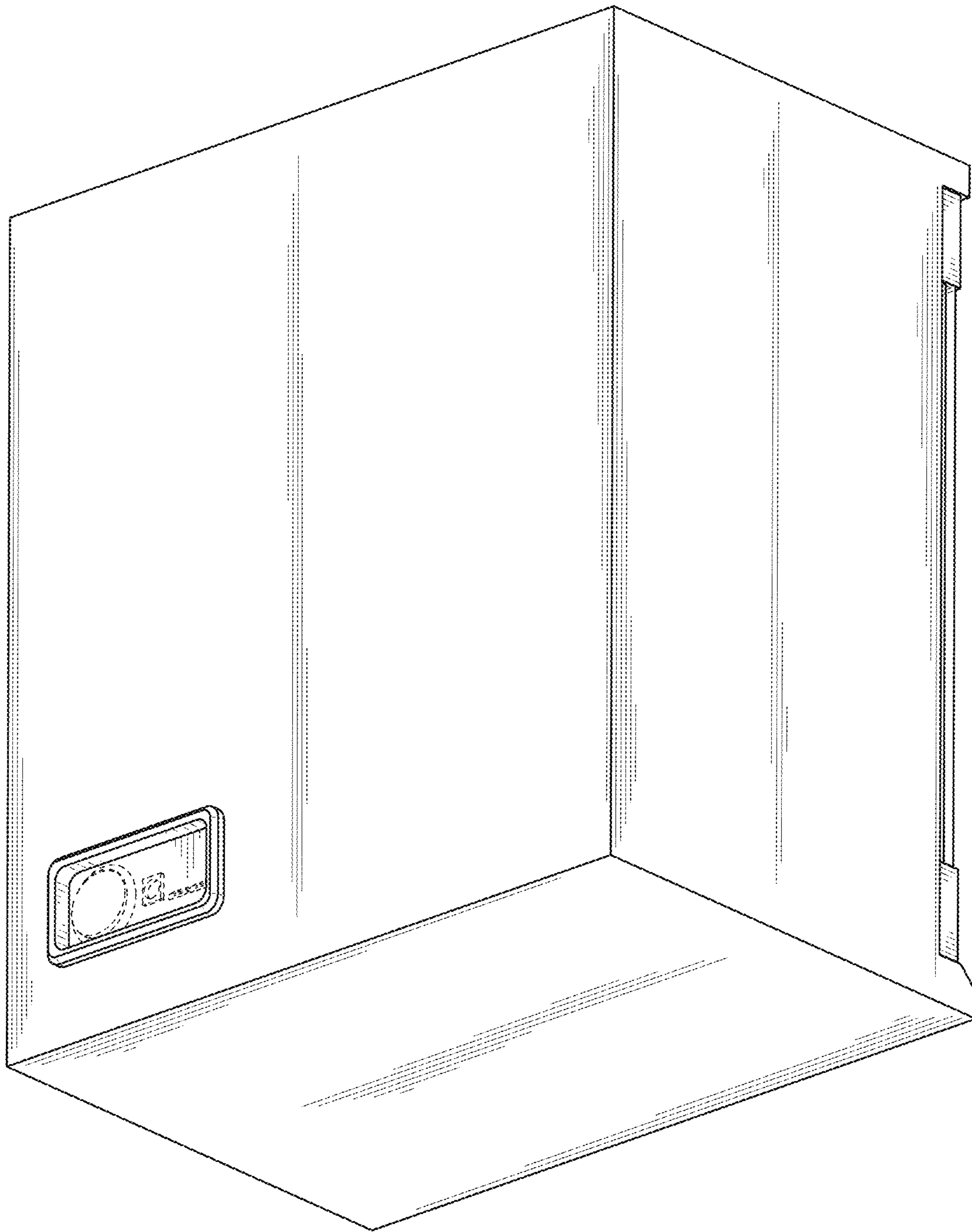

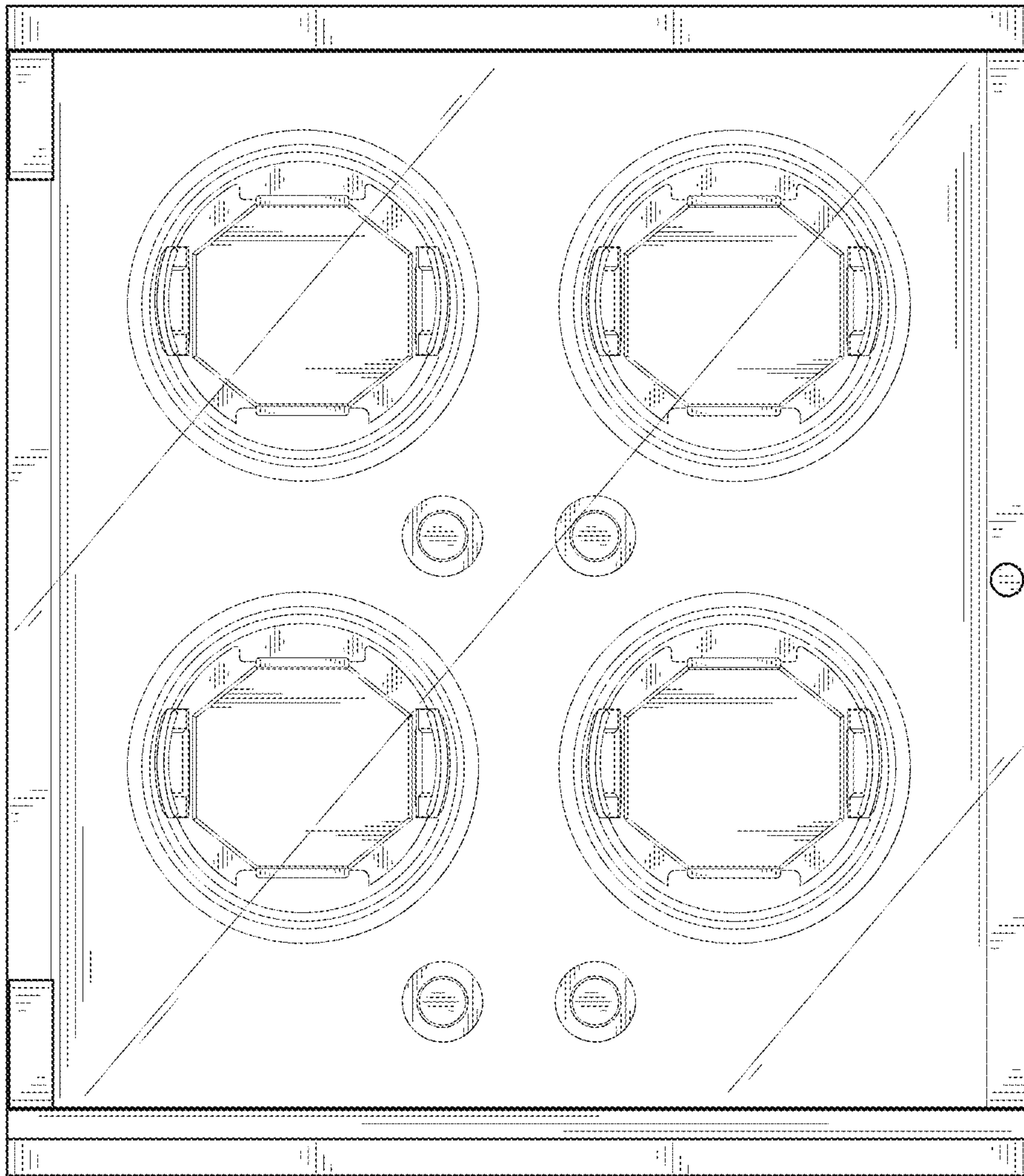

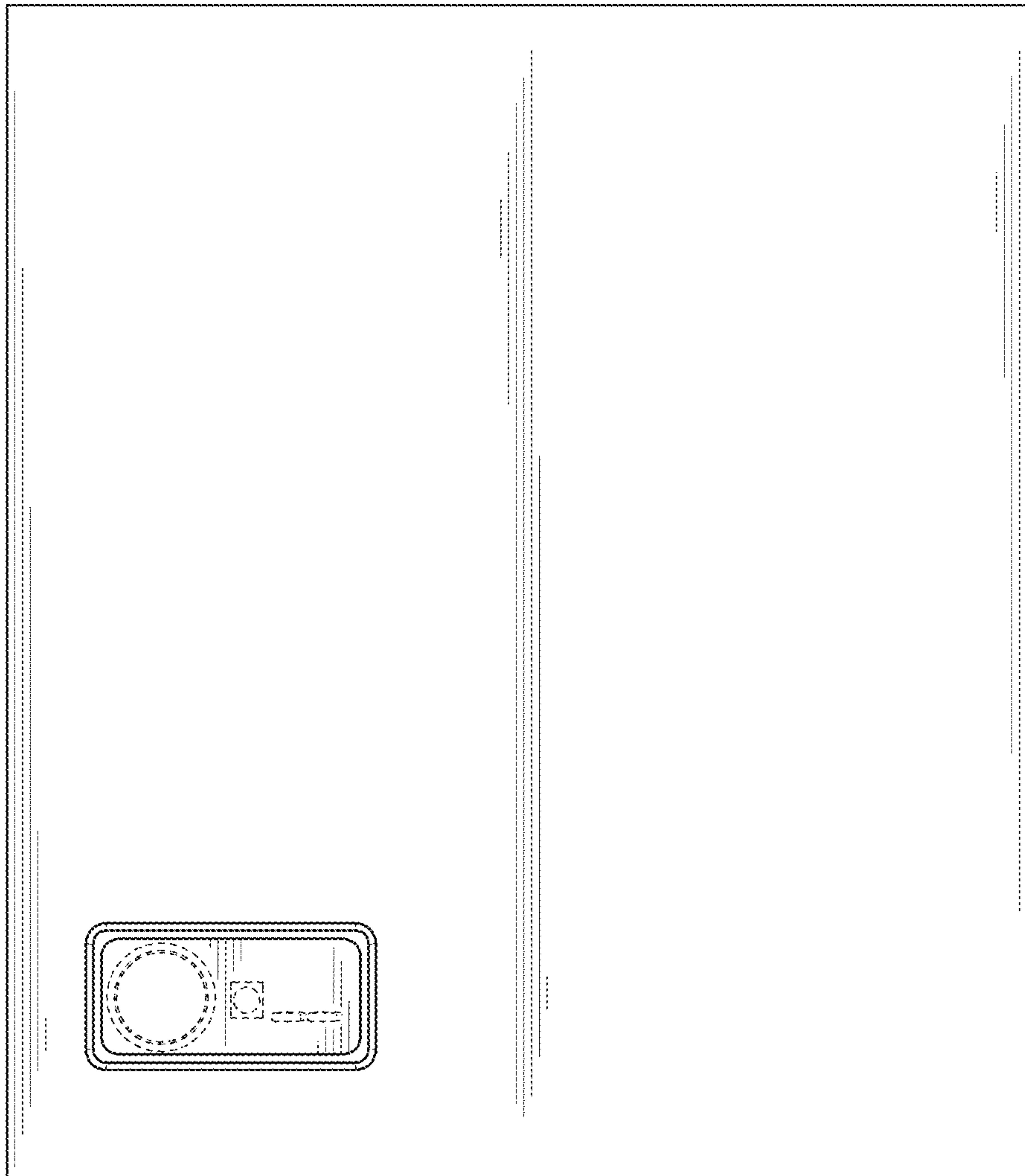

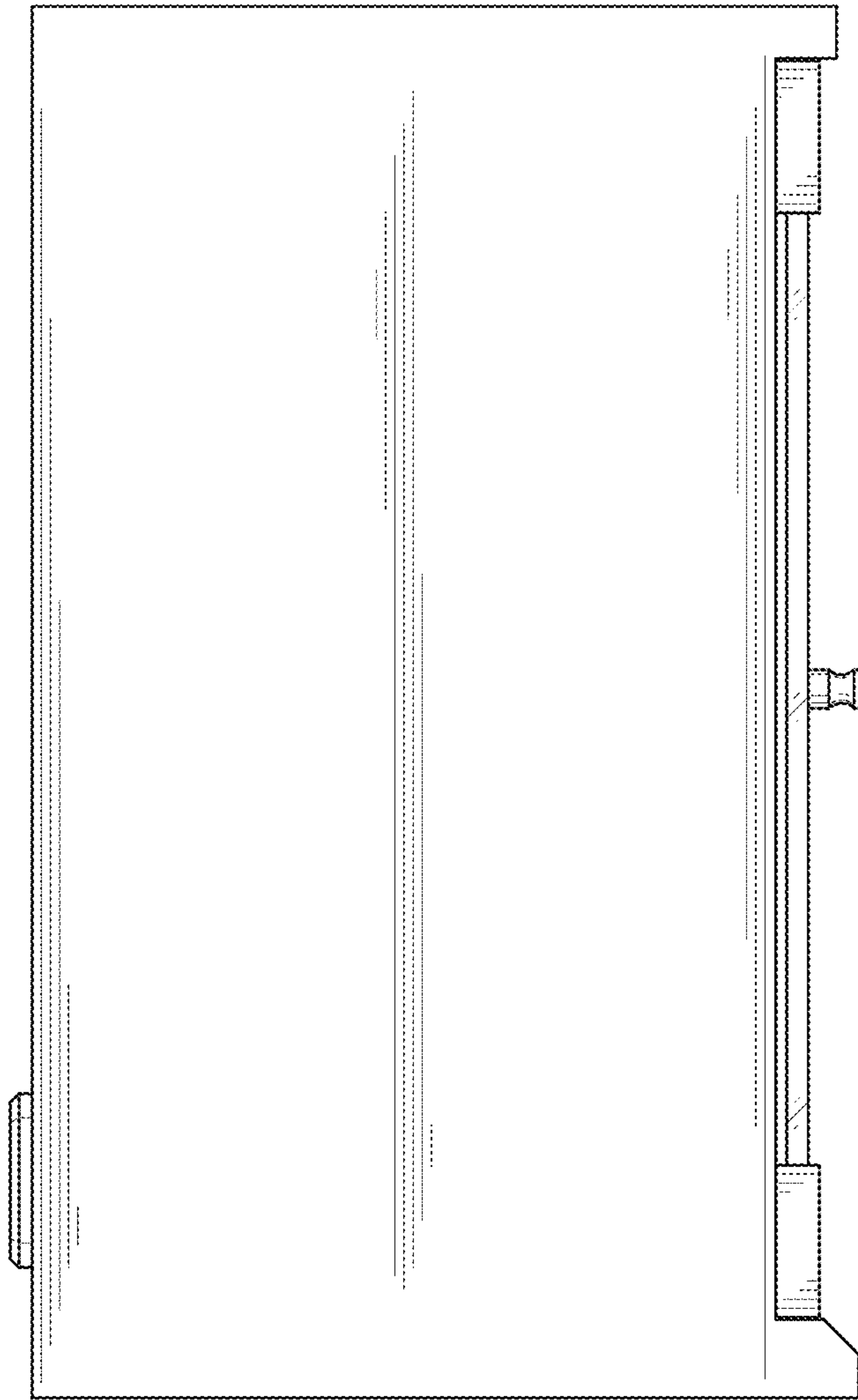

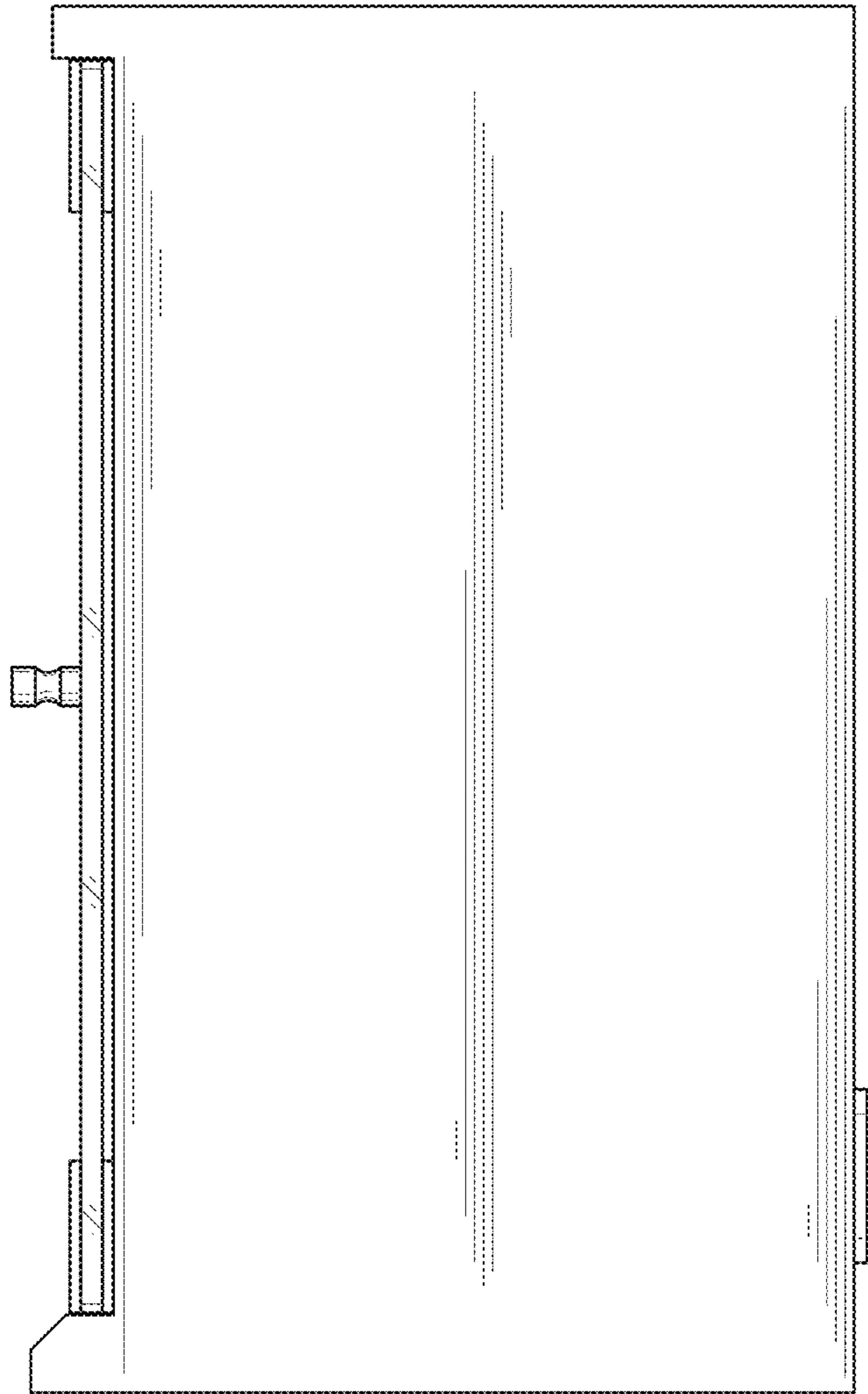

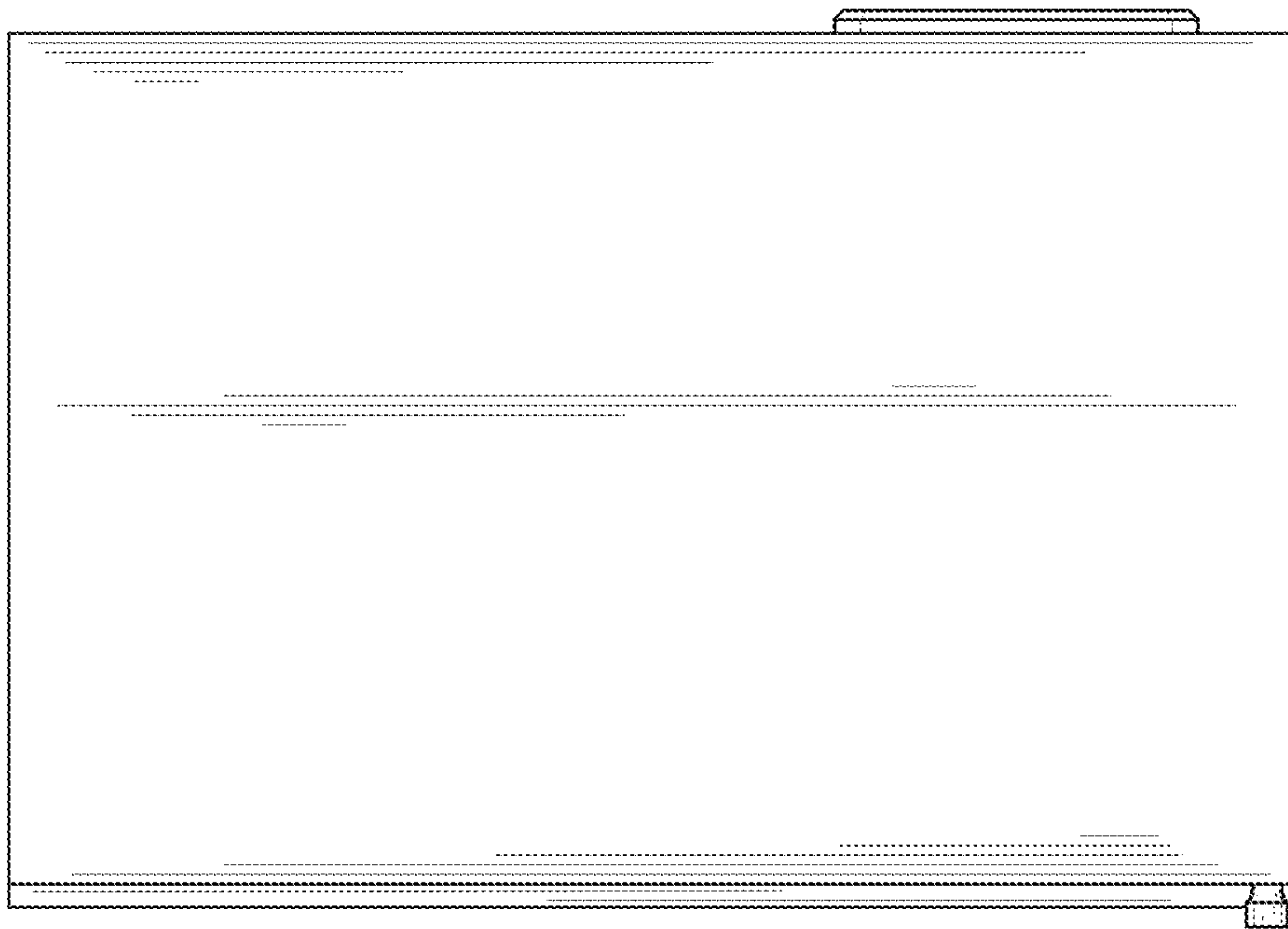

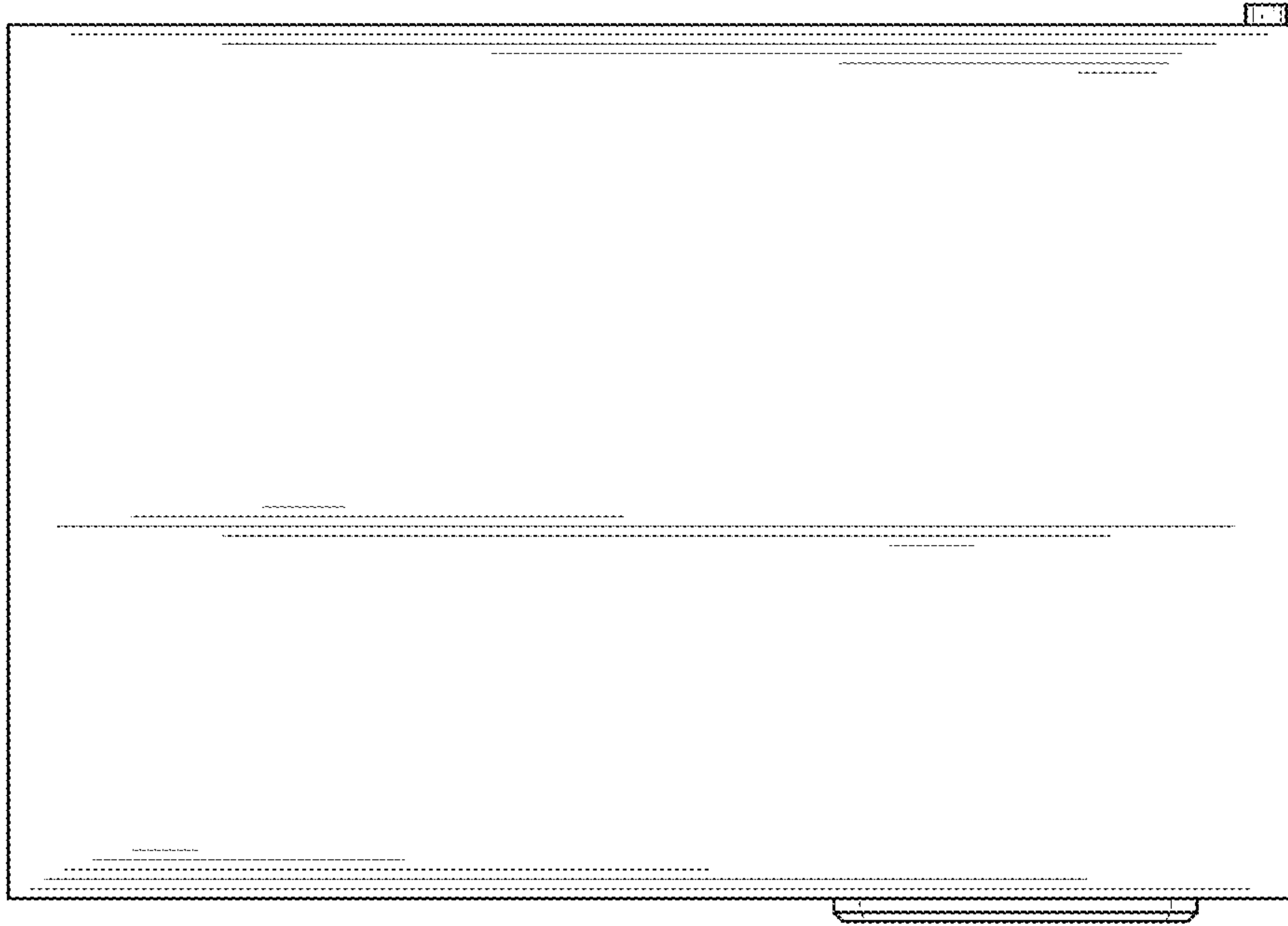

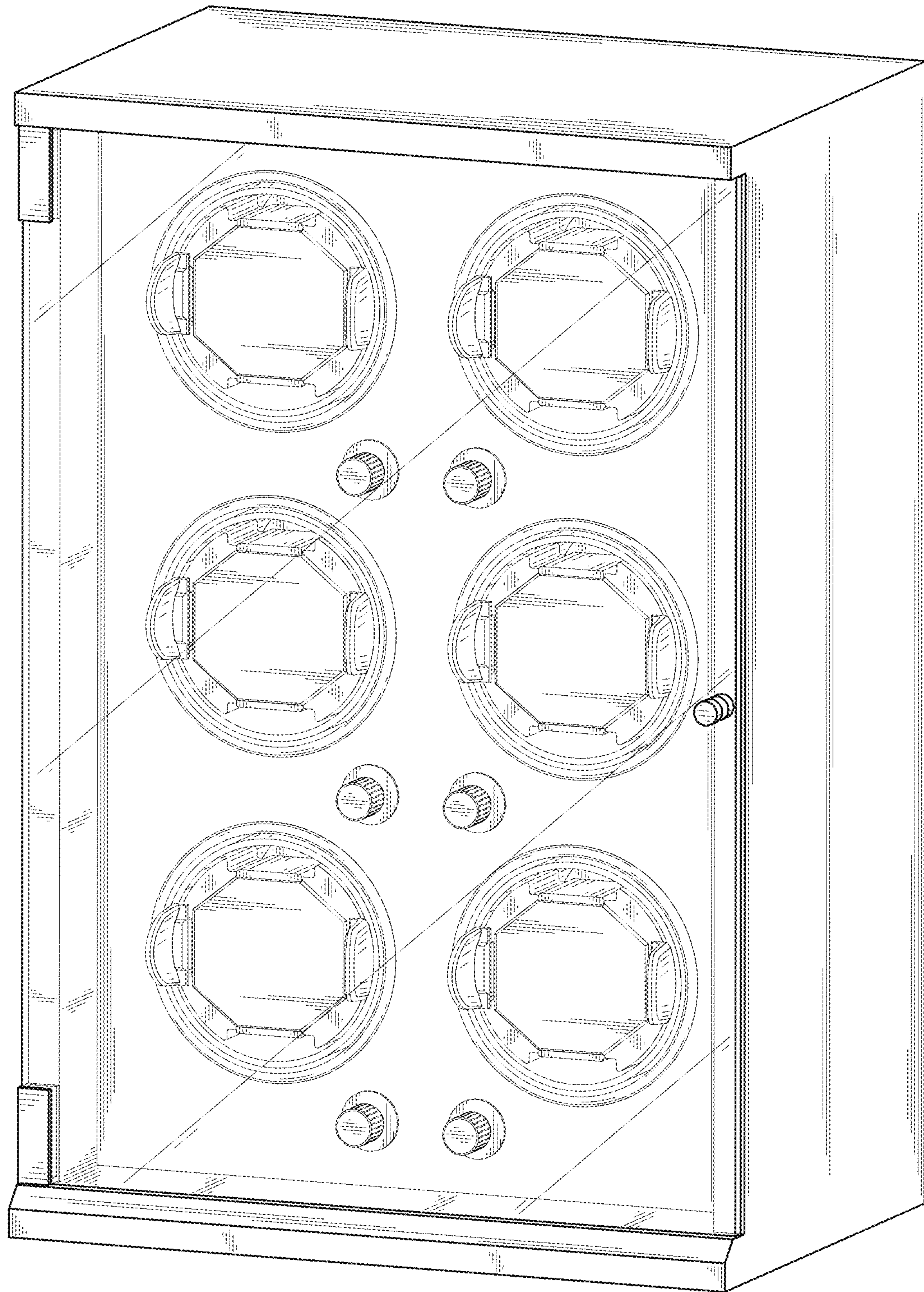

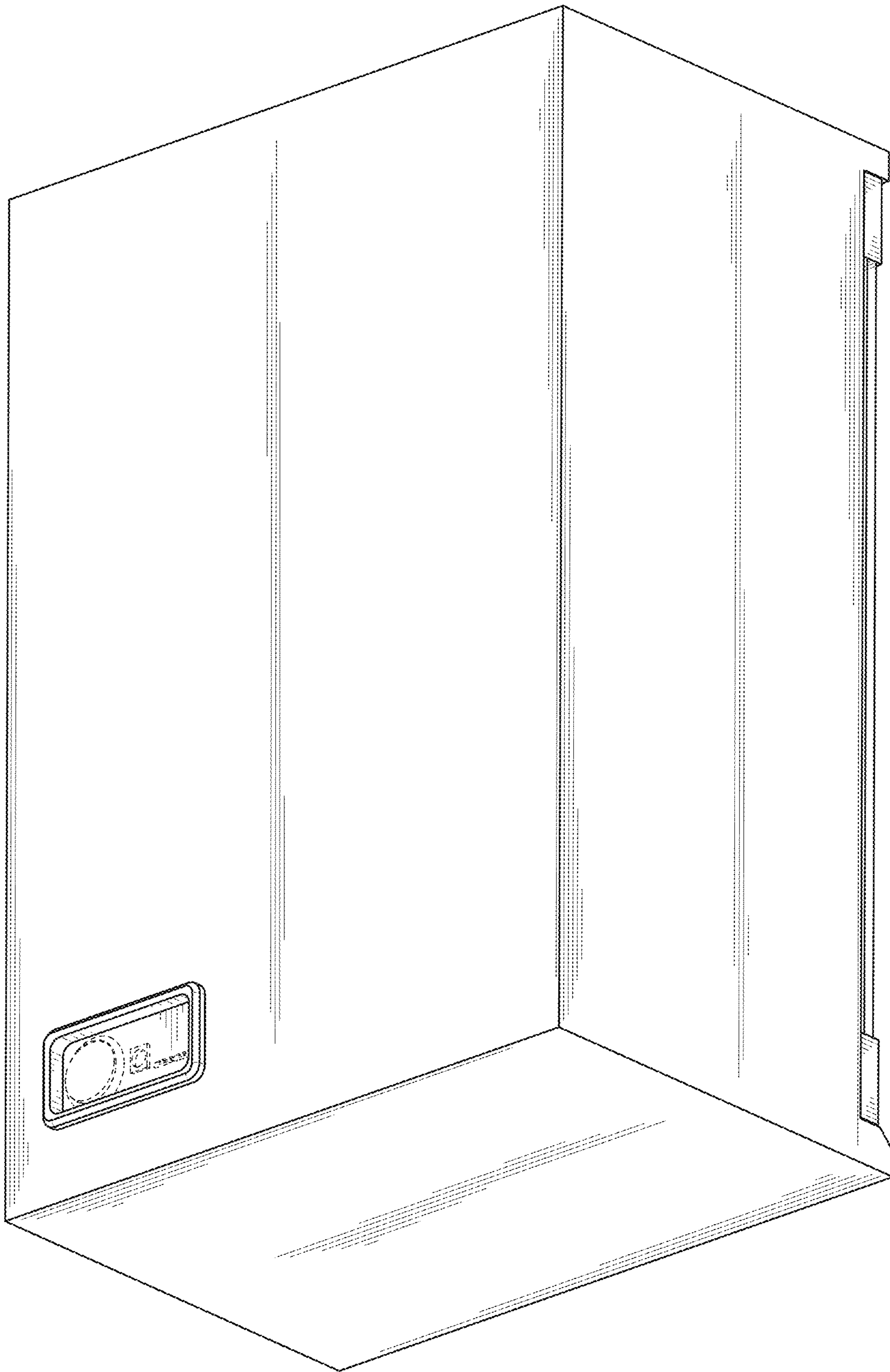

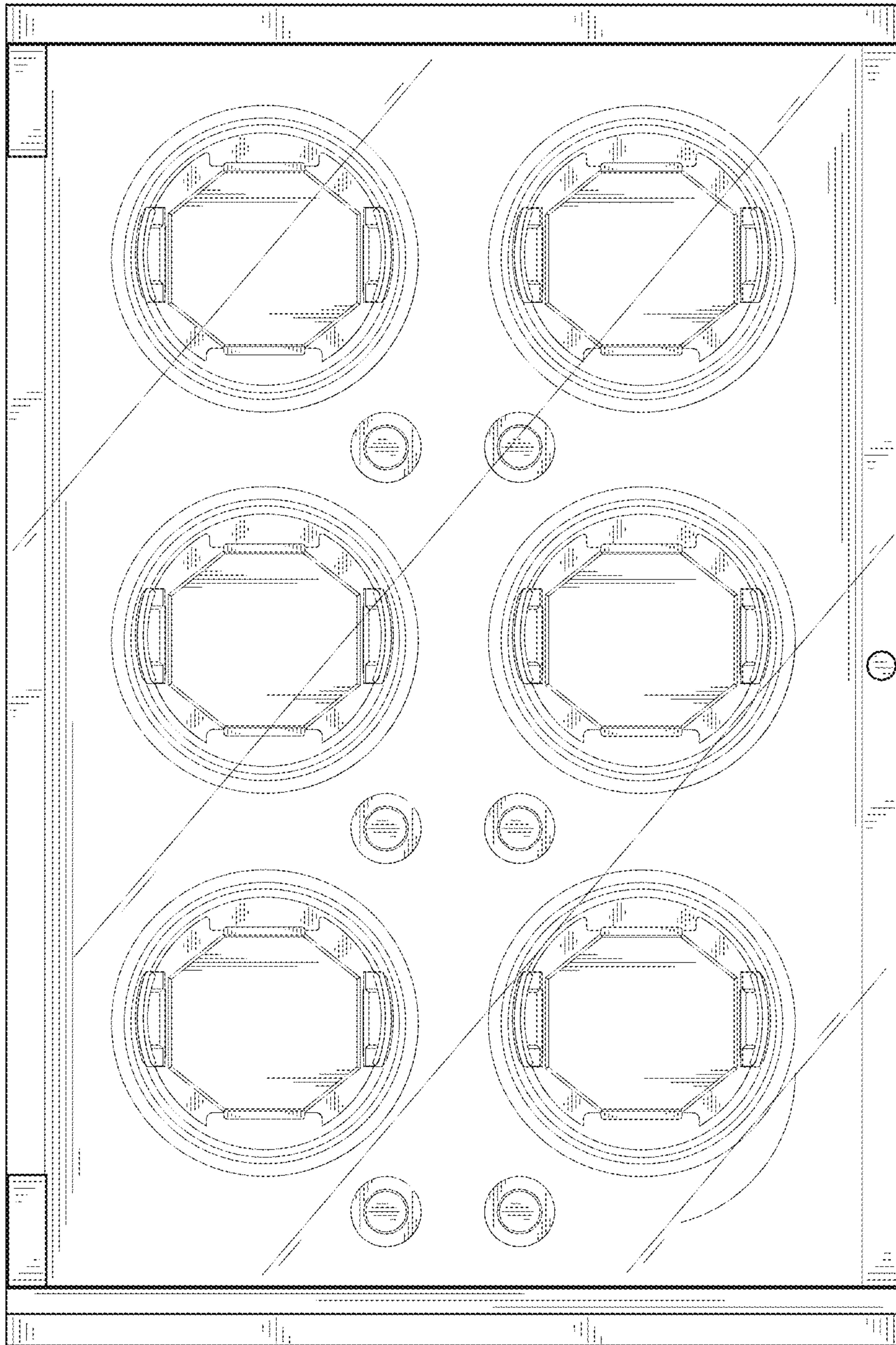

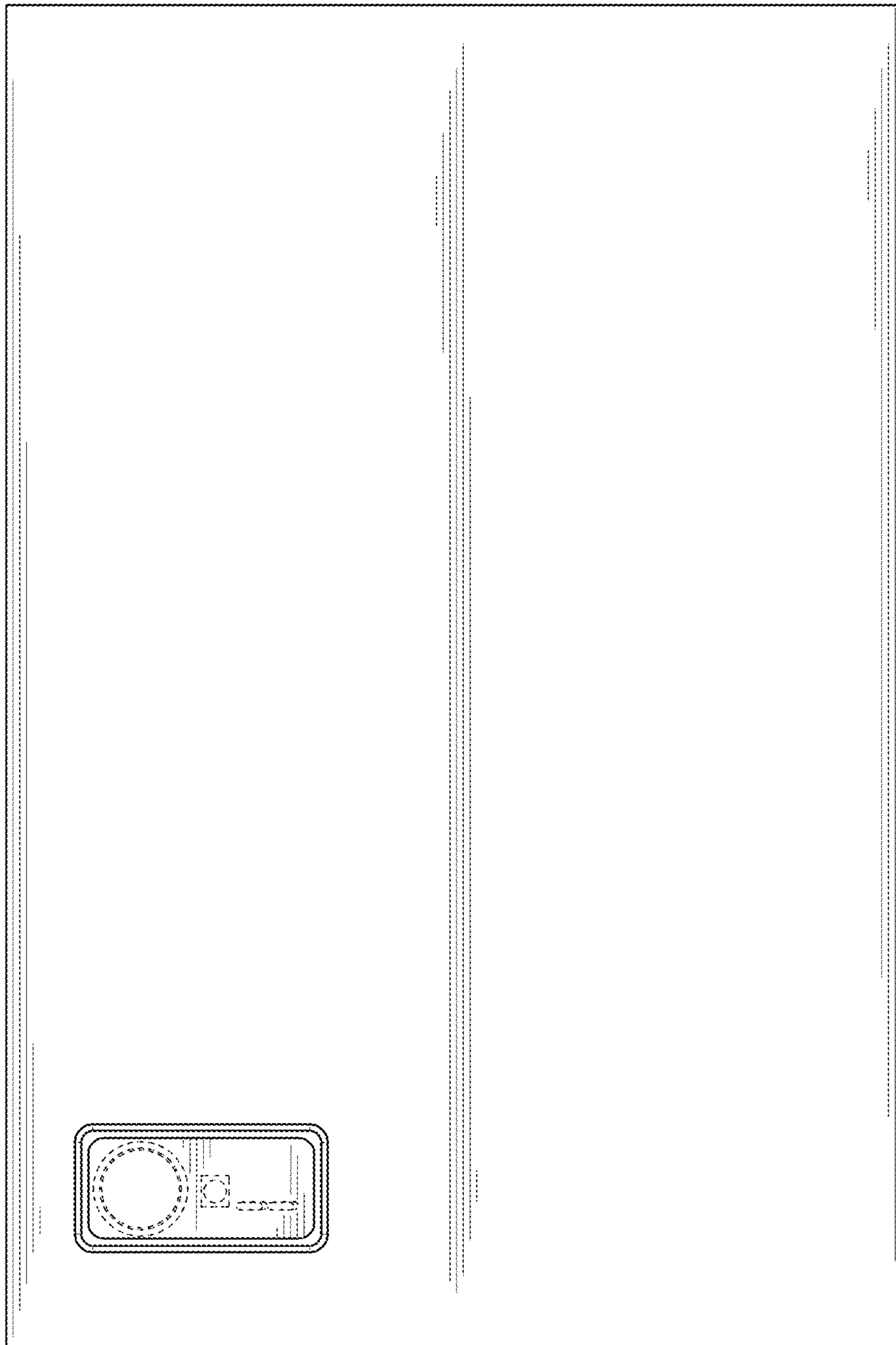

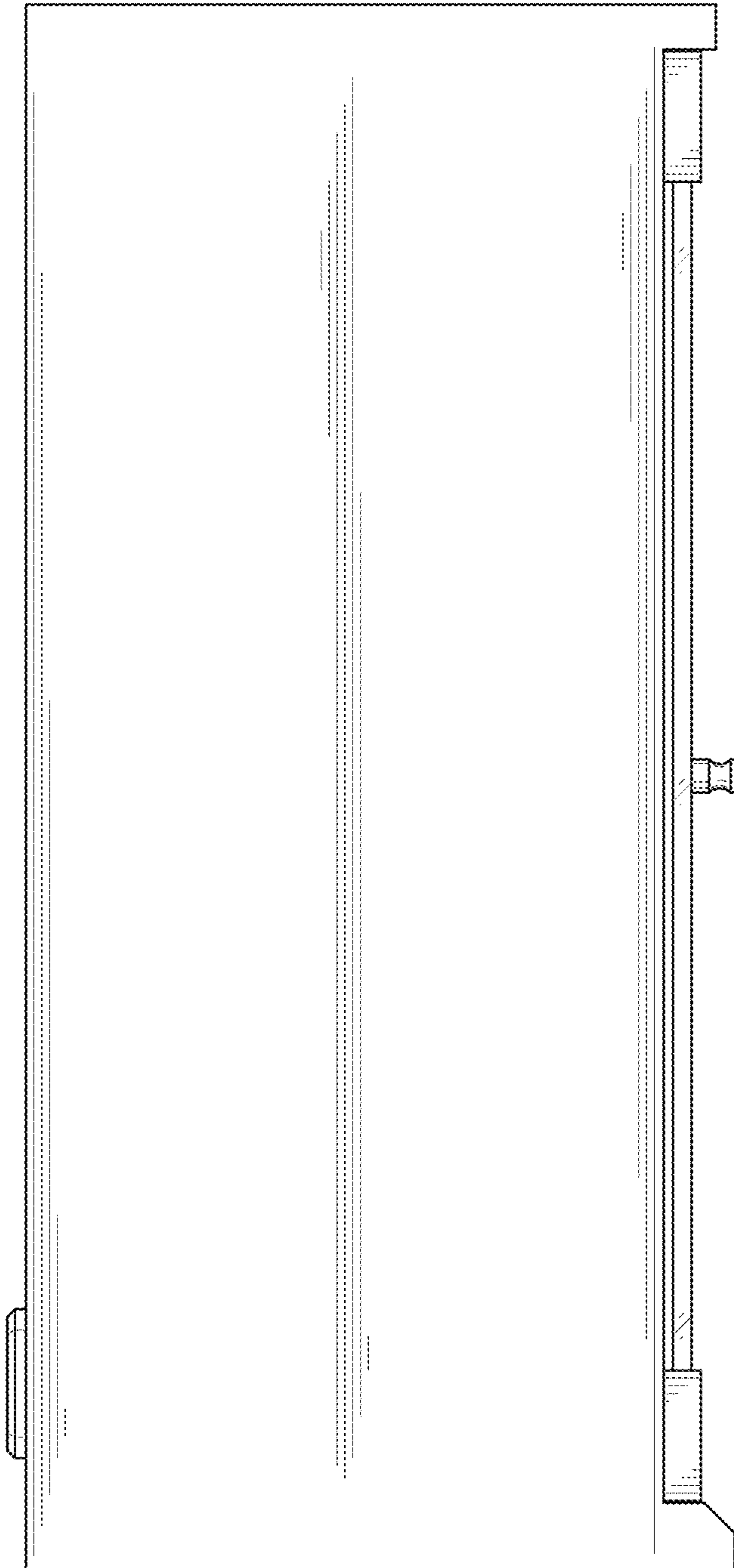

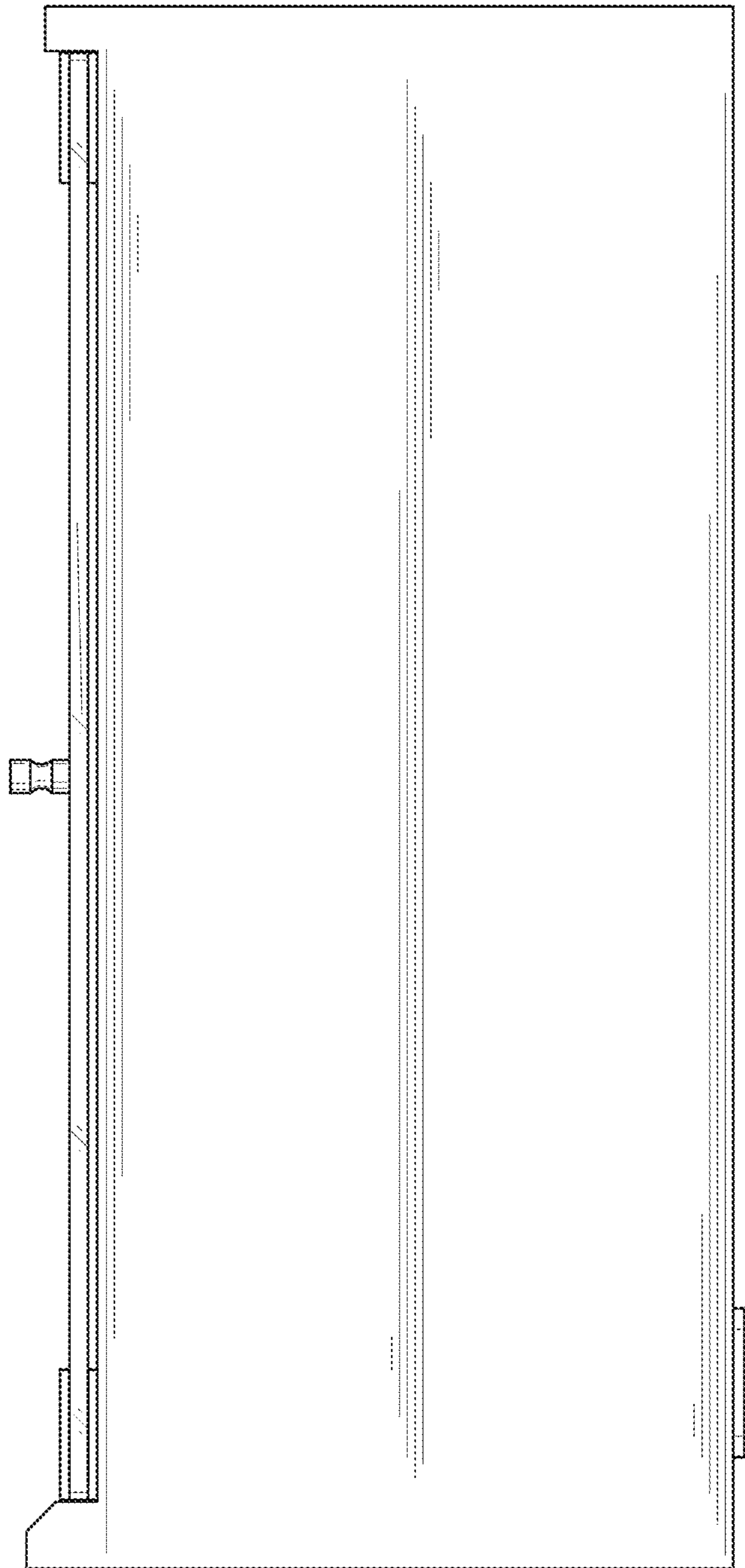

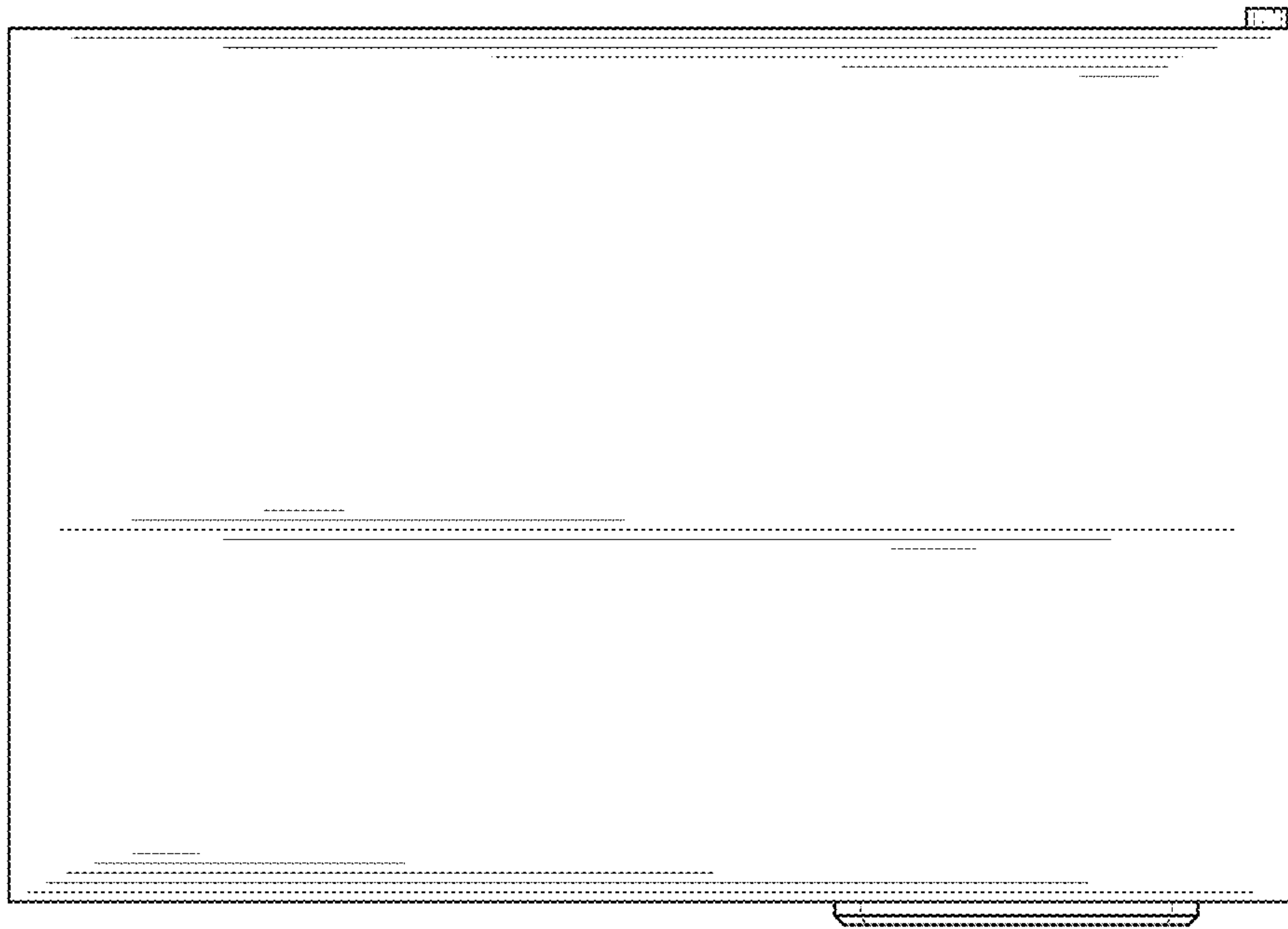
