(57) **CLAIM**

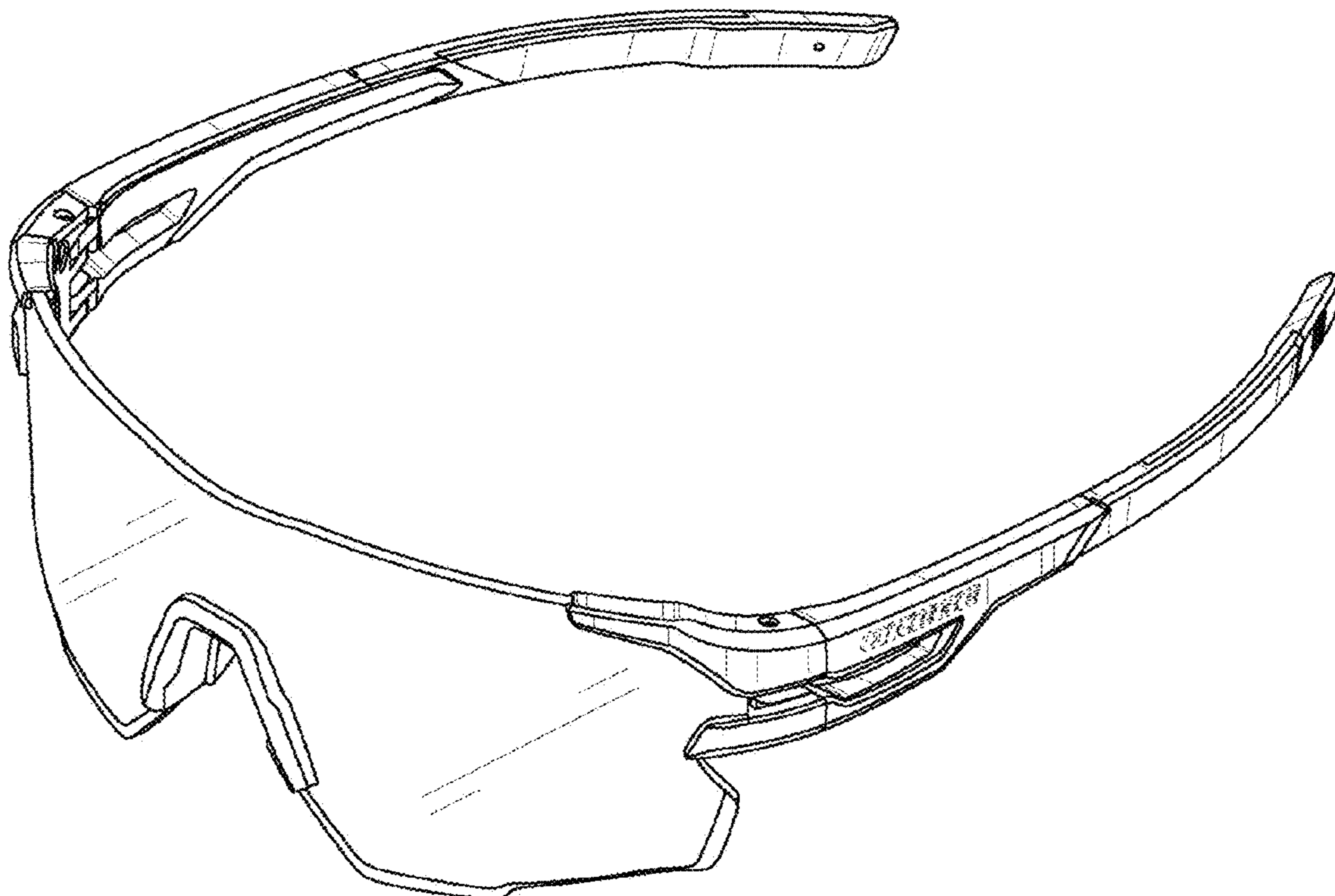
The ornamental design for sports sunglasses, as shown and described.

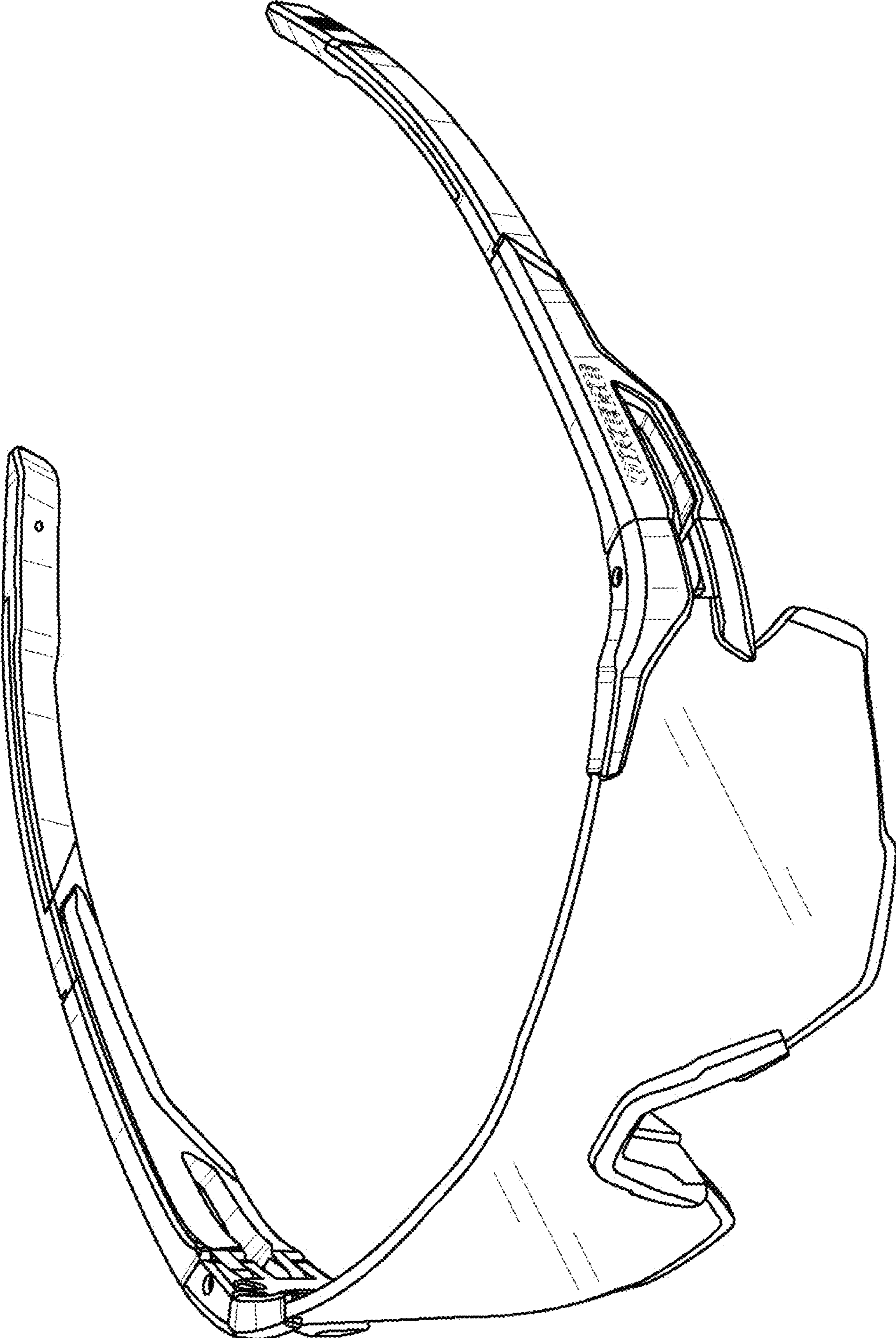

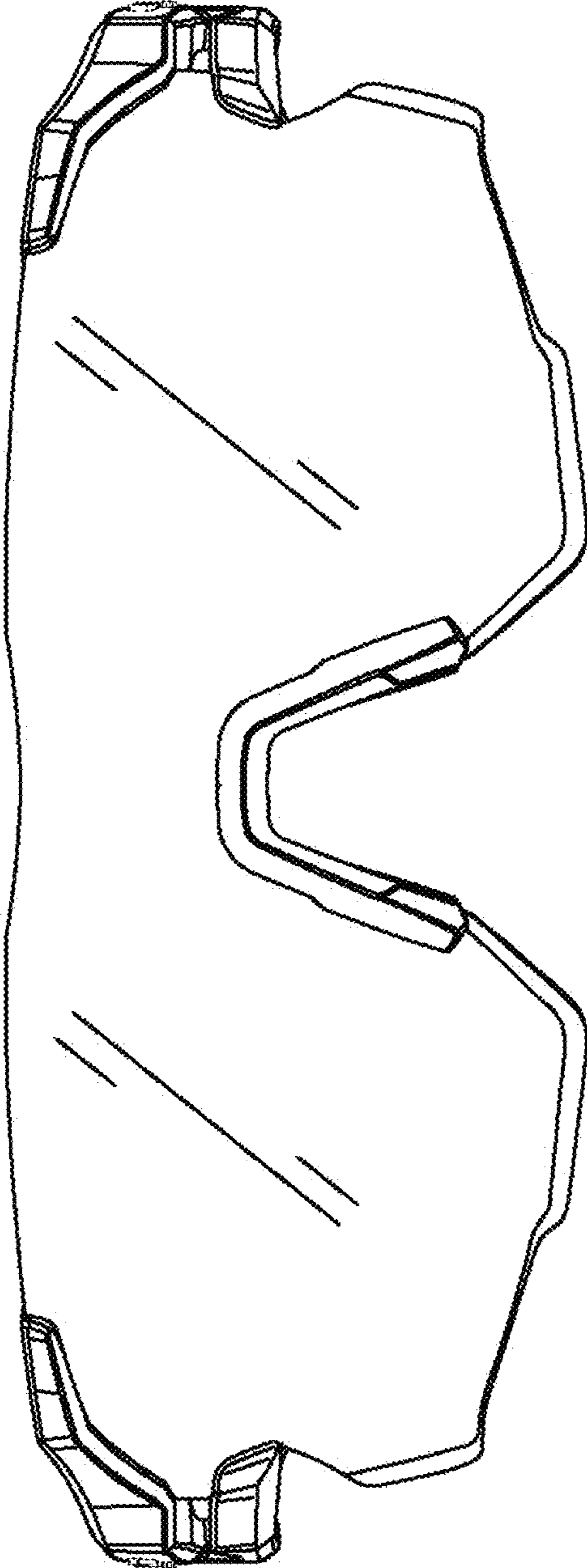

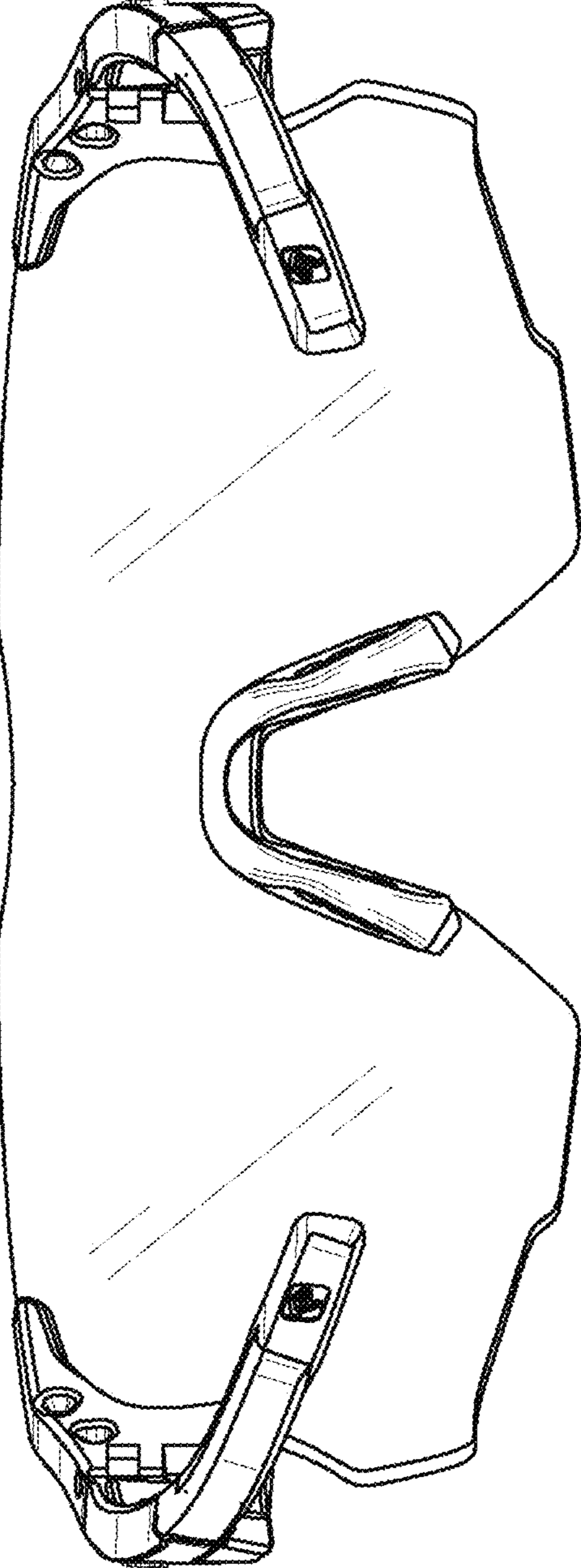

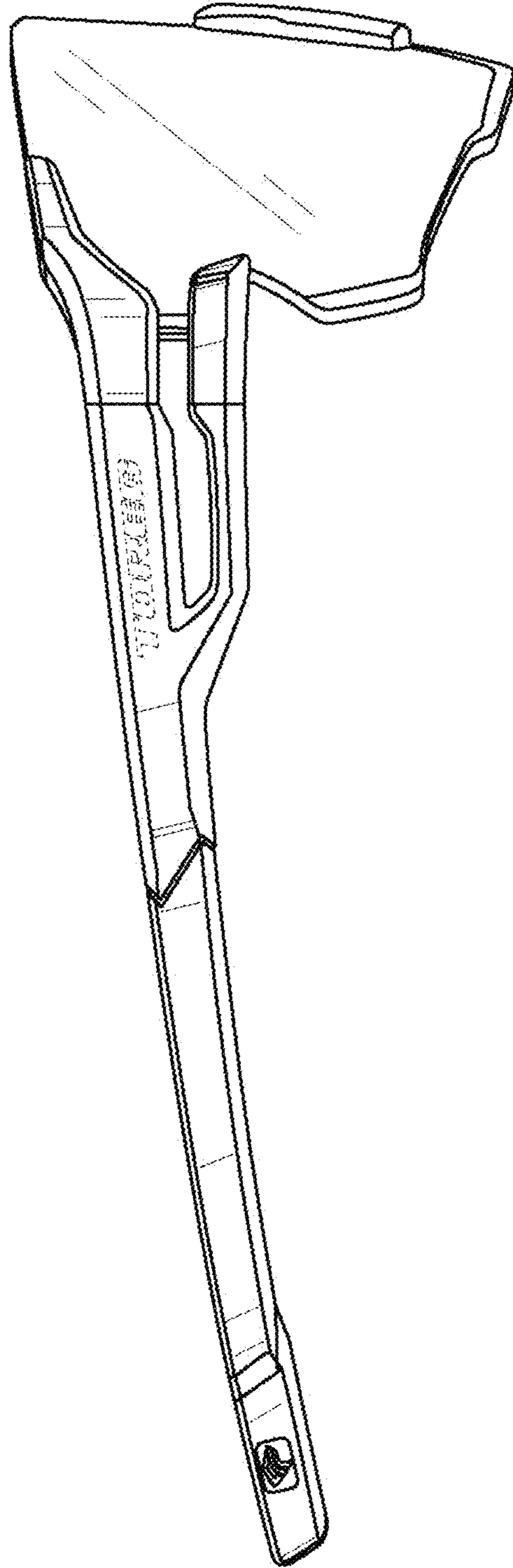

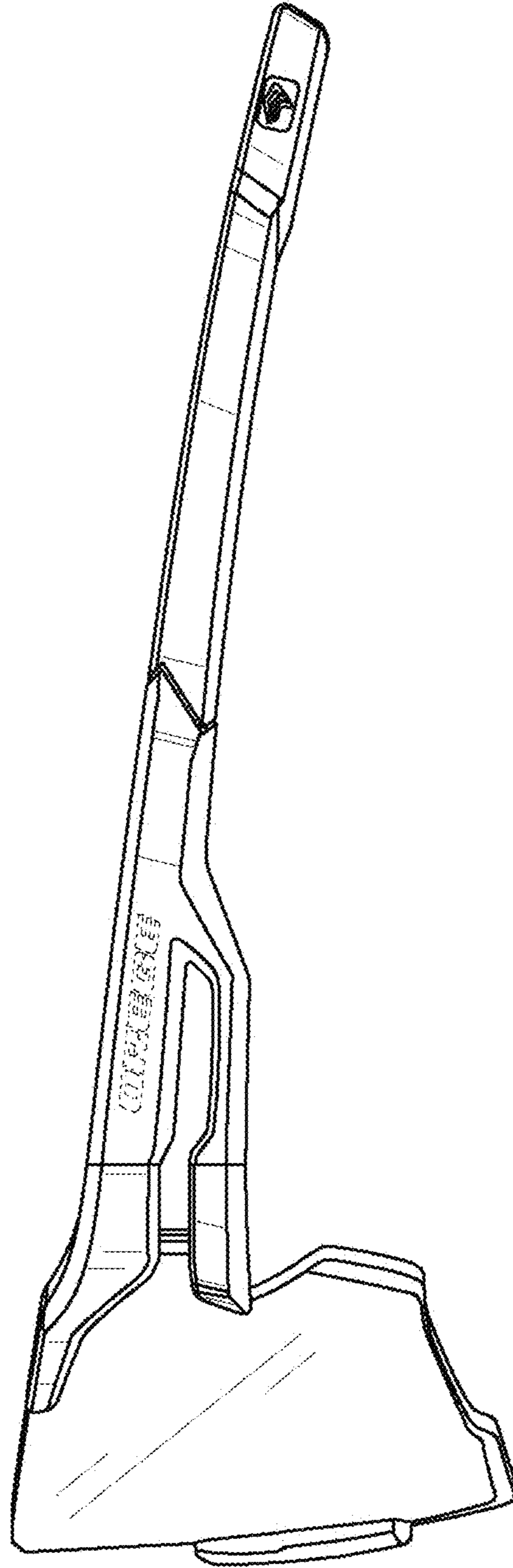

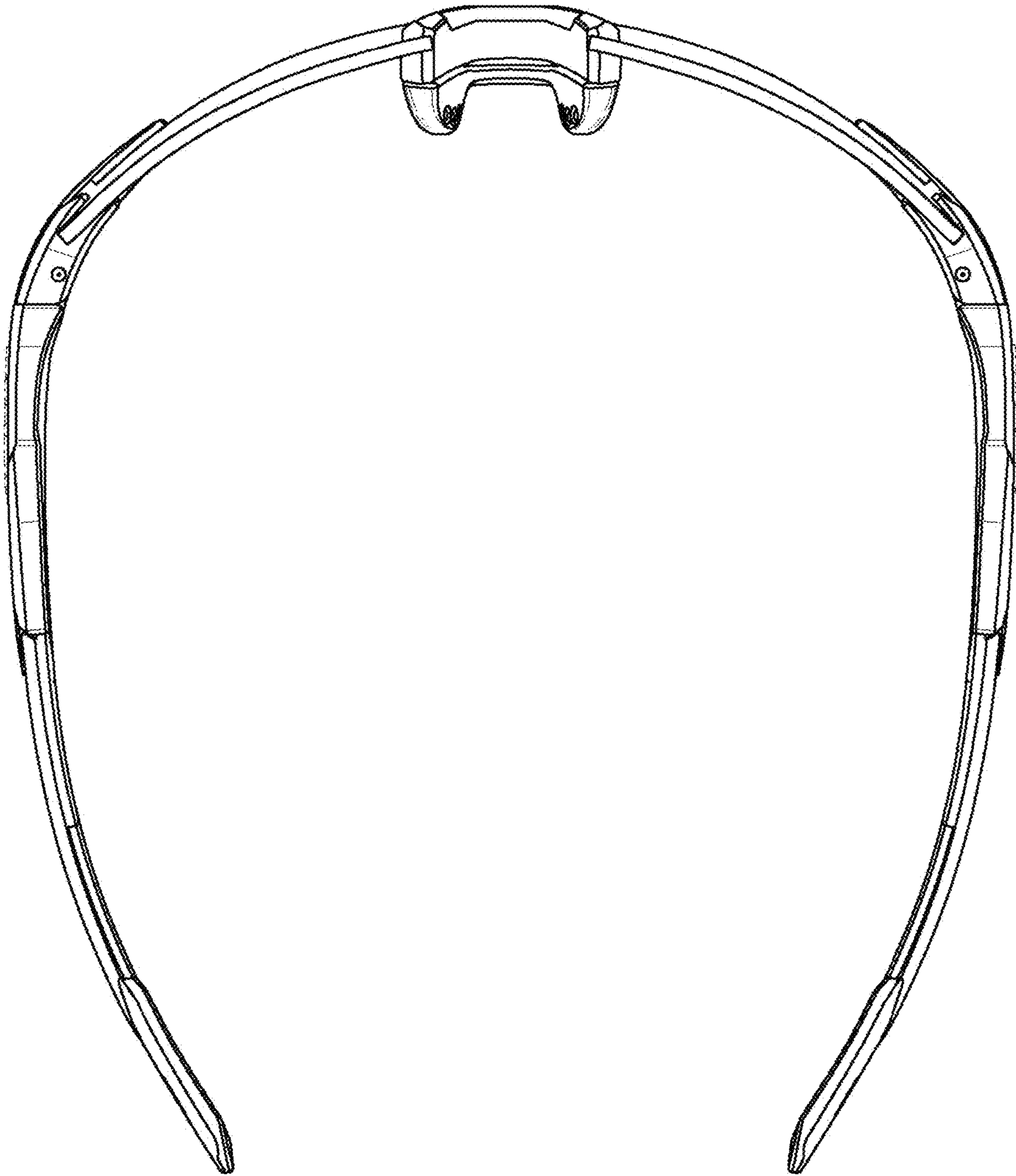

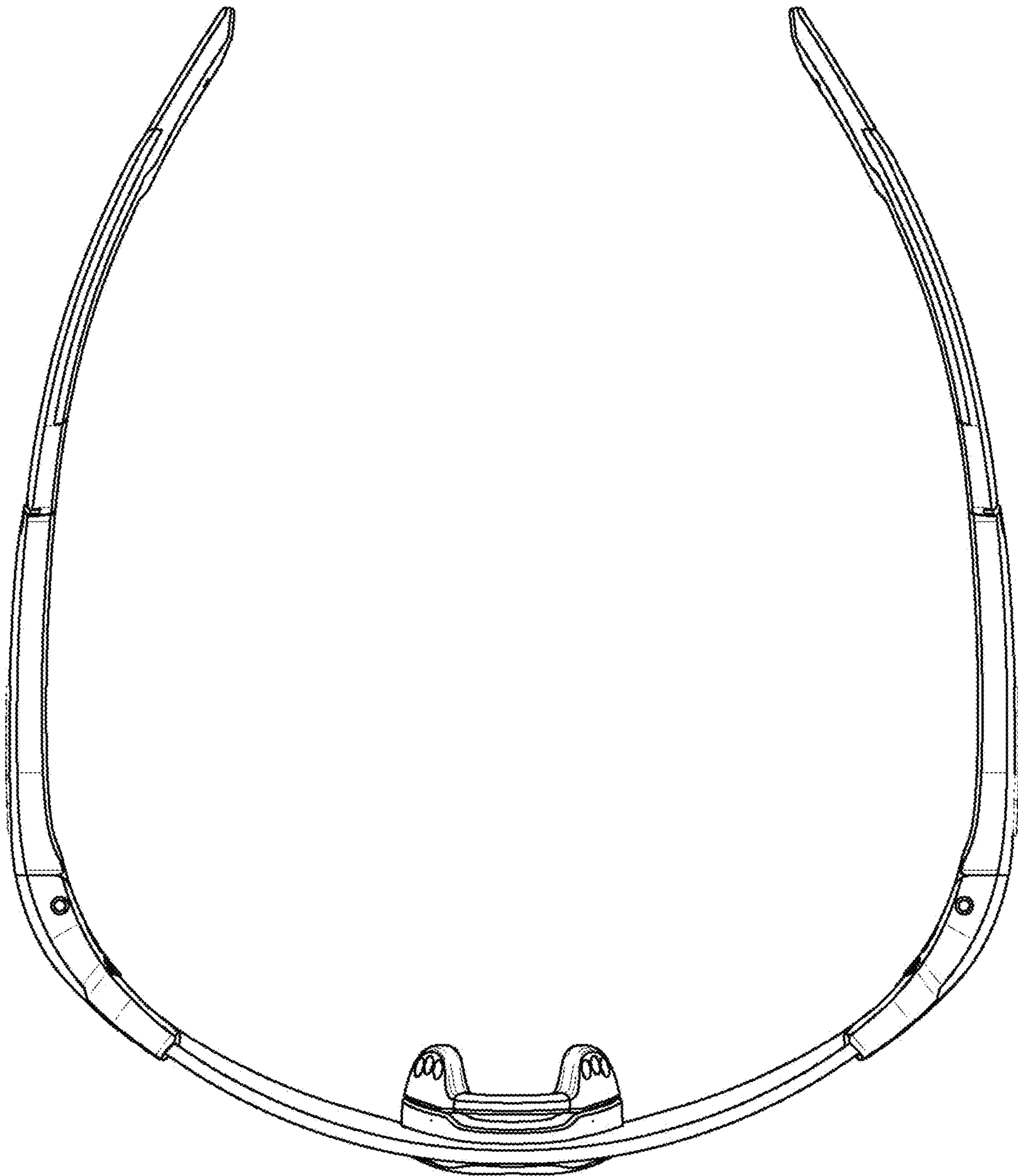
