FIG. 7 is a bottom plan view thereof.

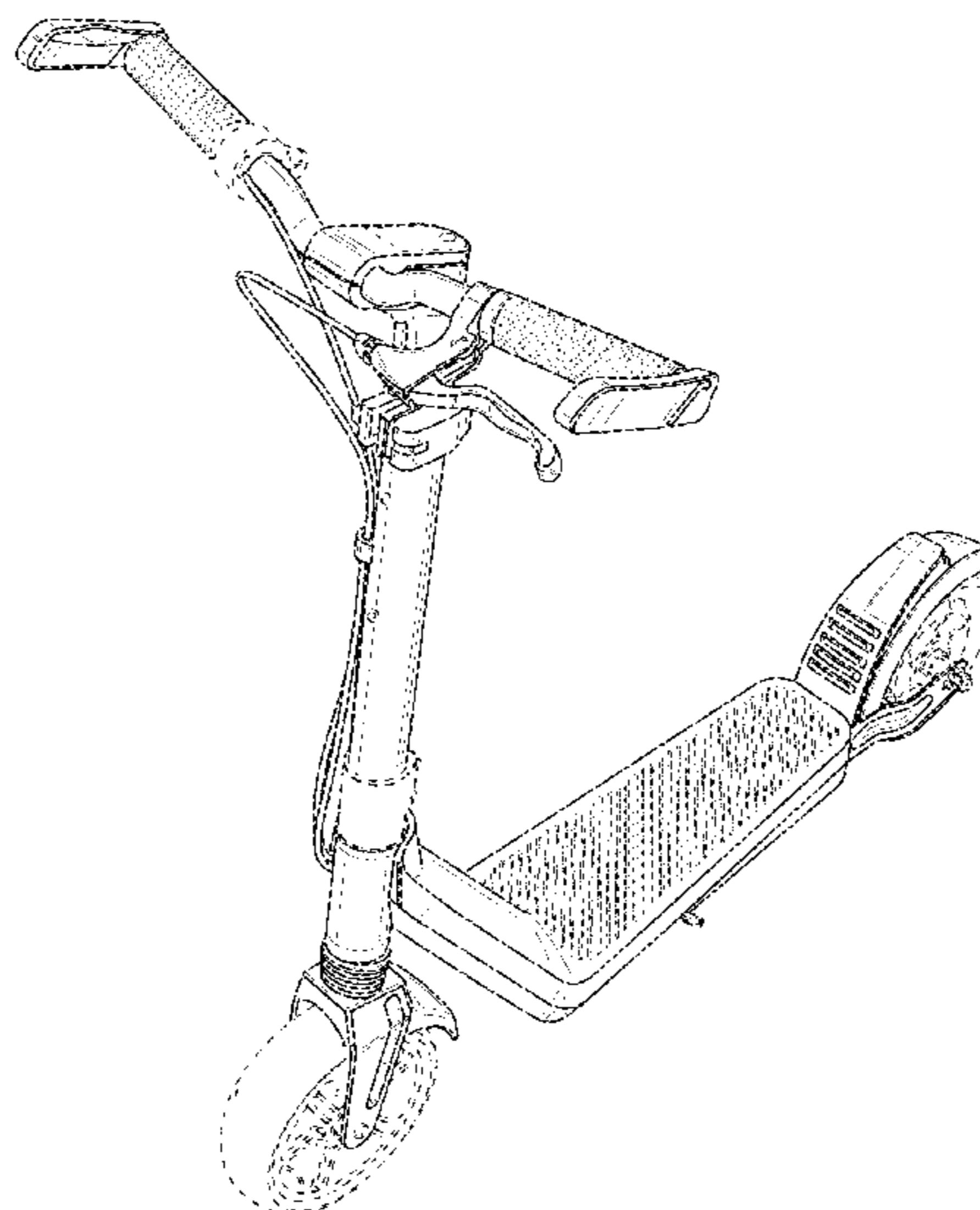
The broken lines illustrate portions of the electric scooter which form no part of the claimed design.

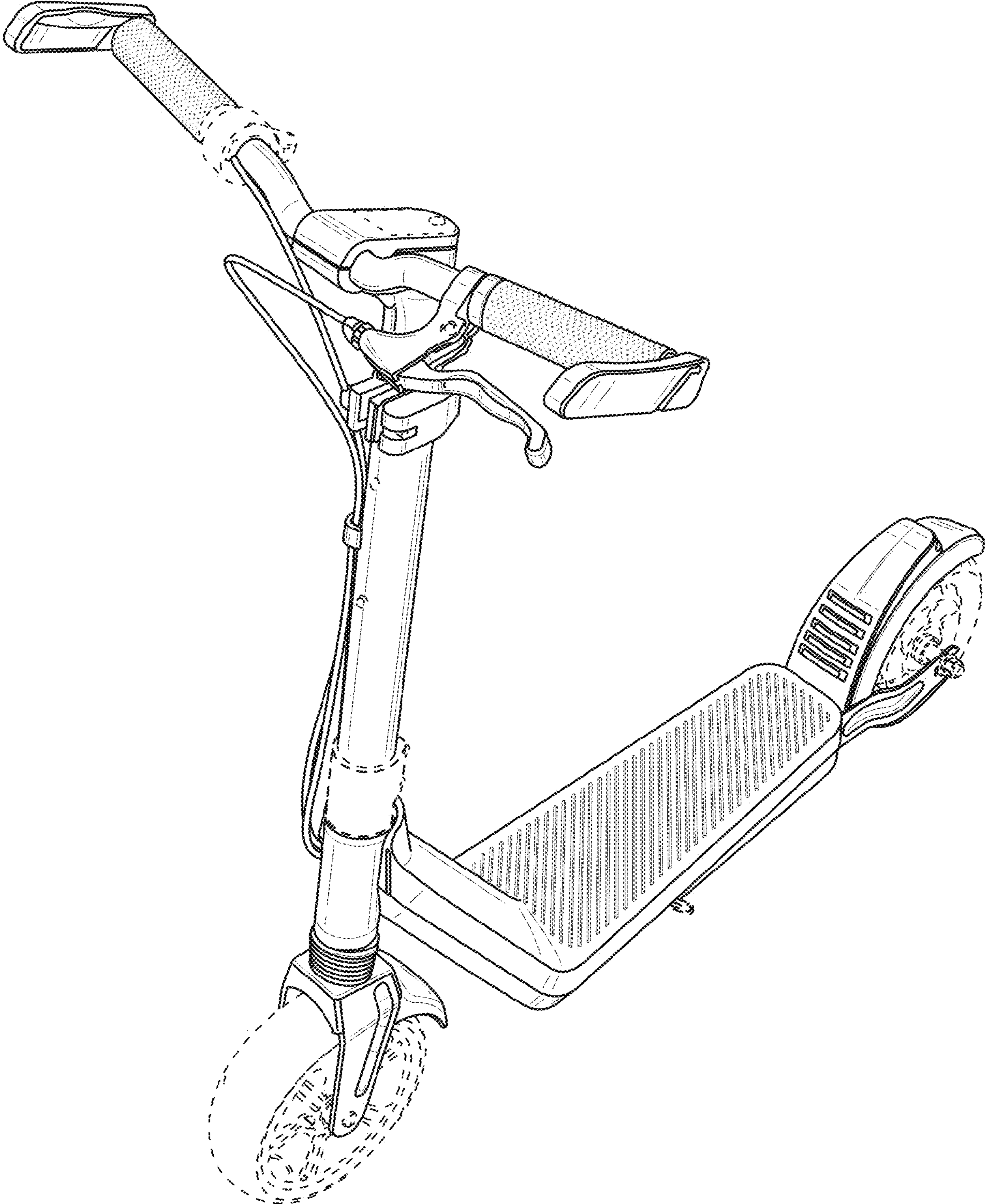

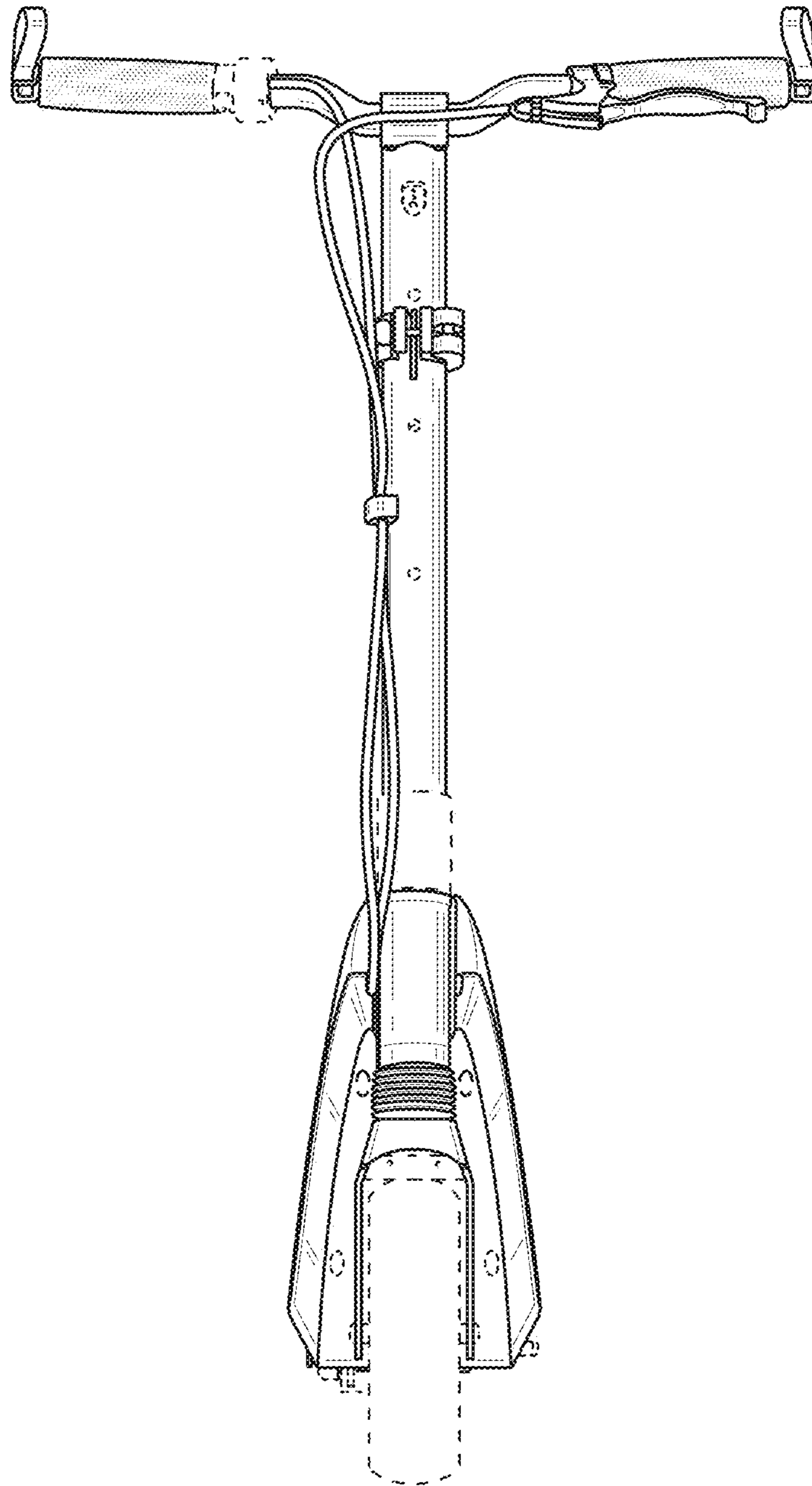

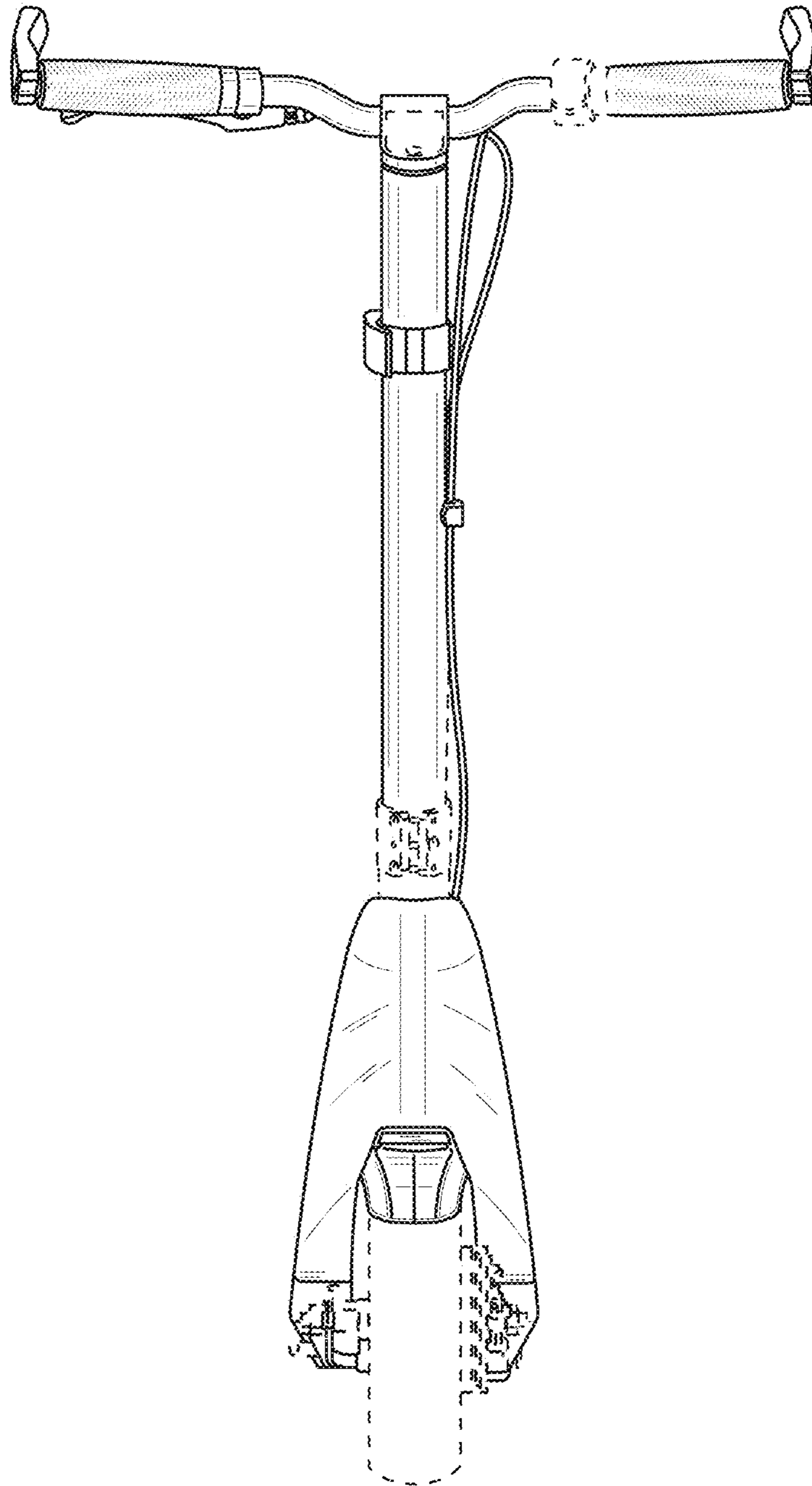

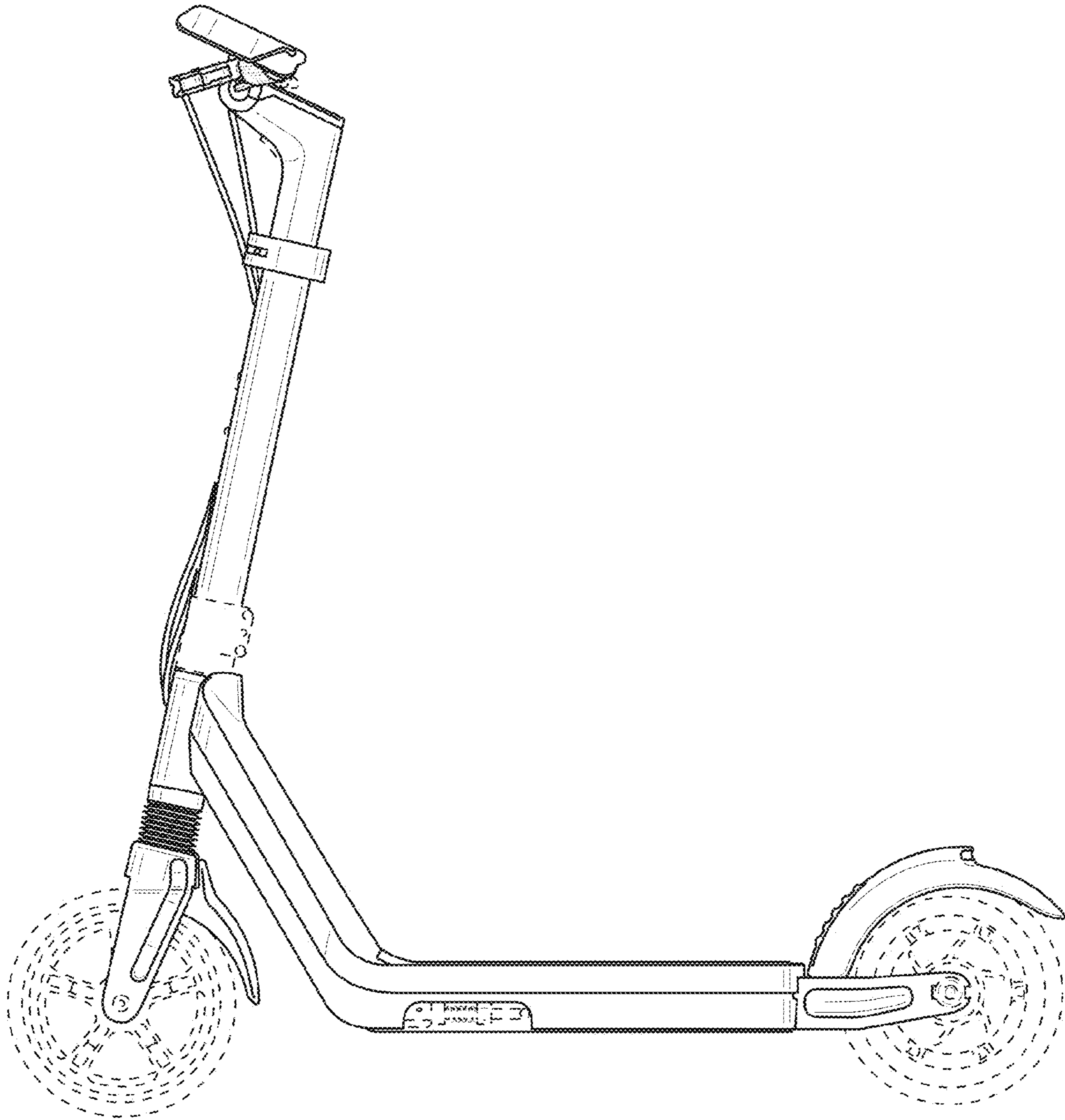

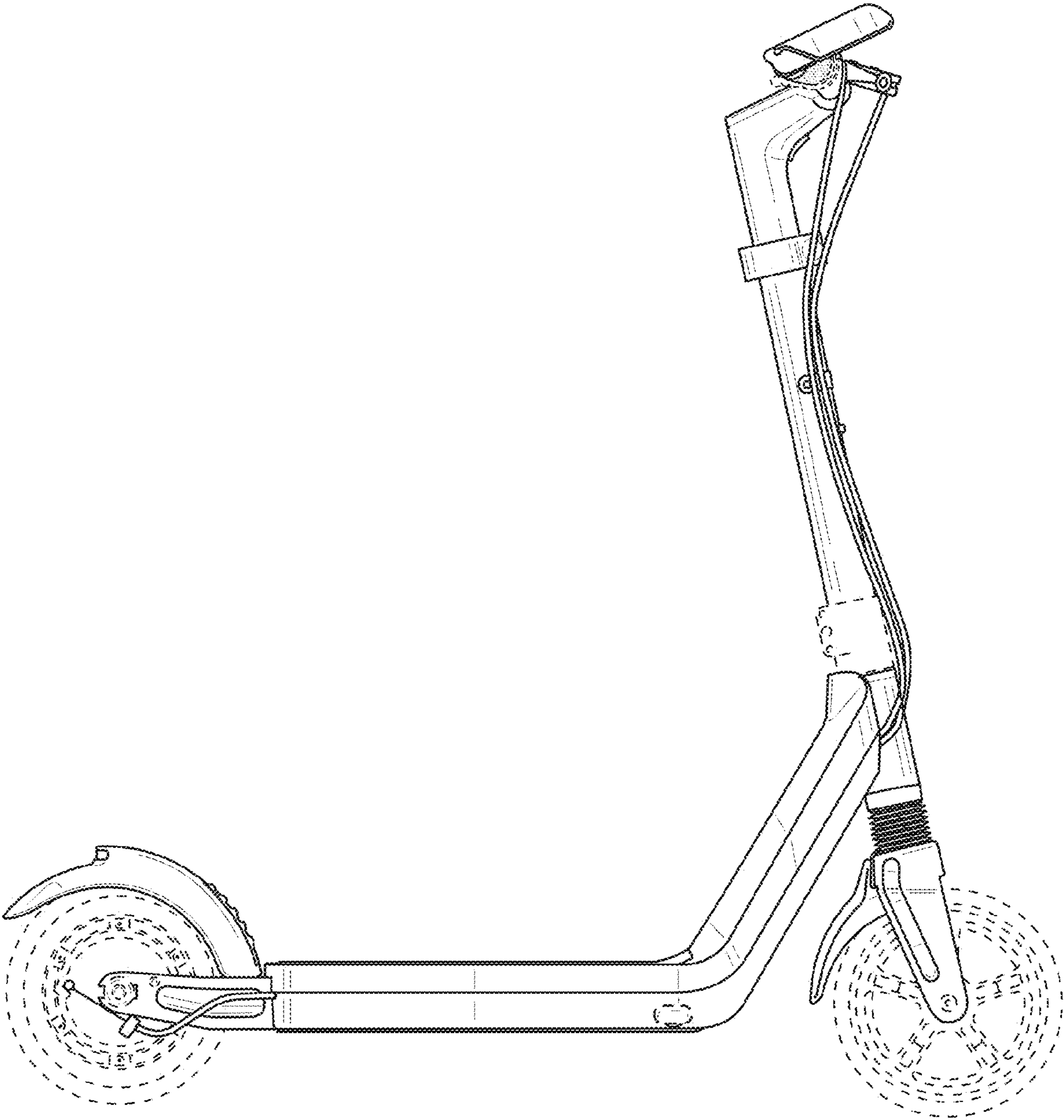

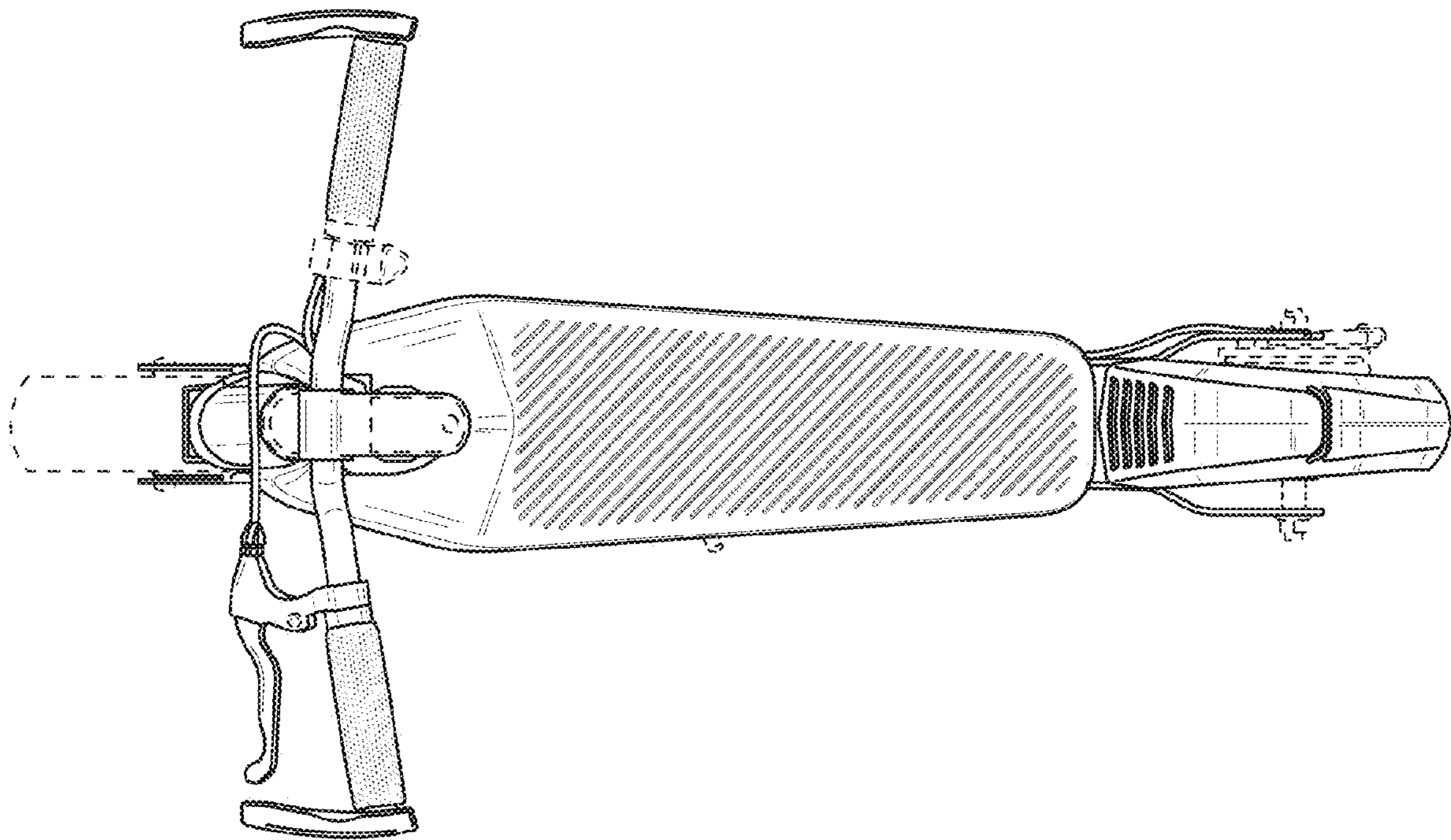

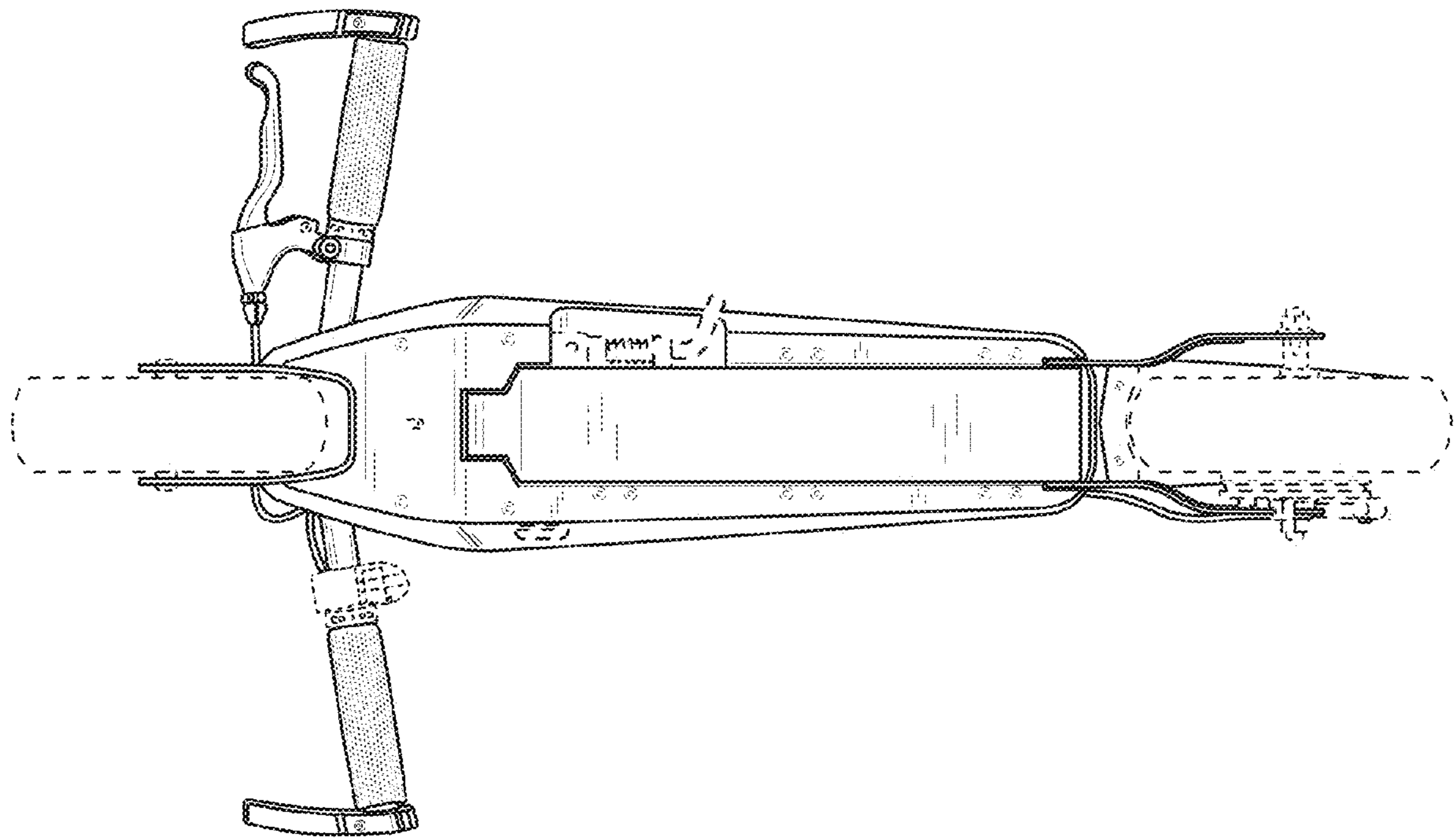
