(57) **CLAIM**

The ornamental design for an abdominal binder, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of an abdominal binder, showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a left side elevation view thereof;
 FIG. 5 is a right side elevation view thereof;
 FIG. 6 is an enlarged top plan view thereof;
 FIG. 7 is an enlarged bottom plan view thereof;
 FIG. 8 is an enlarged view of a portion indicated with numeric 8 in FIG. 1; and,
 FIG. 9 is an enlarged view of a portion indicated with numeric 9 in FIG. 1.

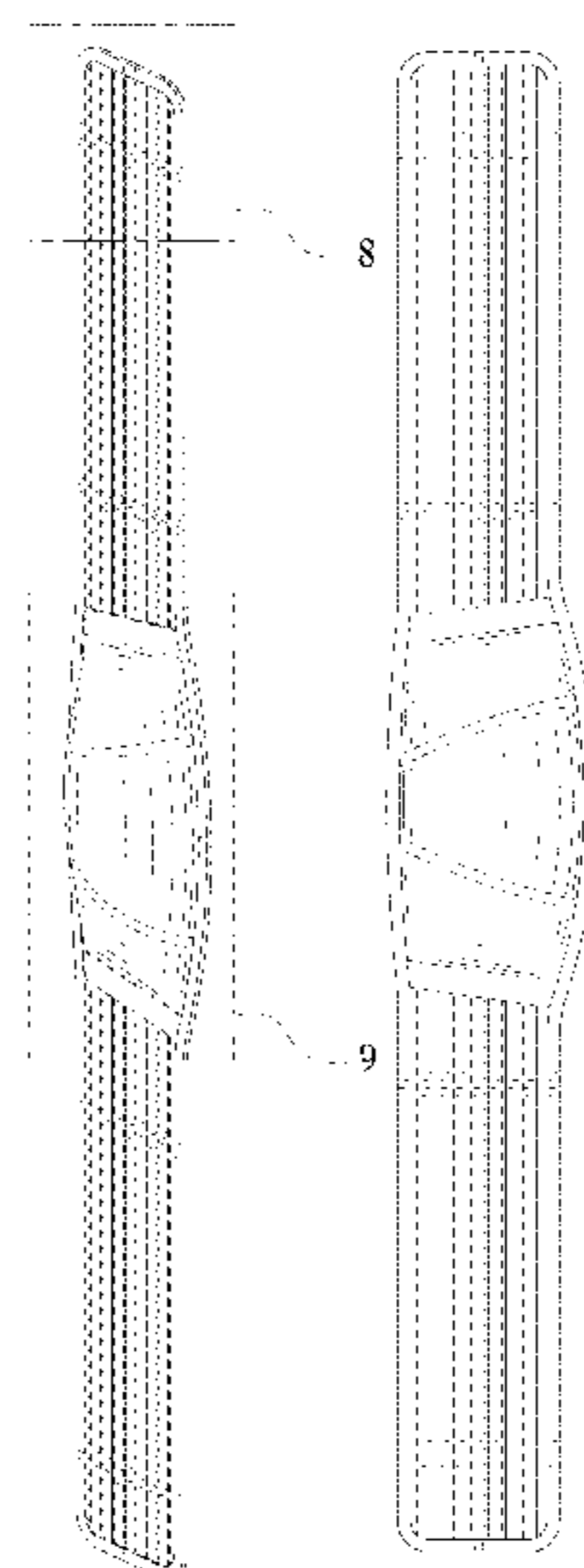

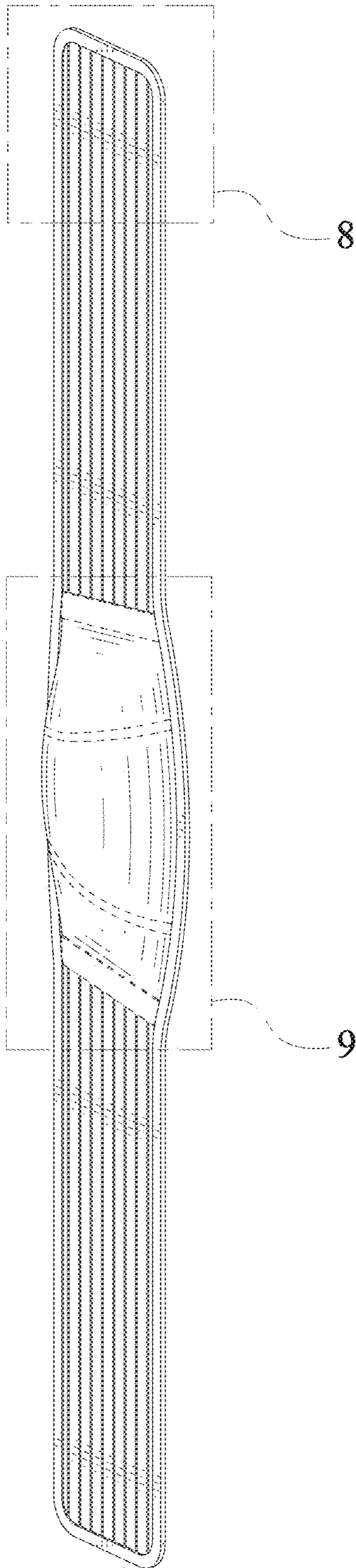

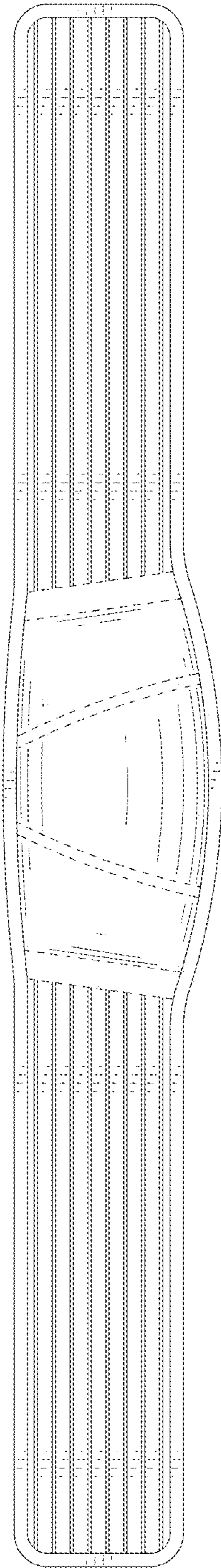

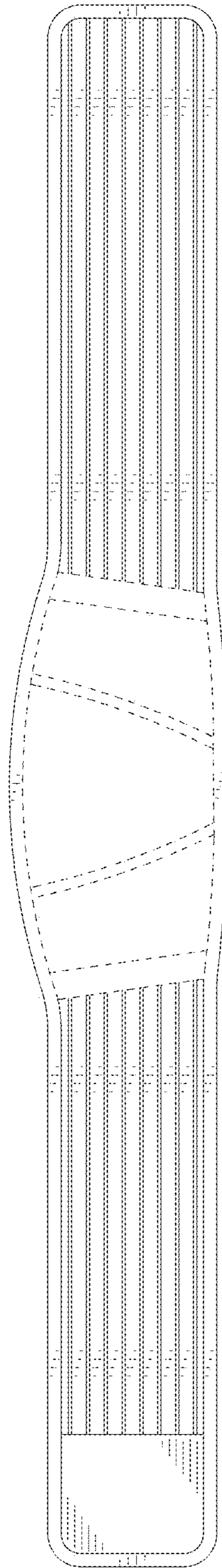

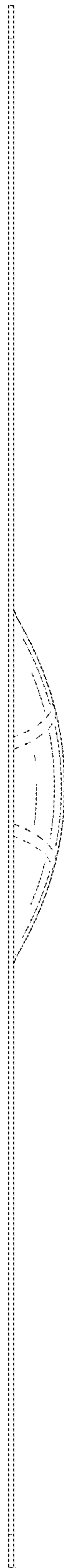

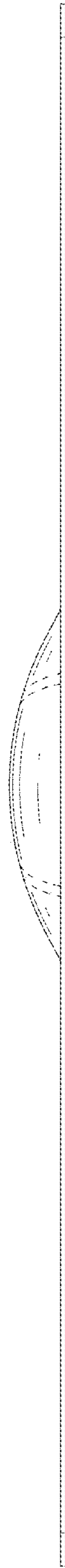

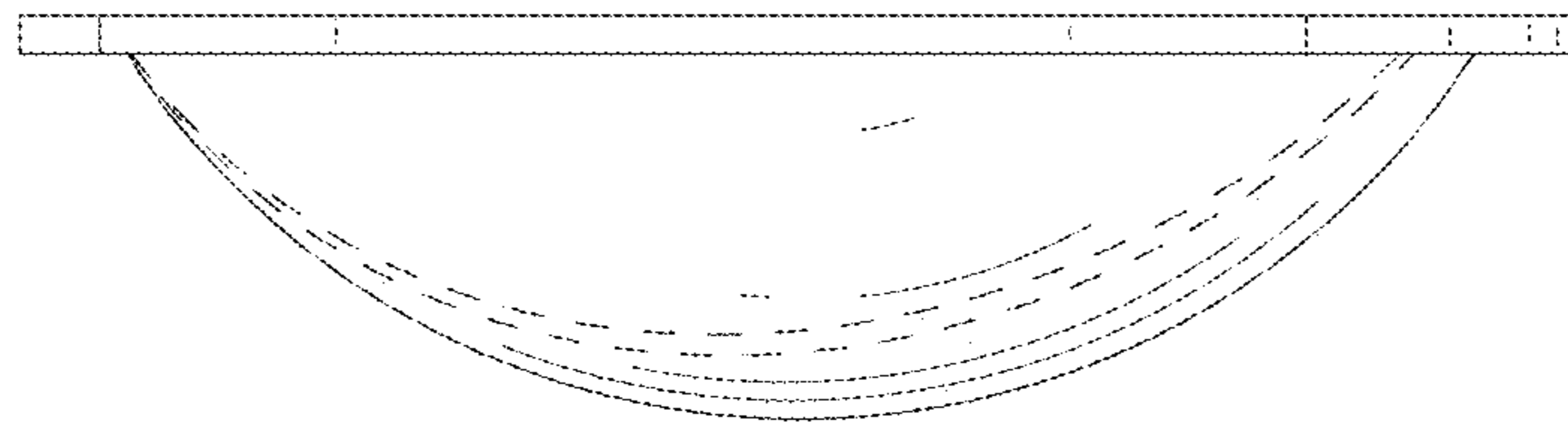

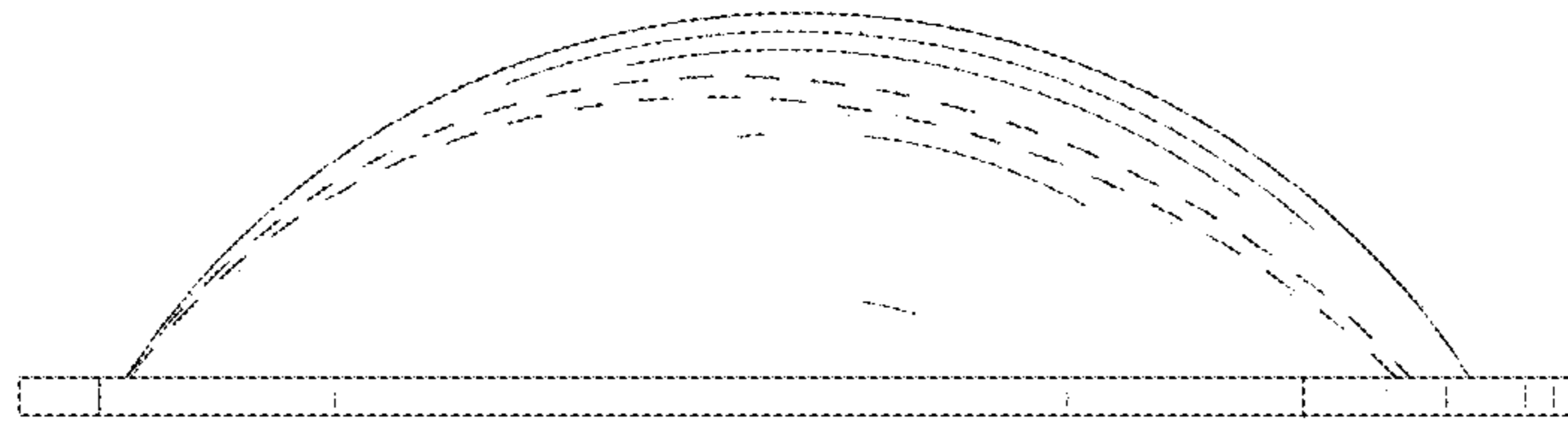

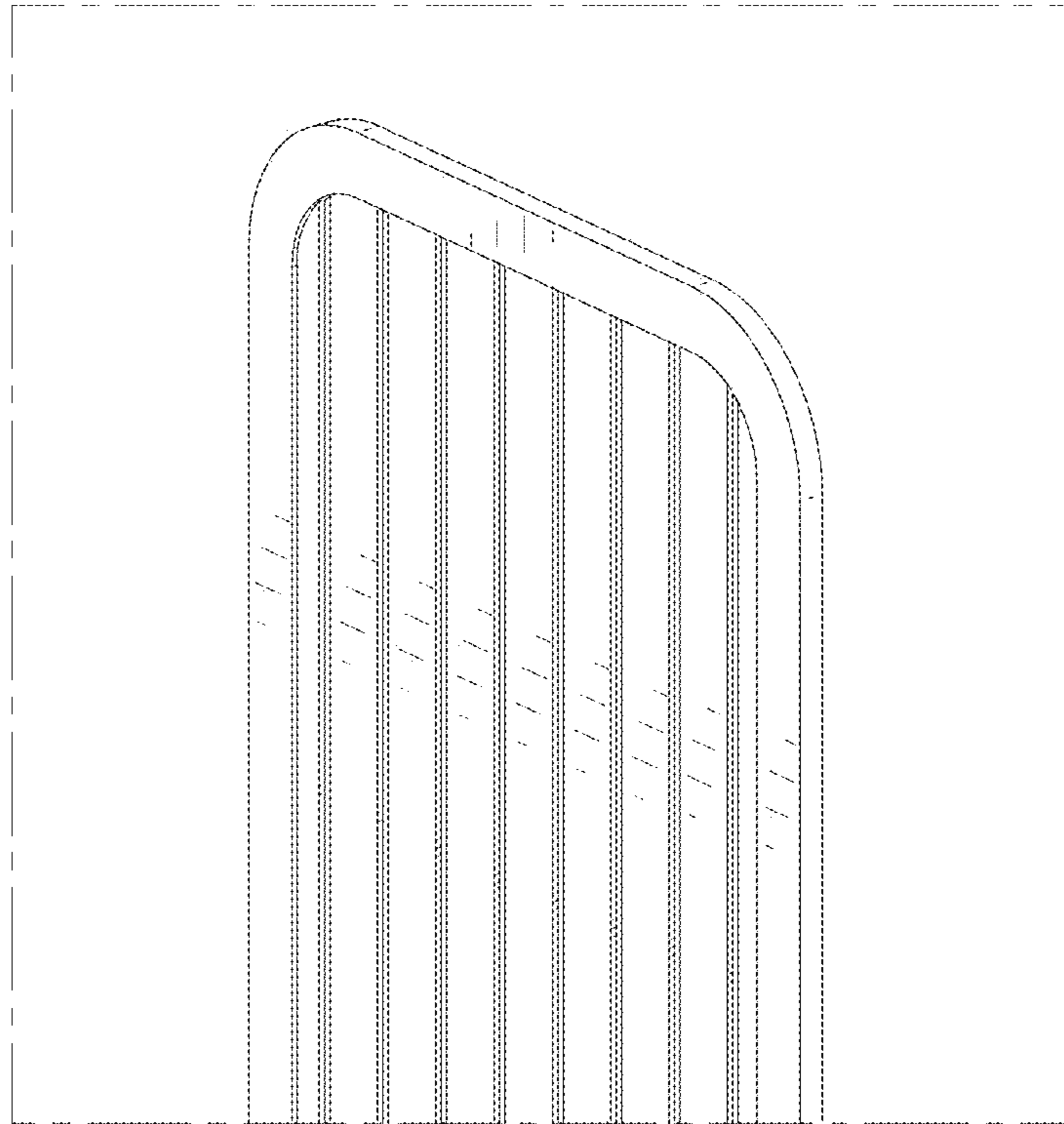

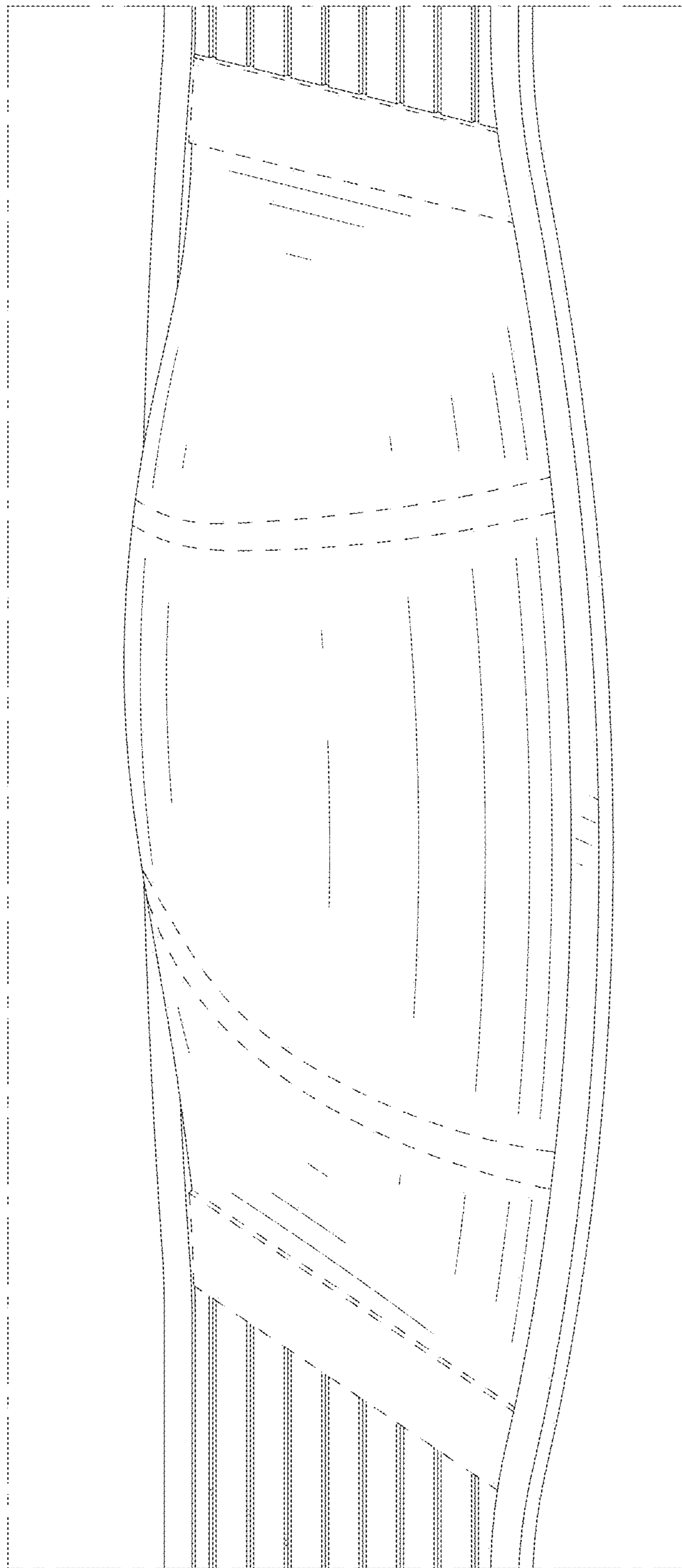
