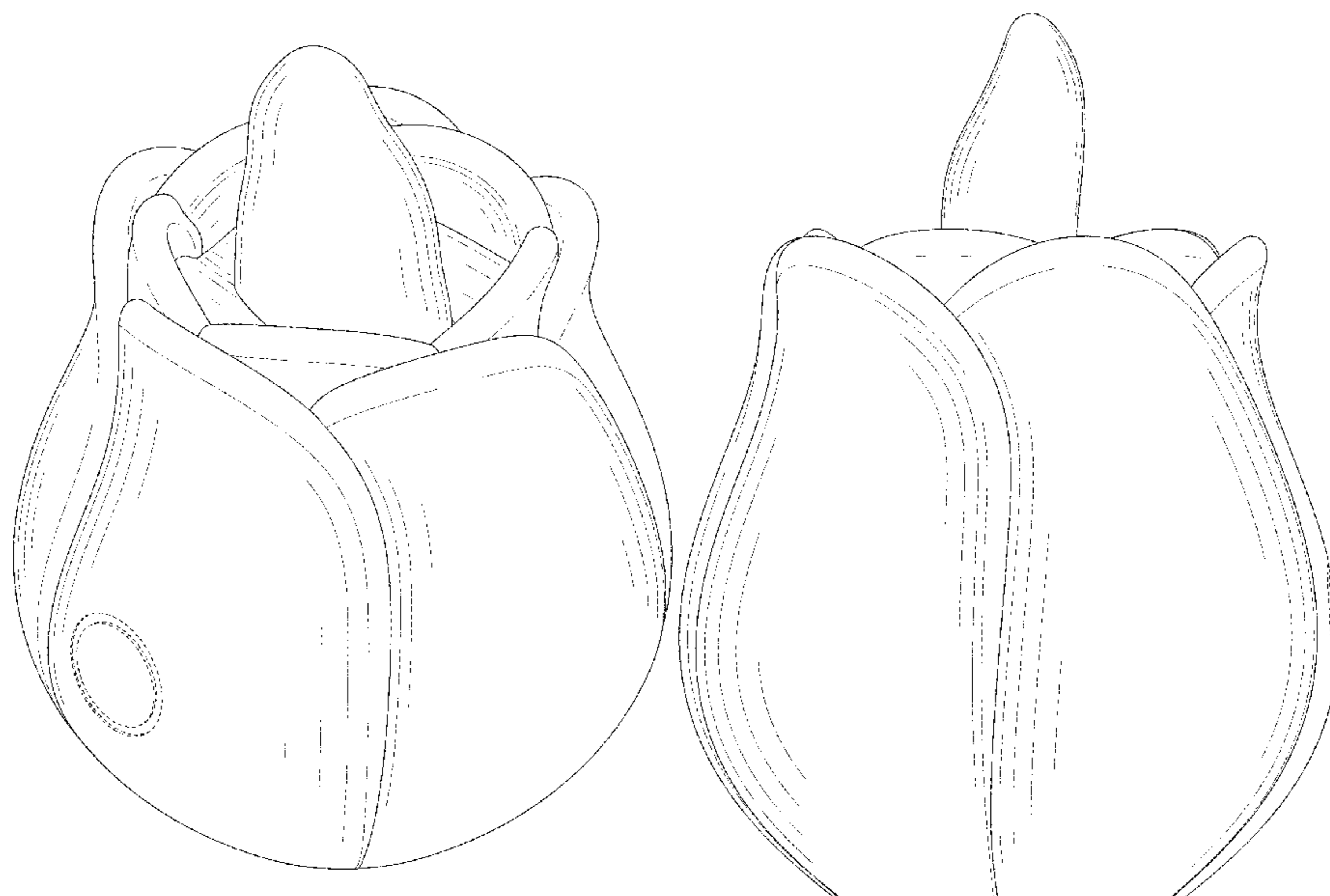
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a massager, showing my design.

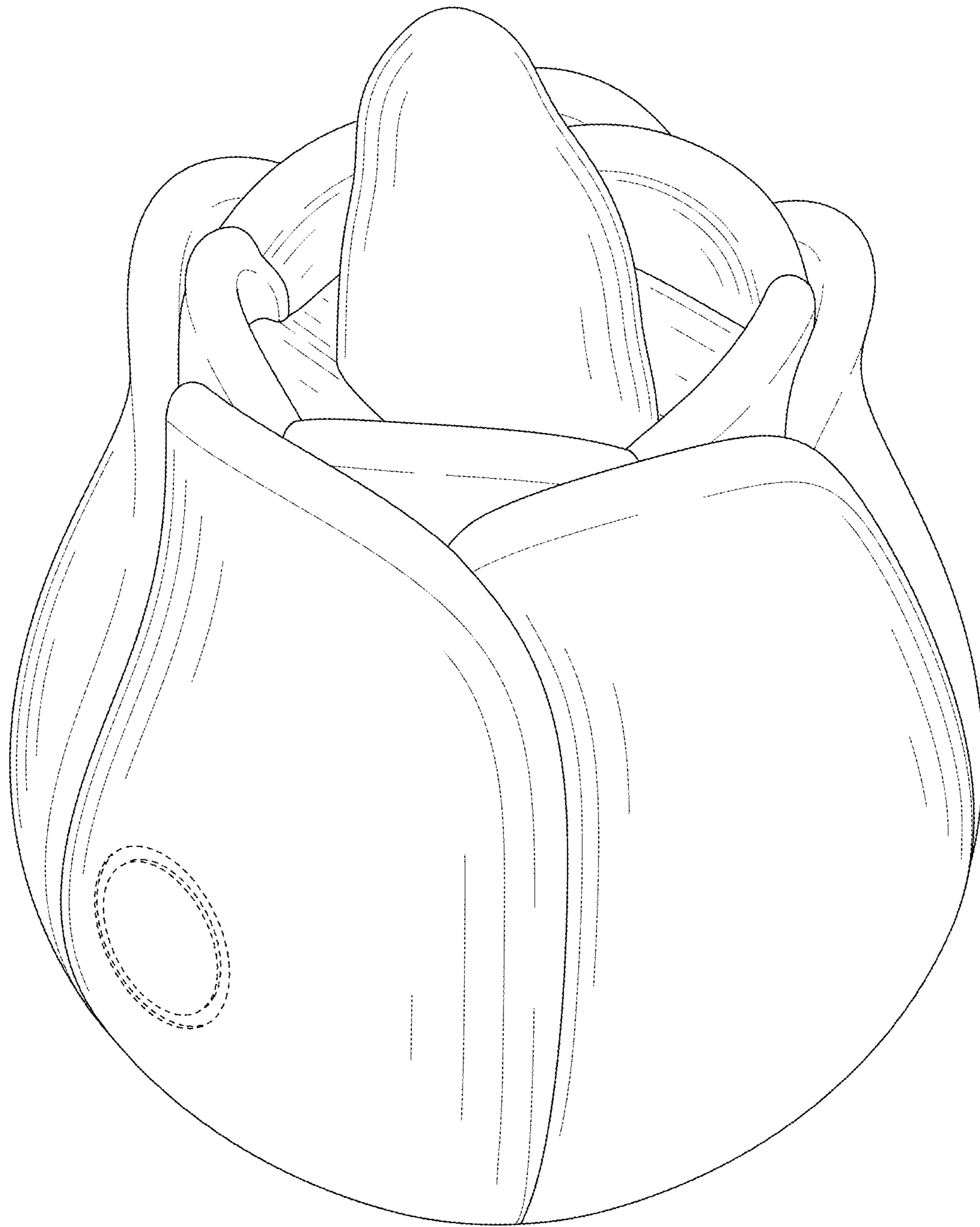

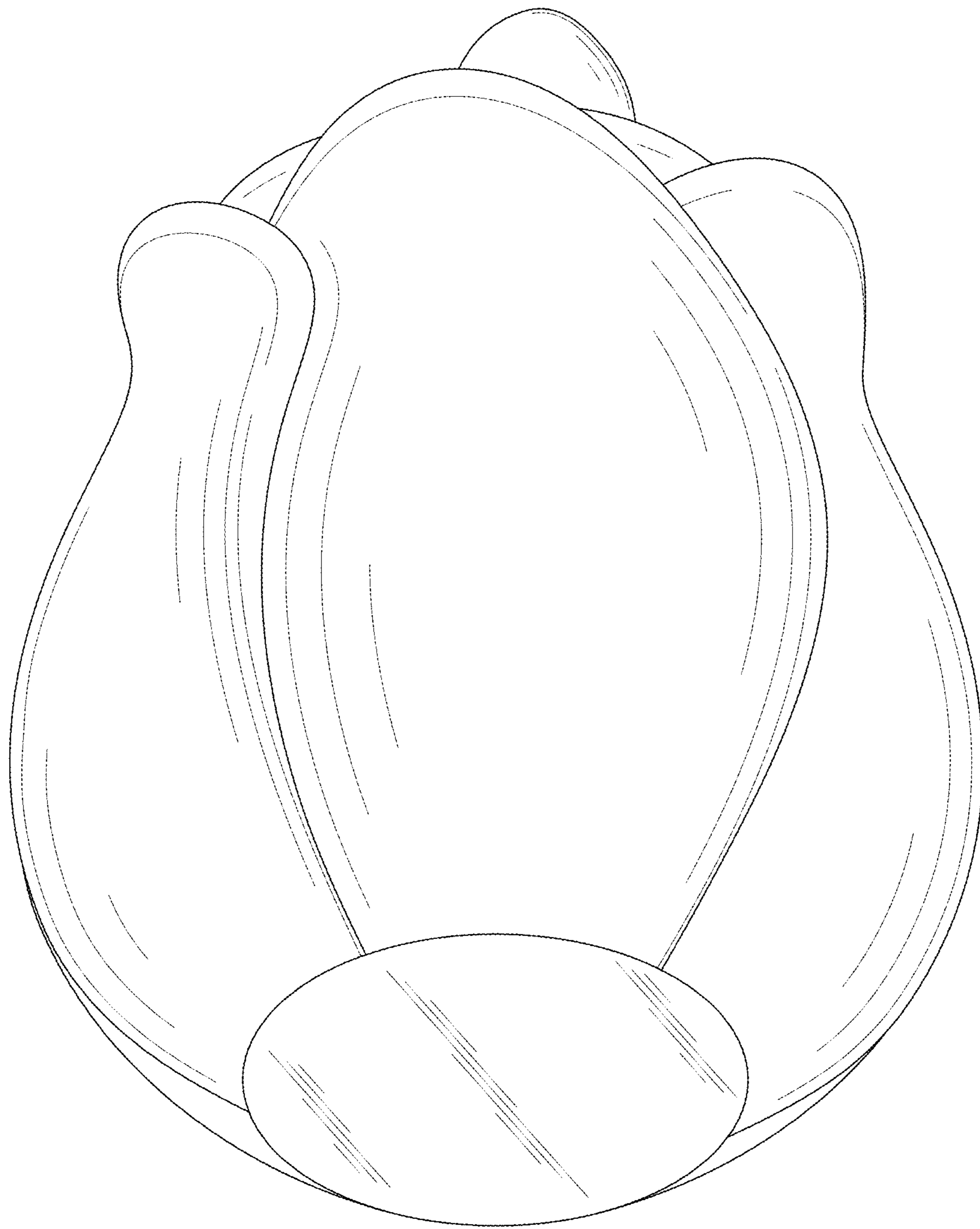

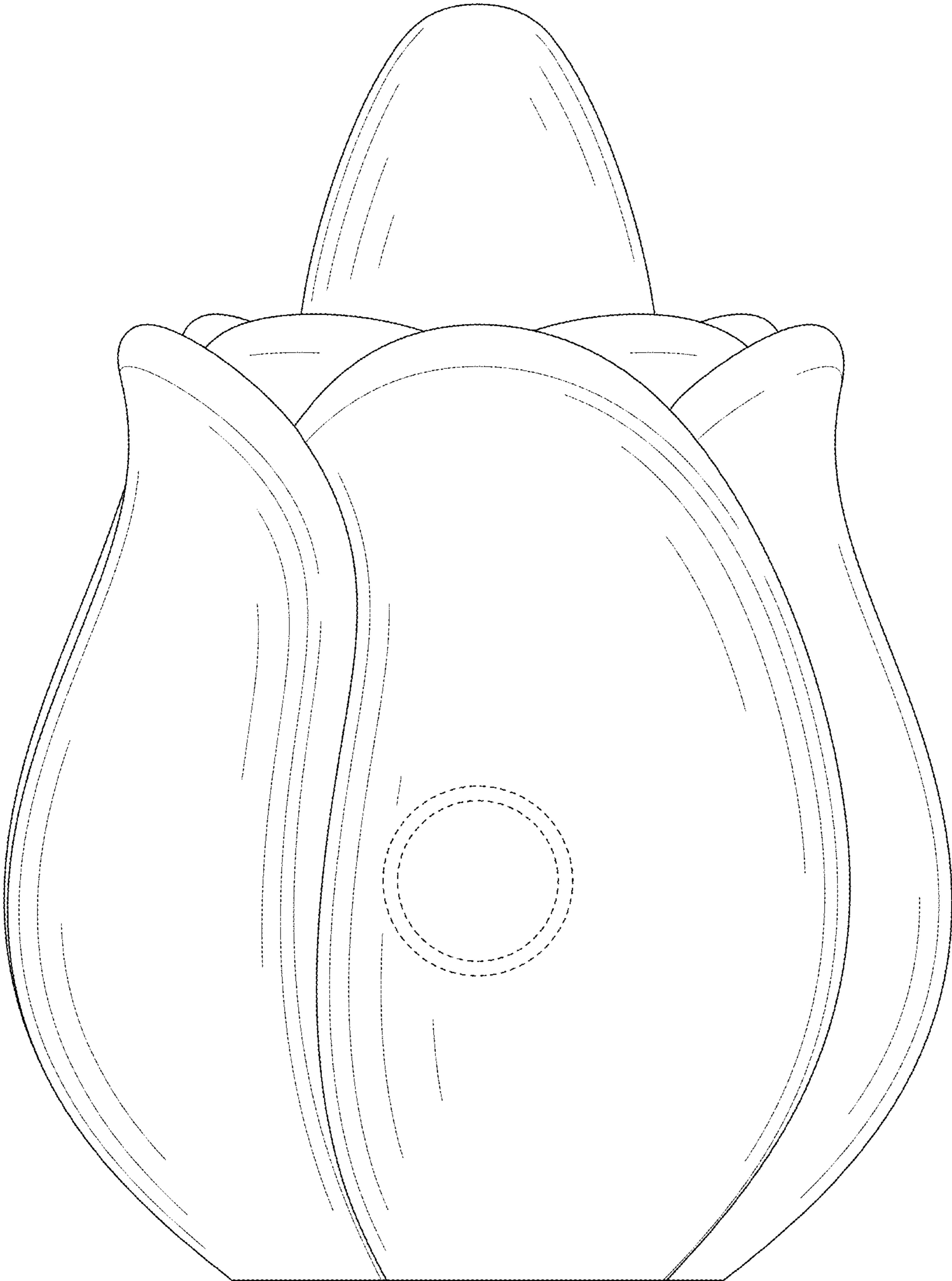

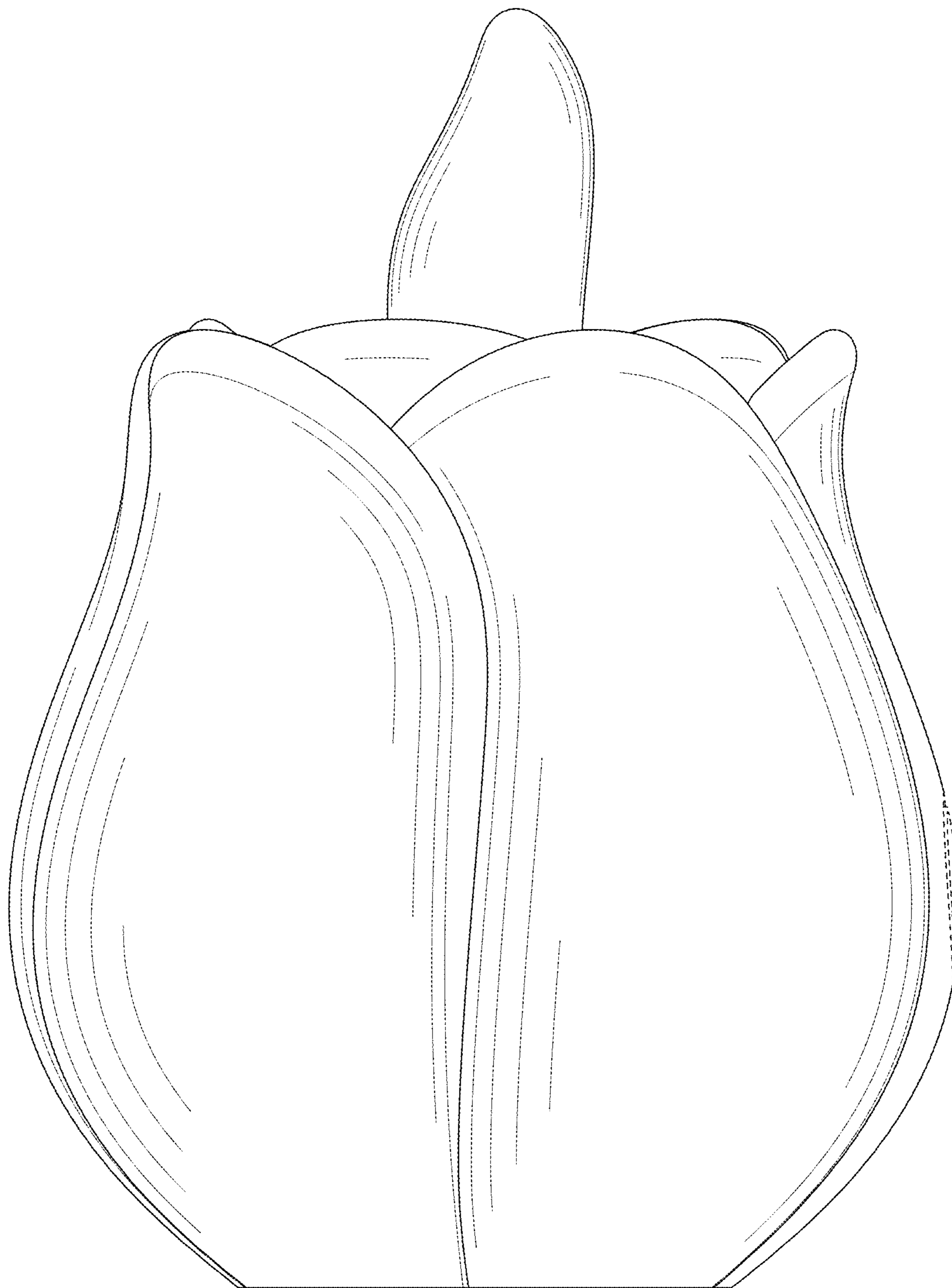

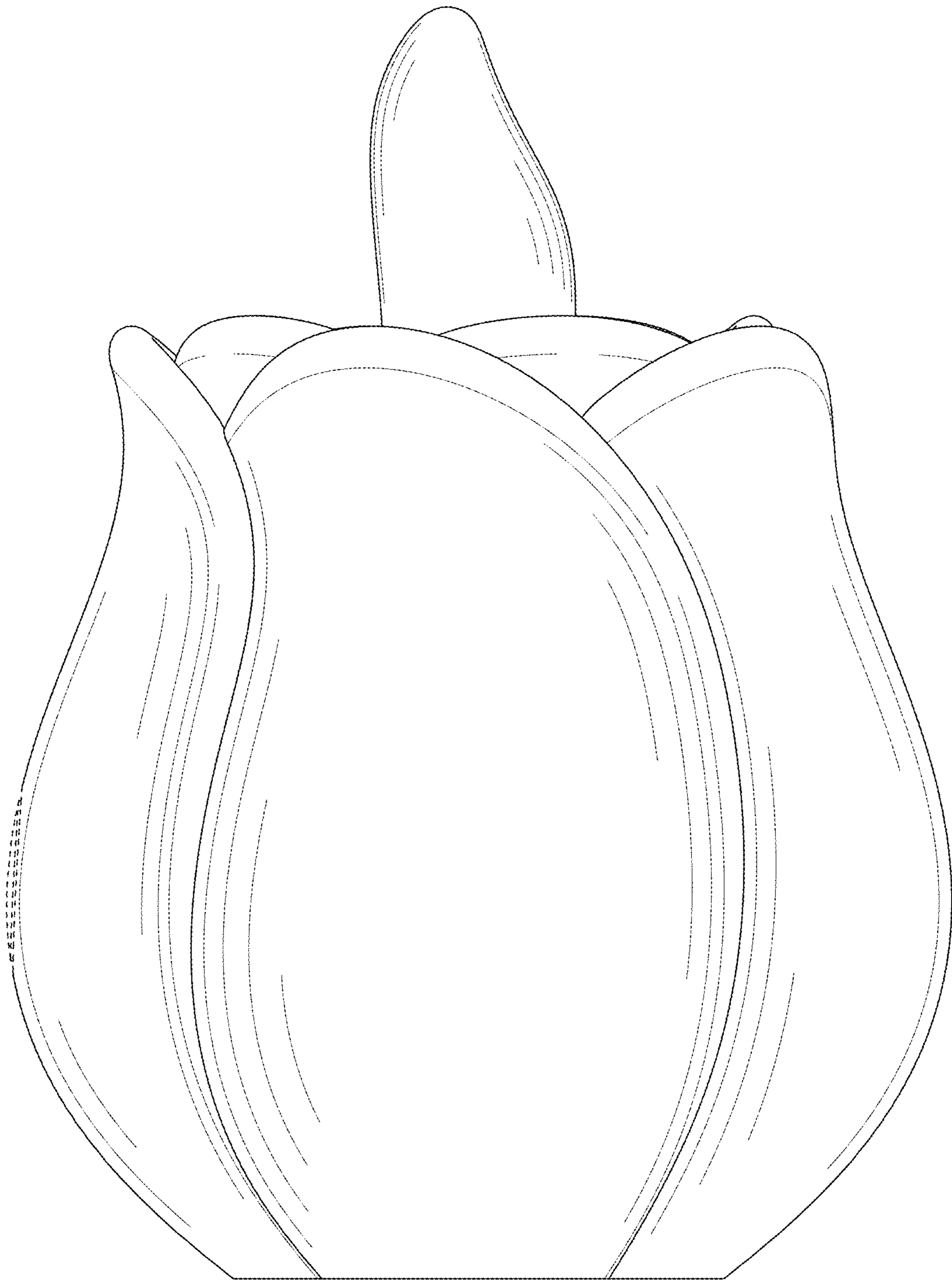

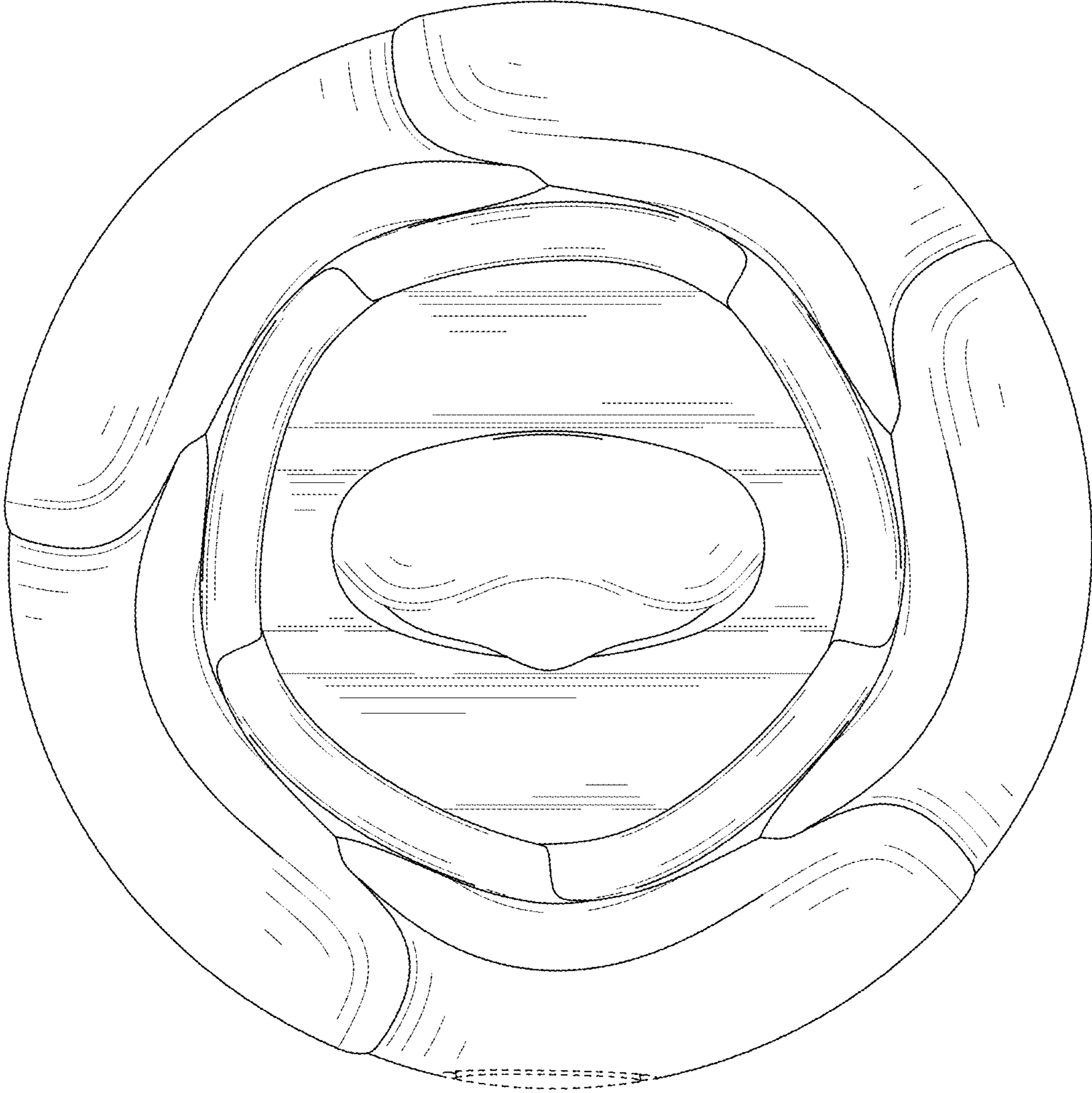

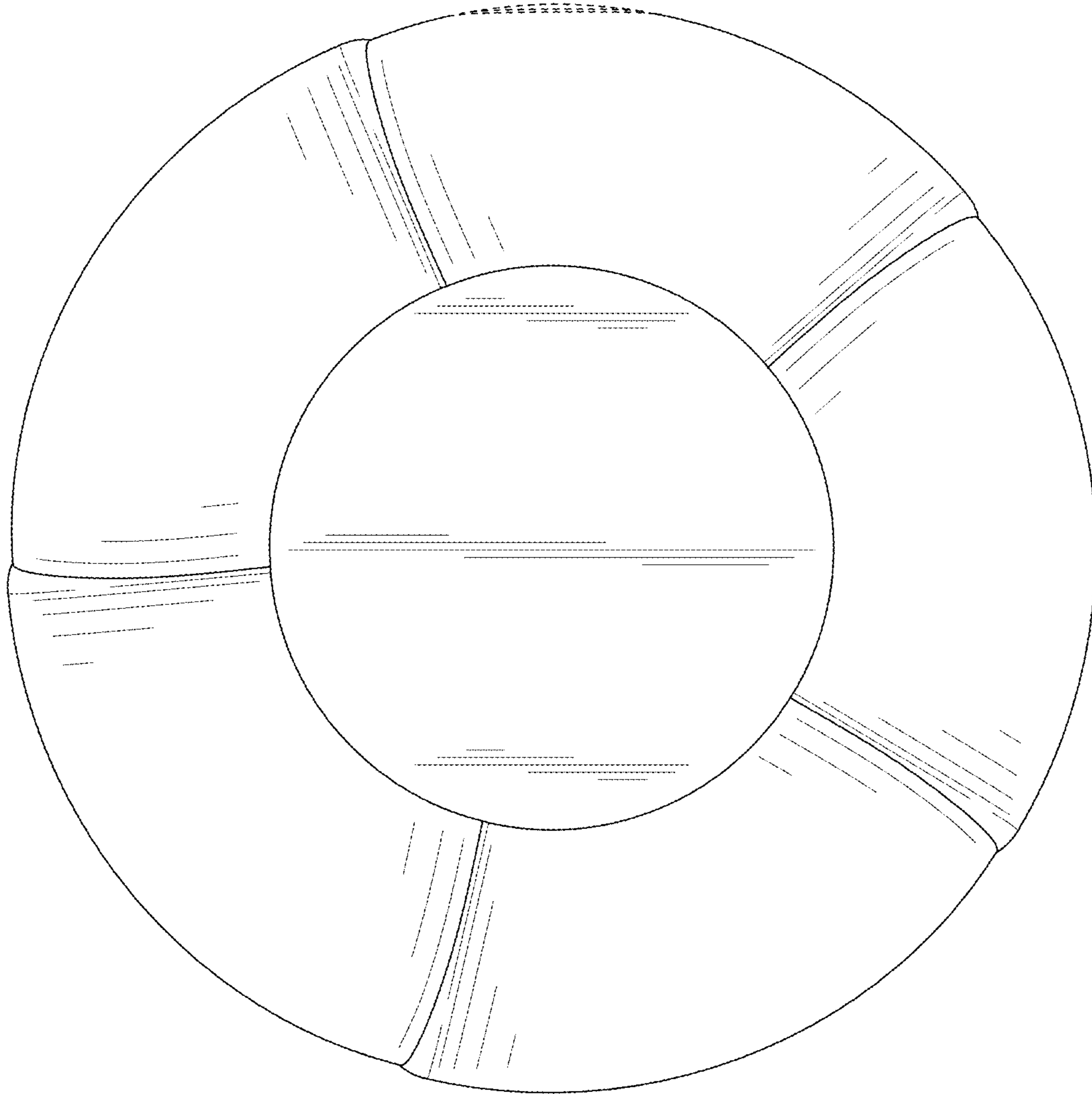
