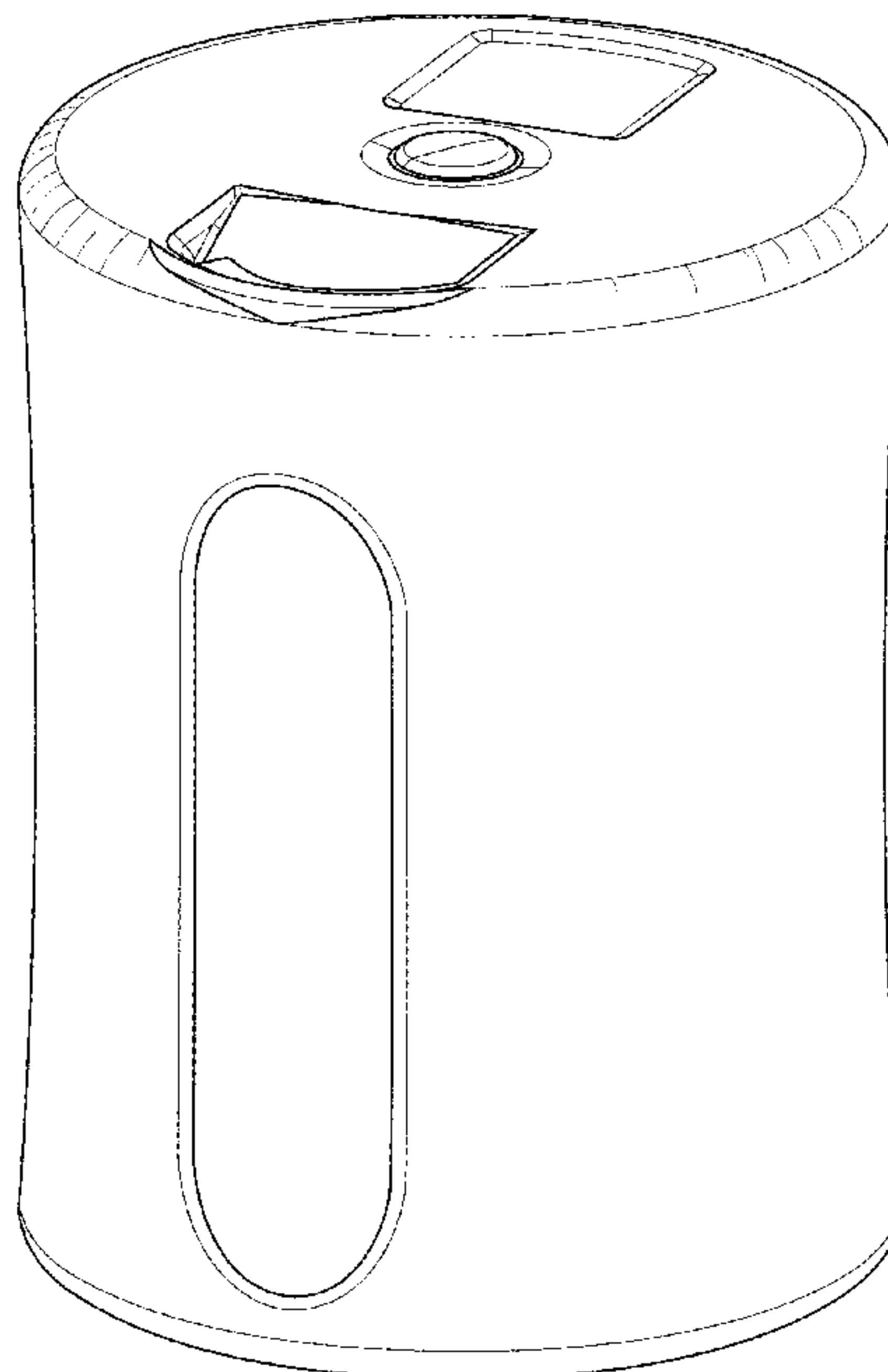
(57) **CLAIM**

We claim an ornamental design for a molecular diagnostic device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a molecular diagnostic device in accordance with the present design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a left side view thereof; and, FIG. 8 is a bottom perspective view thereof. The broken lines depict portions of the molecular diagnostic device that form no part of the claimed design.

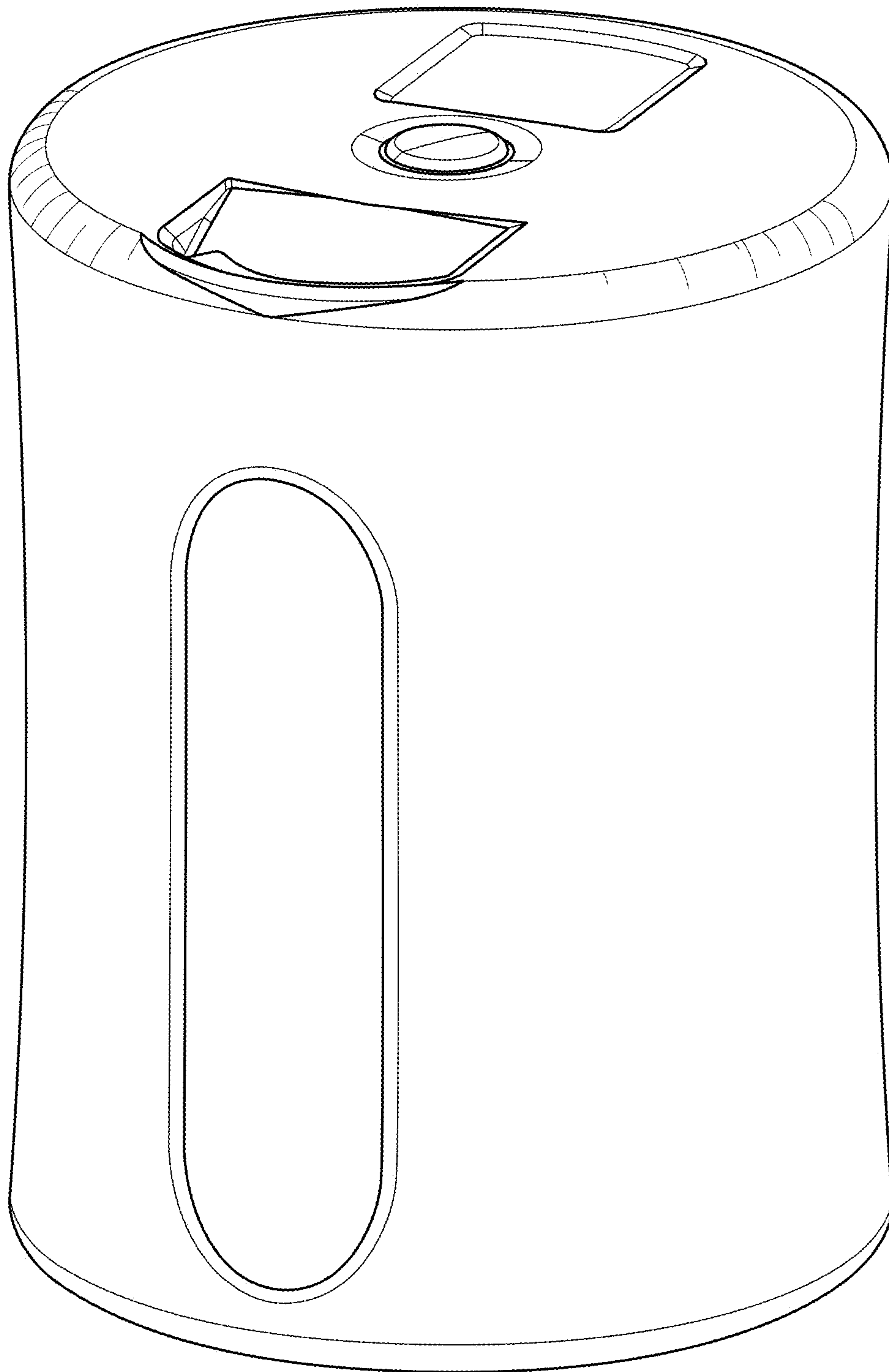

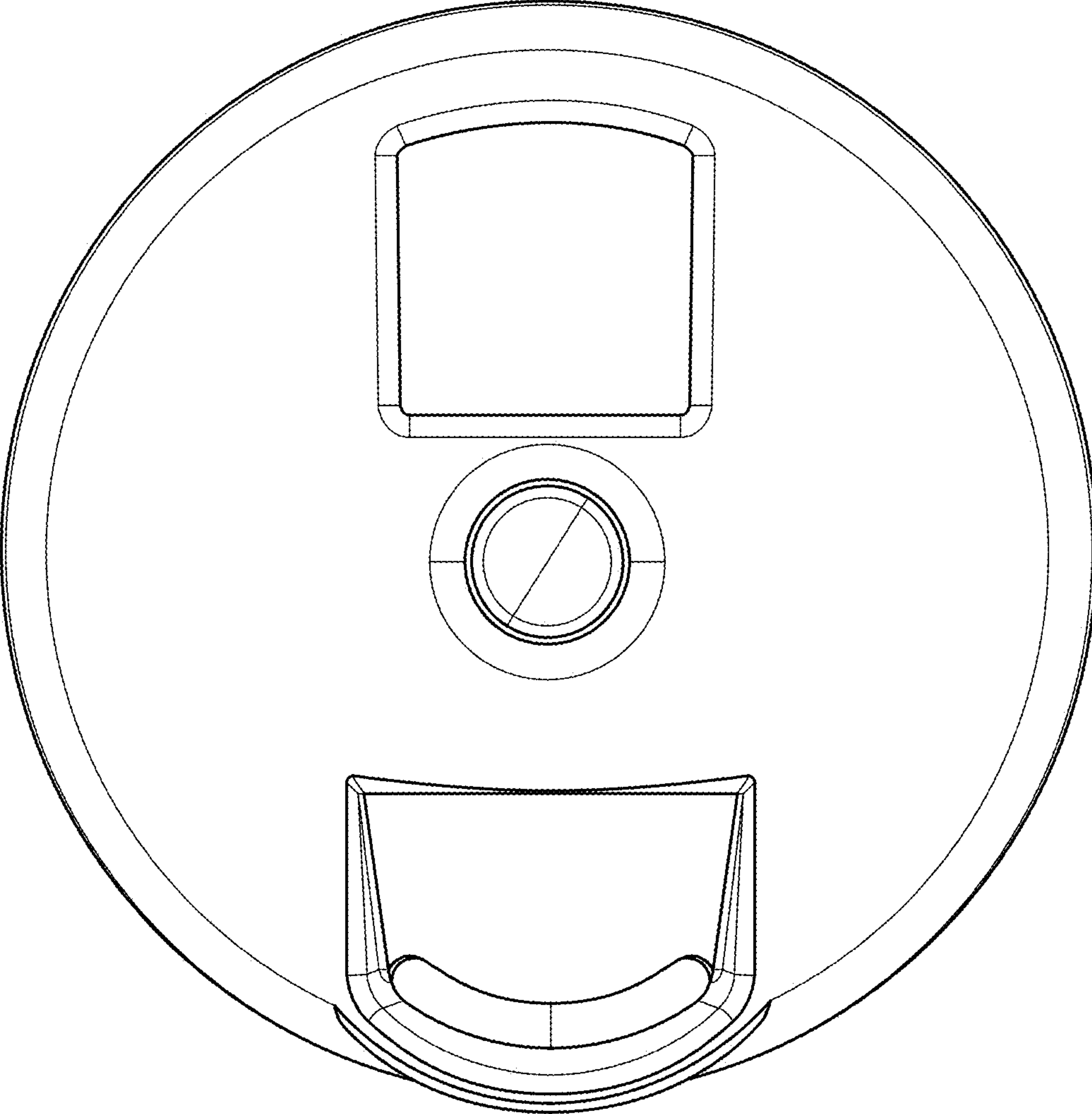

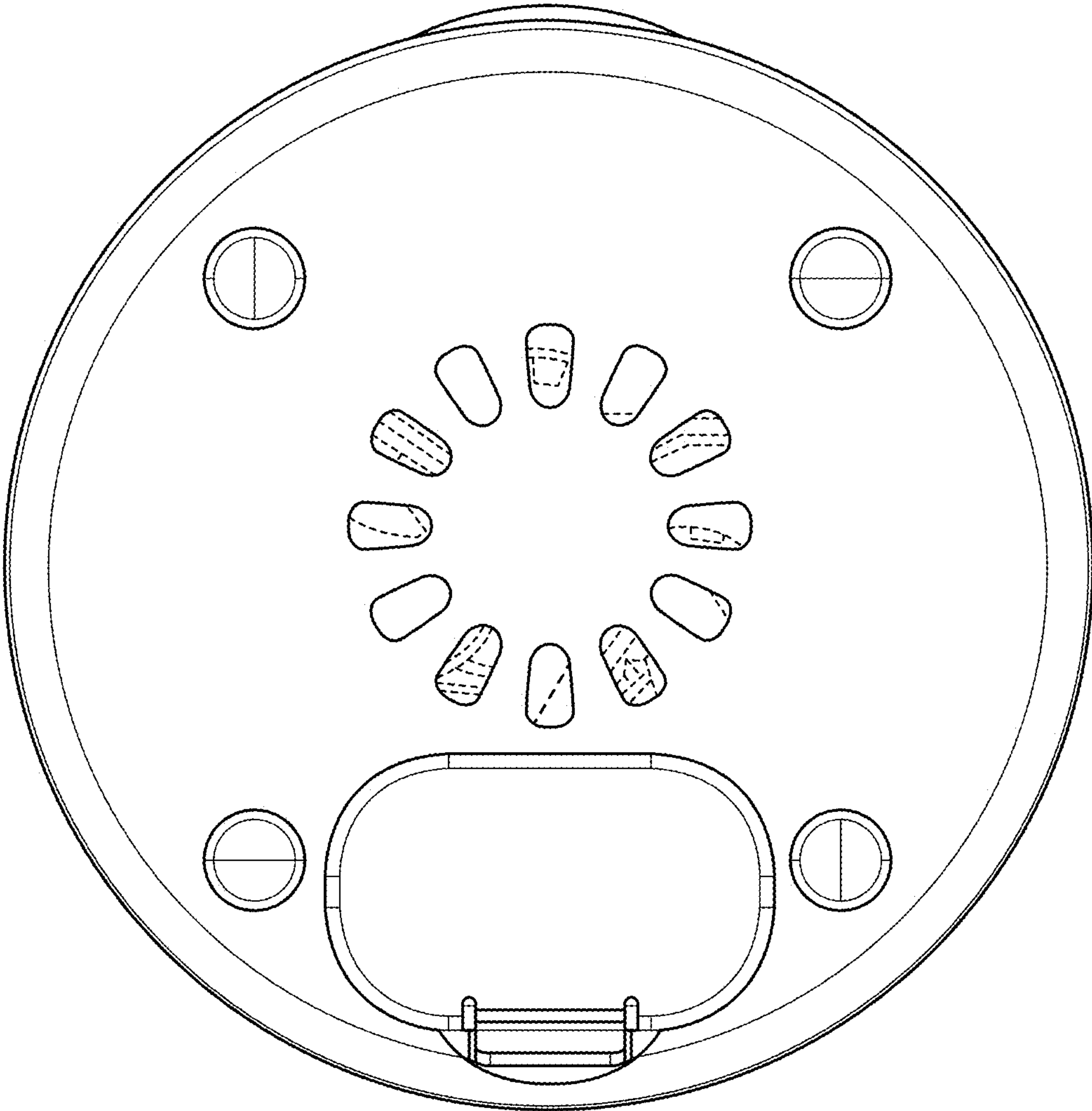

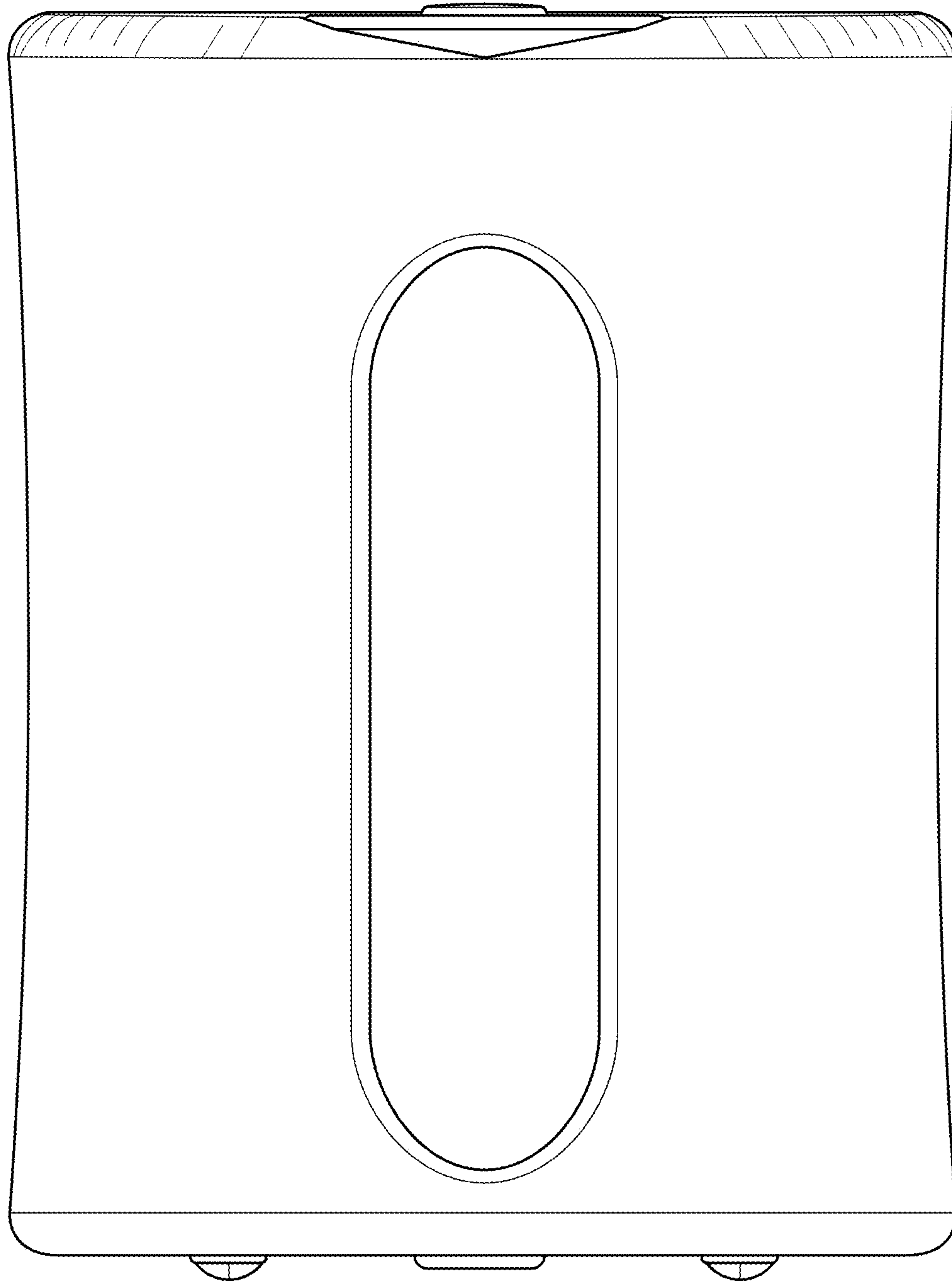

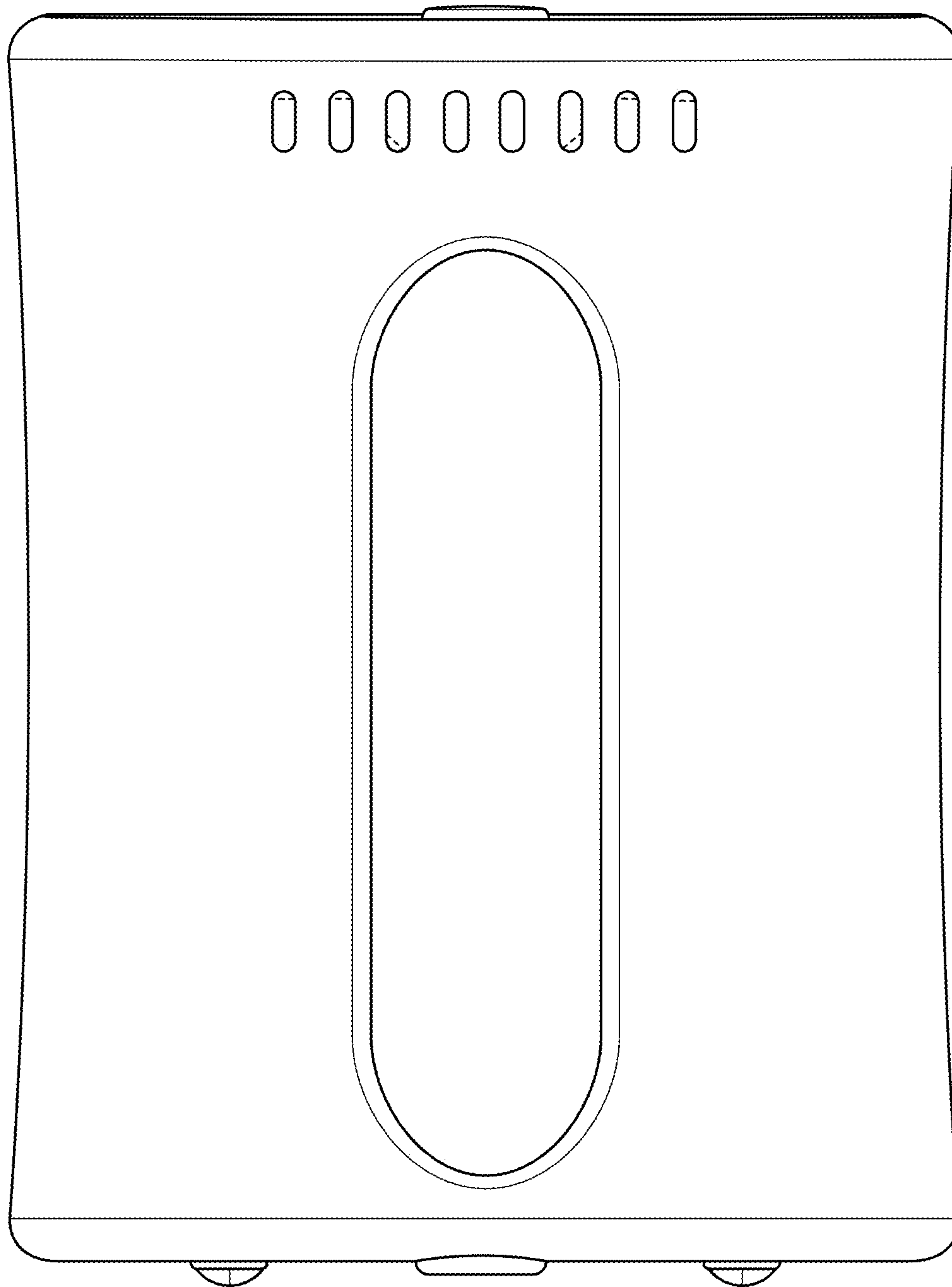

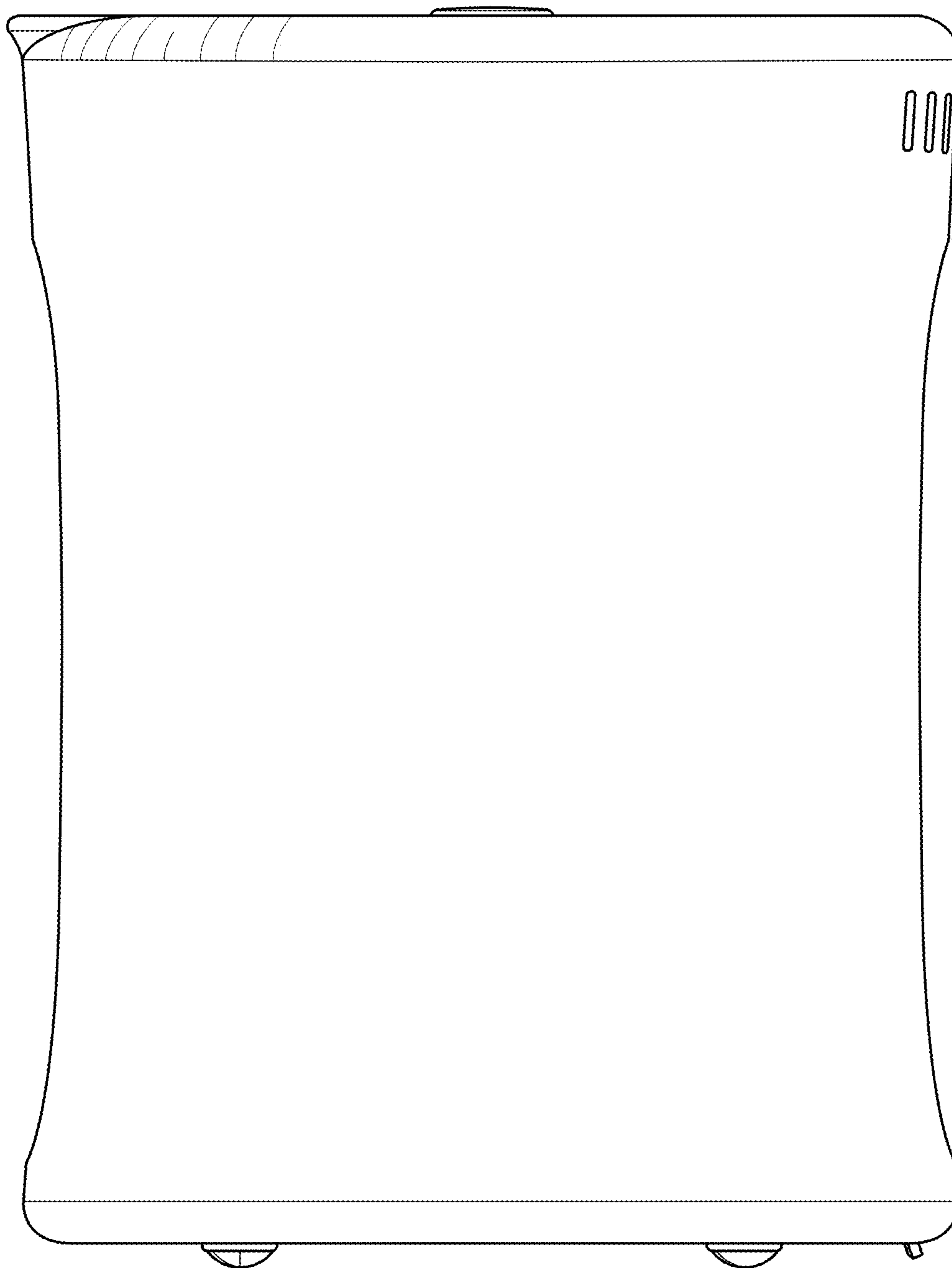

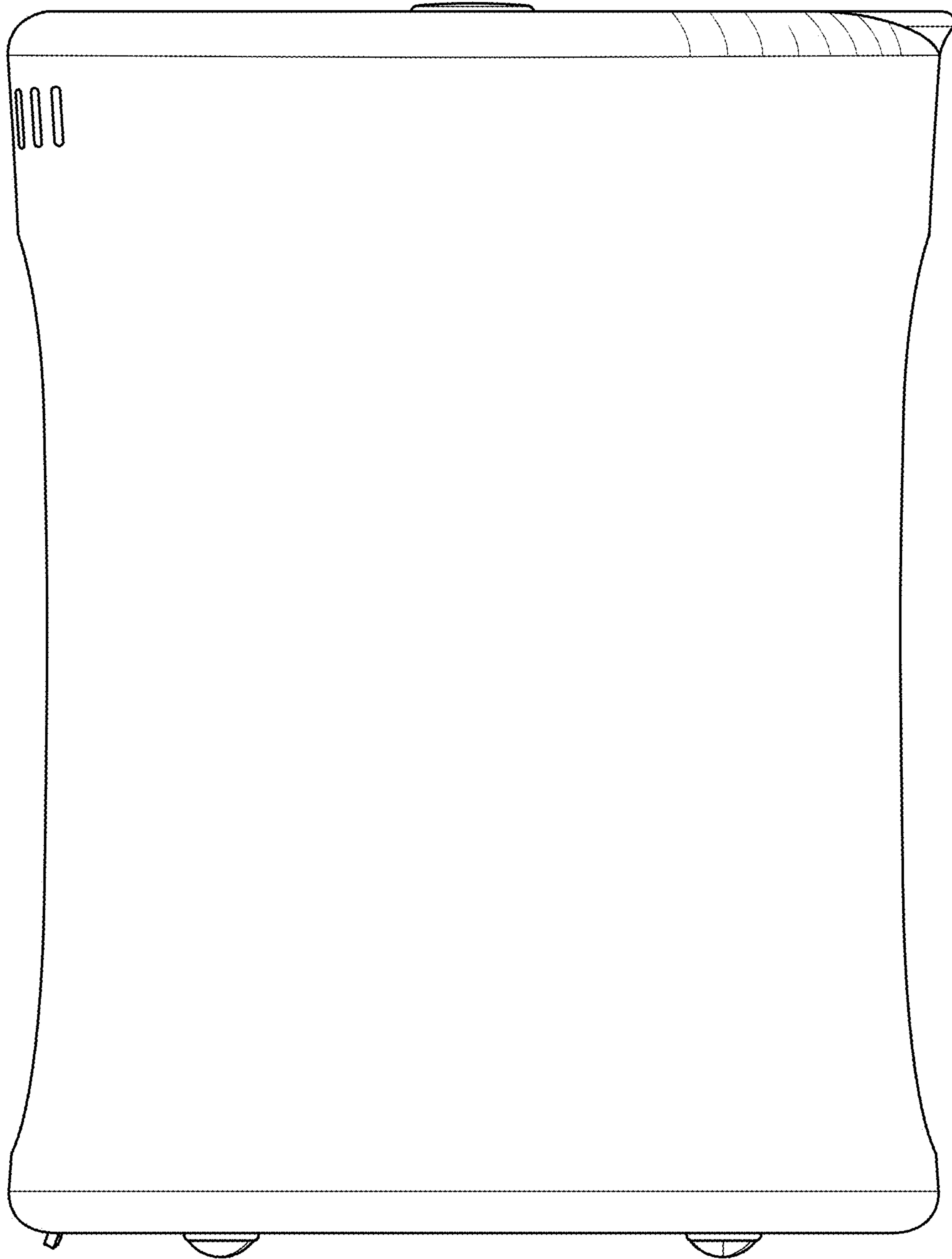

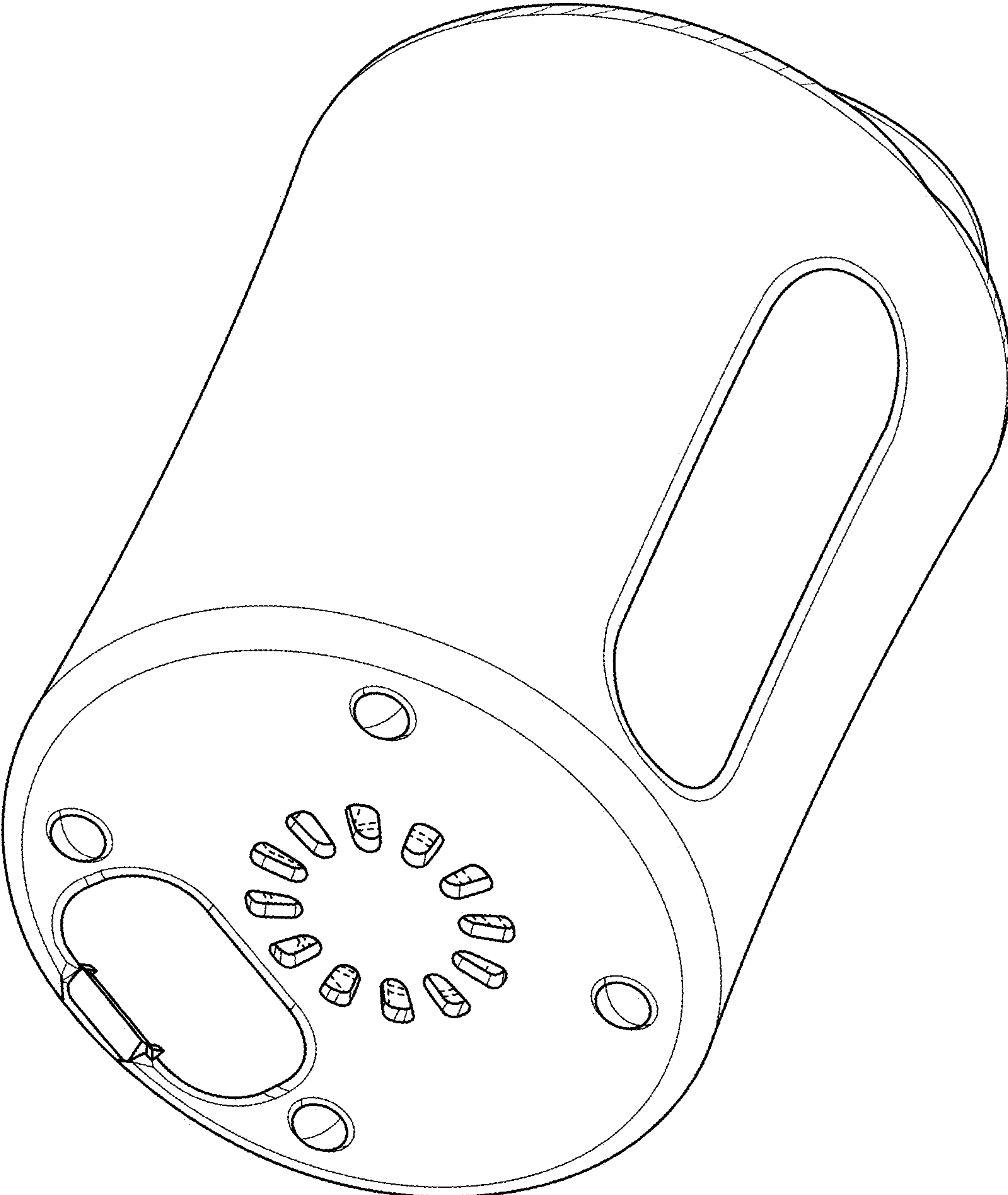
