FIG. 11 is a partial enlarged view of portion 11 in FIG. 3.

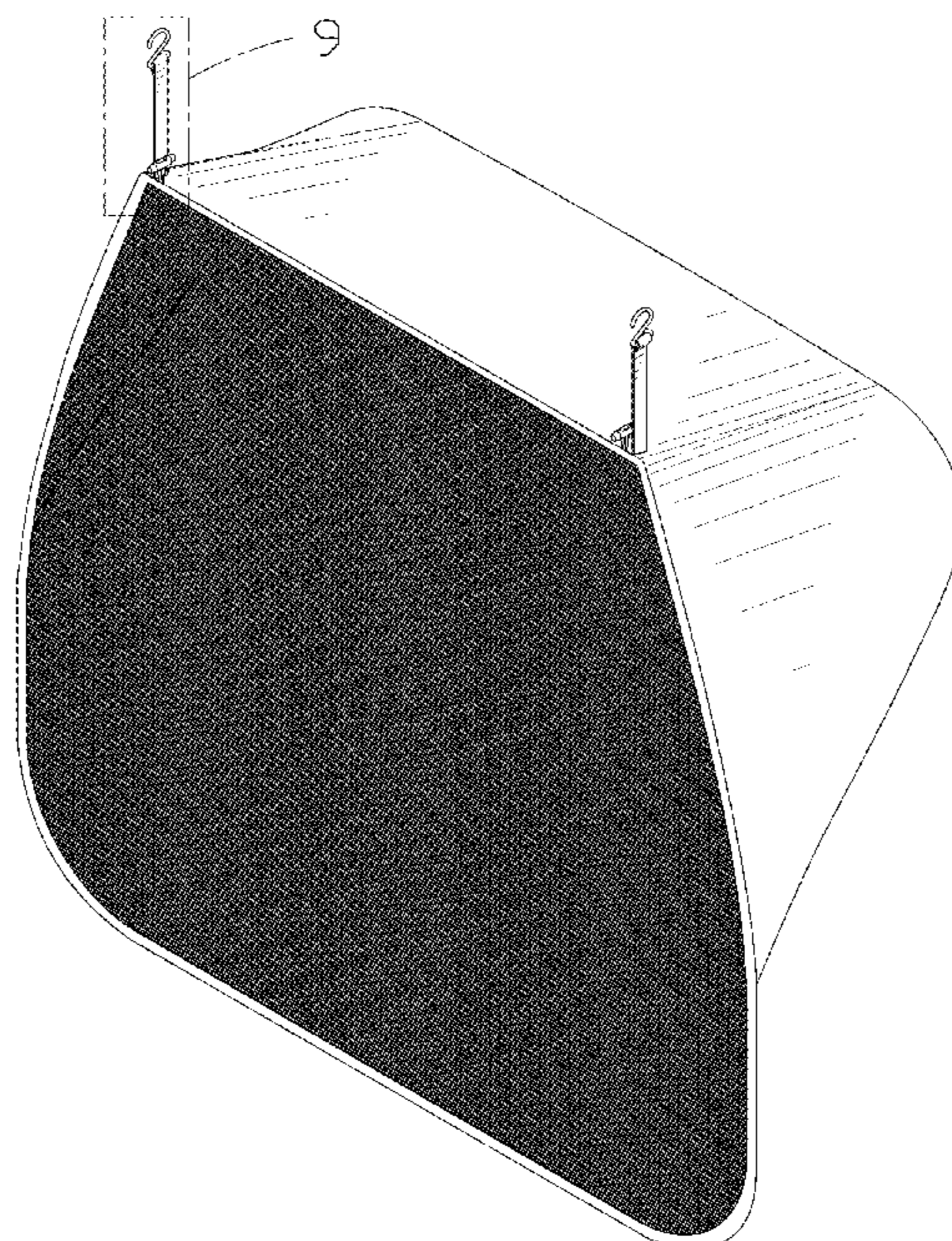
The dot-dash lines in FIGS. 9-11 are for the purpose of depicting the boundary lines of the enlarged views and form no part of the claimed design.

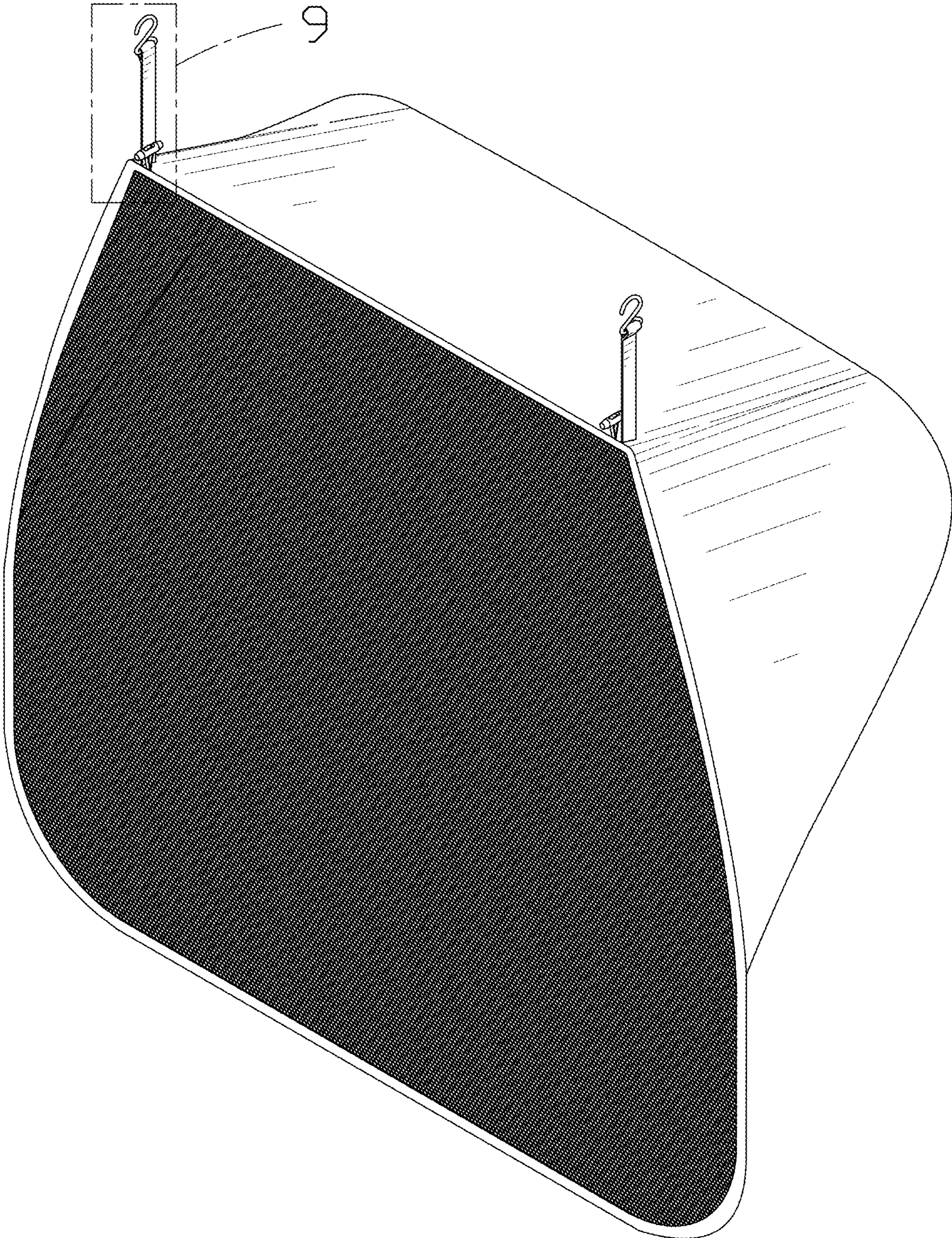

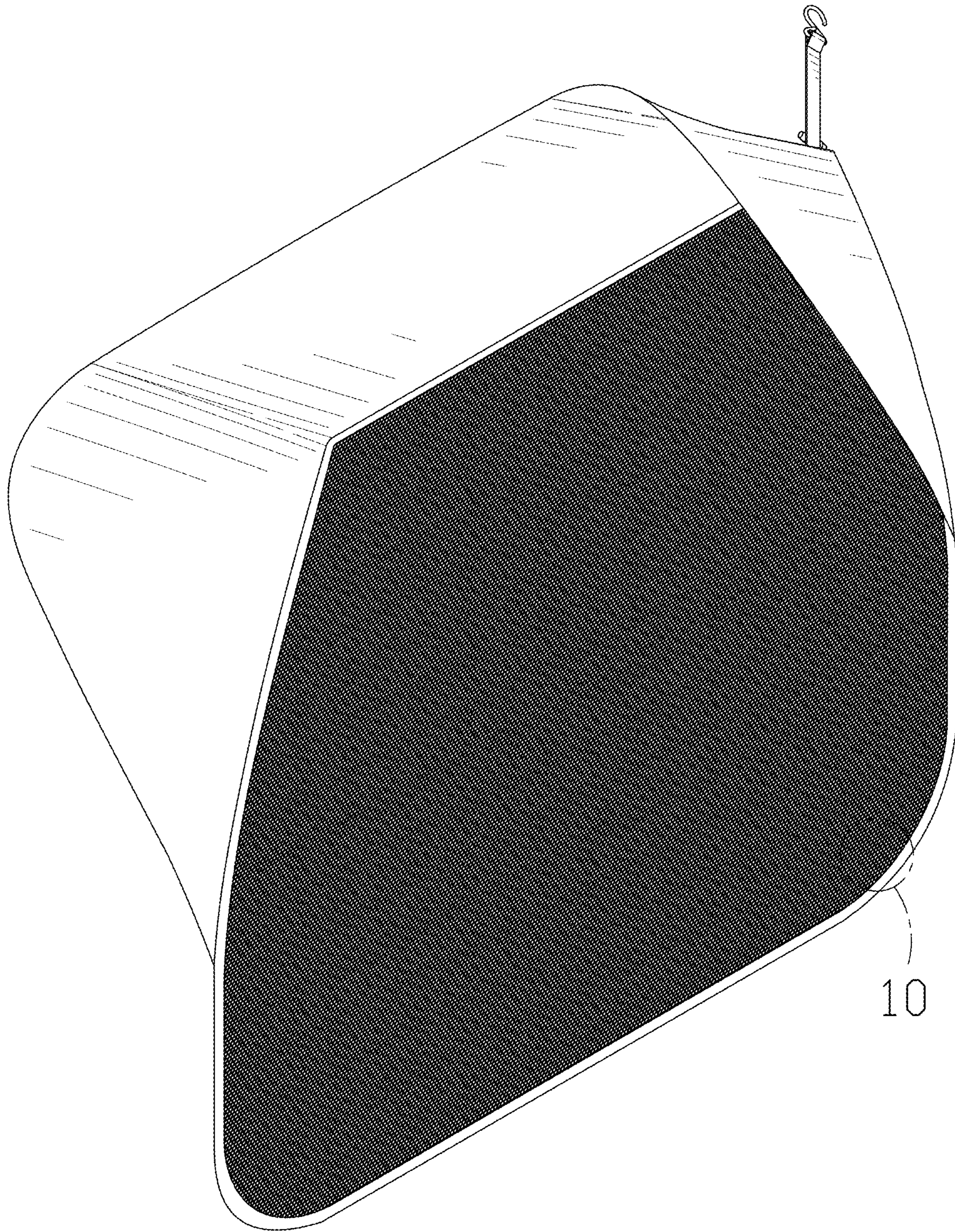

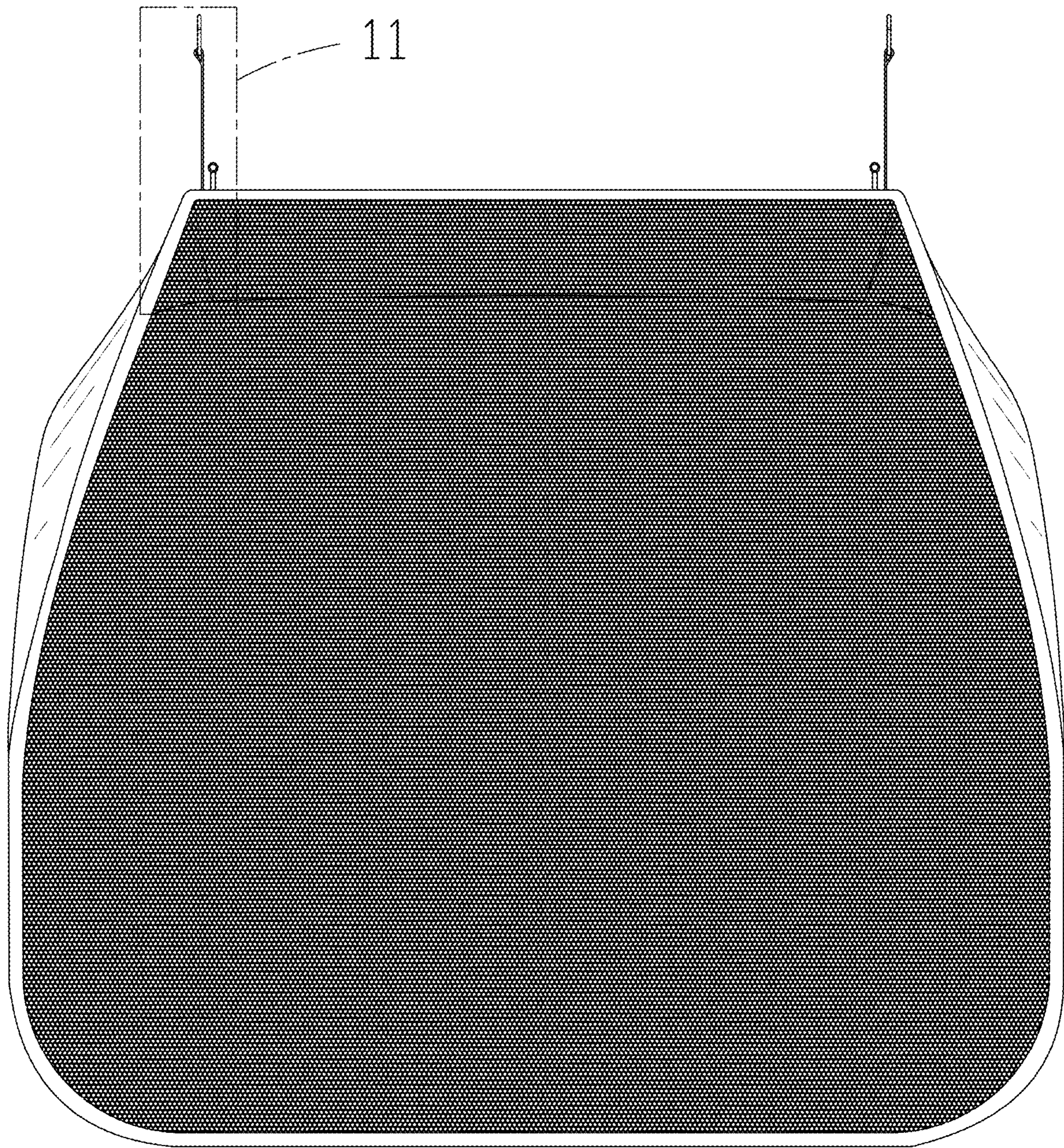

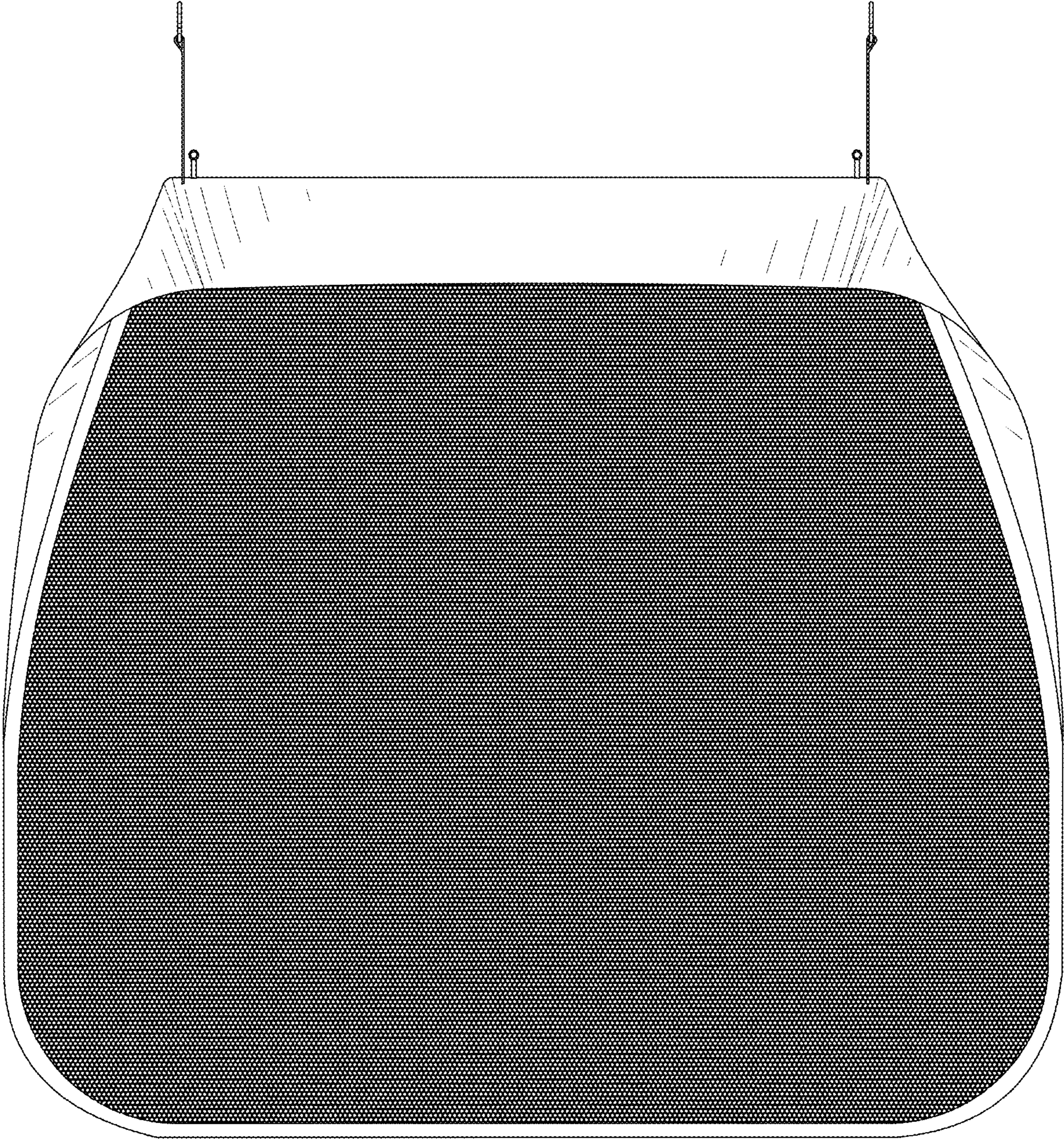

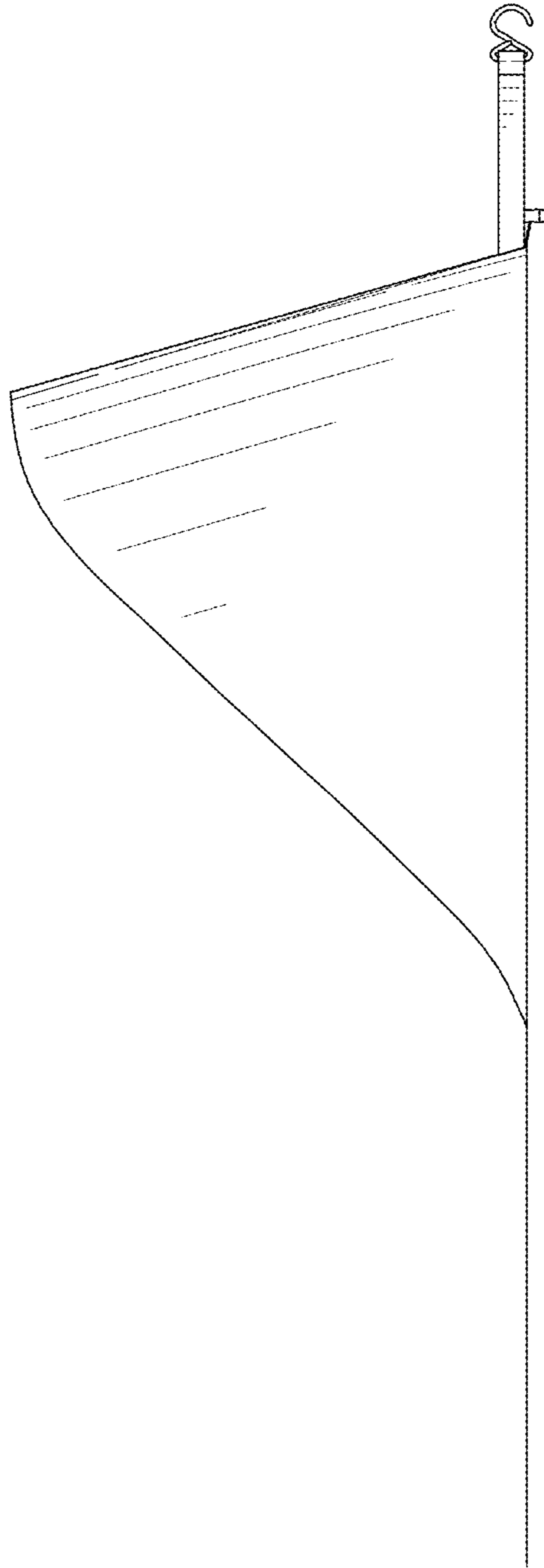

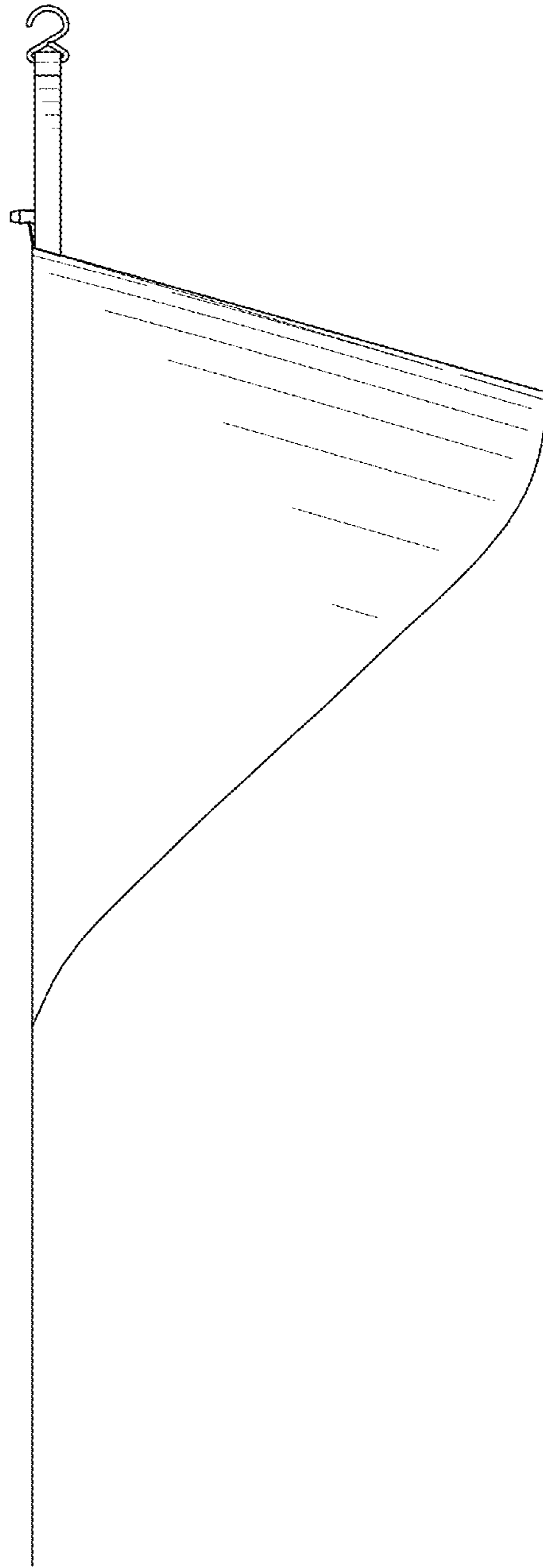

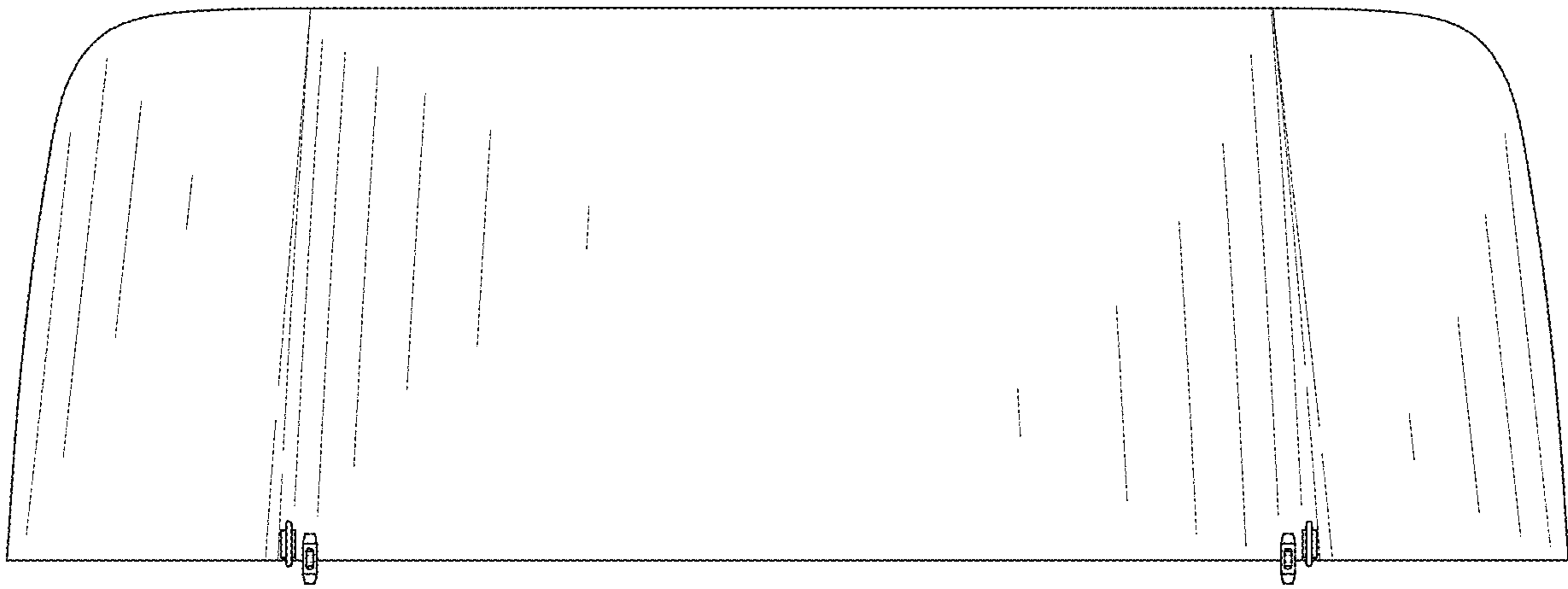

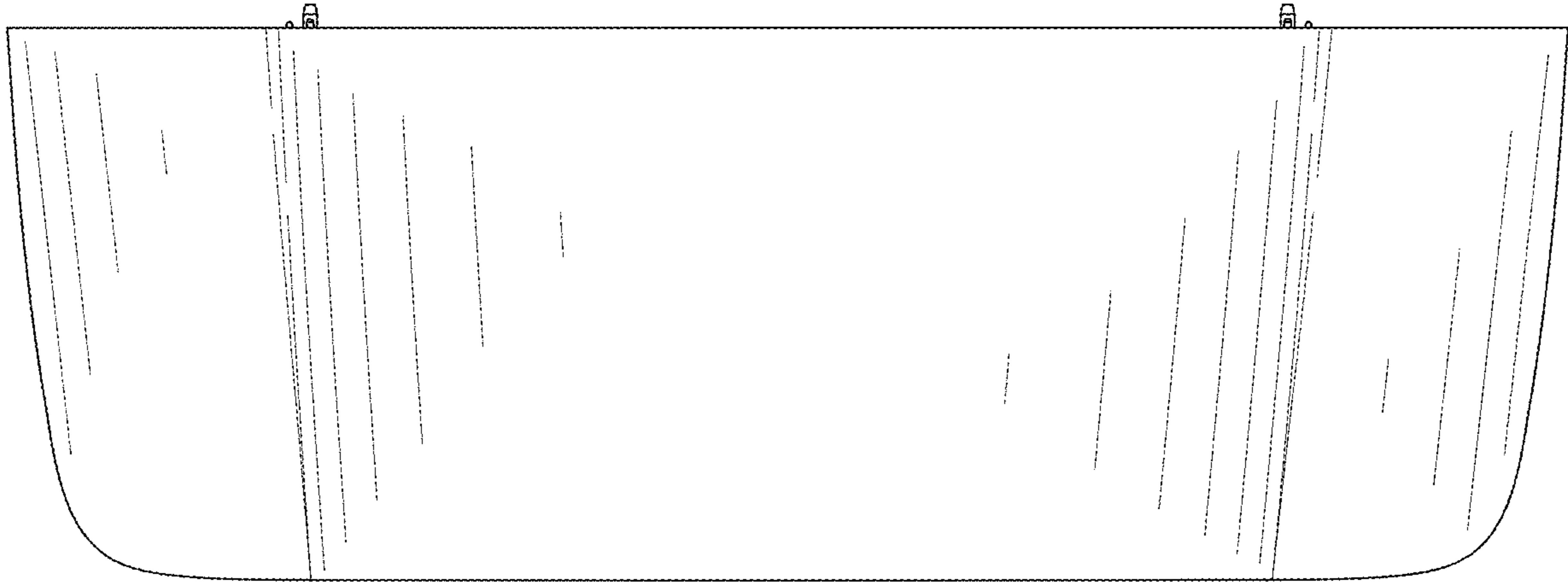

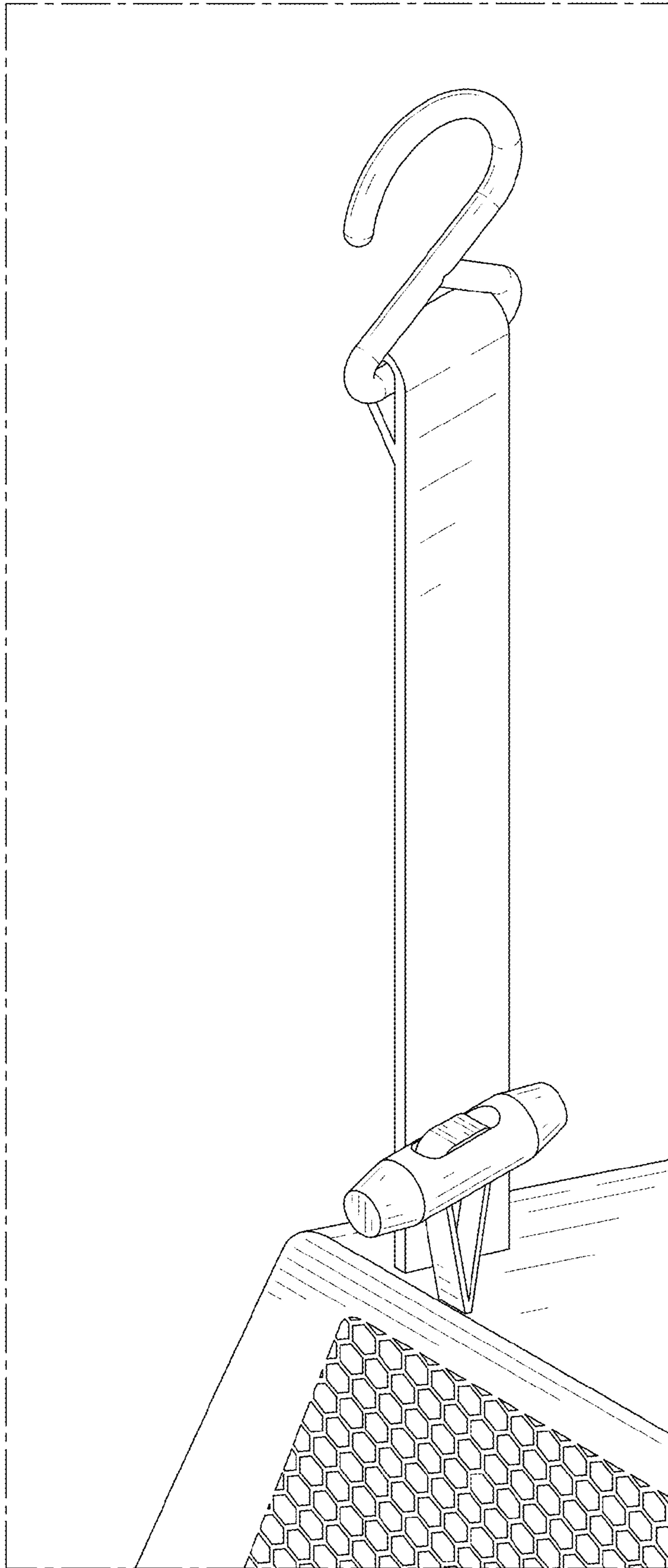

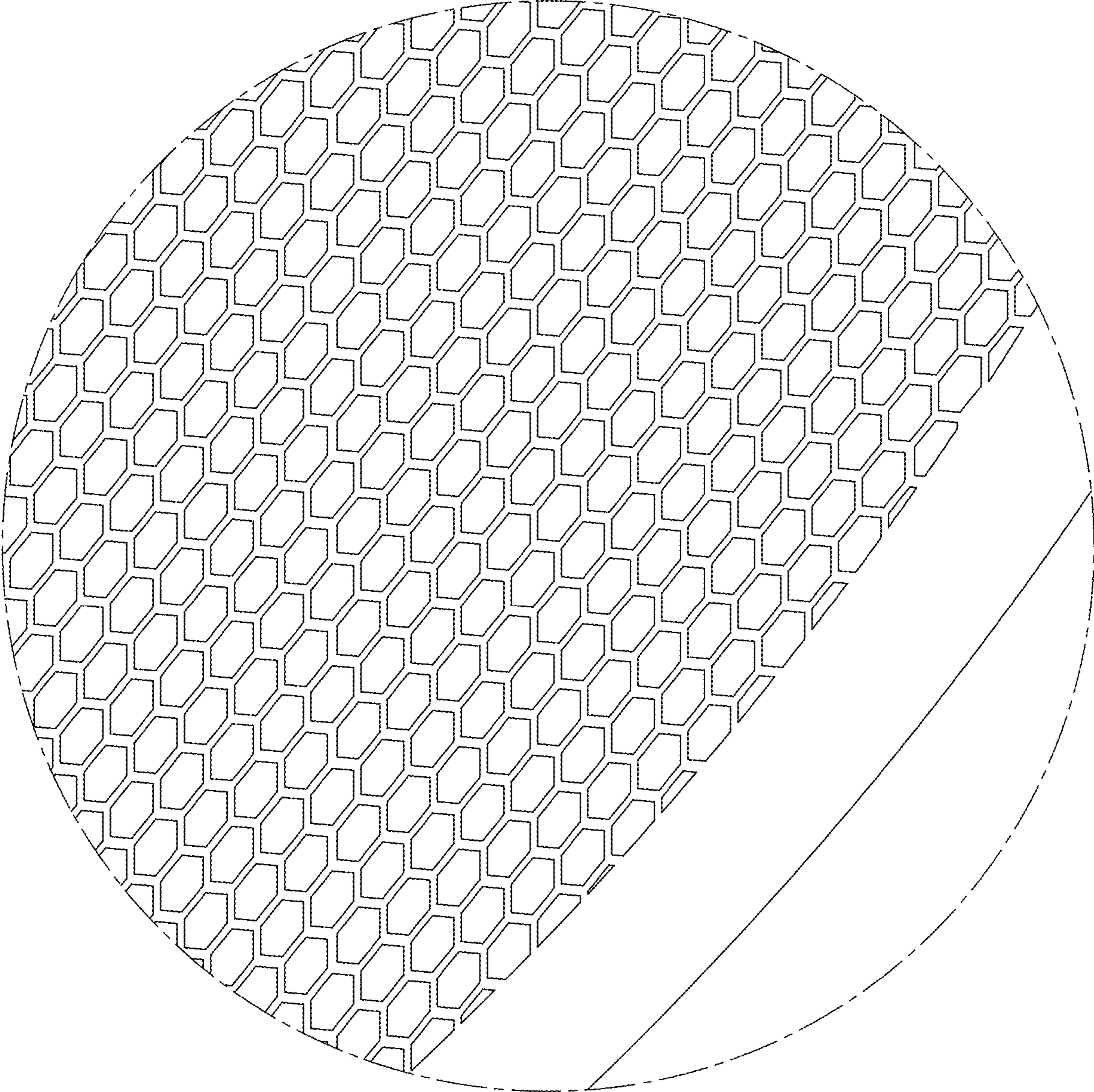

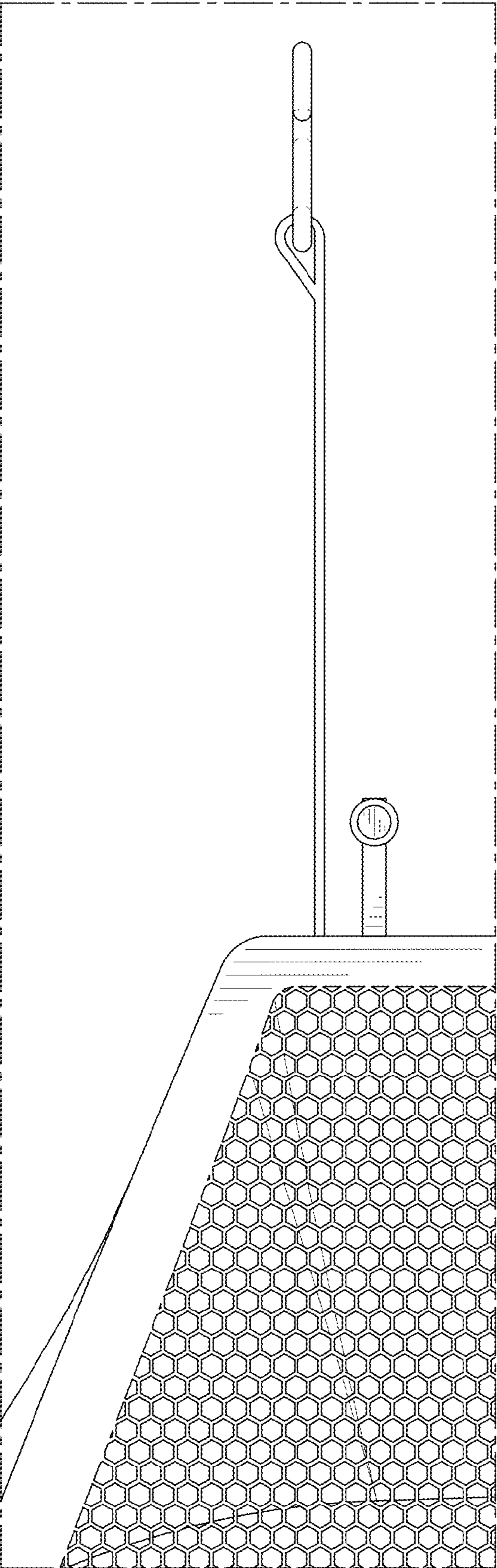
