**DESCRIPTION**

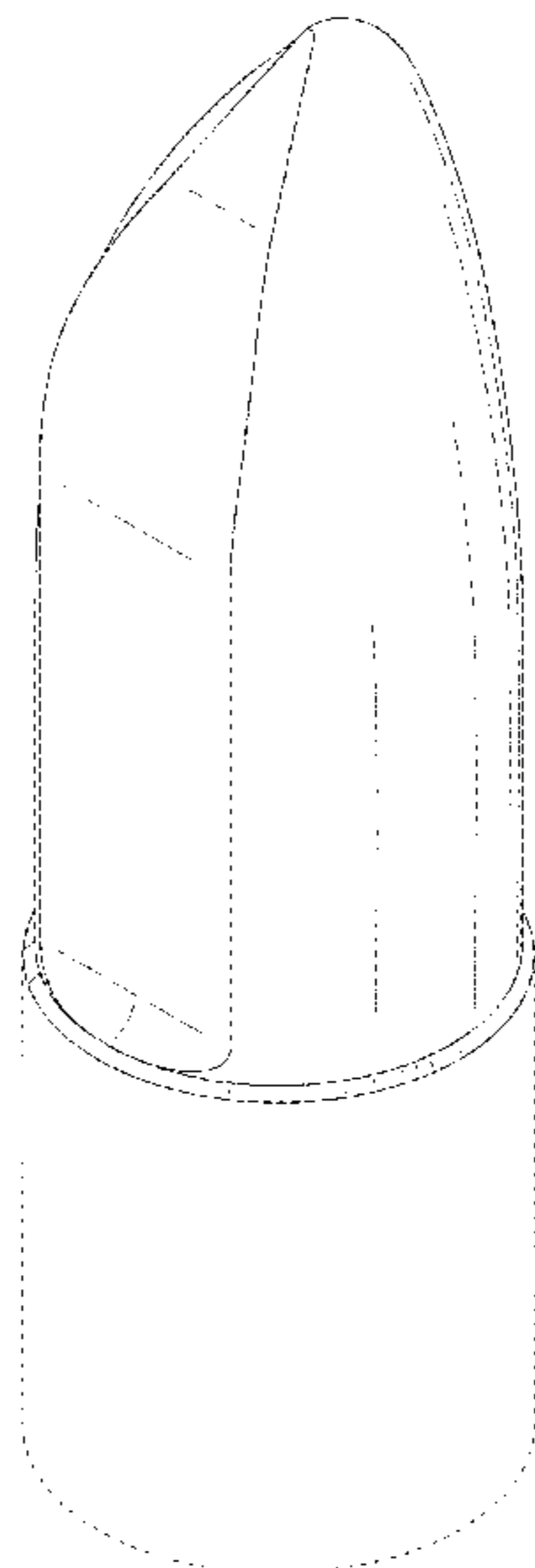
FIG. 1 is a top front isometric perspective view of a lipstick bullet showing the claimed design;

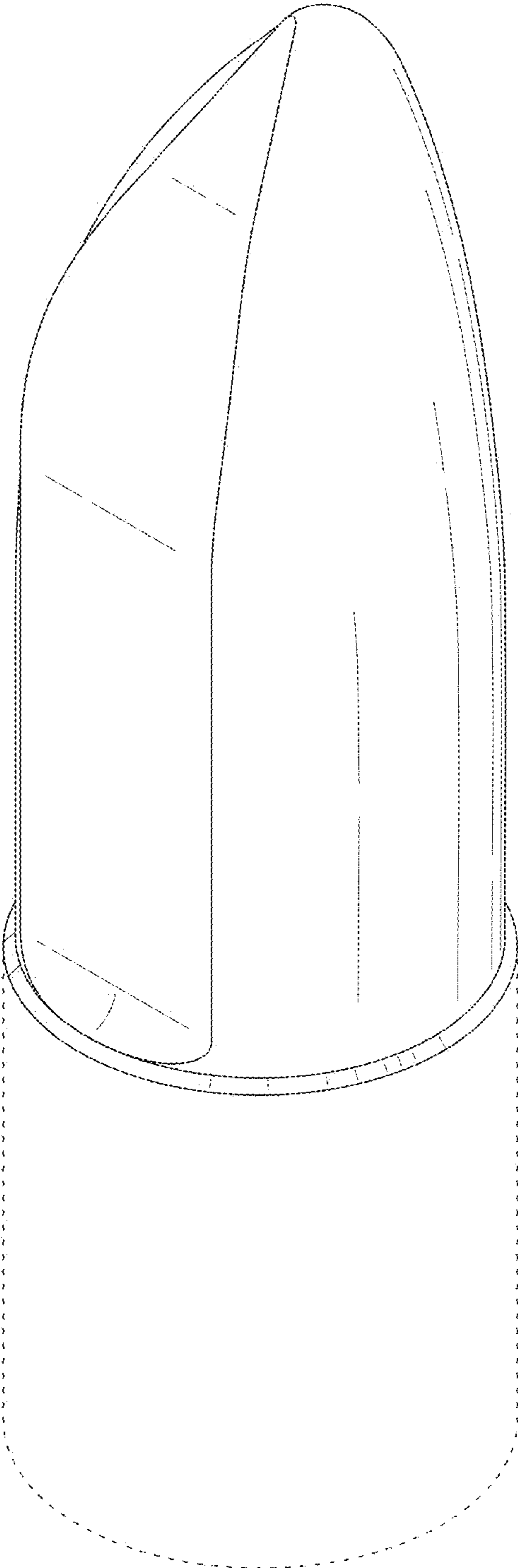

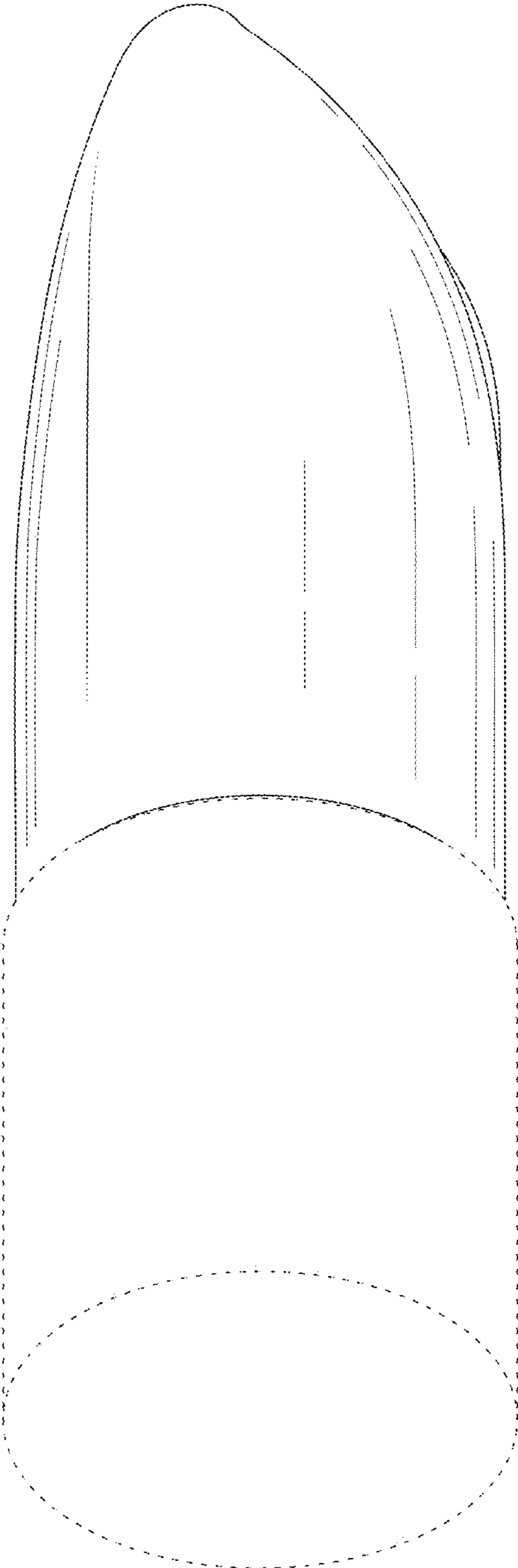

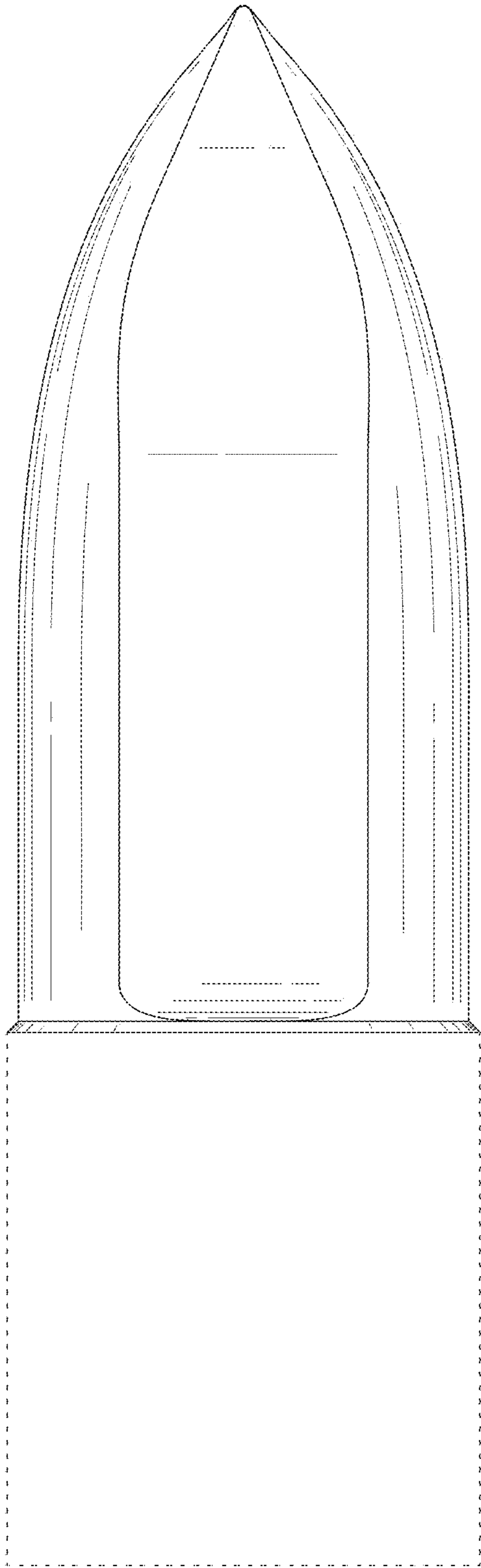

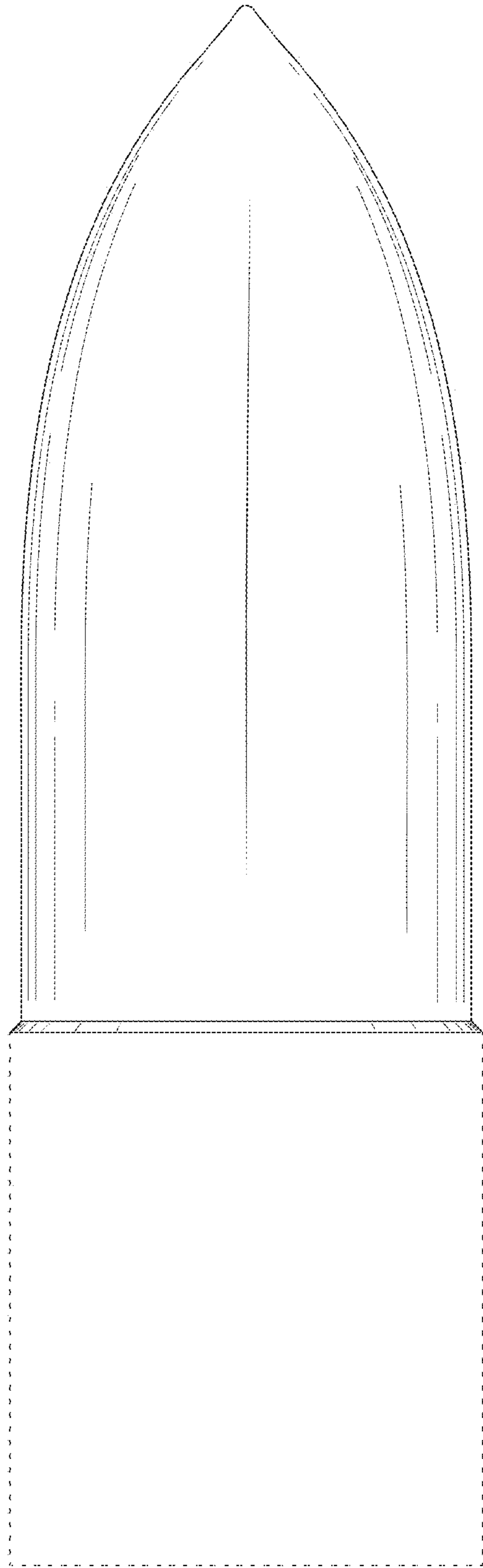

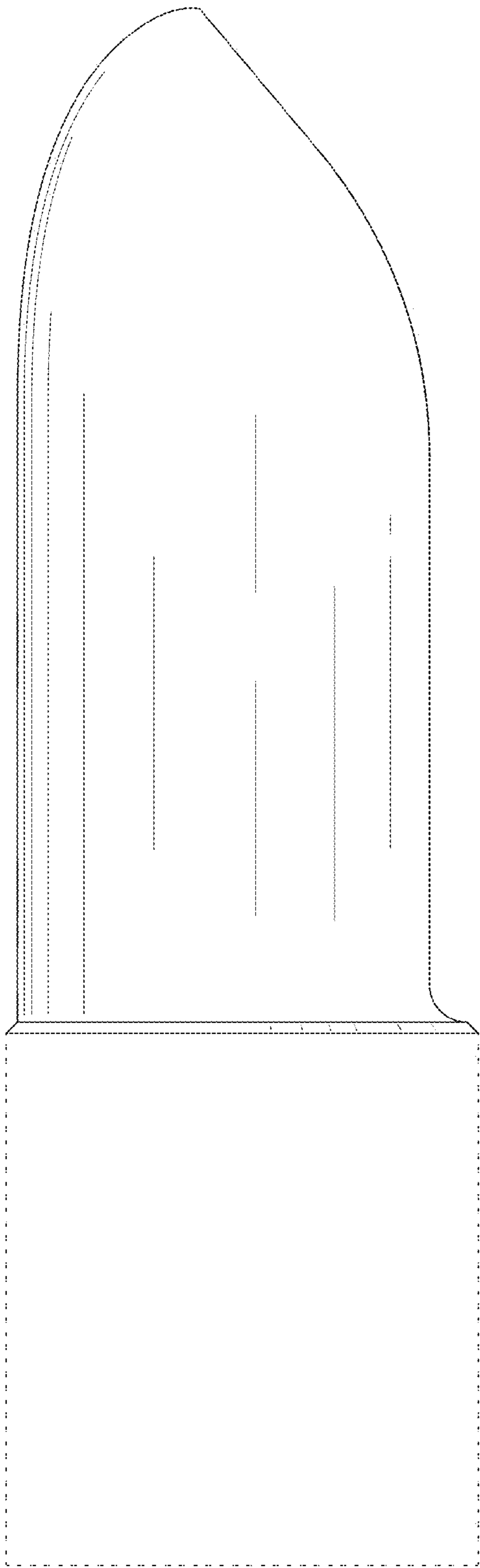

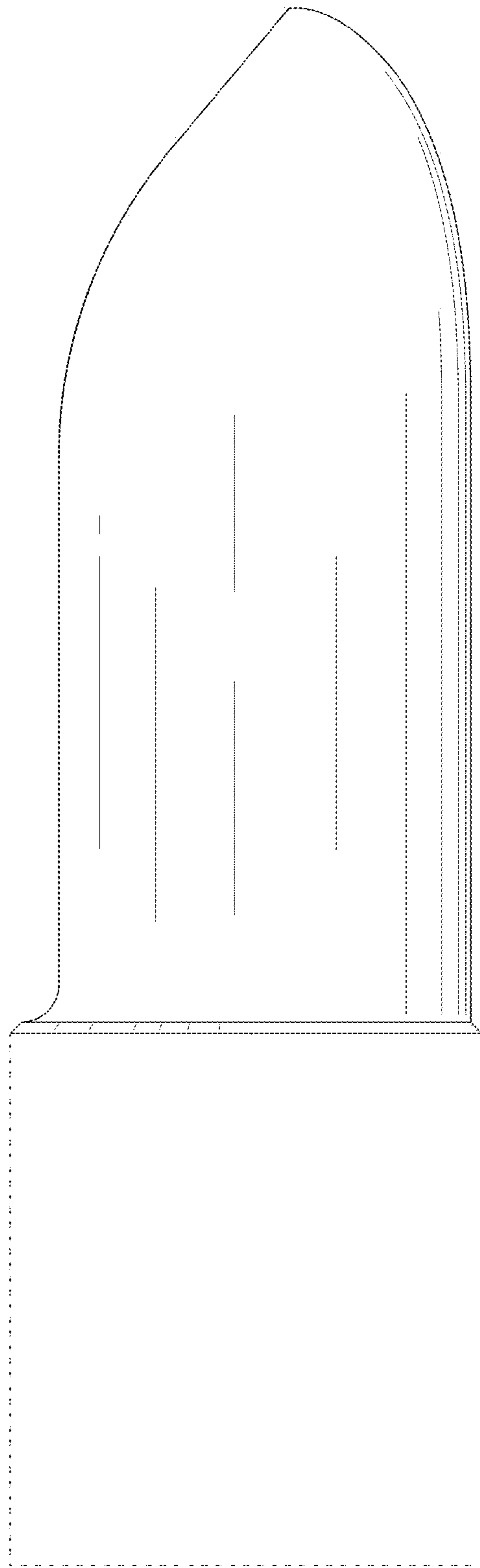

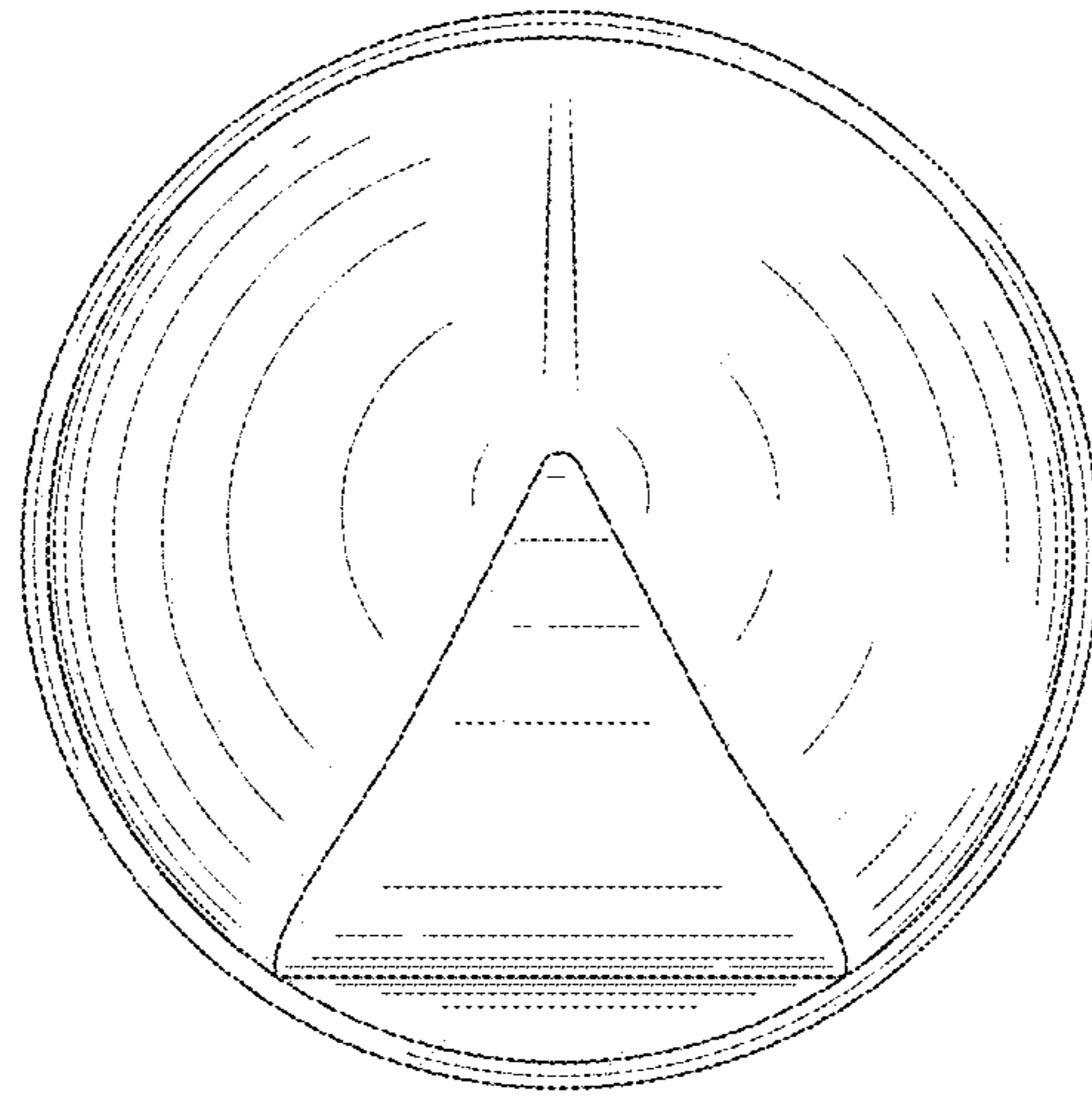

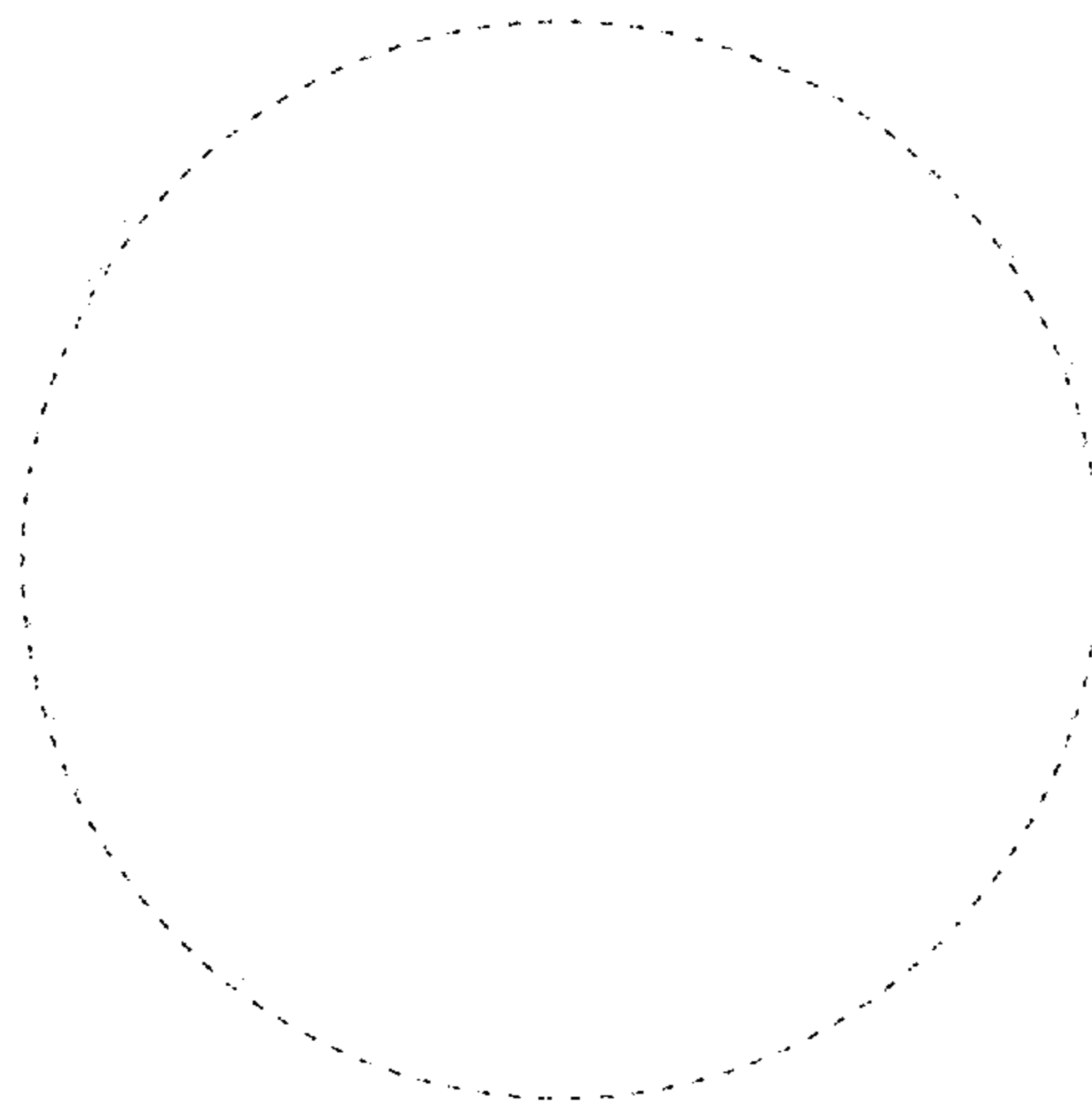
