(57) **CLAIM**

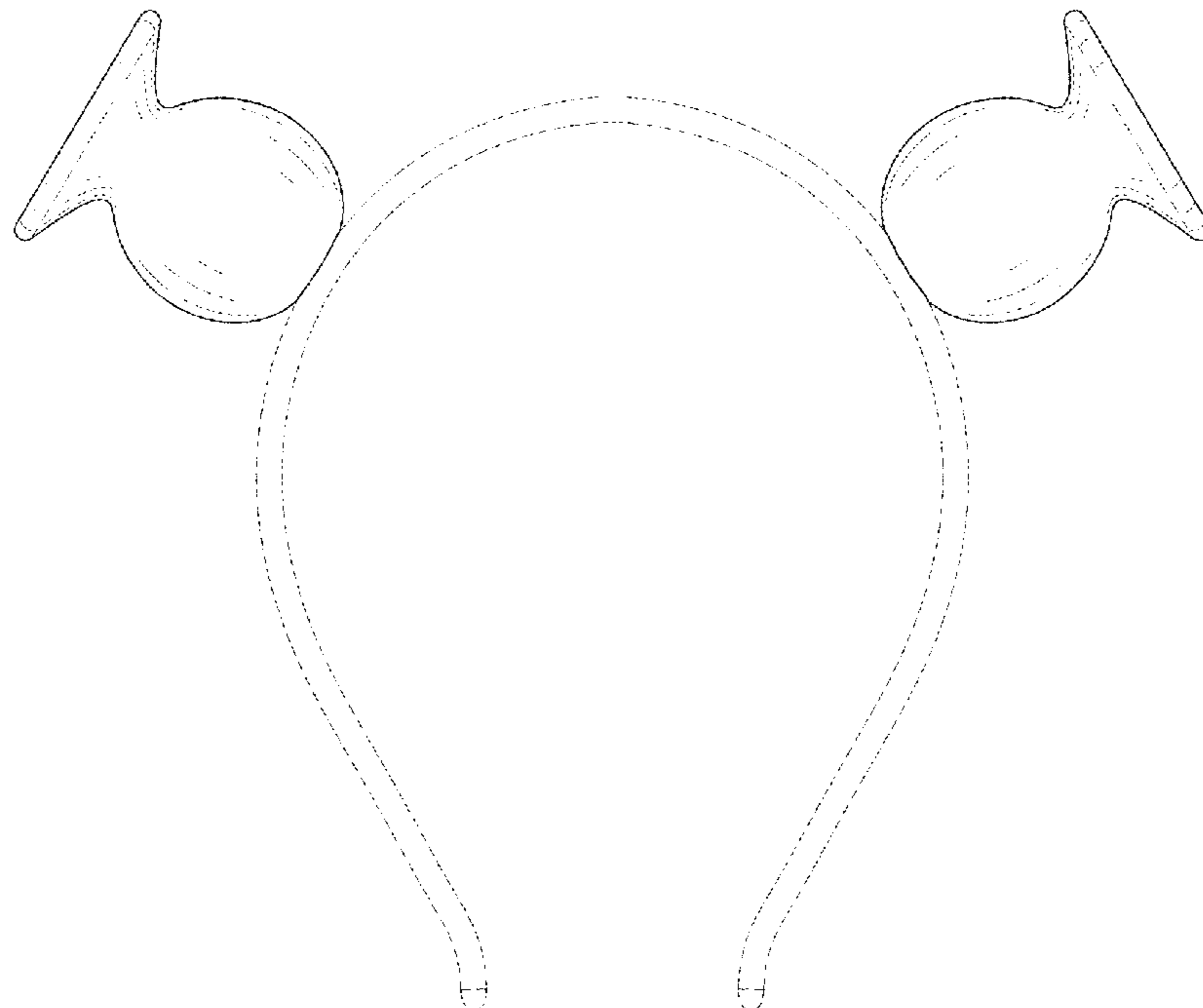
The ornamental design for a headband, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a headband, showing my new design;
FIG. 2 is a front elevational view thereof, the rear elevational view is identical;

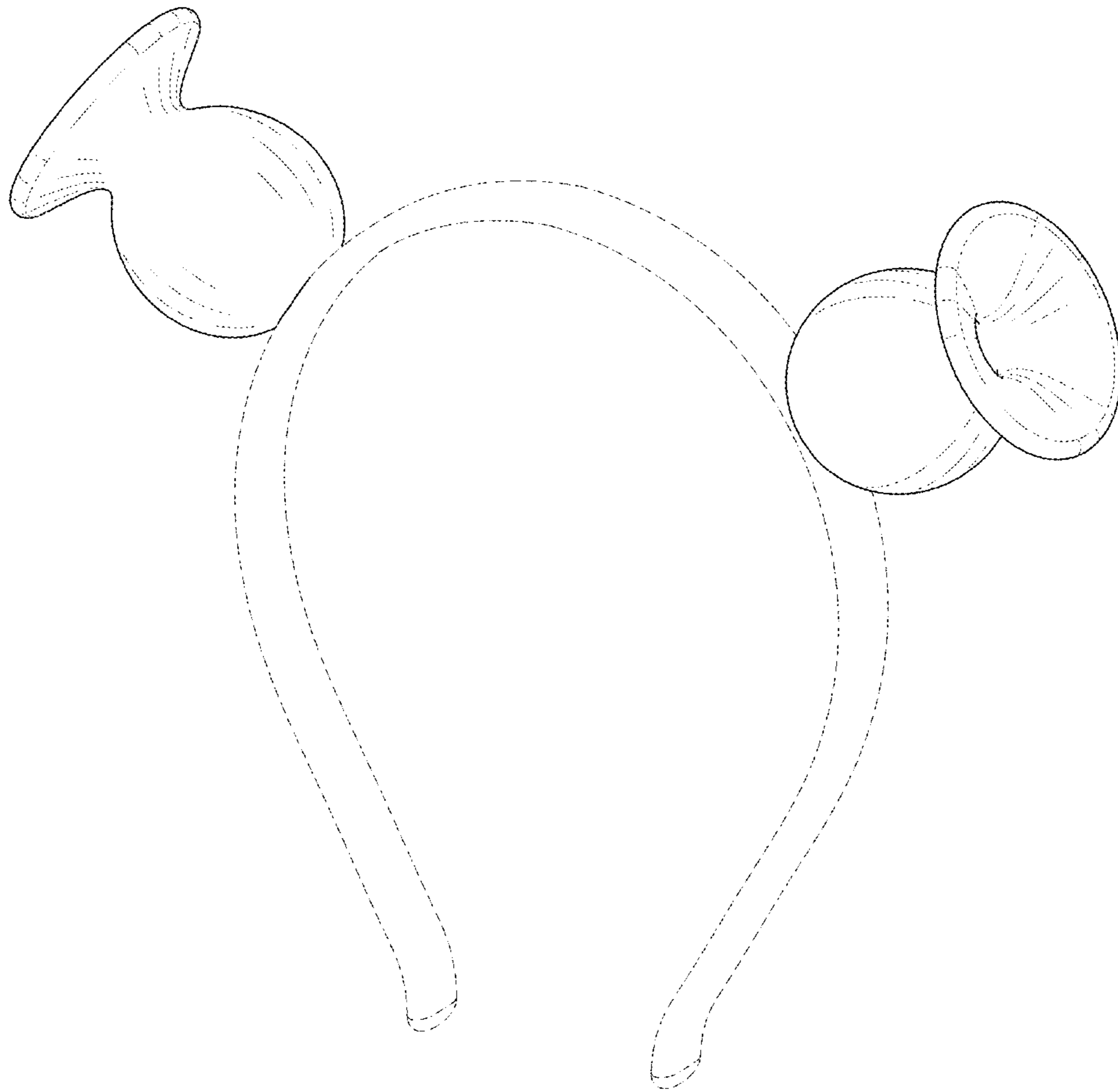

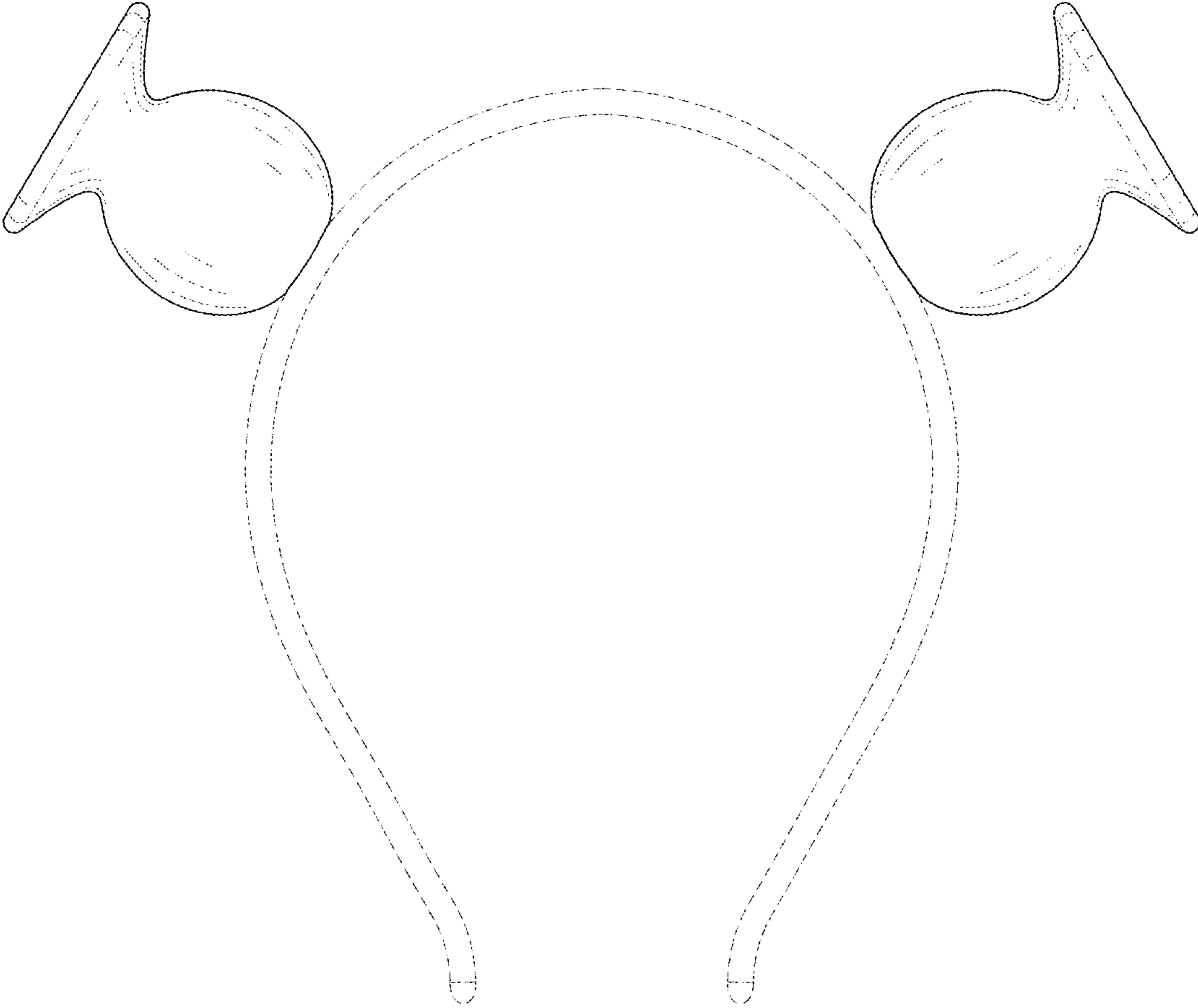

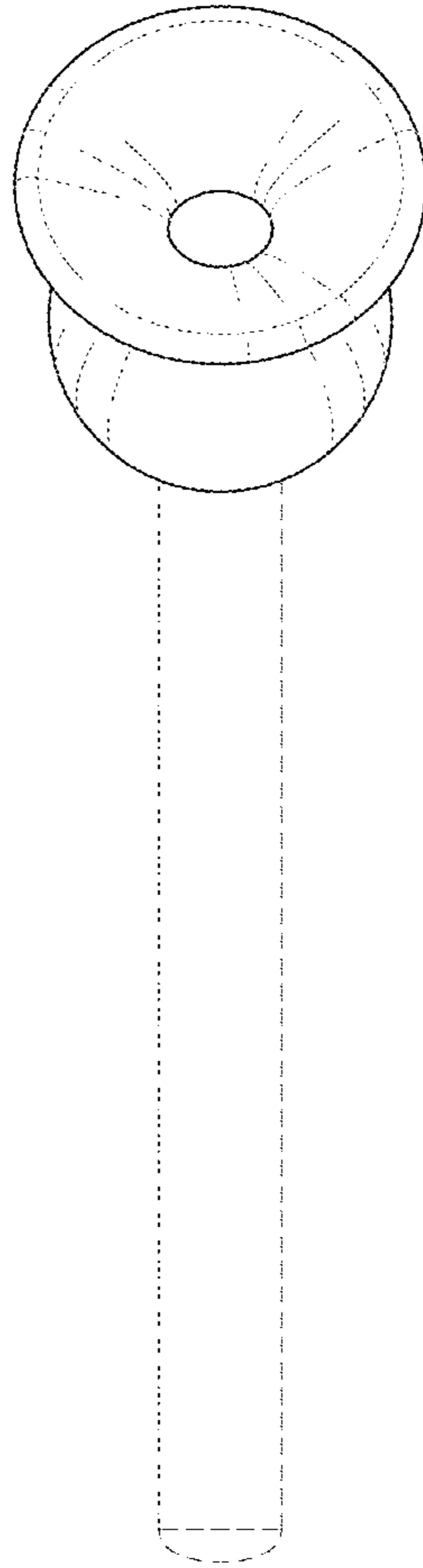

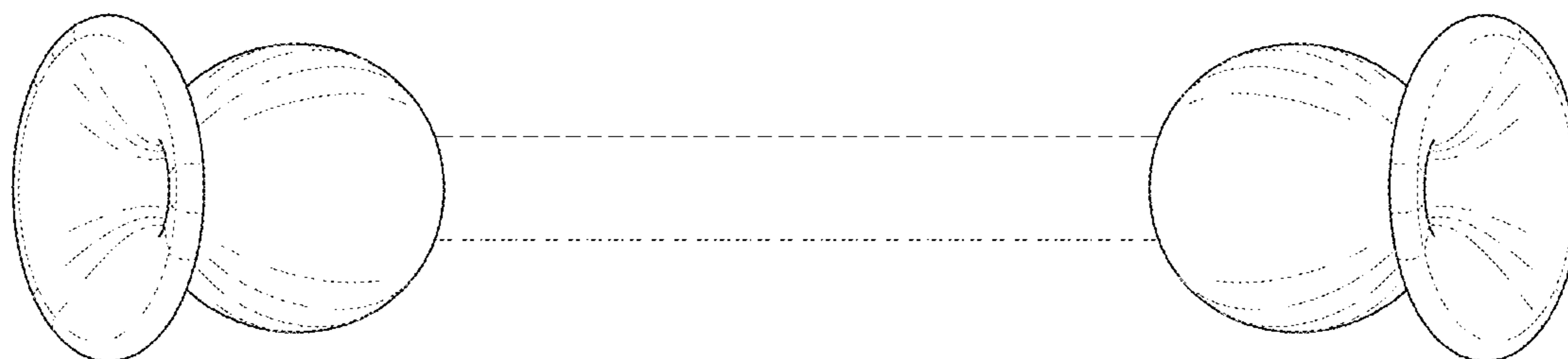

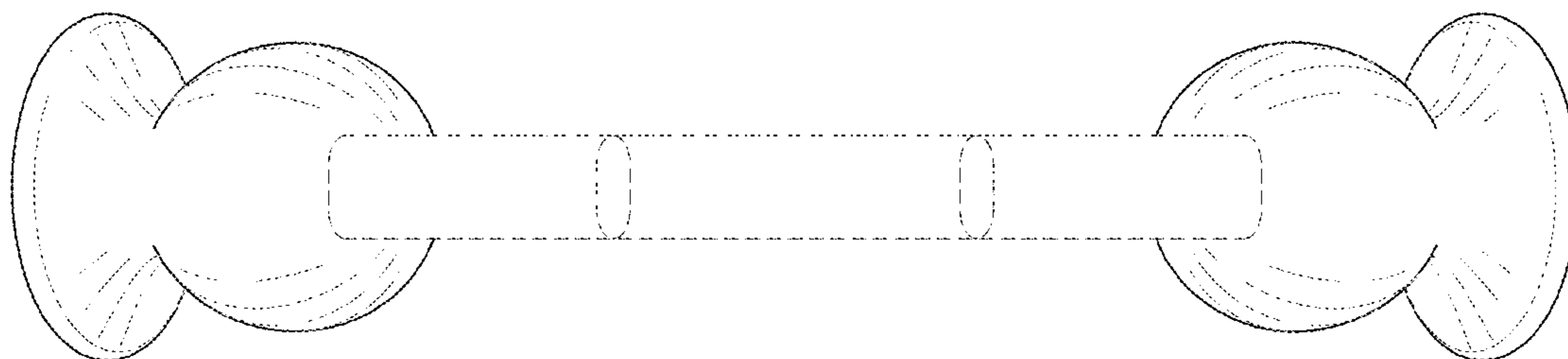
