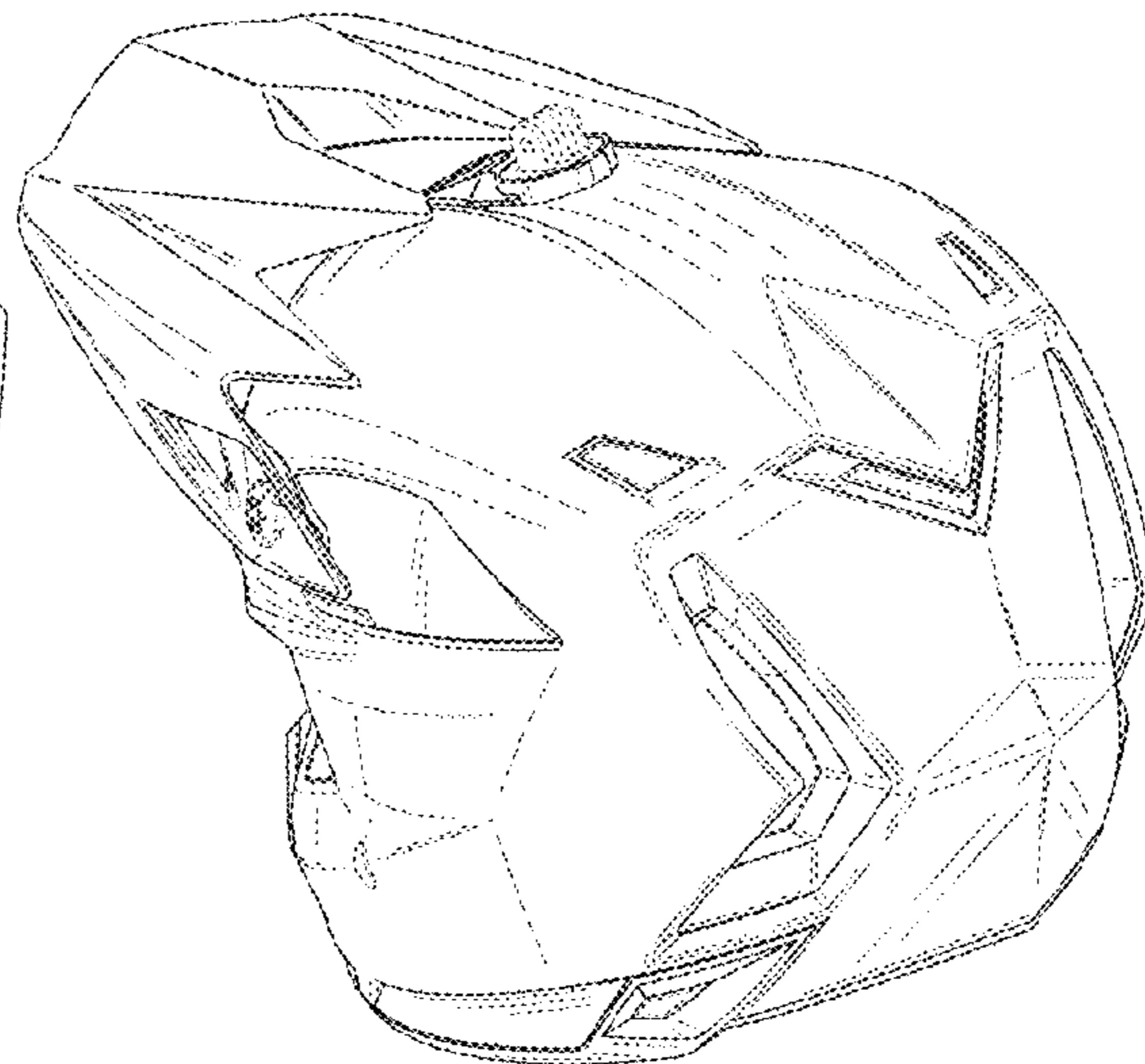
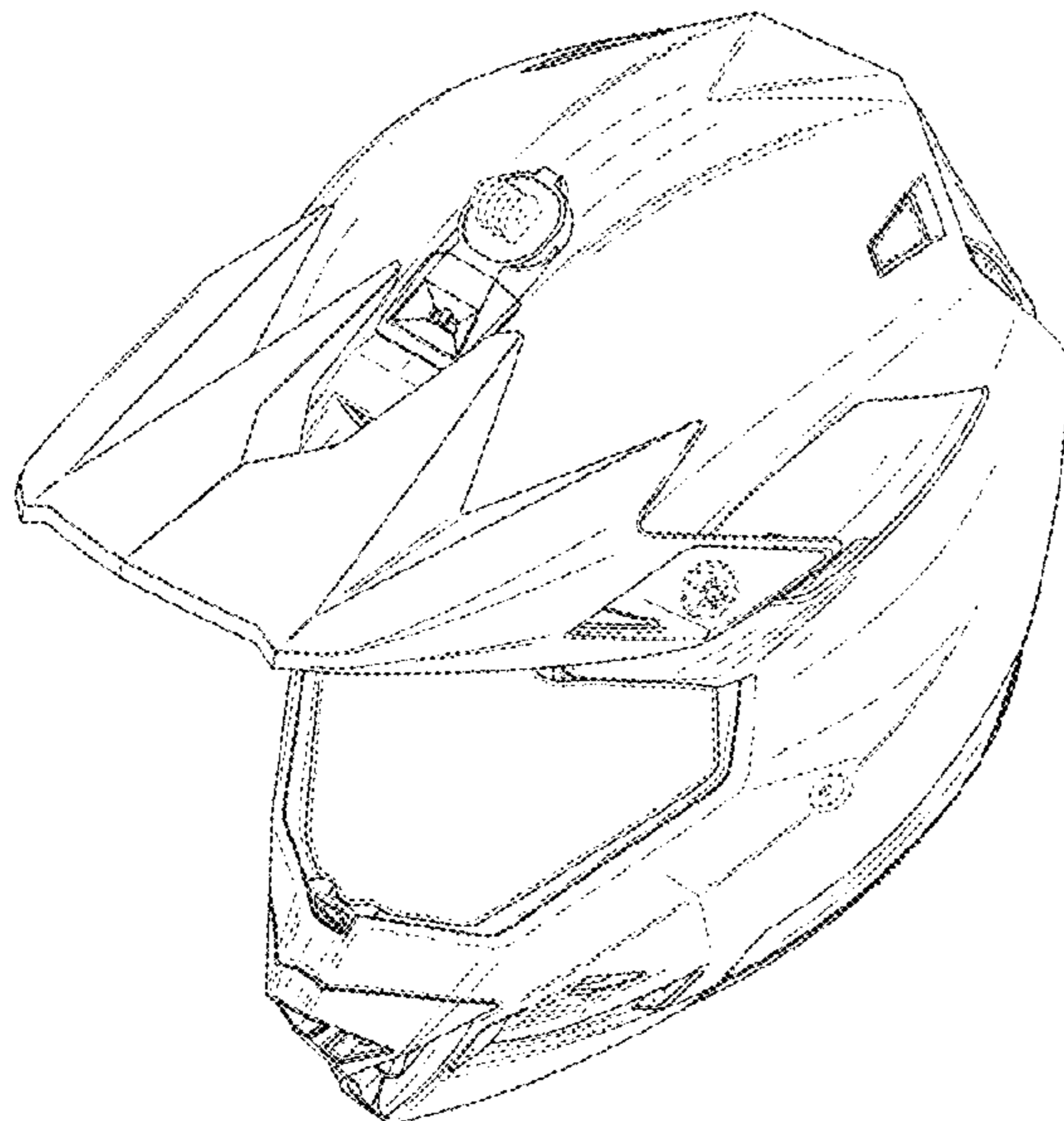
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top front right isometric view of a helmet showing our new design;

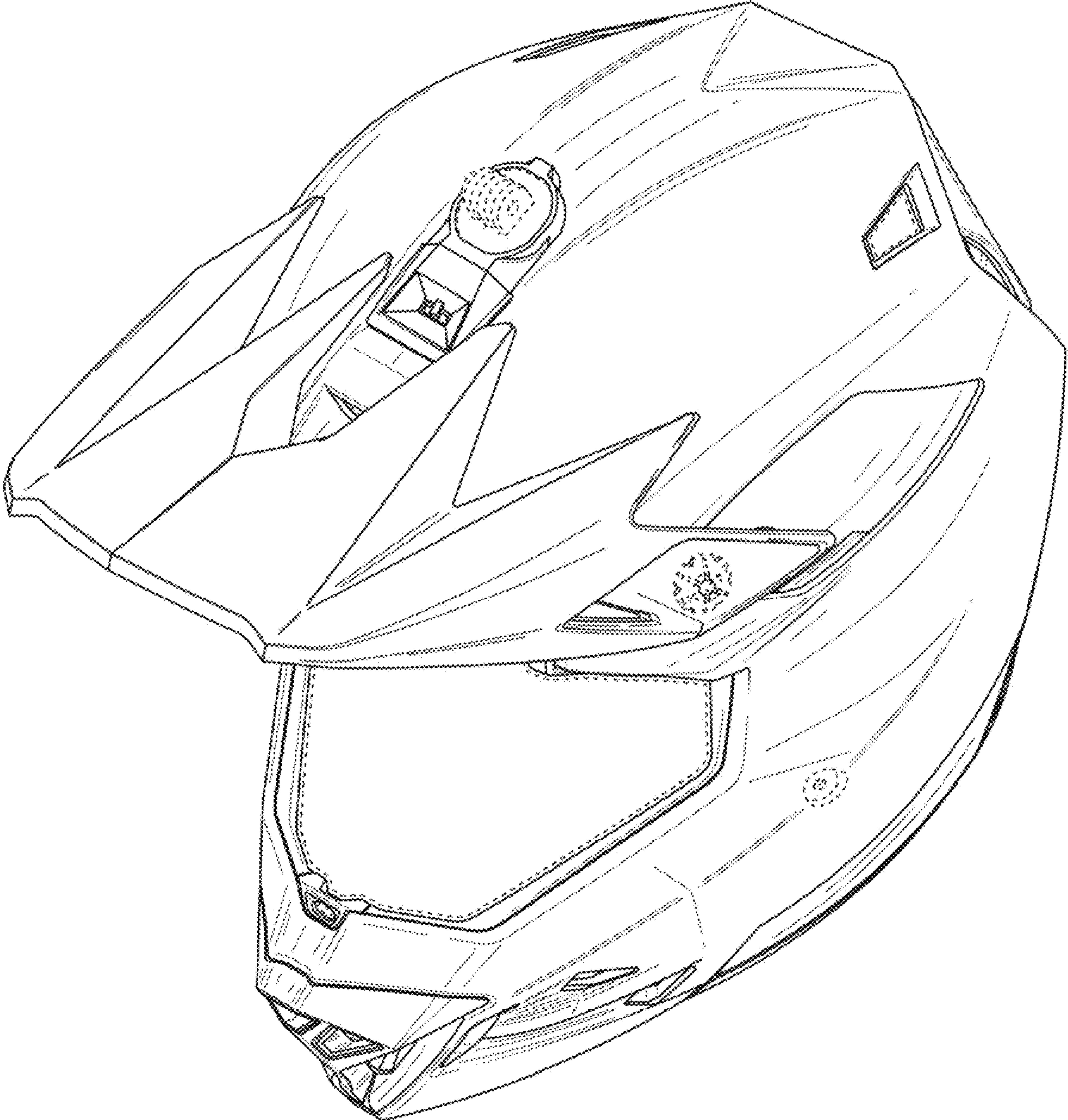

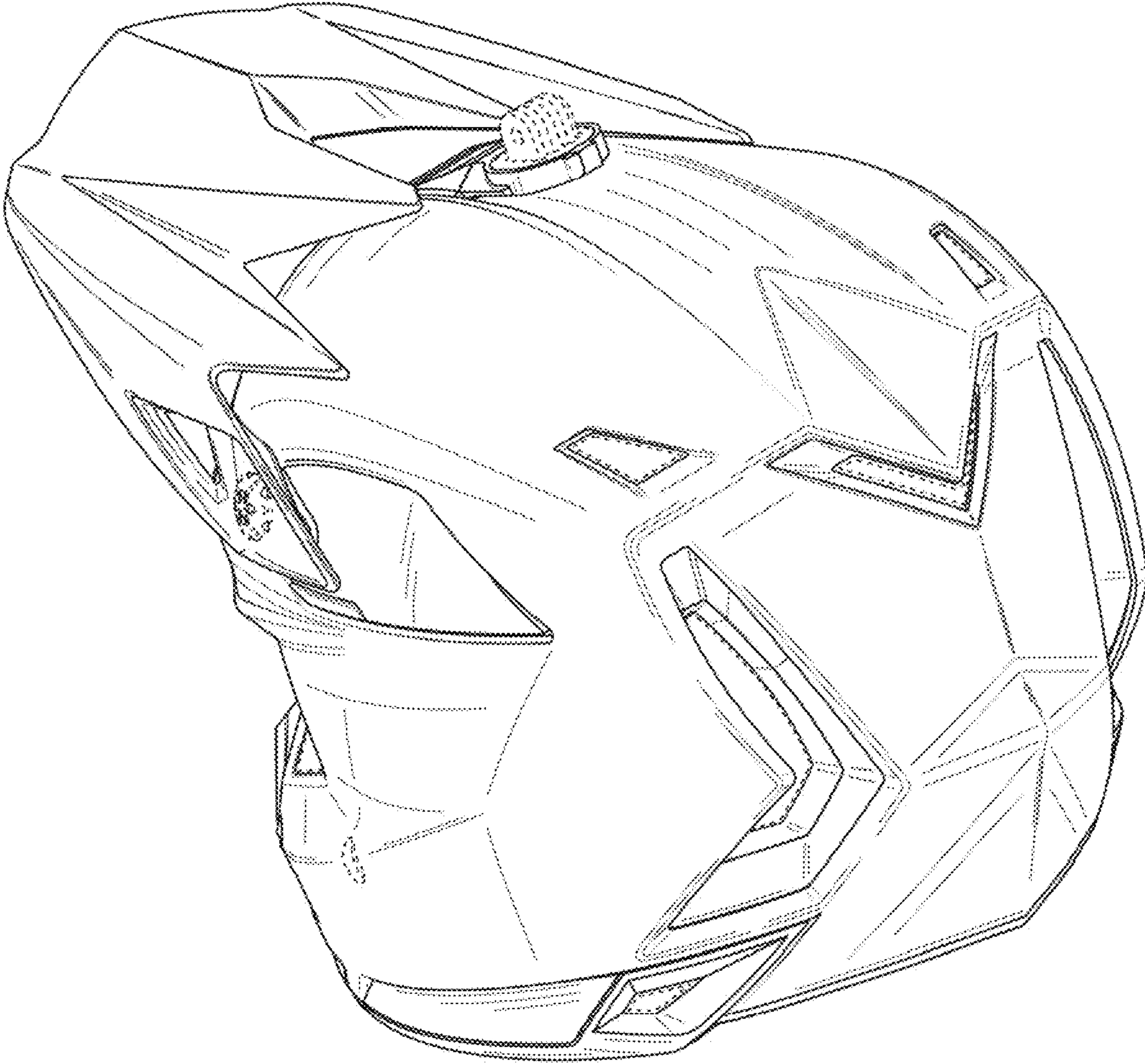

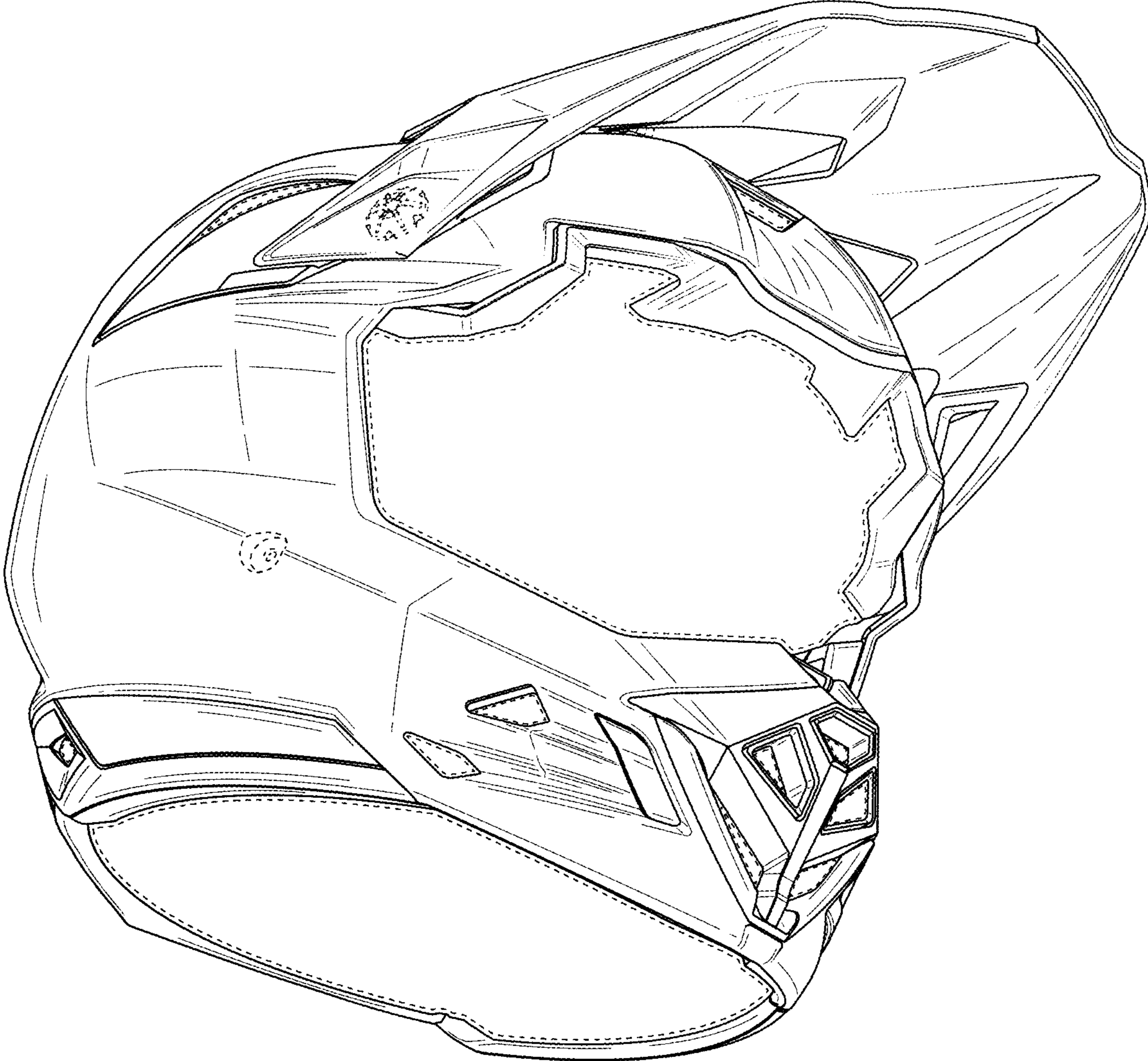

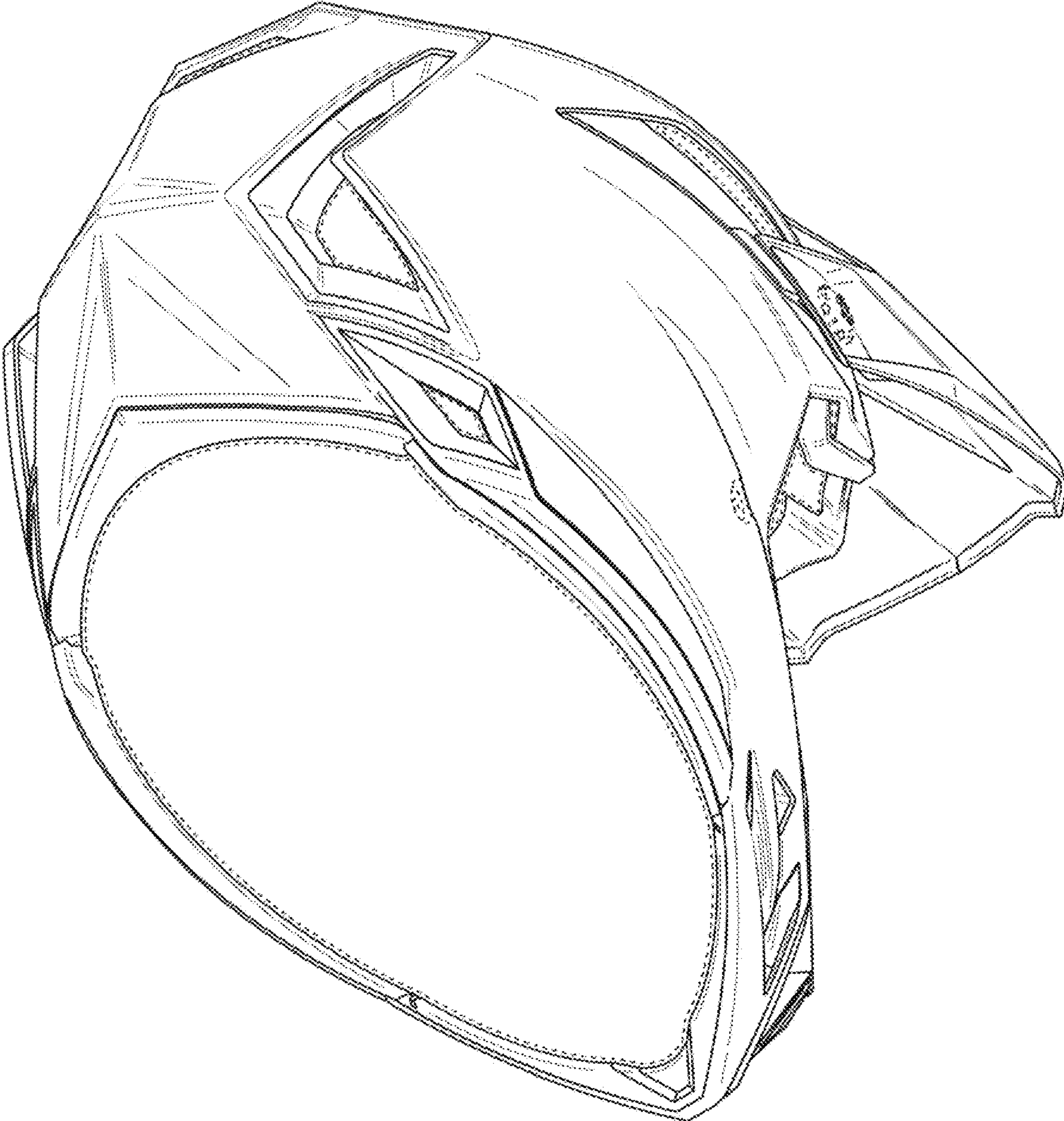

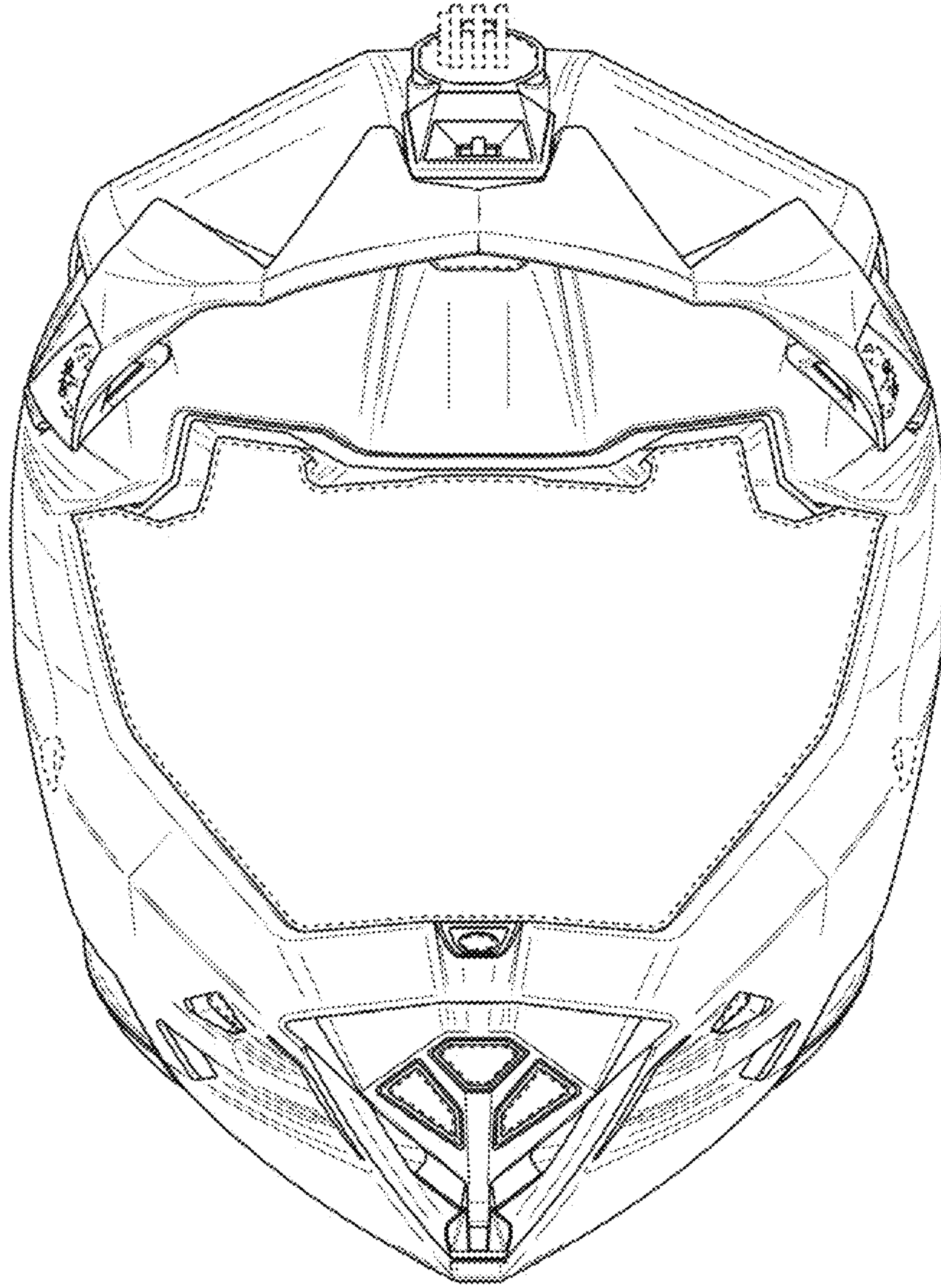

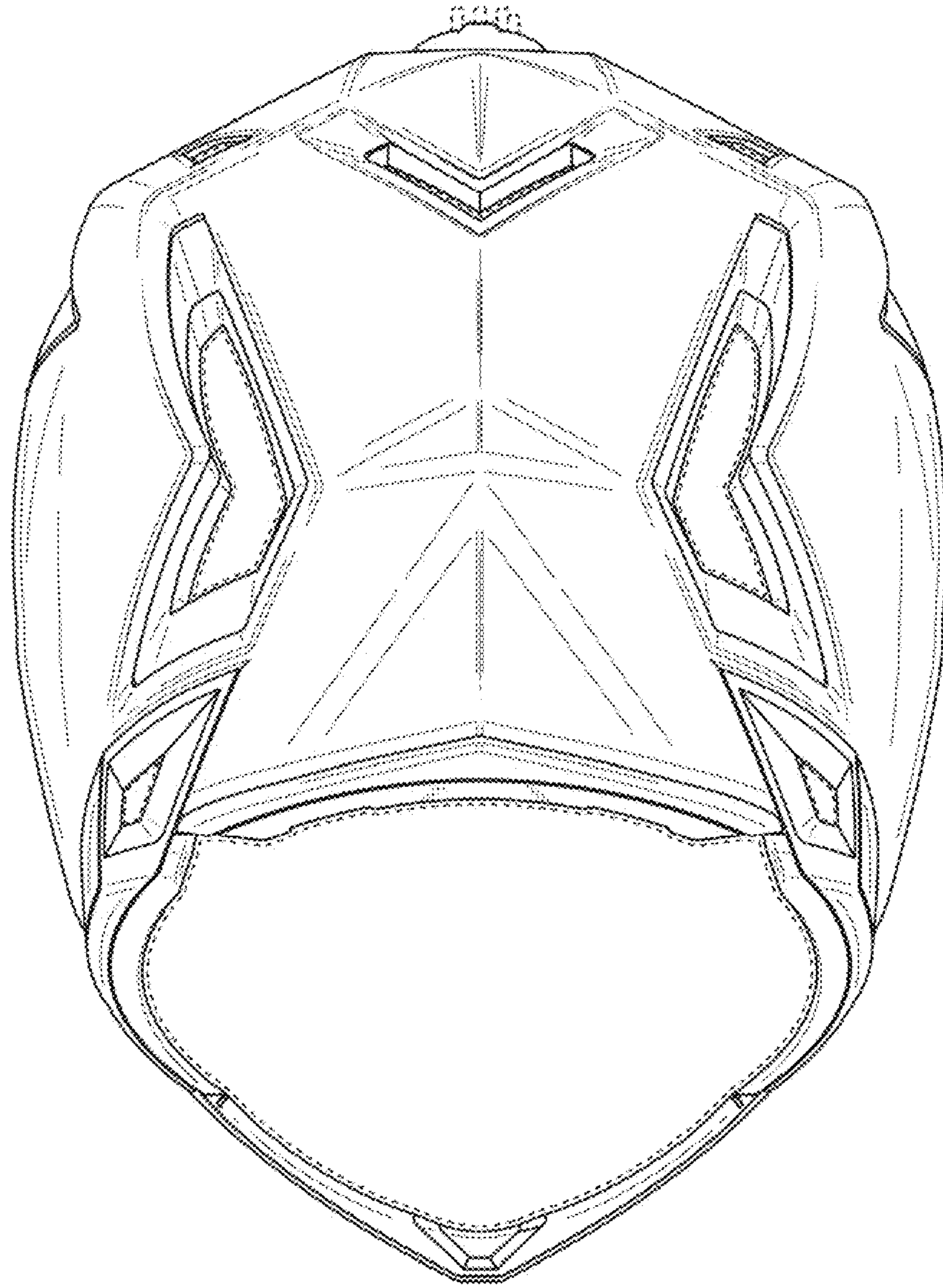

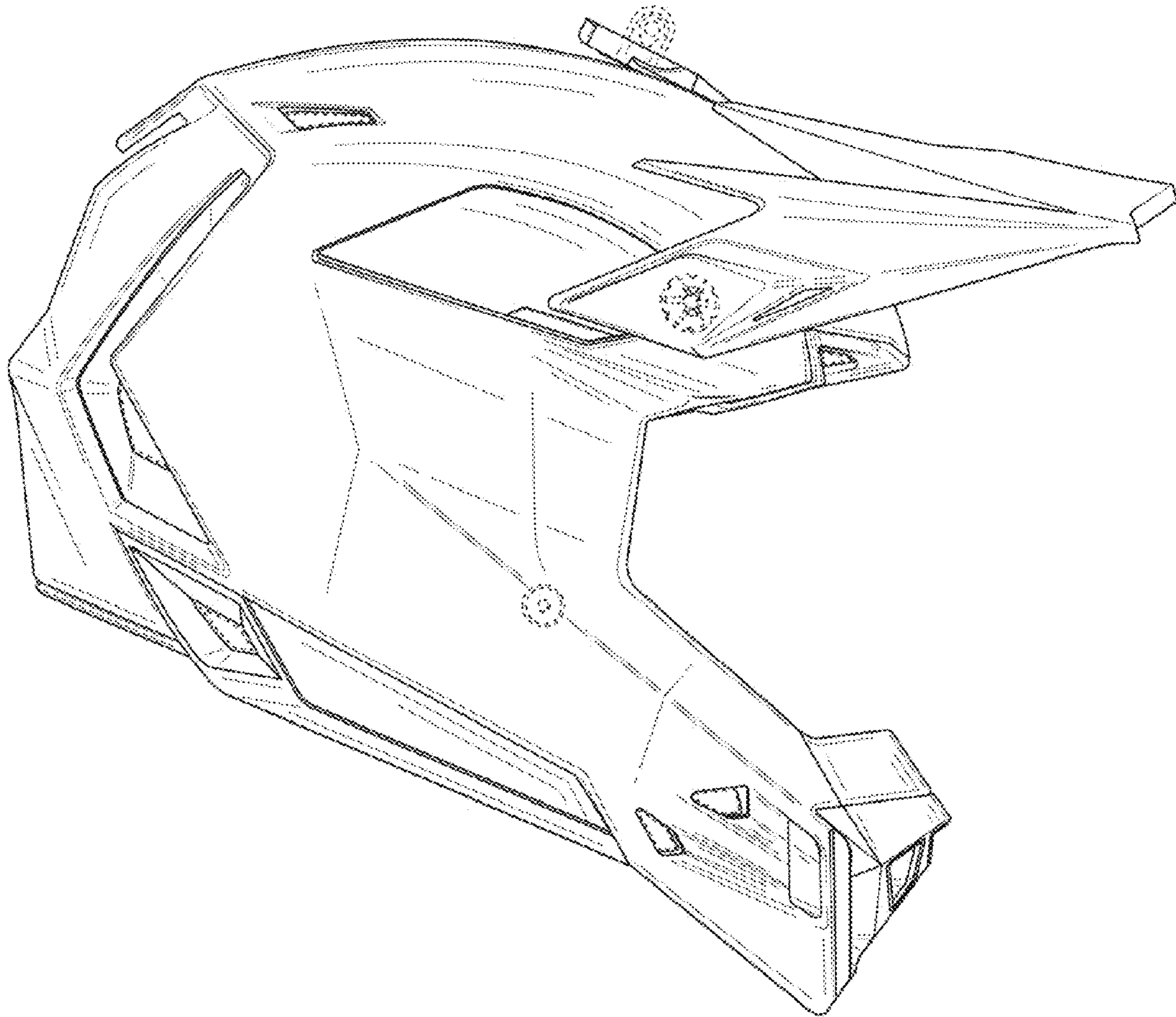

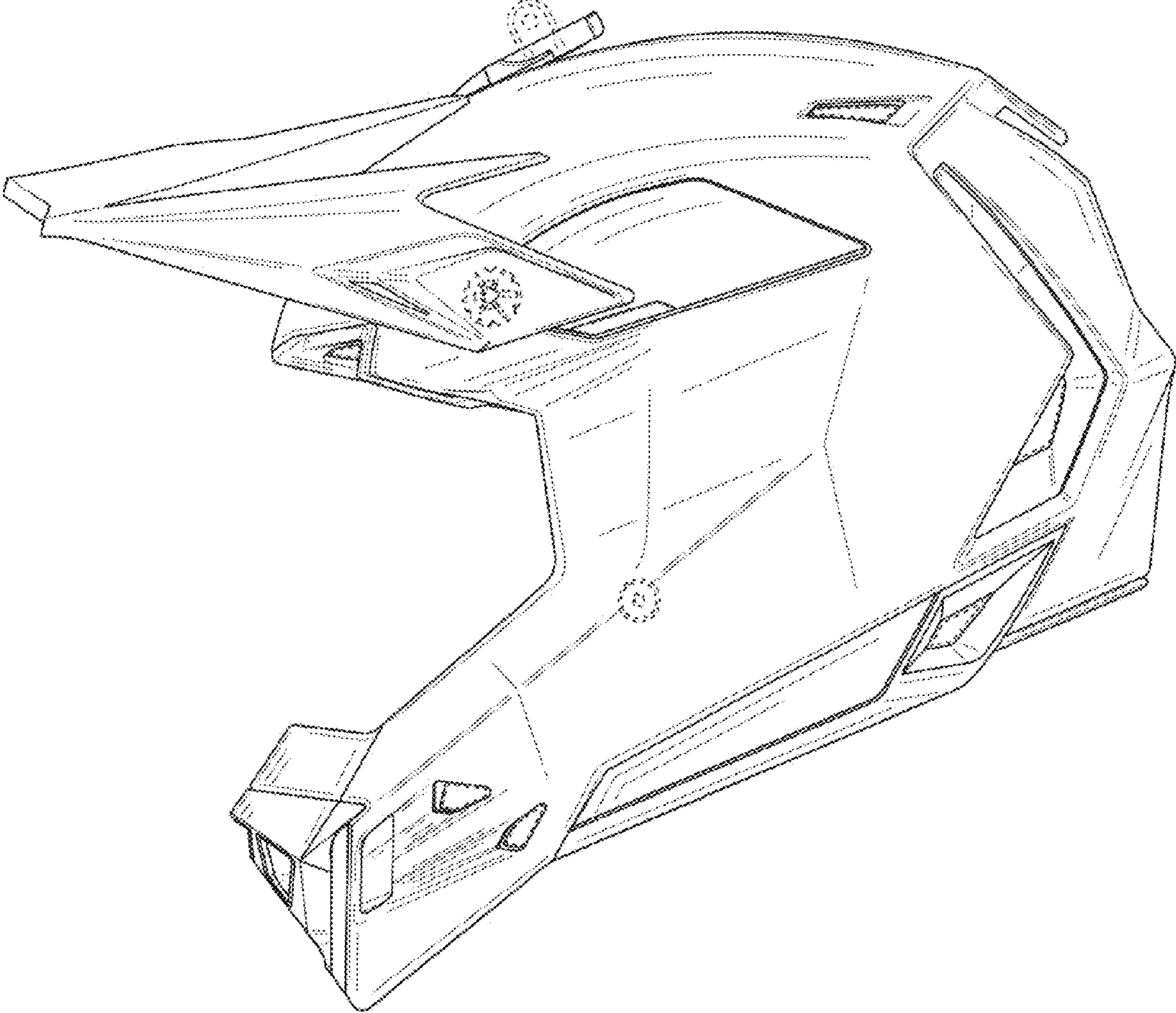

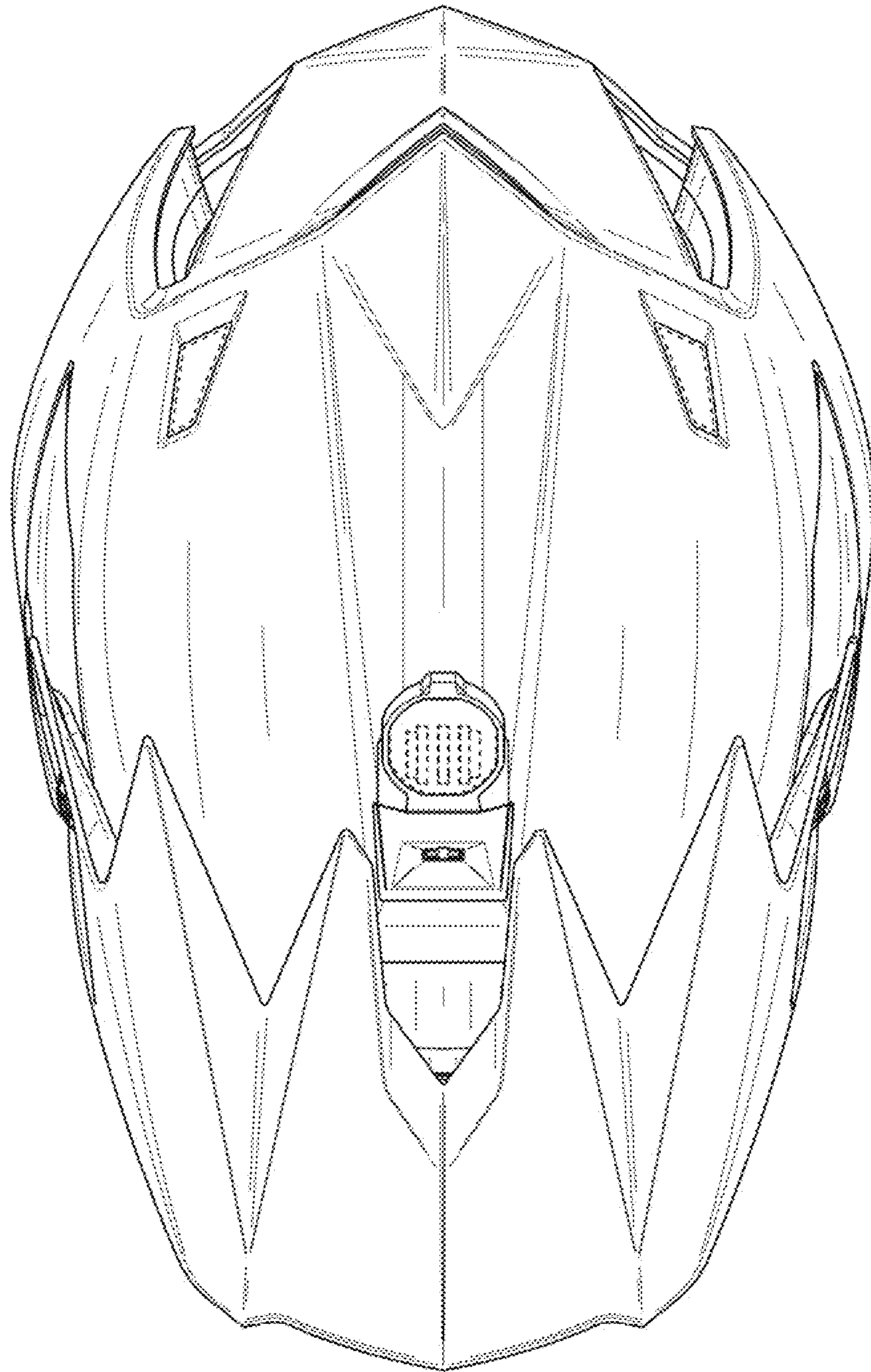

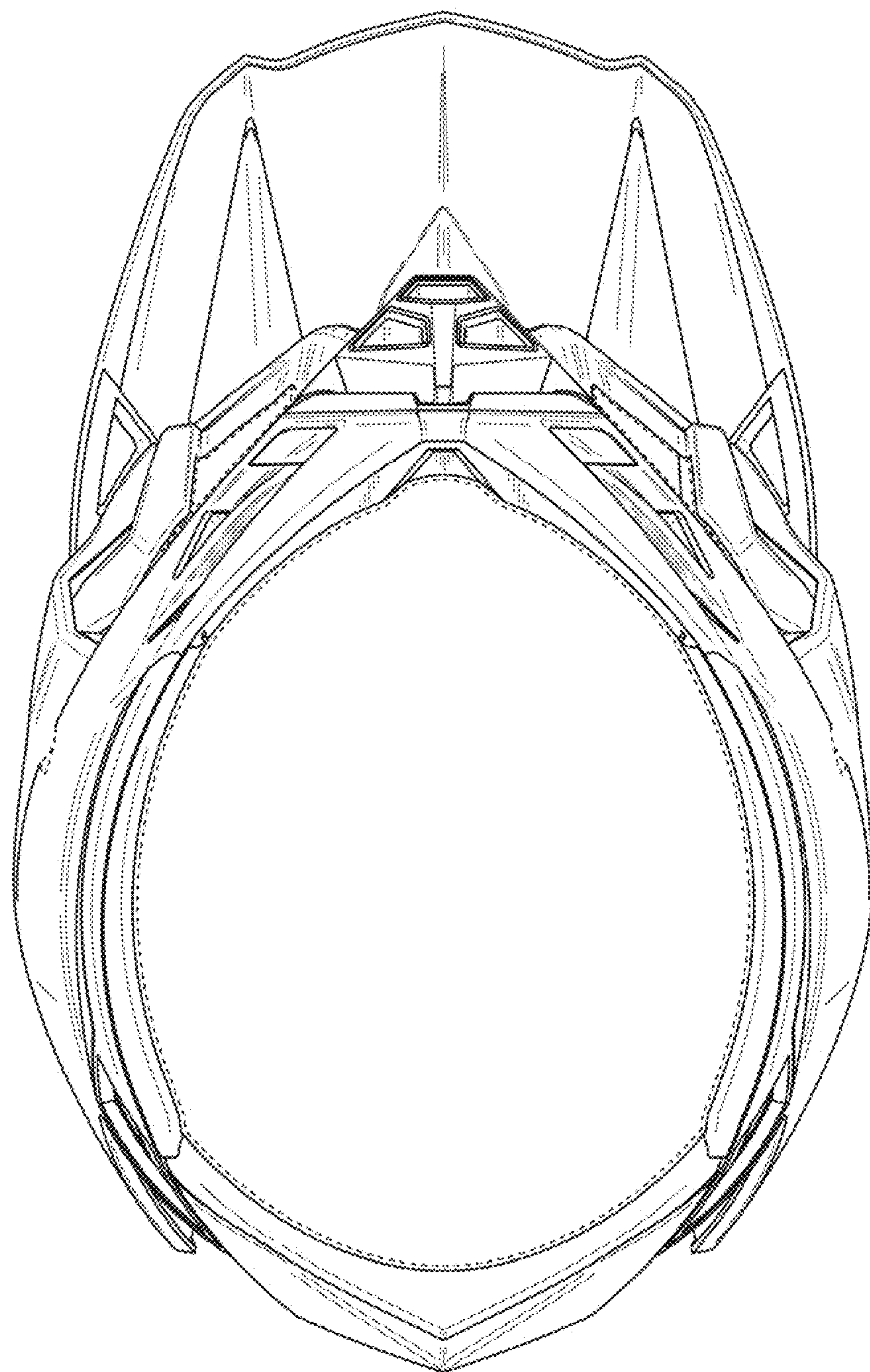
