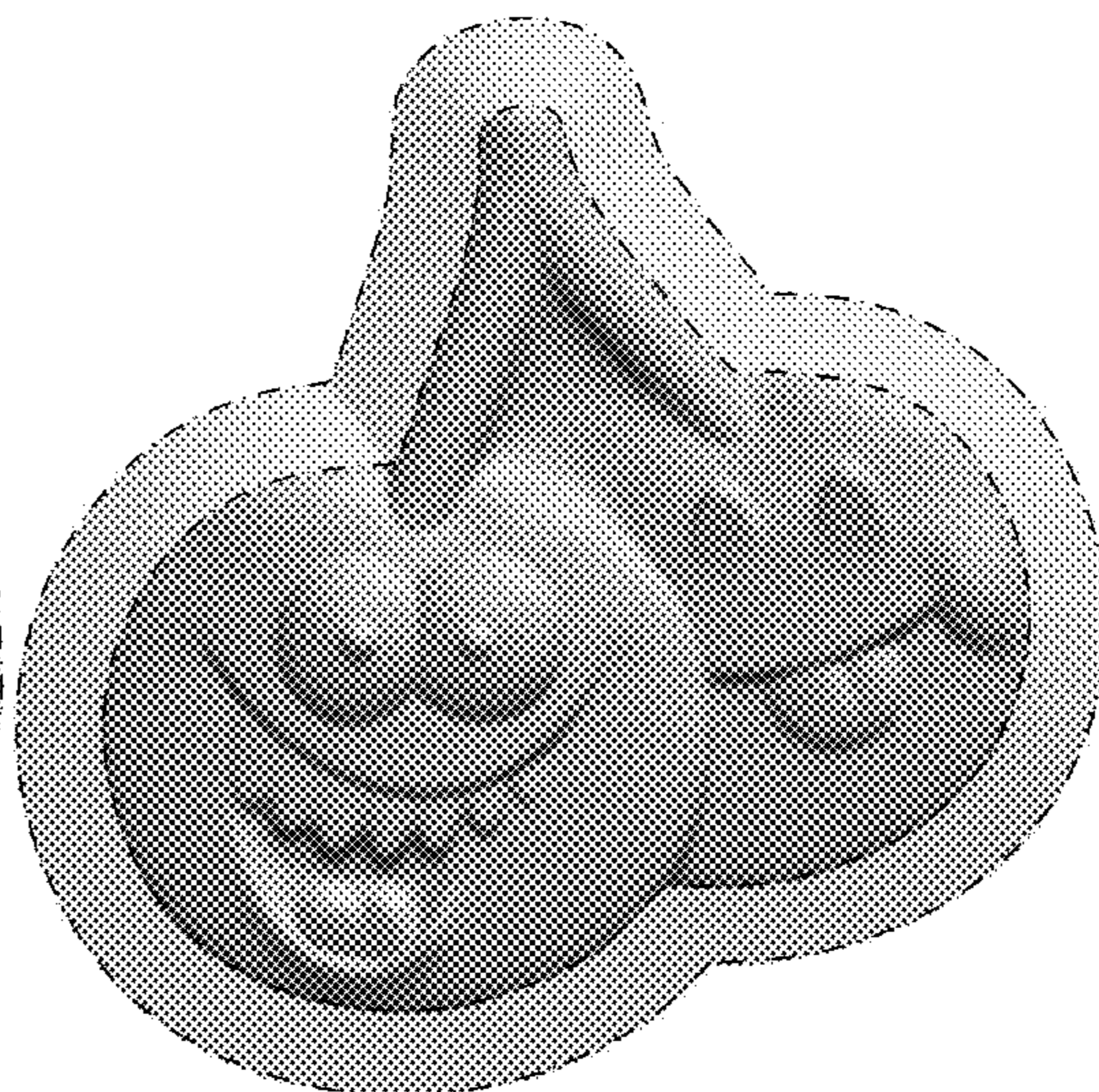
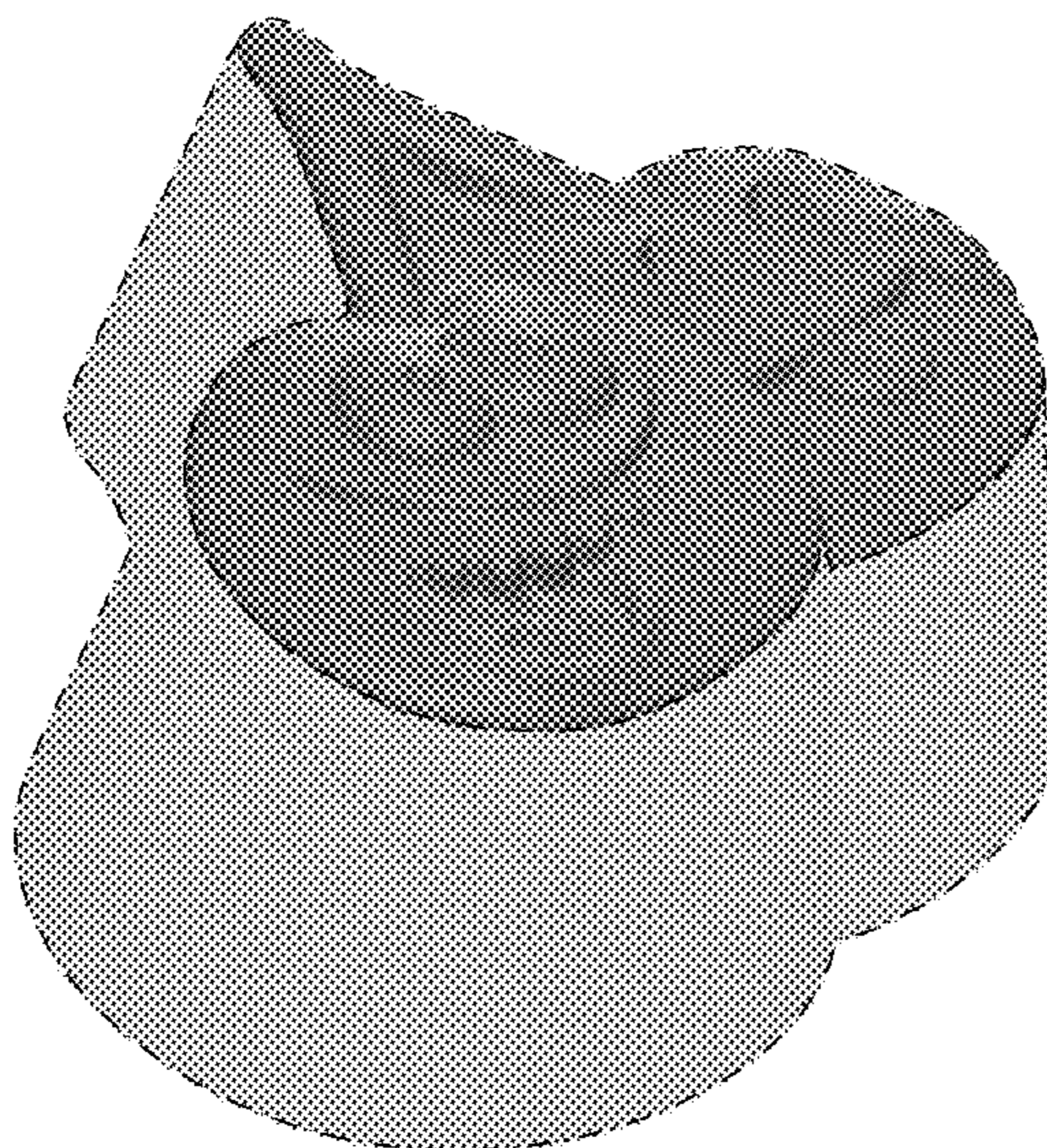
The ornamental design for a confection, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom and left side perspective view of a confection showing our new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a front elevation view thereof; and, FIG. 7 is a rear elevation view thereof.

The dash-dot lines in FIGS. 1-7 and the areas within the dash-dot lines shown in phantom show portions of the confection that form no part of the claimed design.

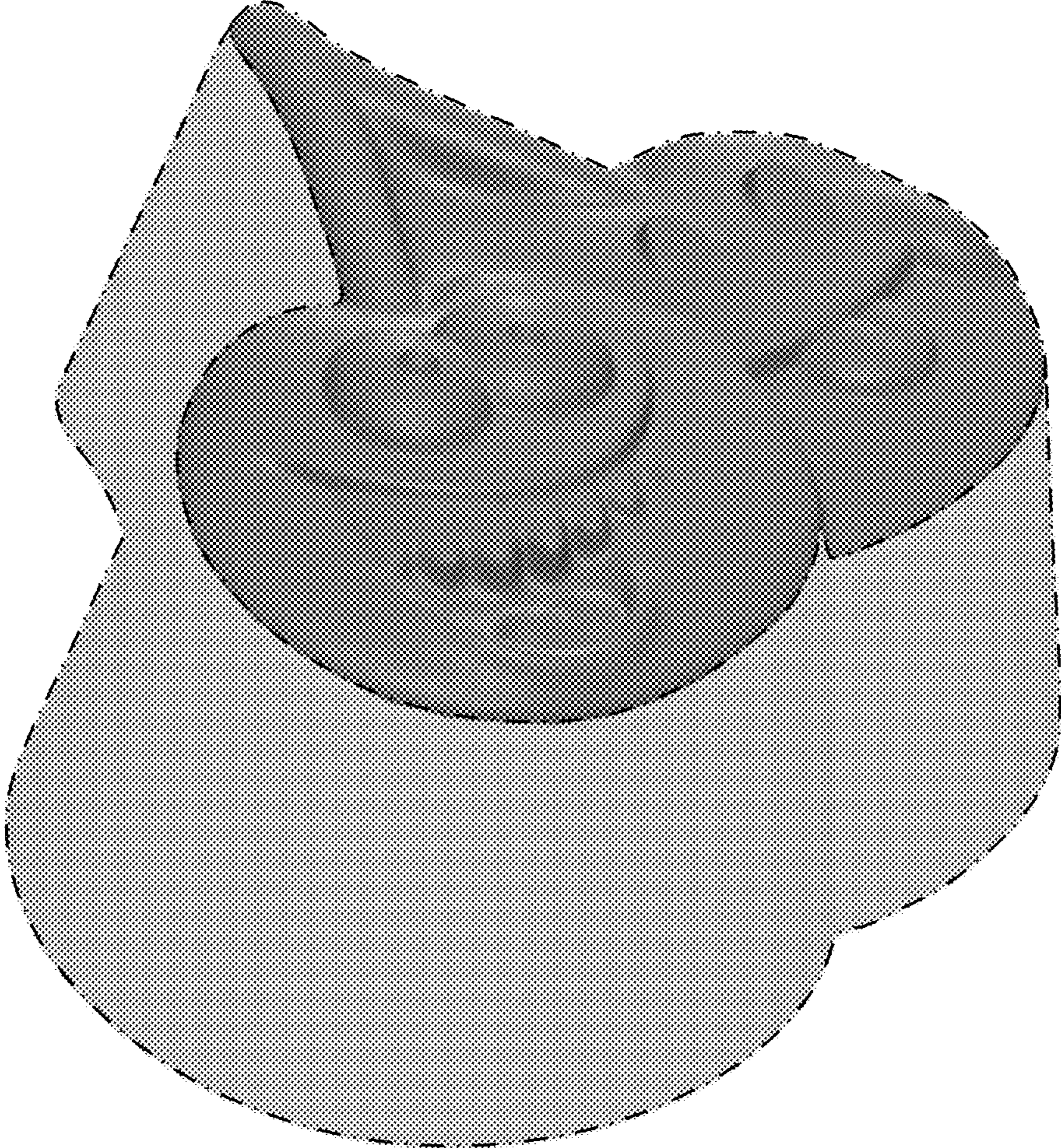

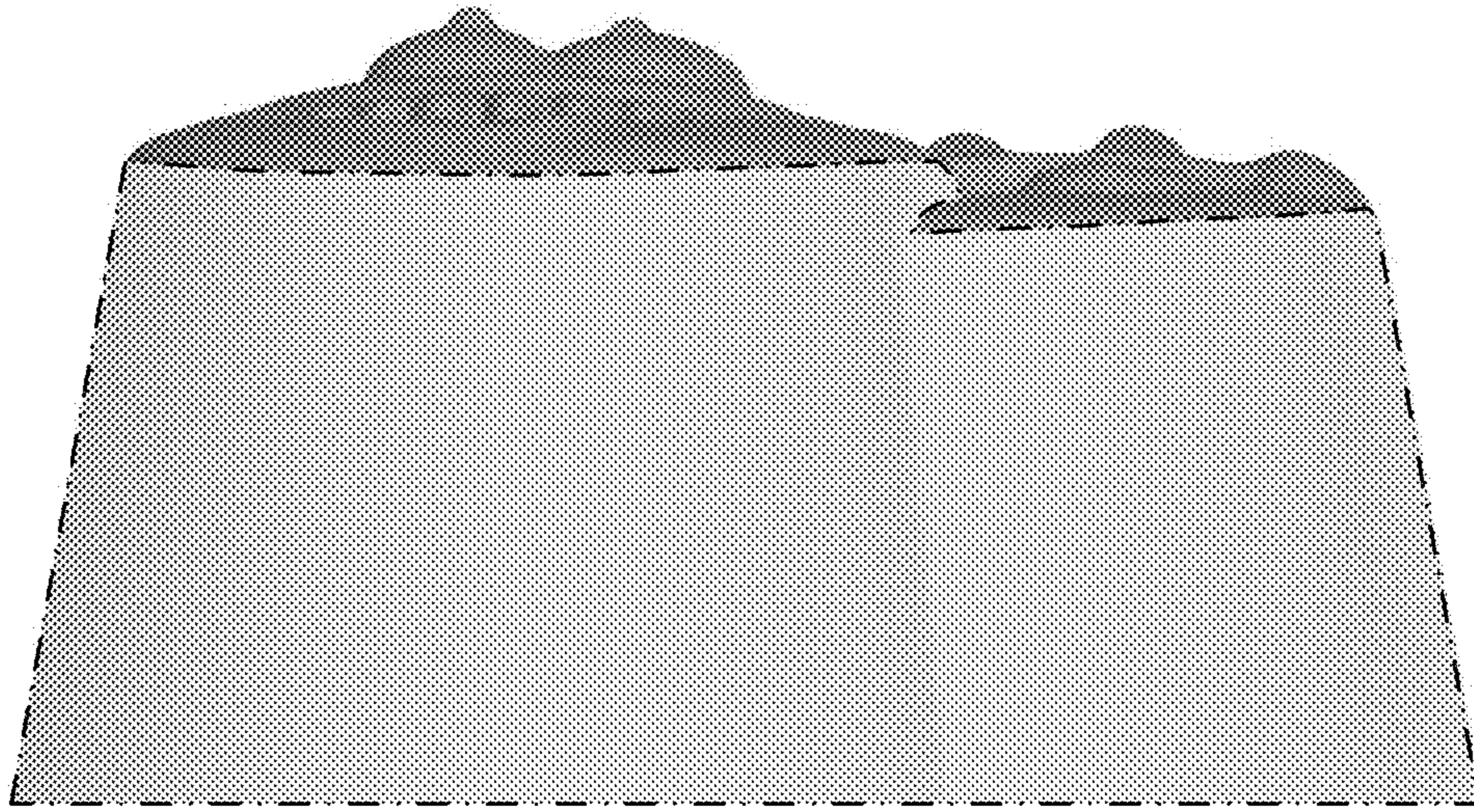

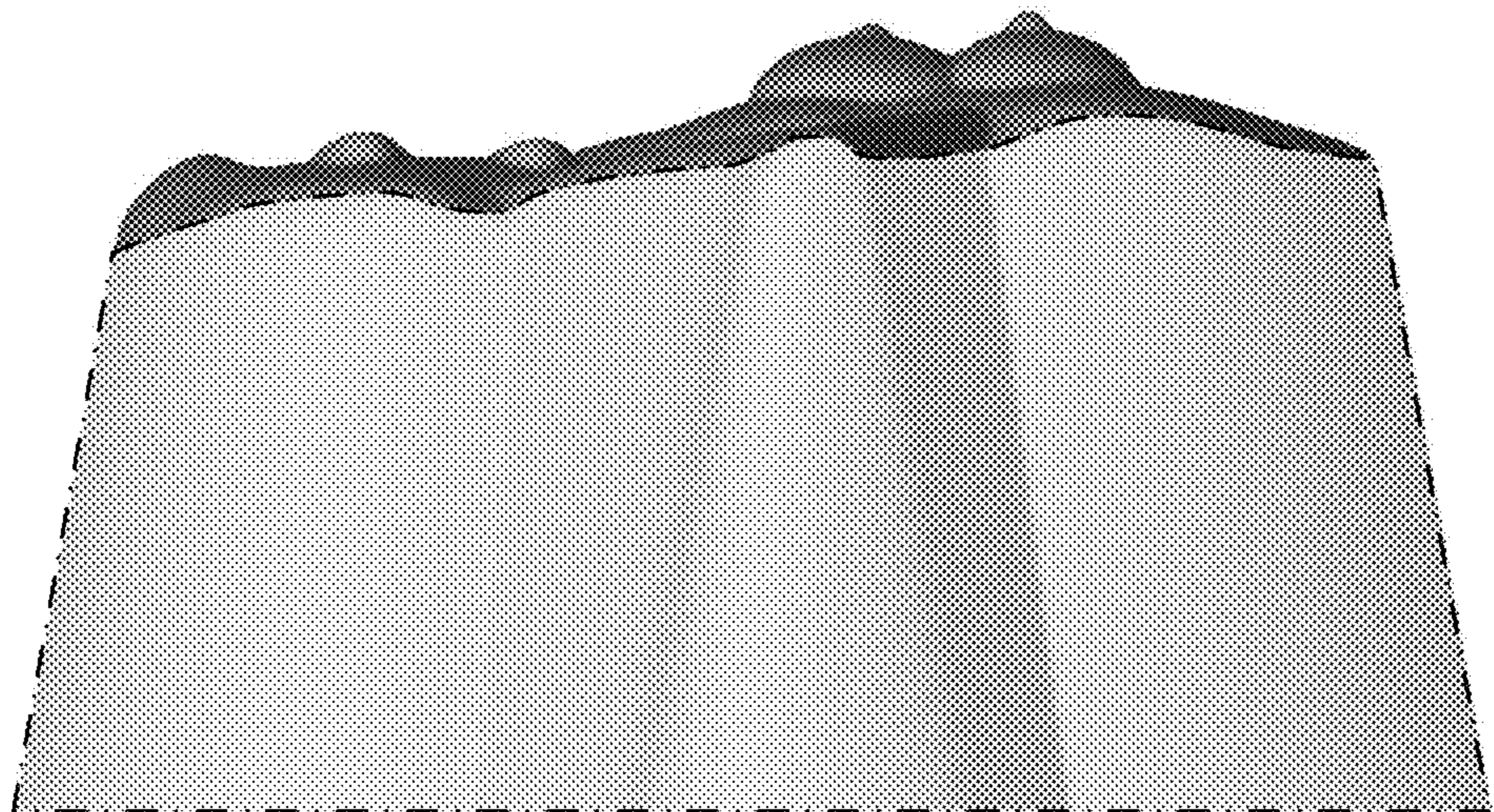

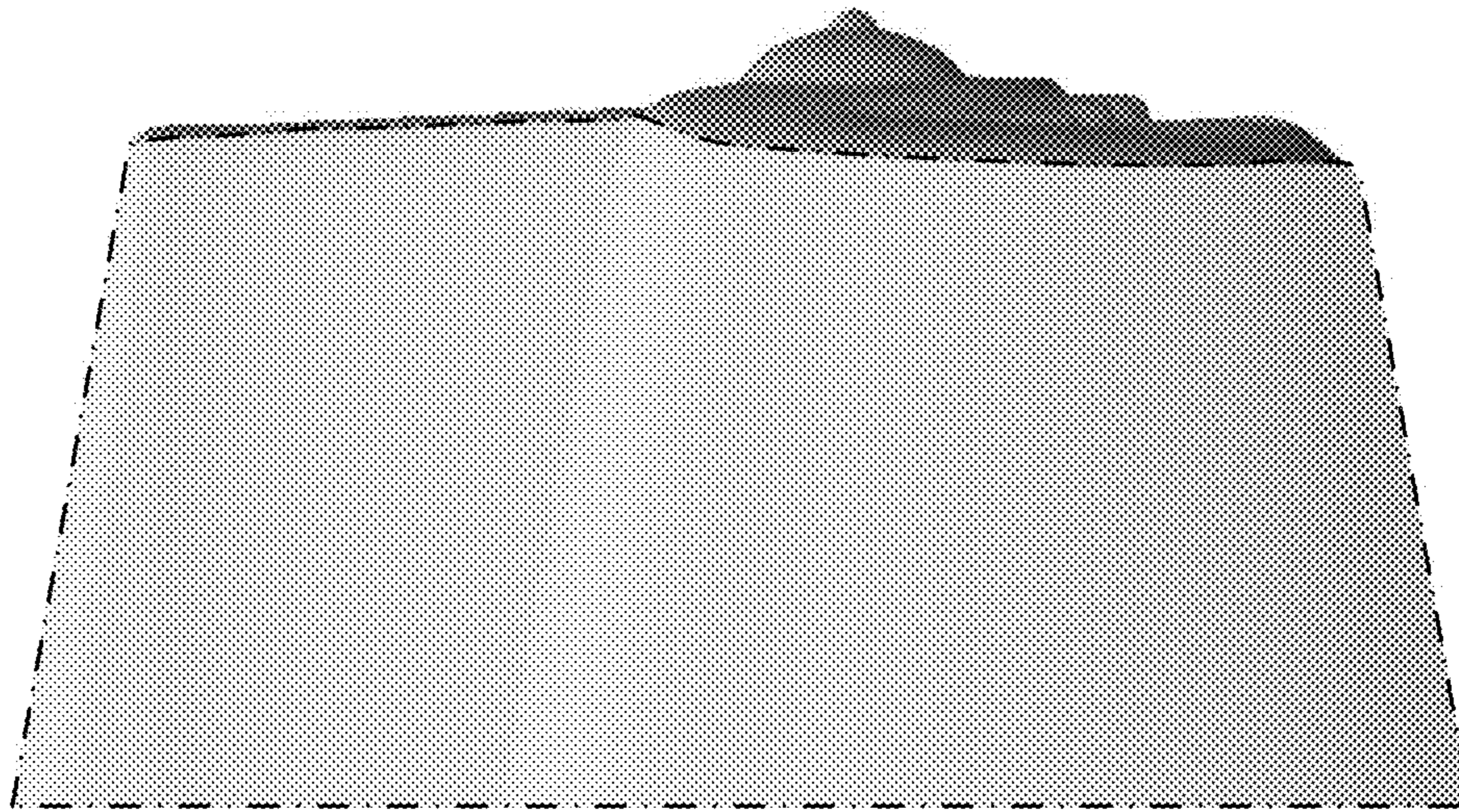

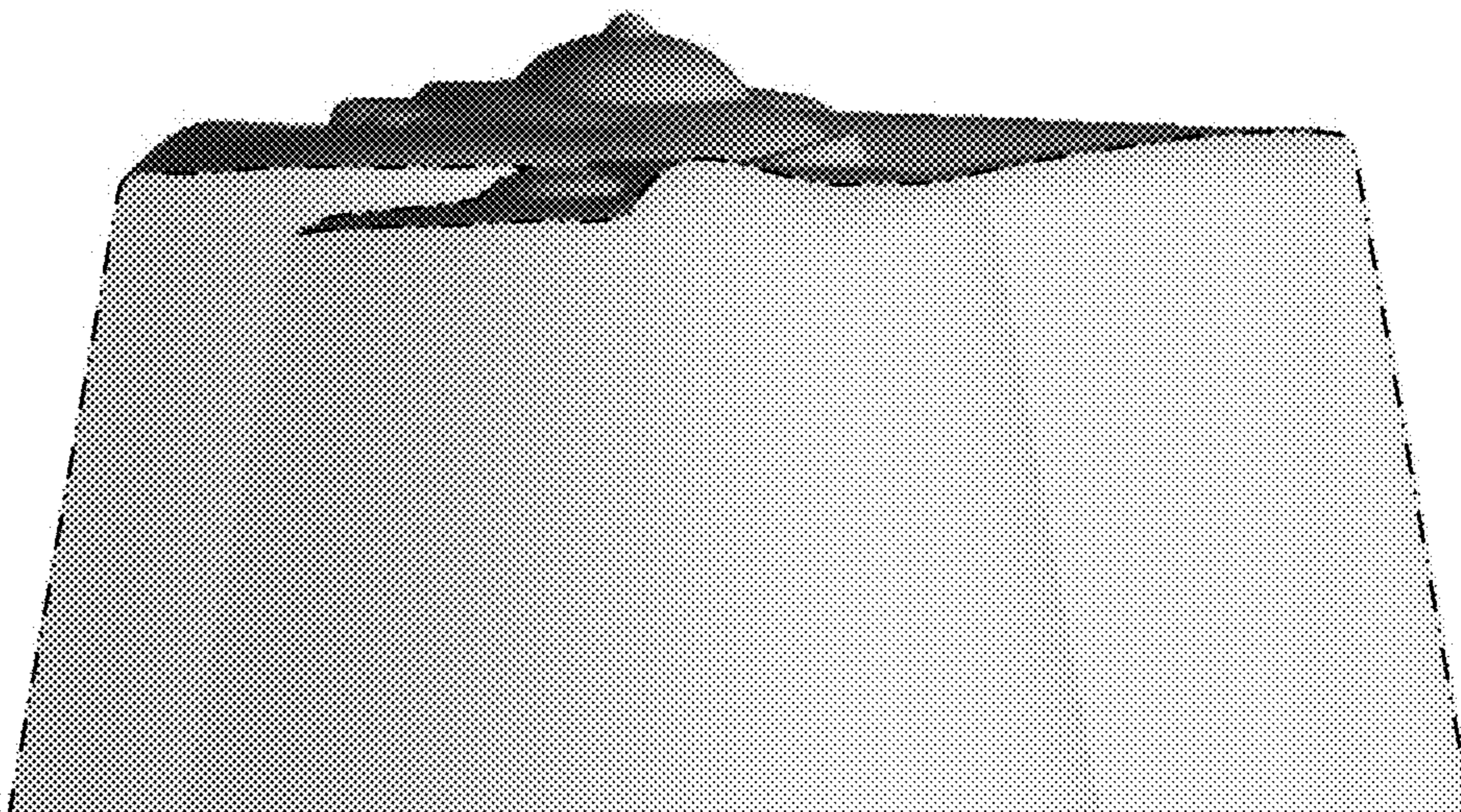

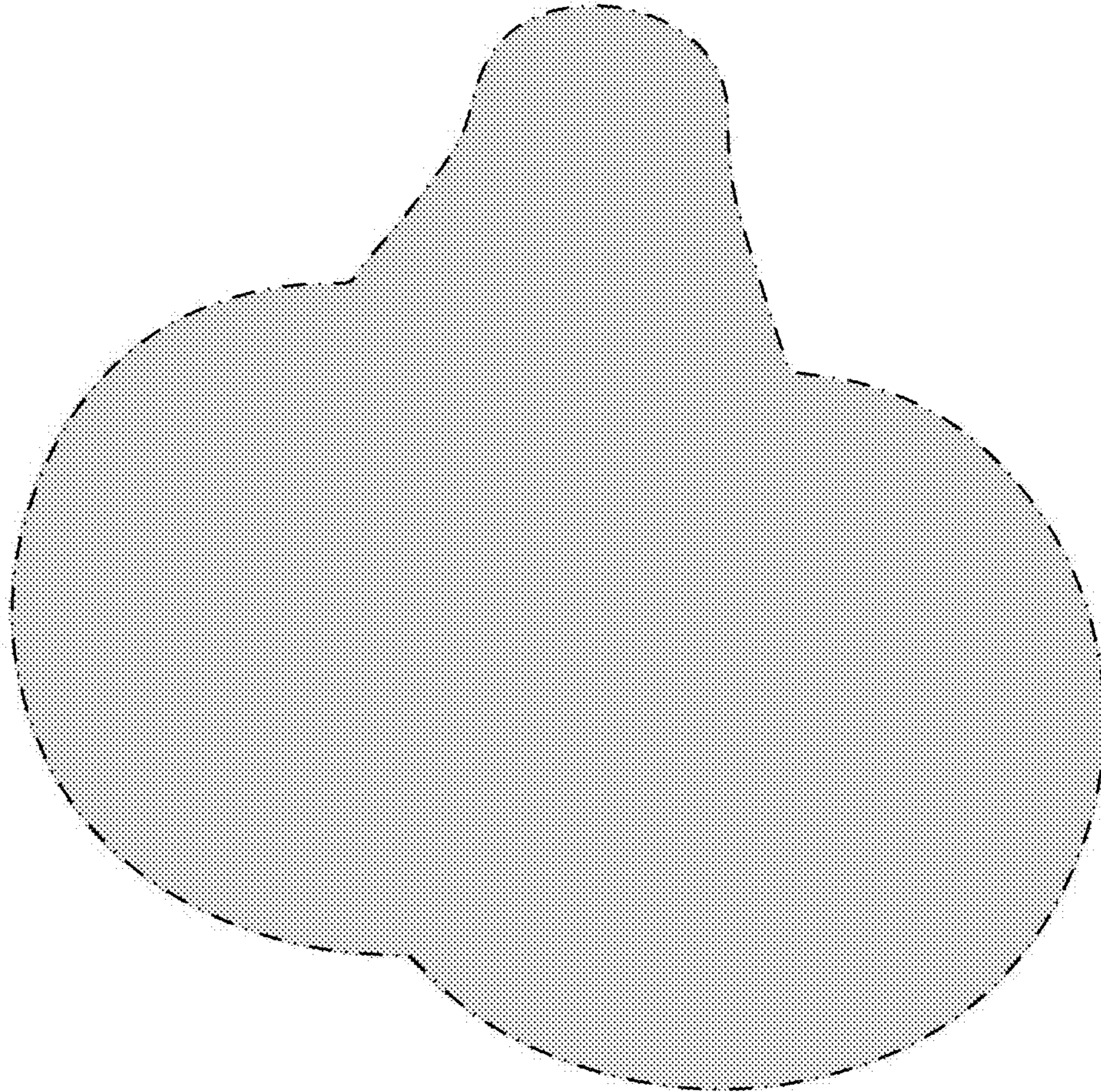
