DESCRIPTION

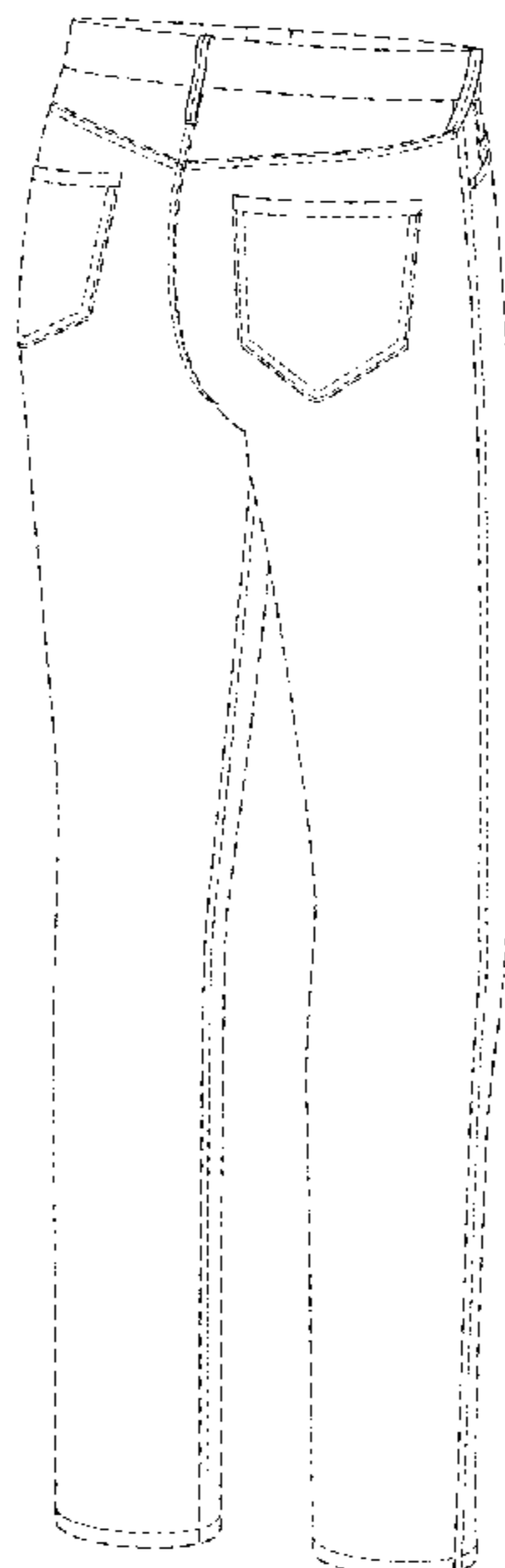
FIG. 1 is a rear perspective view of pants showing a first embodiment of my new design;

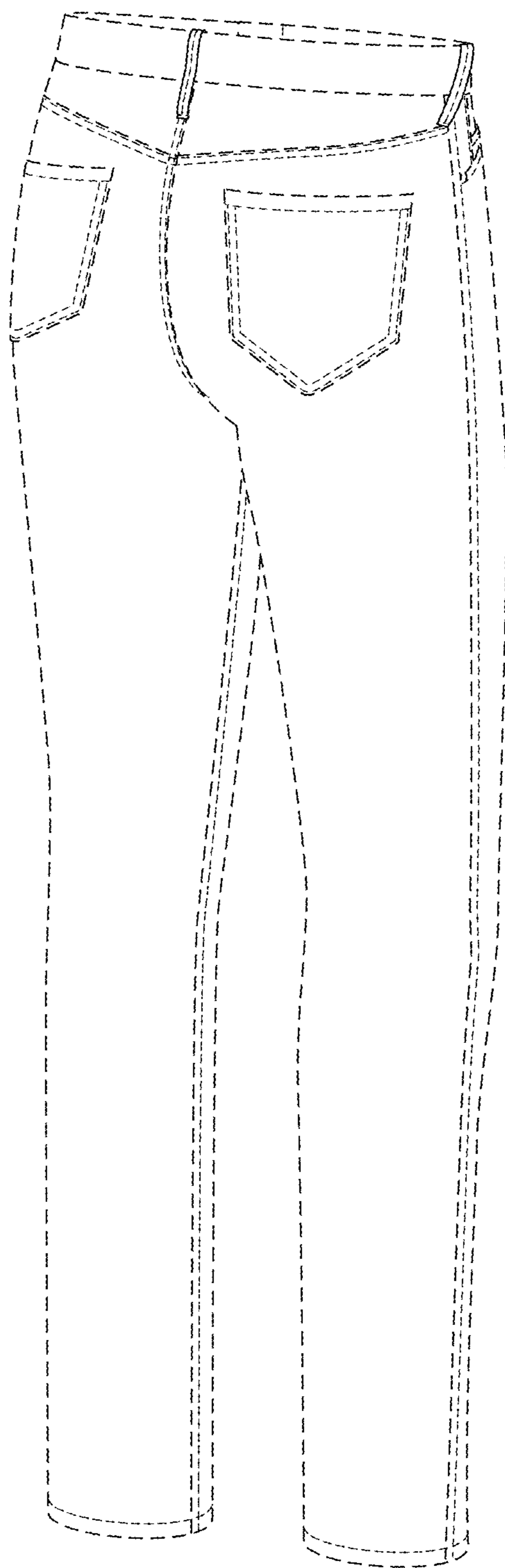

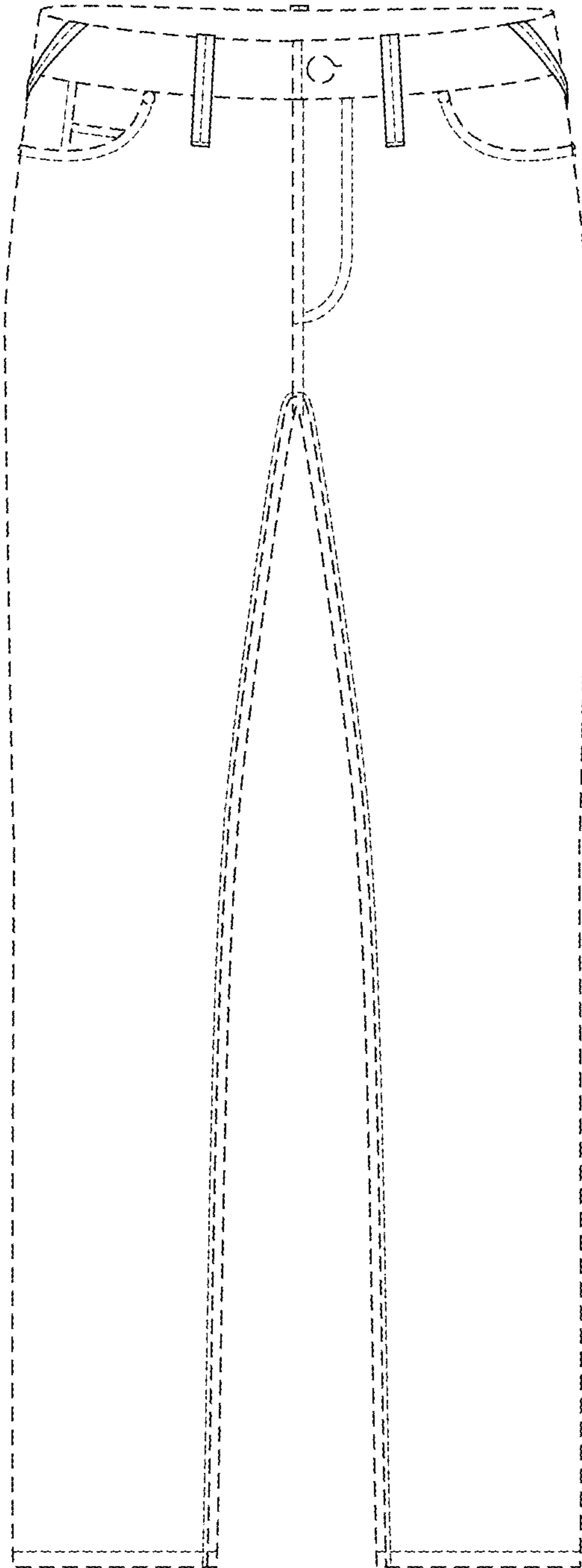

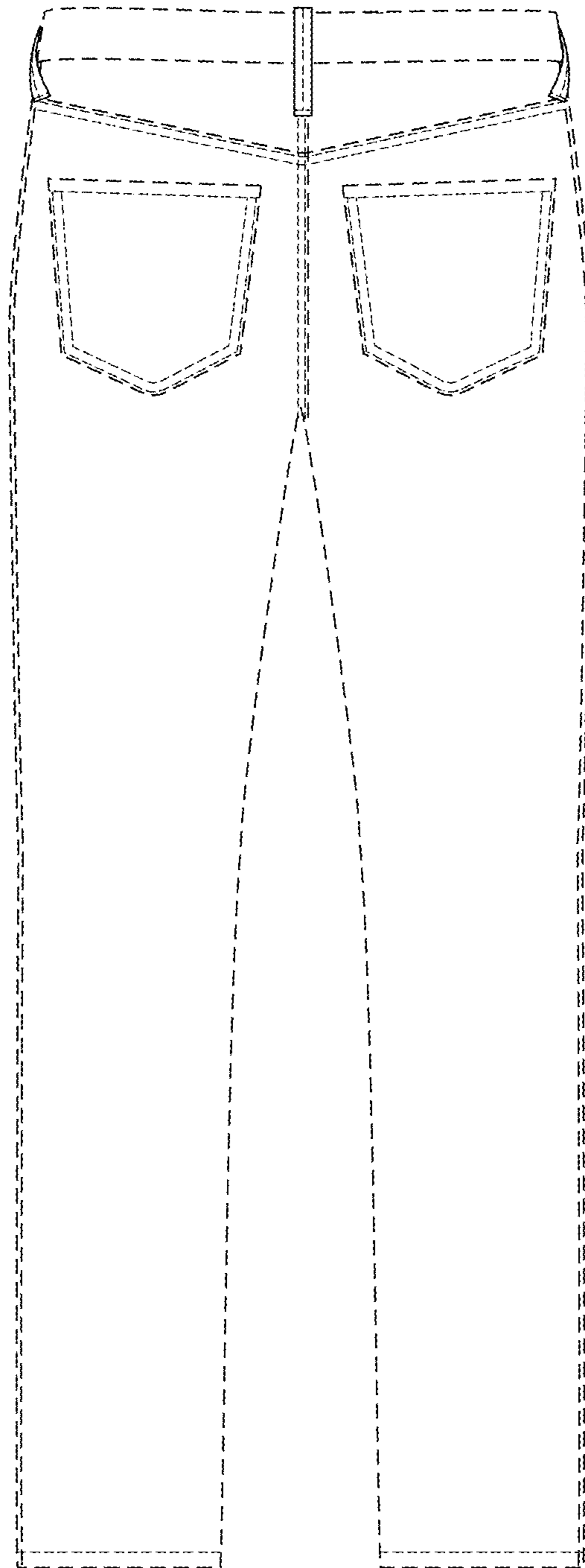

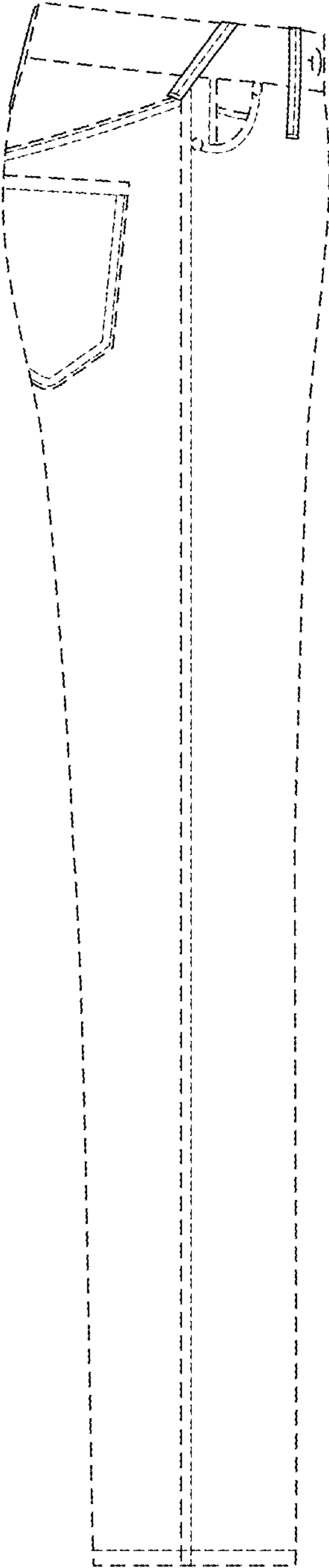

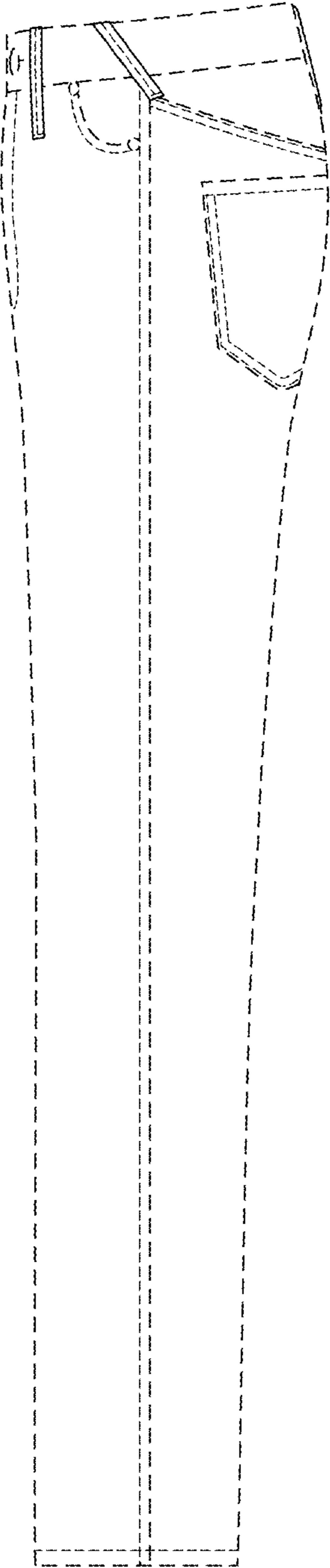

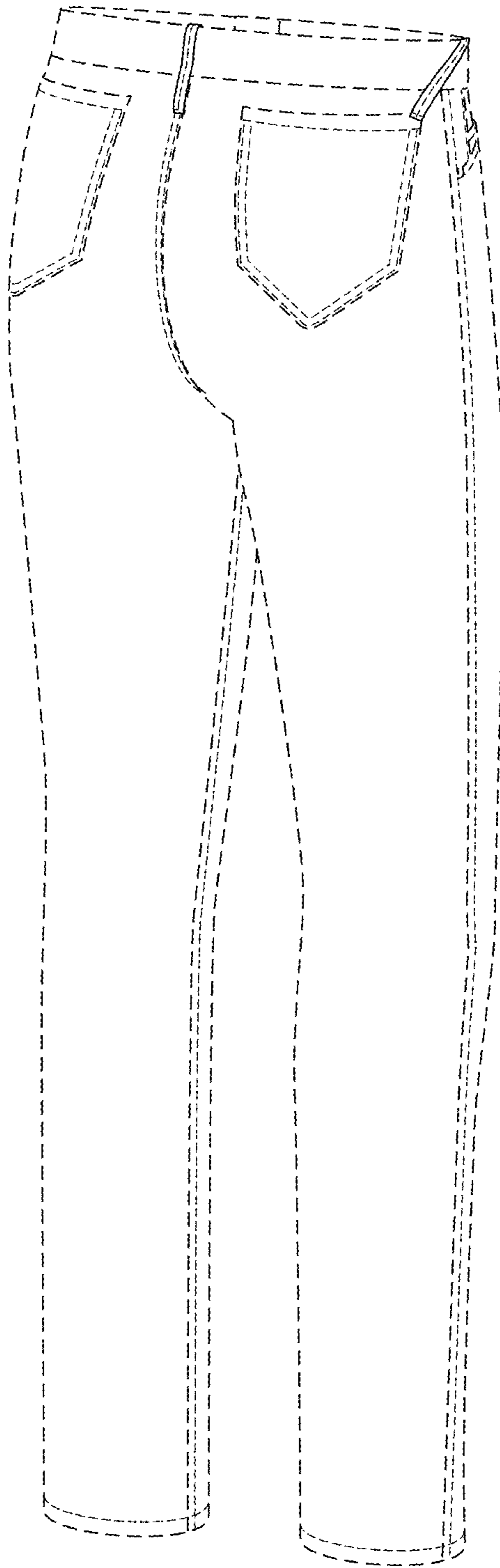

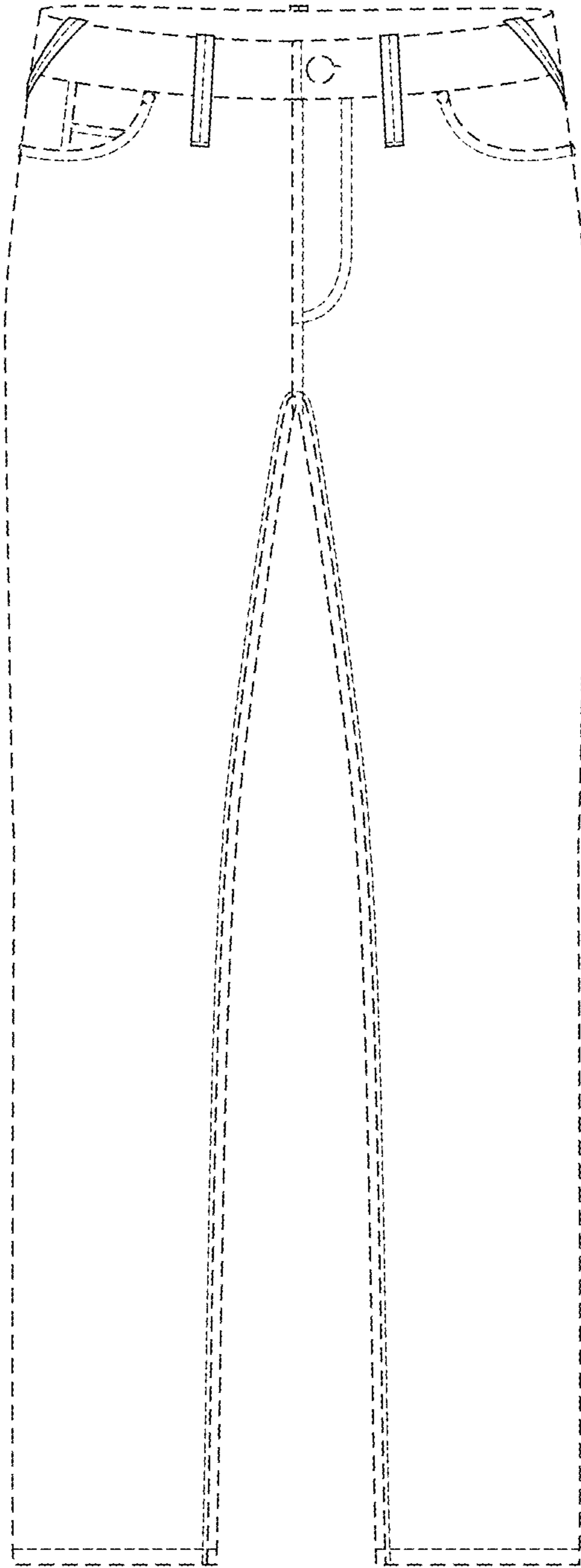

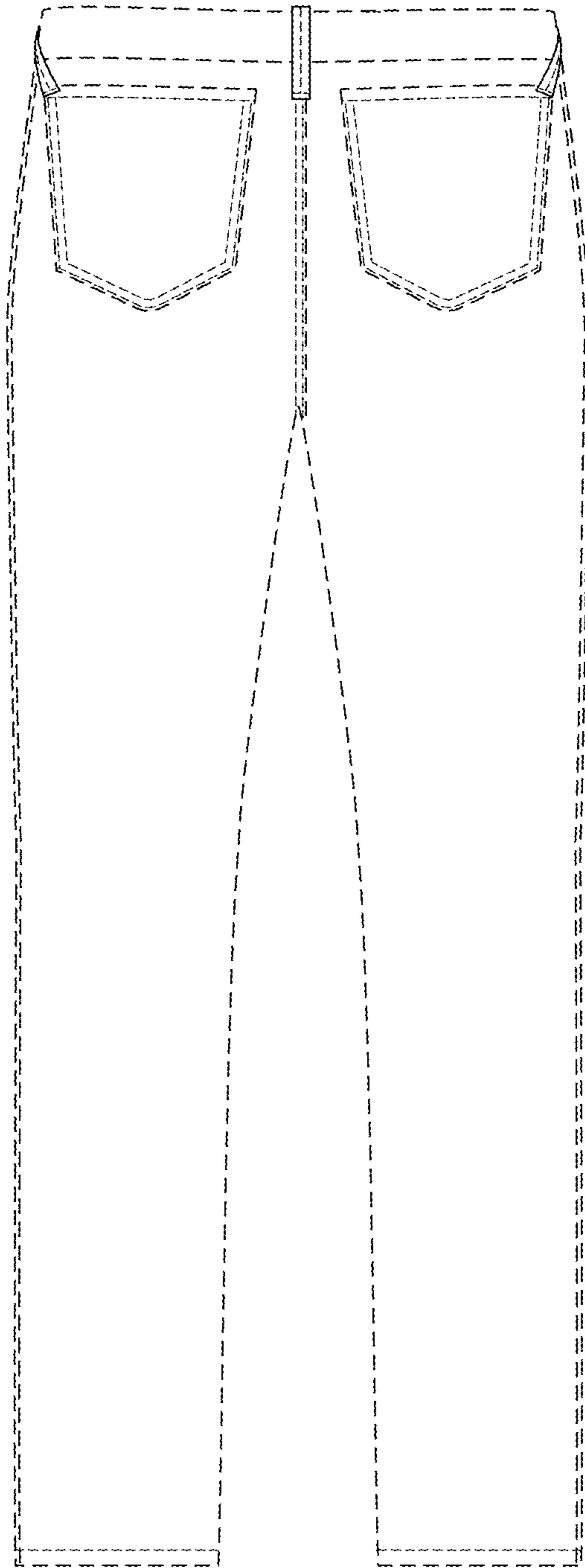

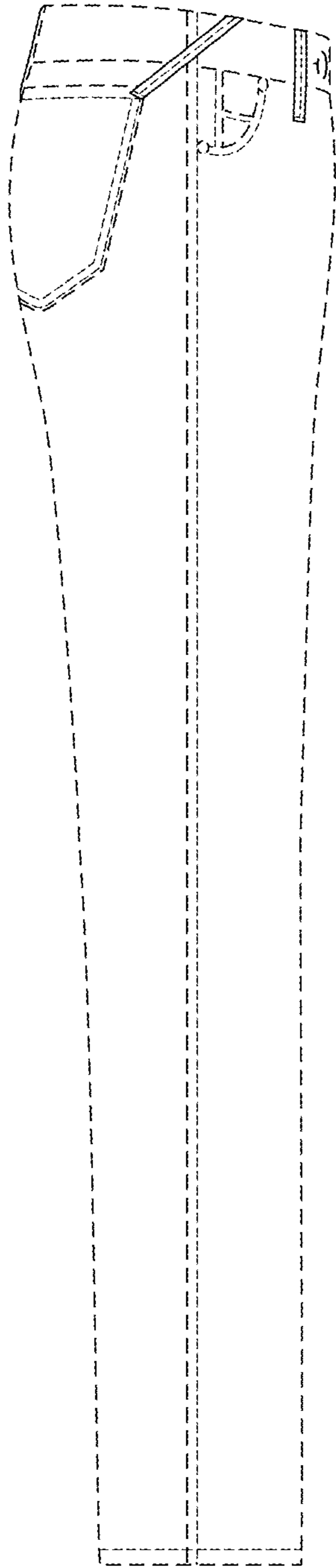

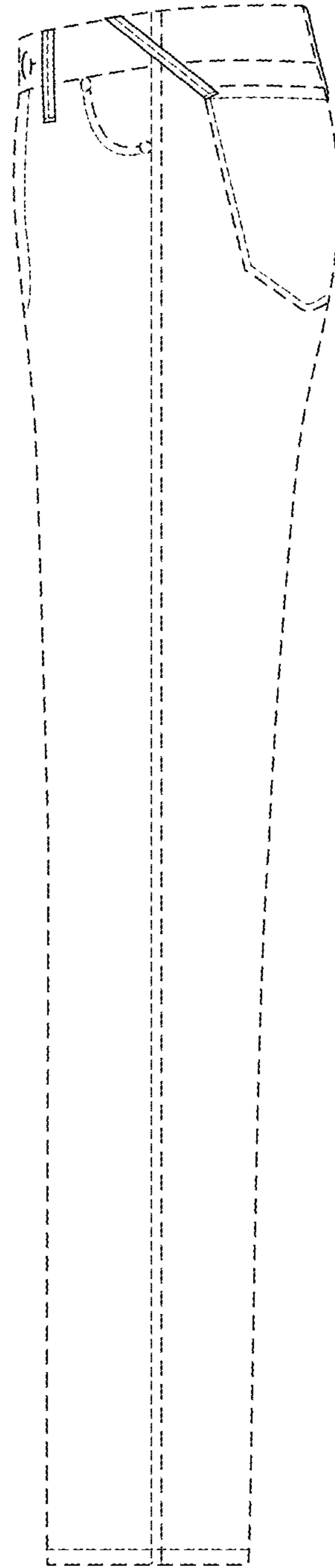
